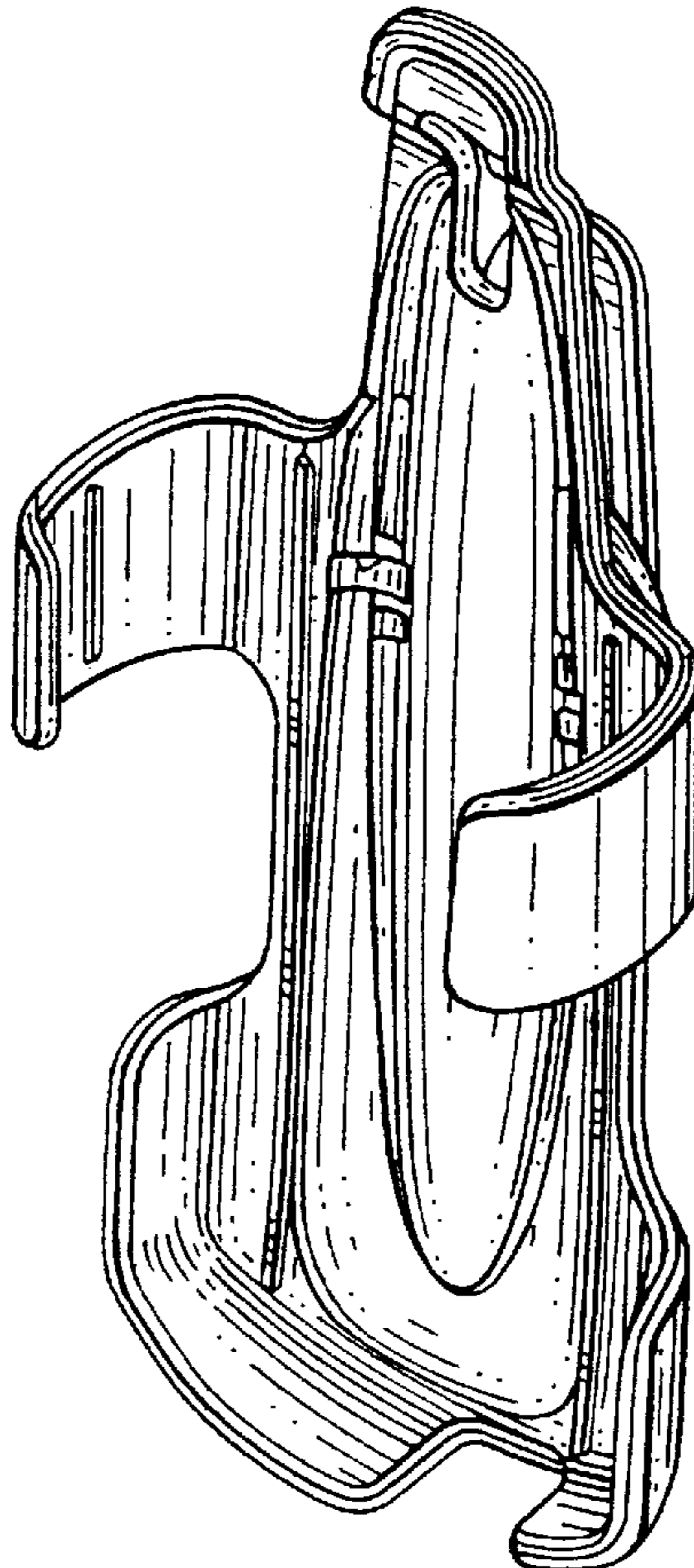
[57] **CLAIM**

The ornamental design of a holder for handset, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of a holder for headset showing our new design;  
FIG. 2 is a right side view thereof;  
FIG. 3 is a front, top and right side perspective view thereof;  
FIG. 4 is a rear, bottom and left side perspective view thereof;  
FIG. 5 is a front elevational view thereof;  
FIG. 6 is a left side view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.

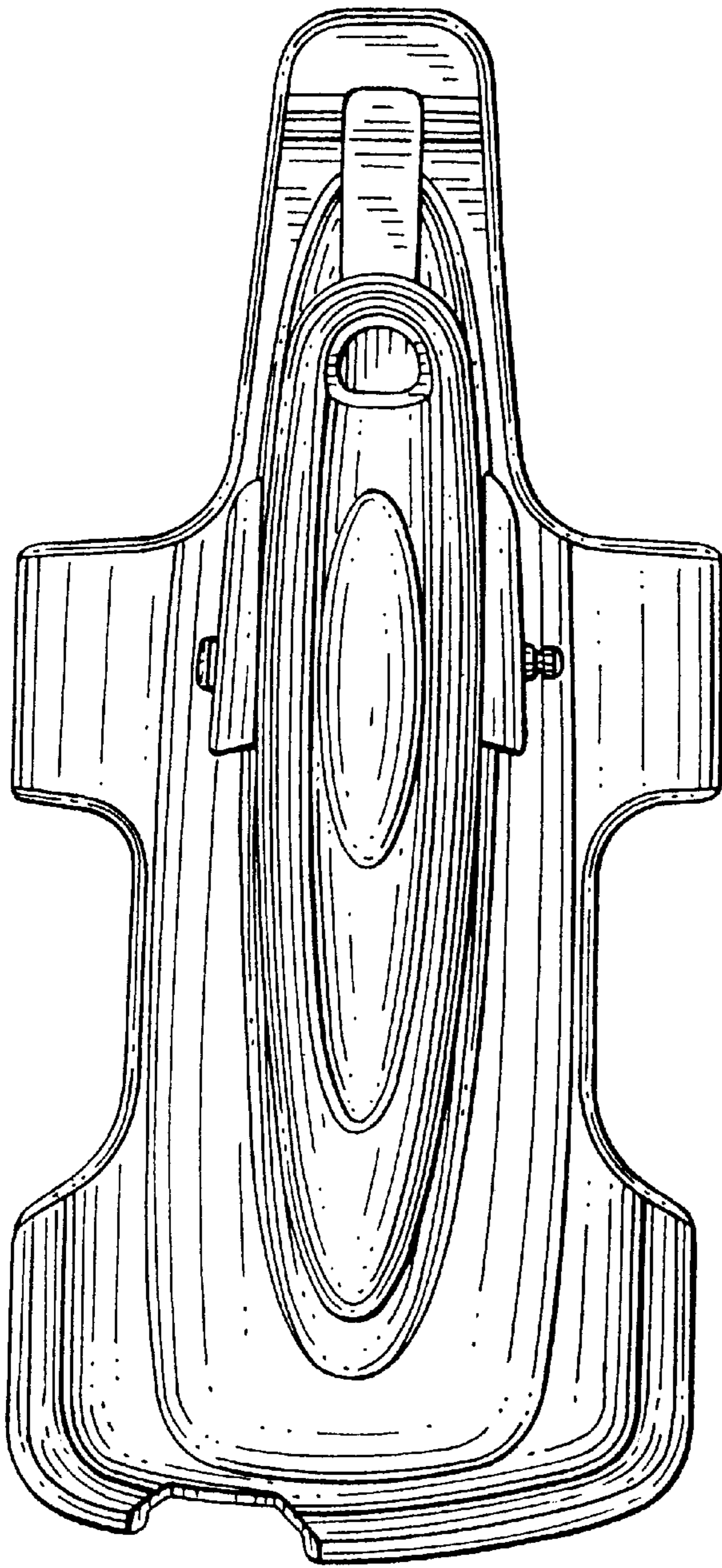

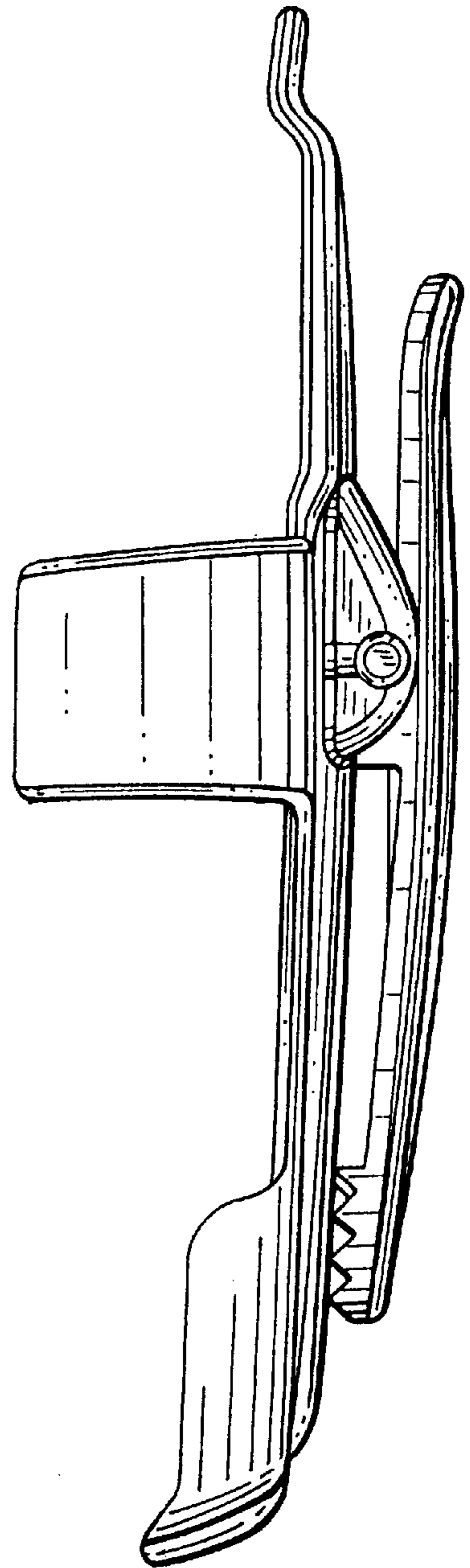

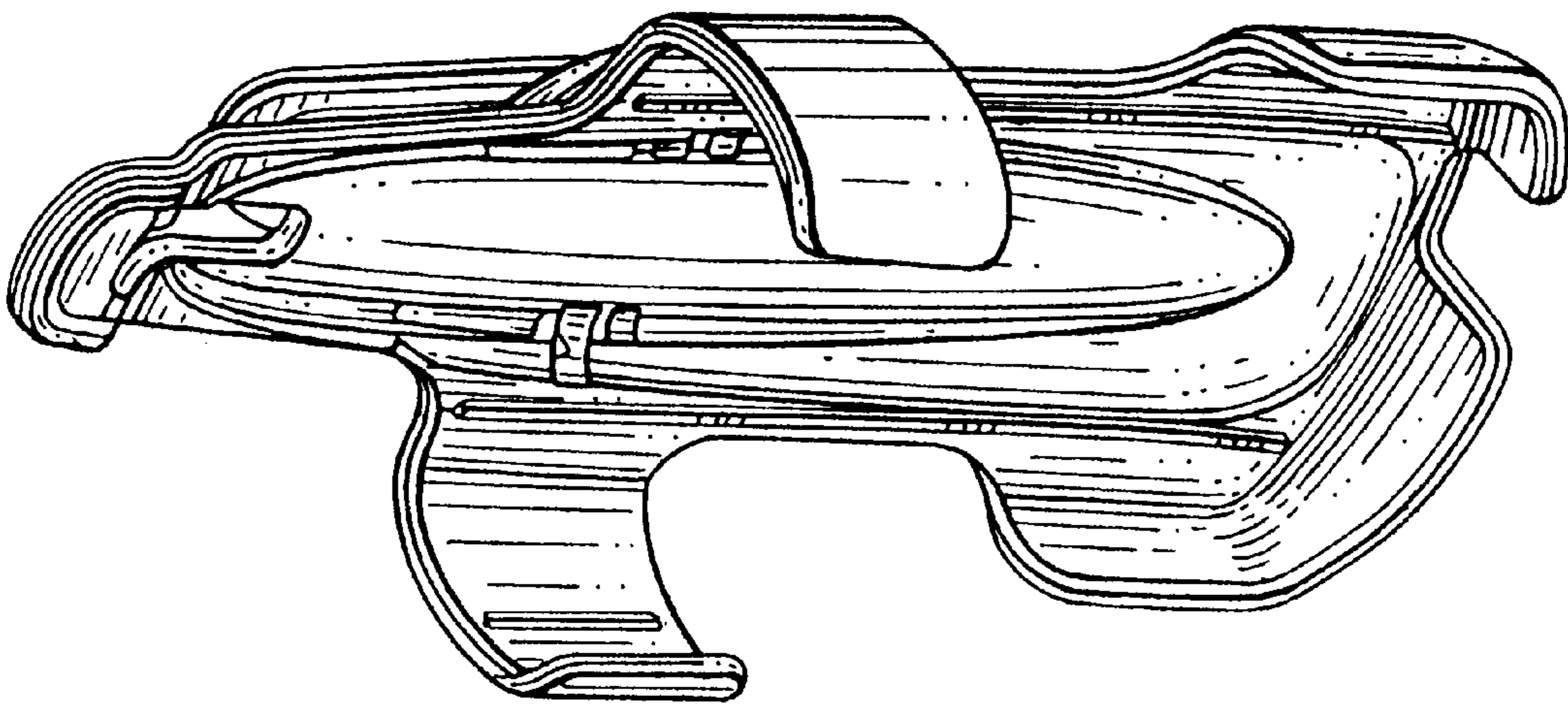

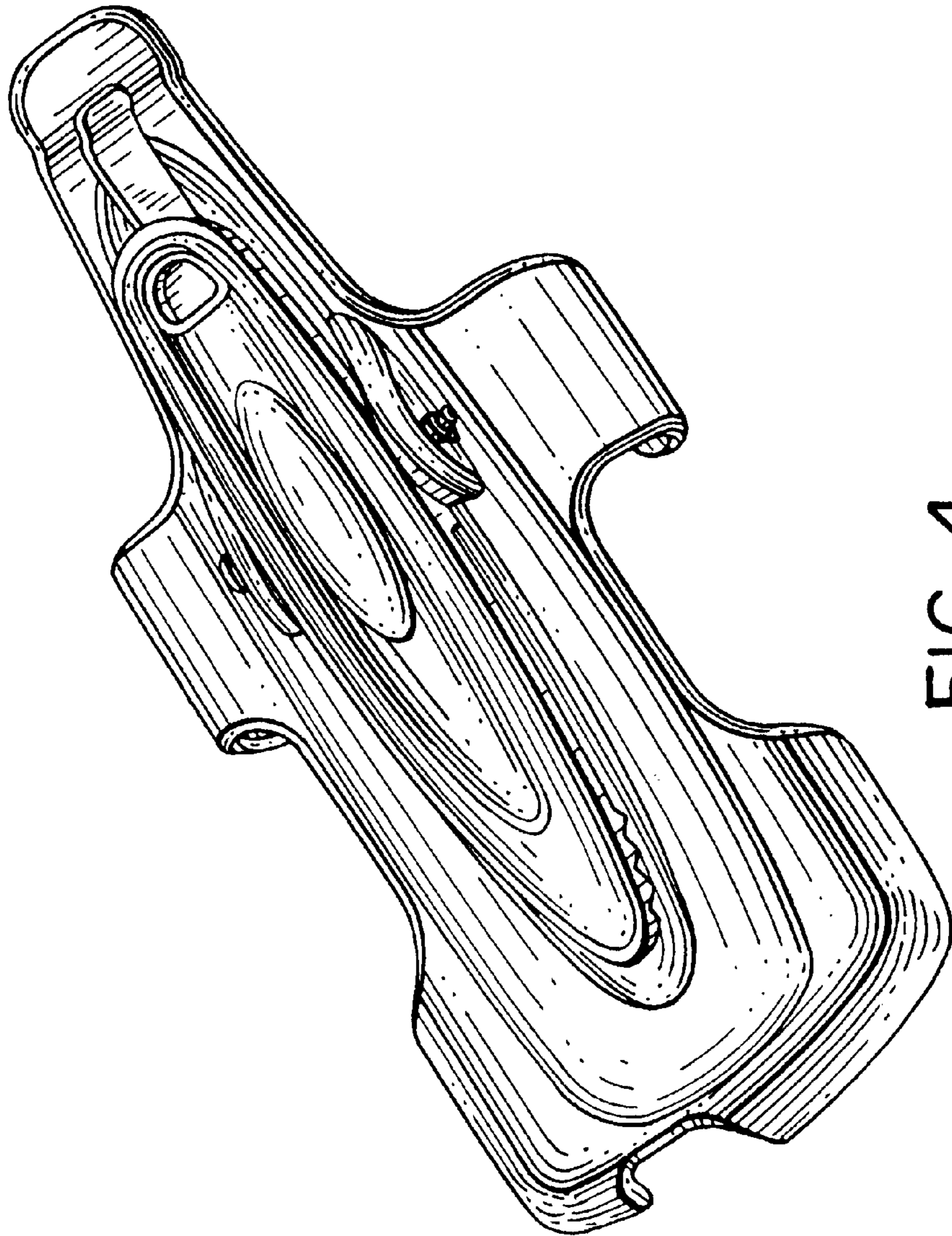

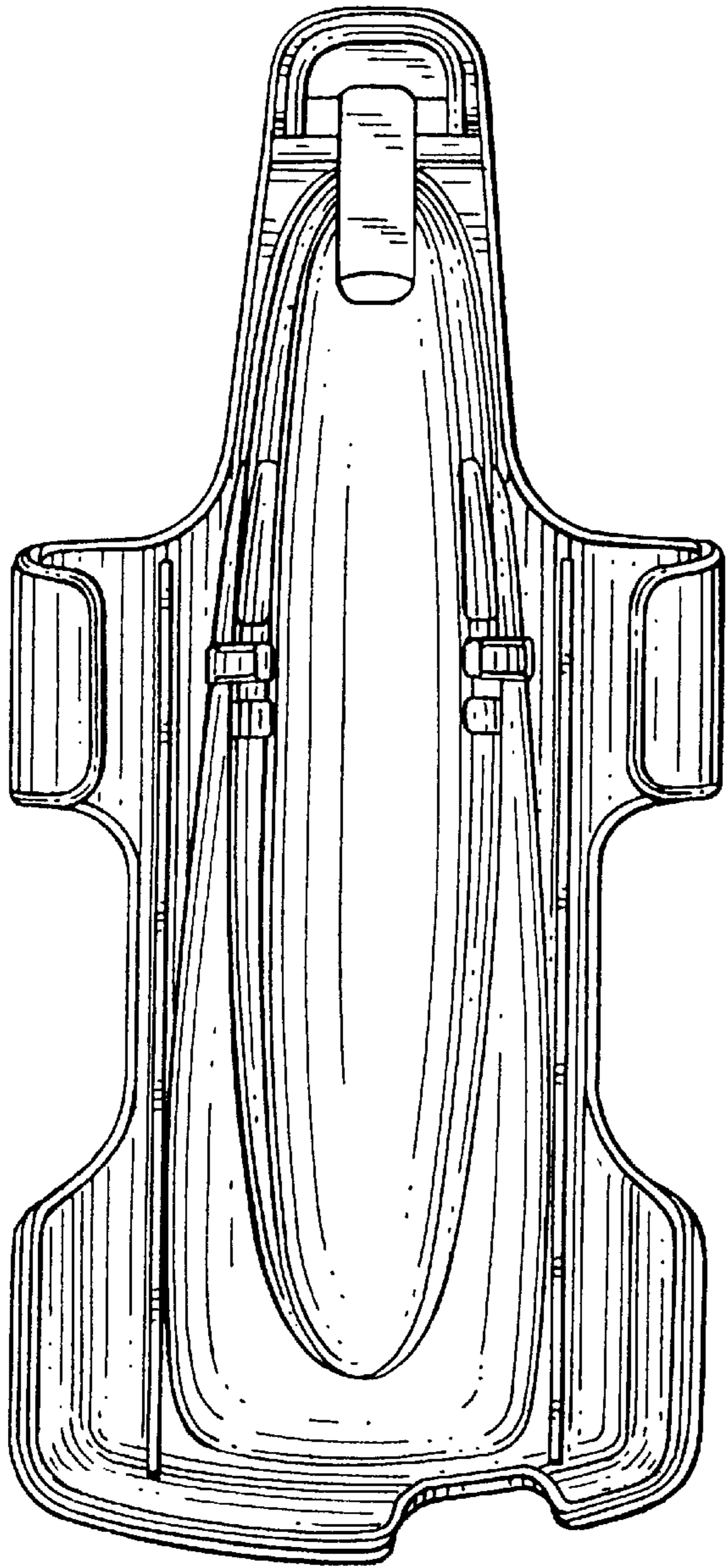

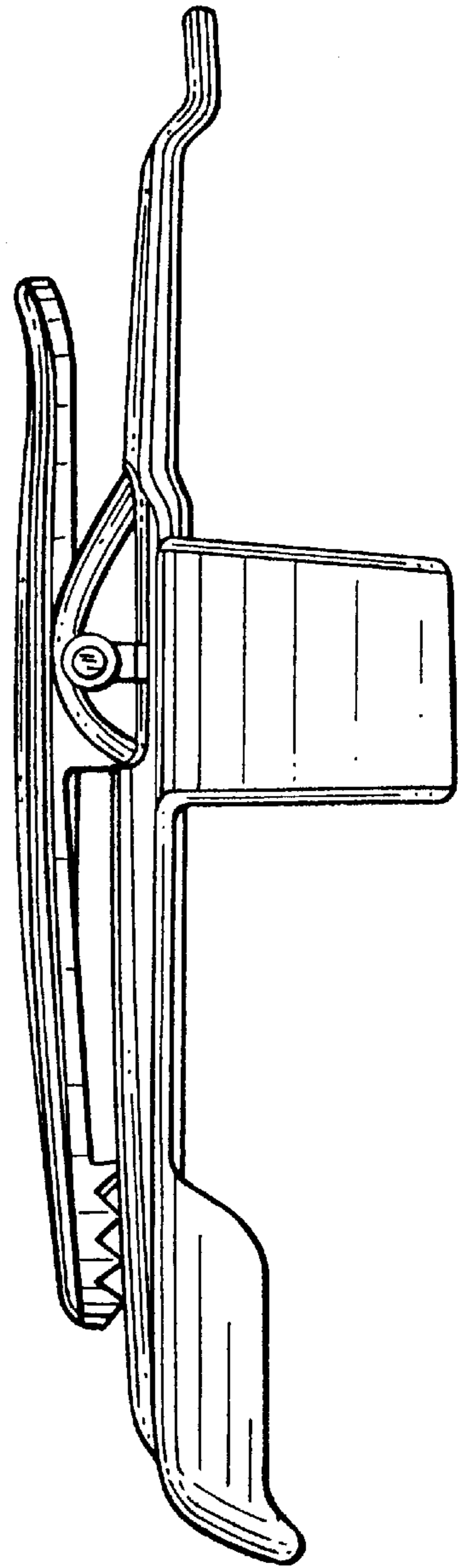

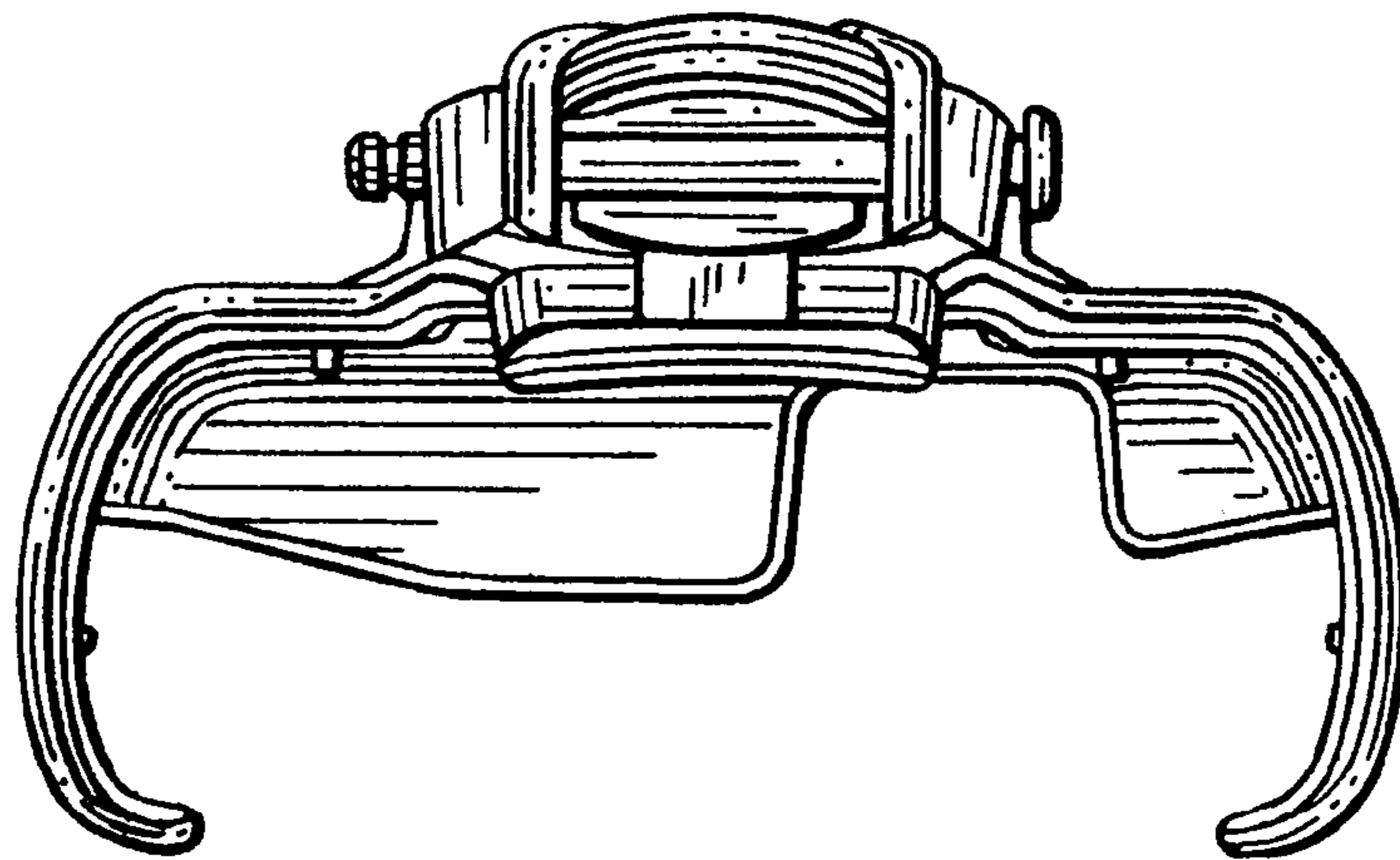

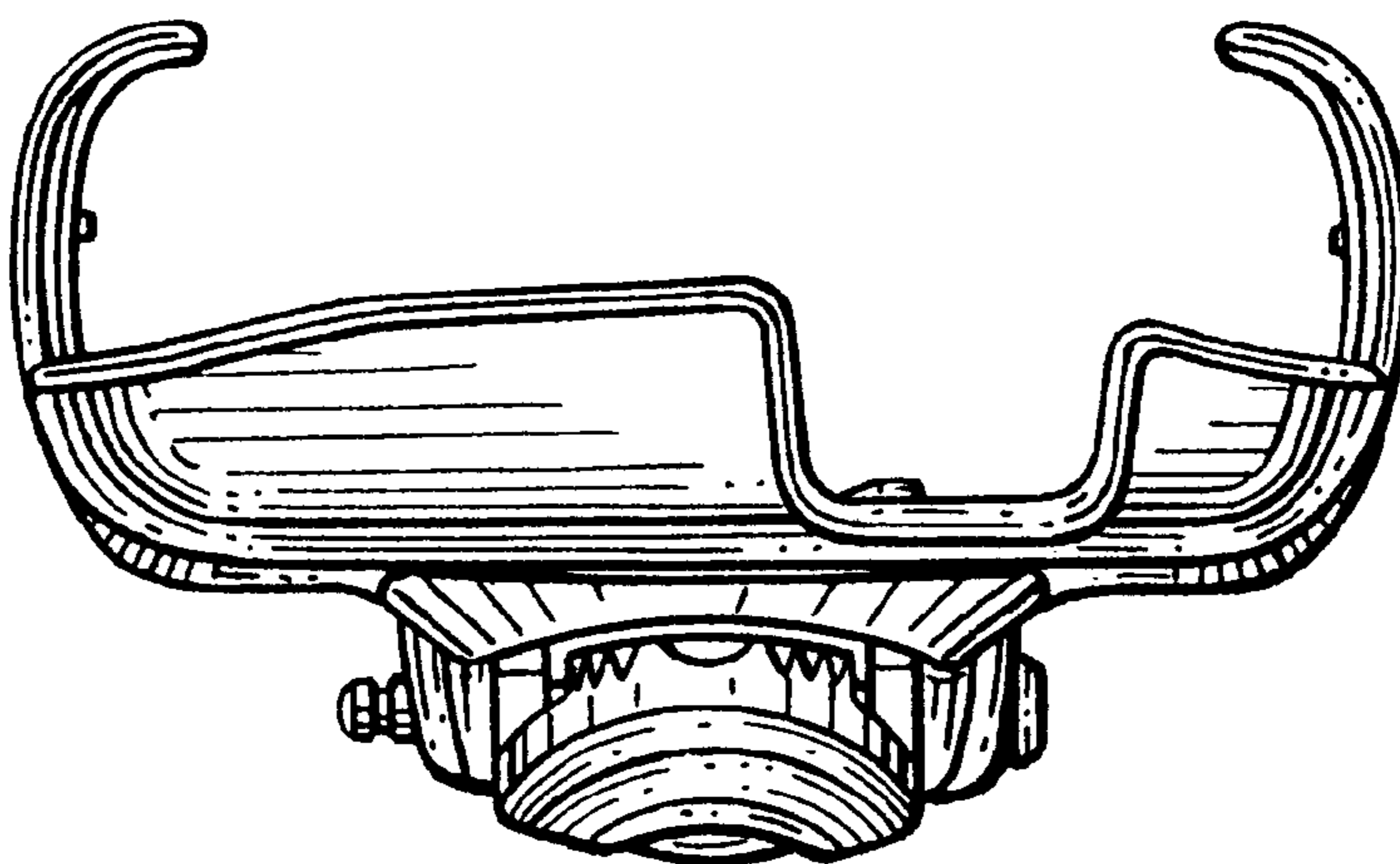
