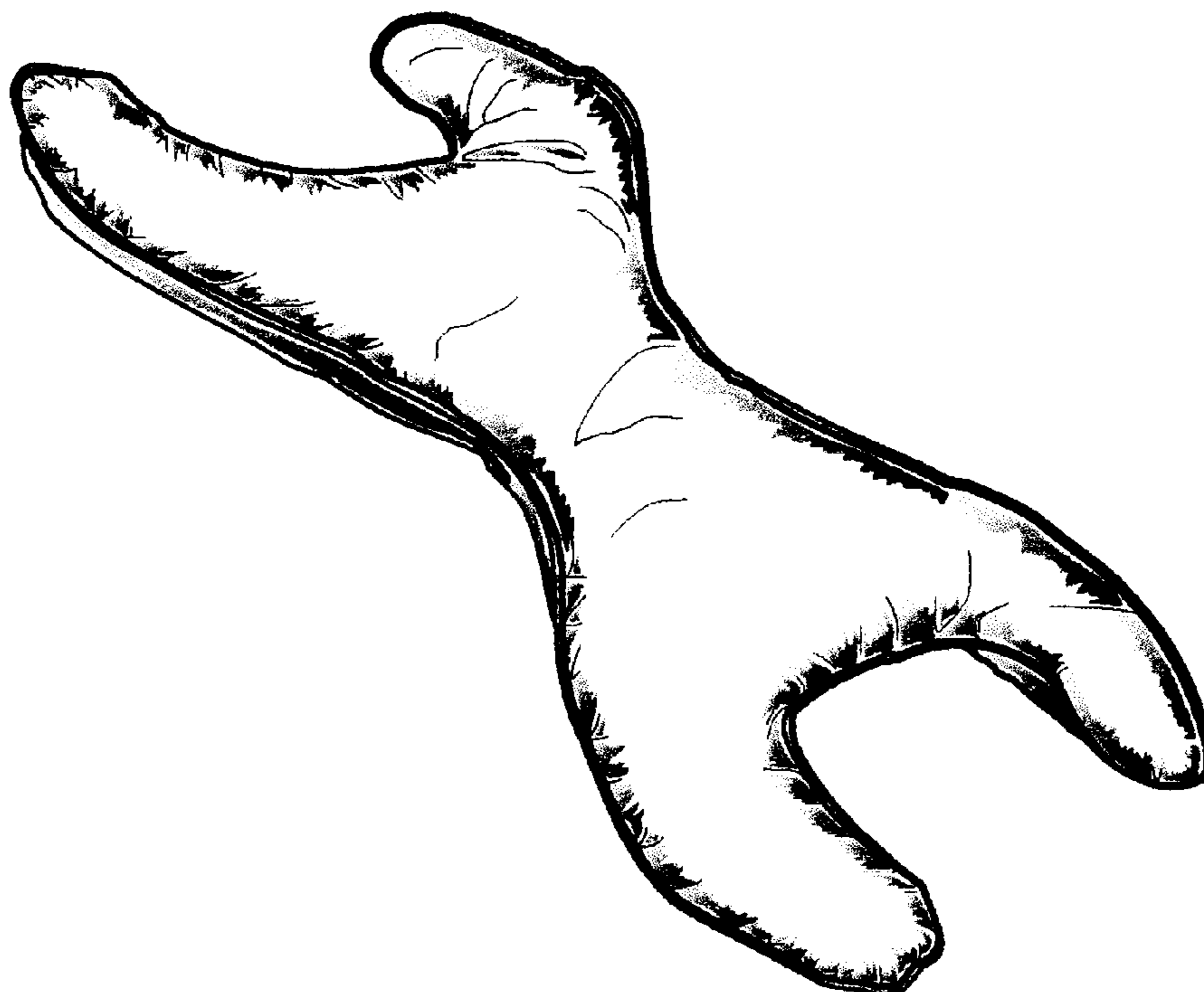
[57] **CLAIM**

The ornamental design for a face pillow, as shown and described.

DESCRIPTION

FIG. 1. Is a perspective top view of my face pillow;
 FIG. 2. Is a top plan view thereof, with the bottom plan view being a substantial mirror image;
 FIG. 3. Is a front view thereof, with the back view being a substantial mirror image;
 FIG. 4. Is a right side elevational view thereof, with the left side elevational view being a substantial mirror image;
 FIG. 5. Is a top perspective view of another embodiment of my face pillow;
 FIG. 6. Is a top view of the embodiment shown in FIG. 5, with the bottom view being a substantial mirror image thereof;
 FIG. 7. Is a front view of the embodiment shown in FIG. 5, with the back view being a substantial mirror image thereof; and,
 FIG. 8. Is a side elevational view of the embodiment shown in FIG. 5, with the opposite elevational view being a substantial mirror image thereof.

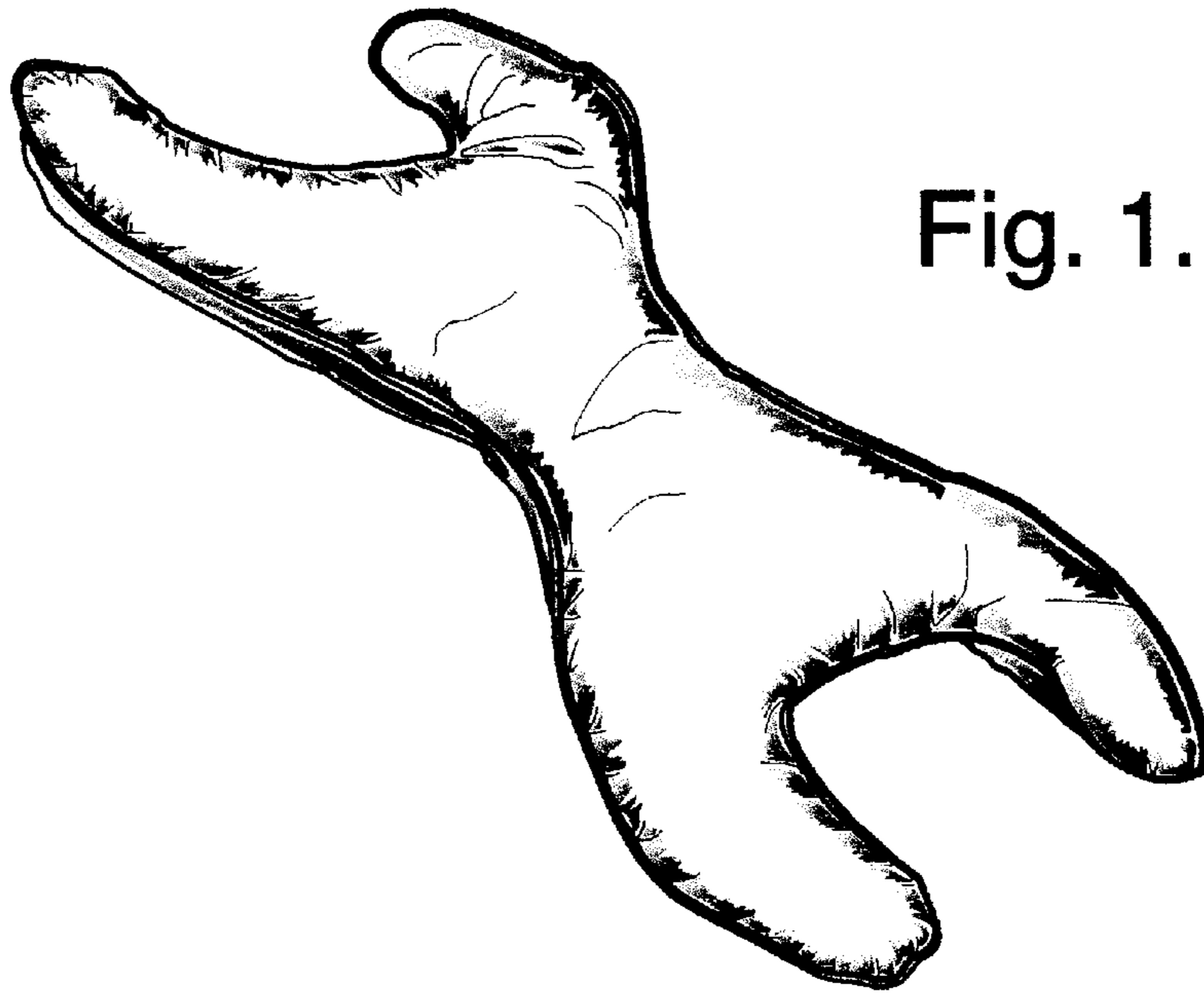

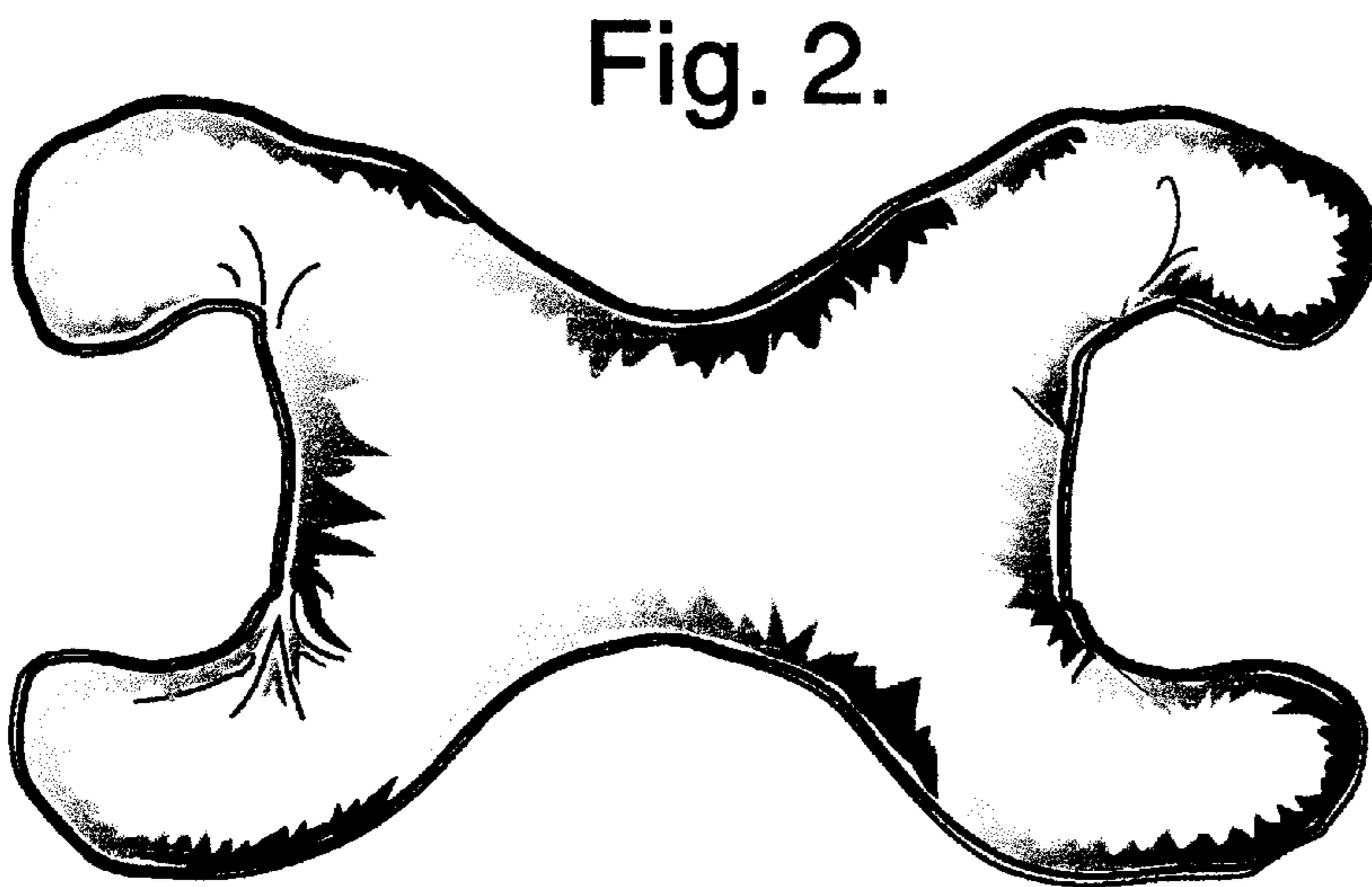

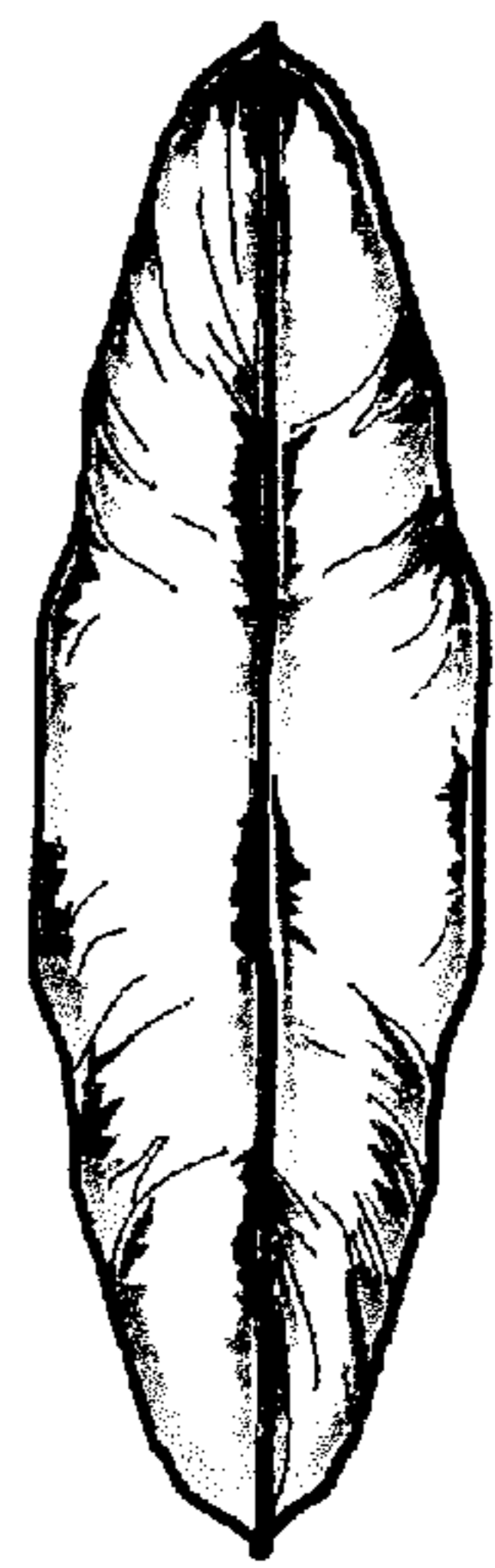

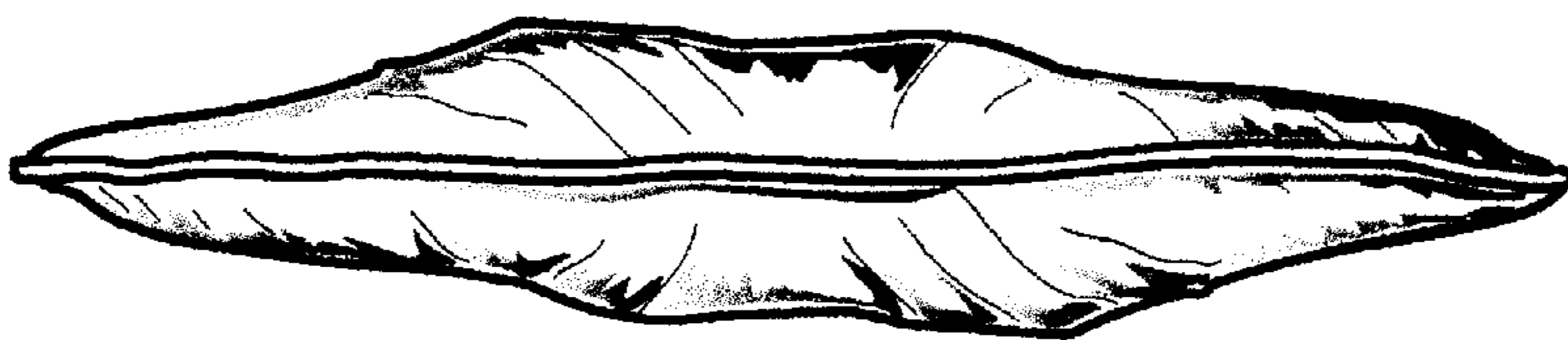

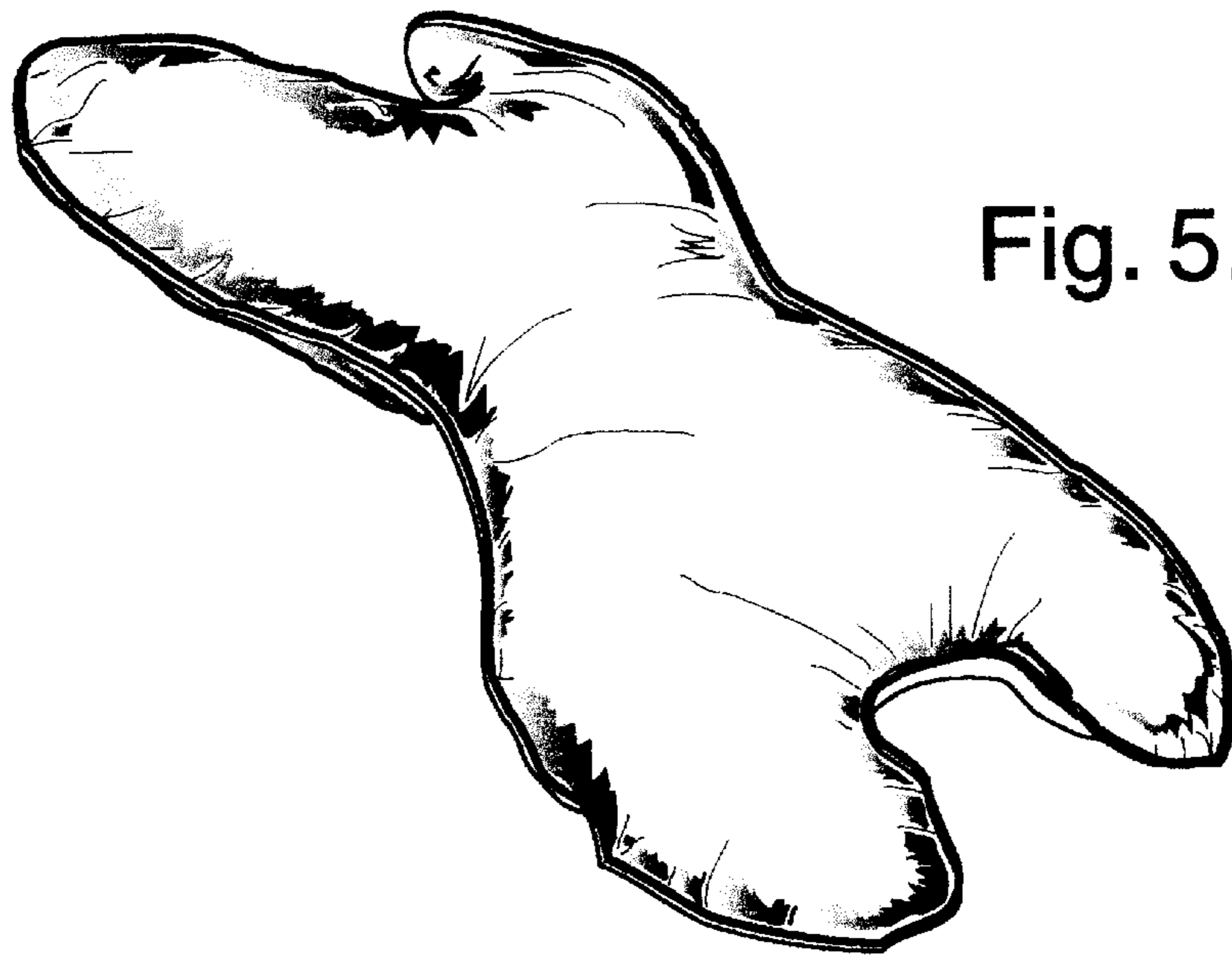

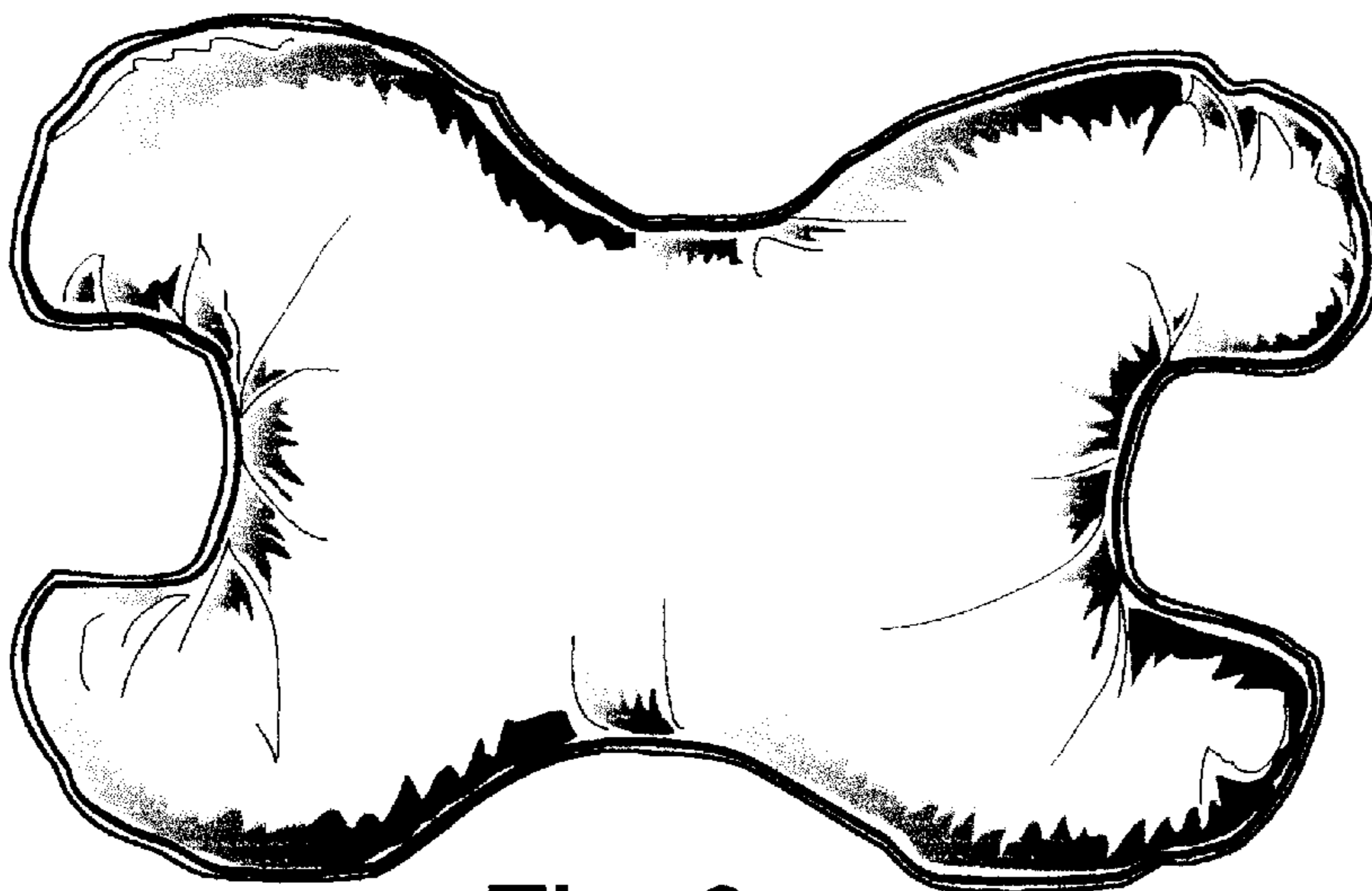

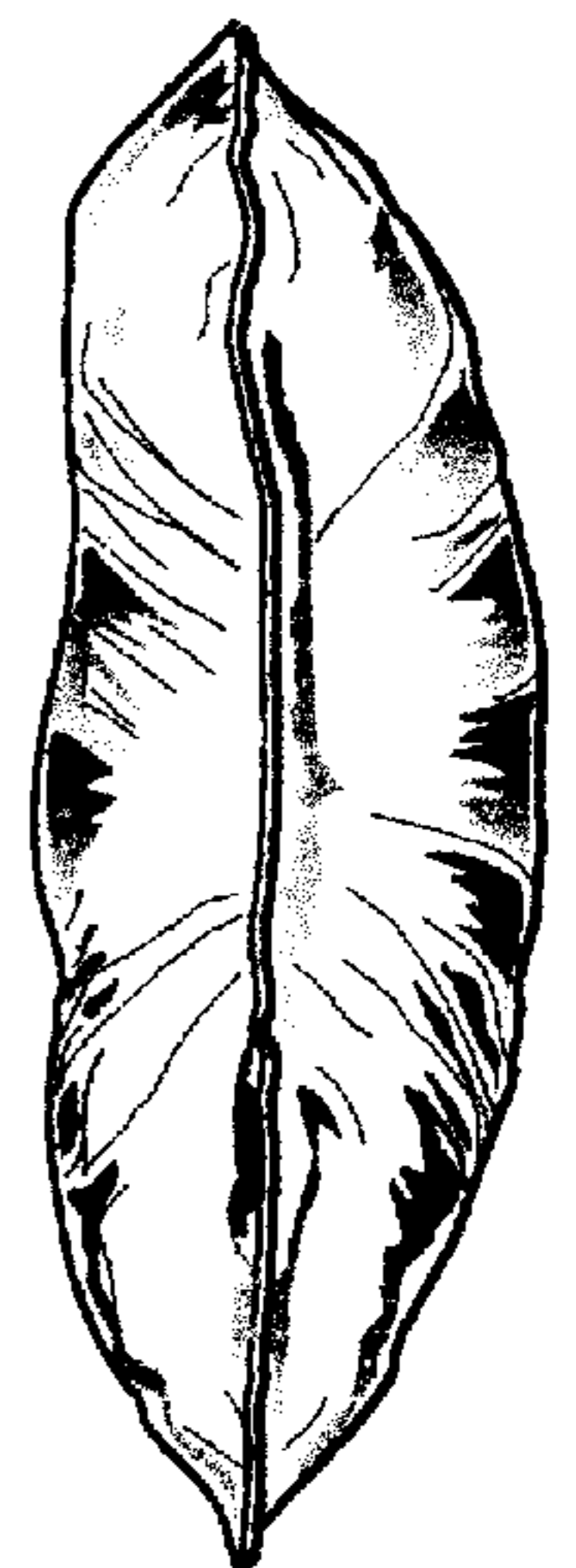

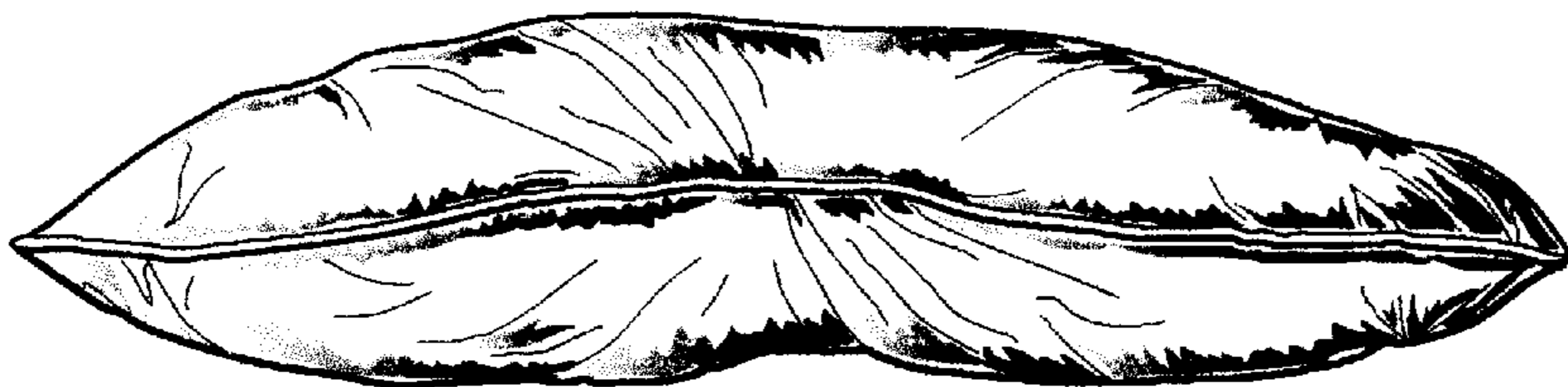
