The ornamental design for a ring, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a ring according to the design of this invention;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a right side elevational view thereof, the left side view being a mirror image;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view thereof, with an opened lid.

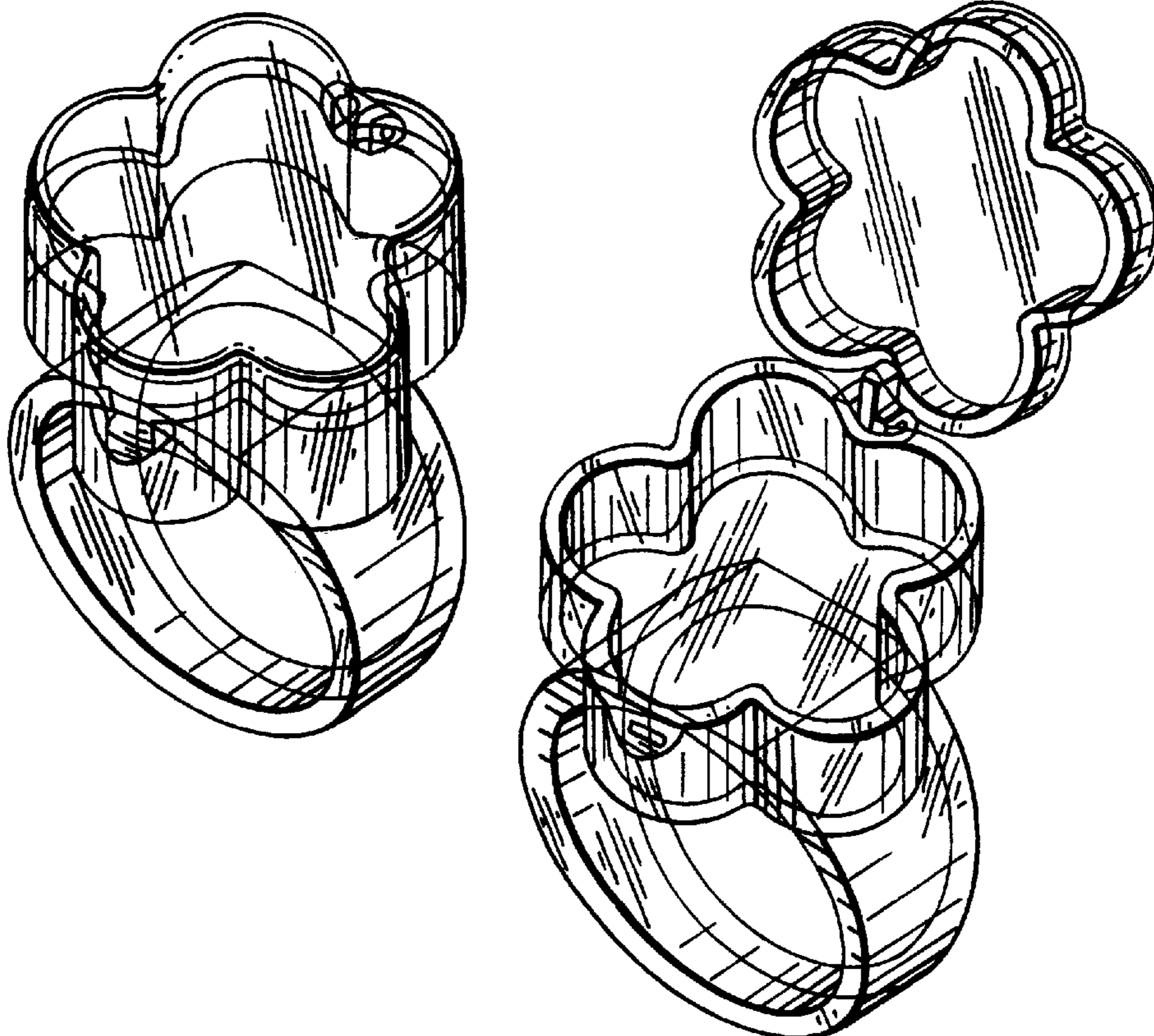

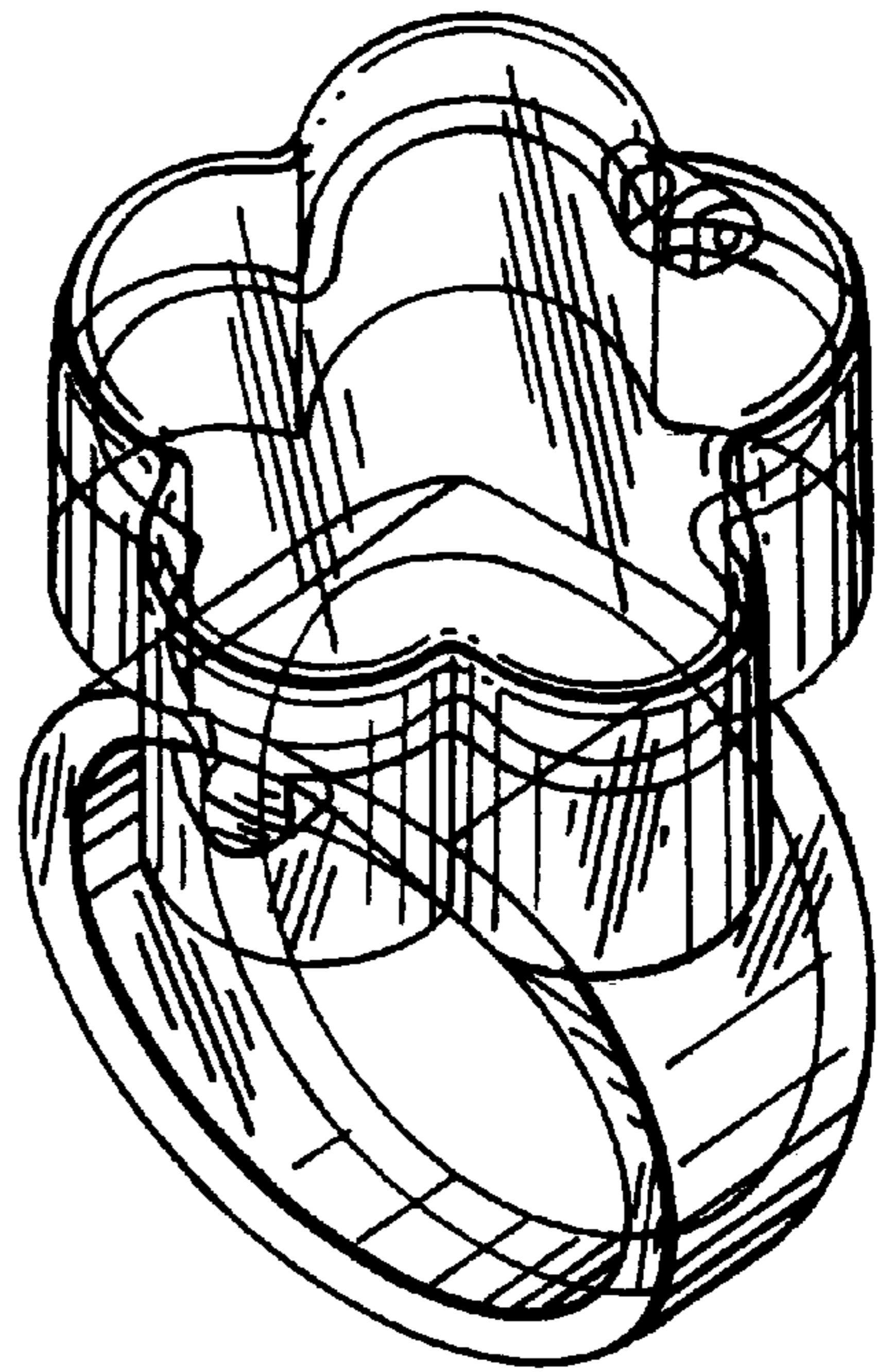

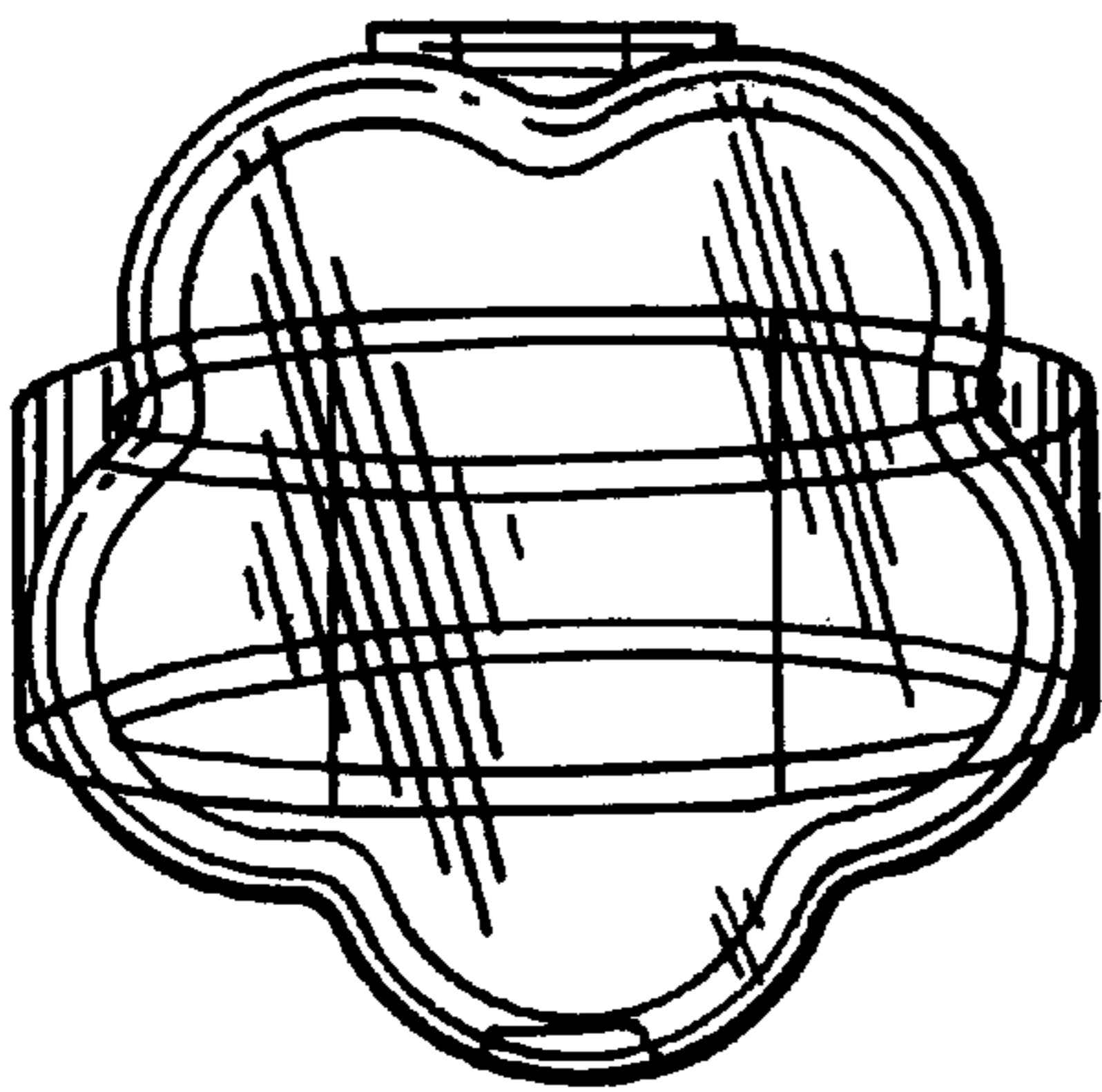

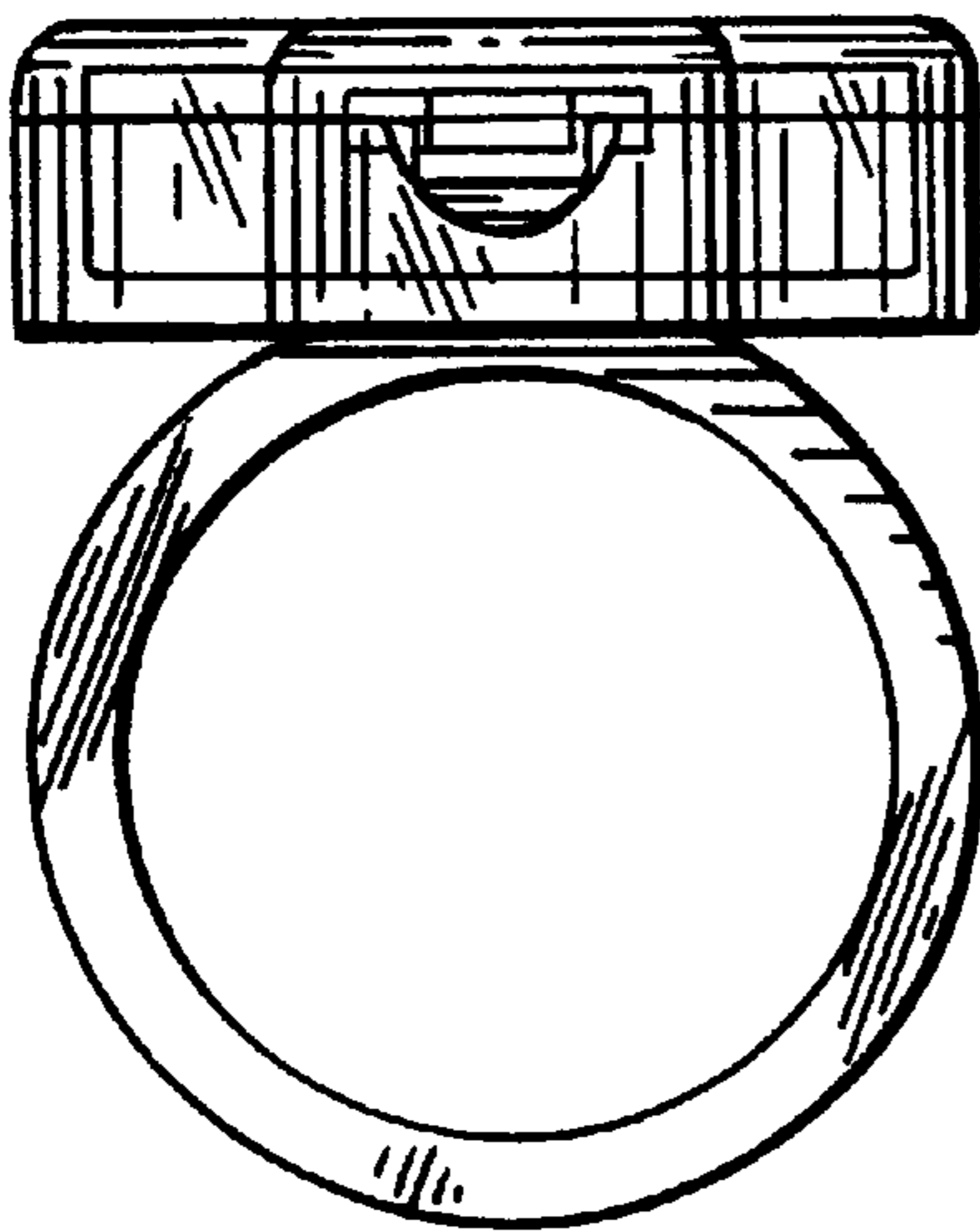

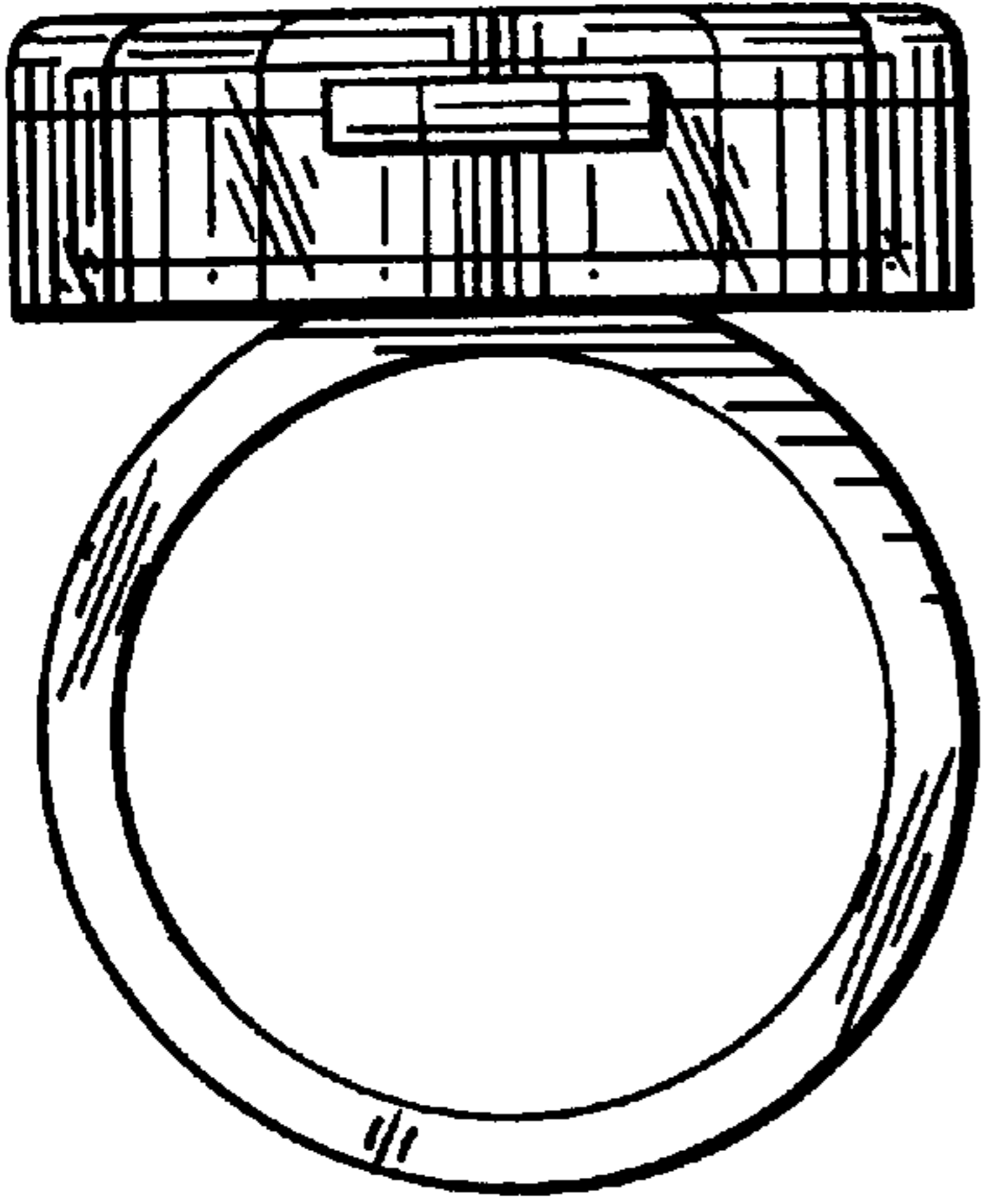
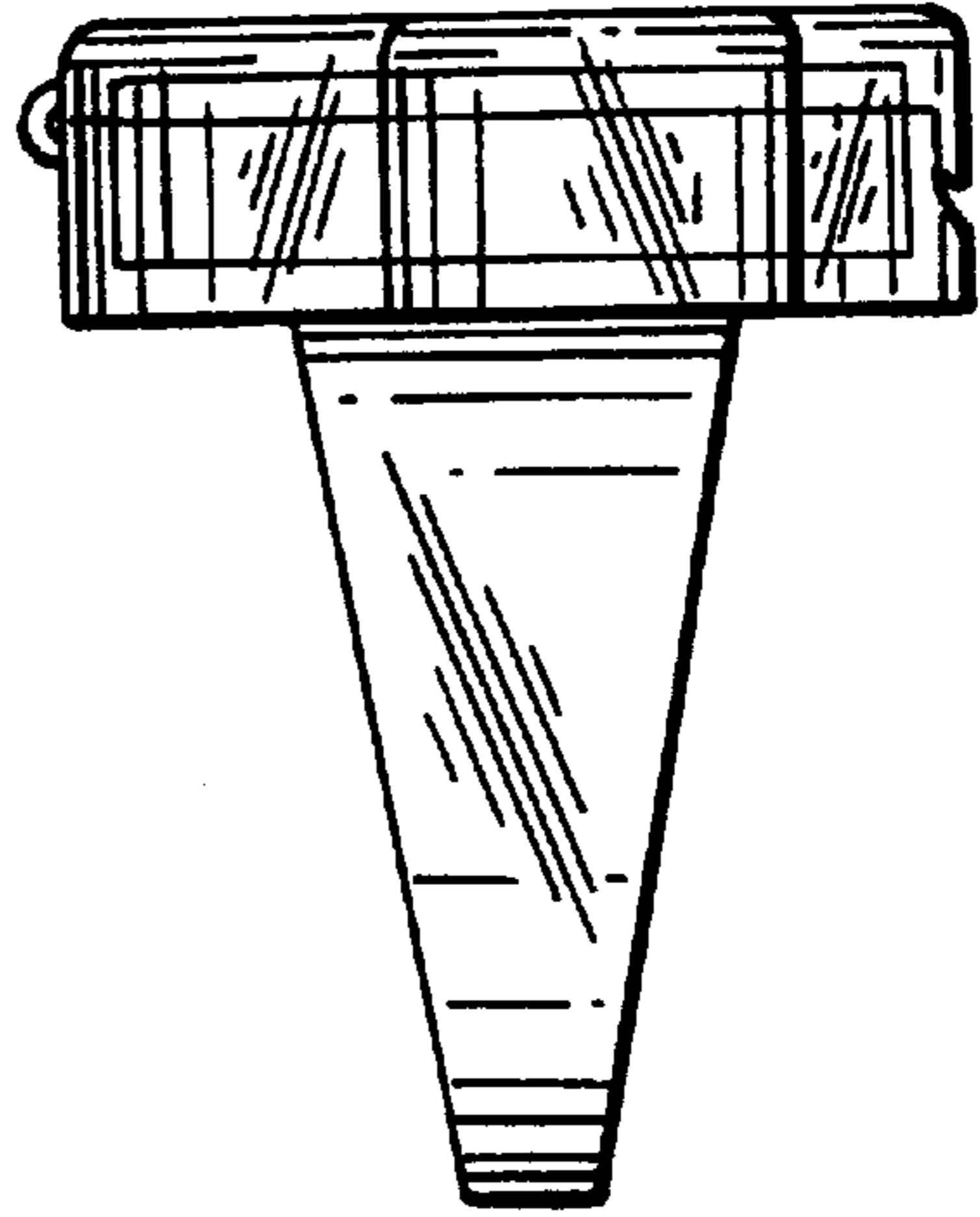

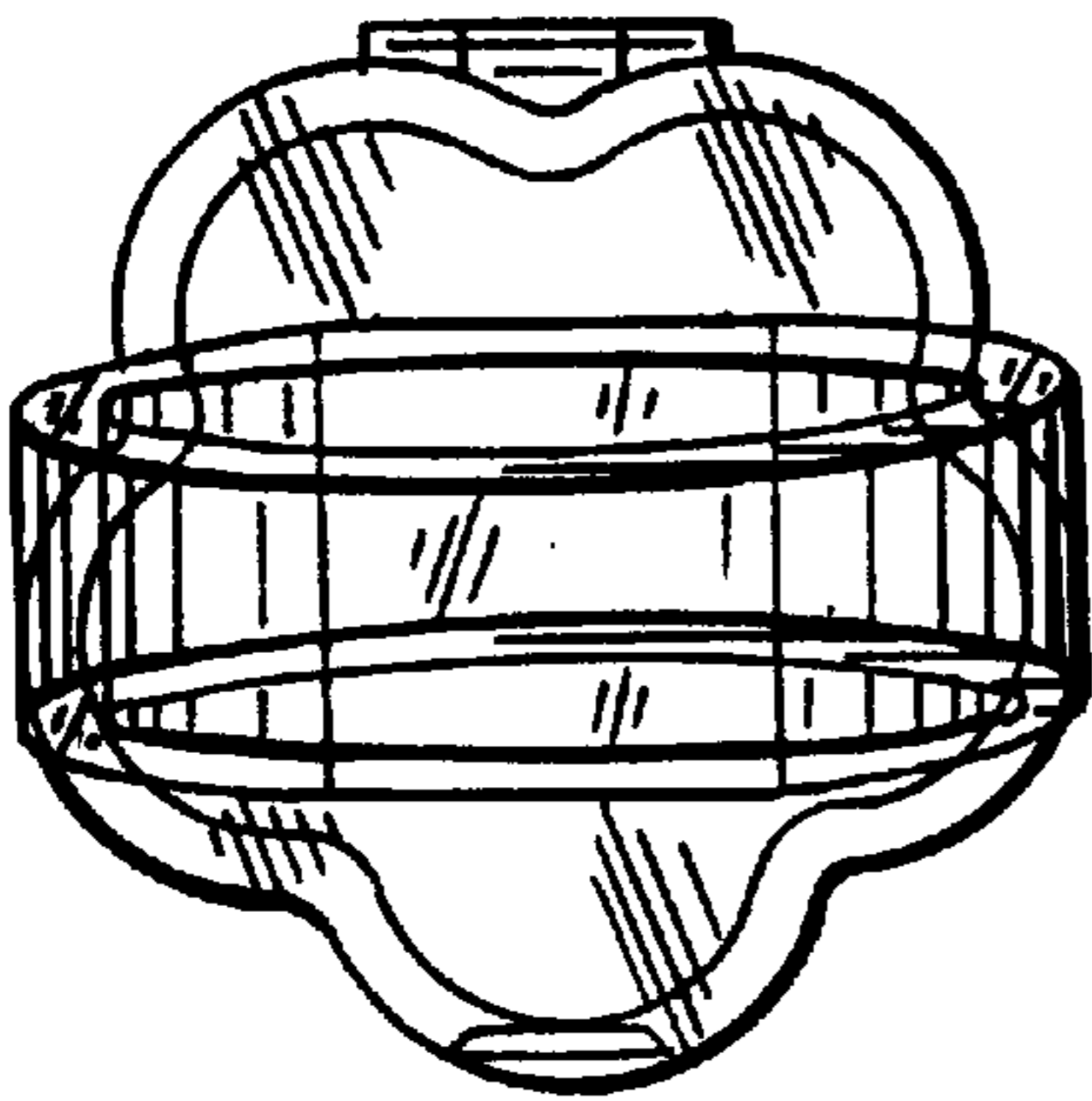

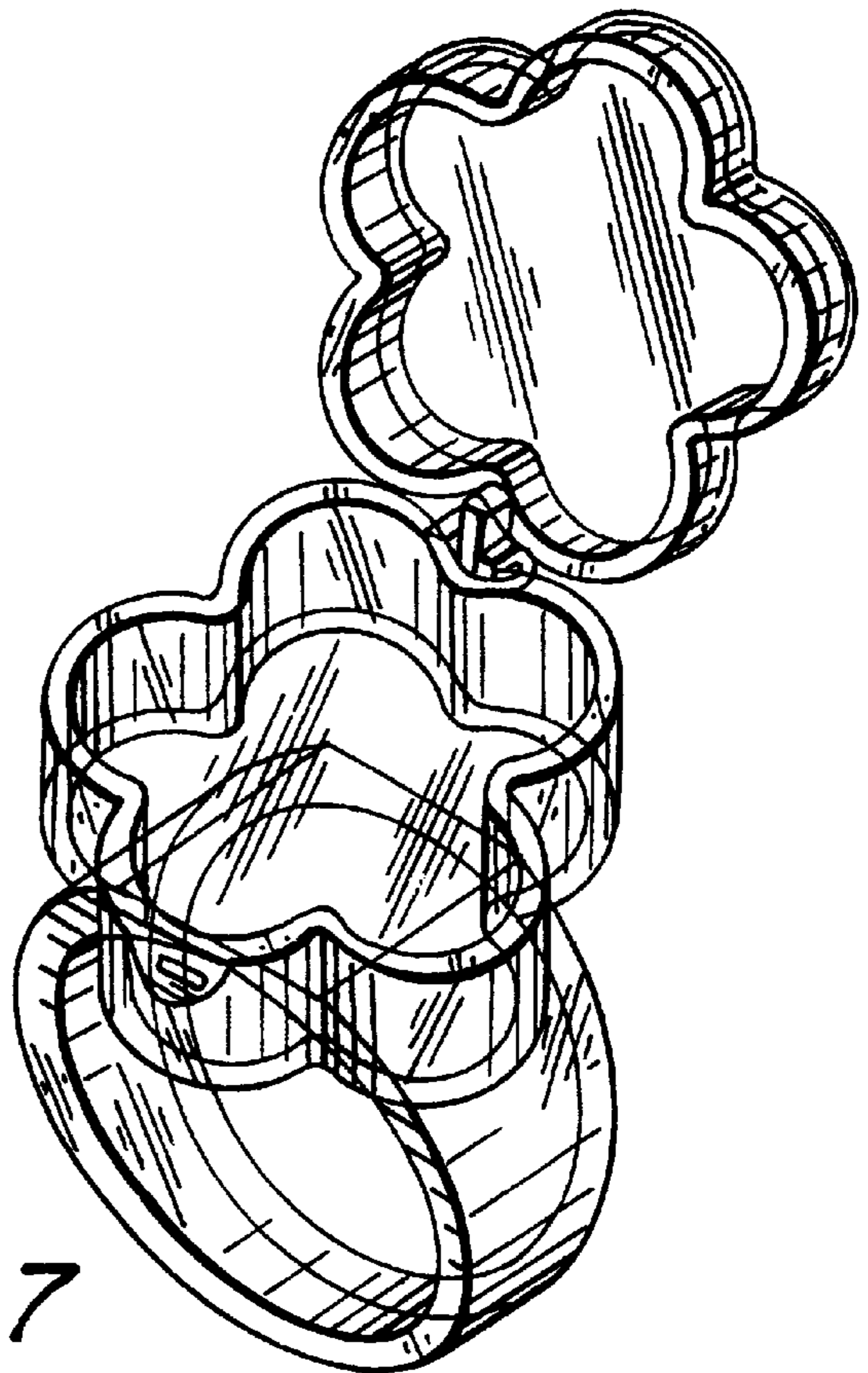
