[57] **CLAIM**

The ornamental design for a radiotelephone antenna, as shown and described.

DESCRIPTION

FIG. 1 is a top, left and front perspective view of the radiotelephone antenna showing my new design in the retracted position;

FIG. 2 is a top, left and front perspective view of the radiotelephone antenna shown in FIG. 1 in the extended position;

FIG. 3 is a left side elevational view of the radiotelephone antenna shown in FIG. 1;

FIG. 4 is a front elevational view of the radiotelephone antenna shown in FIG. 1;

FIG. 5 is a bottom elevational view of the radiotelephone antenna shown in FIG. 1;

FIG. 6 is a top elevational view of the radiotelephone antenna shown in FIG. 1;

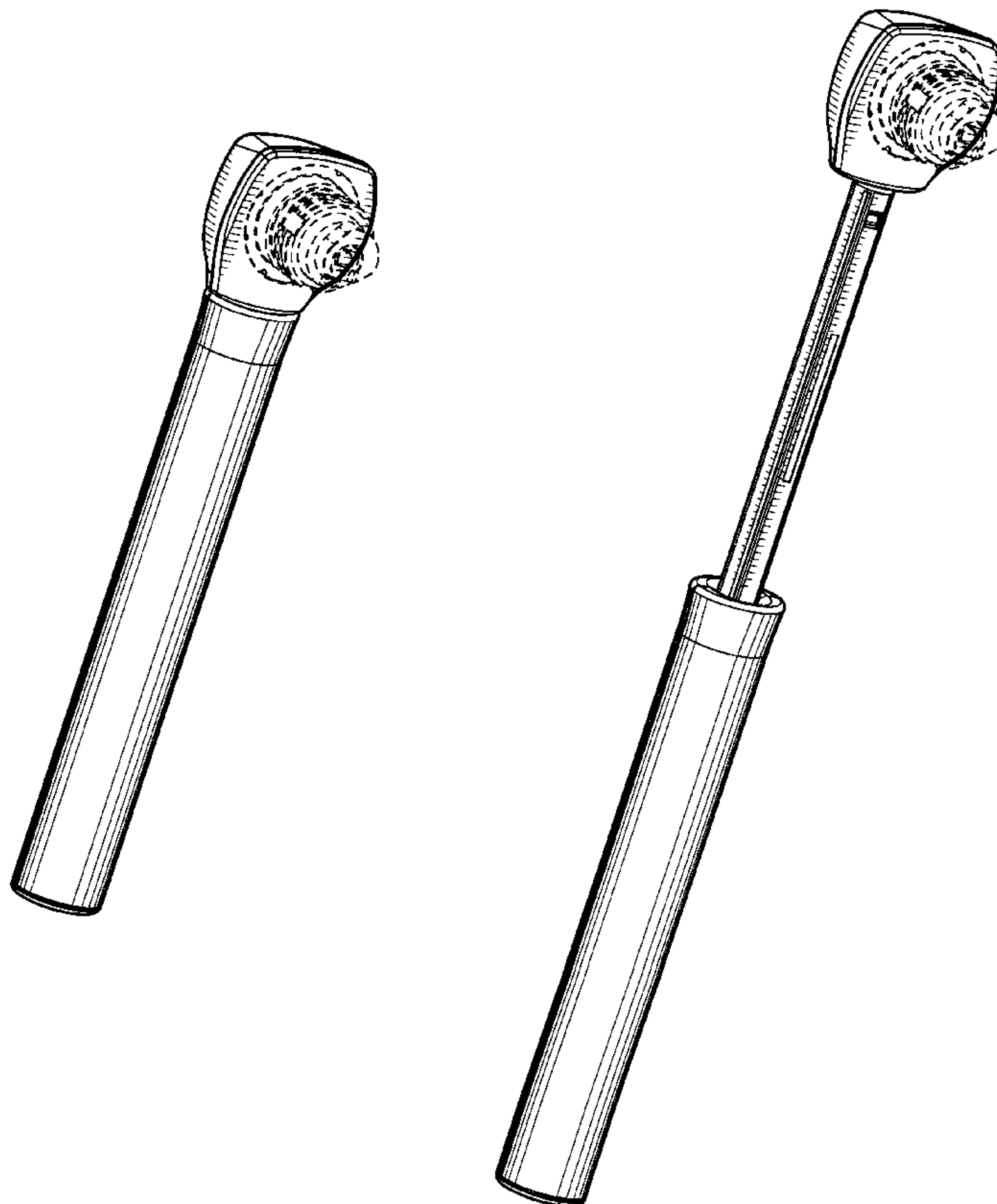
FIG. 7 is a right side elevational view of the radiotelephone antenna shown in FIG. 1; and,

FIG. 8 is a rear elevational view of the radiotelephone antenna shown in FIG. 1.

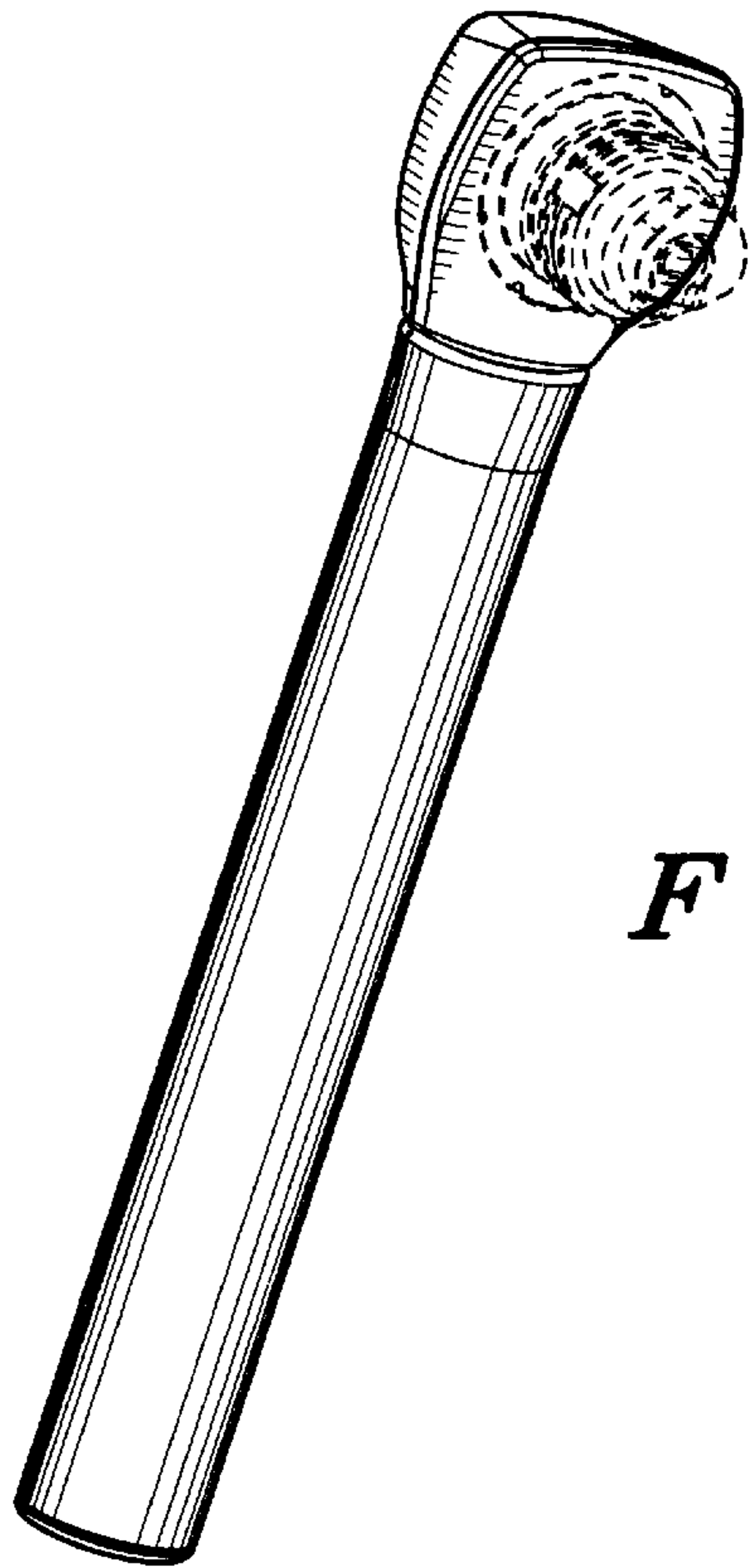

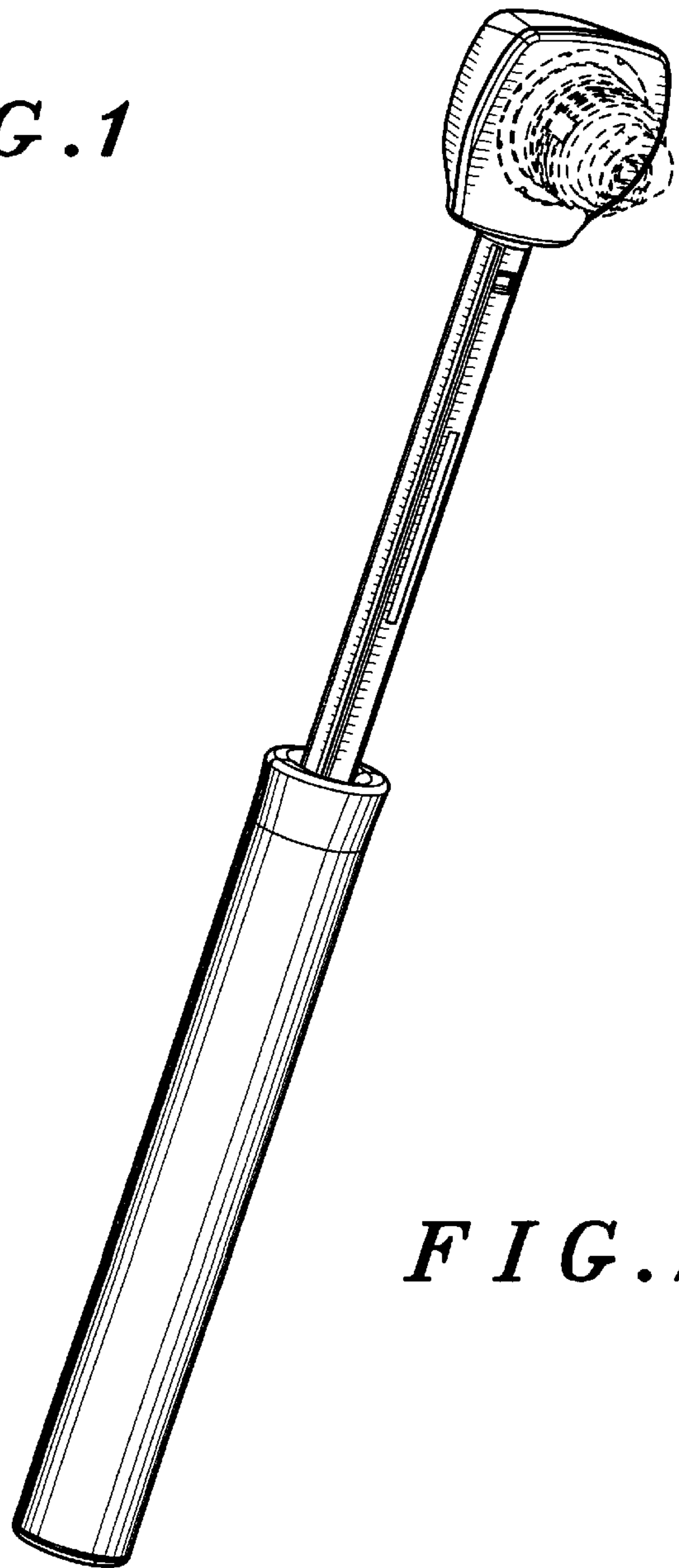

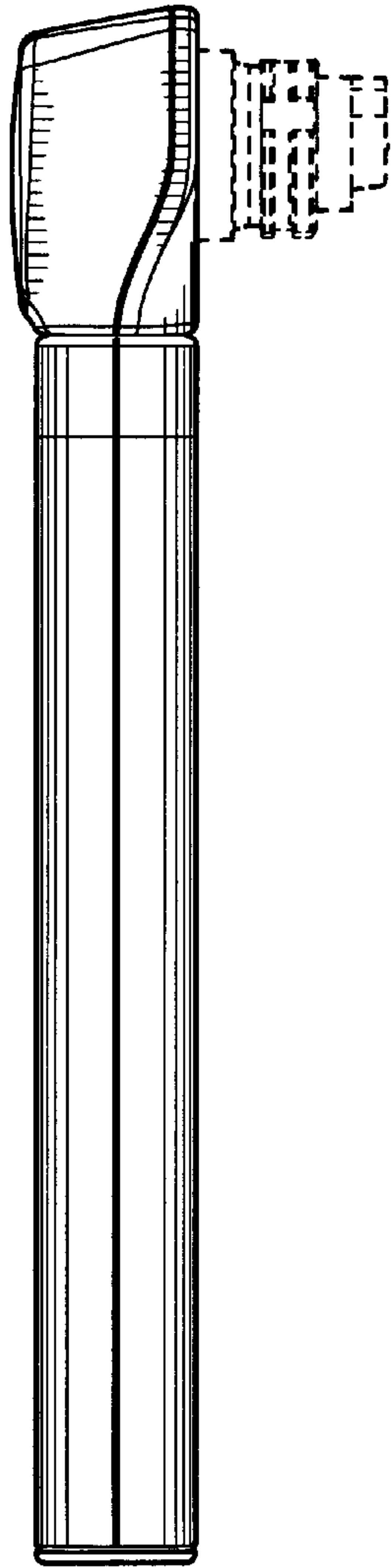

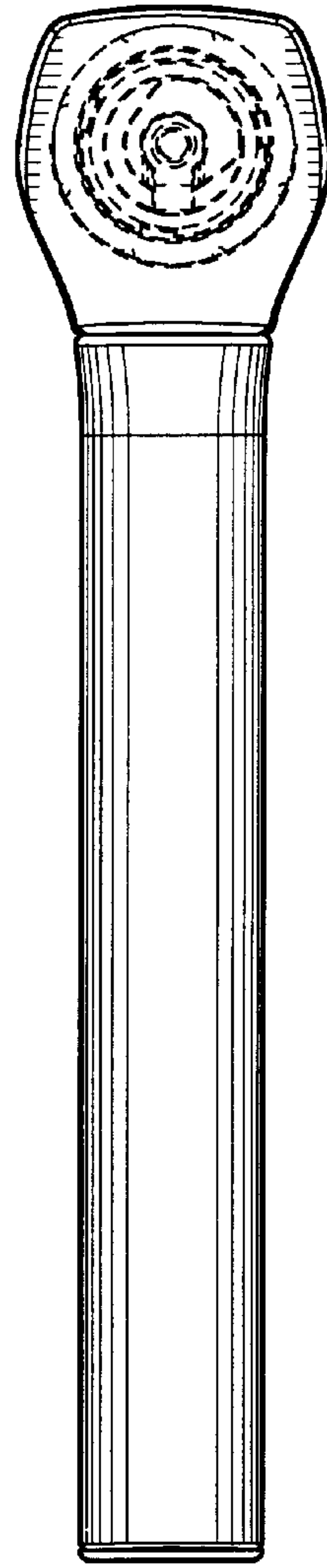

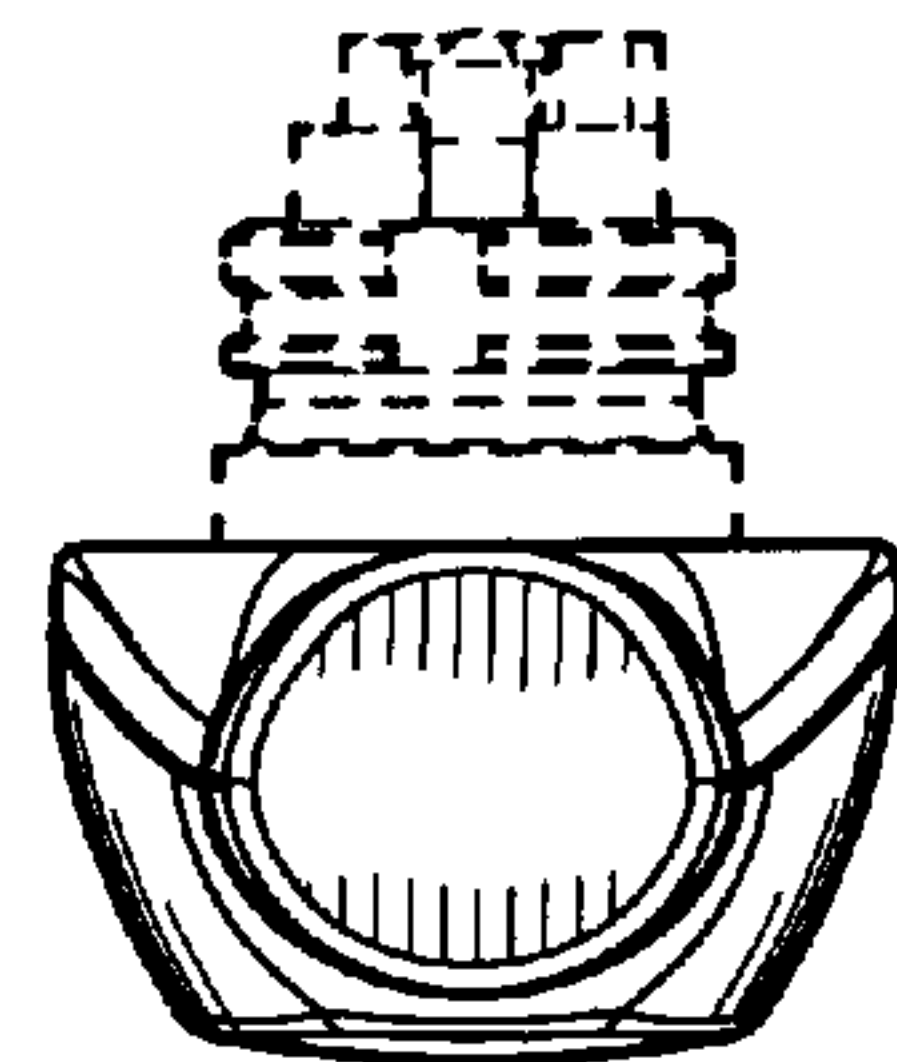

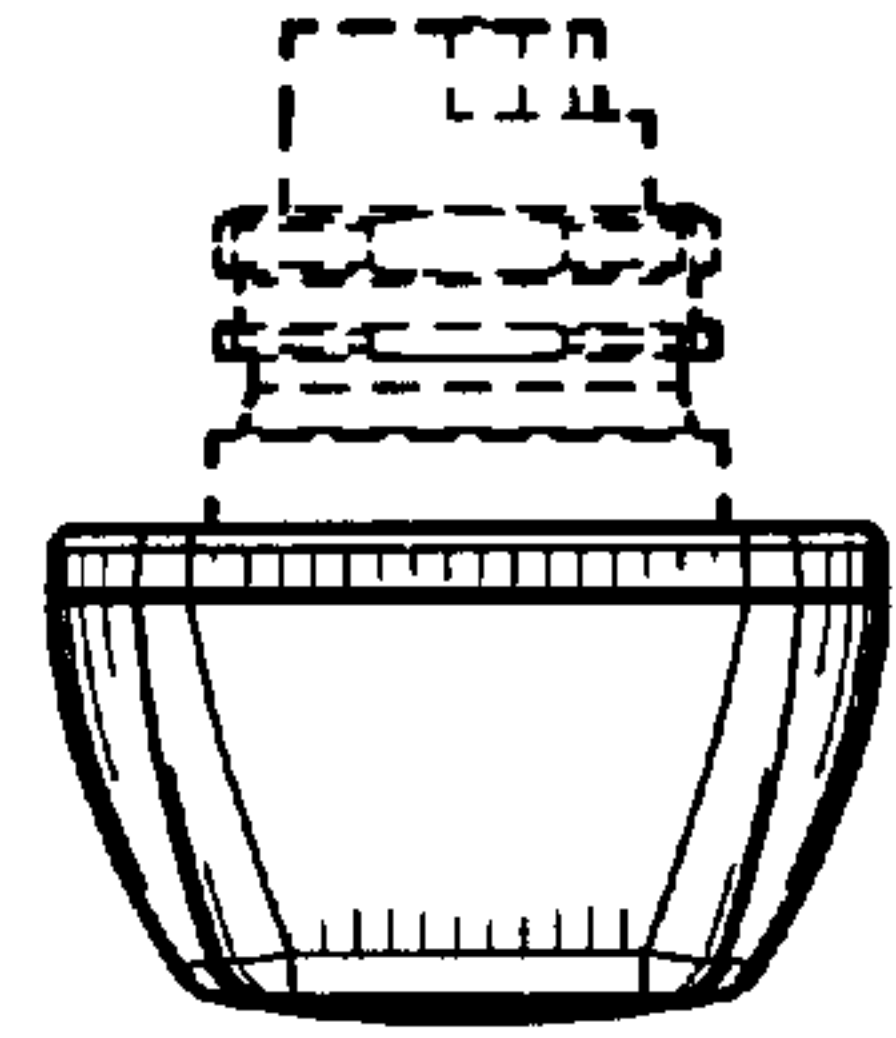

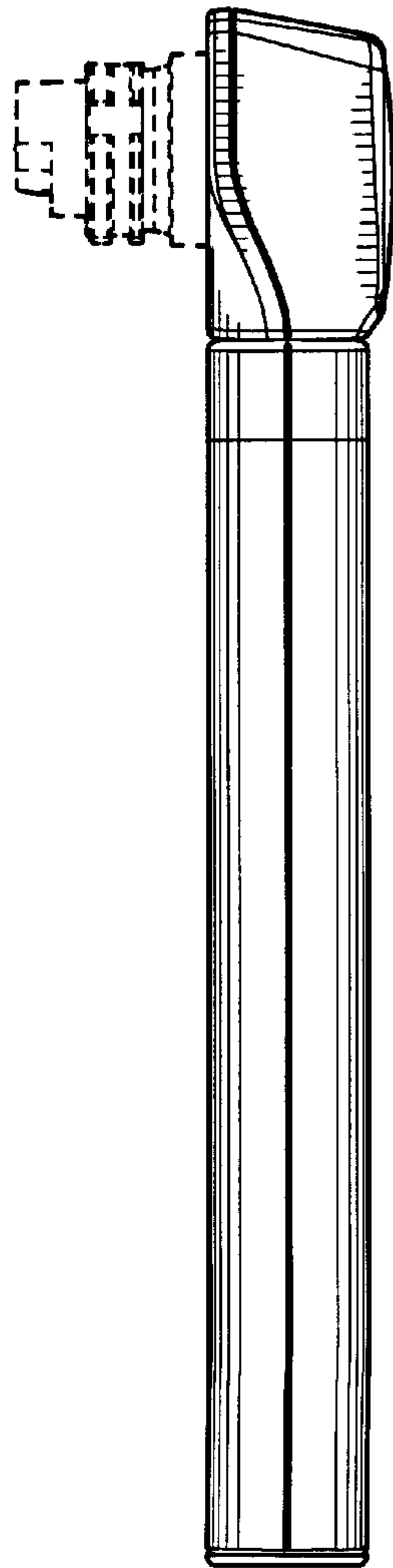

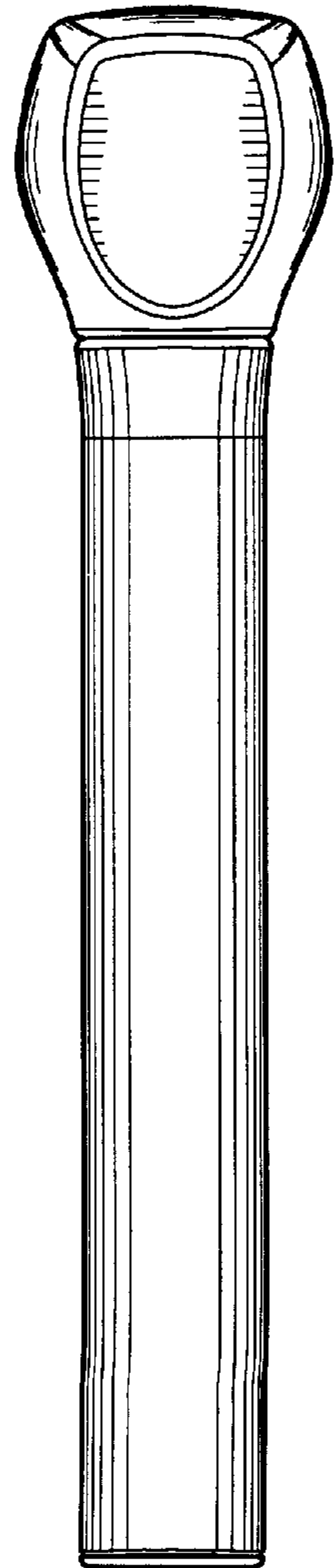
