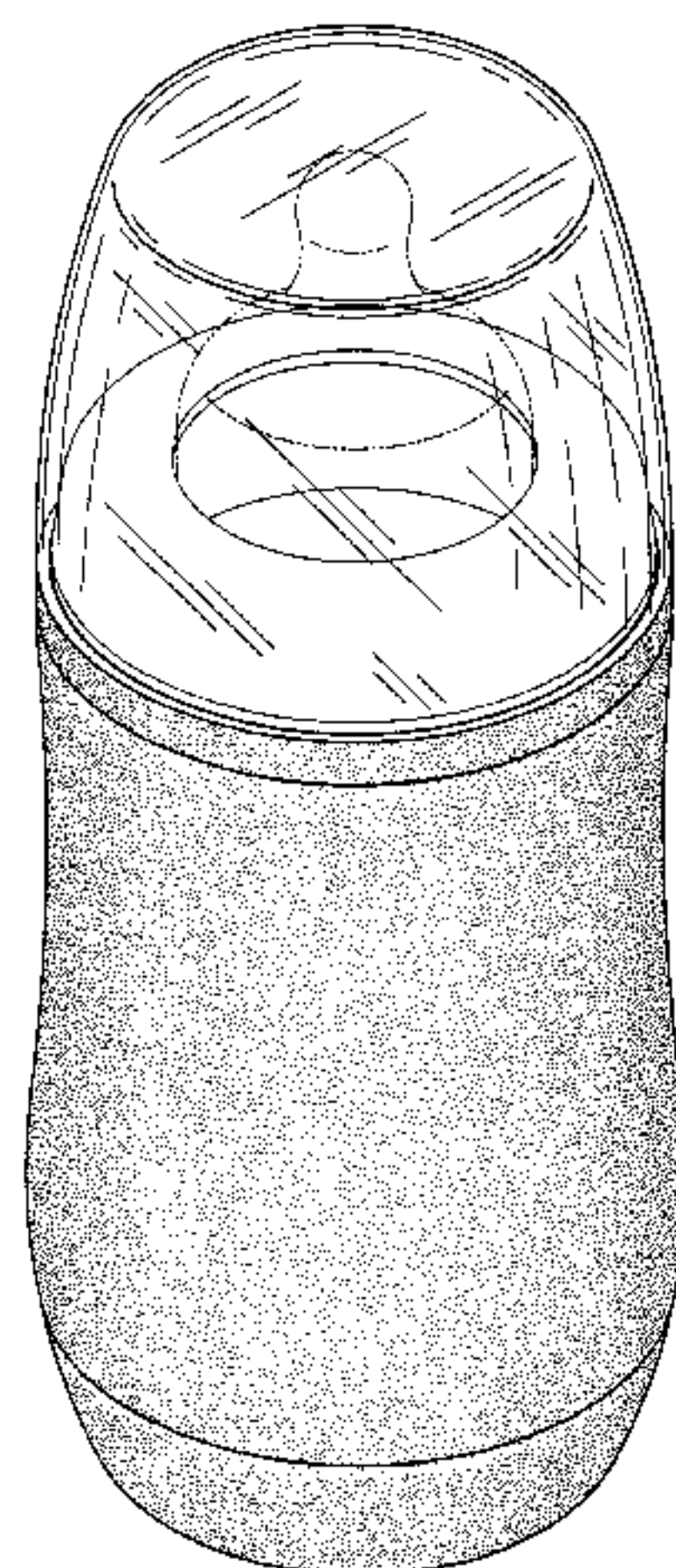
### [57] CLAIM

The ornamental design for a baby bottle, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a baby bottle showing our new design;  
FIG. 2 is an exploded perspective view of the baby bottle of FIG. 1 showing the cap removed;  
FIG. 3 is a front view of the baby bottle of FIG. 1;  
FIG. 4 is a top view of the baby bottle of FIG. 1;  
FIG. 5 is the top view of the baby bottle of FIG. 1 with the cap removed;  
FIG. 6 is a bottom view of the baby bottle of FIG. 1;  
FIG. 7 is a perspective view of a shorter version of the baby bottle of FIG. 1; and,  
FIG. 8 is a front view of the baby bottle of FIG. 7, the top views of which, with and without the cap, and the bottom view of which are identical to the views respectively shown in FIGS. 4, 5 and 6.

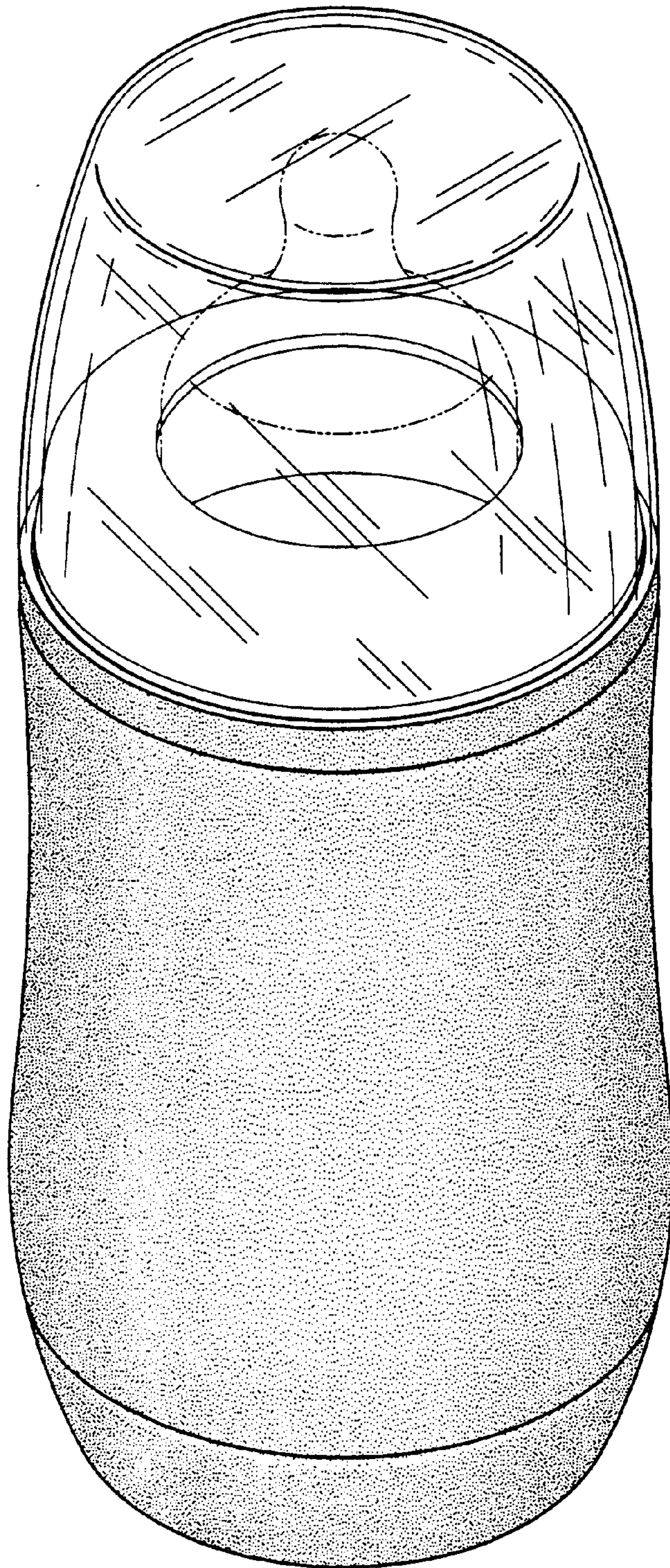

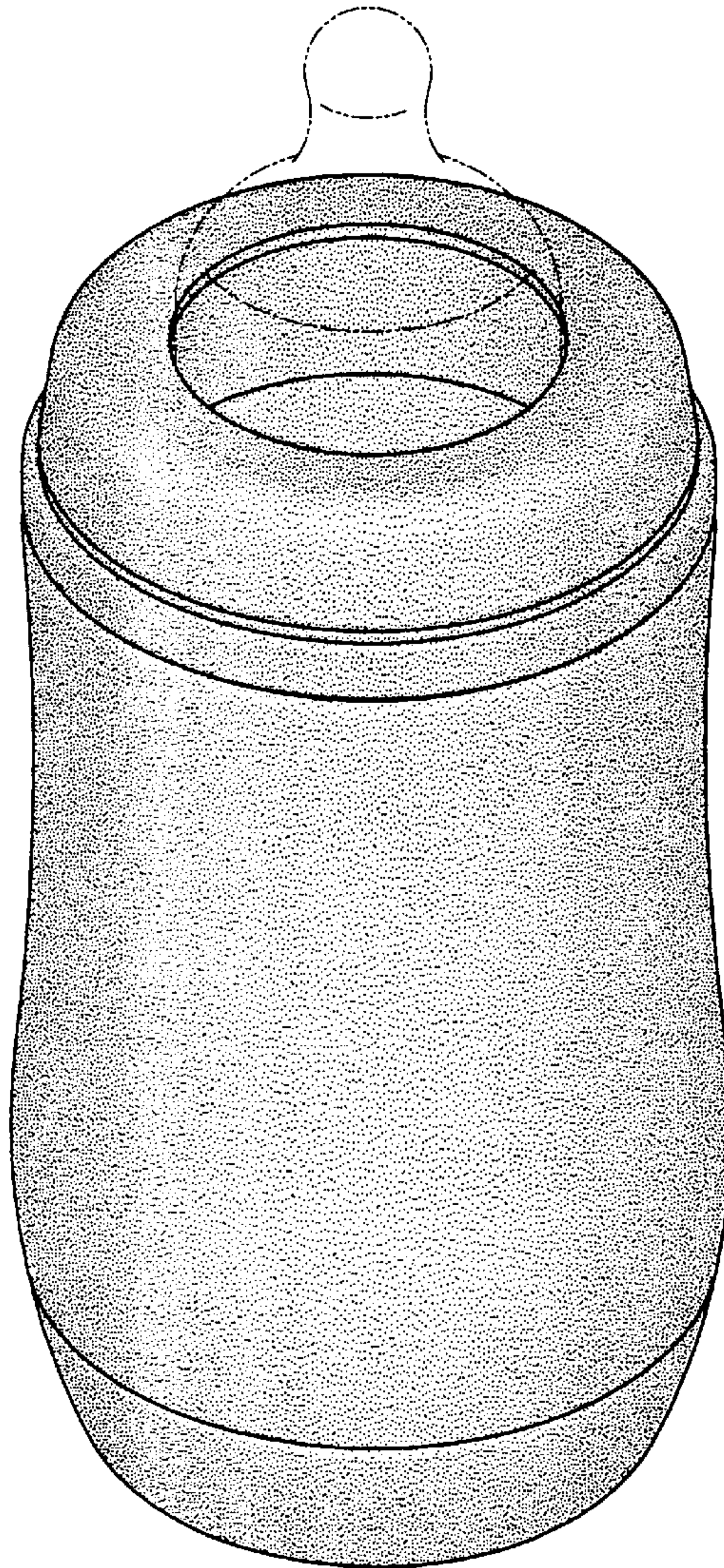
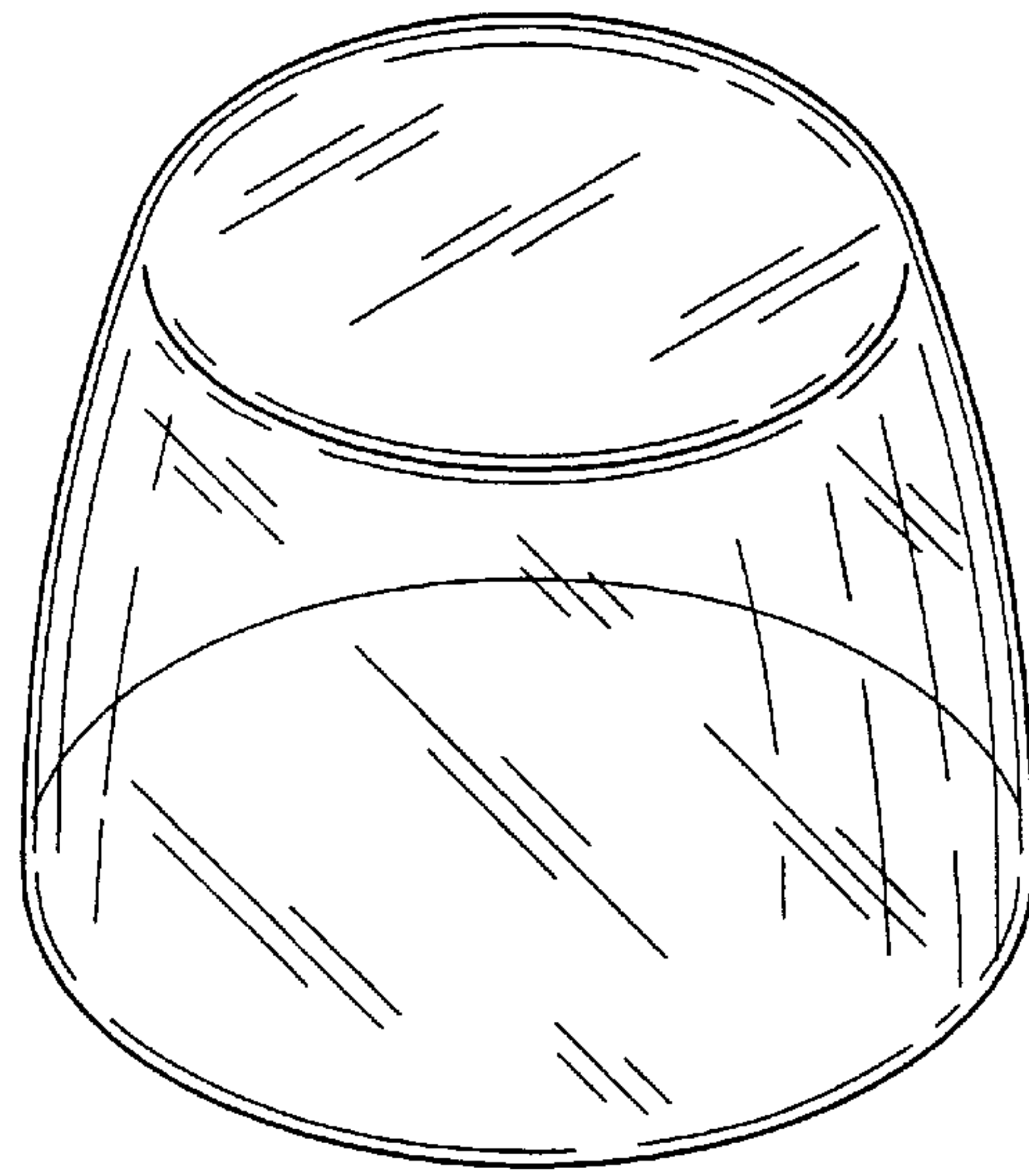




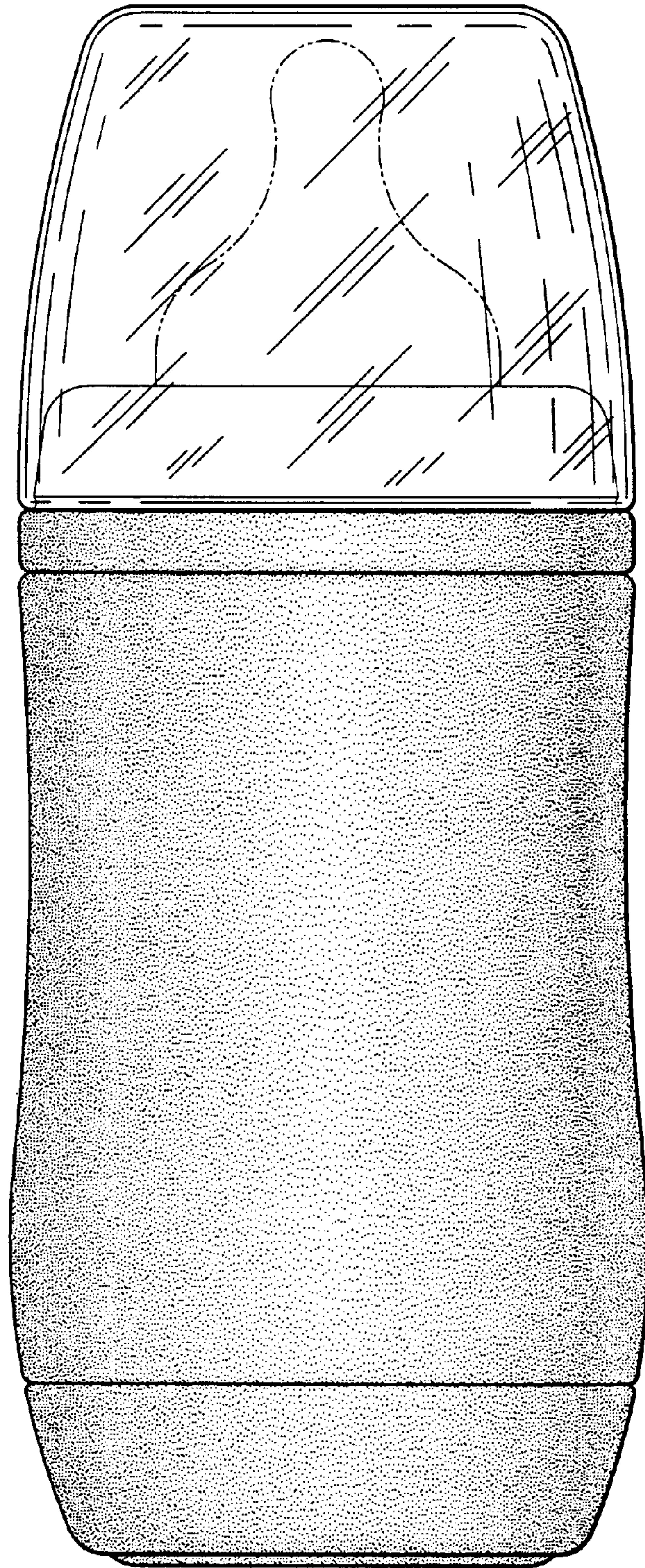

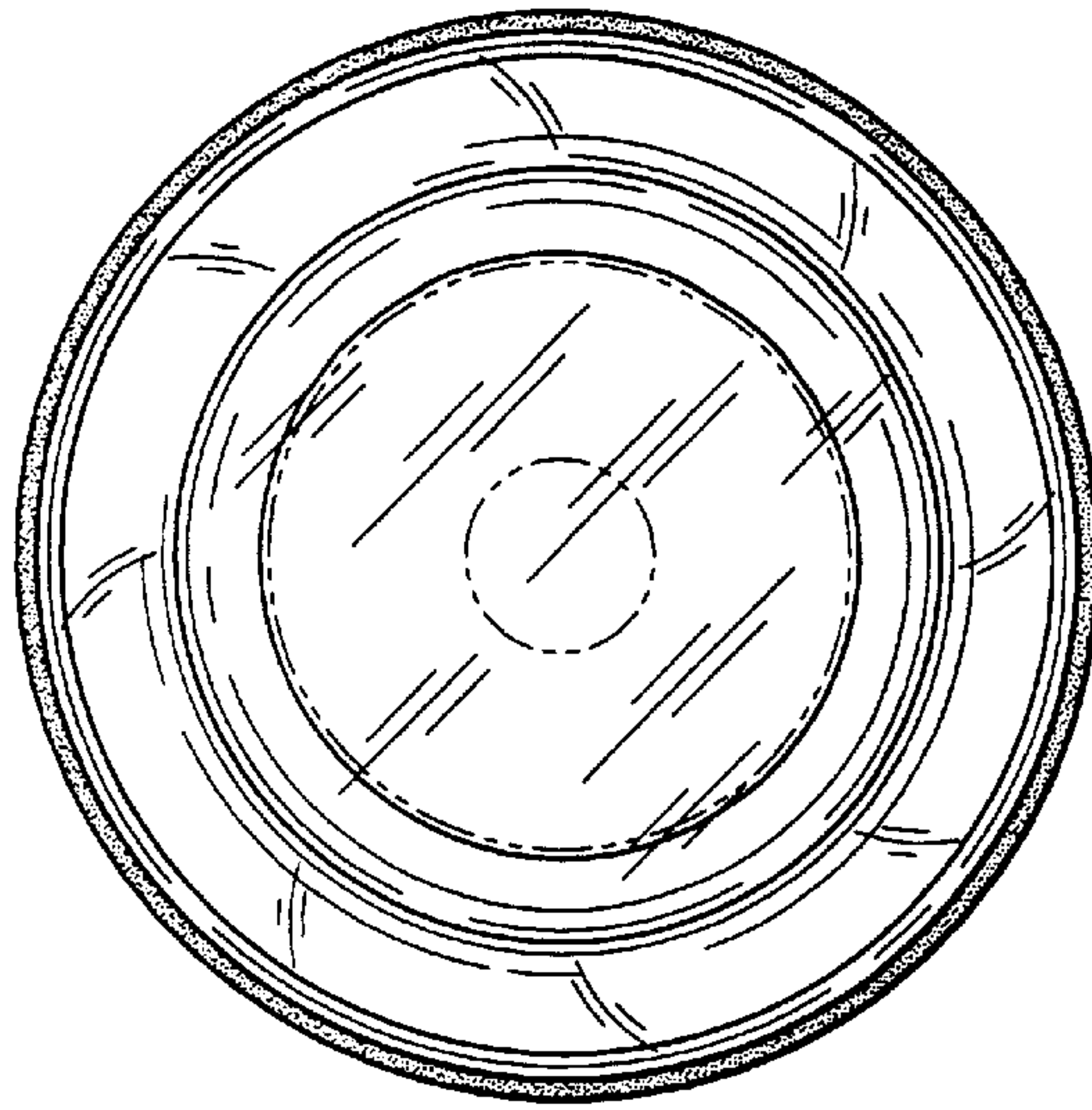




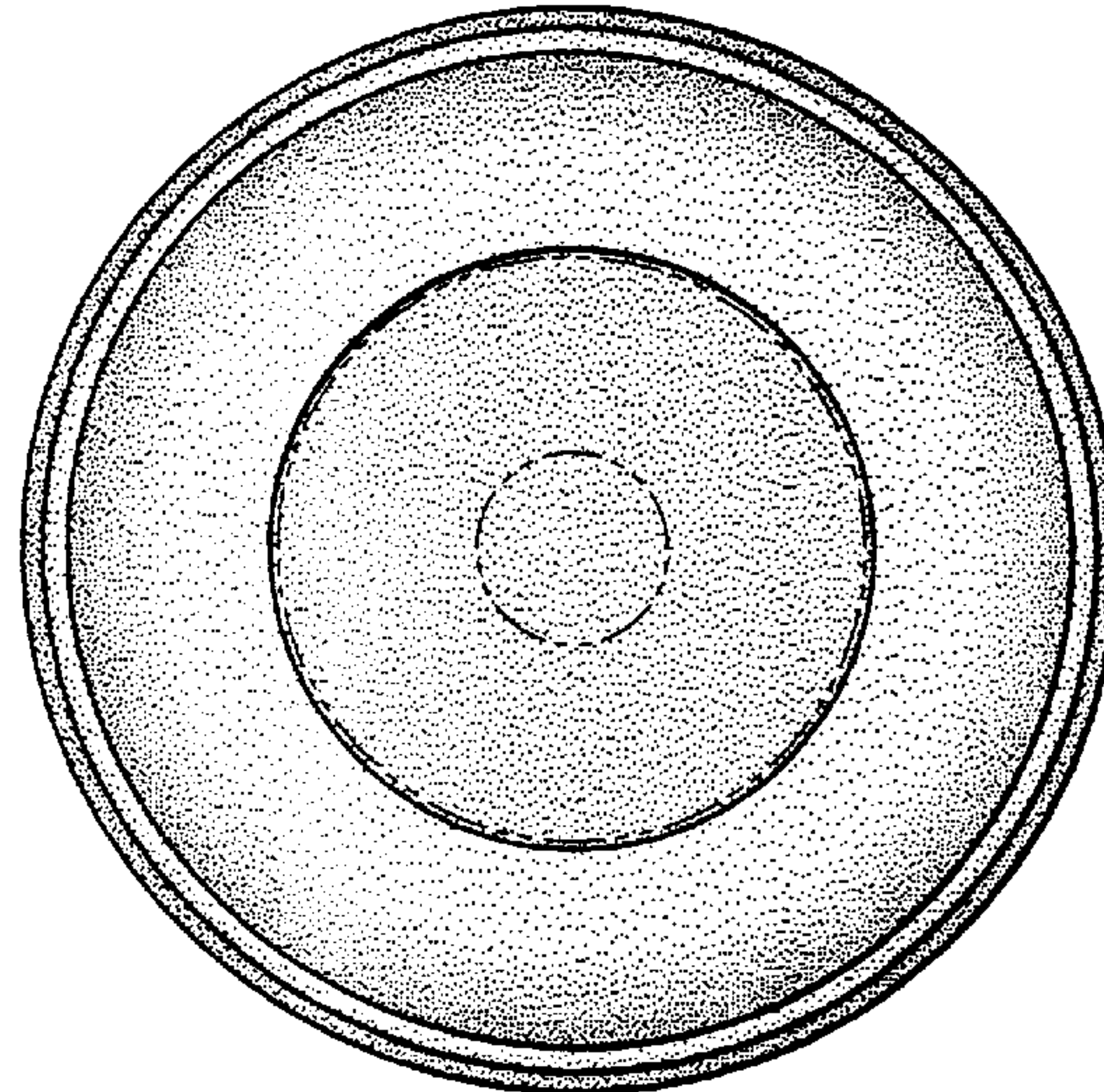

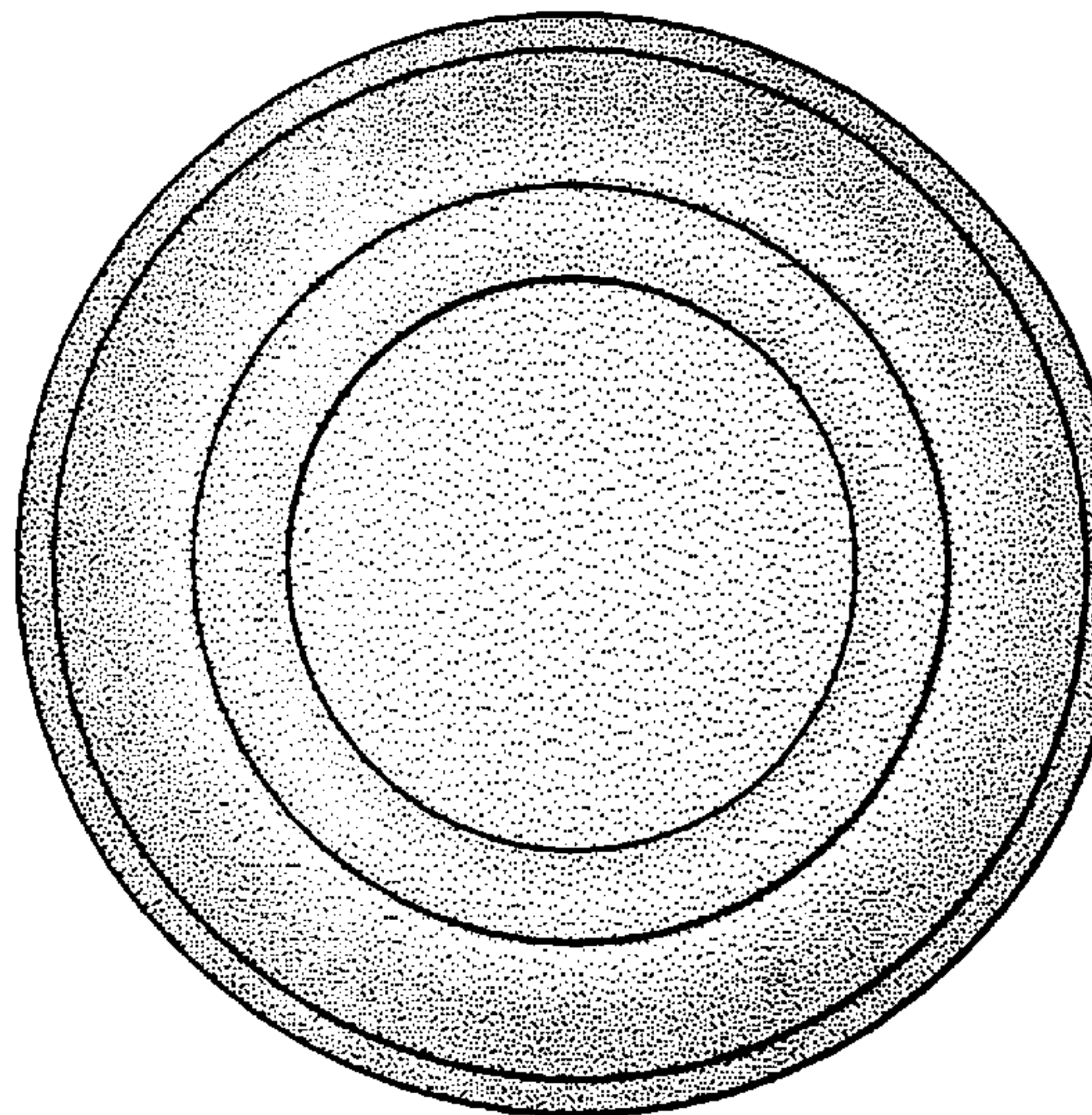

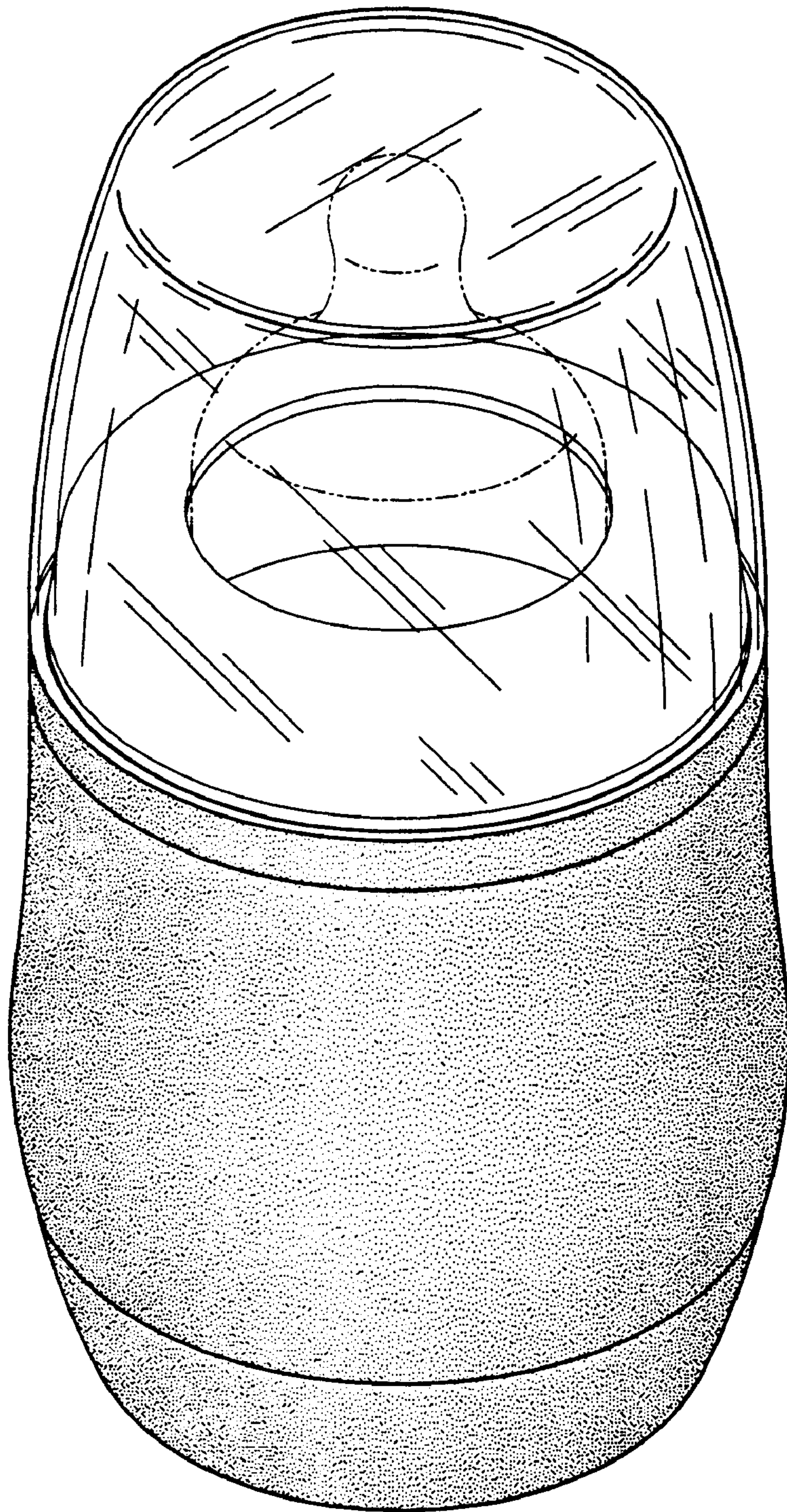

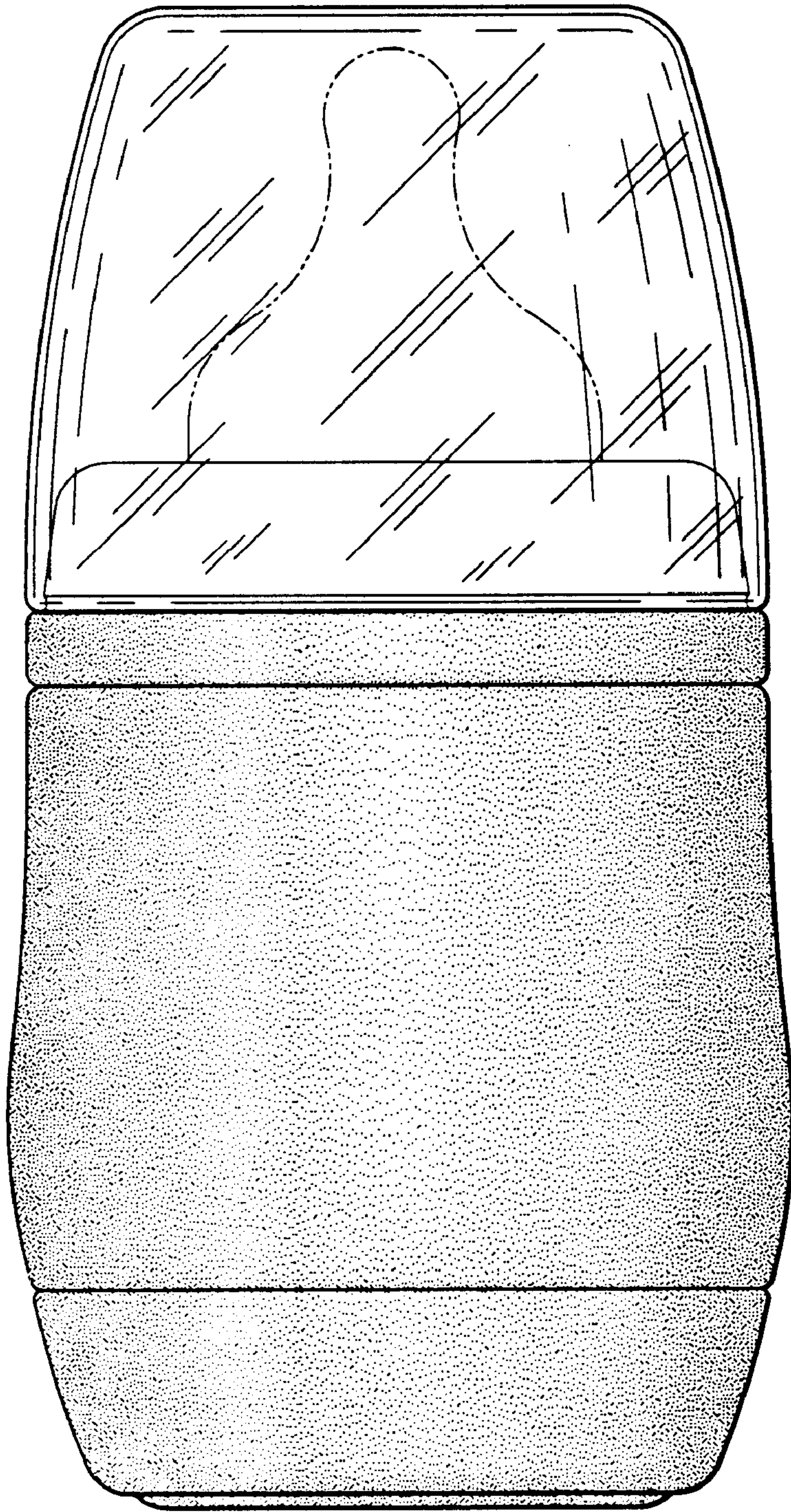
