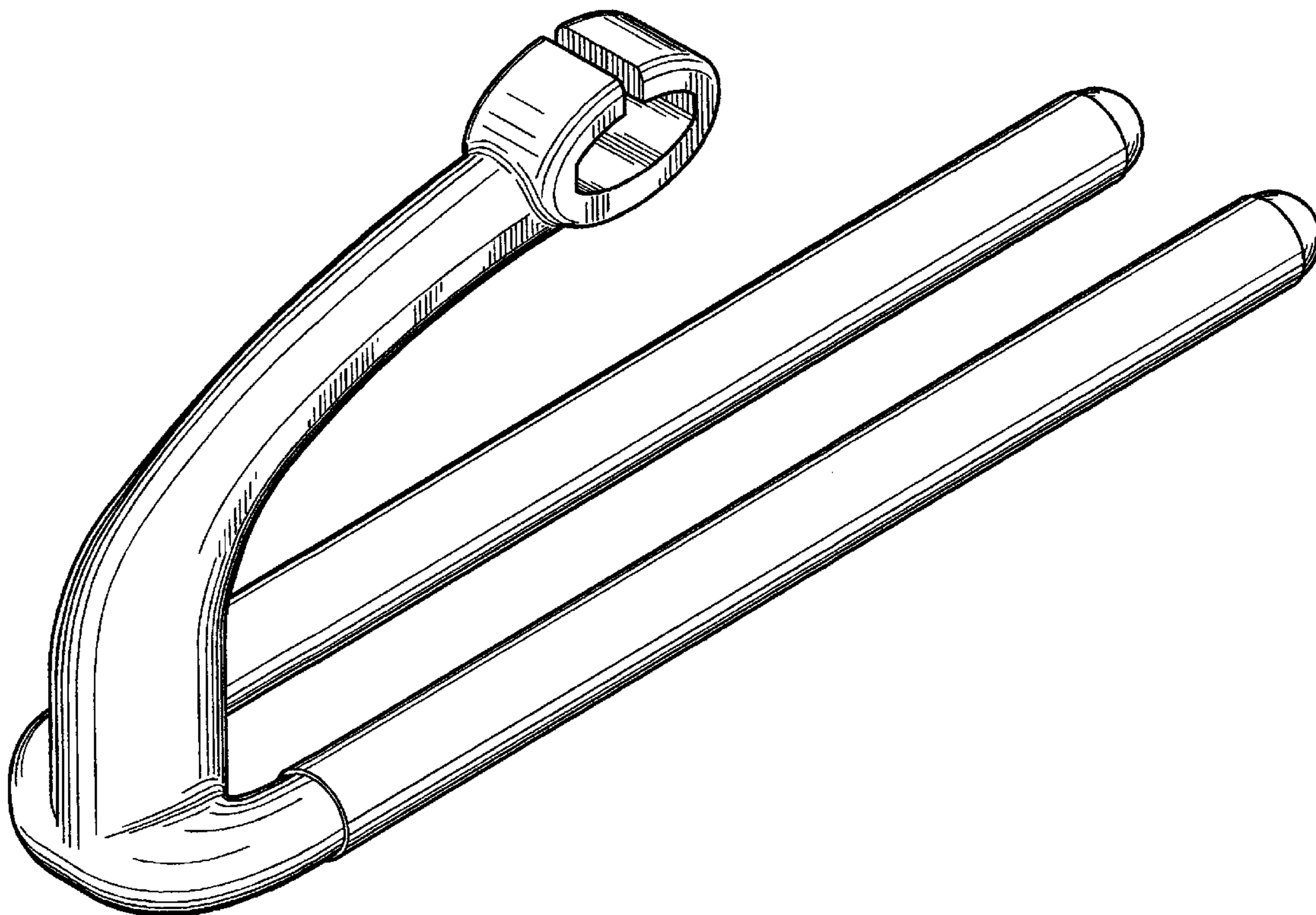
[57] **CLAIM**

The ornamental design for a pants hanger, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a pants hanger showing our new design.
FIG. 2 is a front elevational view of a pants hanger showing our new design, the rear elevational view being a mirror image.
FIG. 3 is a top plan view of a pants hanger showing our new design.
FIG. 4 is a left side elevational view of a pants hanger showing our new design.
FIG. 5 is a right side elevational view of a pants hanger showing our new design; and,
FIG. 6 is a bottom plan view of a pants hanger showing our new design.

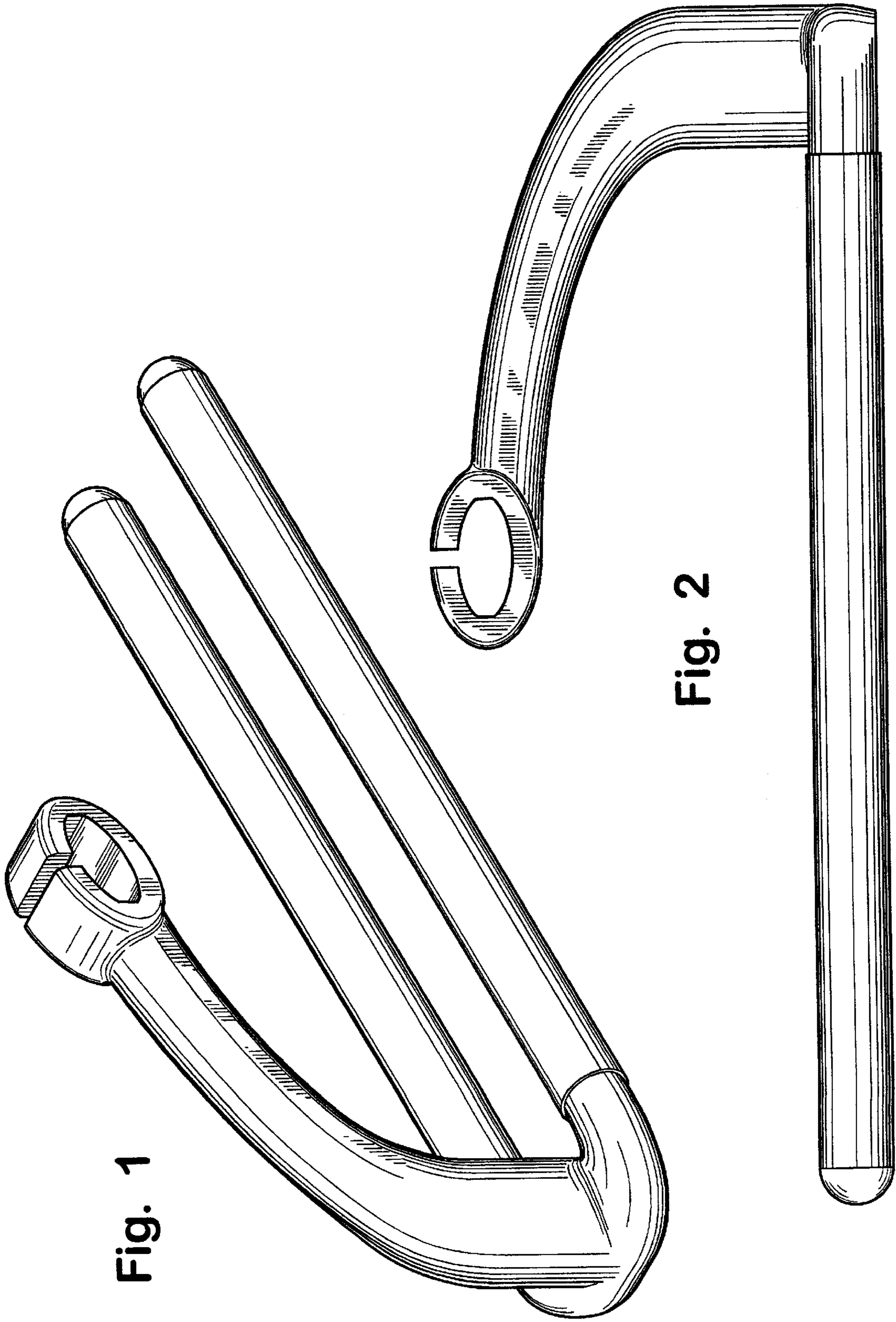

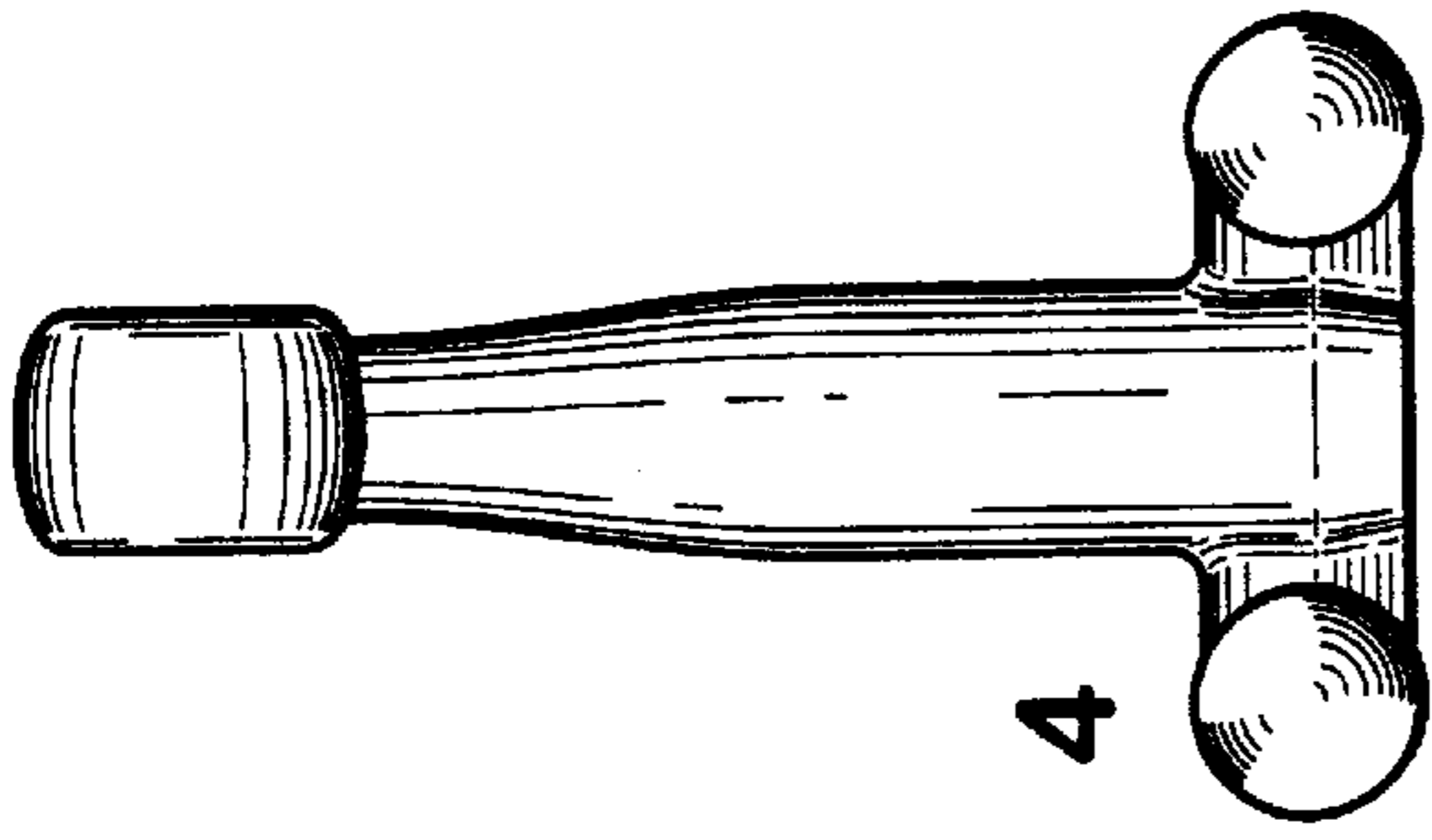

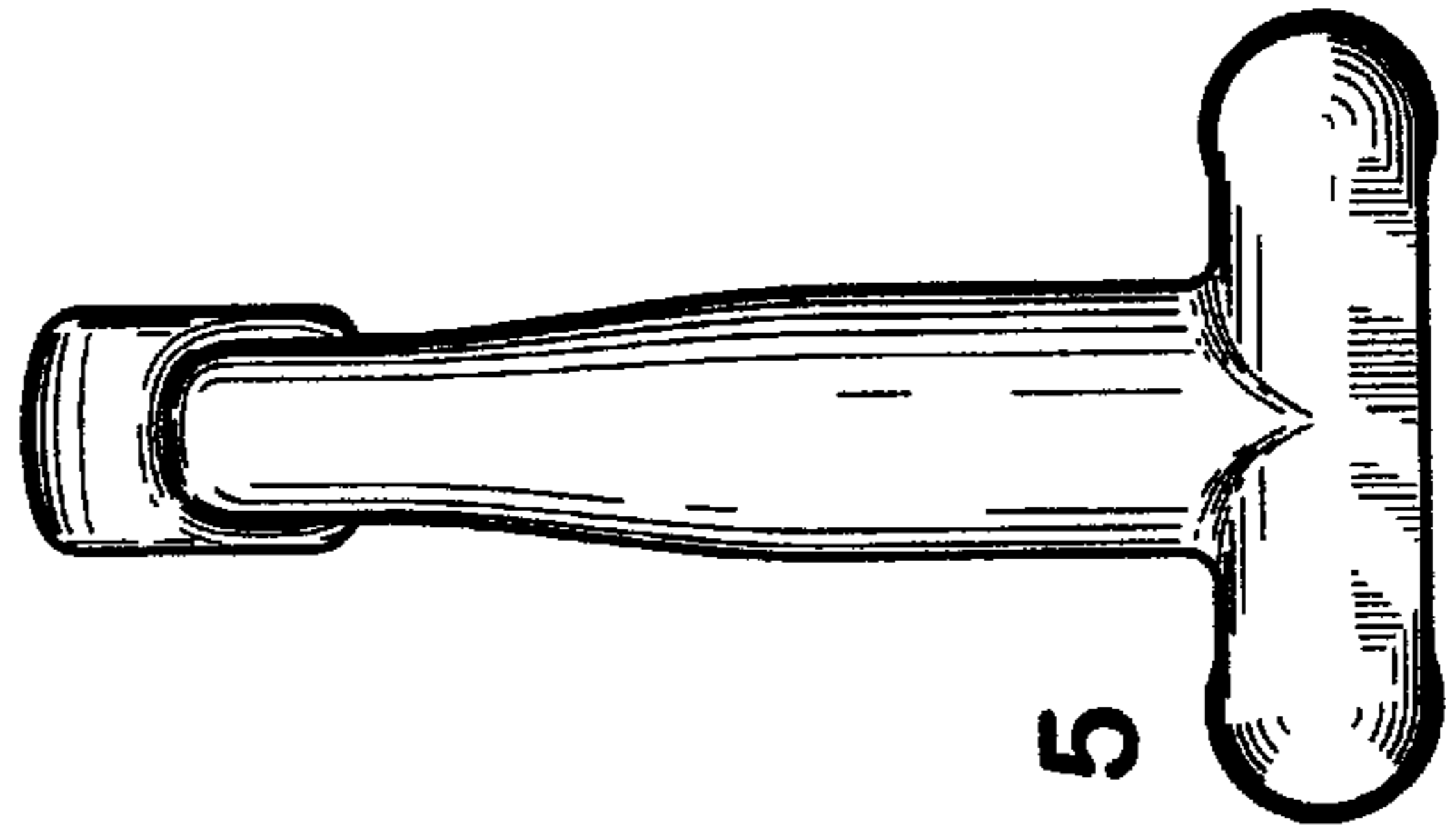

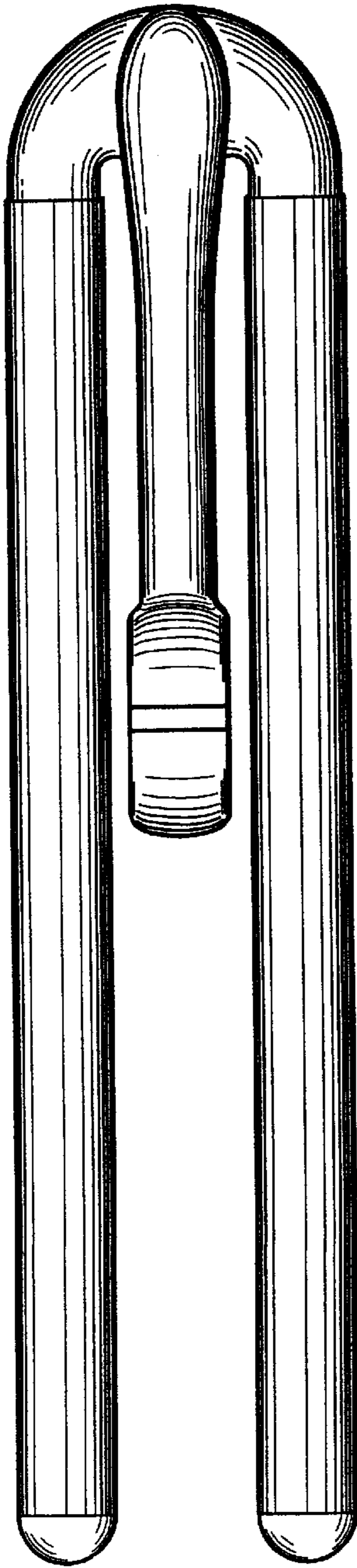

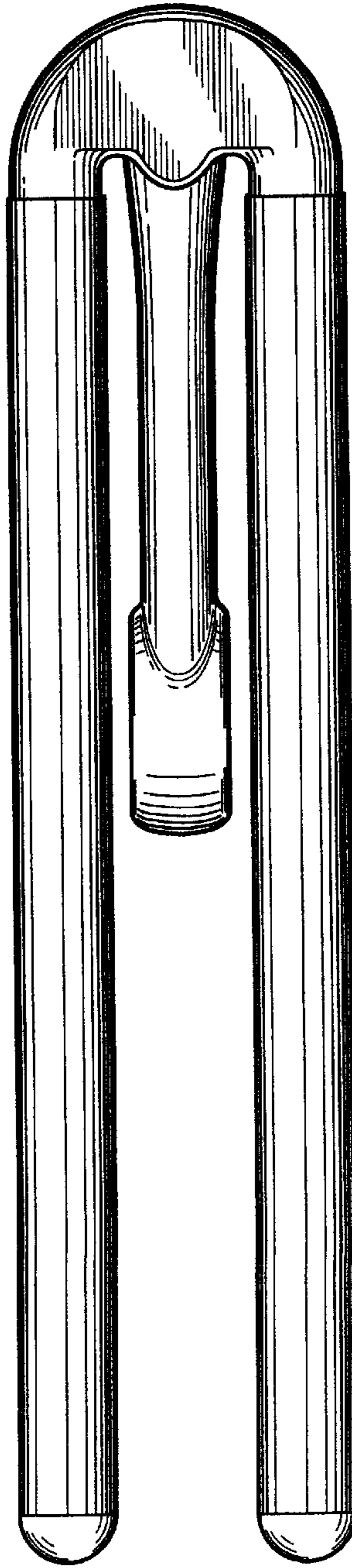
