### DESCRIPTION

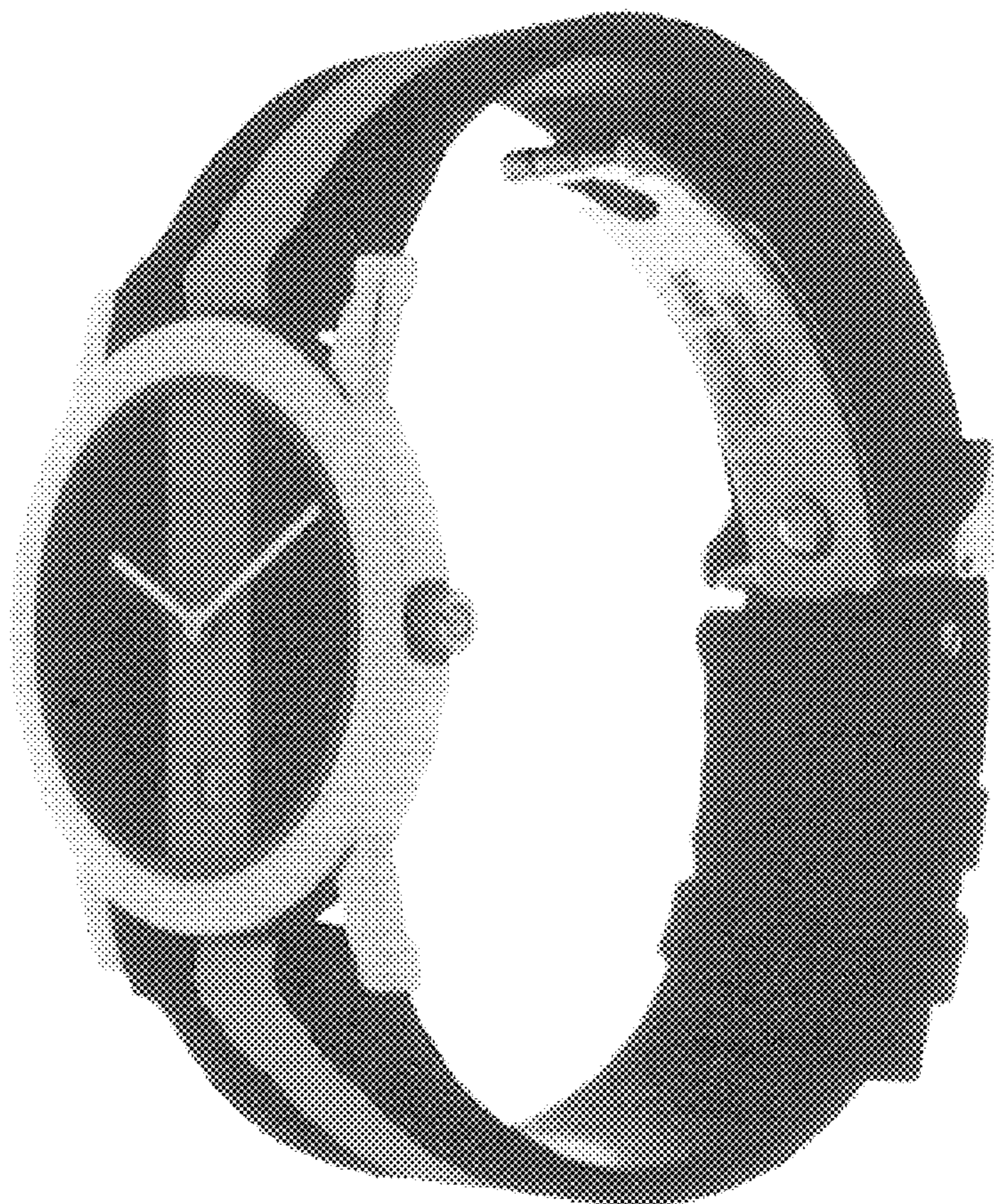

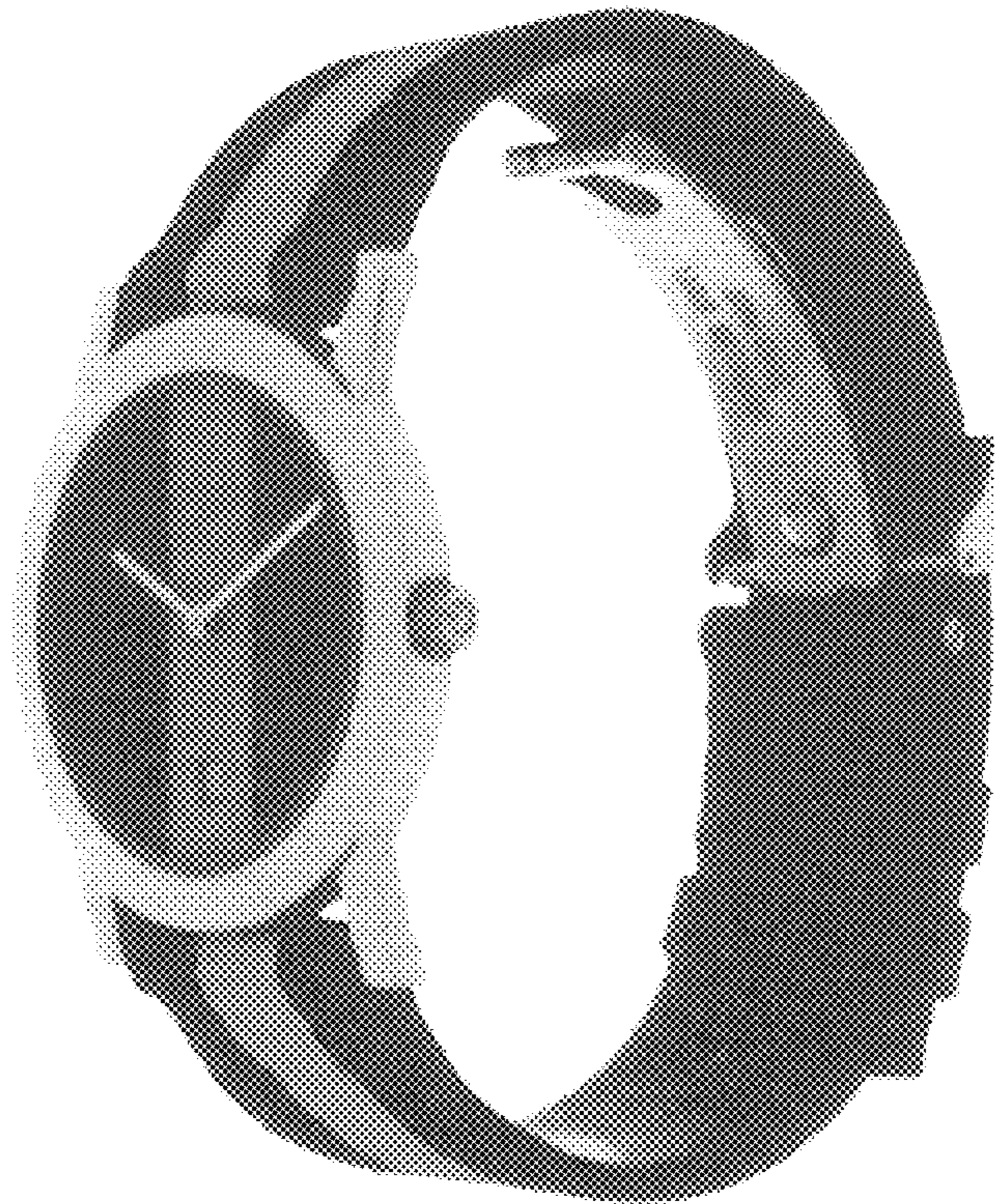

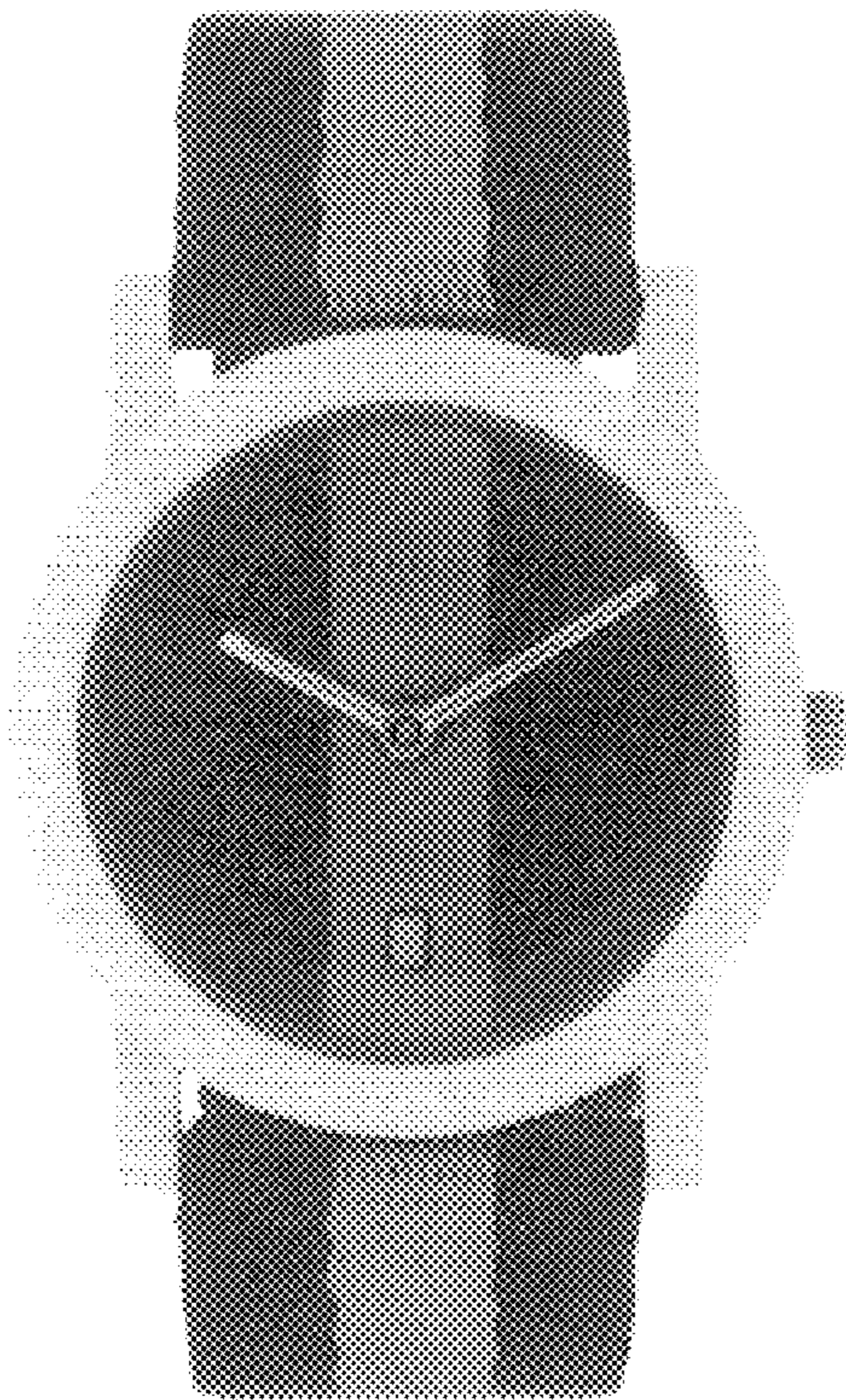

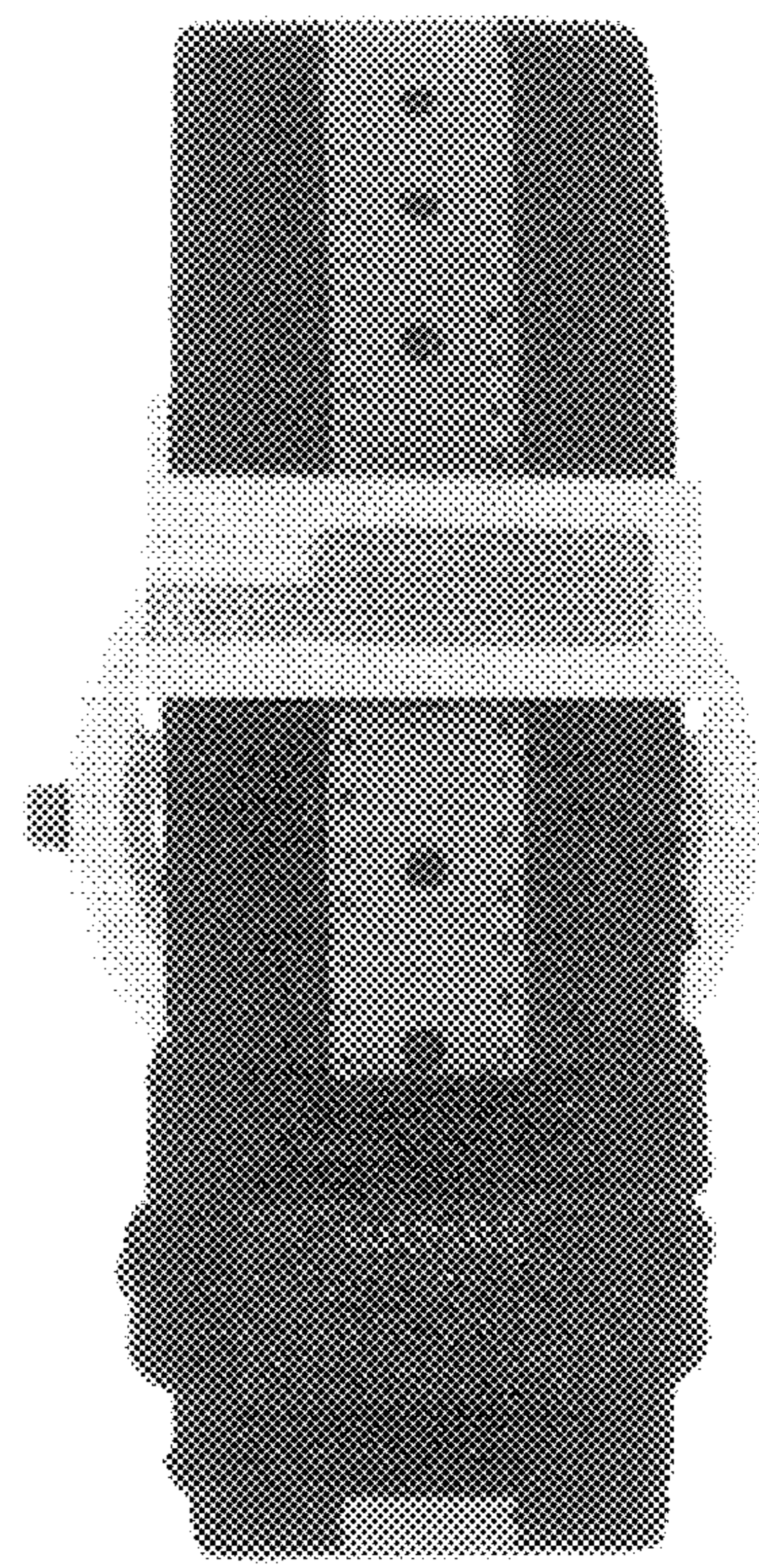

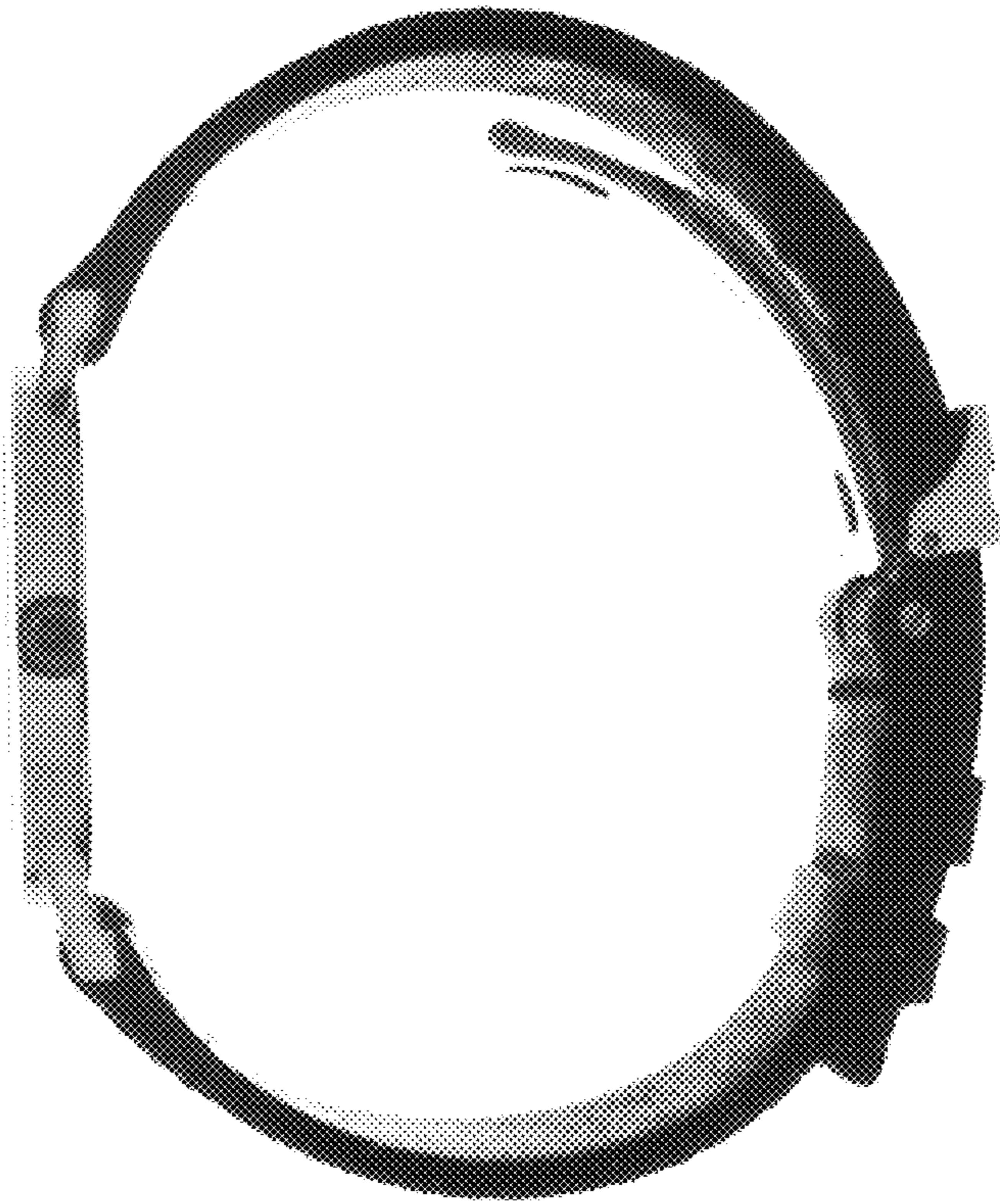

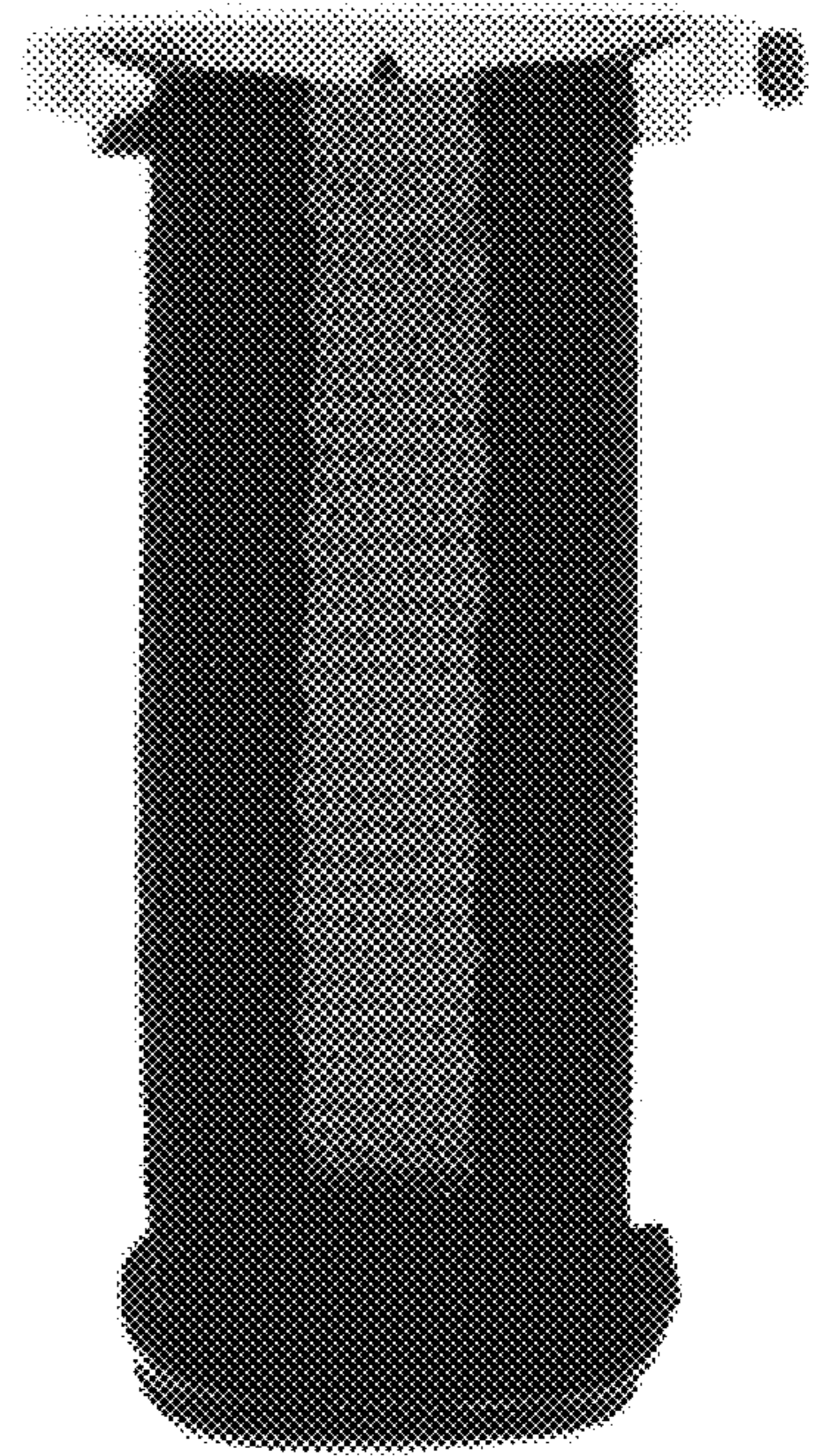

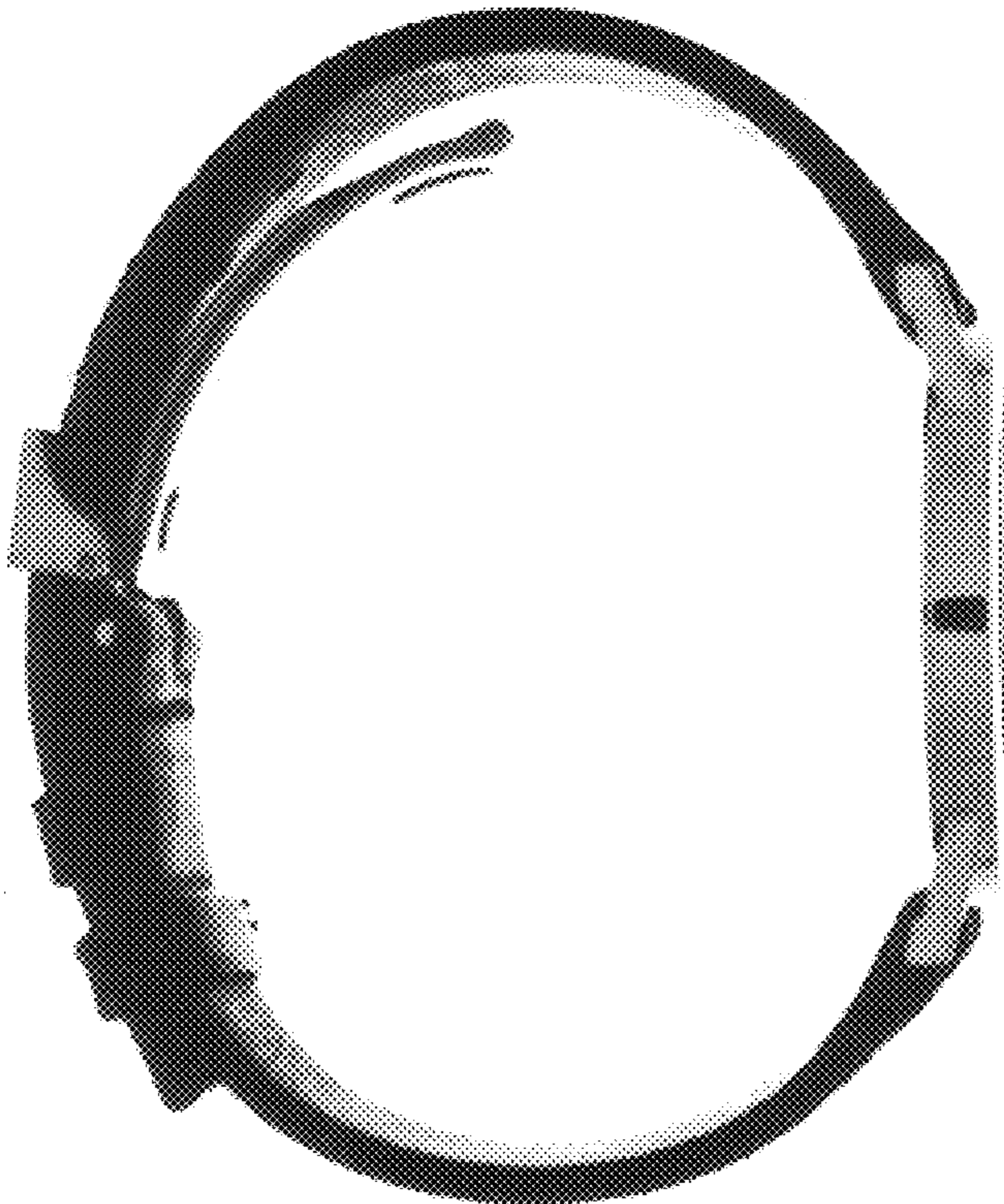
