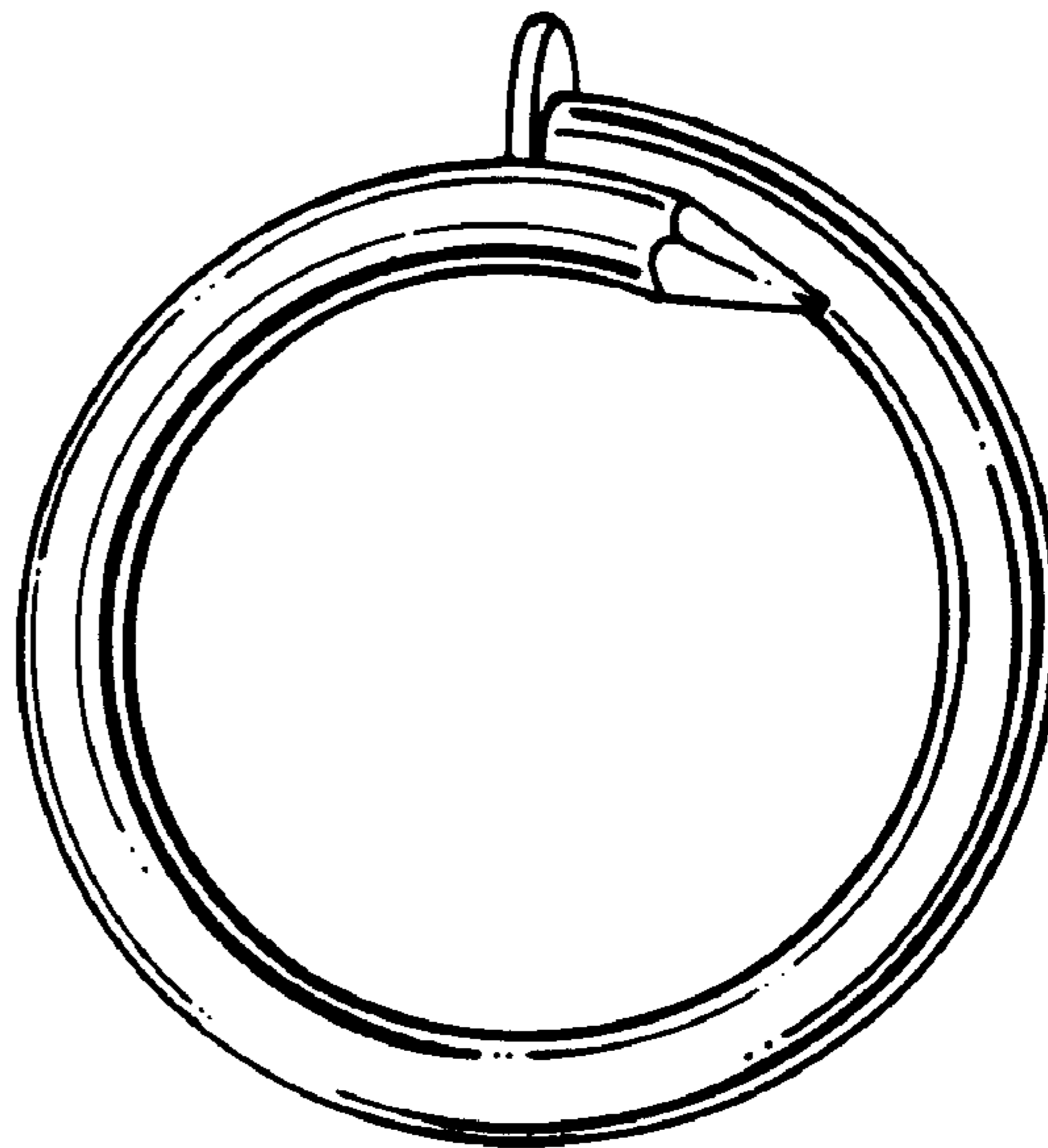
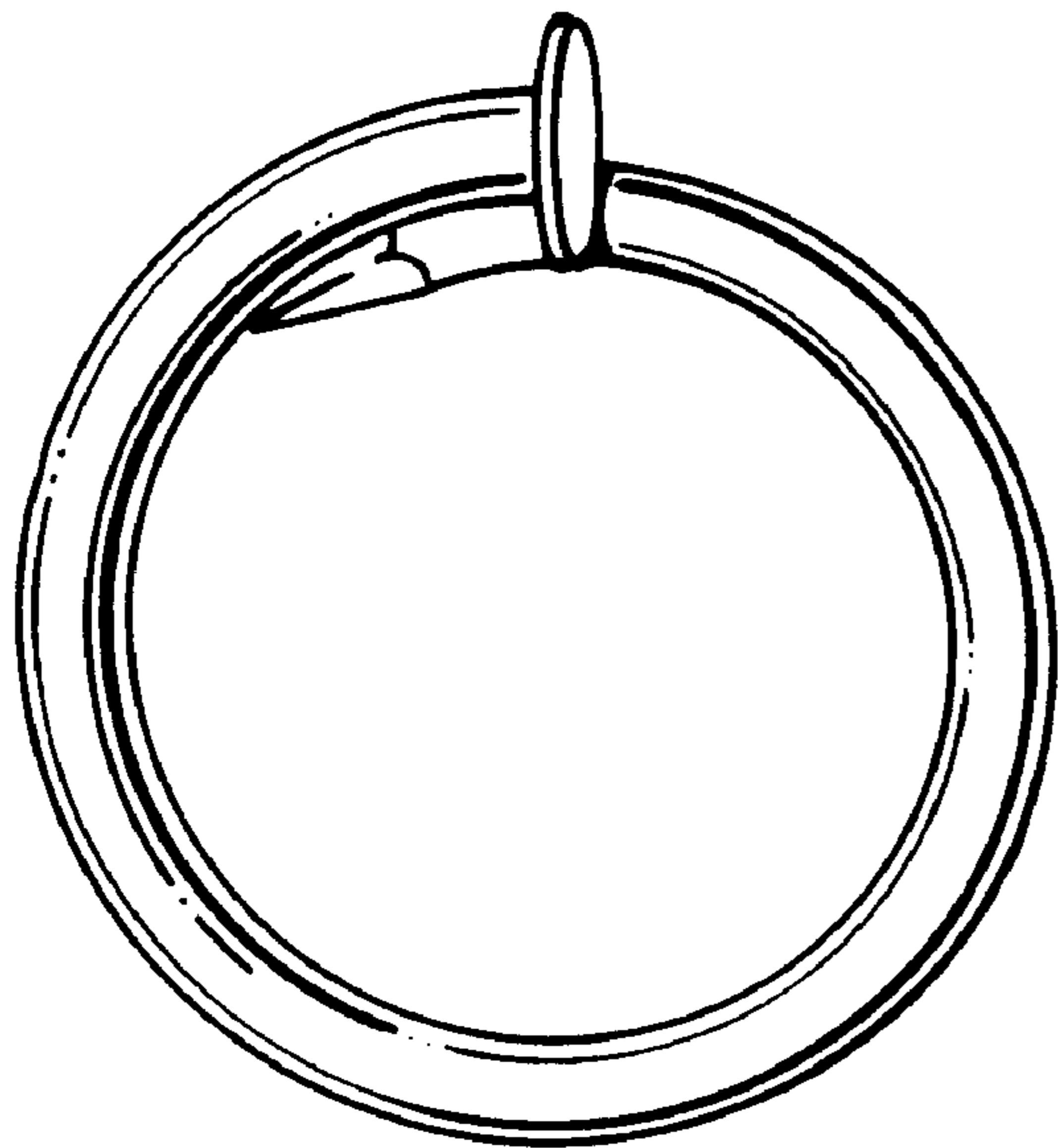
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the ornamental ring illustrating the inventors' concept;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a view taken from one side of the ring;
FIG. 4 is a view taken from the opposite side of FIG. 3; and,
FIG. 5 is an additional side view thereof.

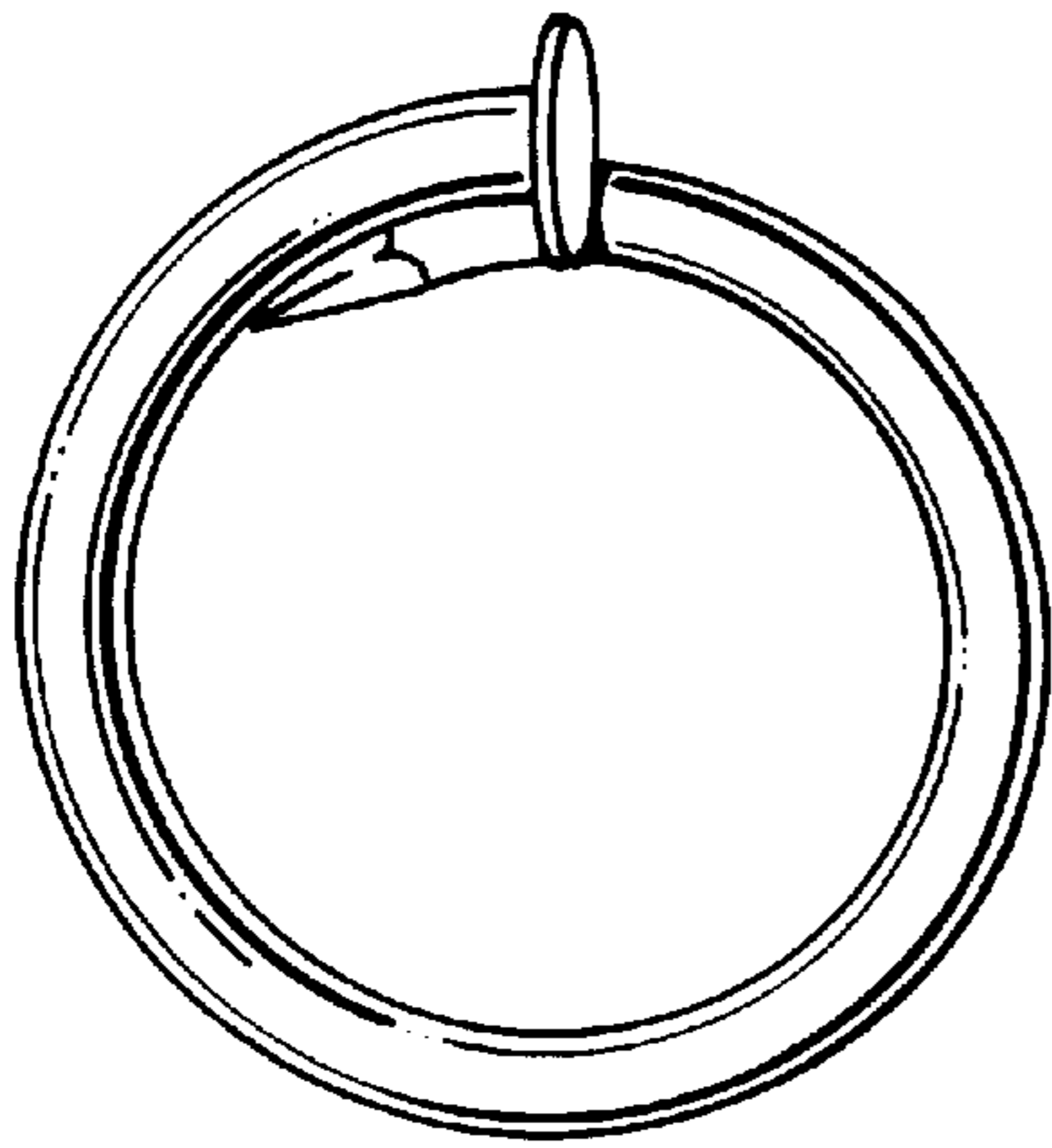

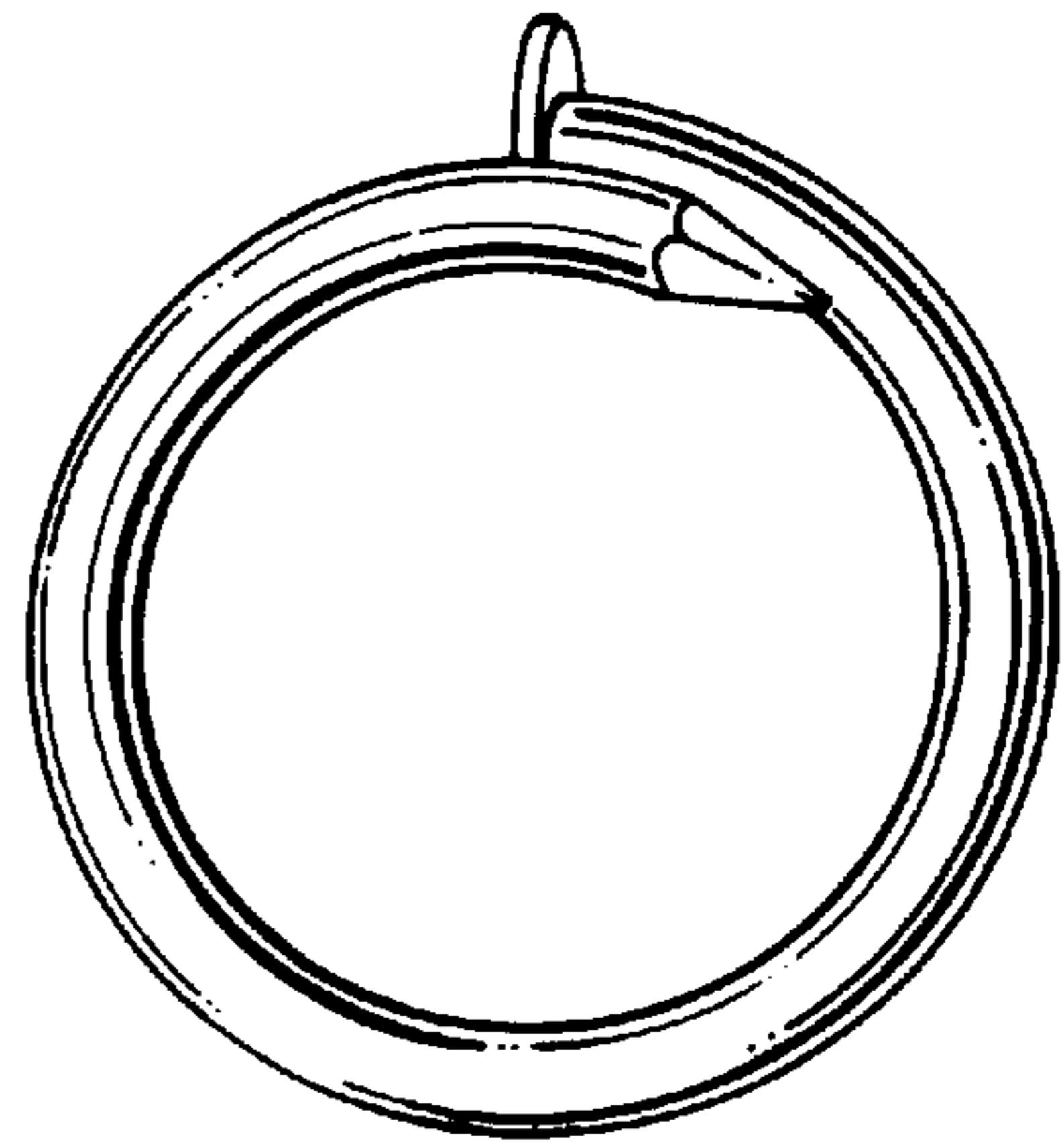

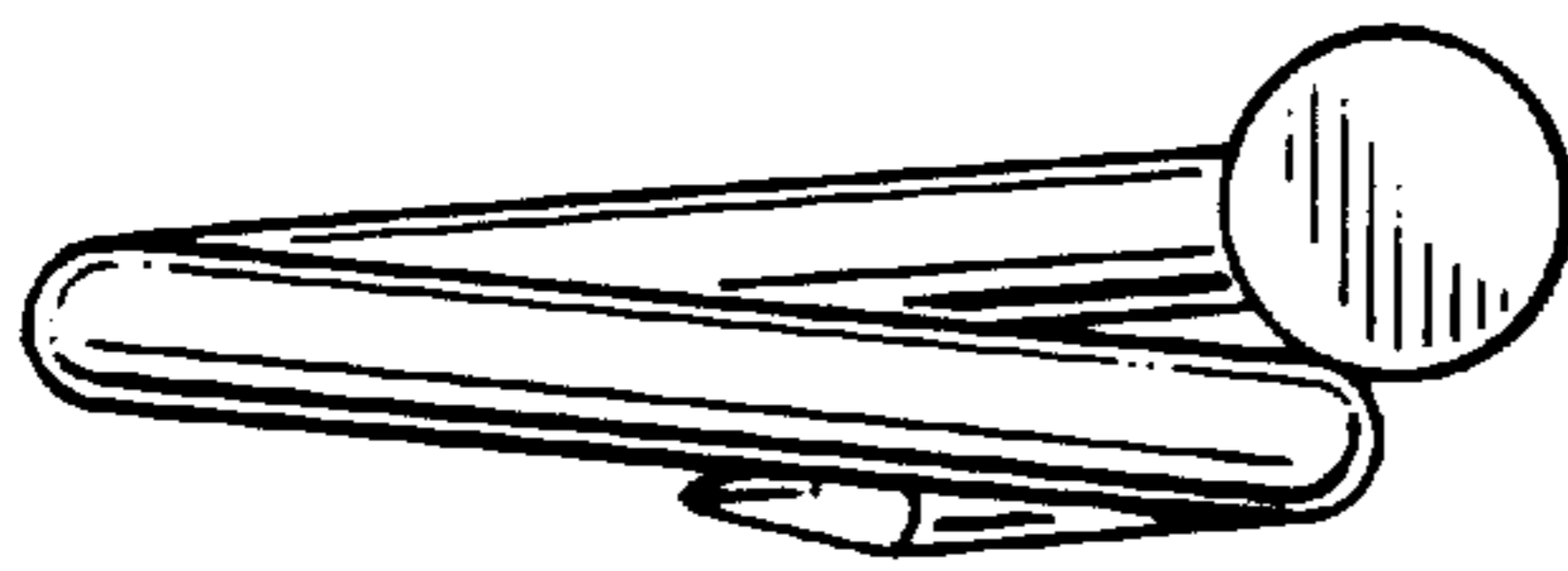

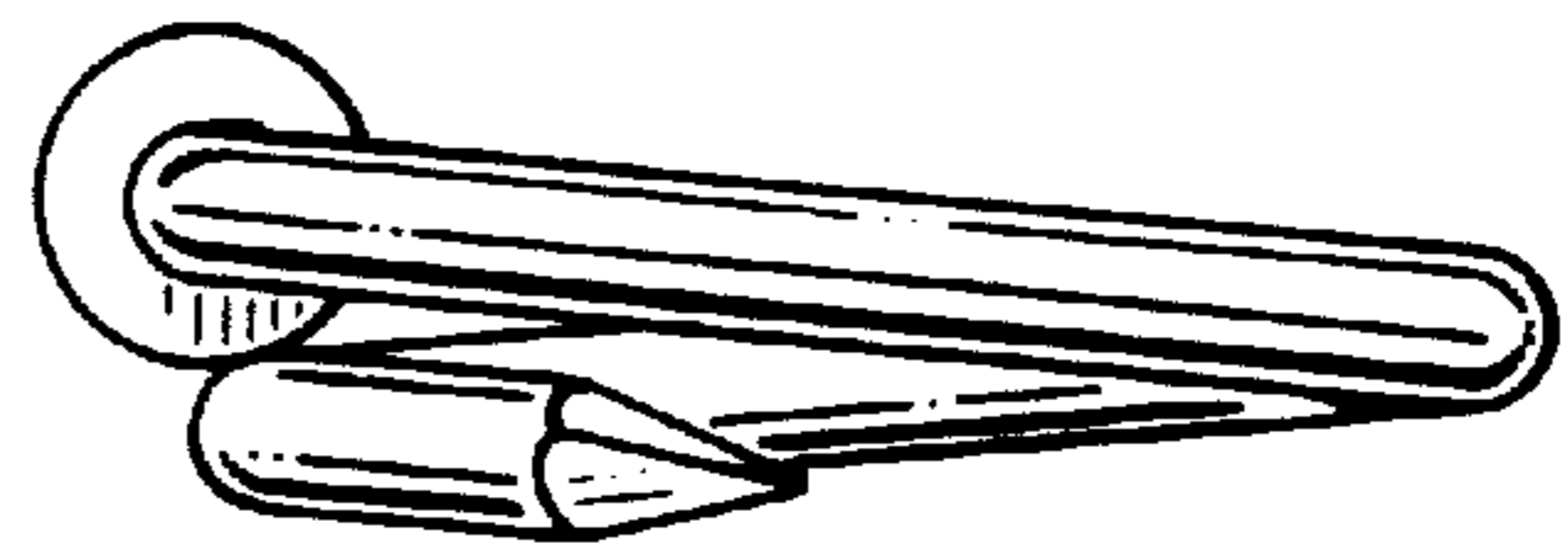

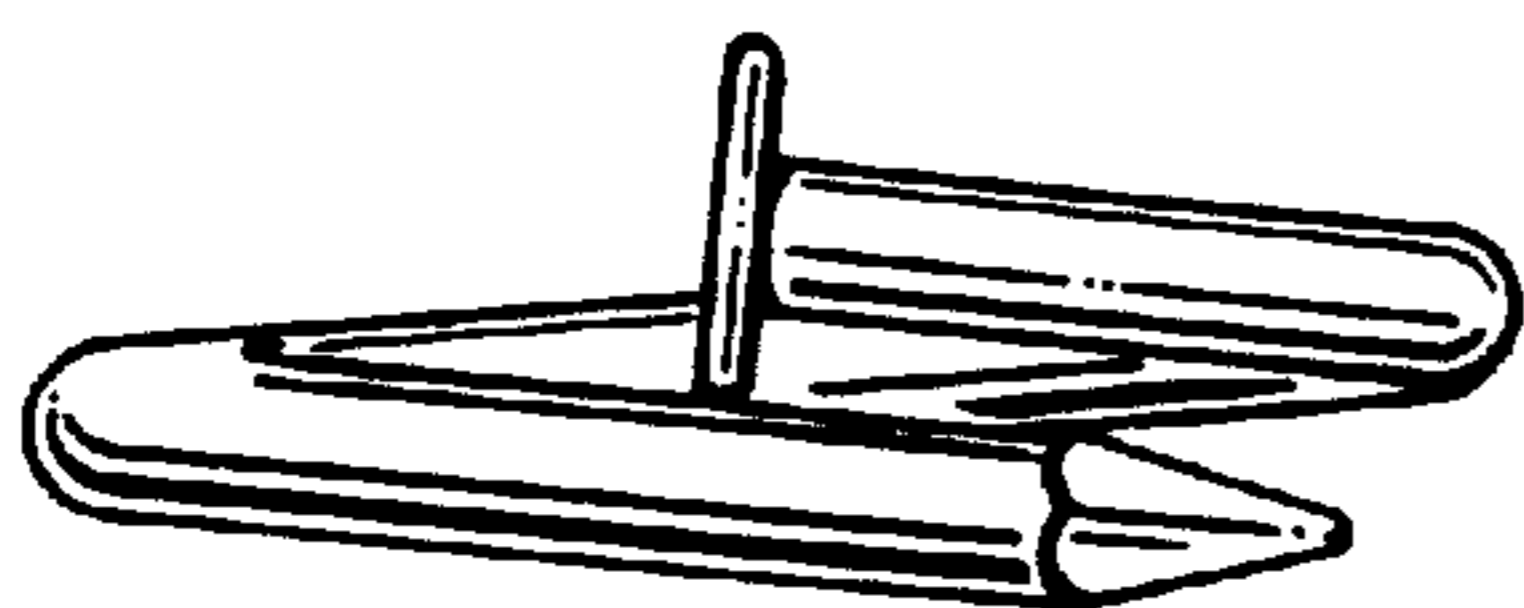
