The ornamental design for an eyeglass and hat connector, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design for an eyeglass and hat connector, with the portion shown in dotted lines being for illustrative purposes only; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a rear view thereof.

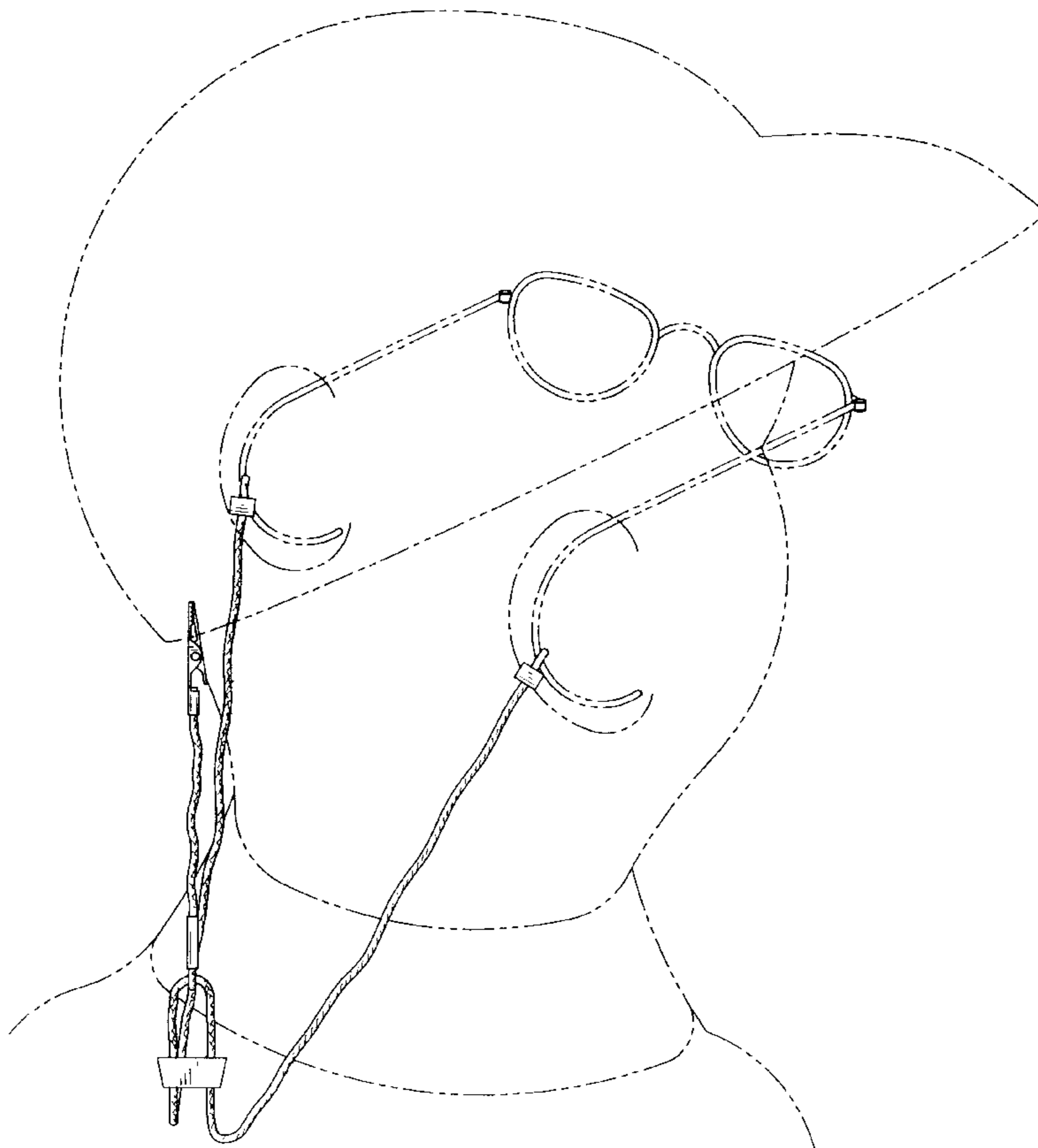

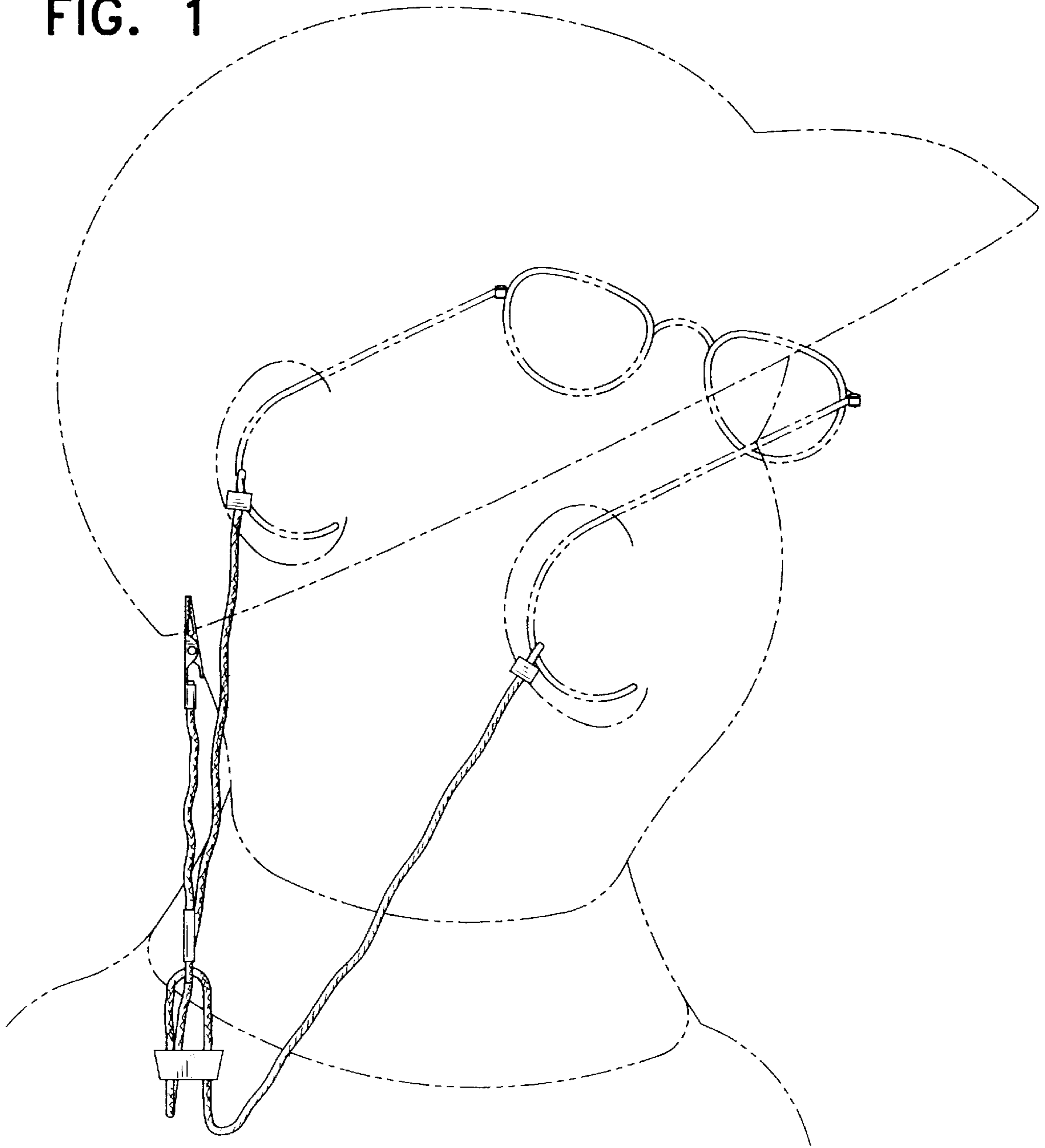

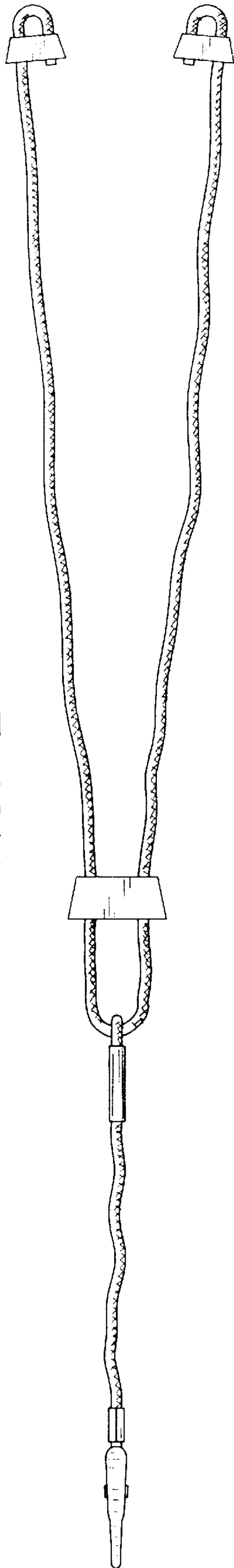

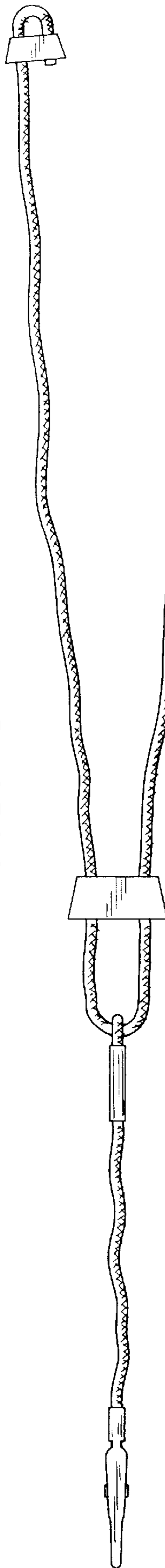
