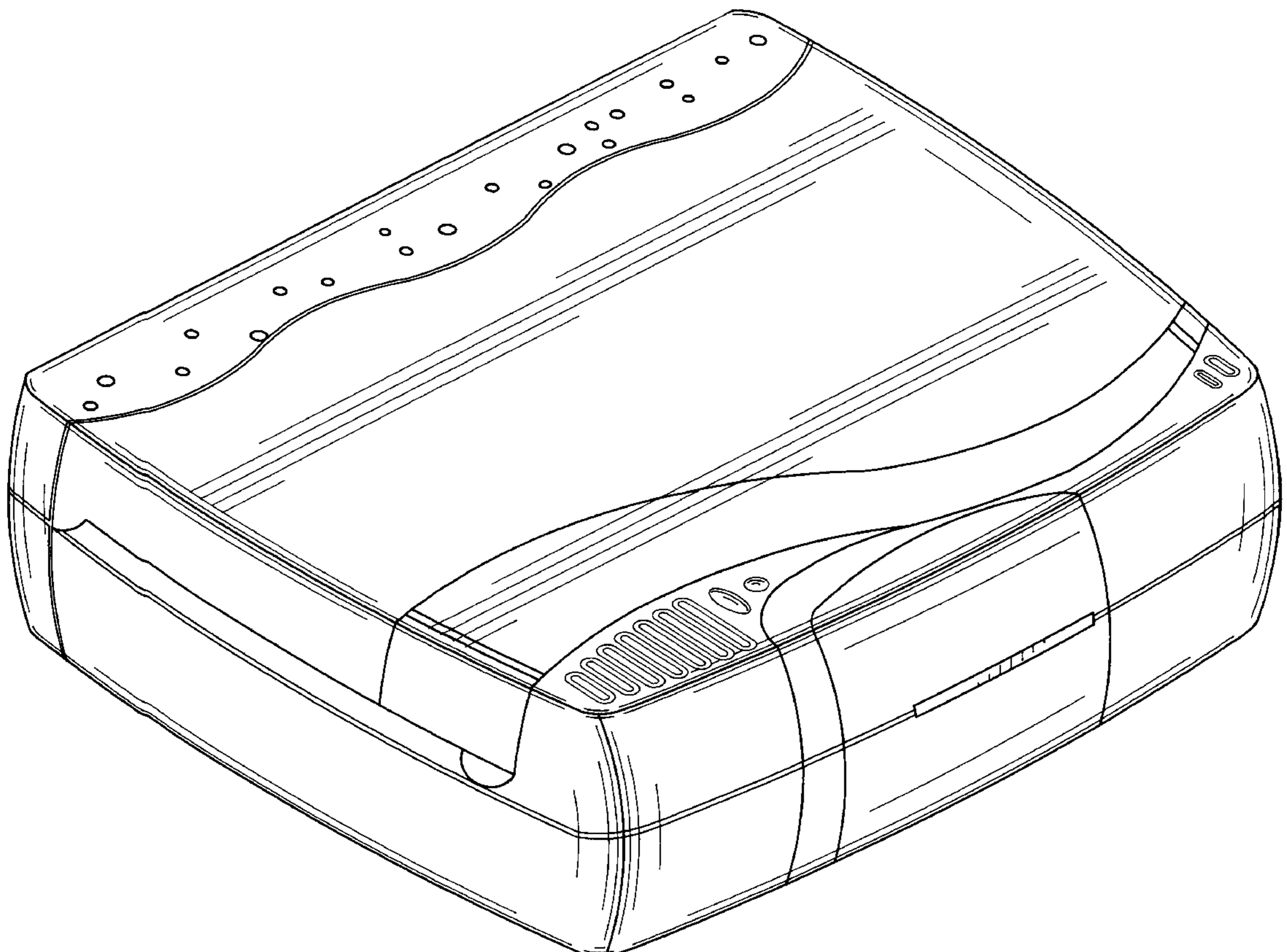
FIG. 4 is a left side elevational view of the hand held electronic game illustrated in FIGS. 1-3;

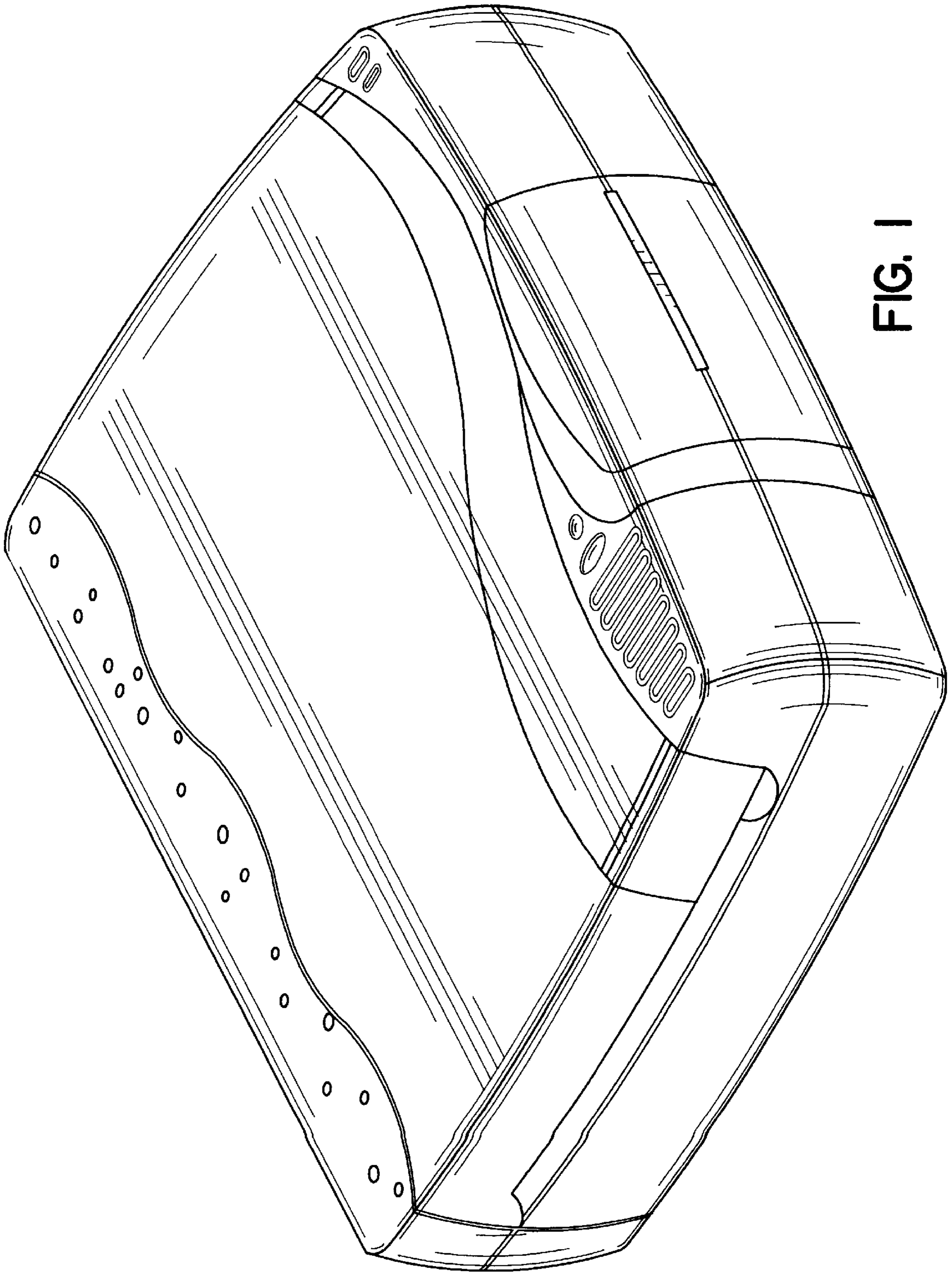

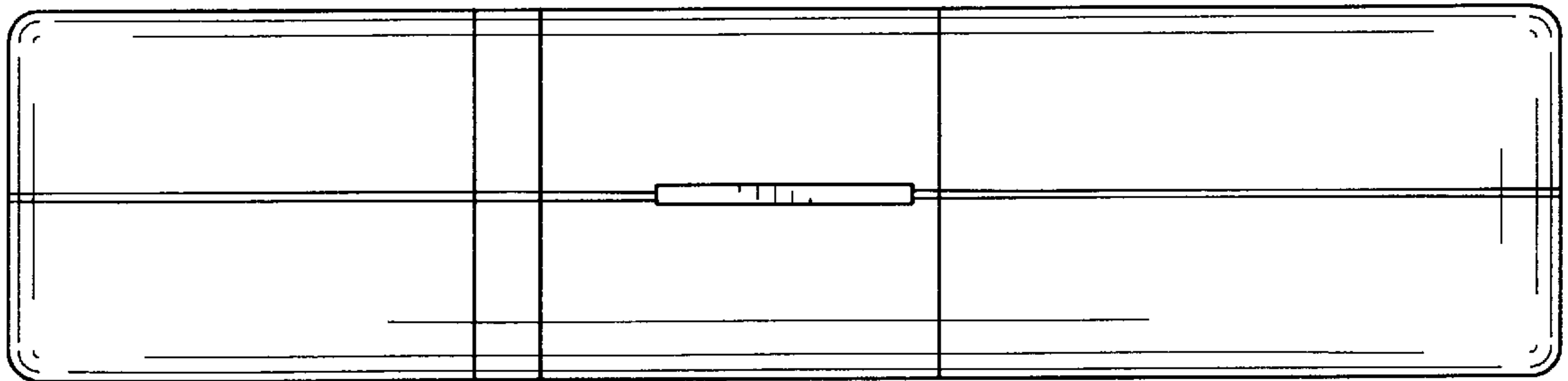

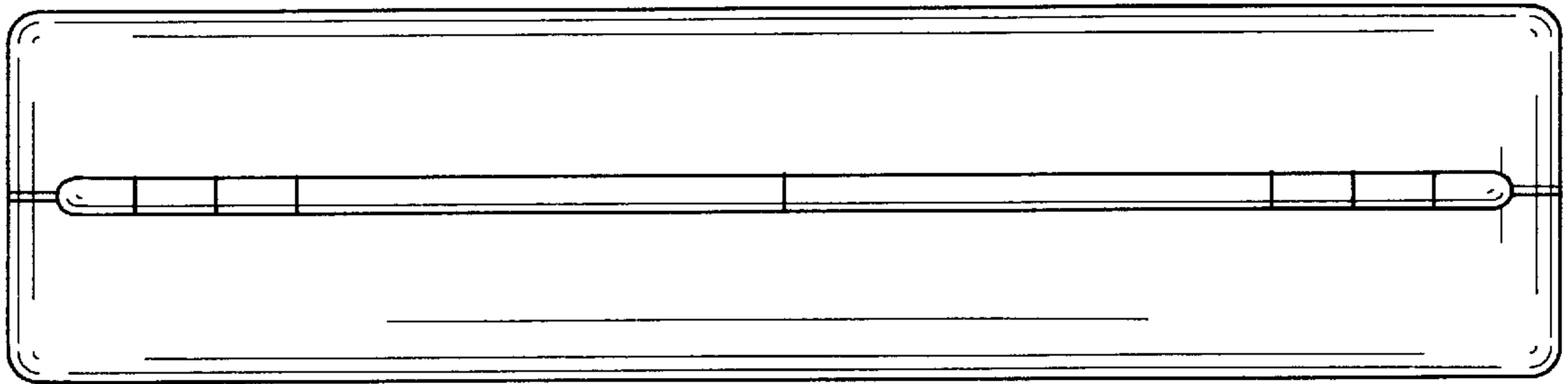

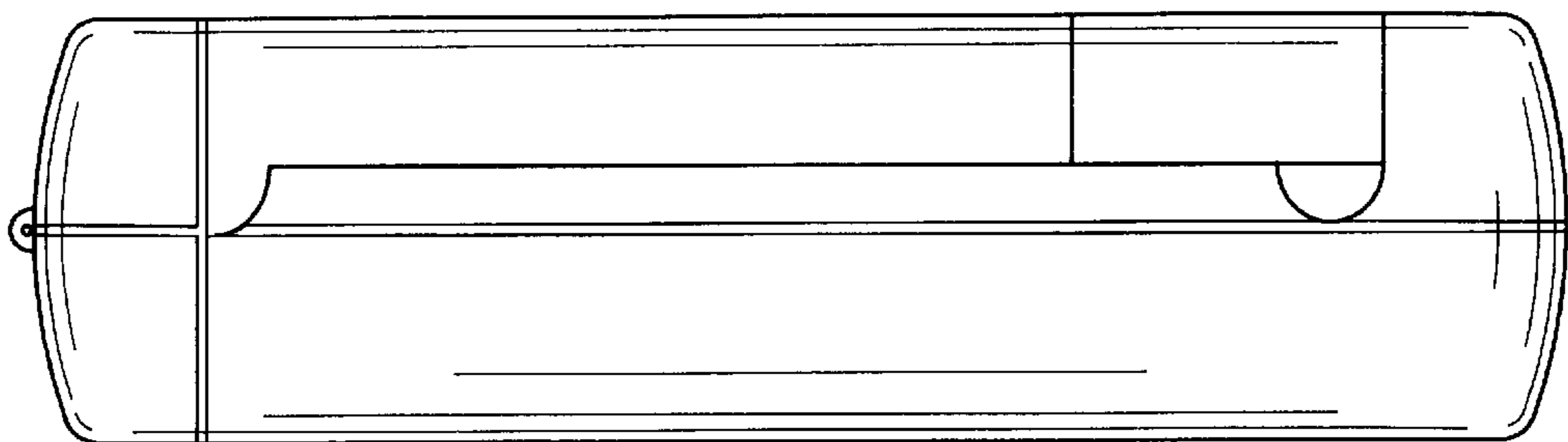

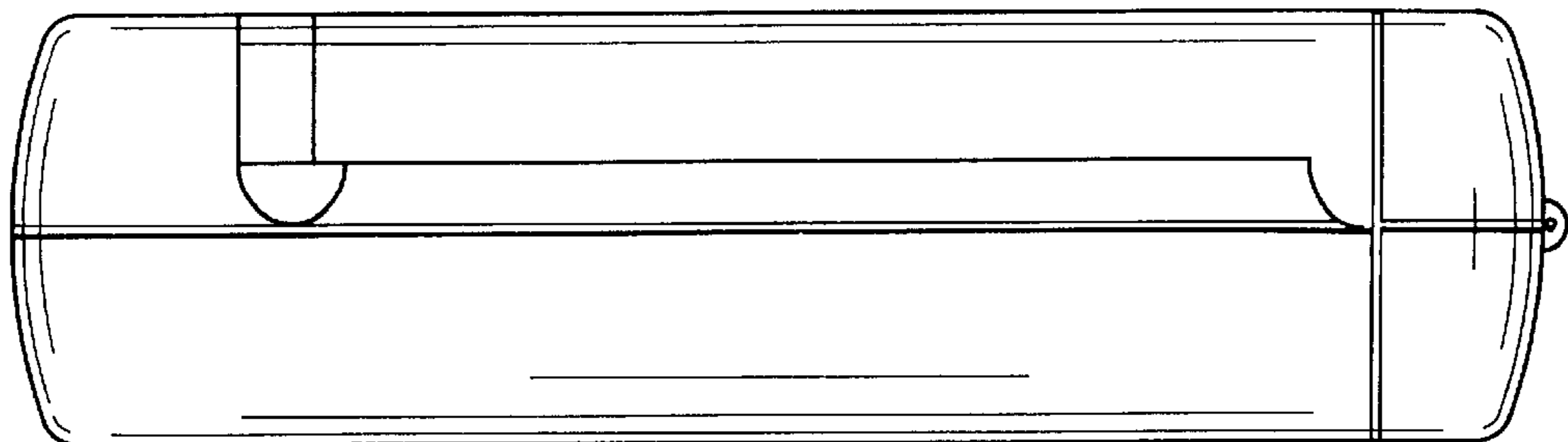

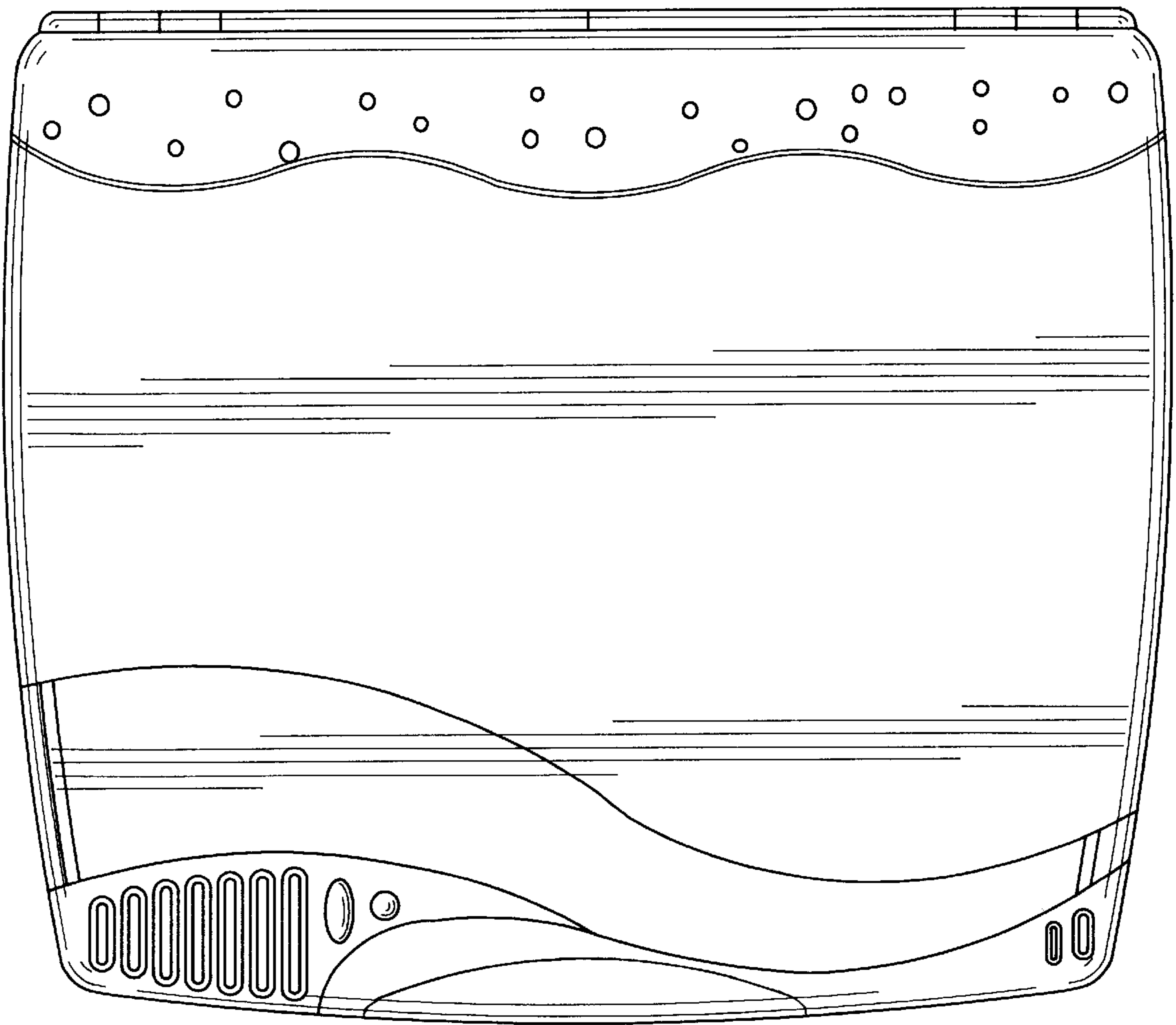

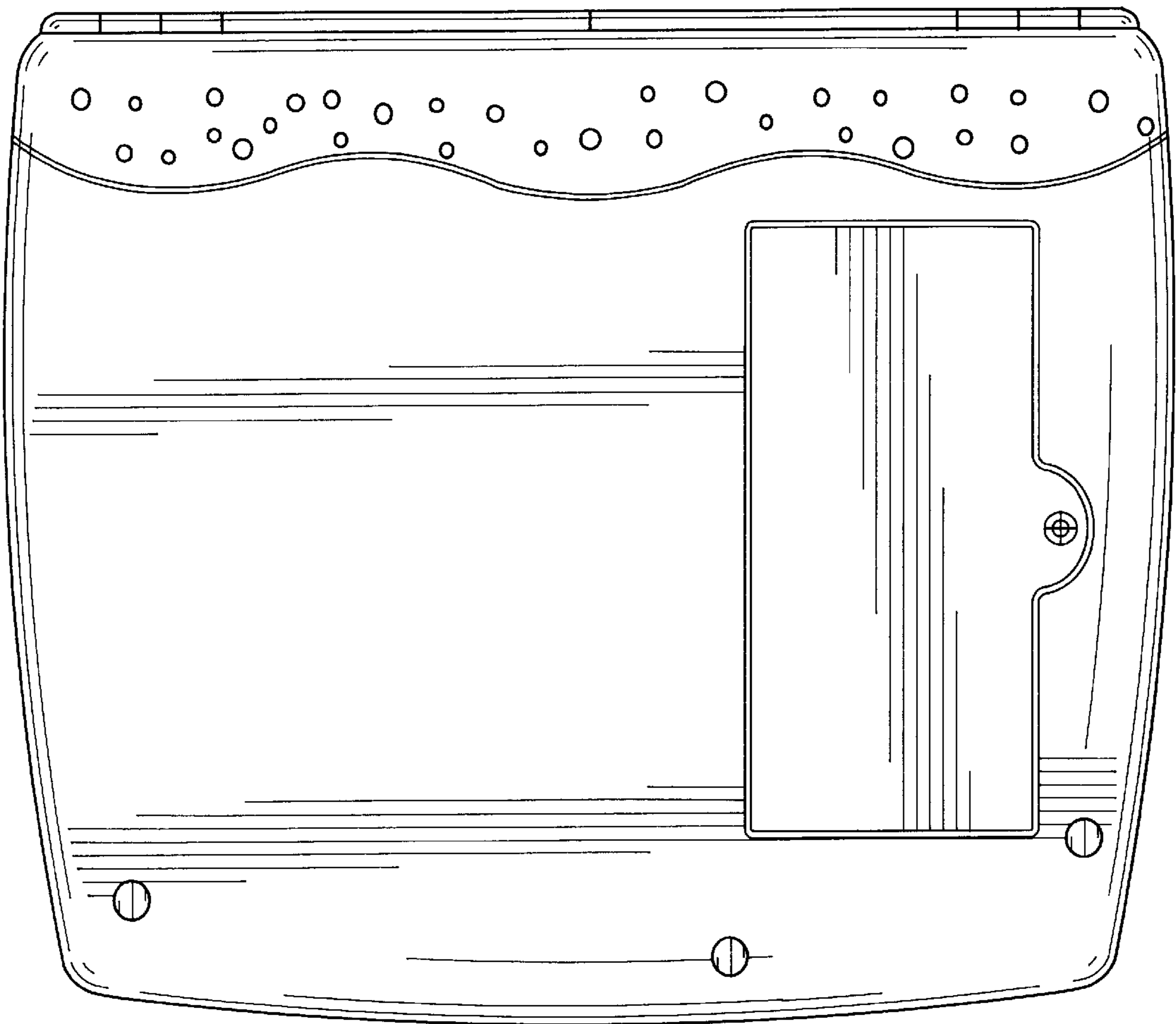
