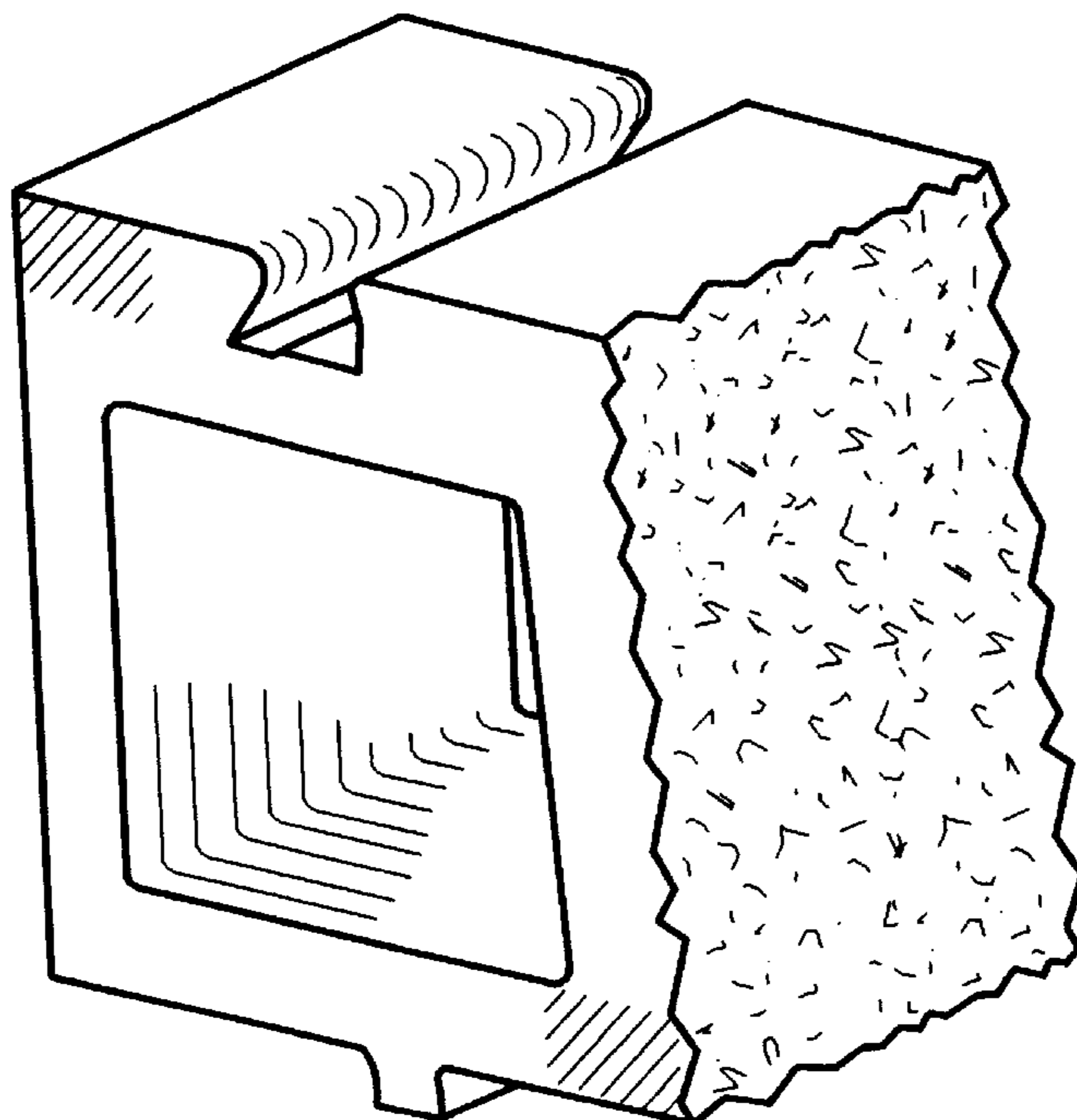
### [57] CLAIM

The ornamental design of a retaining wall block design, as shown and described.

#### DESCRIPTION

FIG. 1 is a front perspective view showing my new retaining wall block design;  
FIG. 2 is a rear perspective view thereof;

FIG. 4 is a front view thereof;  
FIG. 5 is a back view thereof;  
FIG. 6 is a left side view thereof;

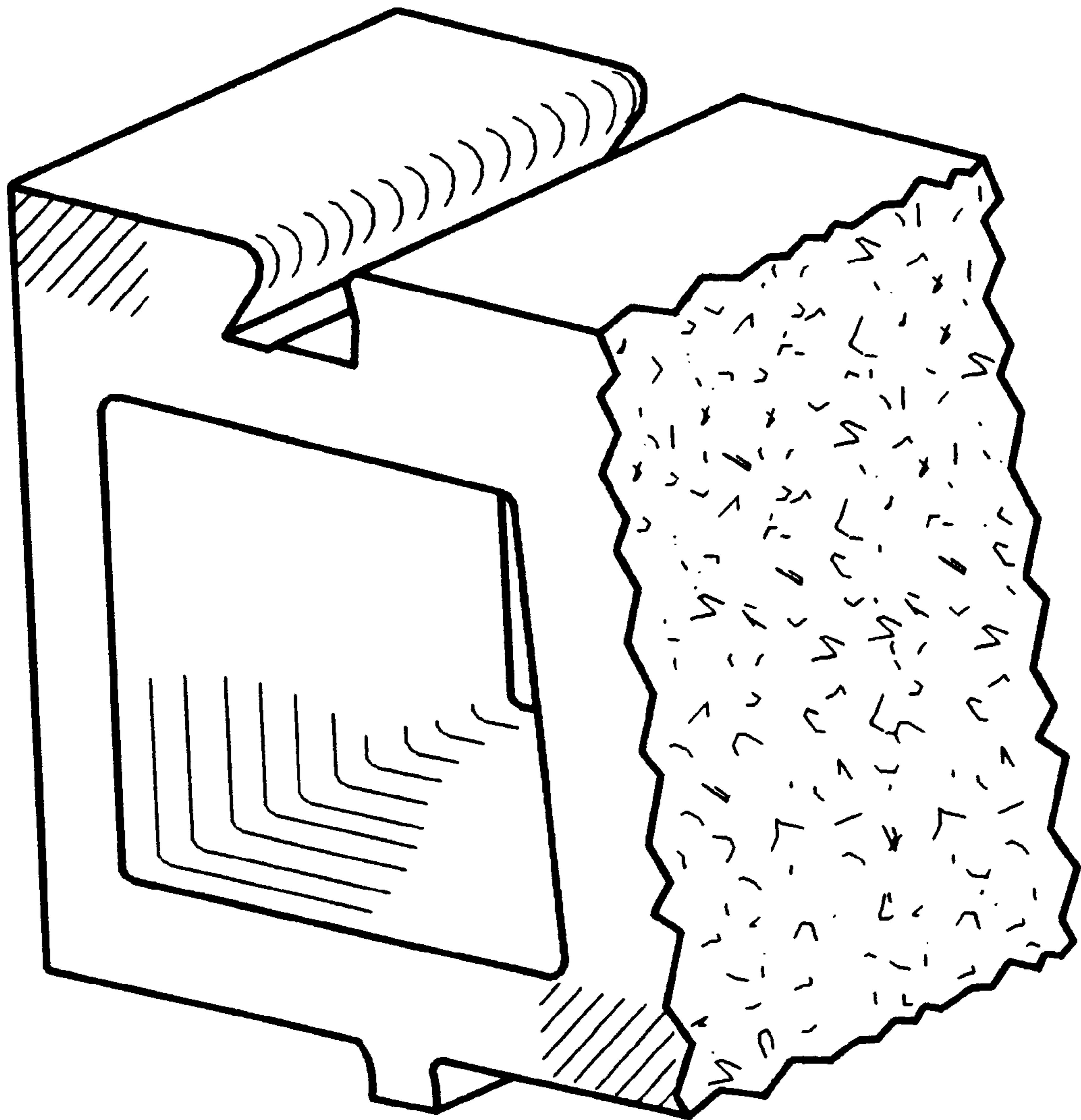

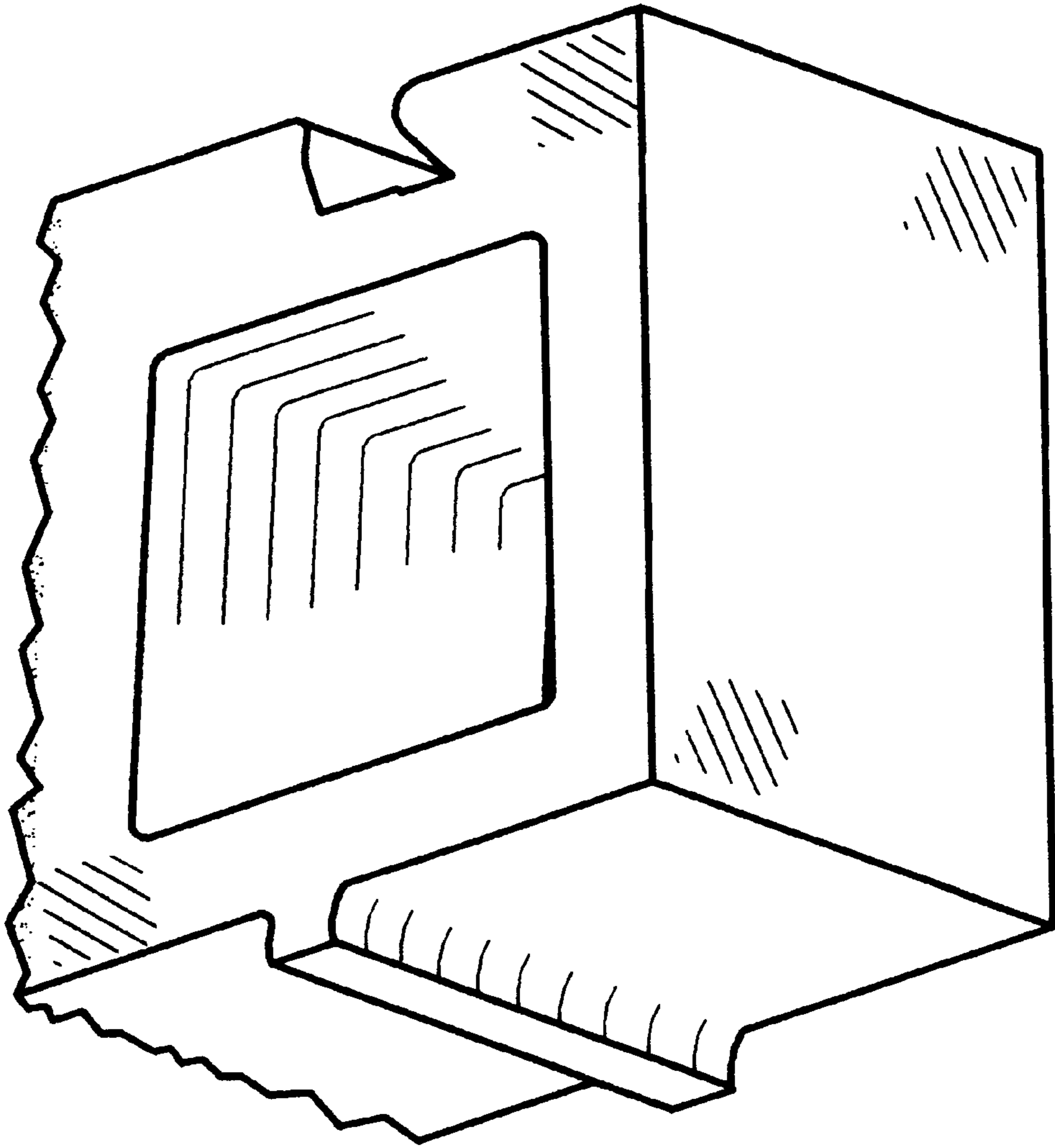

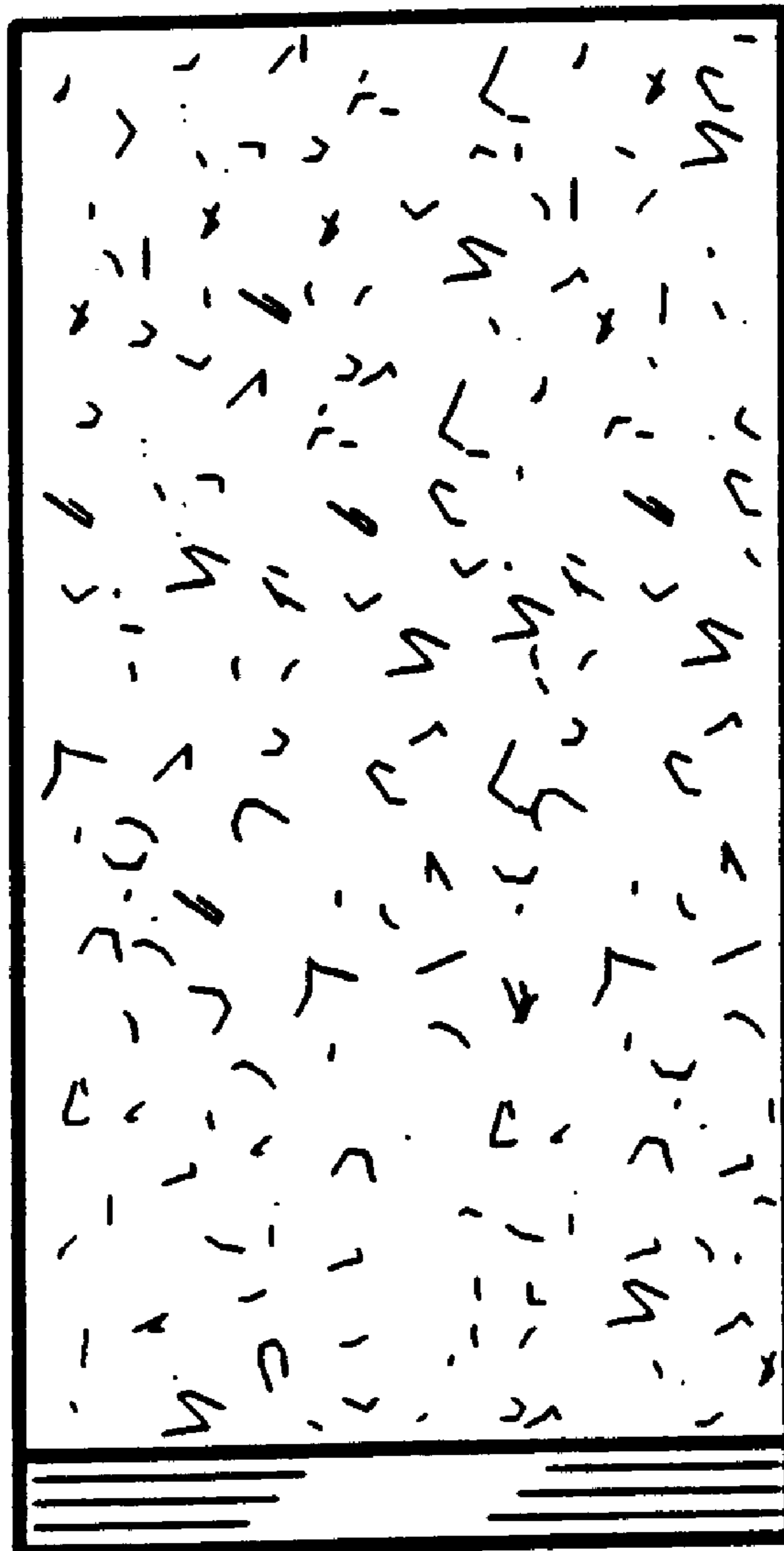

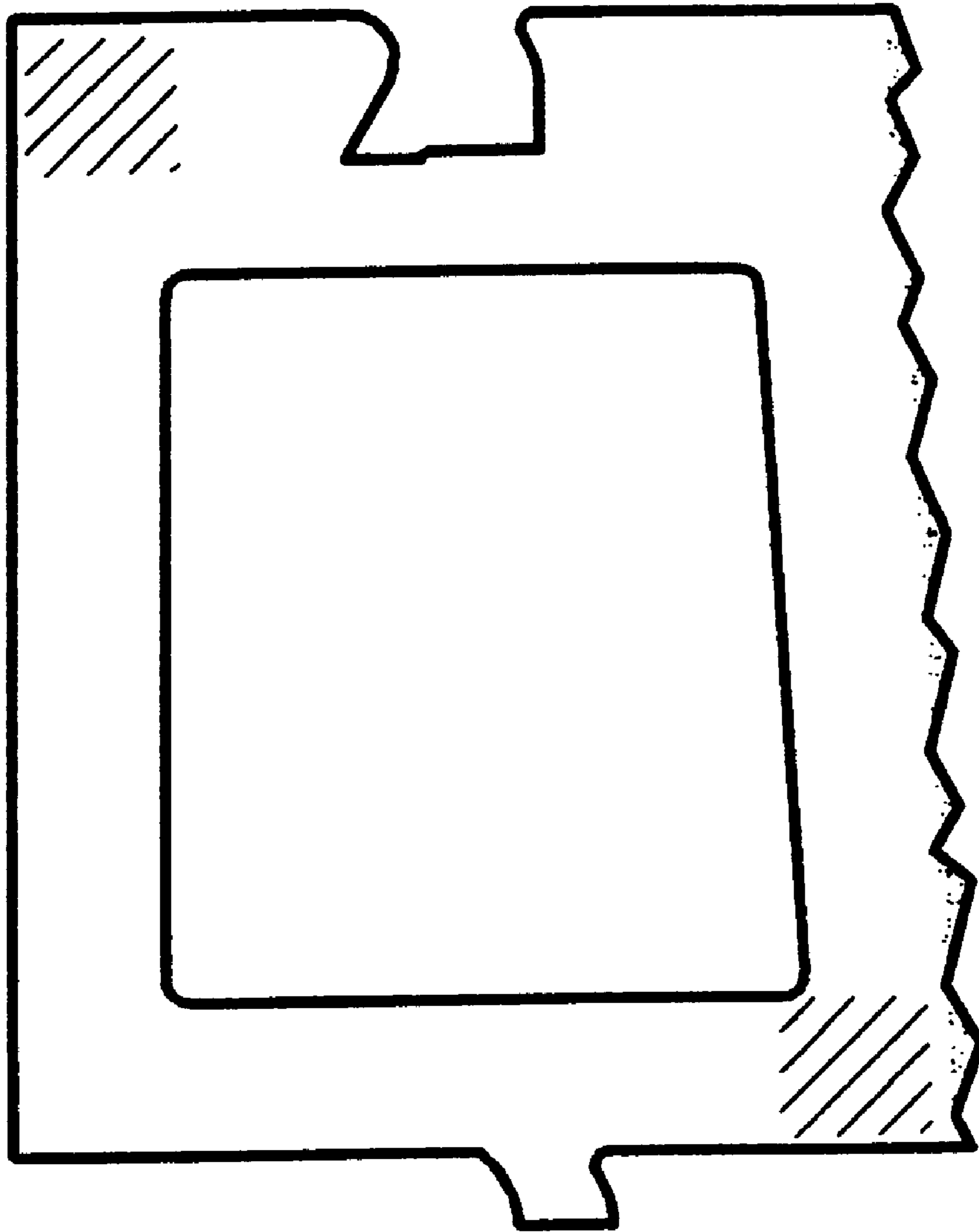

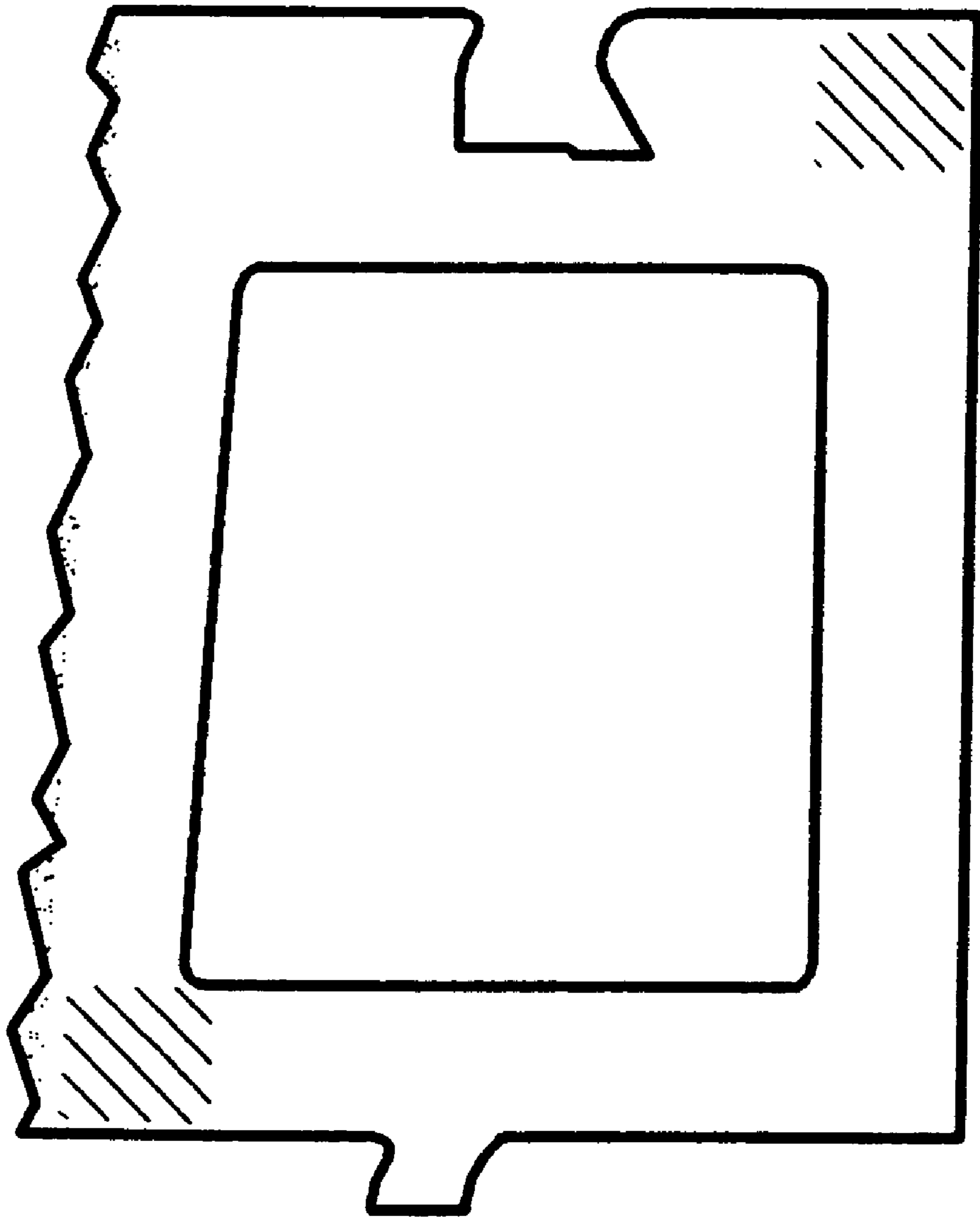

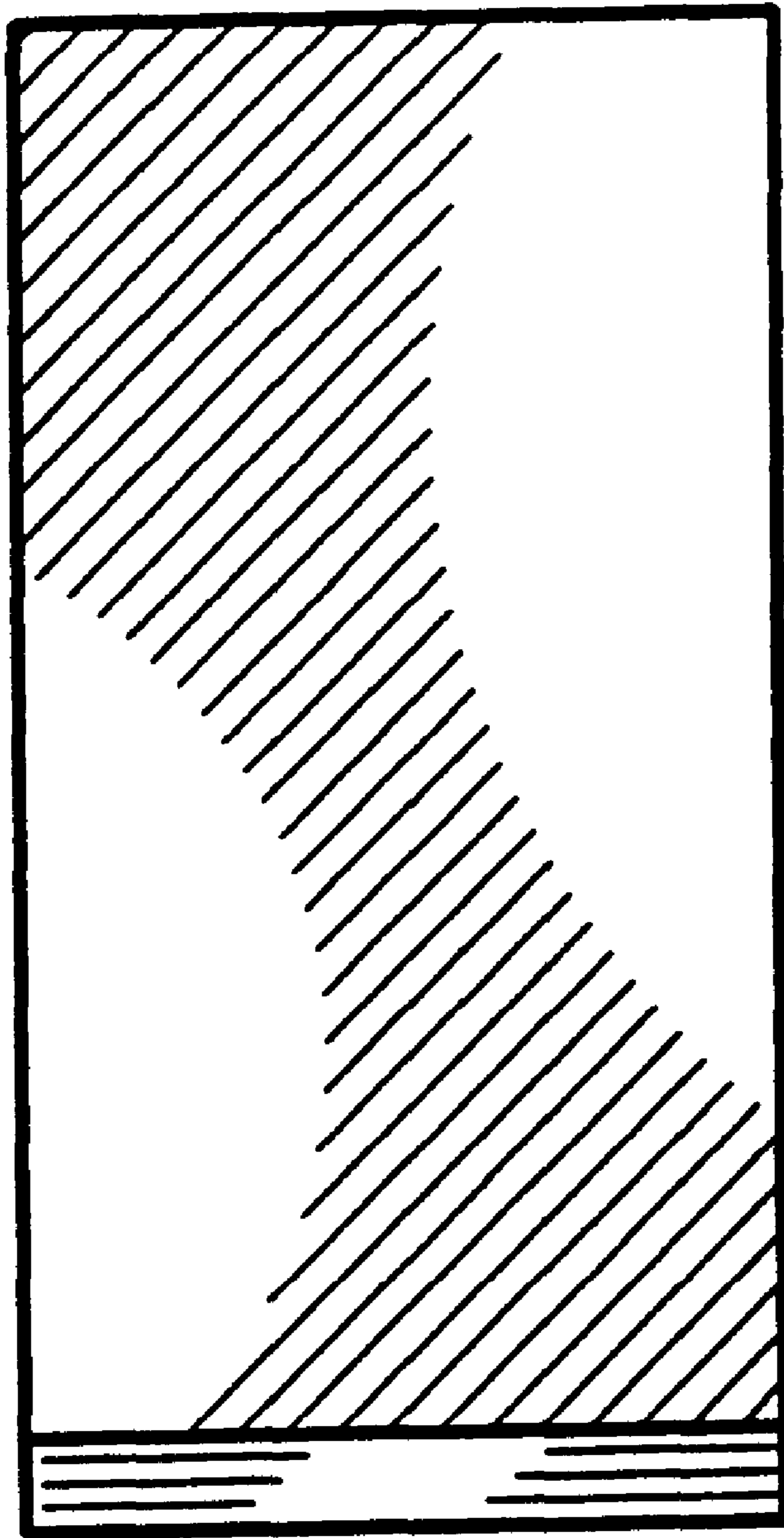

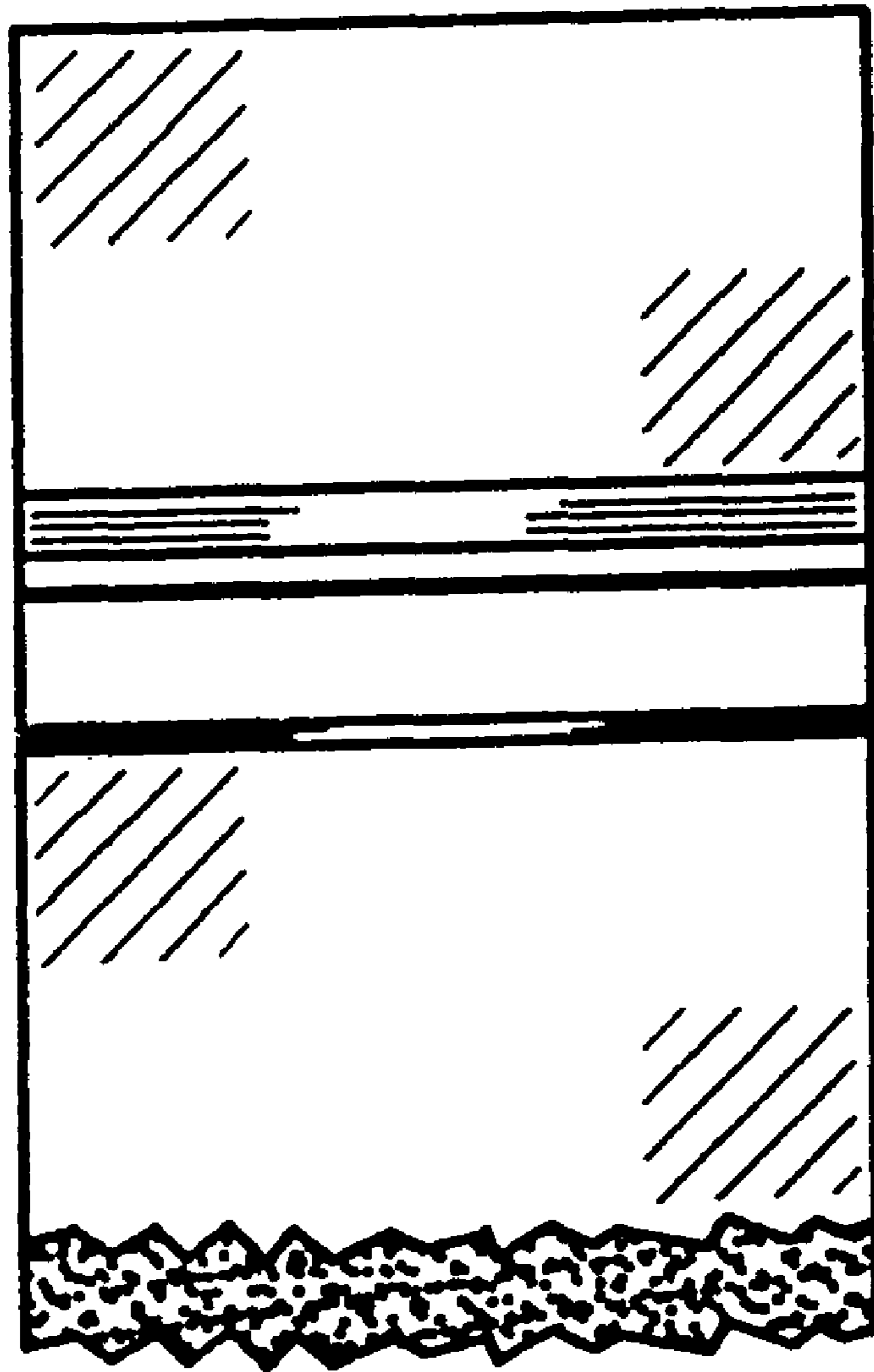

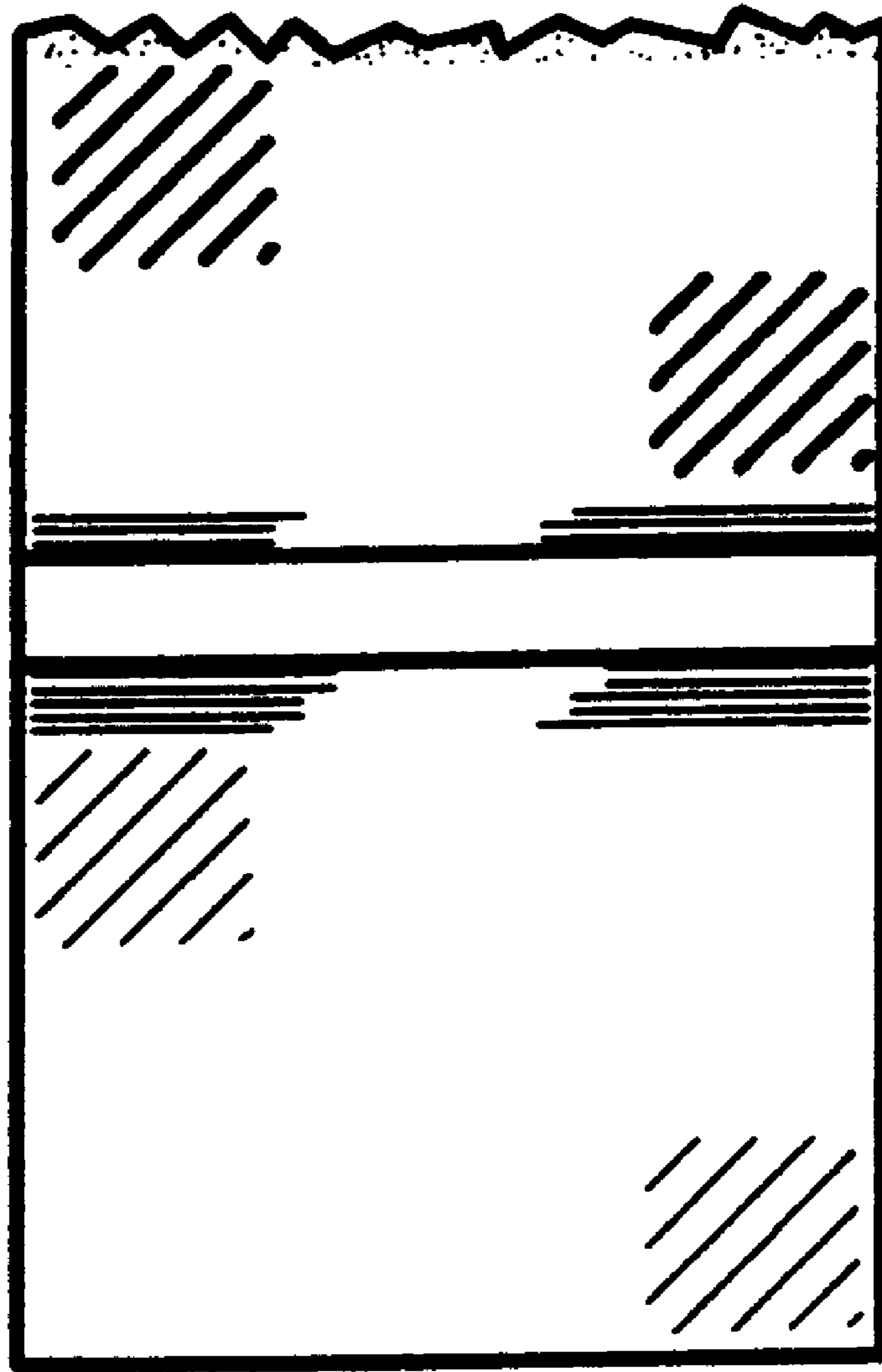
