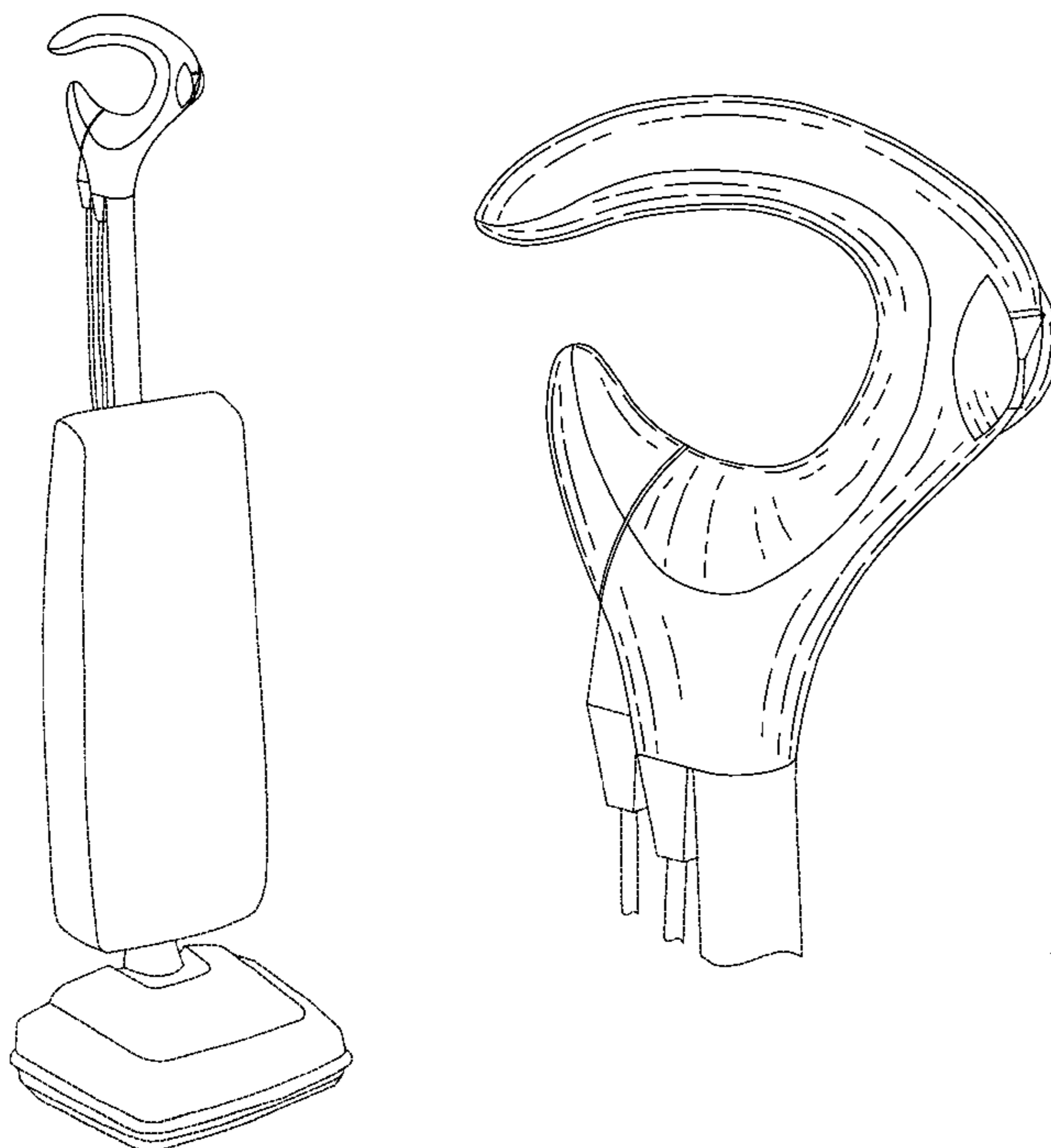
### [57] CLAIM

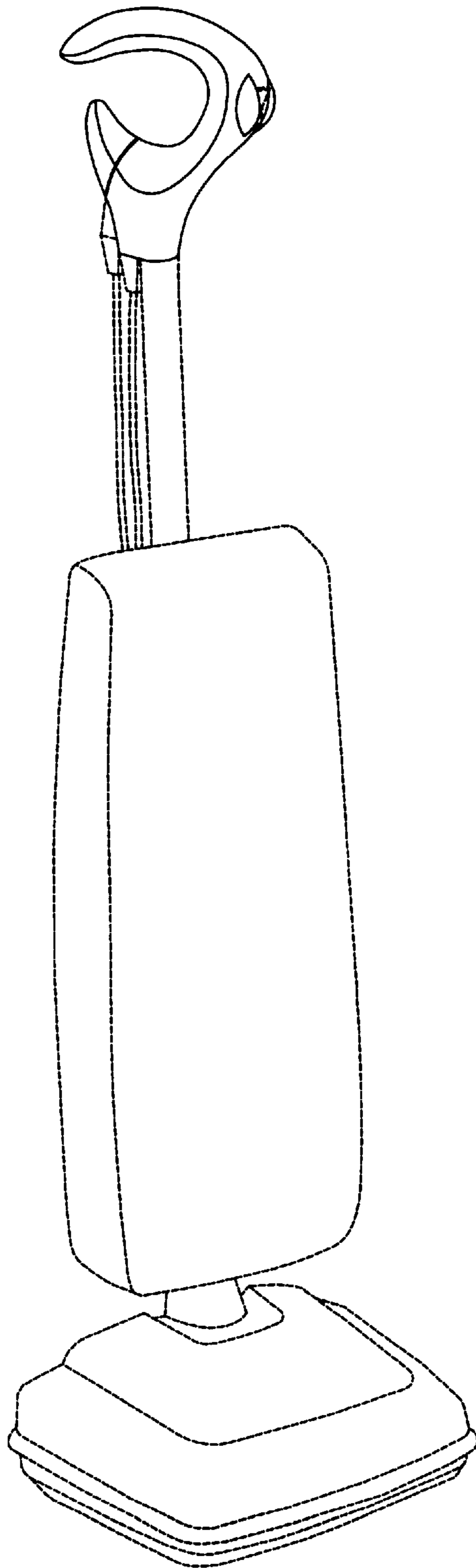
The ornamental design for a handle for floor care apparatus, as shown and described.

### DESCRIPTION

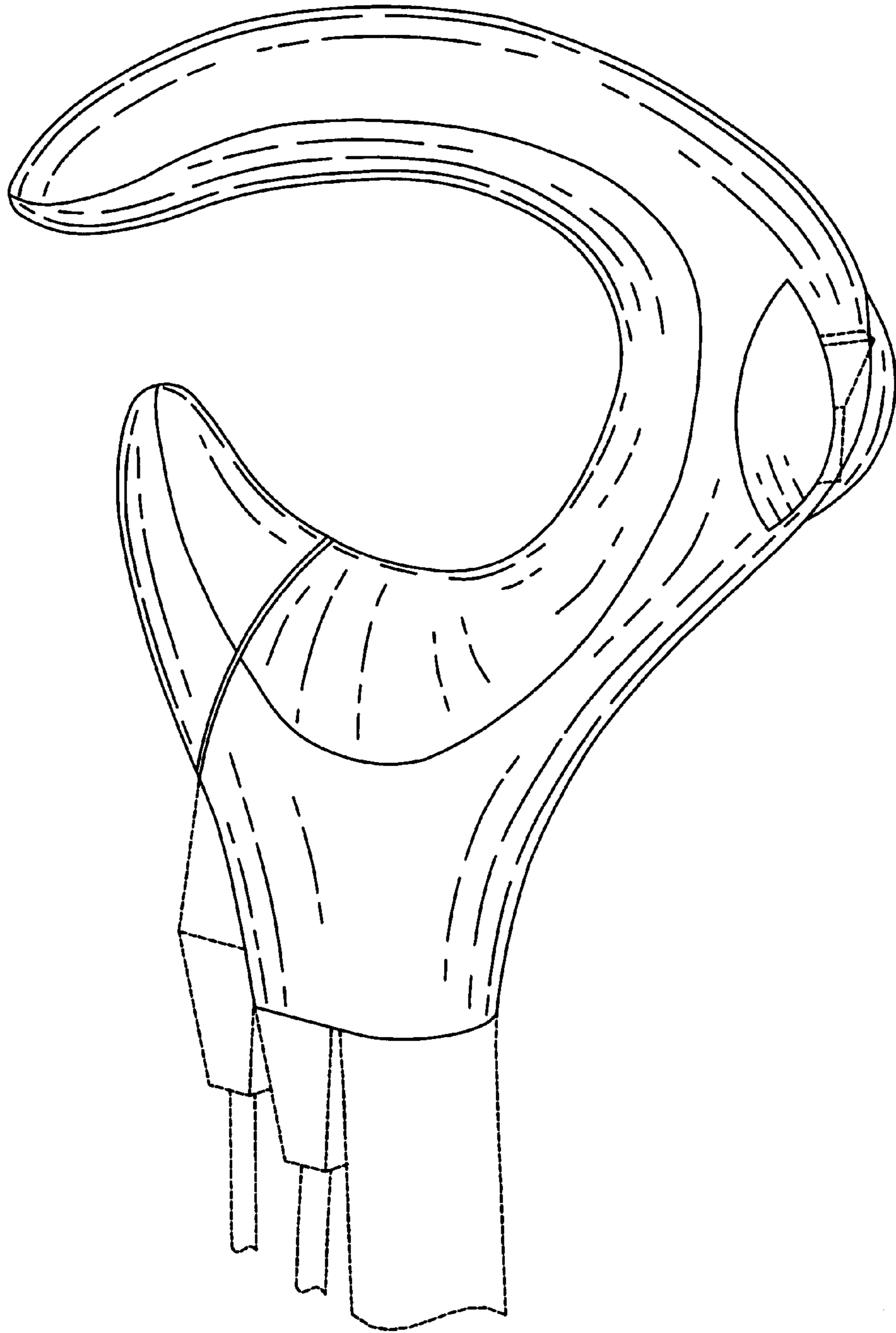
FIG. 1 is a front isometric view of a handle for floor care apparatus showing our new design;

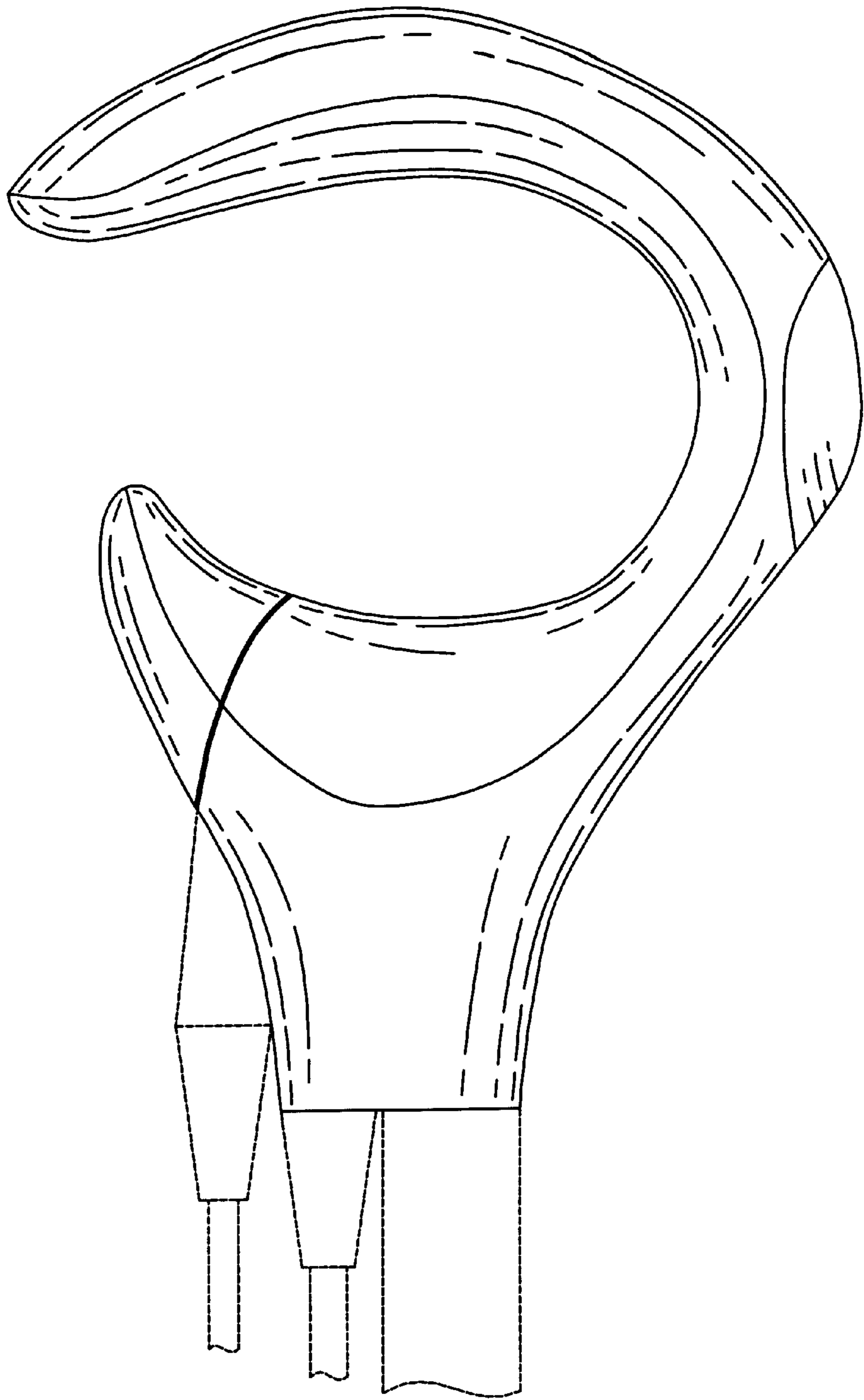




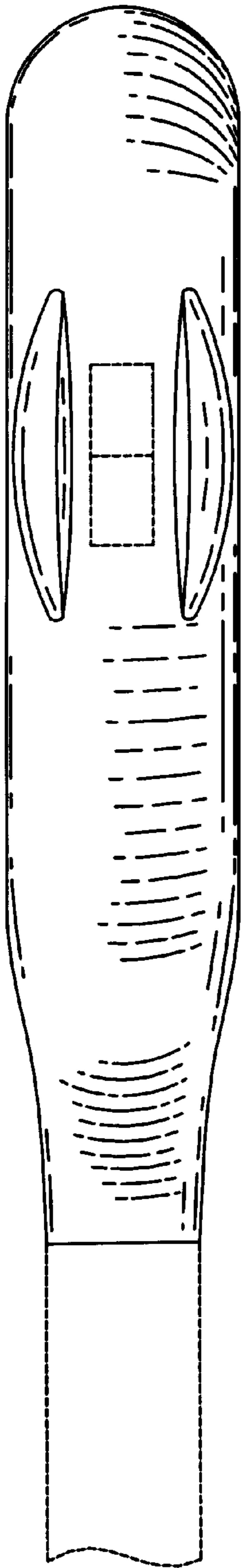

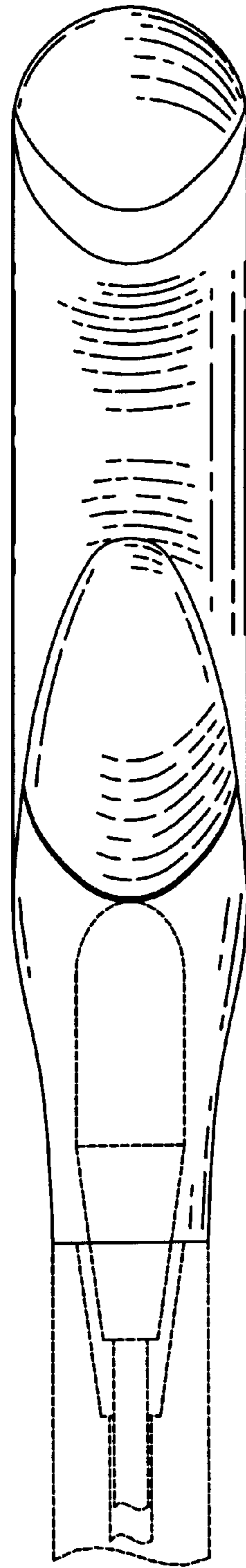

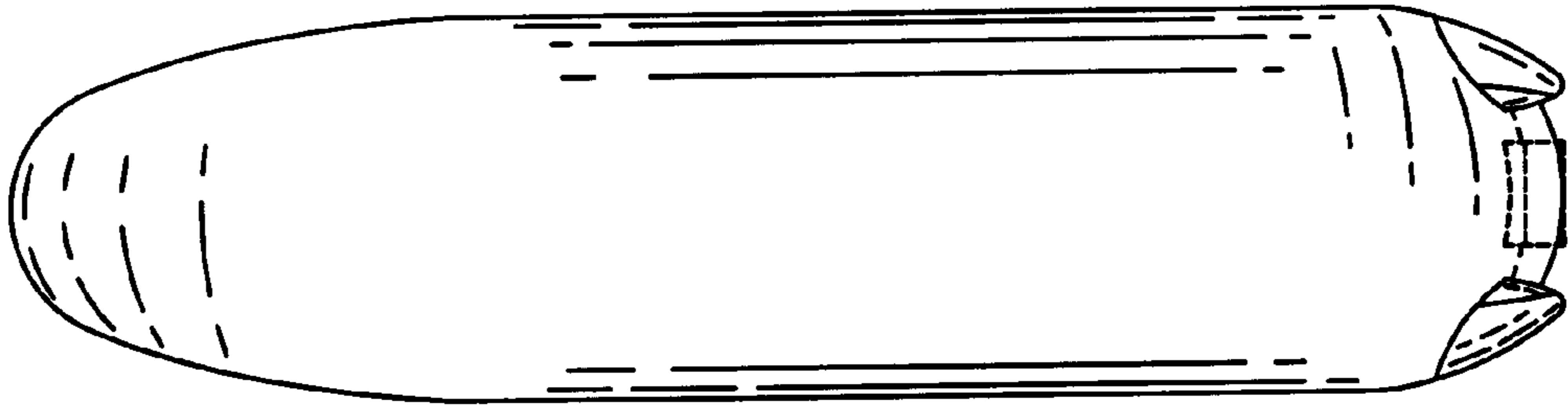

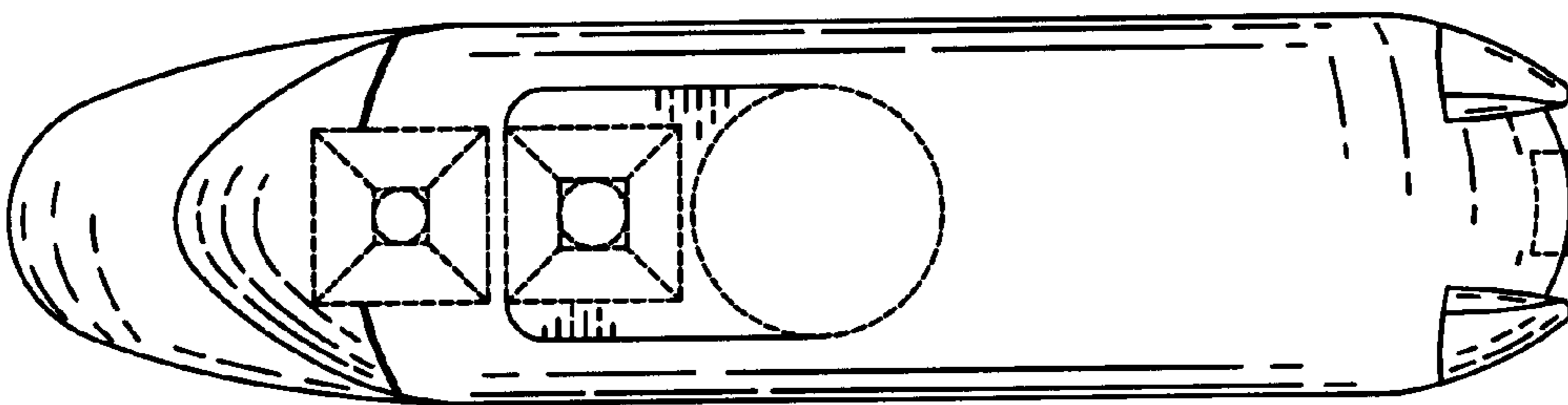
