[57] **CLAIM**

The ornamental design for the clothes closet with drawers,
as shown and described.

The claimed clothes closet with drawers is for storage of clothing, footwear, jewelry, papers and the like.

FIG. 1 is a front perspective view of a first embodiment of a clothes closet with drawers showing my new design with circular openings in the drawers;

FIG. 2 is a front elevational view of a second embodiment of a clothes closet with drawers showing my new design with exterior drawer pulls on the drawers;

FIG. 3 is a back elevational view of the design shown in FIGS. 1 and 2;

FIG. 4 is a side elevational view of the design shown in FIGS. 1 and 2;

FIG. 5 is a side elevational view of the design shown in FIGS. 1 and 2;

FIG. 6 is a top elevational view of the design shown in FIGS. 1 and 2; and,

FIG. 7 is a bottom elevational view of the design shown in FIGS. 1 and 2.

The criss cross shading shown partially on FIGS. 1-6 is understood to continue uniformly across the surfaces shown.

The broken lines at the border of several of the surfaces in FIGS. 1-7 represent stitching.

The surface(s) or portion(s) of the article not shown in the drawing or described in the specification form(s) no part of the claimed design.

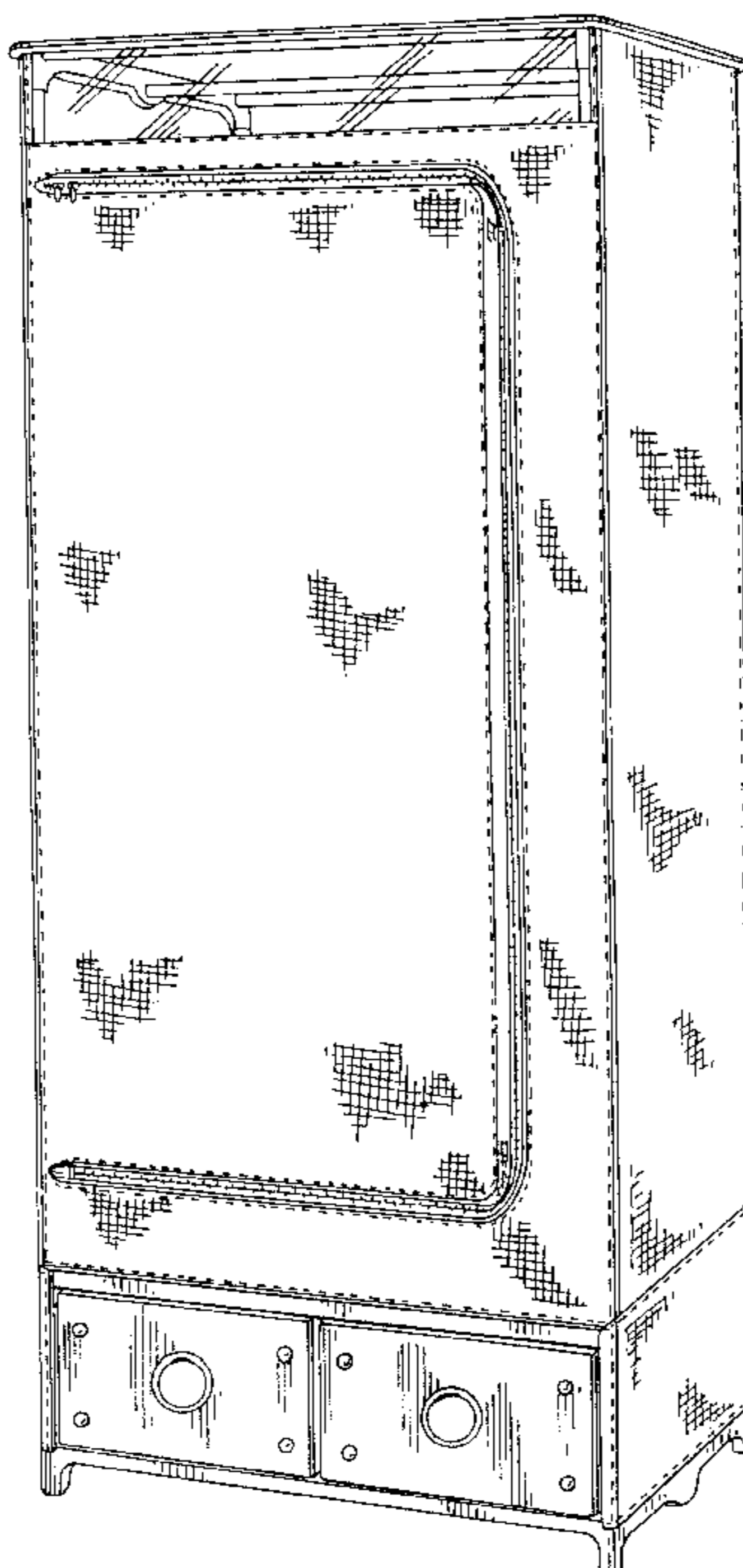
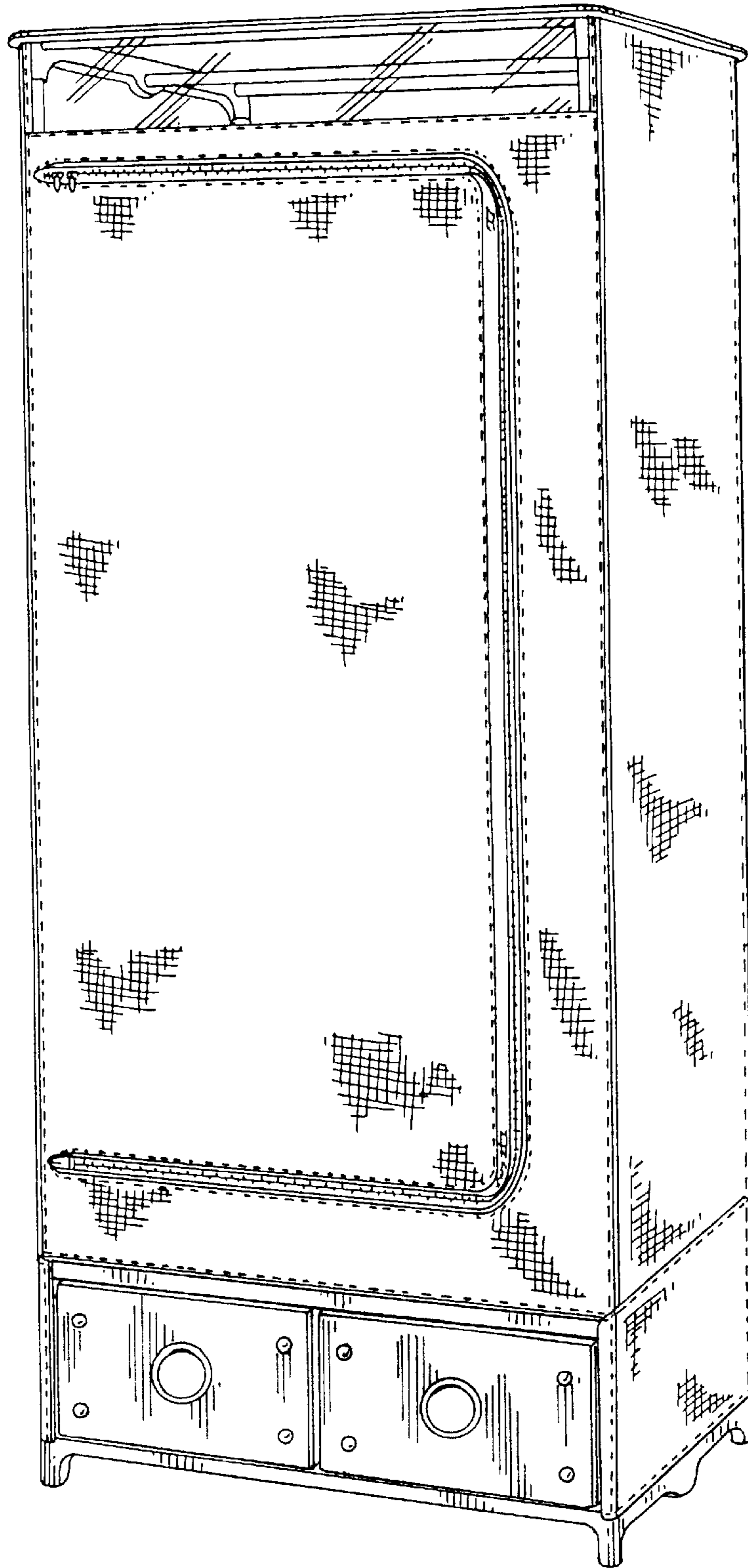

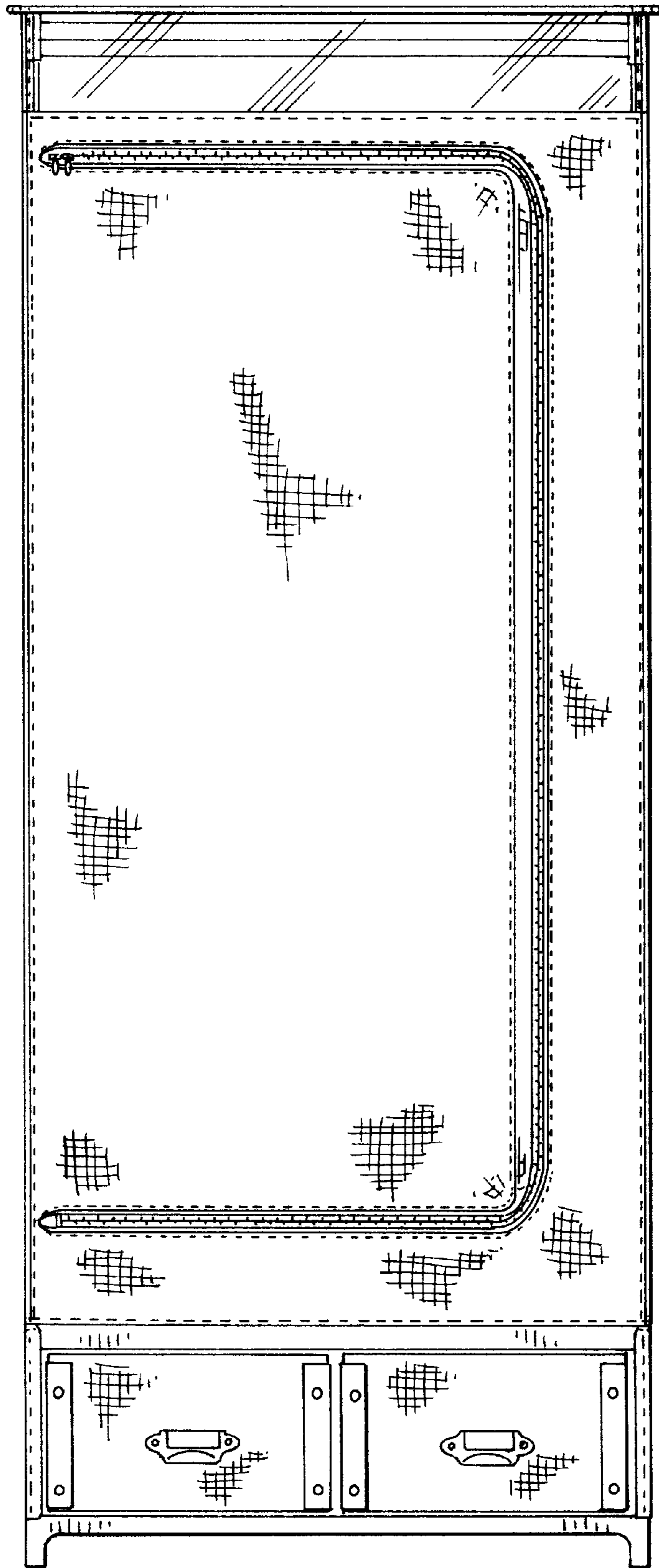
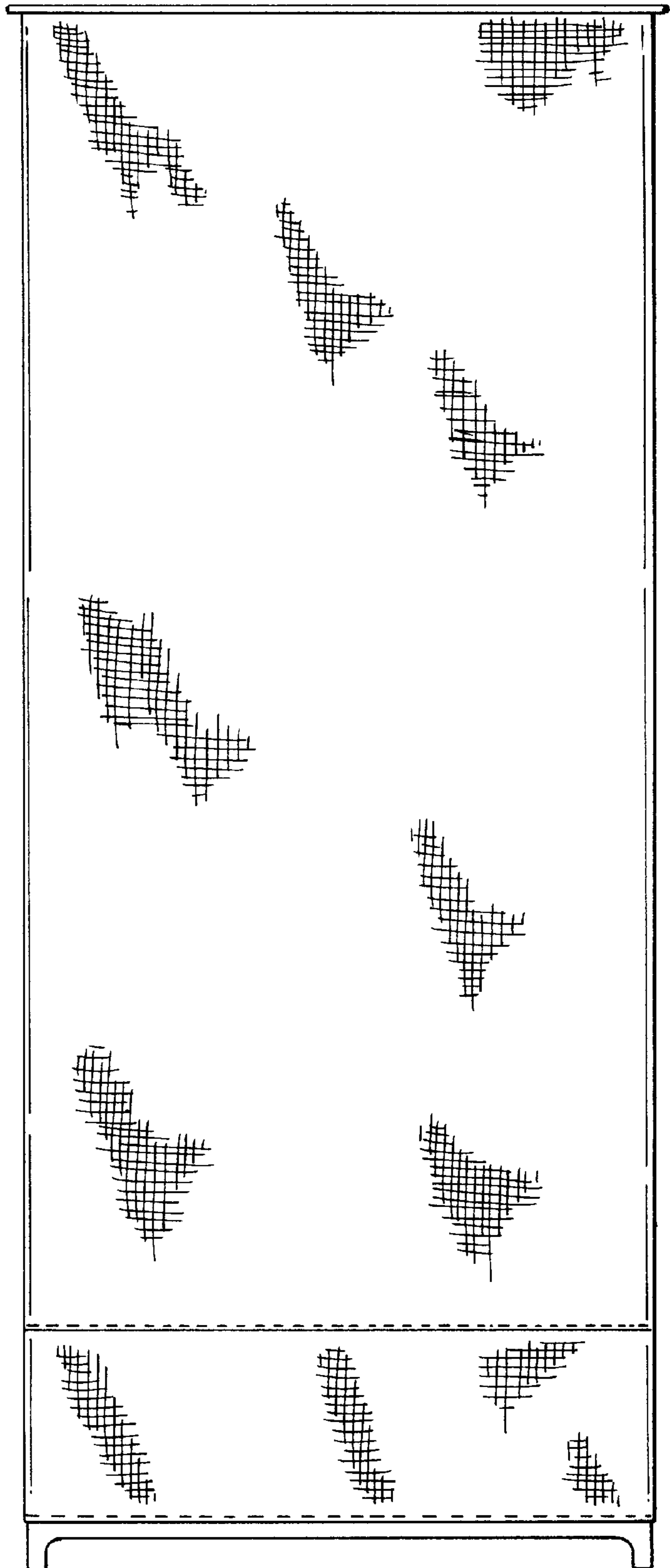

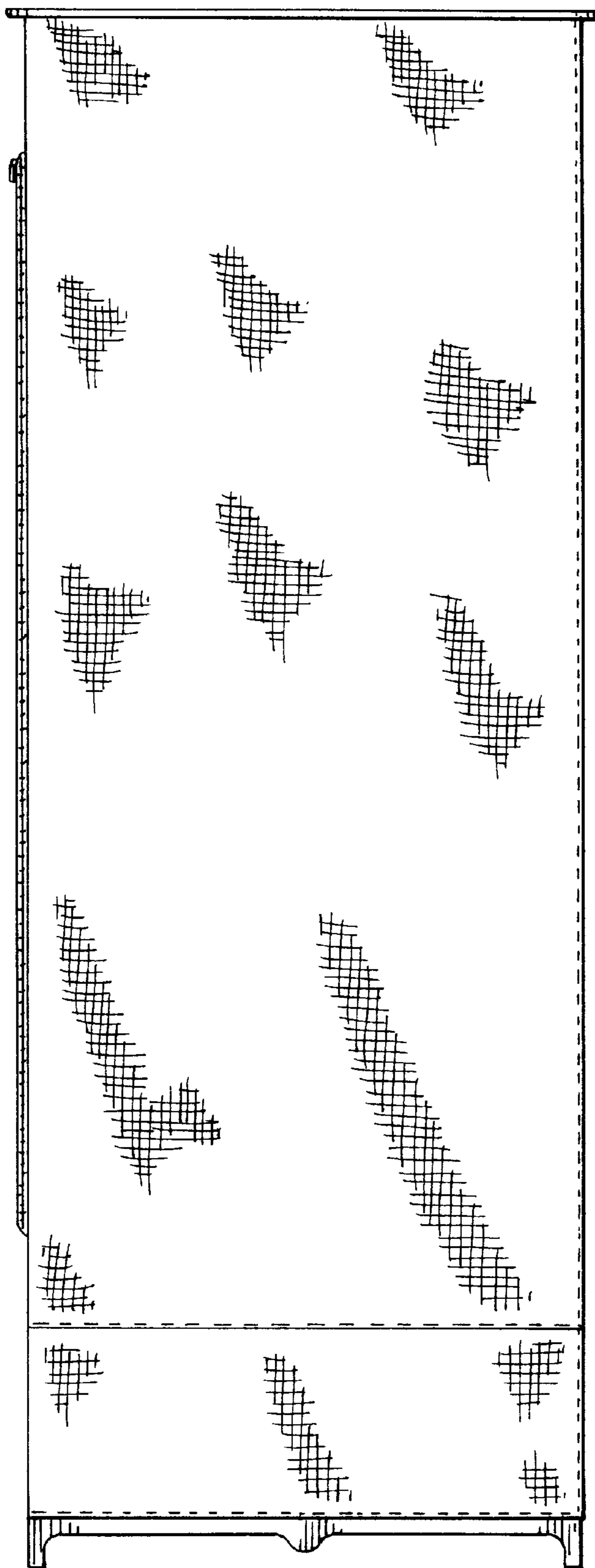
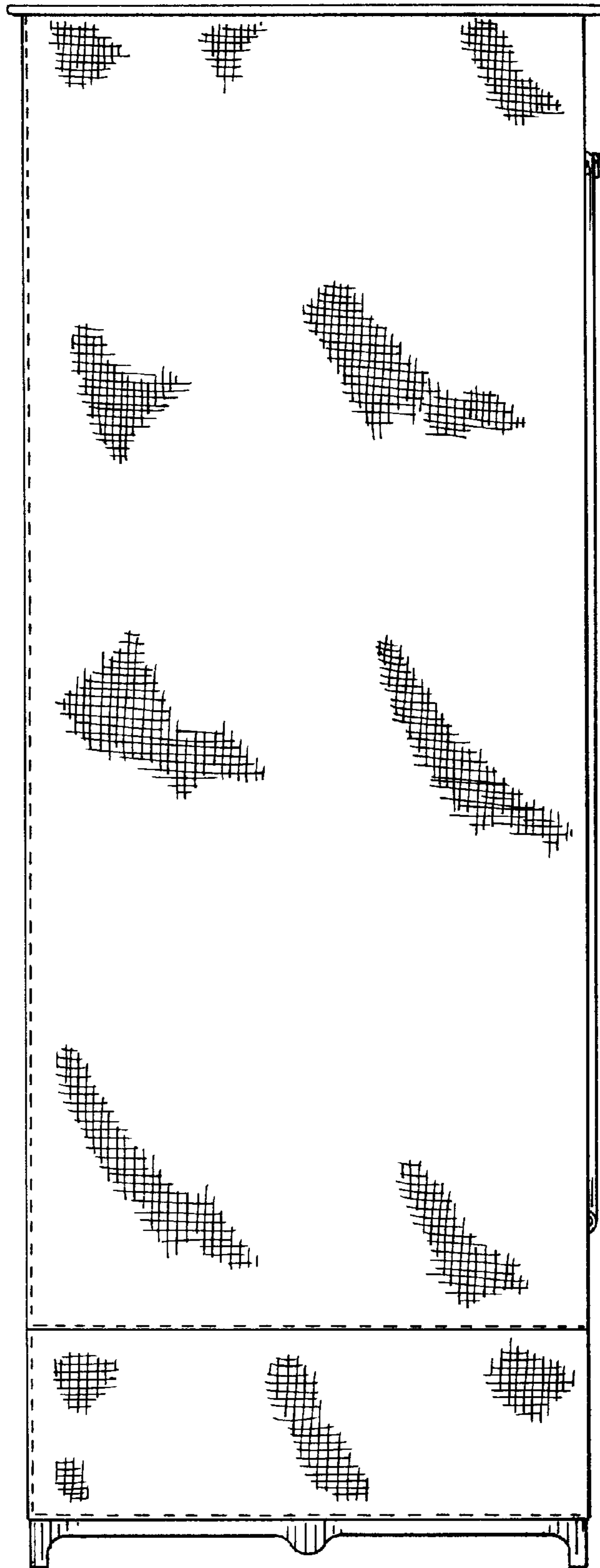

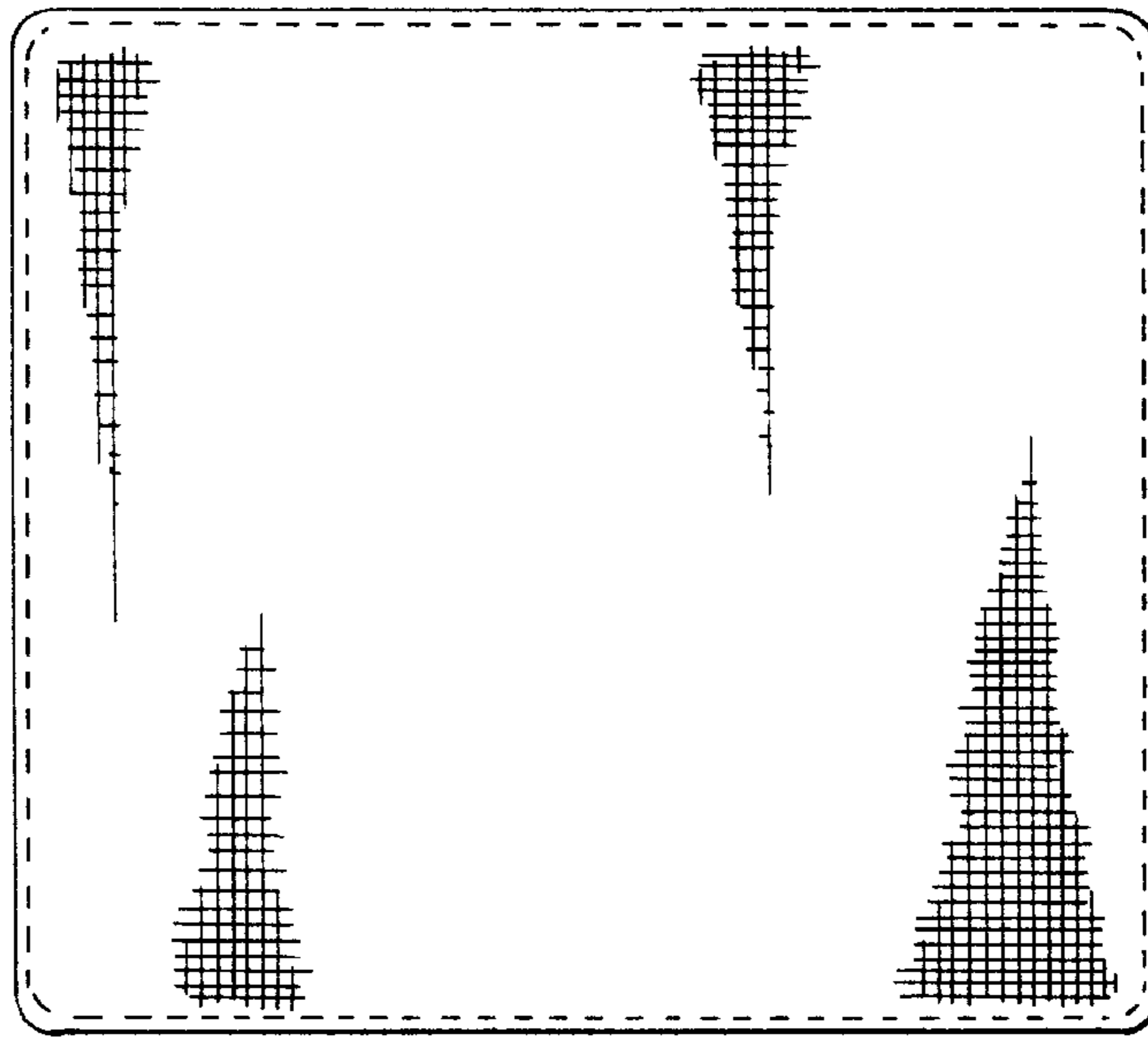

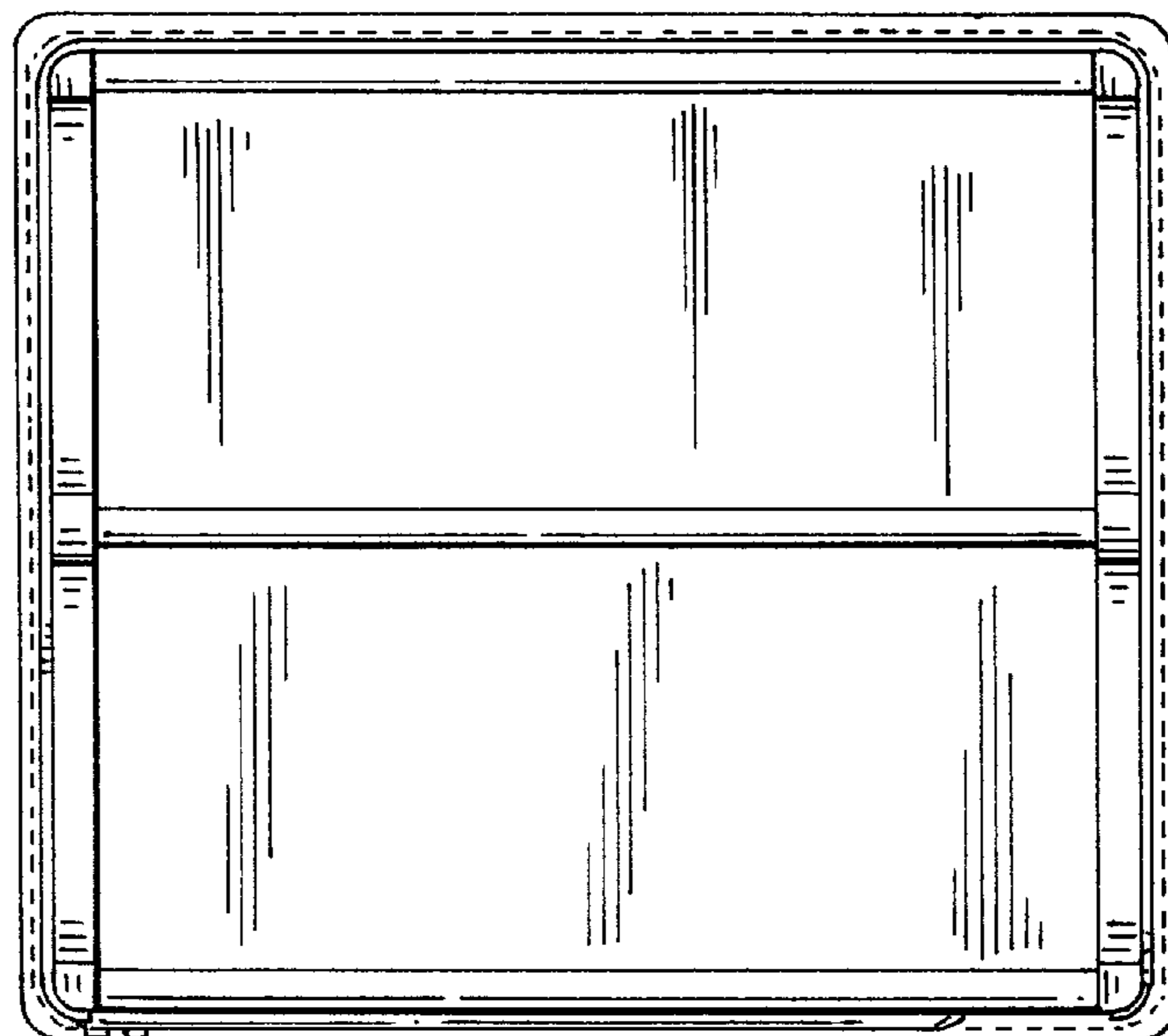
