We claim the ornamental design for a garden tool, as shown and described.

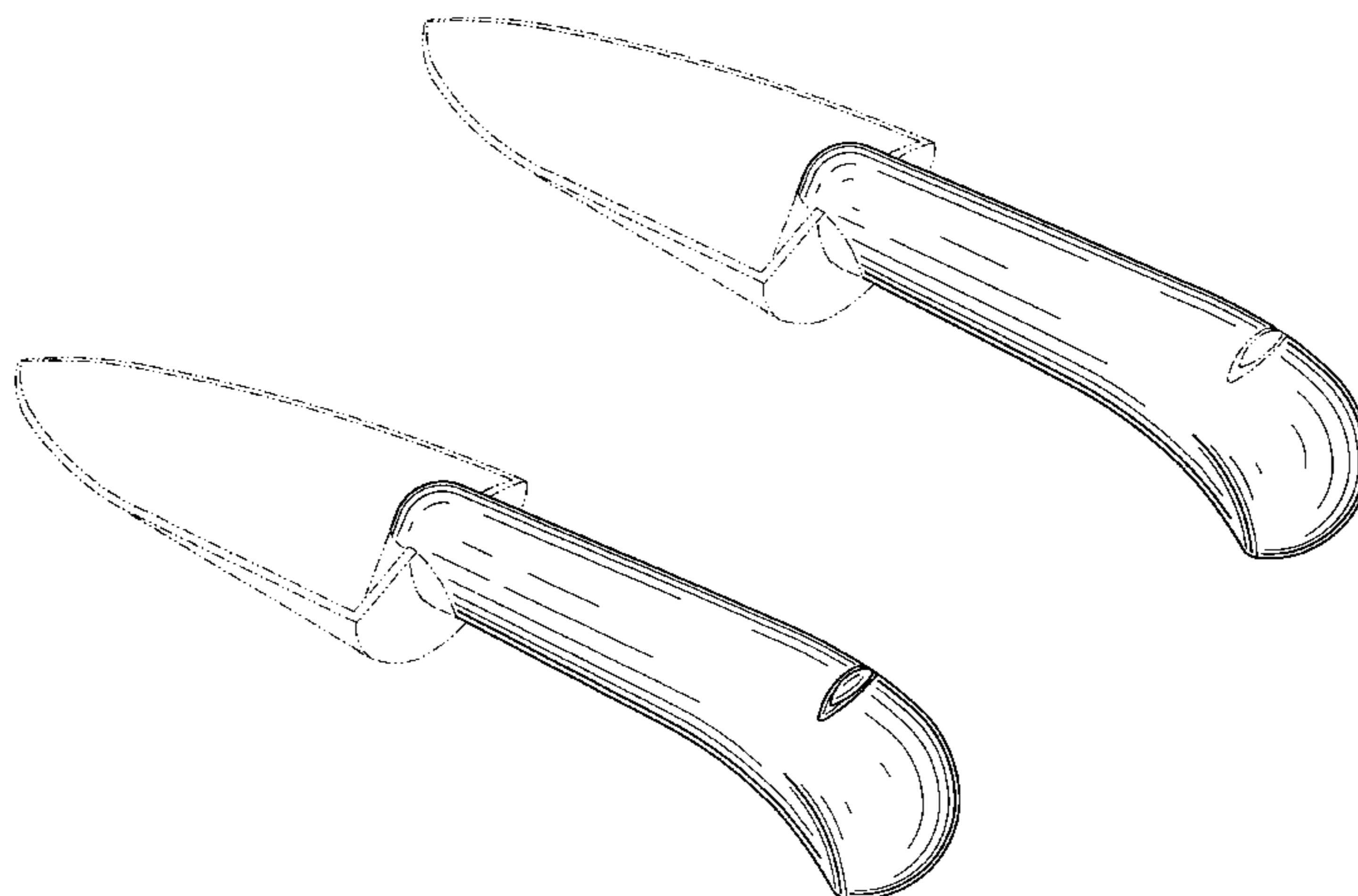
DESCRIPTION

FIG. 1 is a perspective view of a garden tool showing our new design;

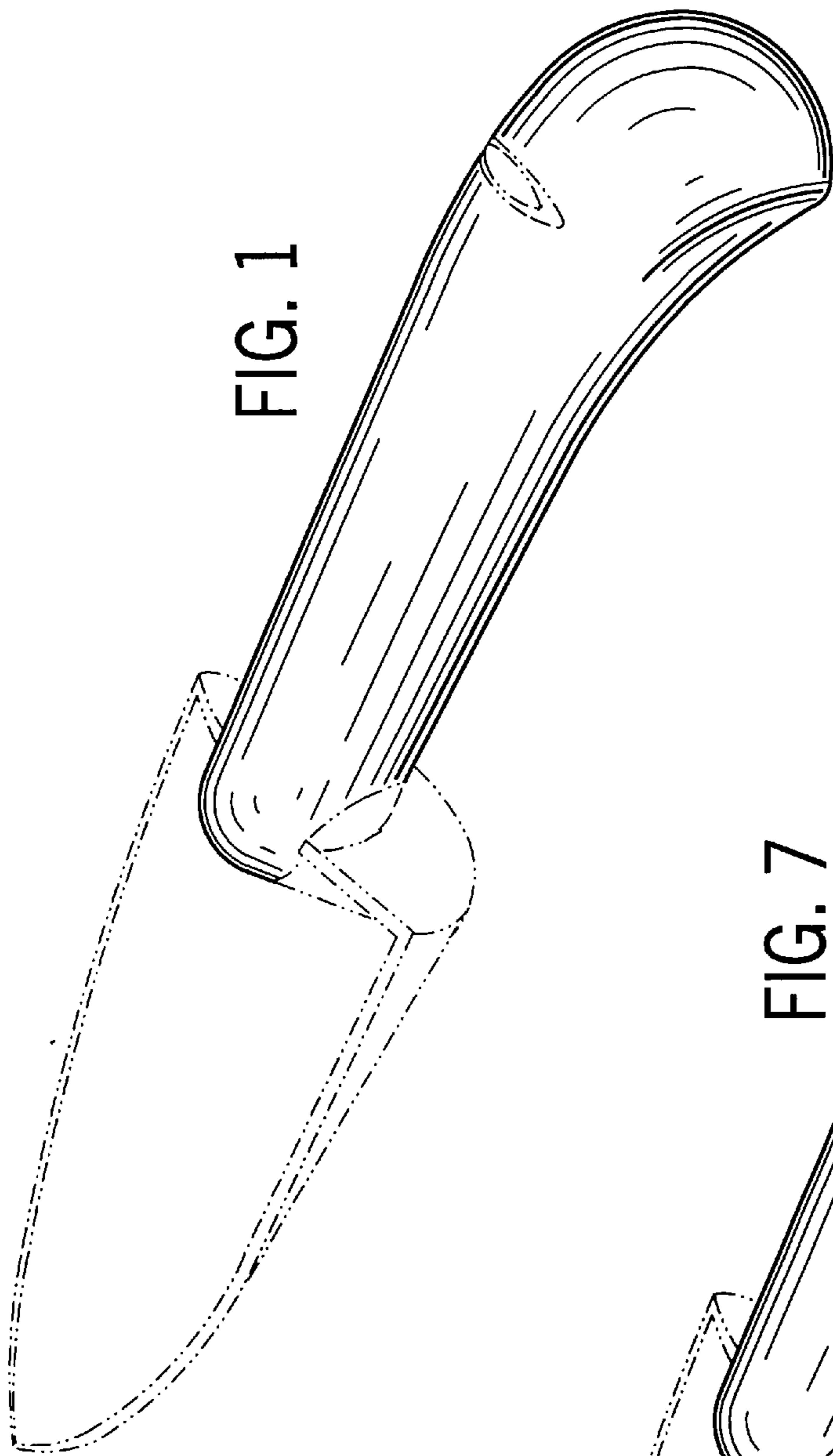

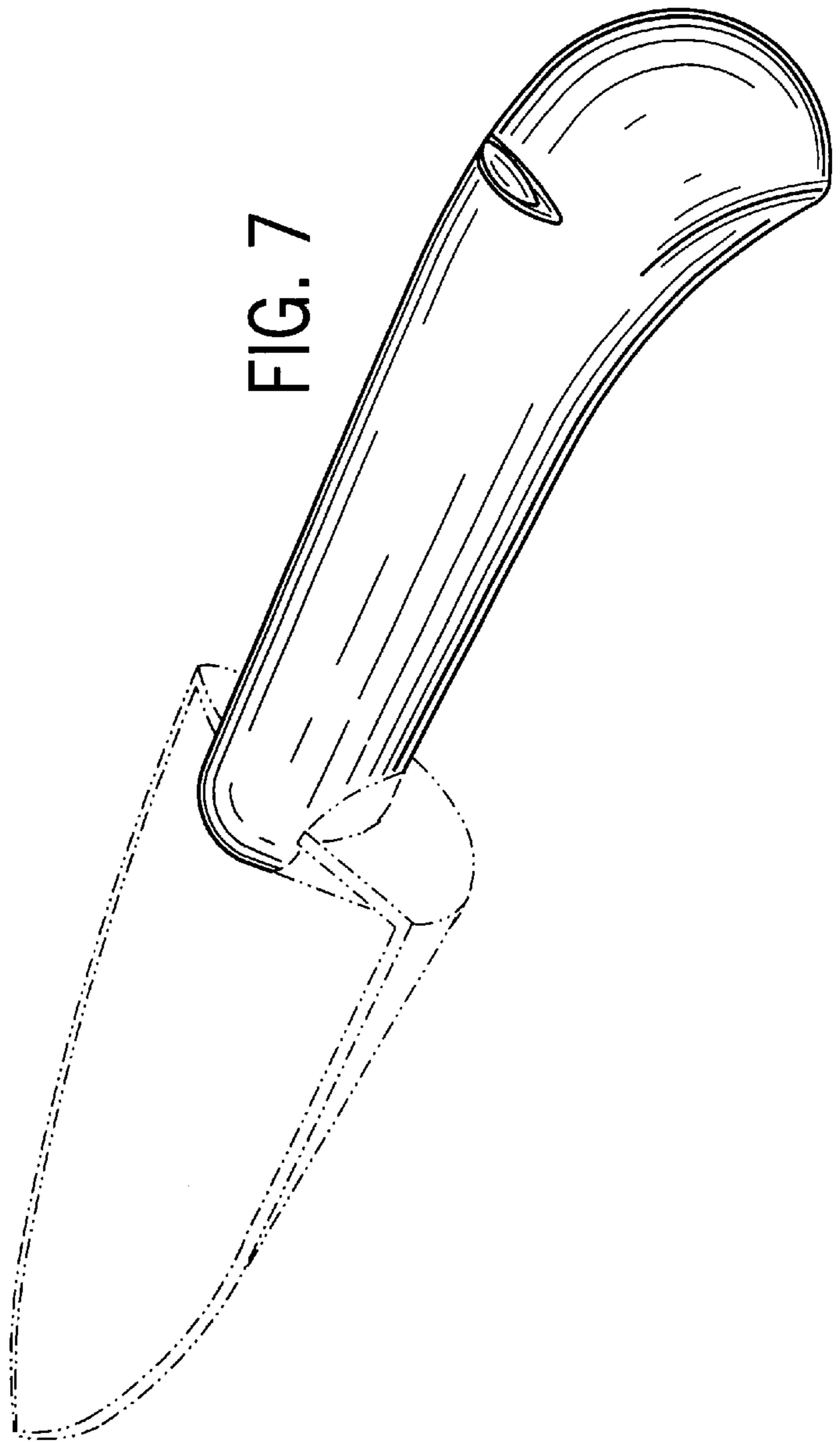
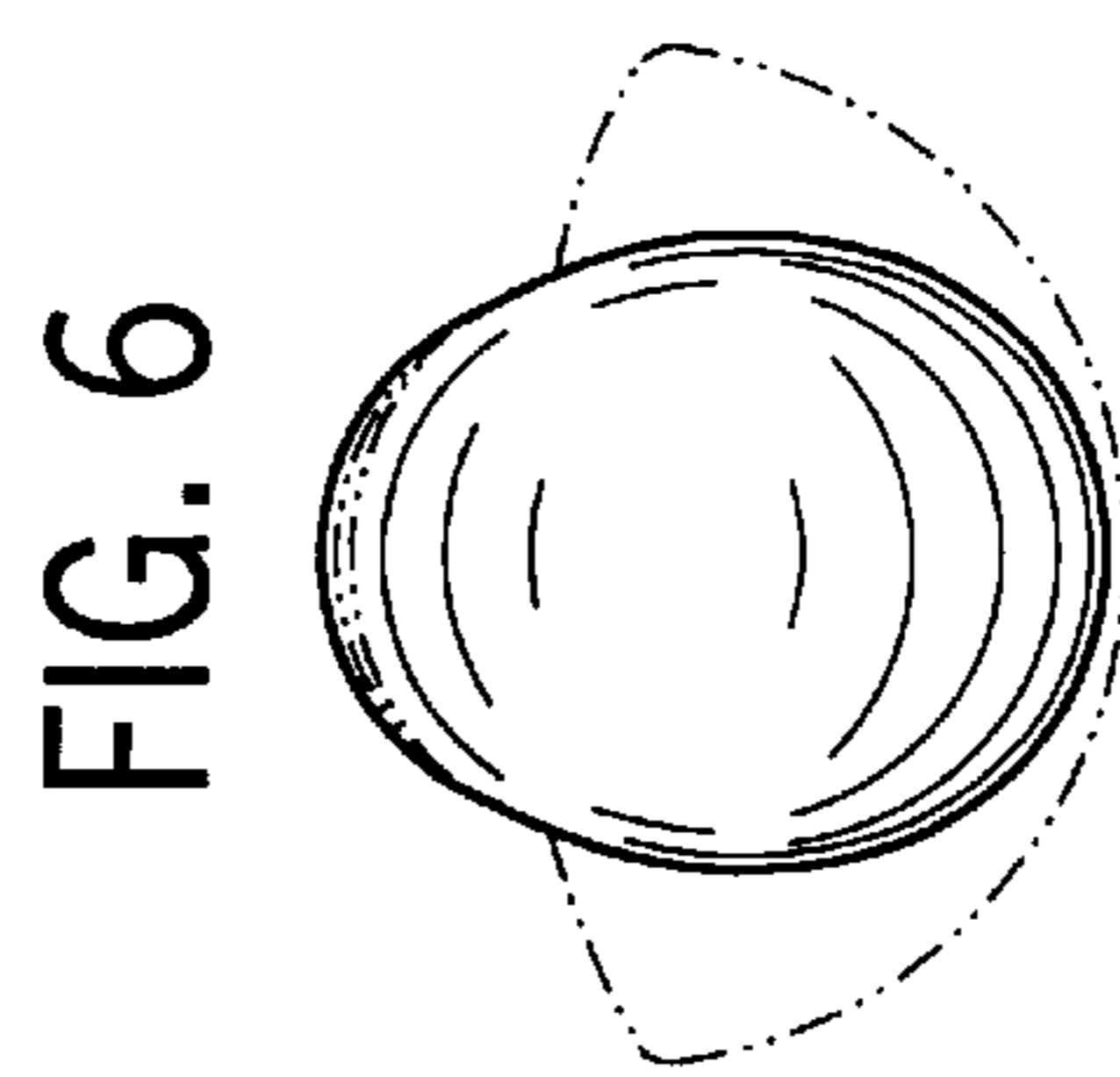
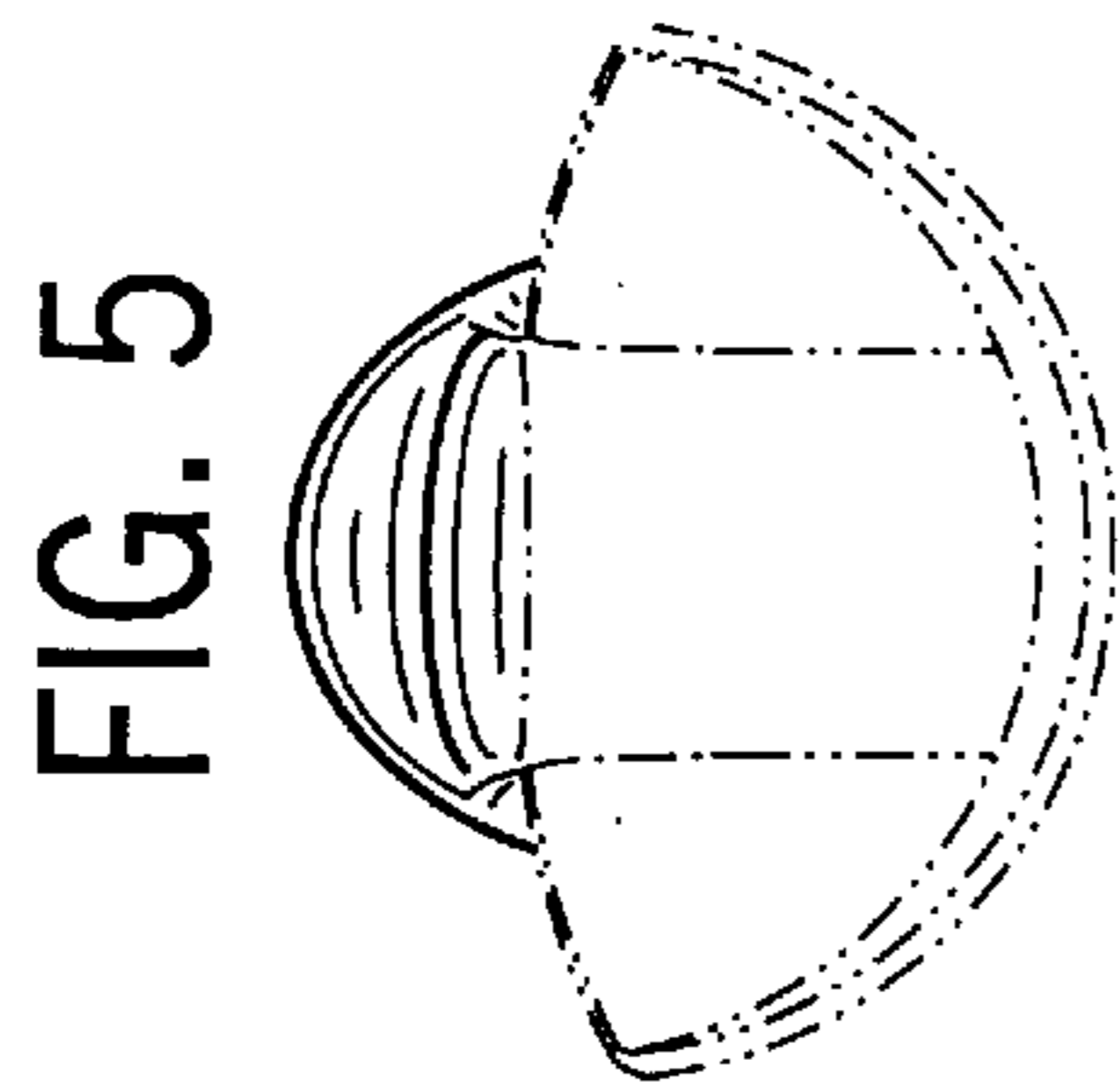
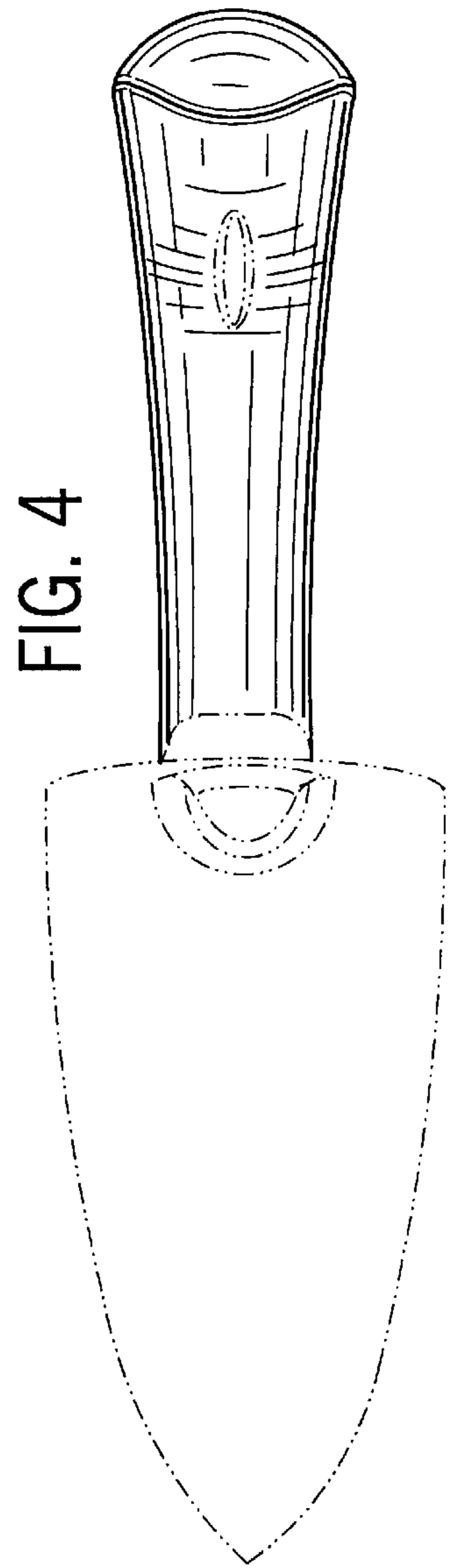
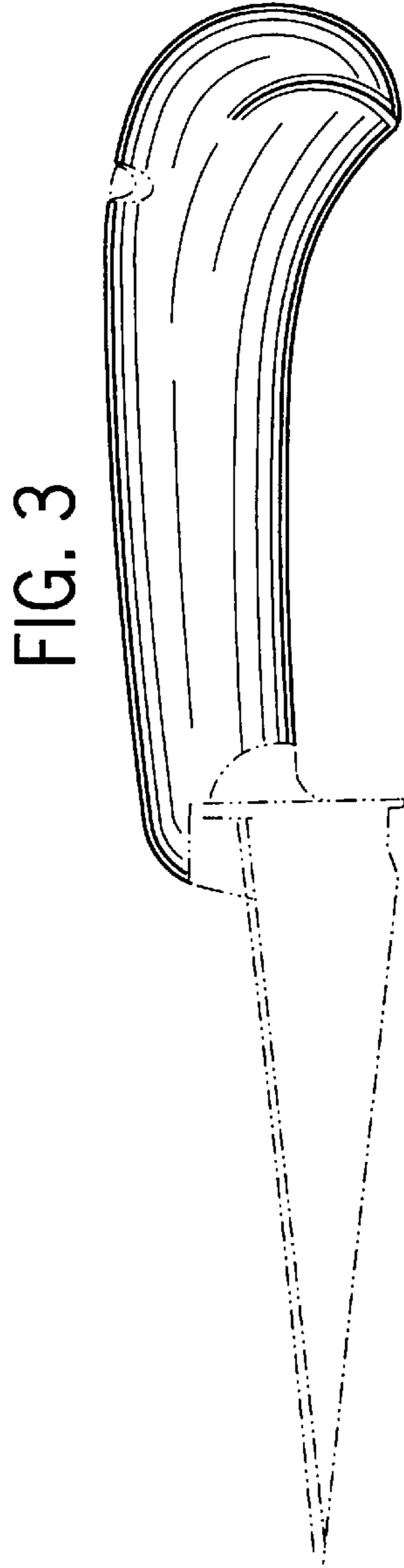
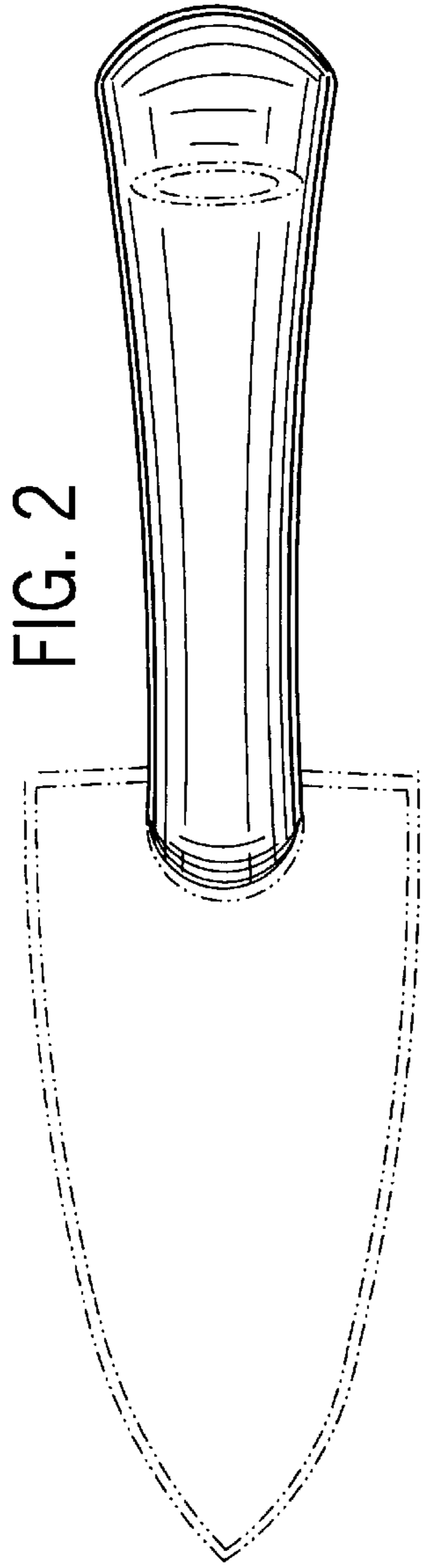
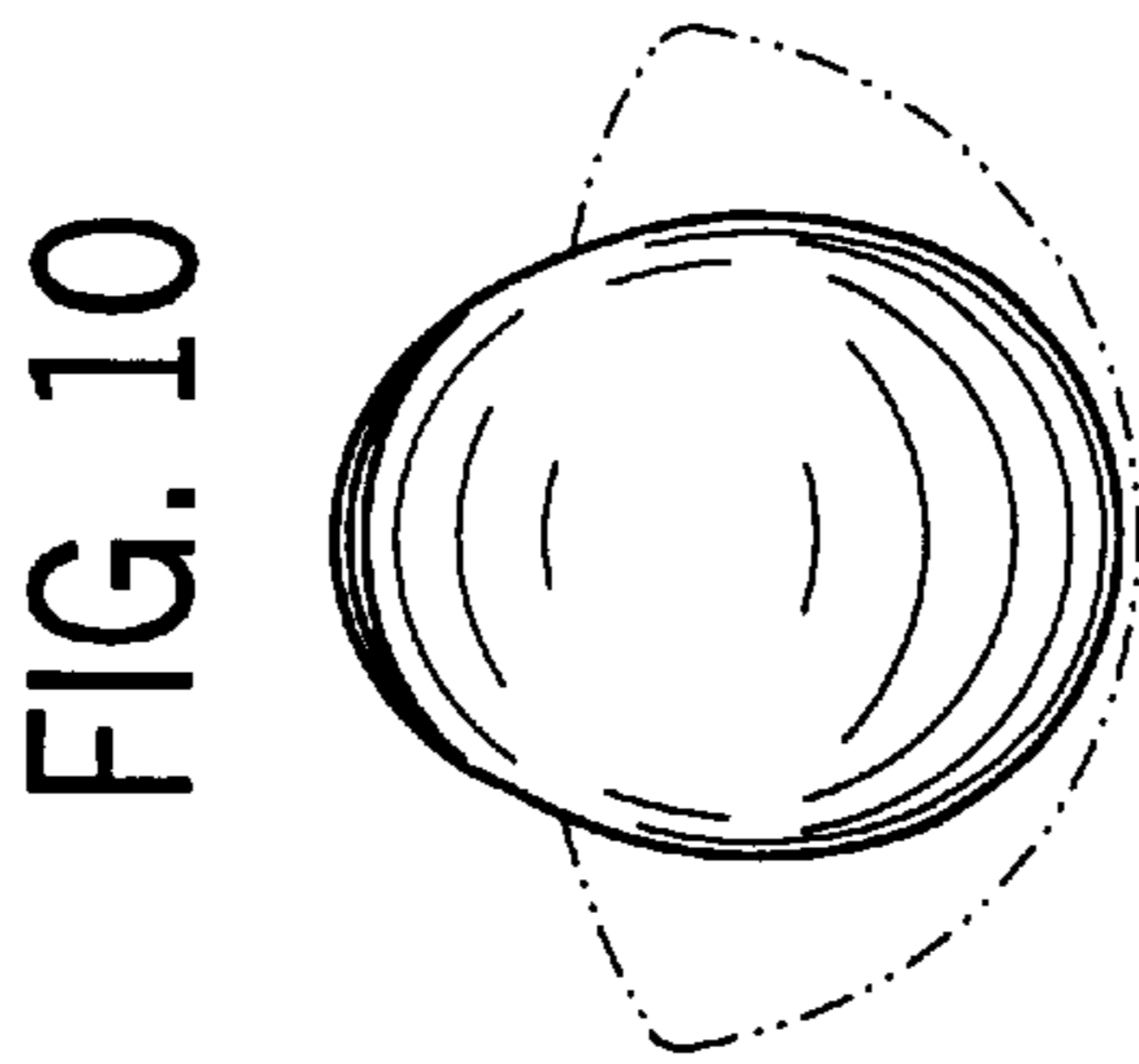
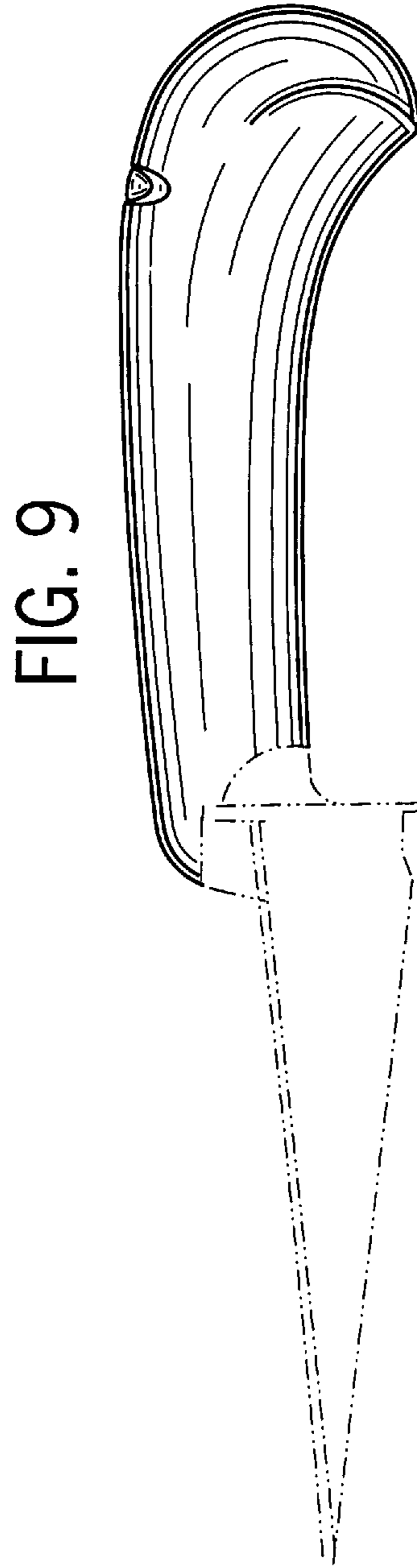
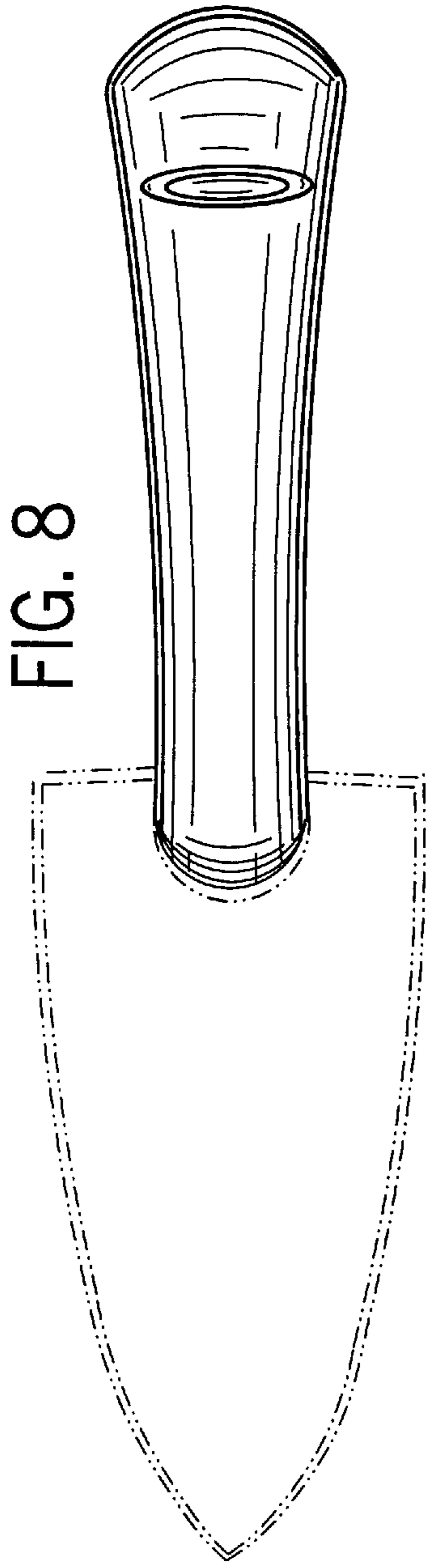

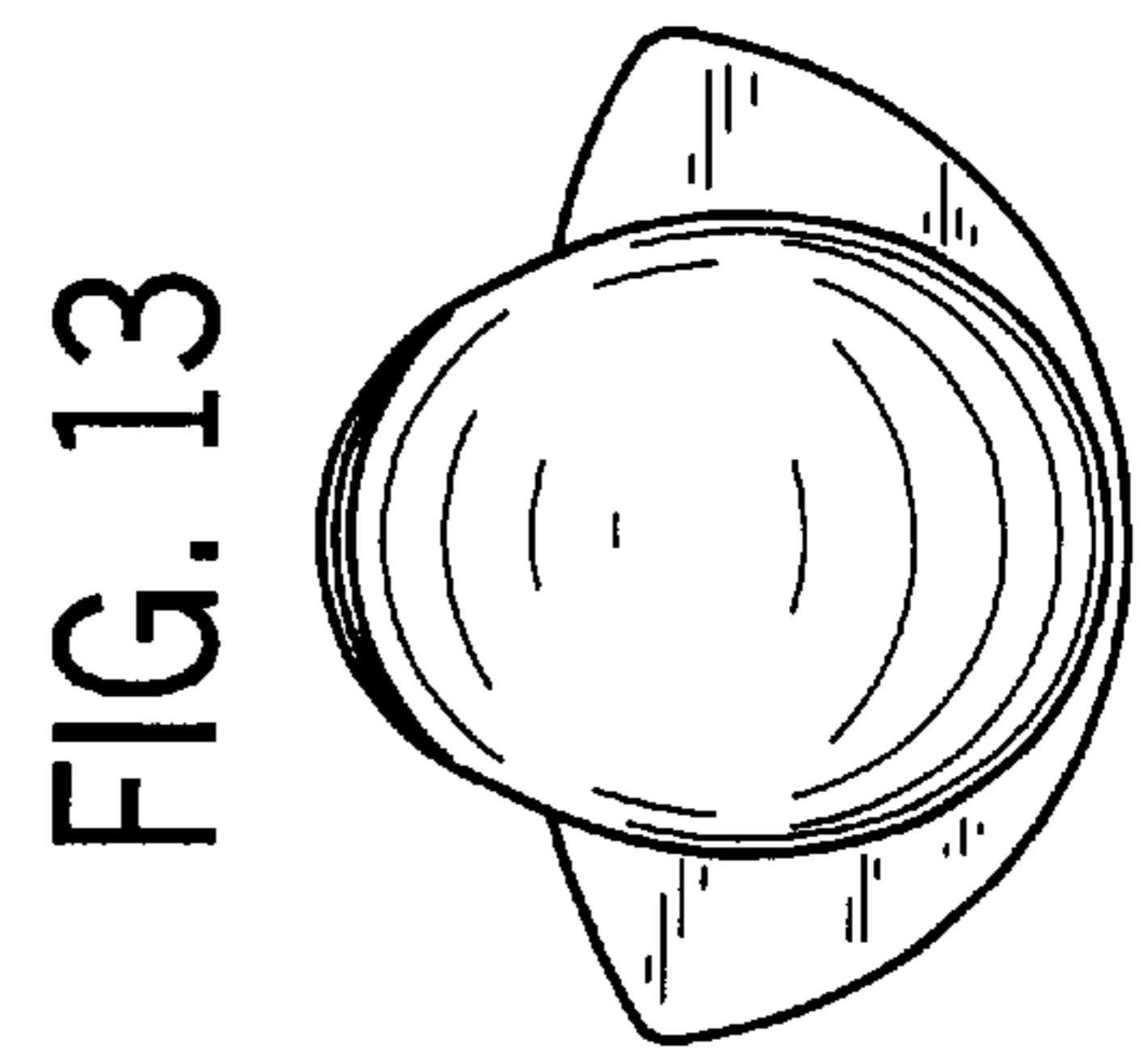
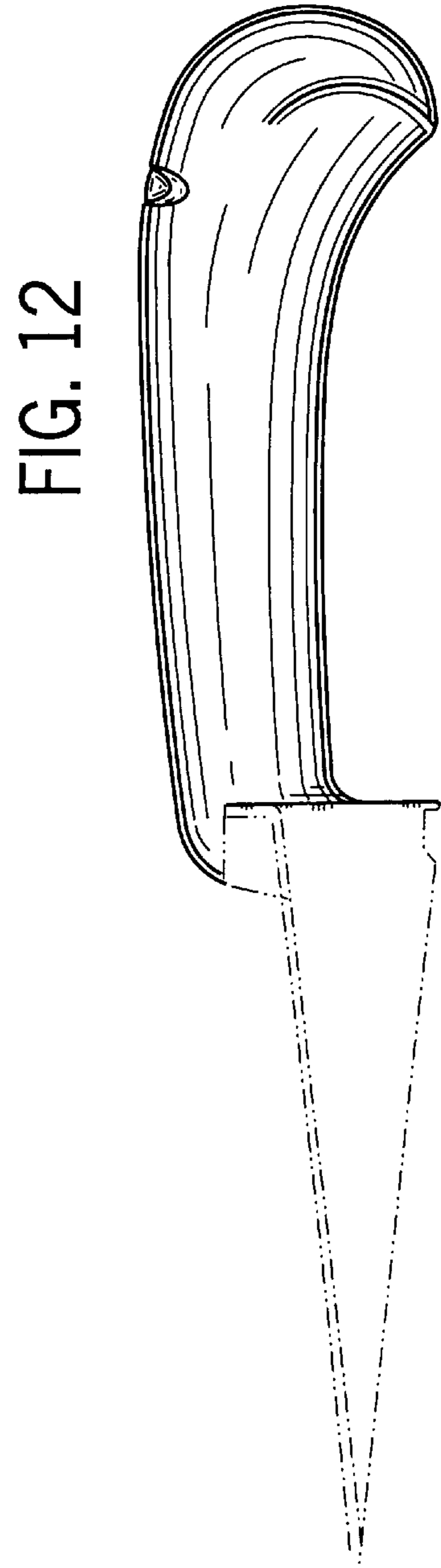
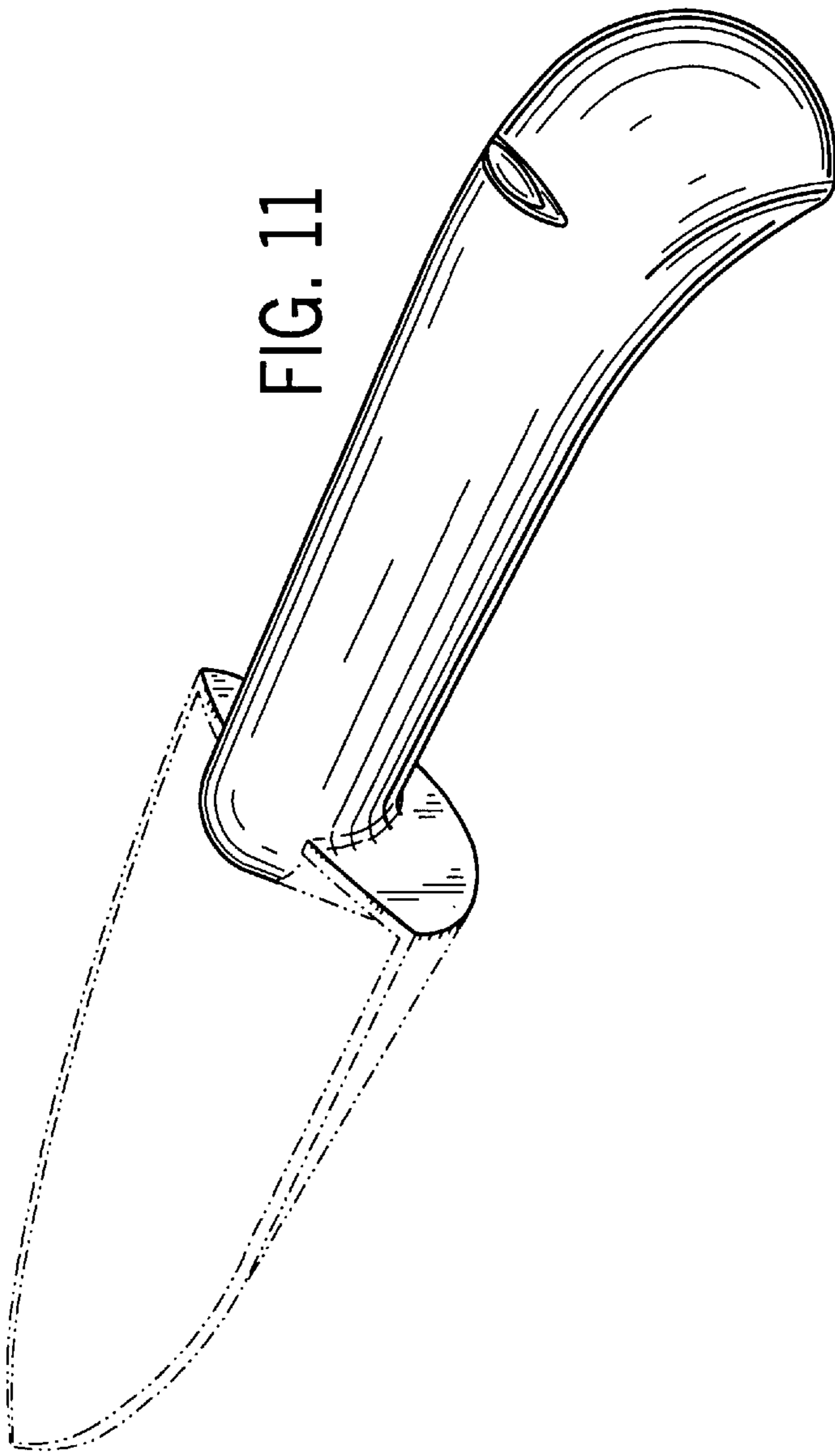

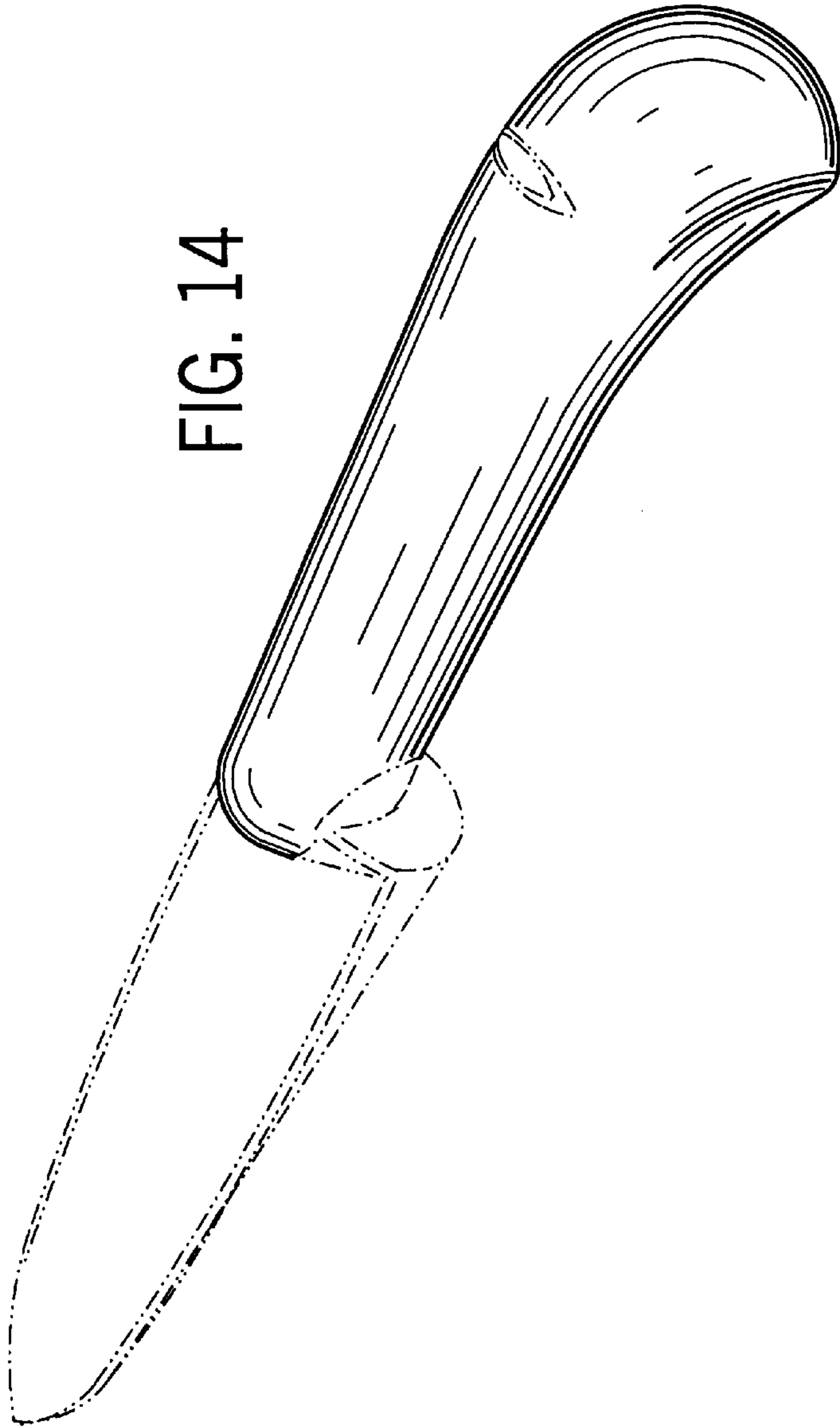

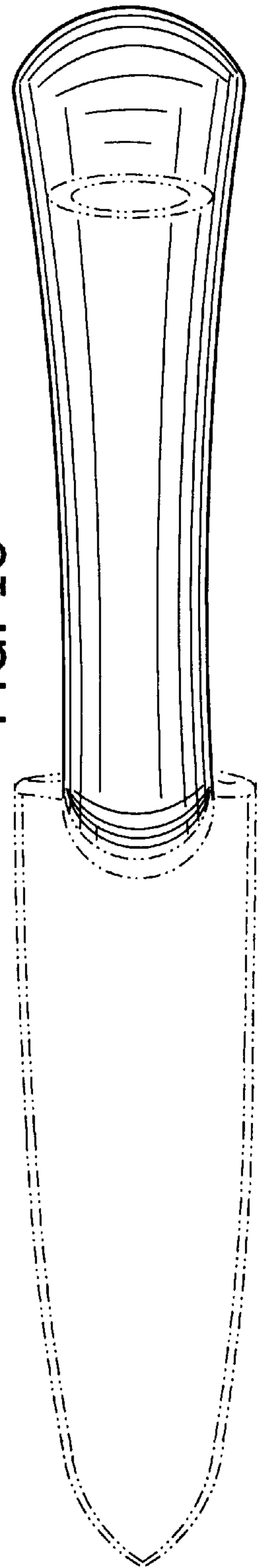

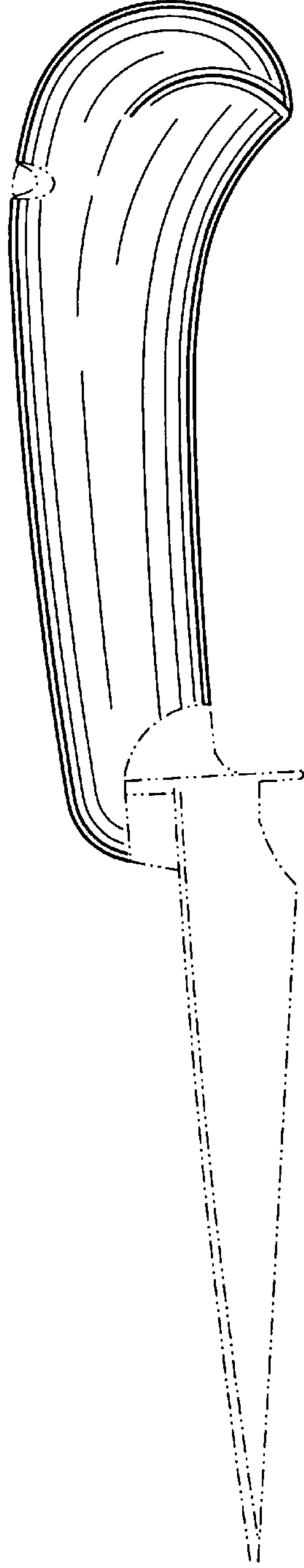

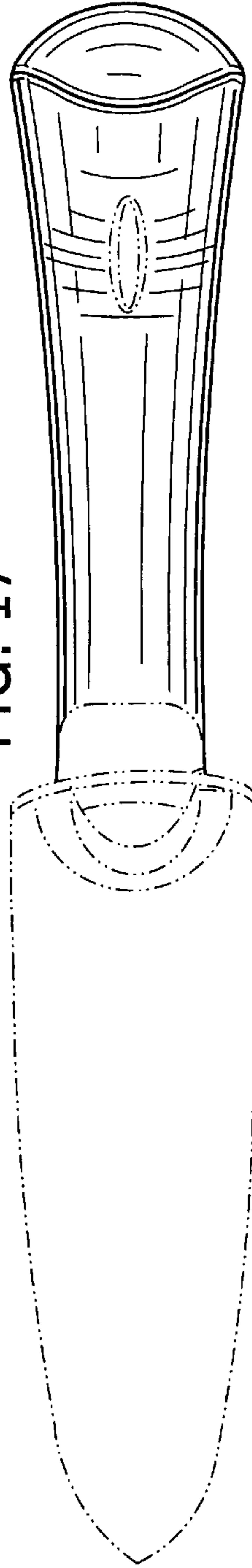

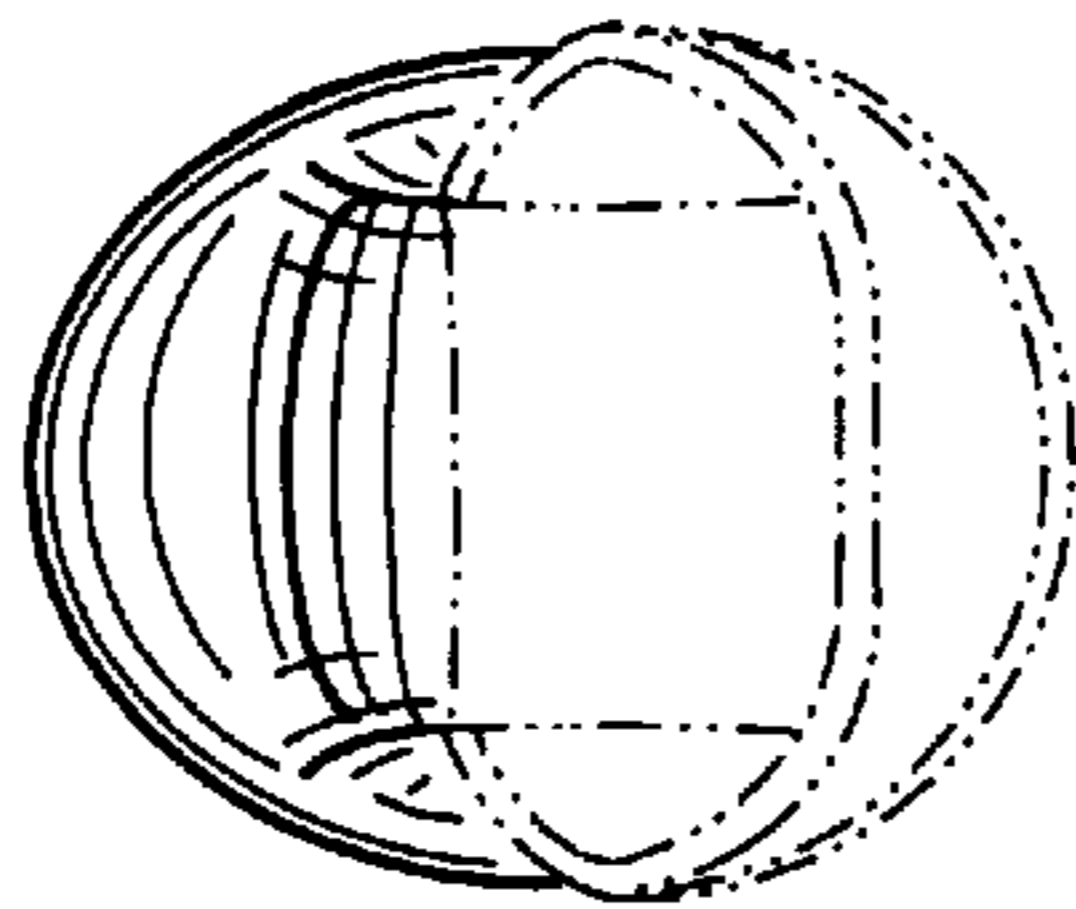
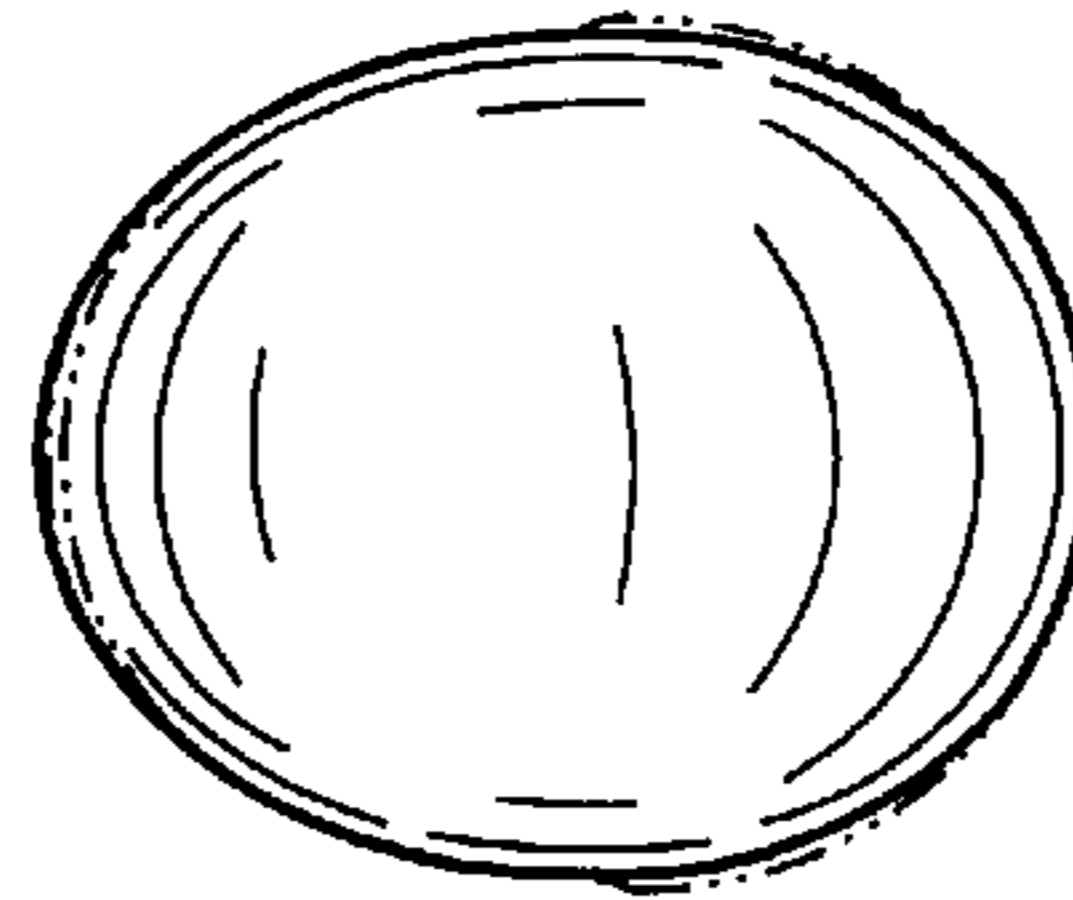

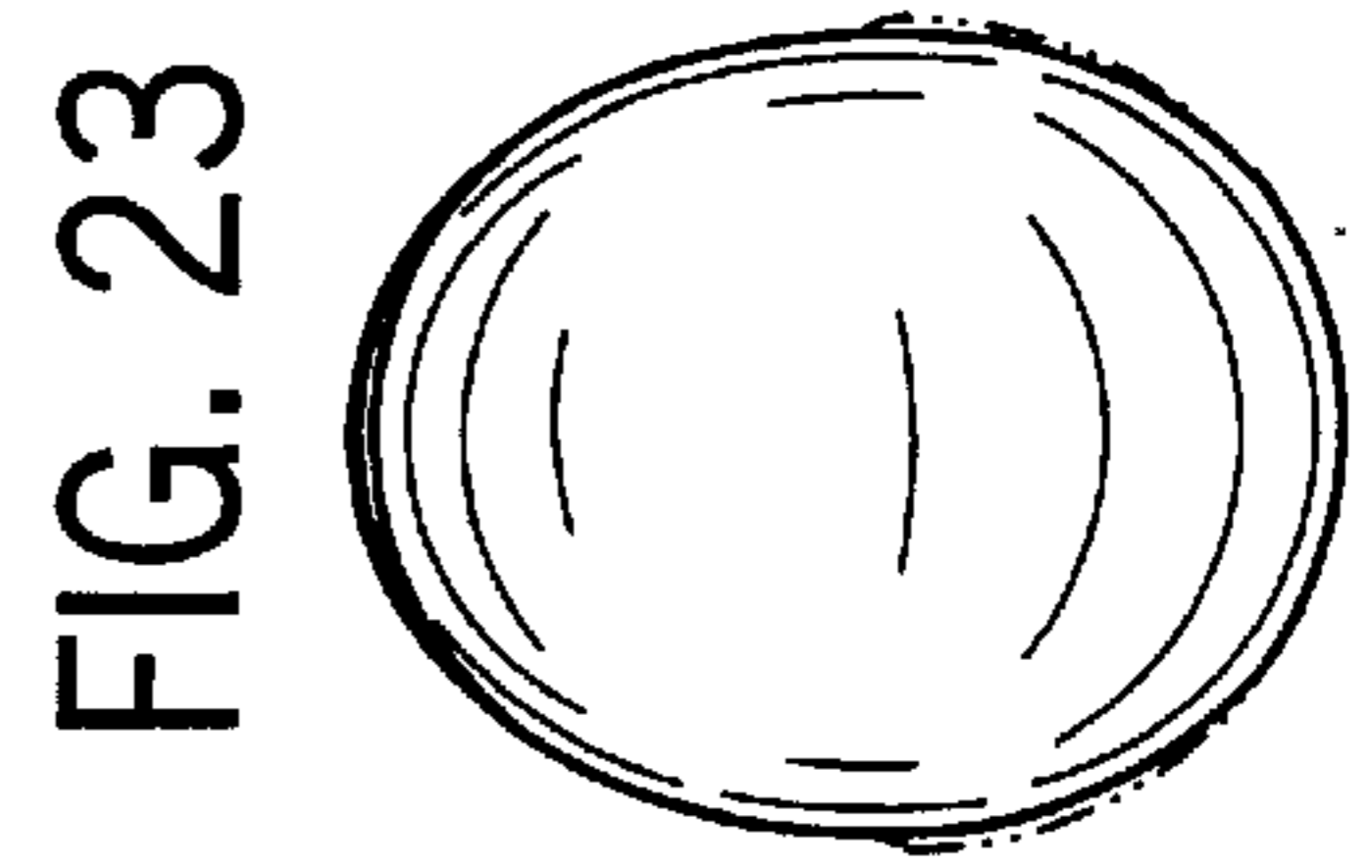
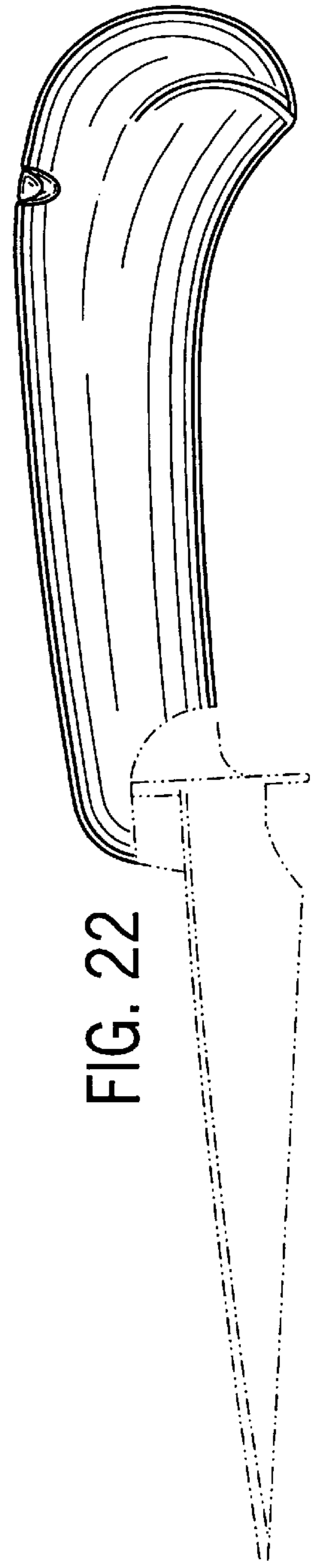
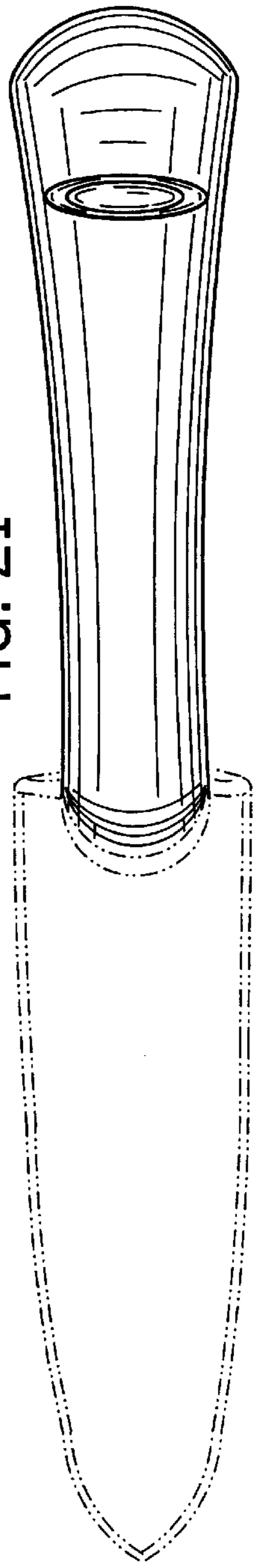
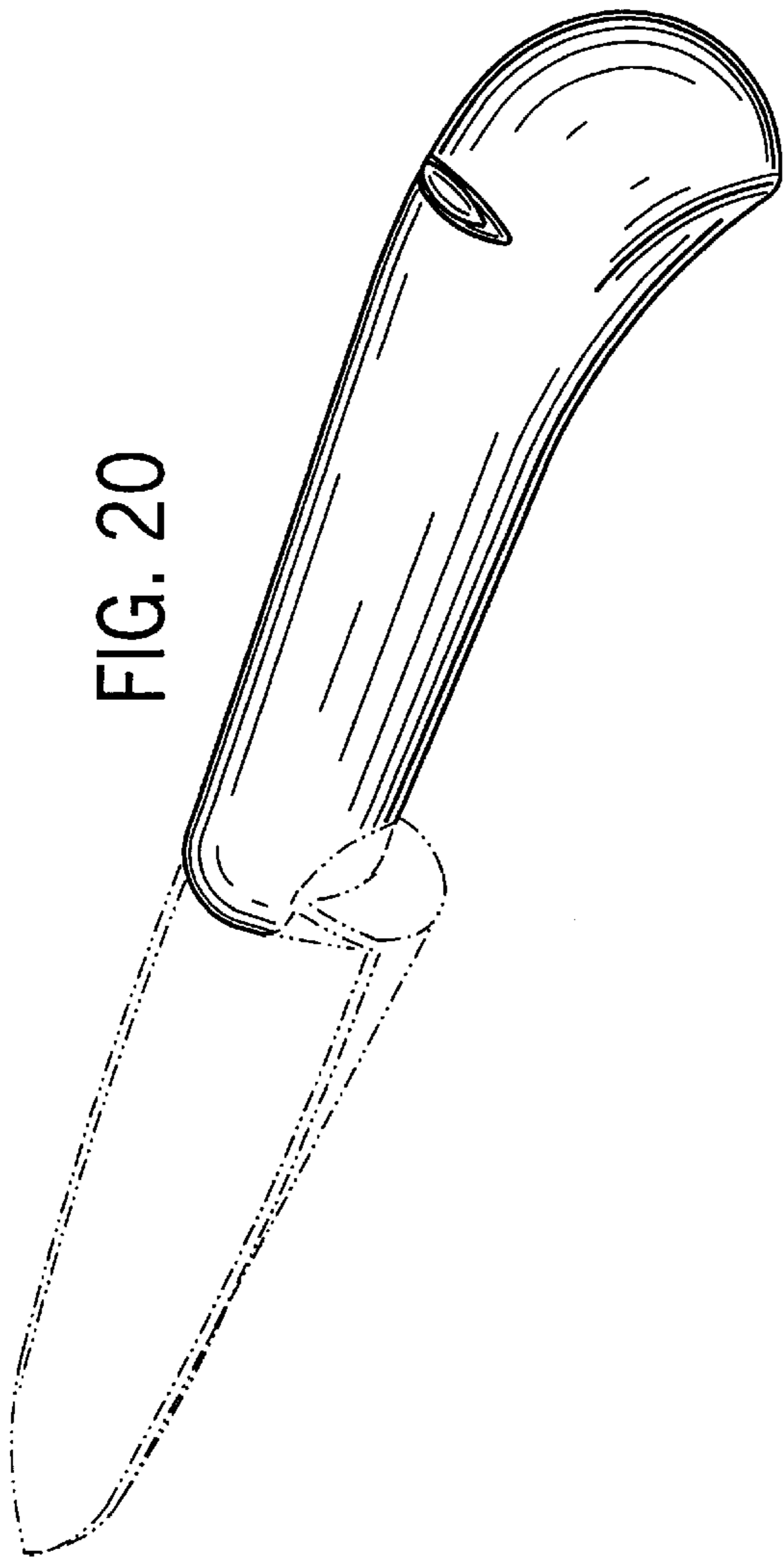

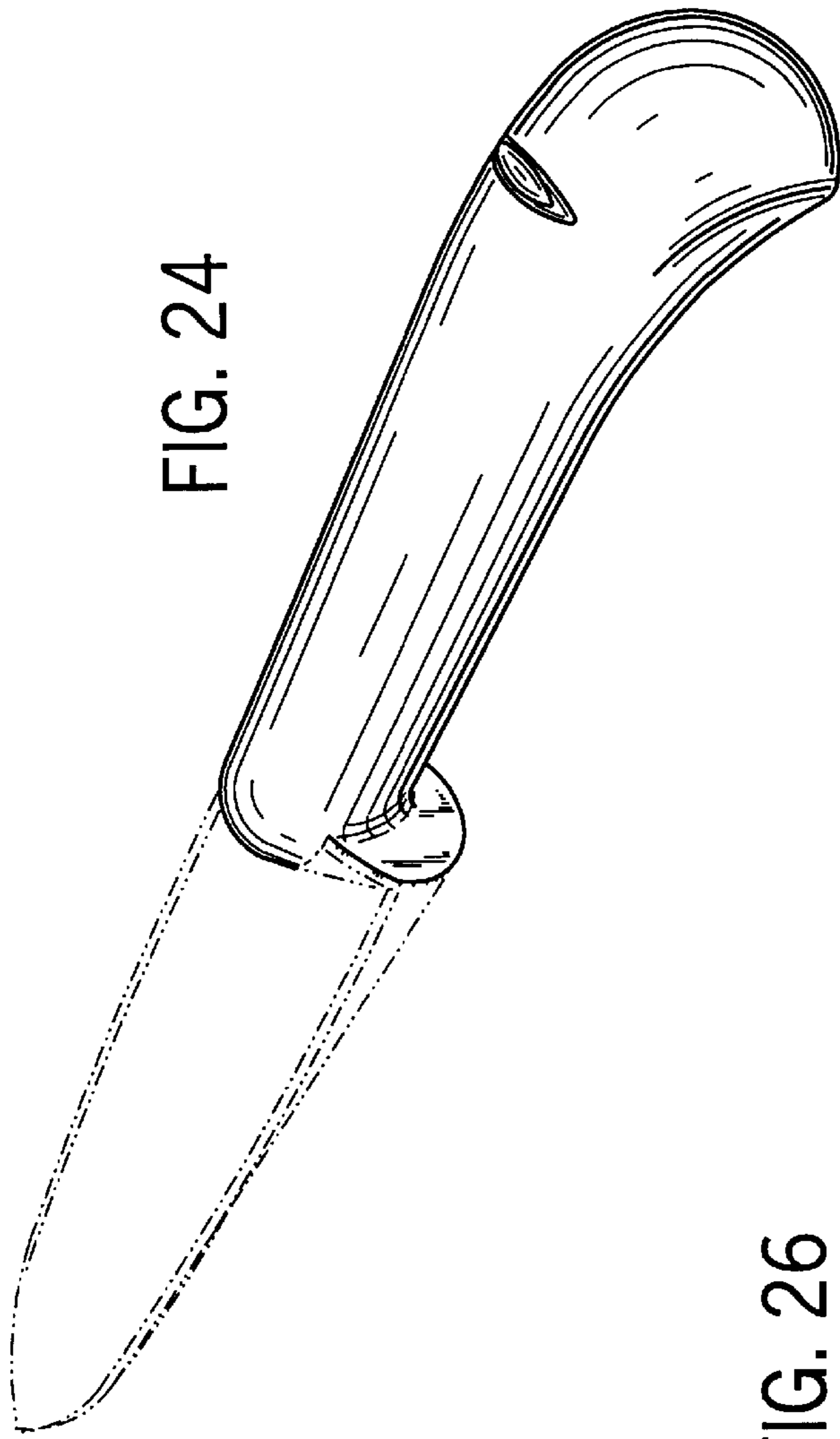

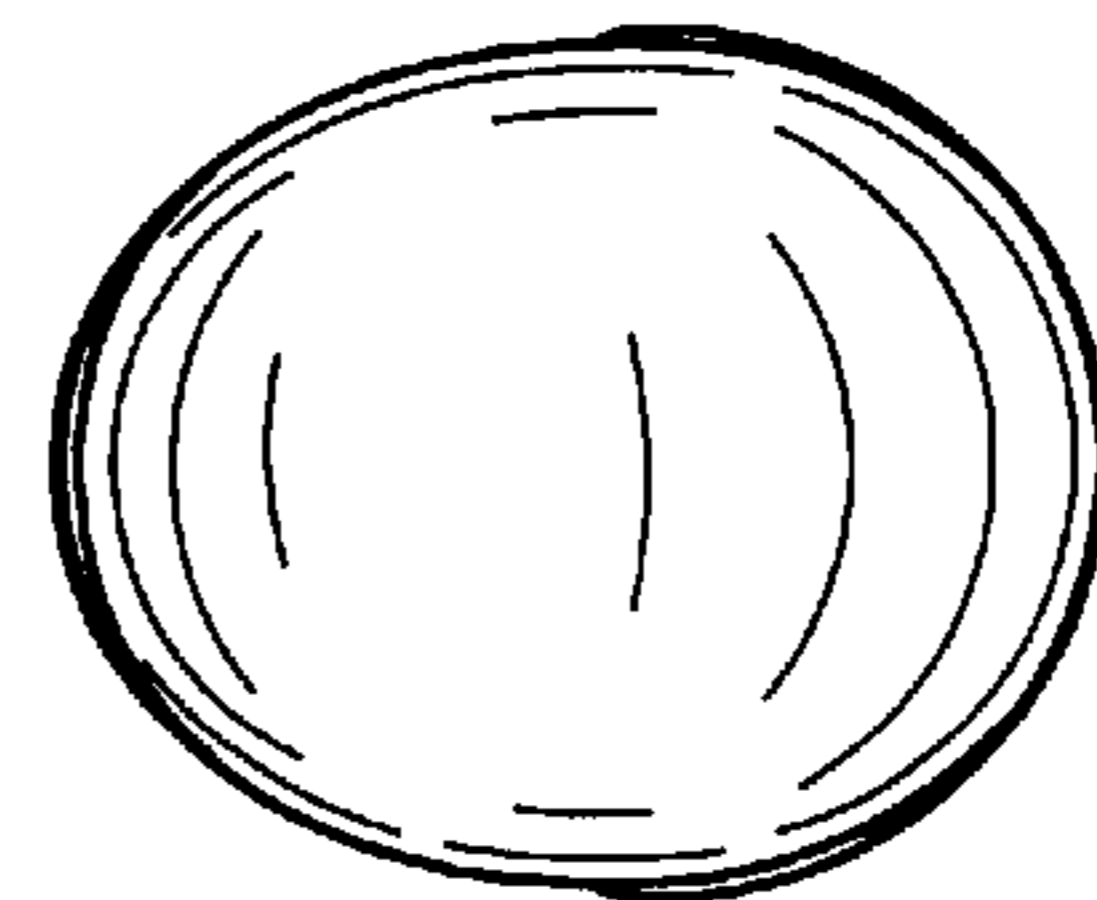
