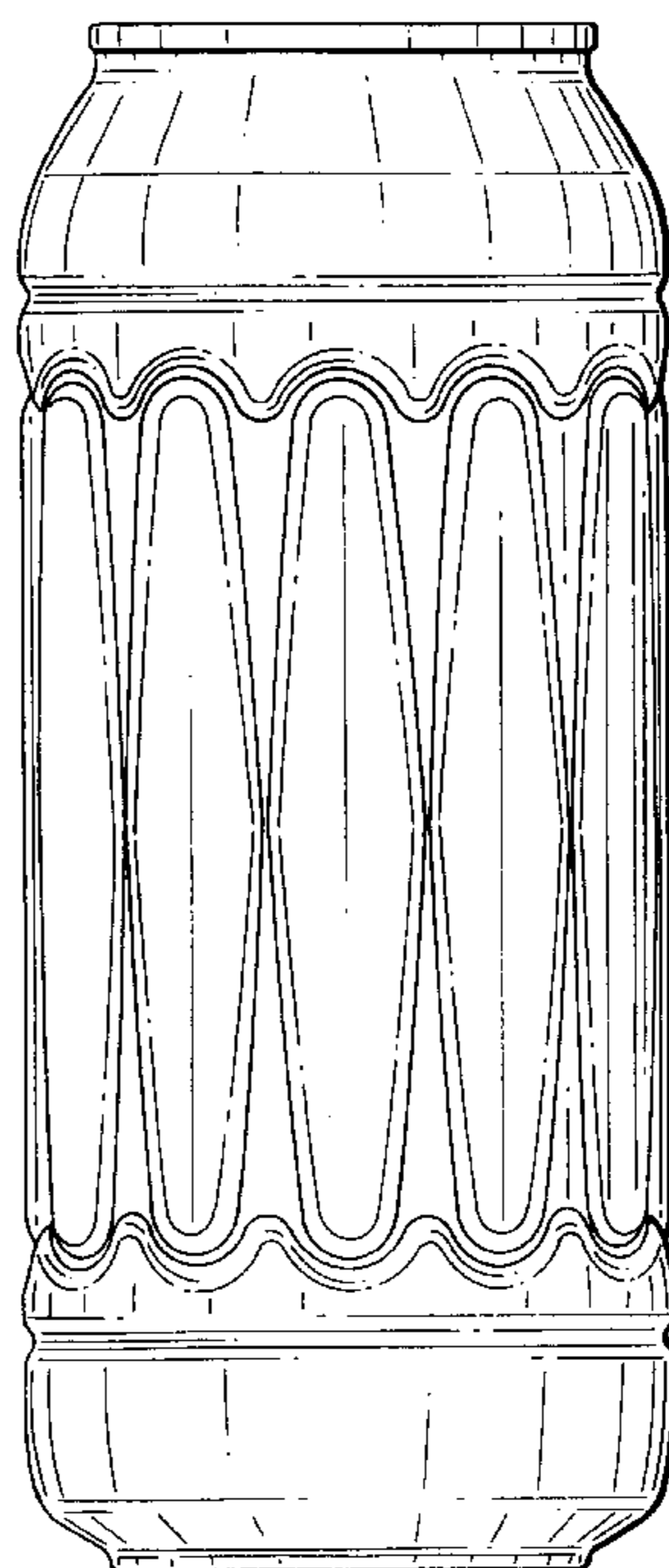
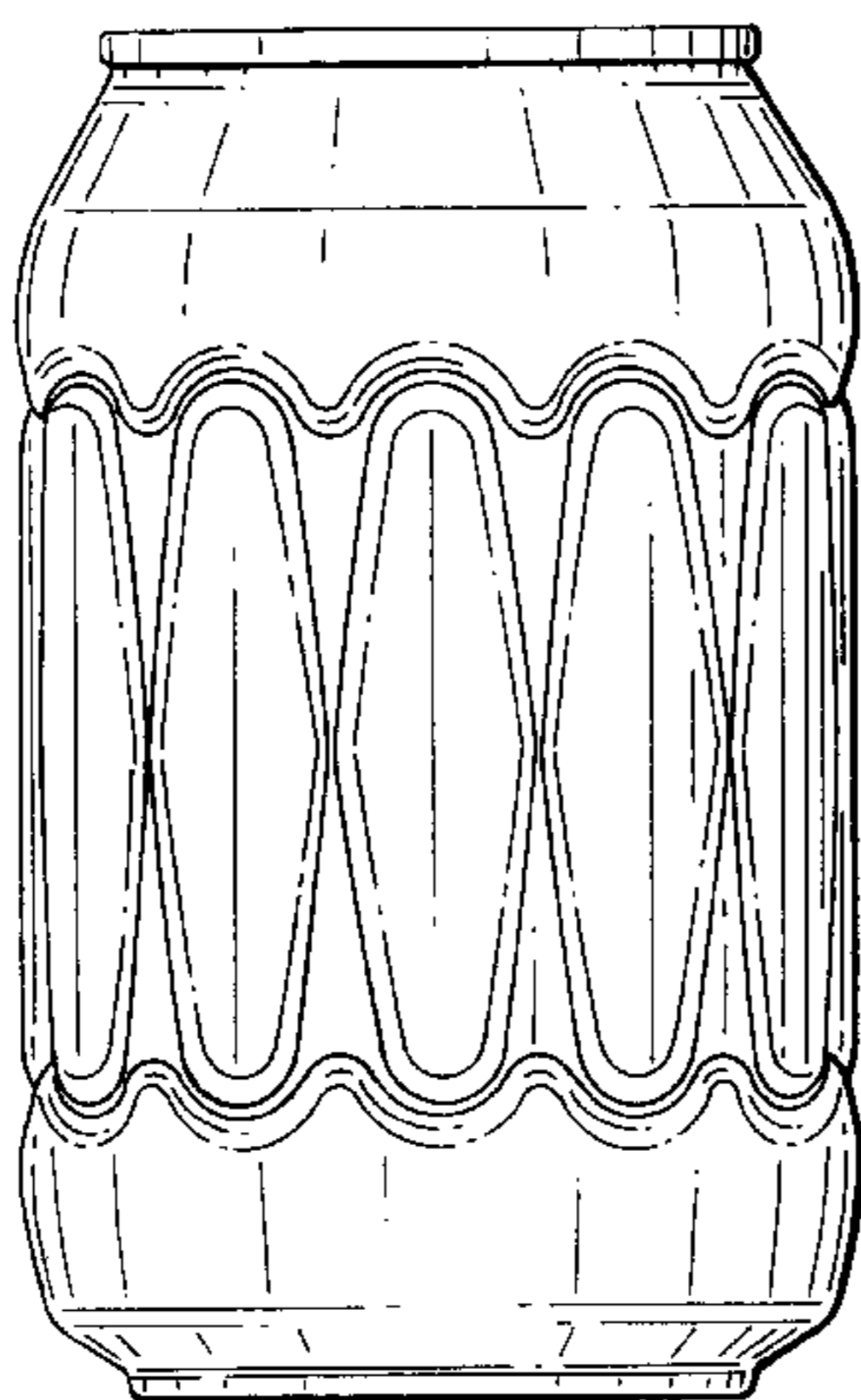
### [57] CLAIM

The ornamental design for a beverage can, as shown and described.

### DESCRIPTION

FIG. 1 is a front elevational view of the cylindrical beverage can showing our new design;  
FIG. 2 is a rear left side elevational view thereof;  
FIG. 3 is a rear right side elevational view thereof;  
FIG. 4 is a front elevational view of the second embodiment of the cylindrical beverage can showing our new design;  
FIG. 5 is a rear left side elevational view thereof; and,  
FIG. 6 is a rear right side elevational view thereof.

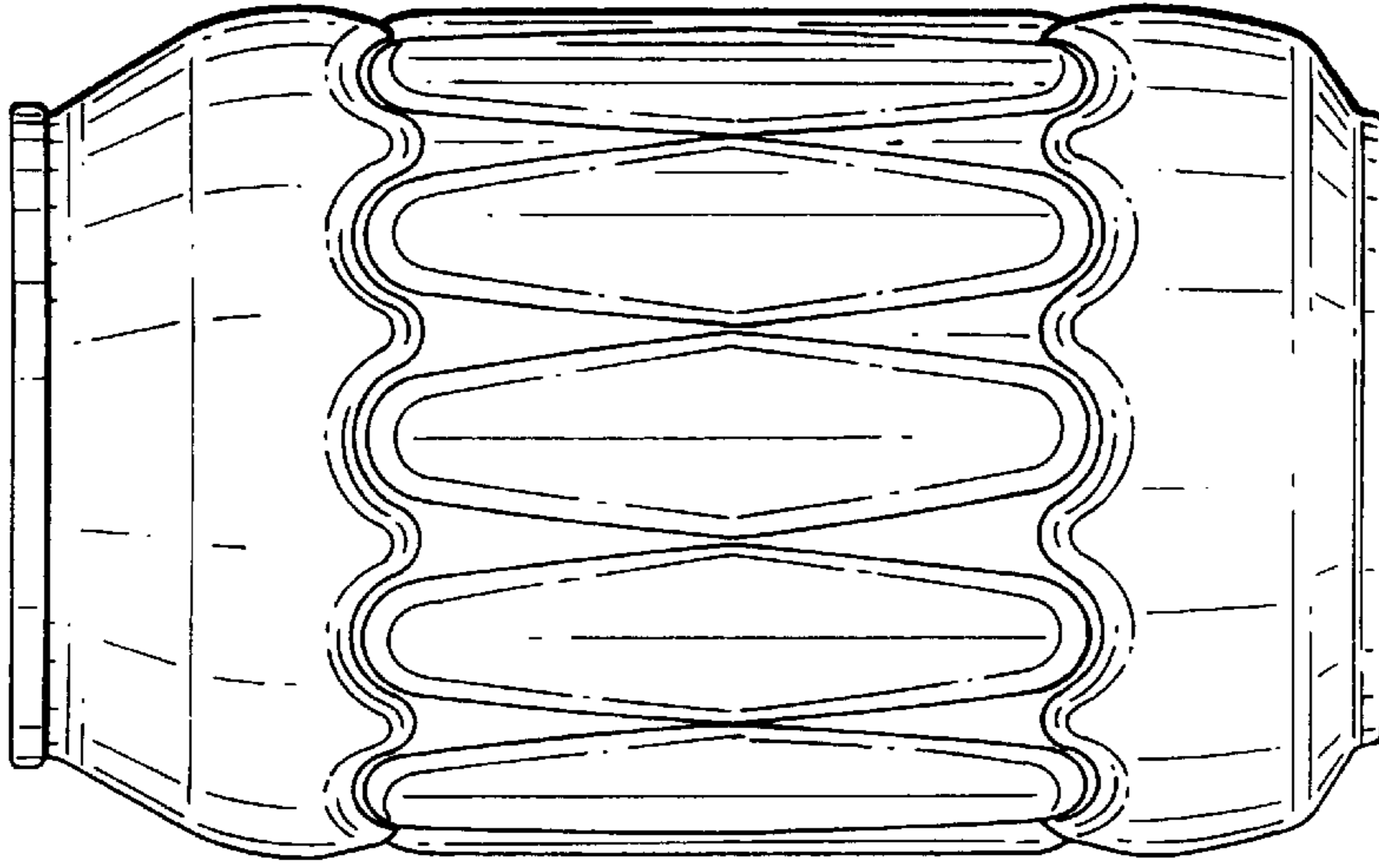

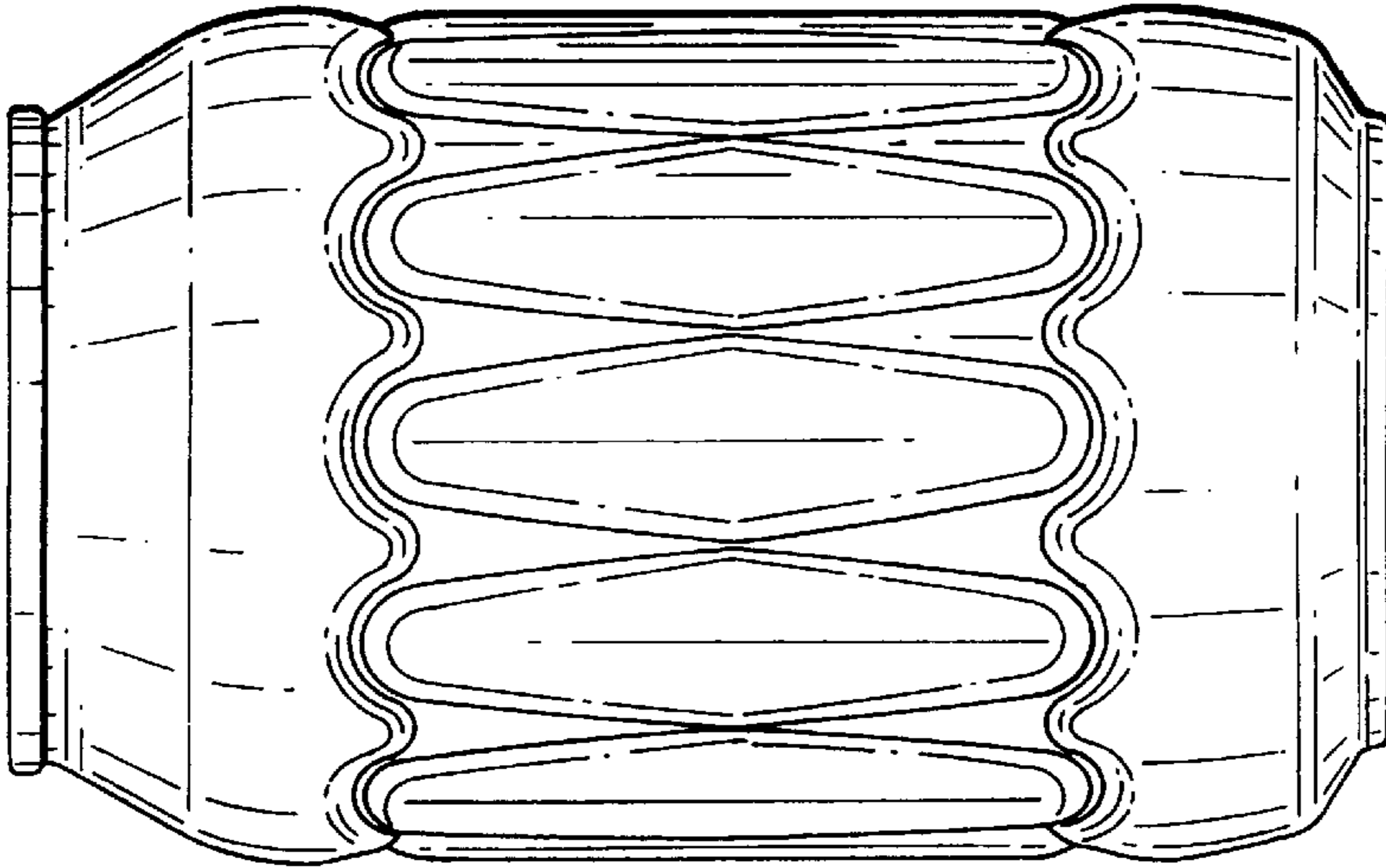

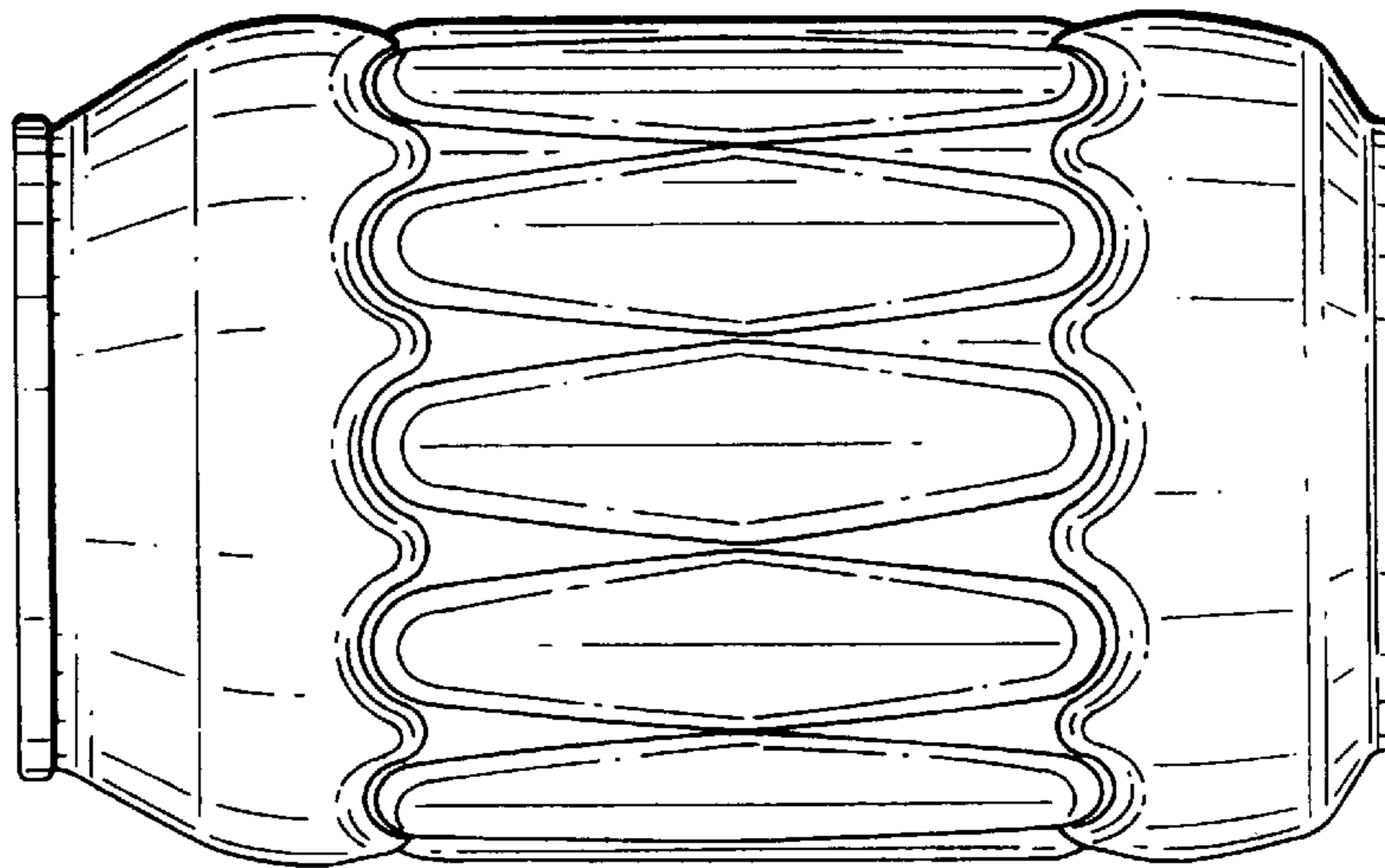

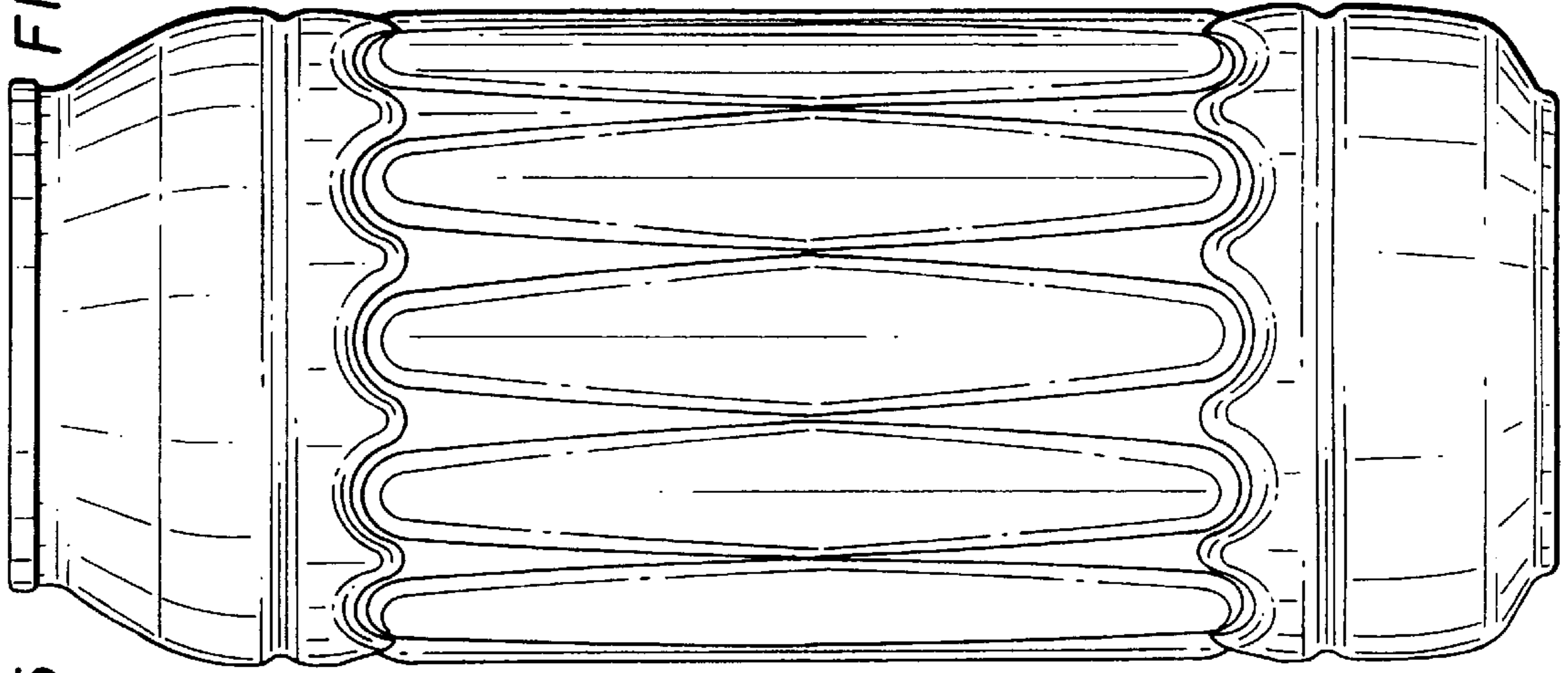

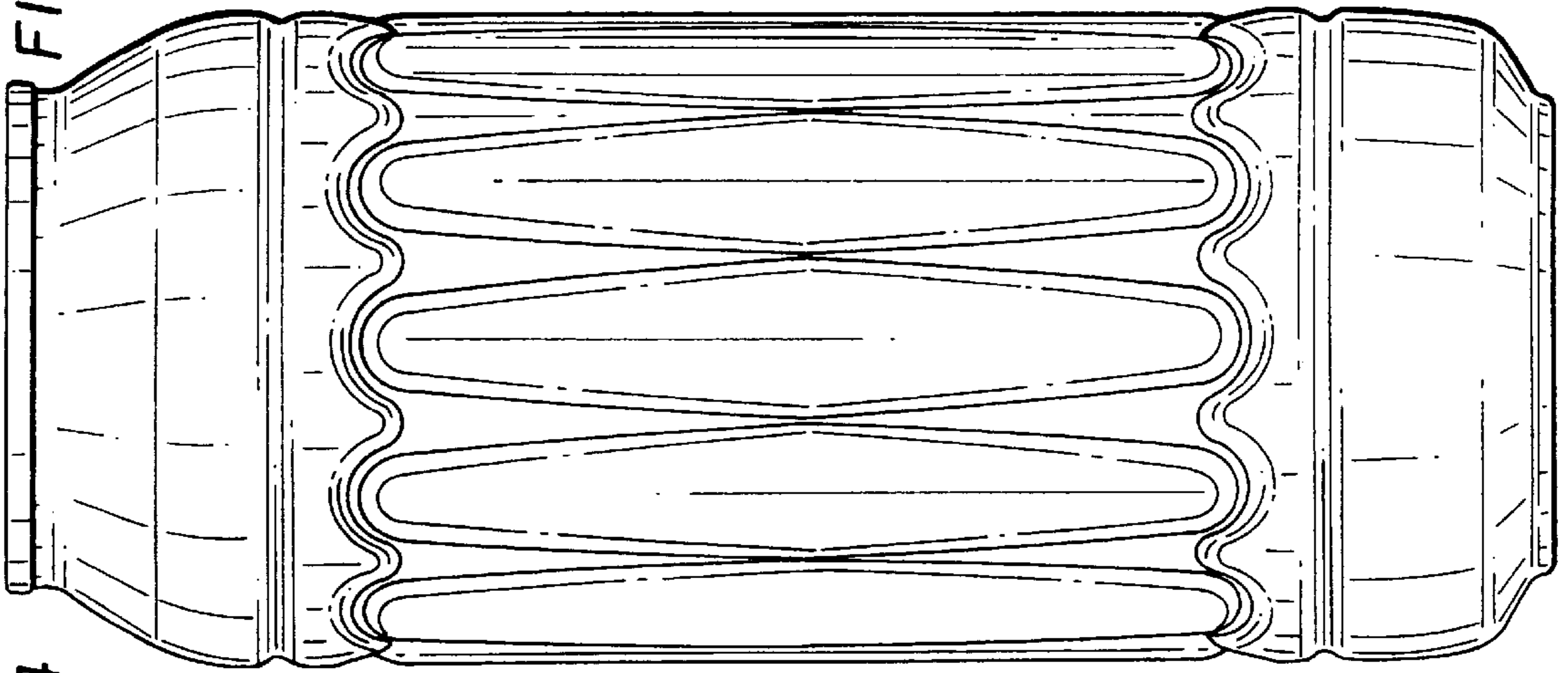
