[57] **CLAIM**

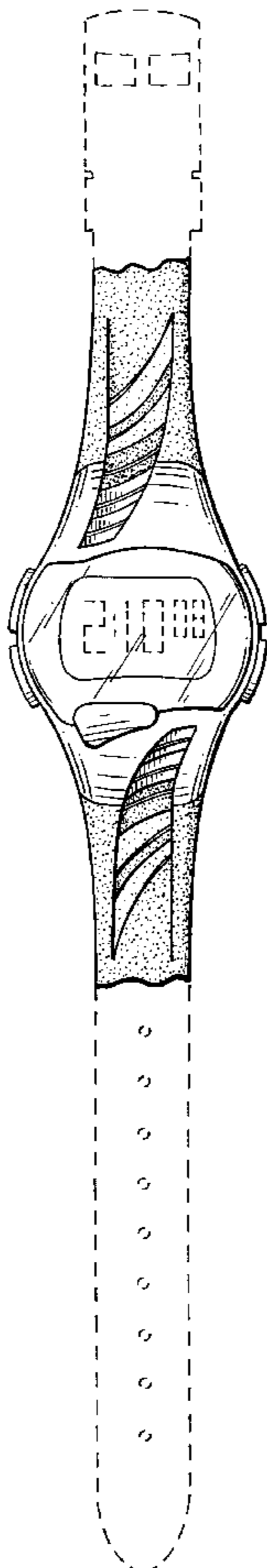
The ornamental design for a watch, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a watch showing my new design; FIG. 2 is a rear plan view thereof; FIG. 3 is a left side view thereof; and, FIG. 4 is a right side view thereof.

The broken line showing of a portion of a watchband in the Figures is environmental only and forms no part of the claimed design.

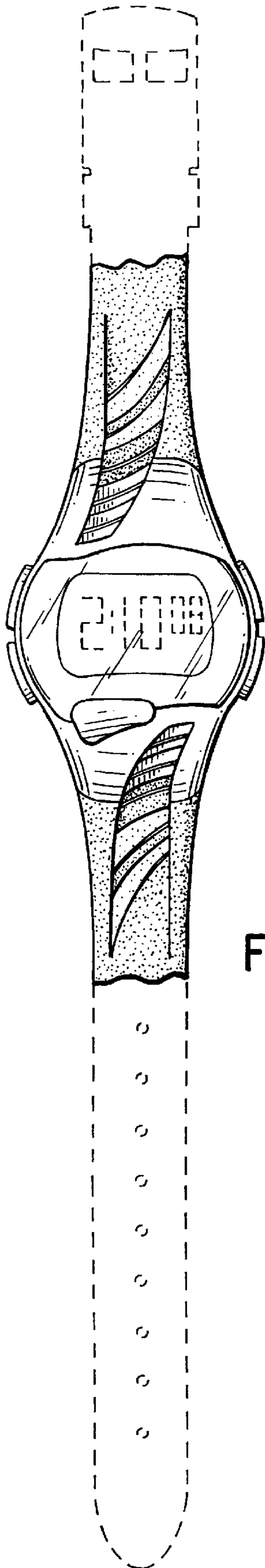

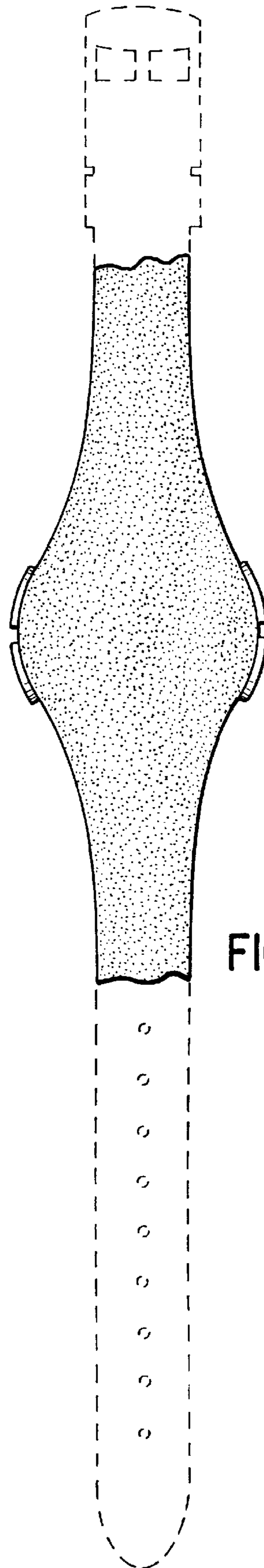

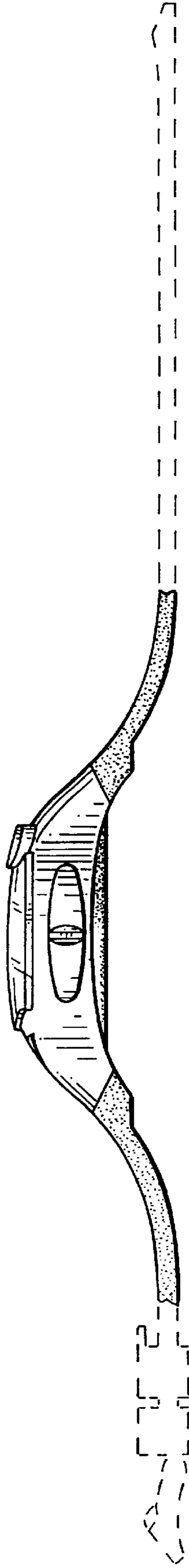

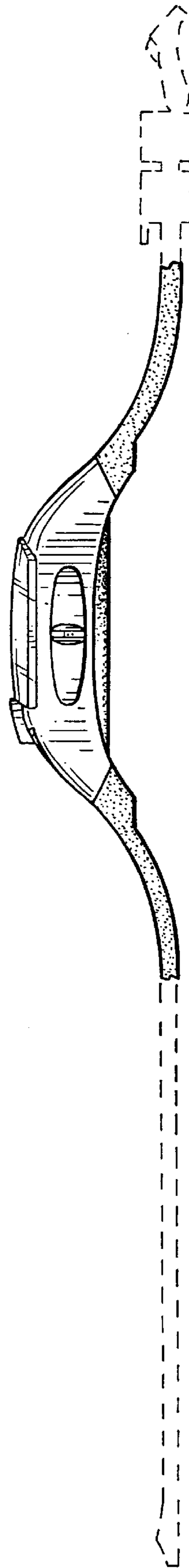
