[57] **CLAIM**

I claim the ornamental design for the watch, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a watch showing my new design.

FIG. 2 is a front elevational view of the dial face only showing the DATE indicator;

FIG. 3 is a front elevational view of the dial face only showing a typical date indication;

FIG. 4 is a front elevational view of the dial face only showing the TIME indicator.

FIG. 5 is a front elevational view of the dial face only showing a typical time indication;

FIG. 6 is a front elevational view of the dial face only showing the ALARM indicator;

FIG. 7 is a front elevational view of the dial face only showing a typical alarm indication;

FIG. 8 is a front elevational view of the dial face only showing the CHRONOGRAPH indicator;

FIG. 9 is a front elevational view of the face only showing a typical indication;

FIG. 10 is a front elevational view of the face only showing the TIMER indicator;

FIG. 11 is a front elevational view of the face only showing a typical timer indication;

FIG. 12 is a front elevational view of all possible “second” indication of the inner dial face, 0-59;

FIG. 13 is a left side elevational view of the watch;

FIG. 14 is a an inverted top plan view of the watch;

FIG. 15 is a right side elevational view of the watch;

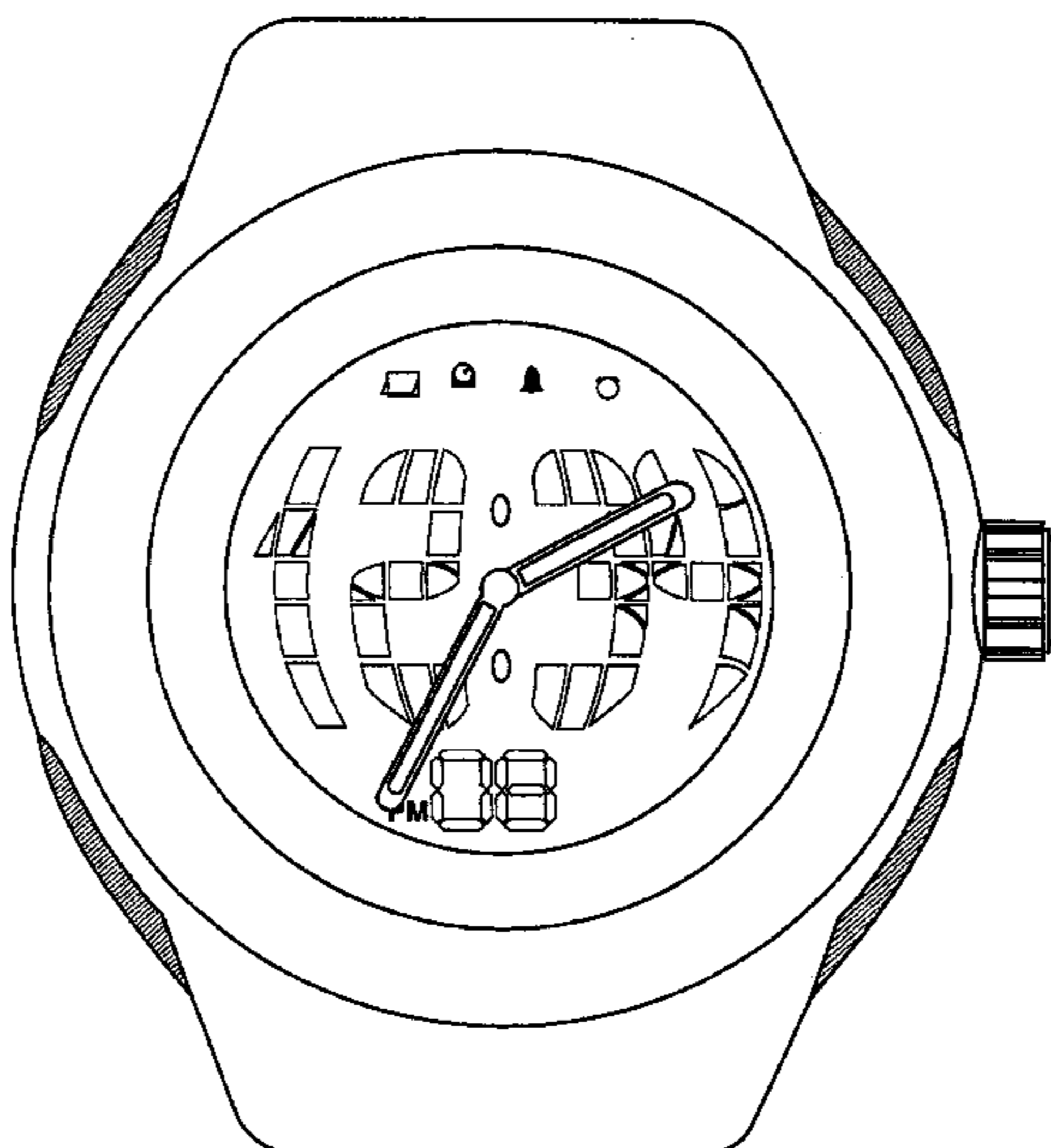
FIG. 16 is a bottom plan view of the watch; and,

FIG. 17 is a left-front and bottom perspective view of the watch.

The broken line showings of a band in FIGS. 13-17 are environmental only and form no part of the claimed design; and in FIGS. 2-12, the watchcase, bezel, and hands have been omitted for ease of illustration.

The back view of the claimed invention is unornamented.

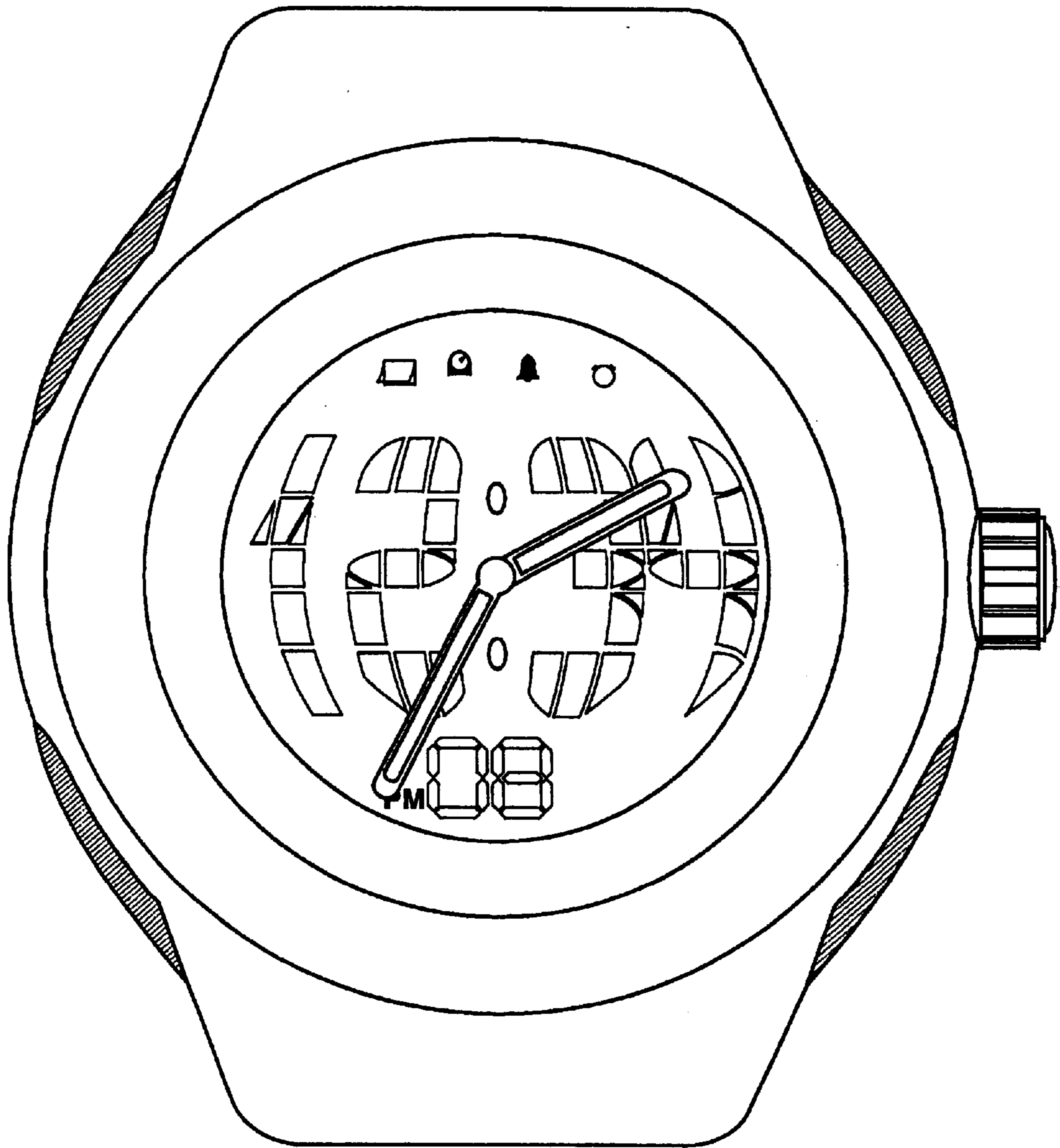

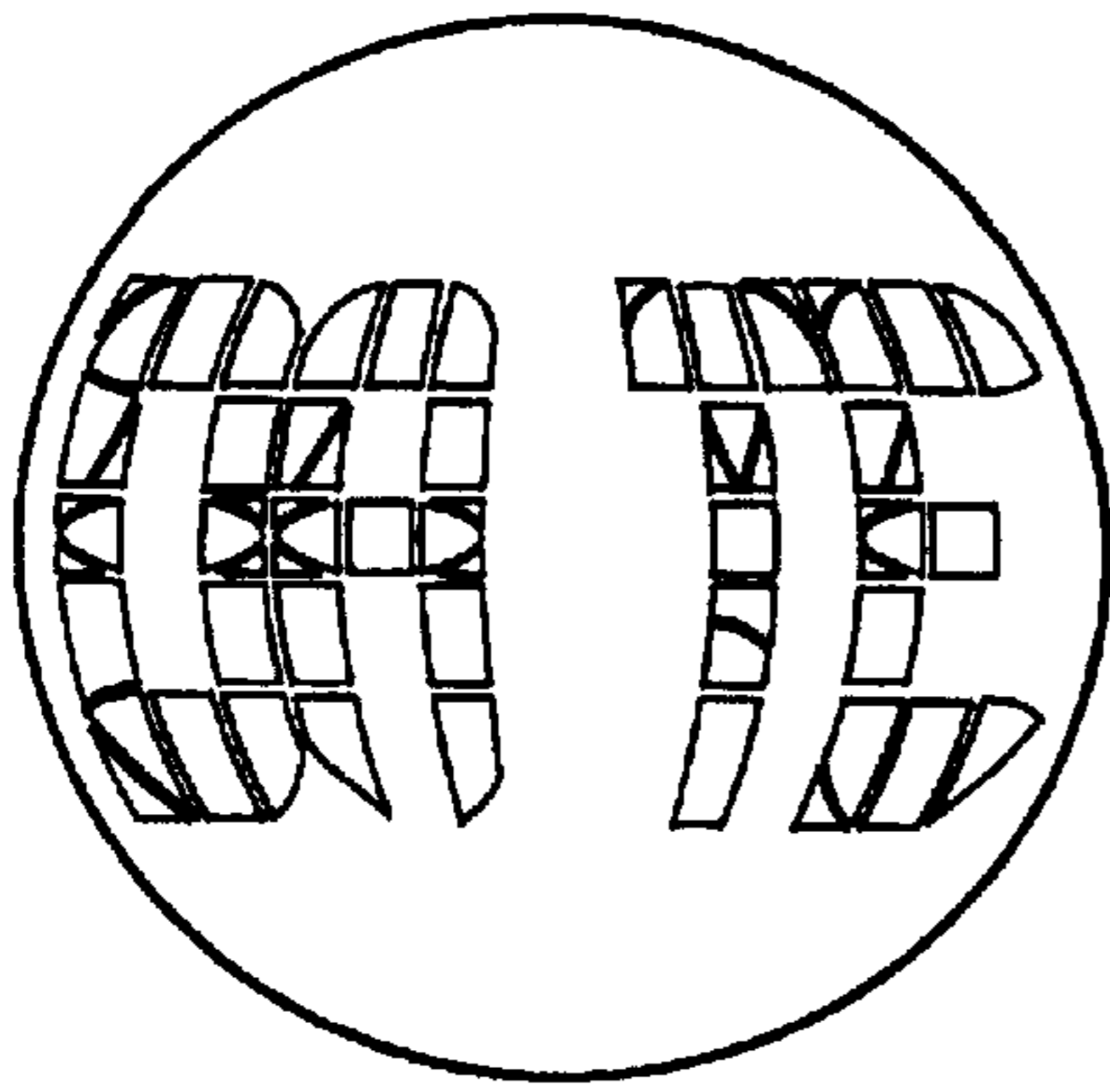

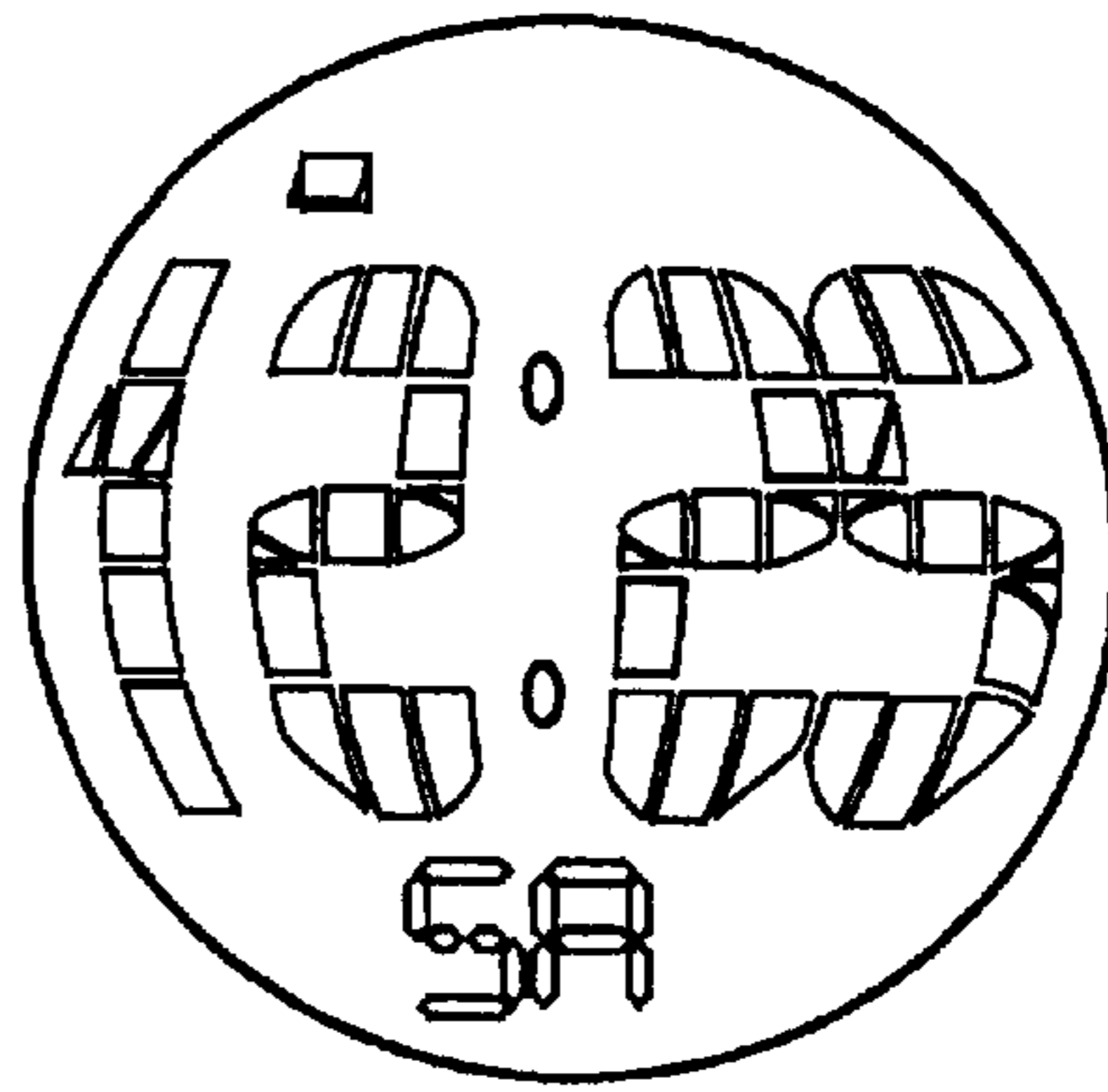

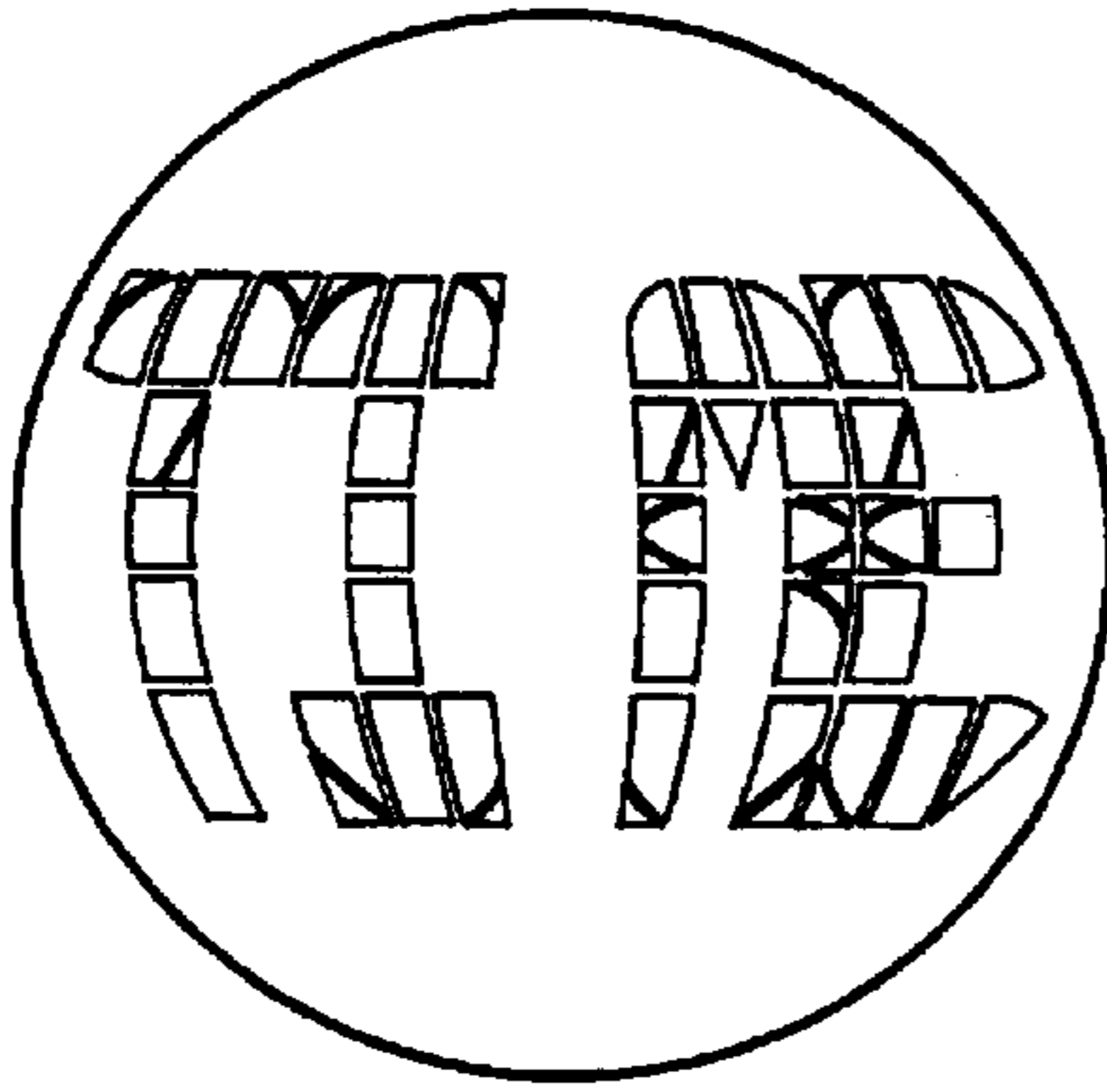

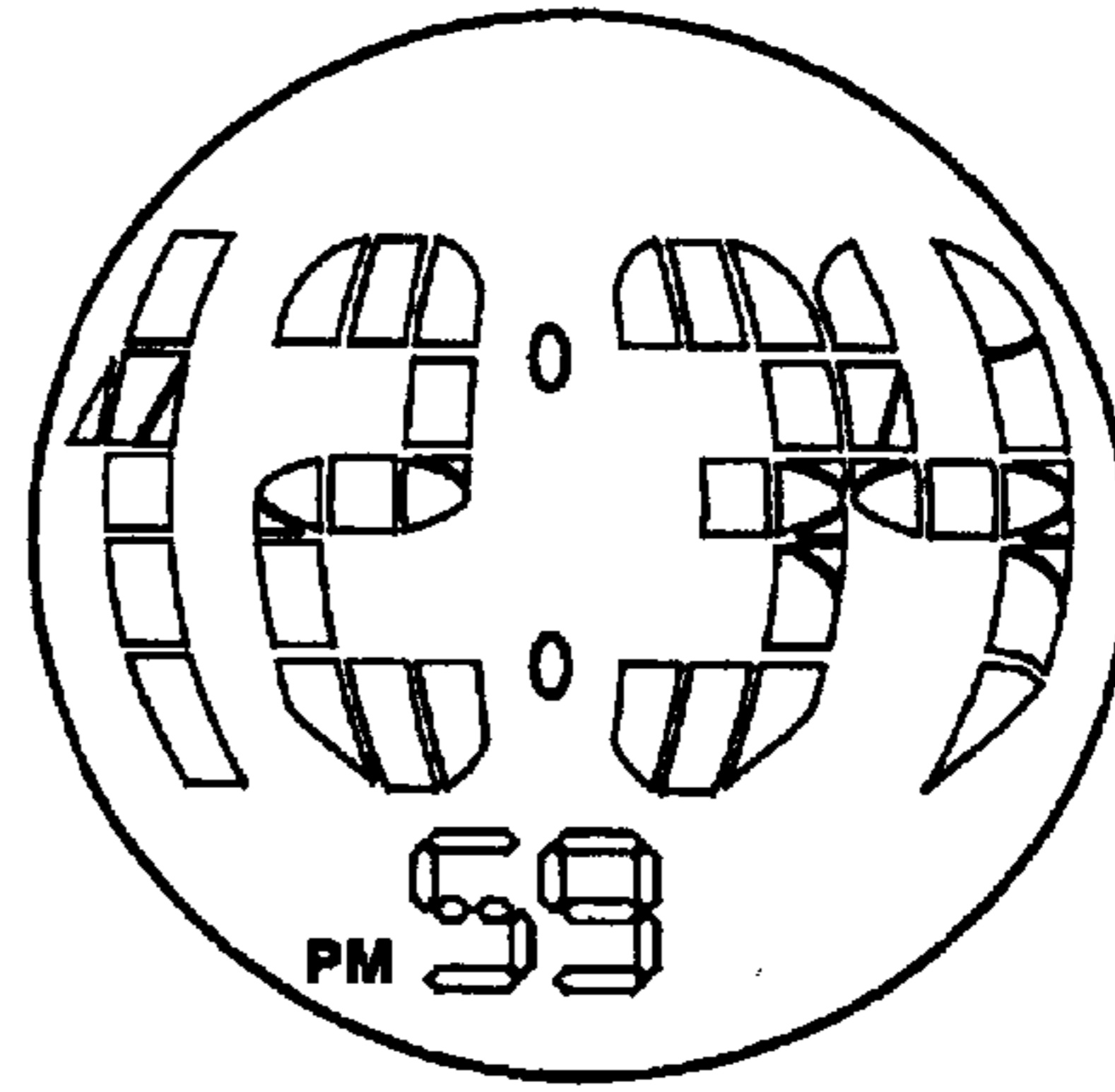

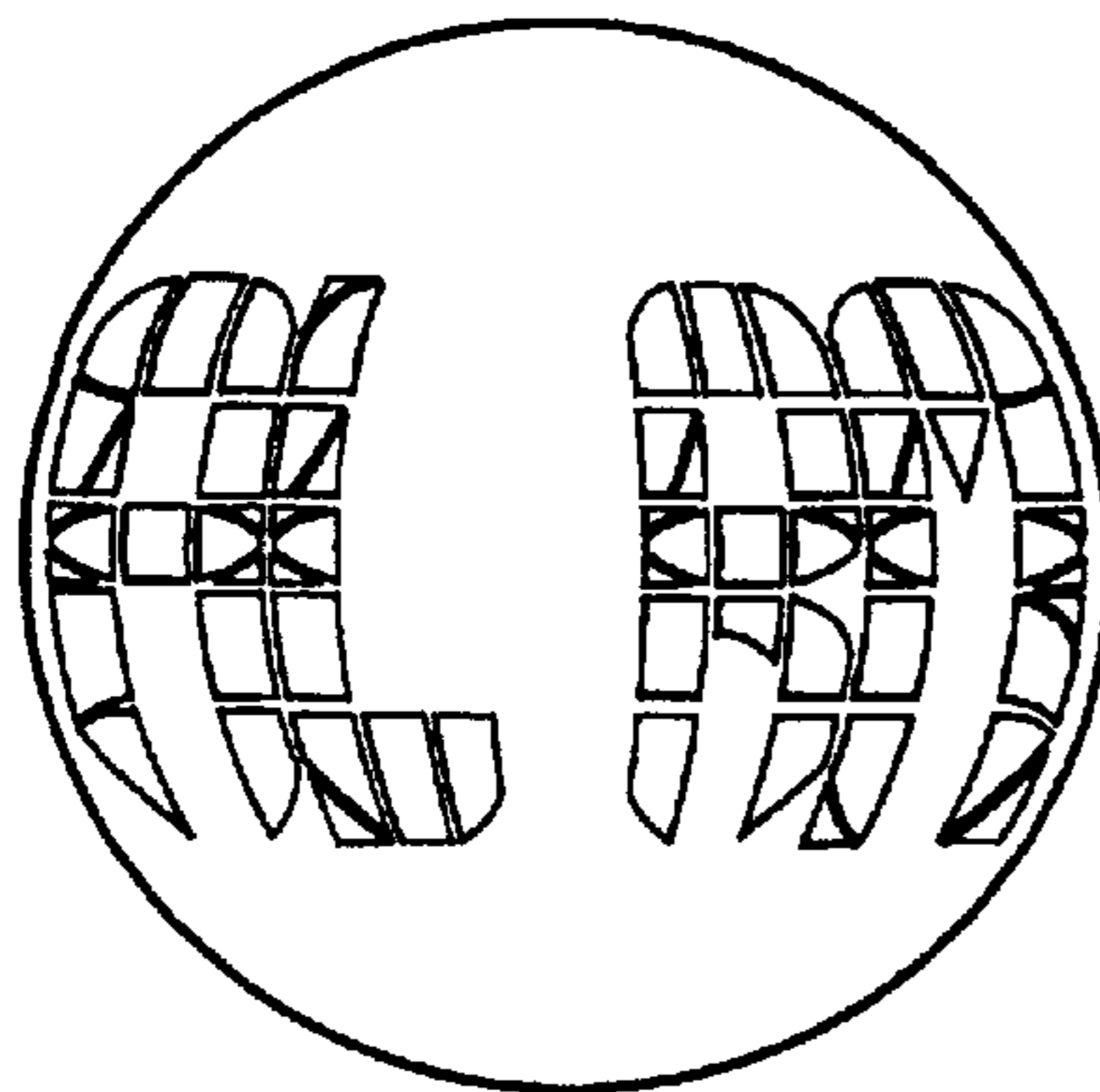

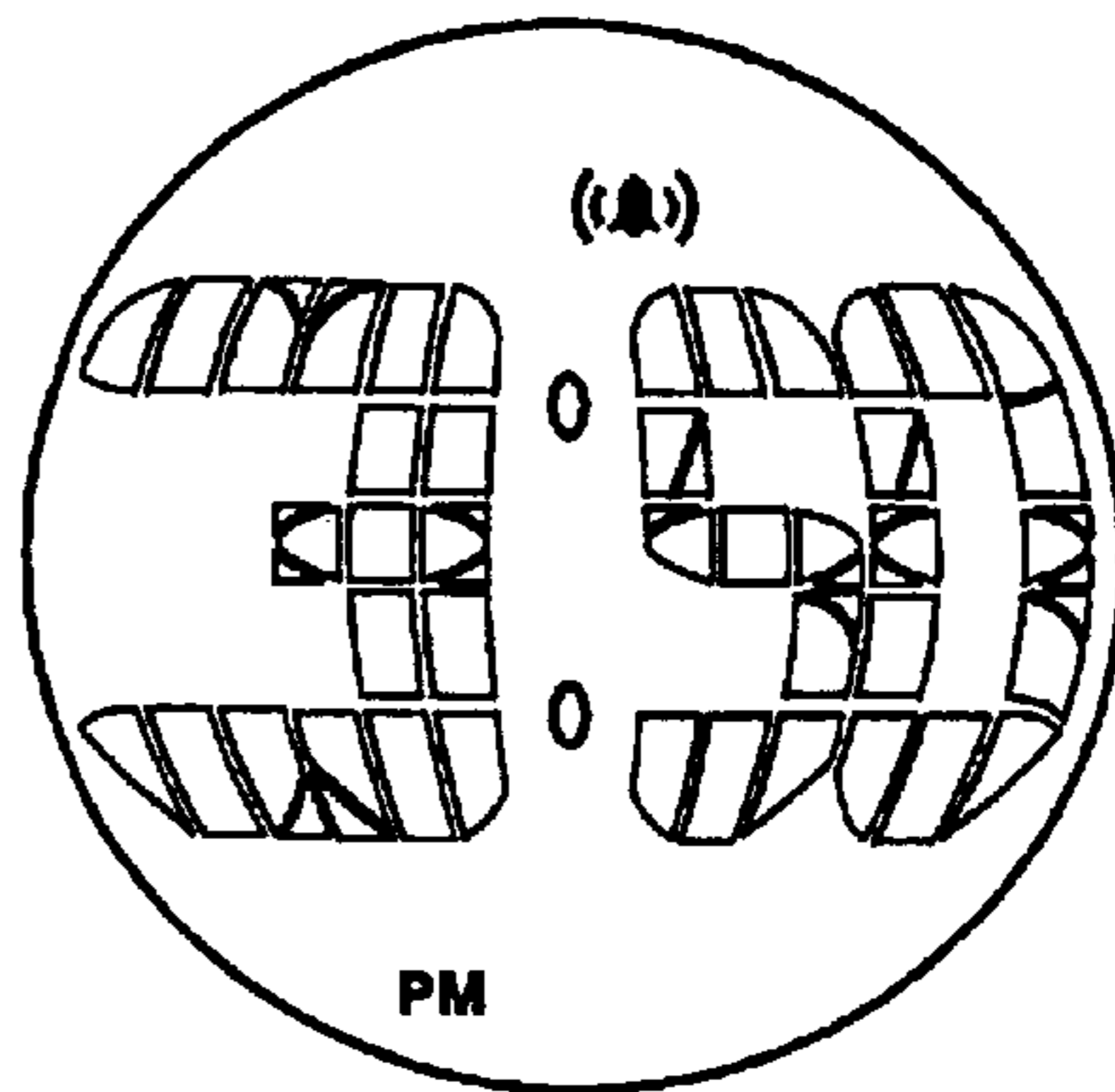

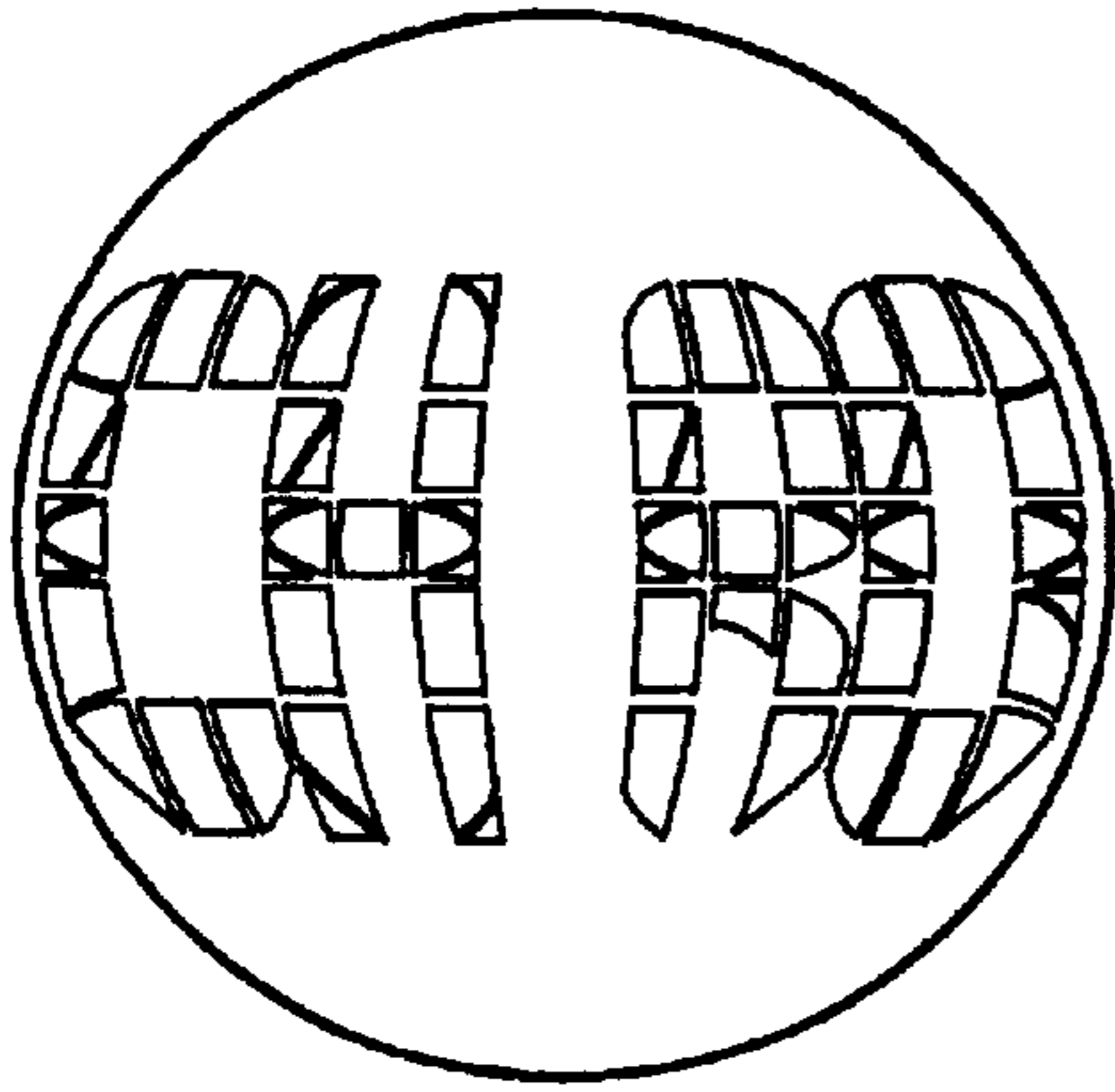

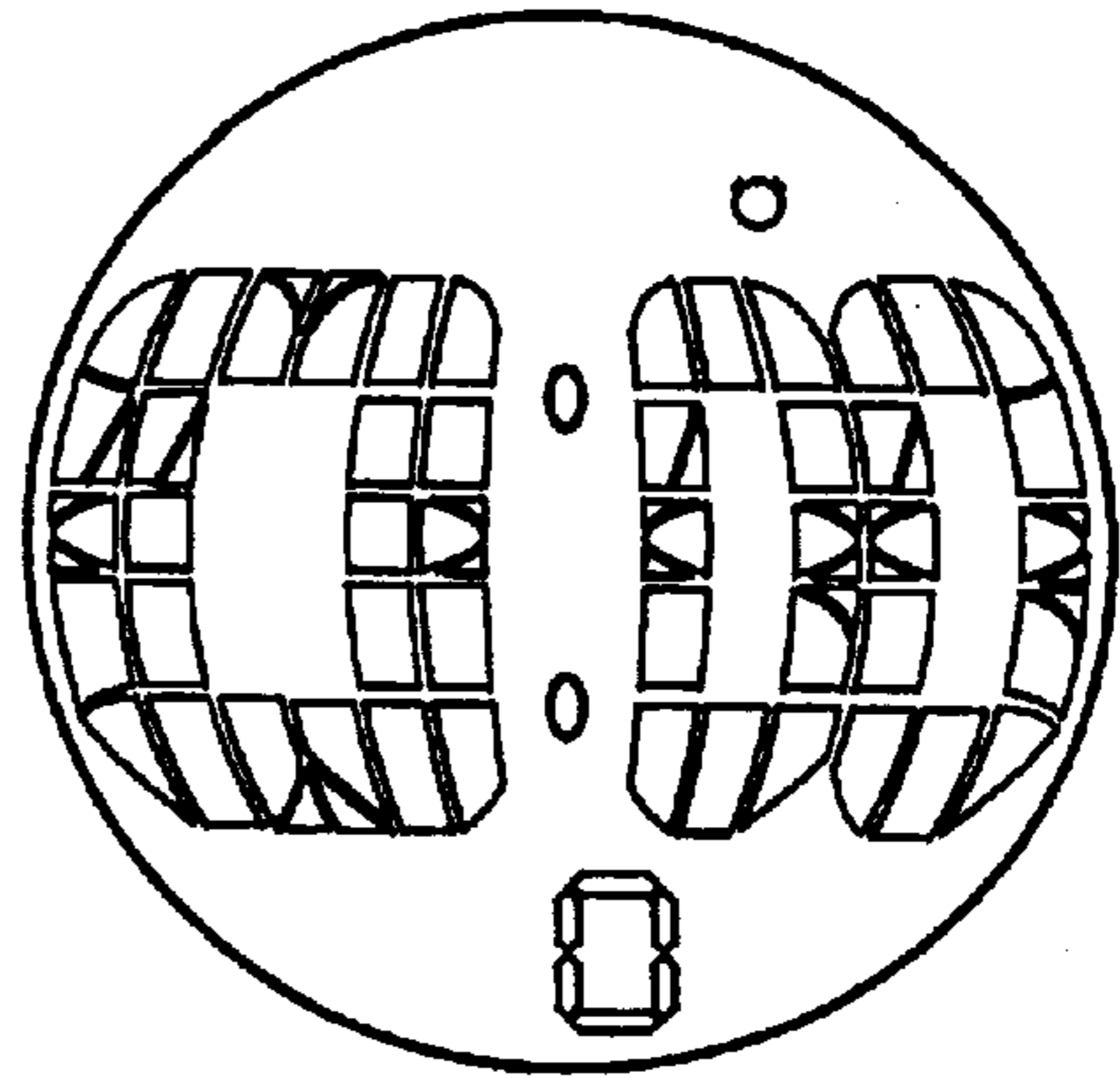

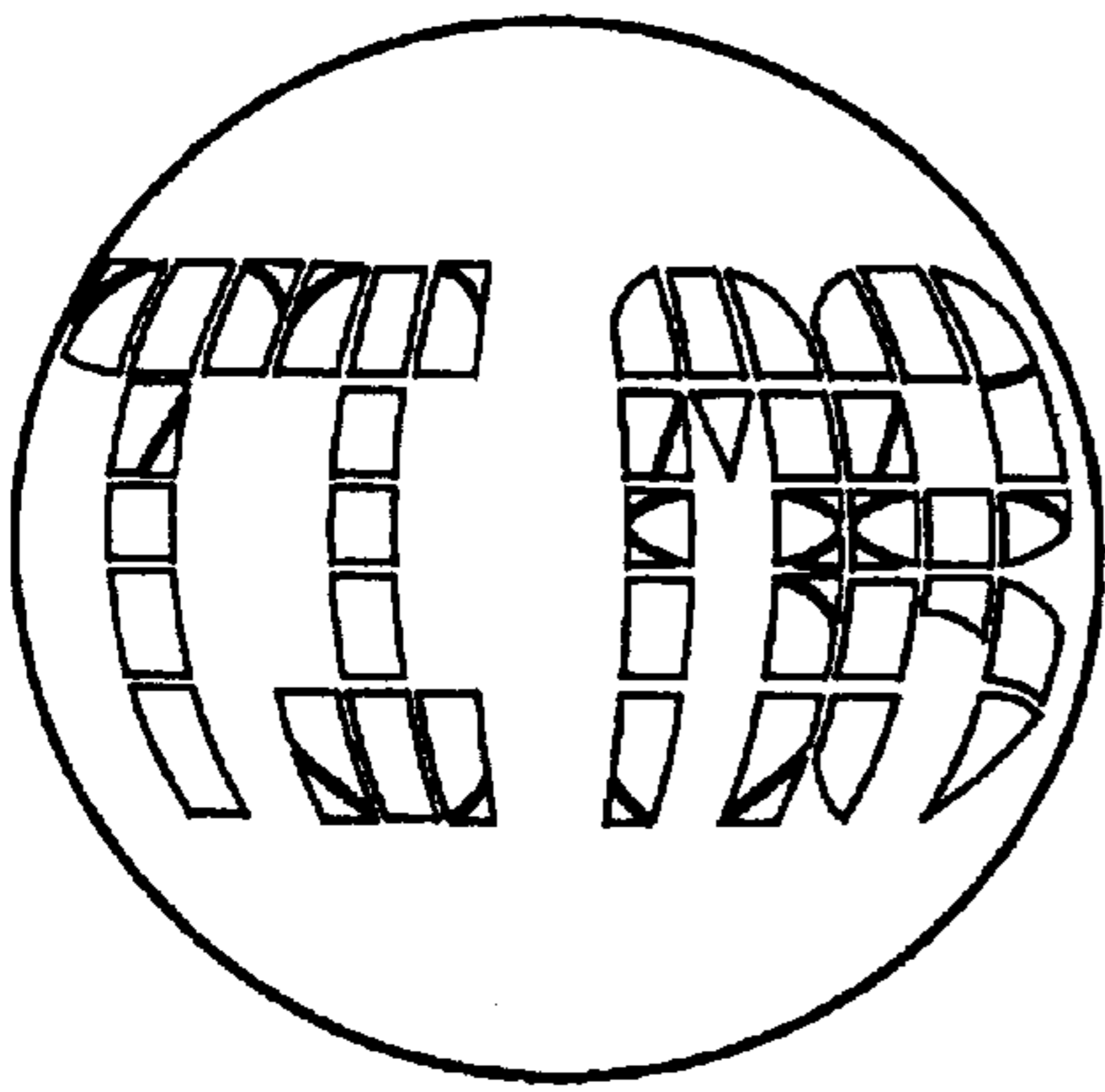

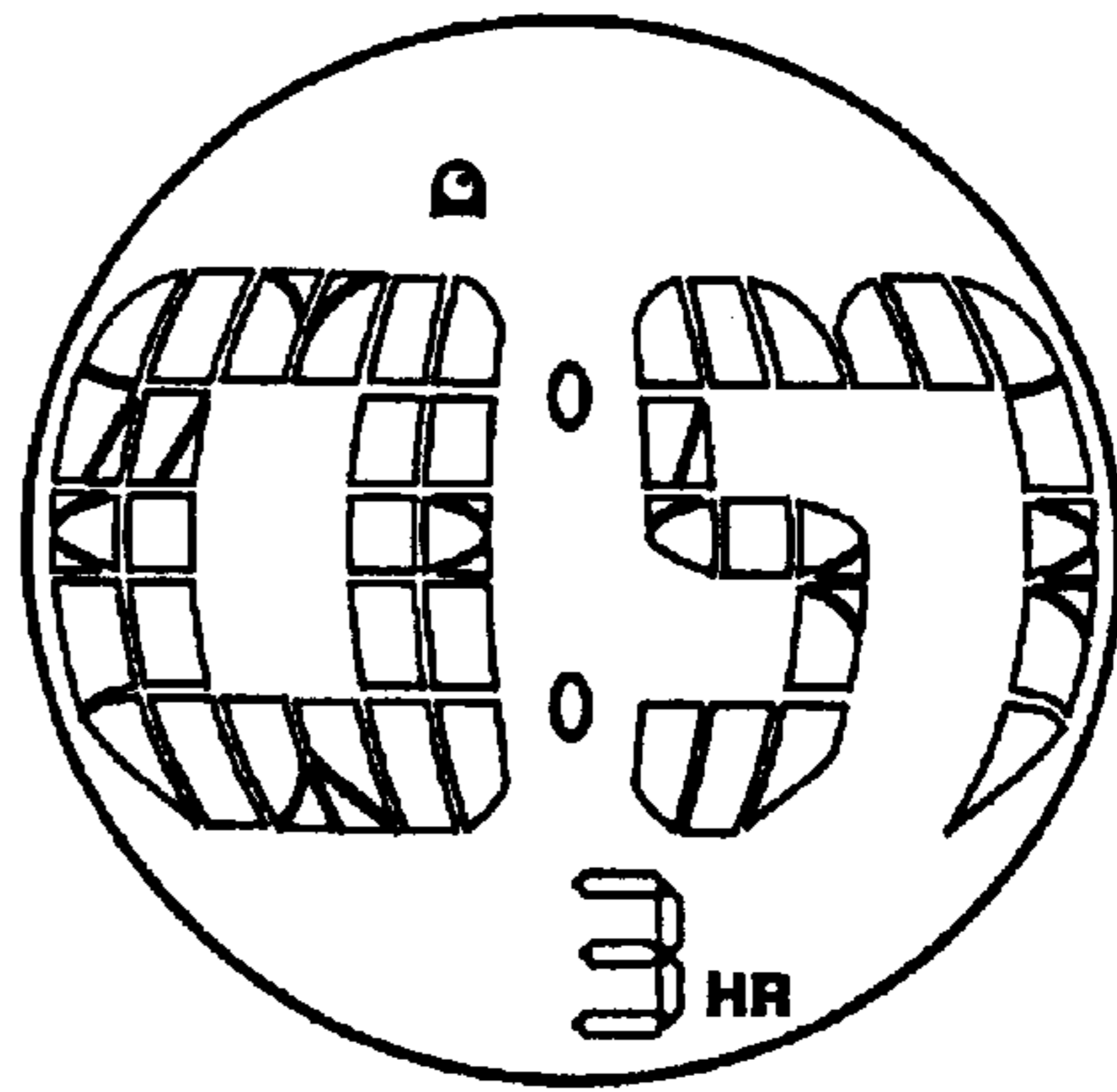

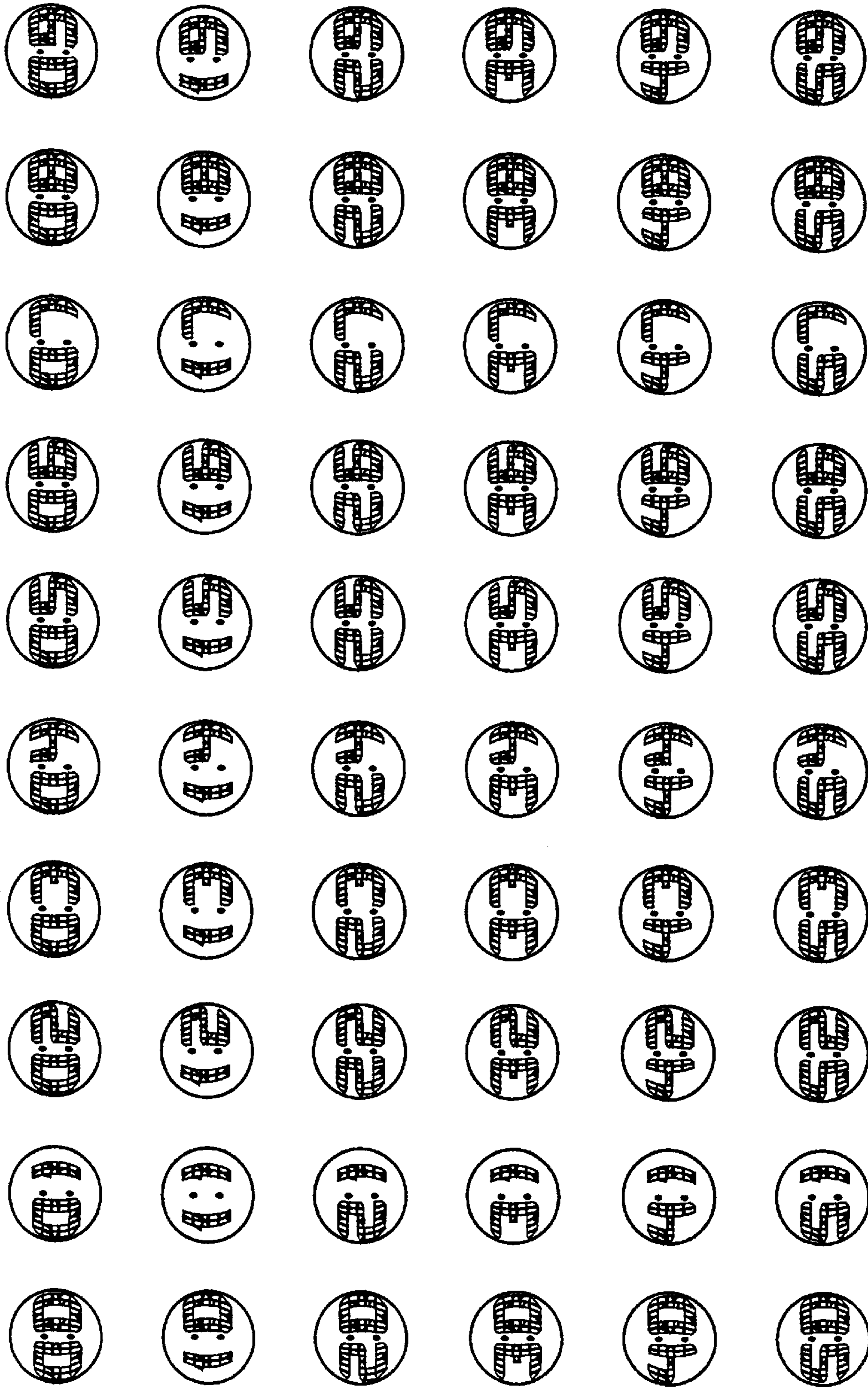

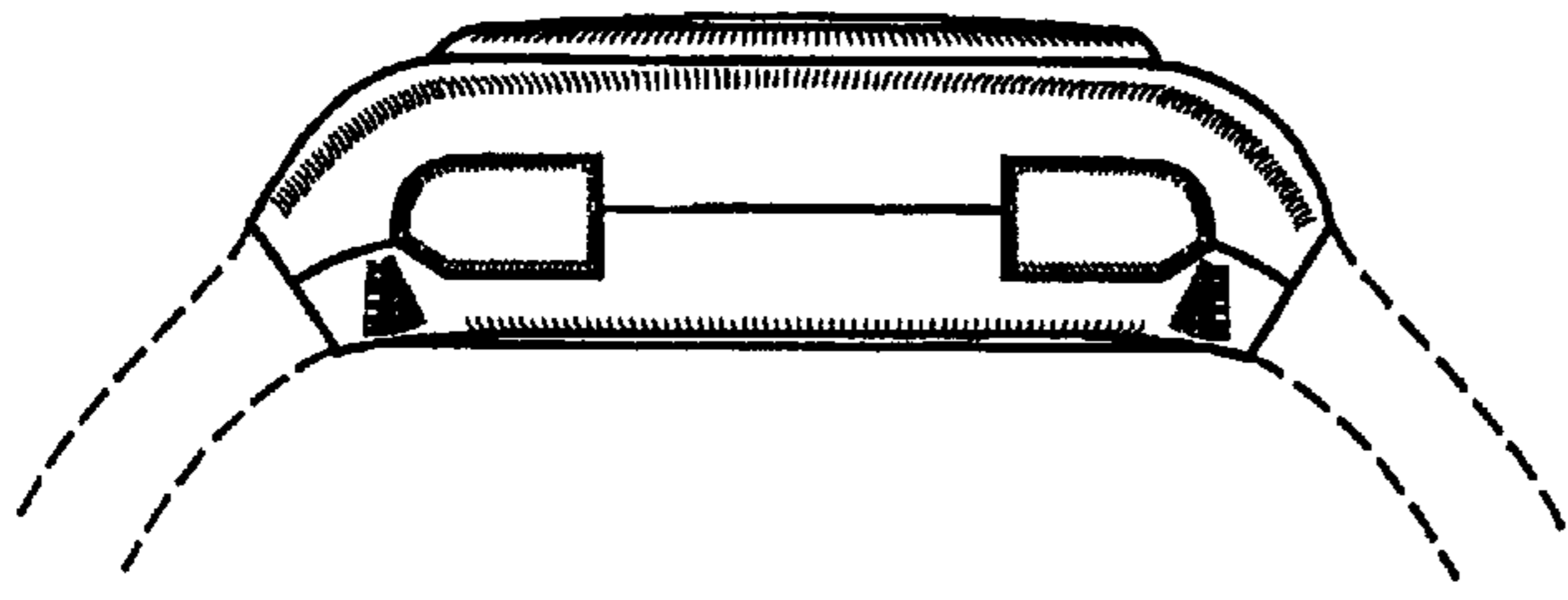

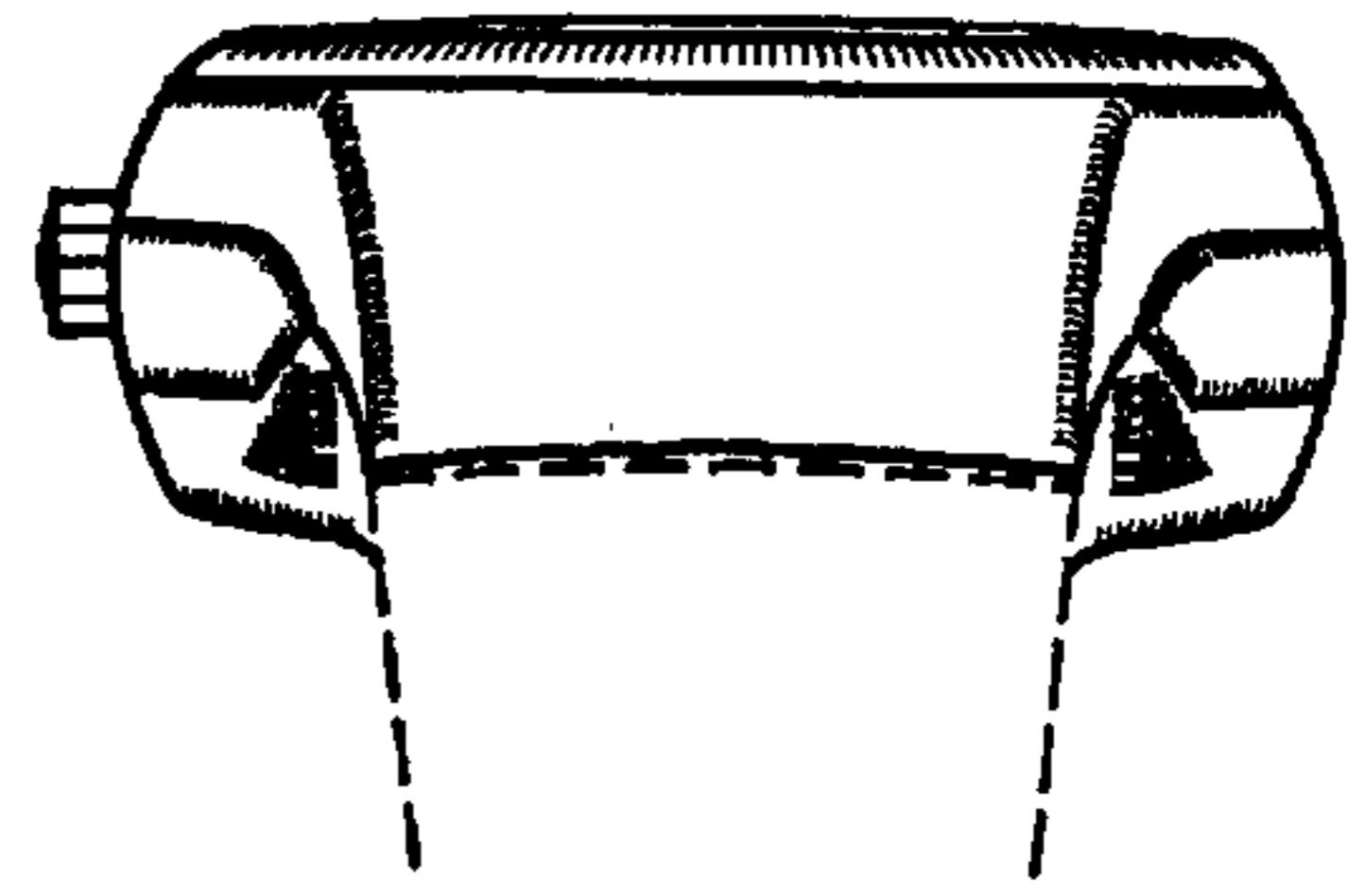

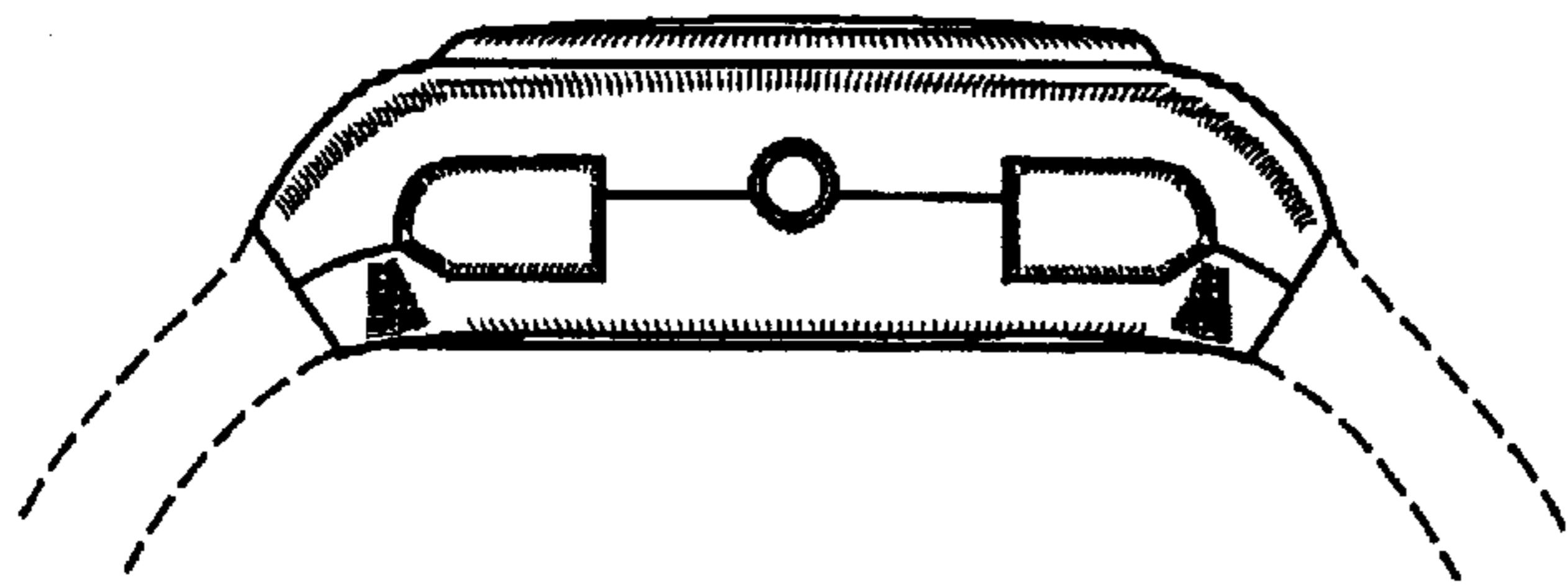

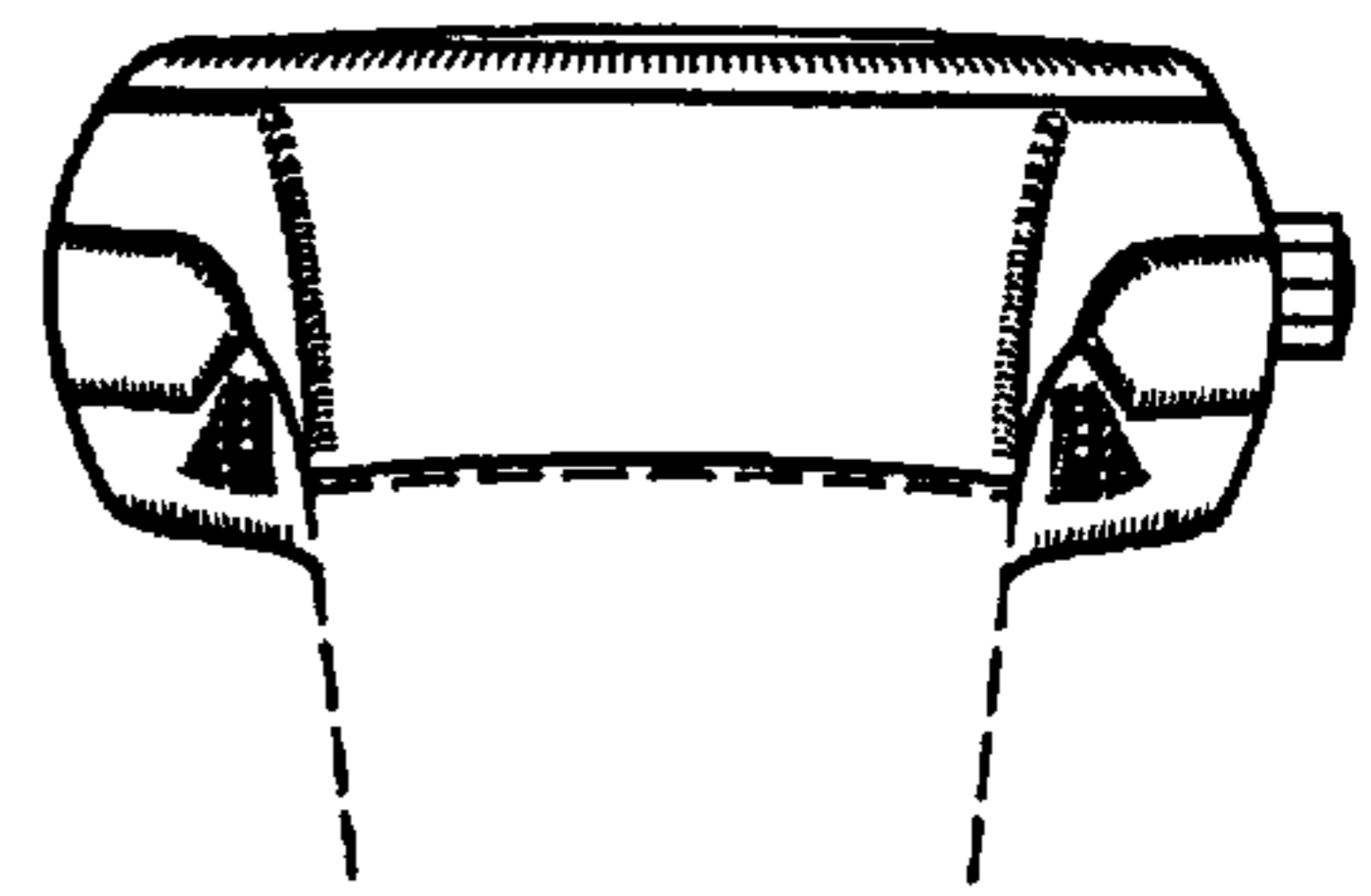

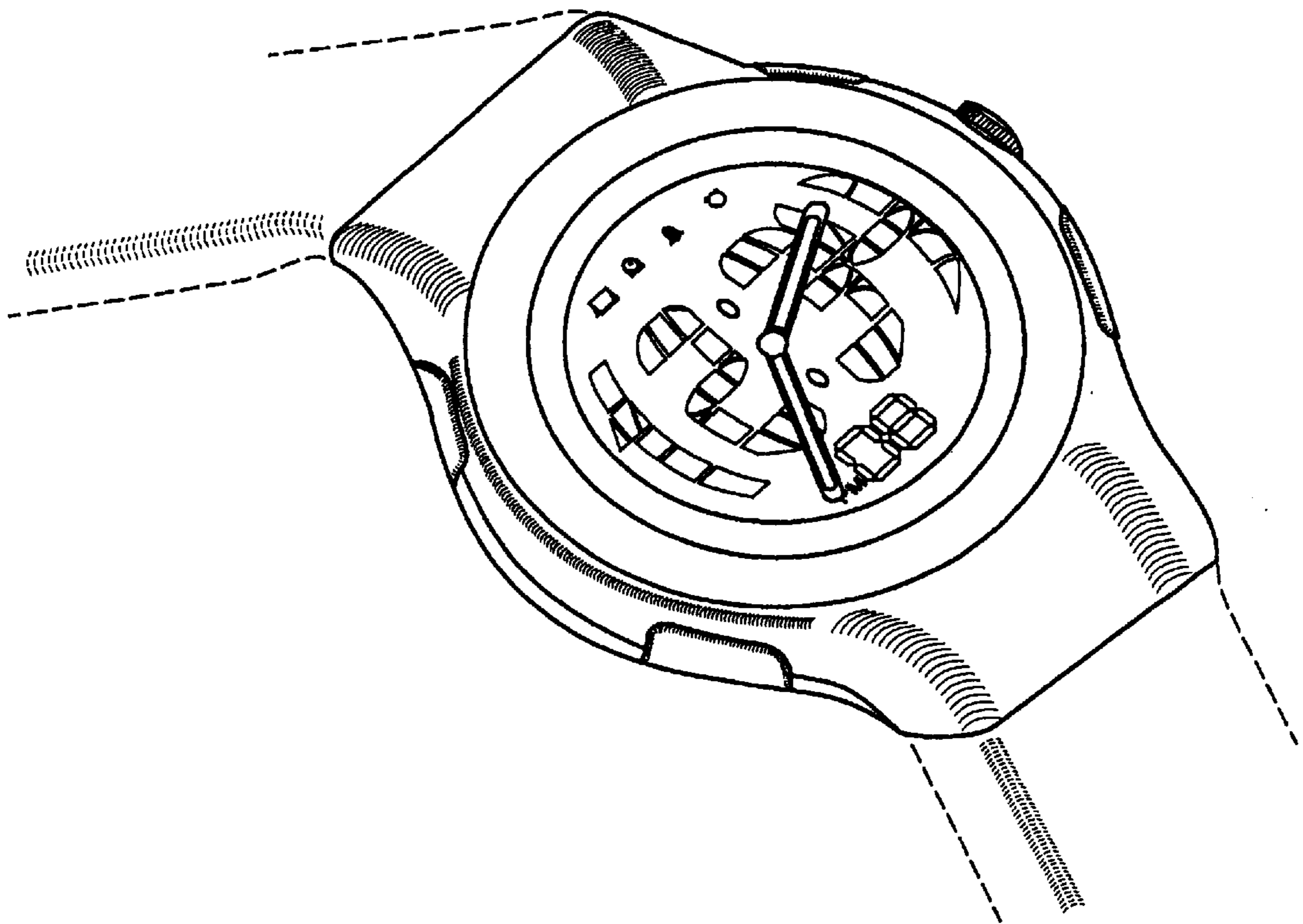
