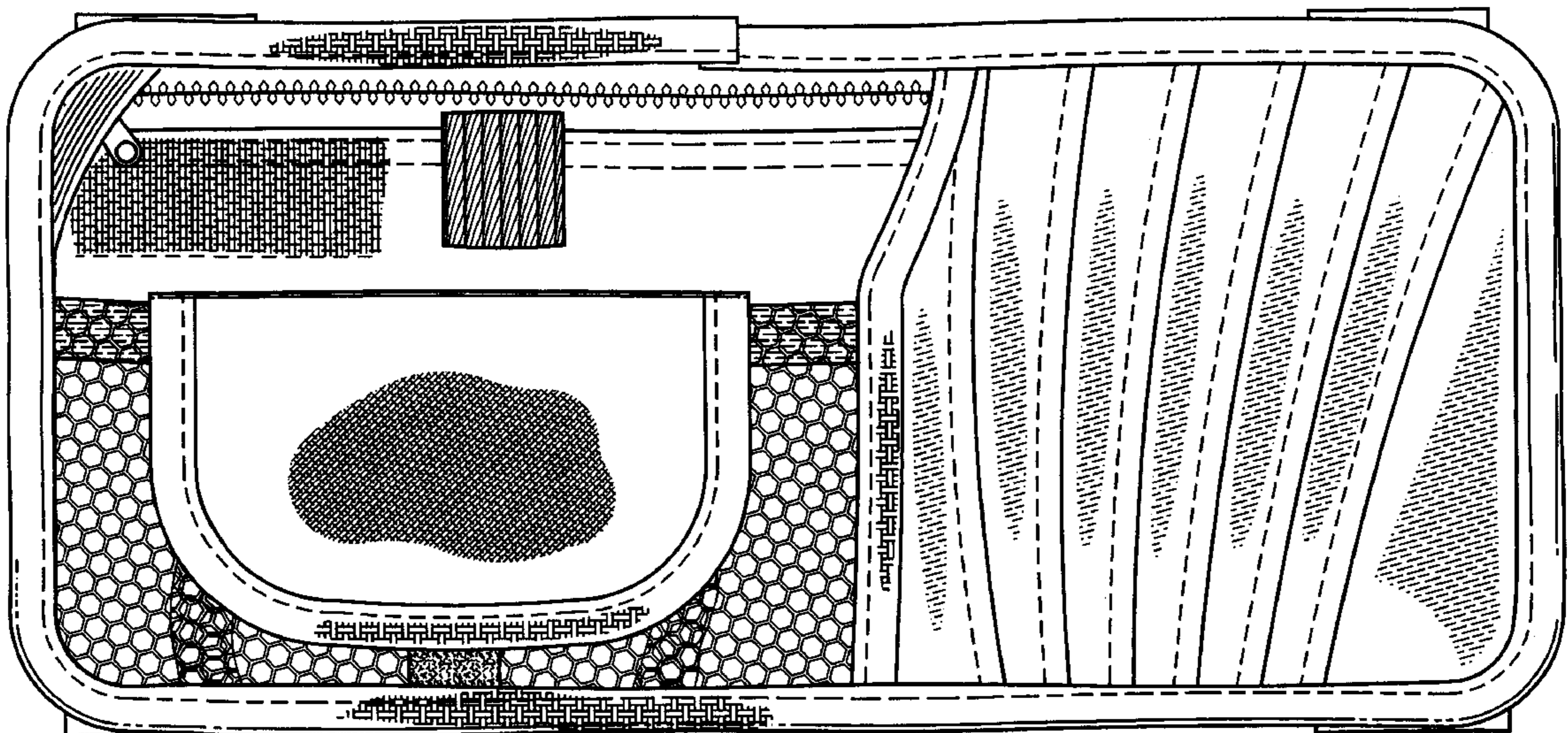
[57] **CLAIM**

I claim the ornamental design for the visor organizer with multi-media carrier, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the visor organizer with multi-media carrier.
 FIG. 2 is a rear view of the organizer.
 FIG. 3 is a left side view of the organizer.
 FIG. 4 is a right side view of the organizer wherein the zipper shown in FIG. 1 is hidden by the thickness of the pocket.
 FIG. 5 is a top view of the organizer wherein the zipper shown in FIG. 1 is hidden by the thickness of the pocket and wherein FIG. 5 is shown in larger scale than FIGS. 1-4 for clarity; and,
 FIG. 6 is a bottom view of the organizer wherein FIG. 6 is shown in larger scale than FIGS. 1-4 for clarity.
 The dashed lines on the organizer are understood to represent stitching.

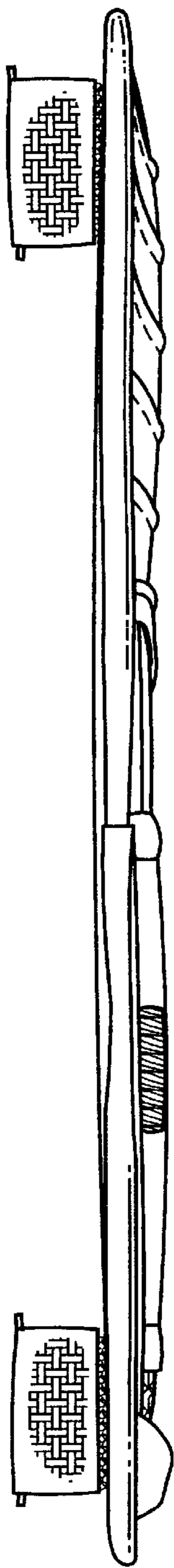

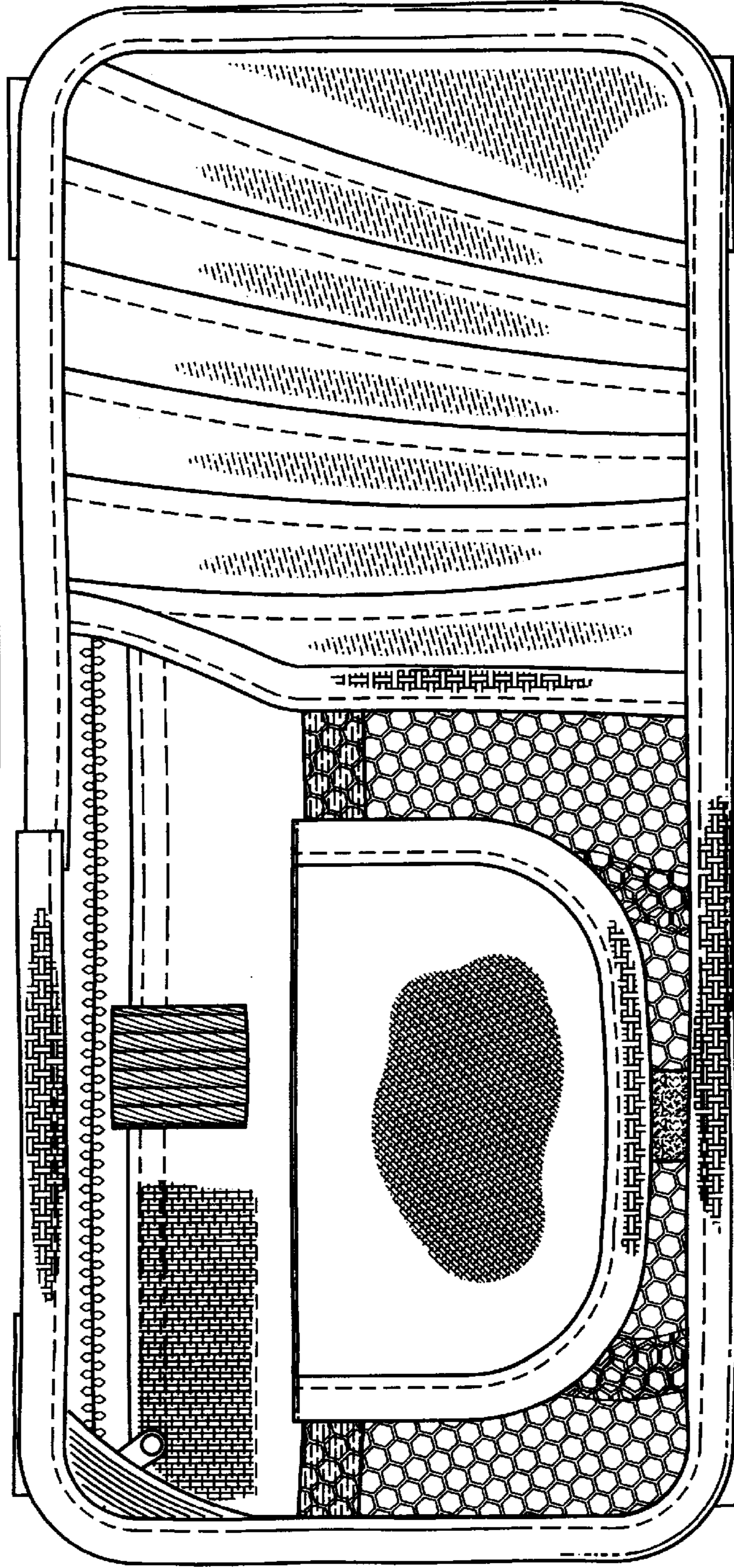

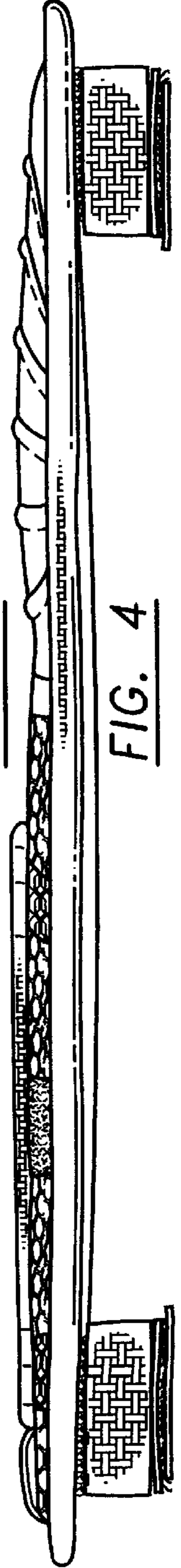

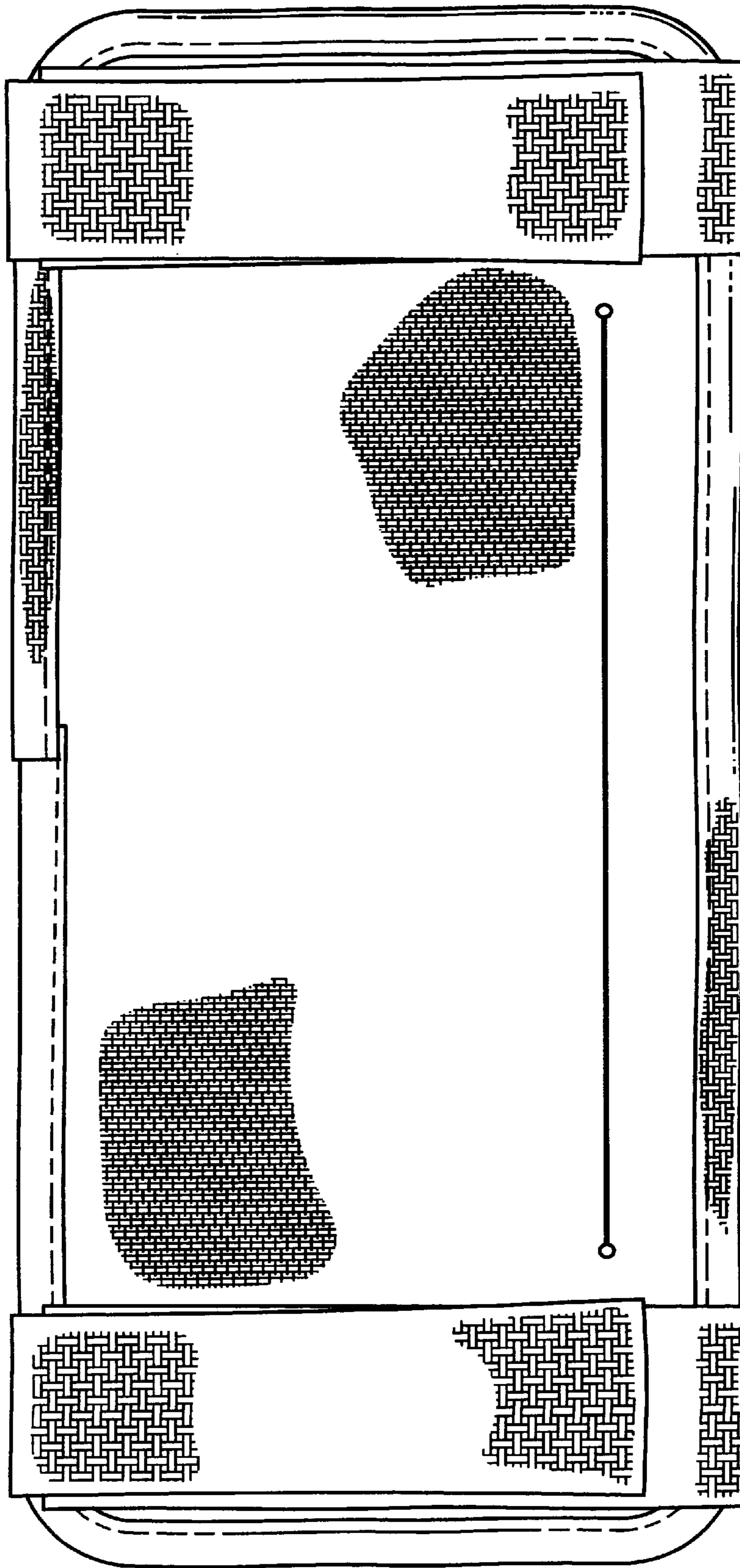

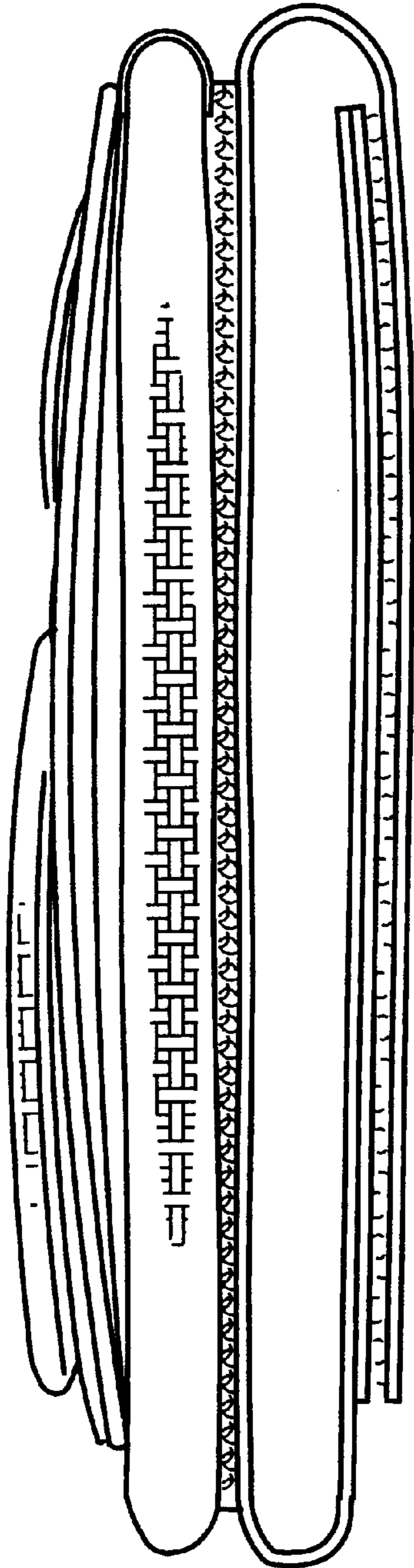

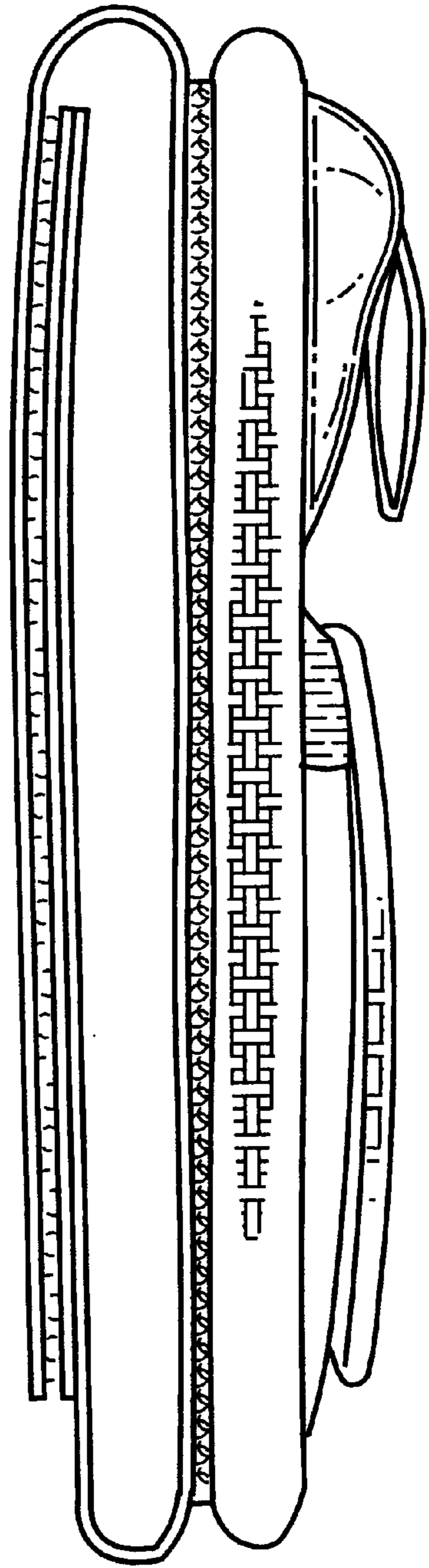
