FIG. 3 is the top view thereof;

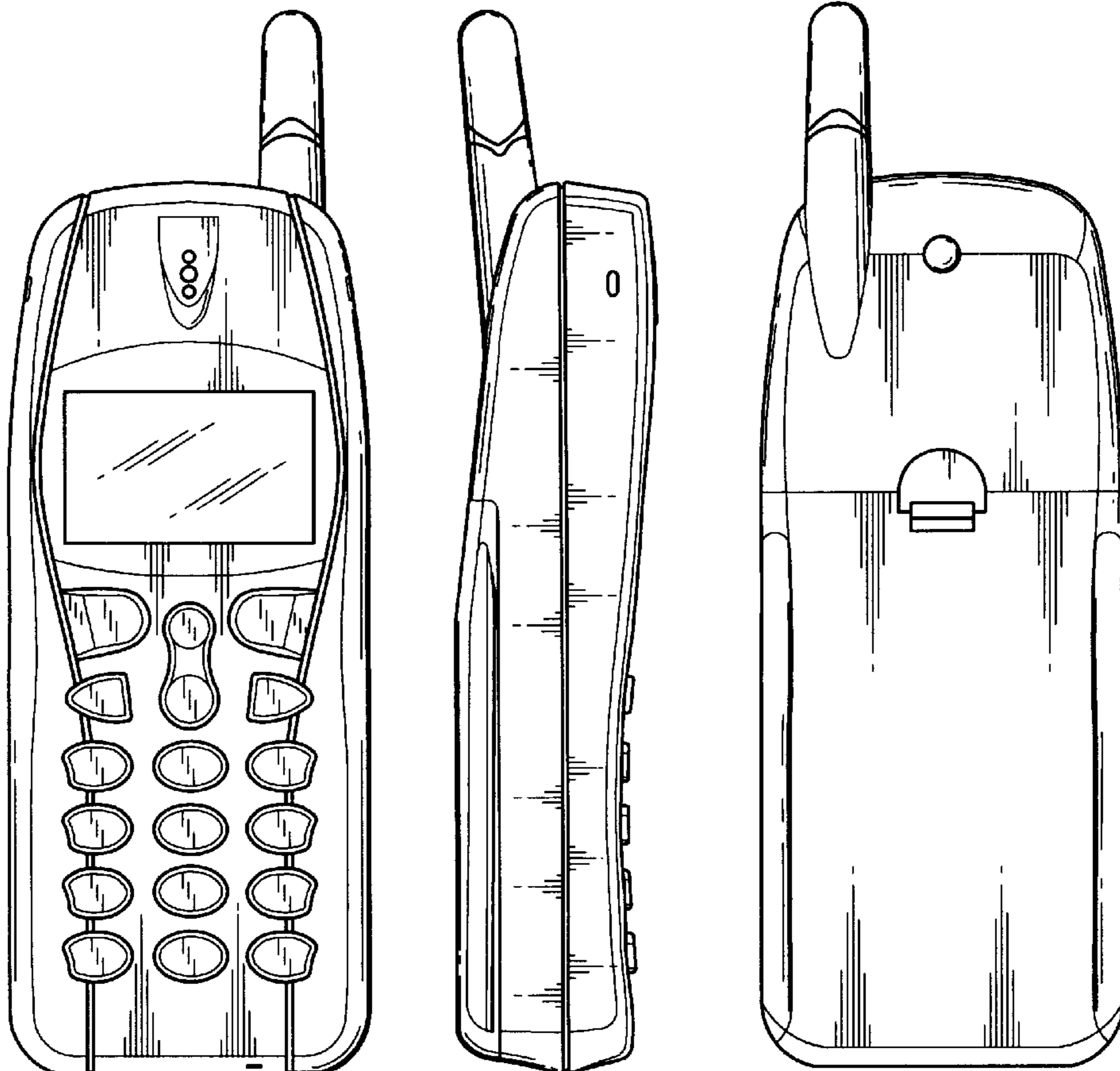
FIG. 4 is the front view thereof;

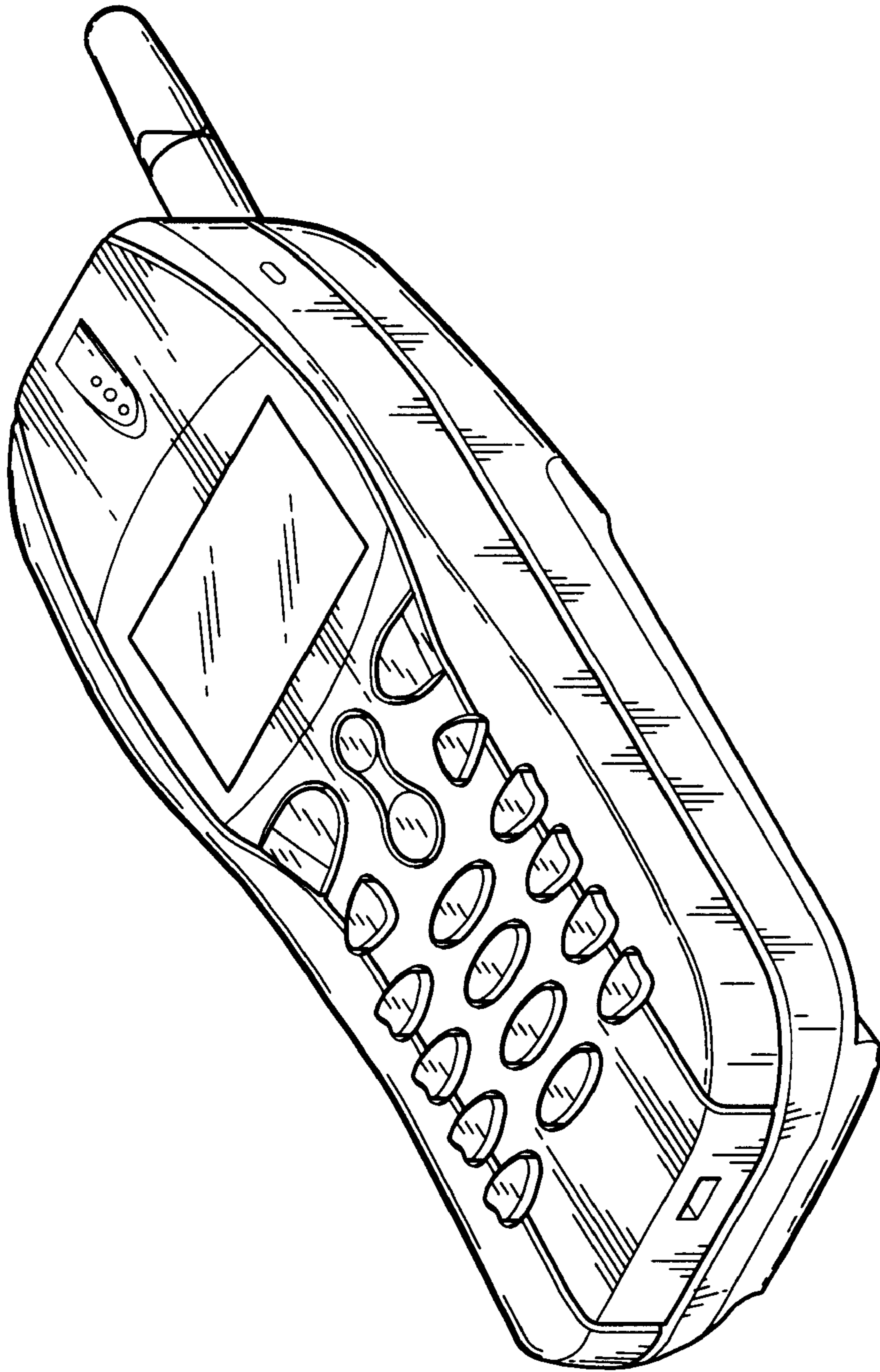

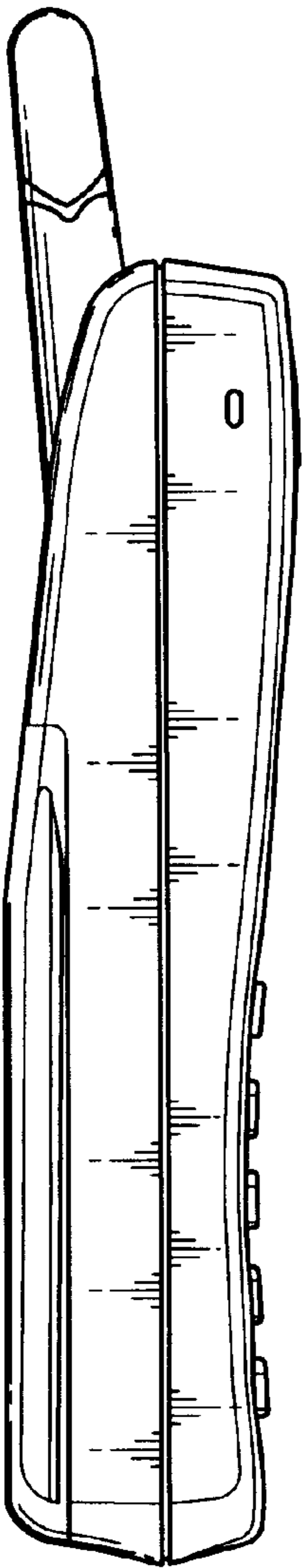

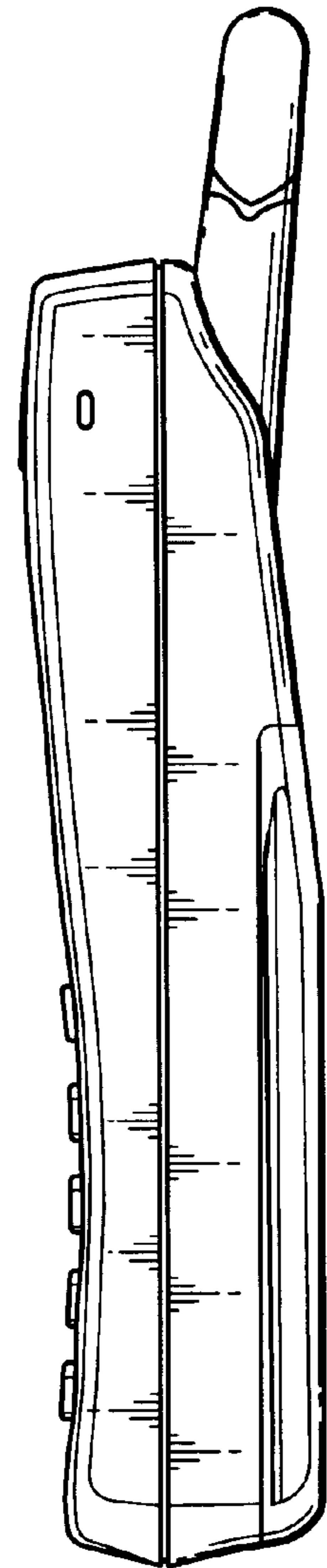

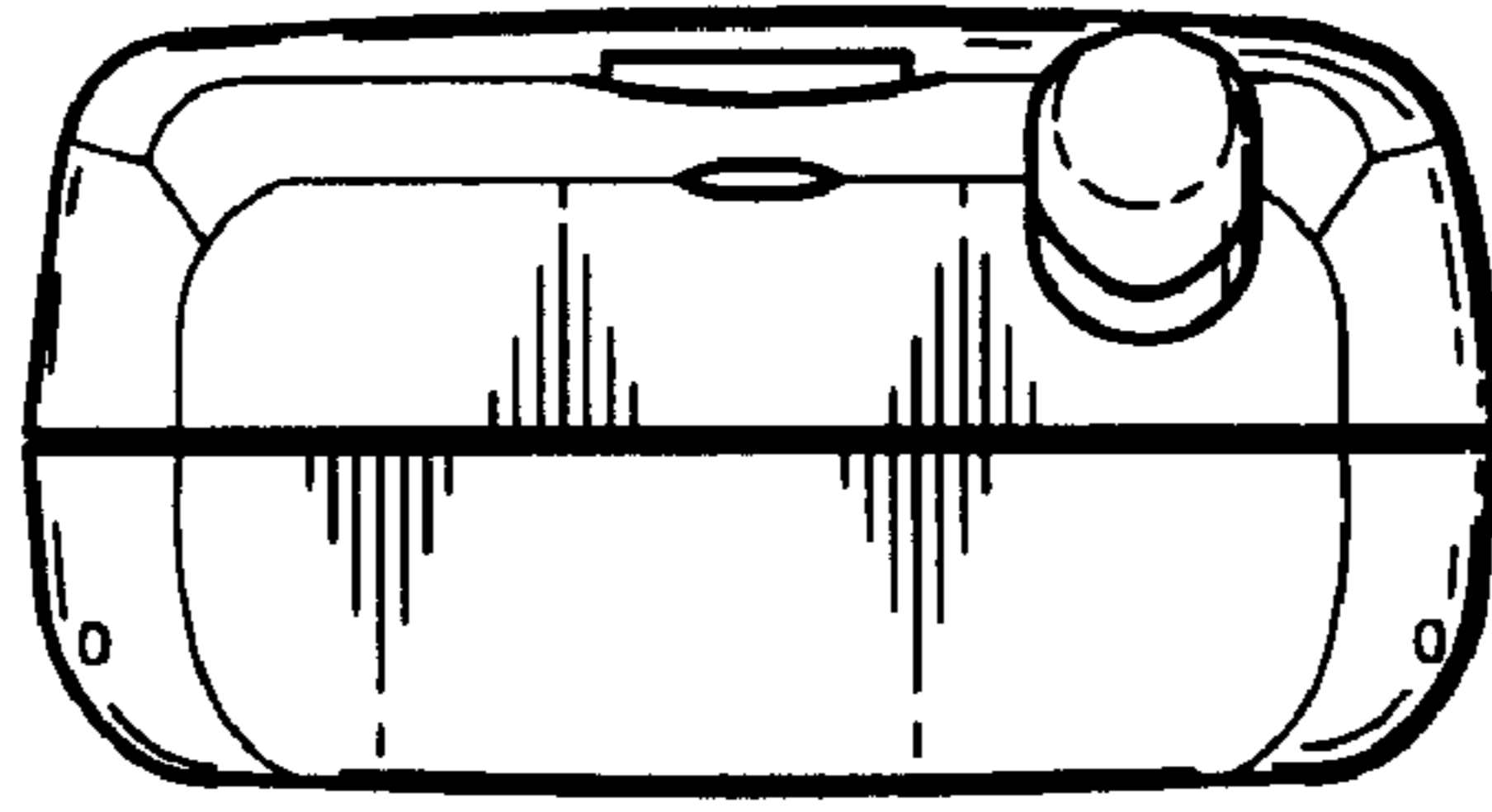

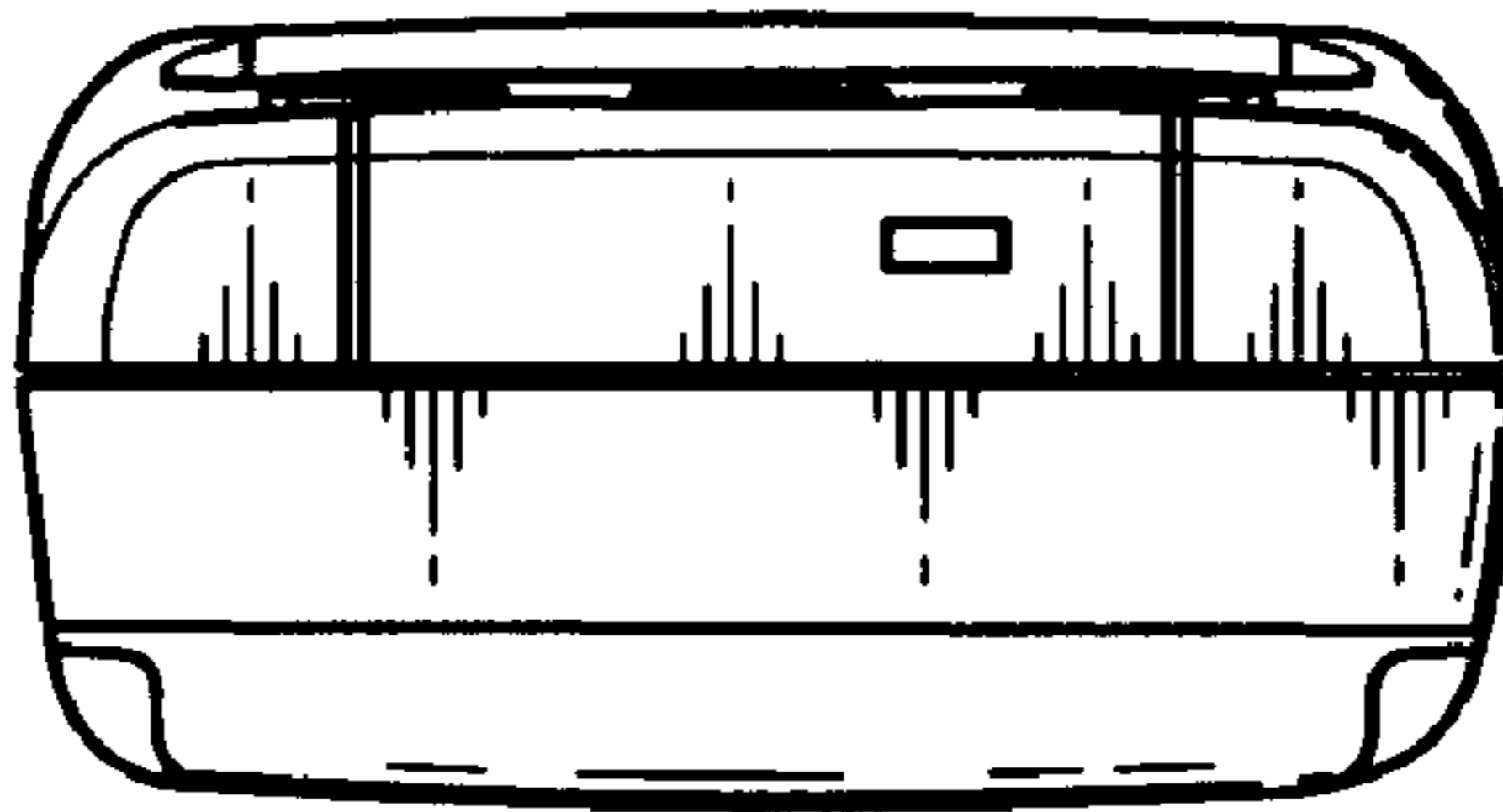

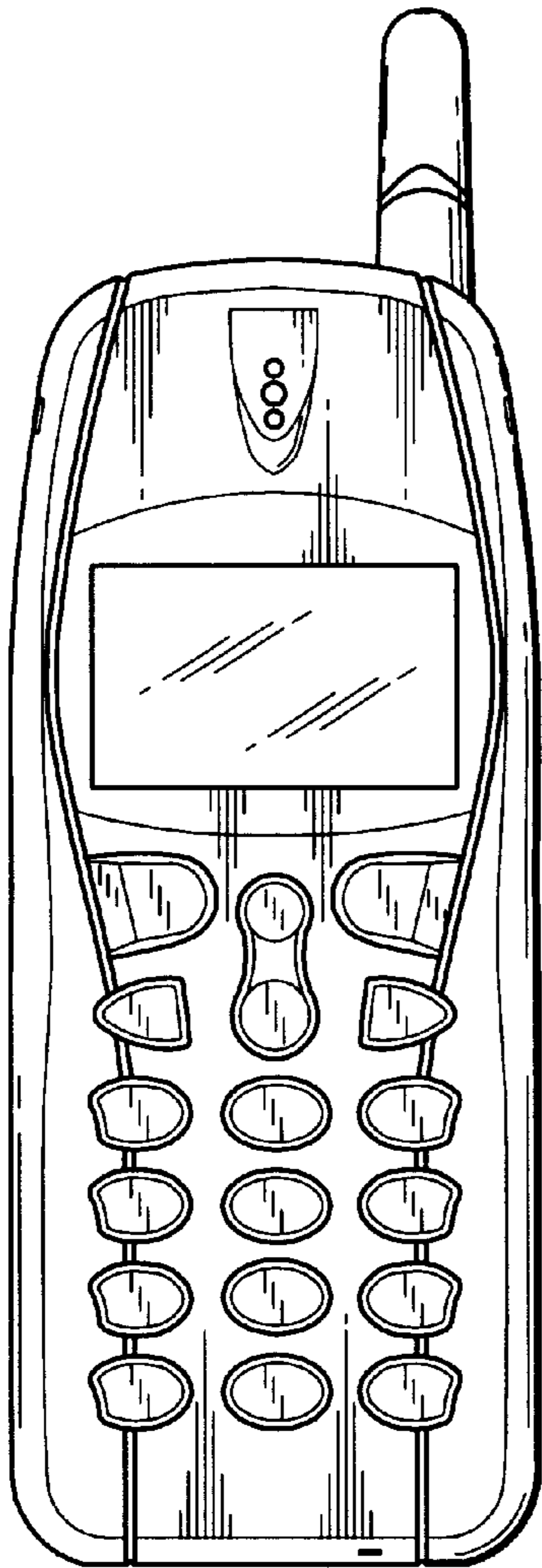

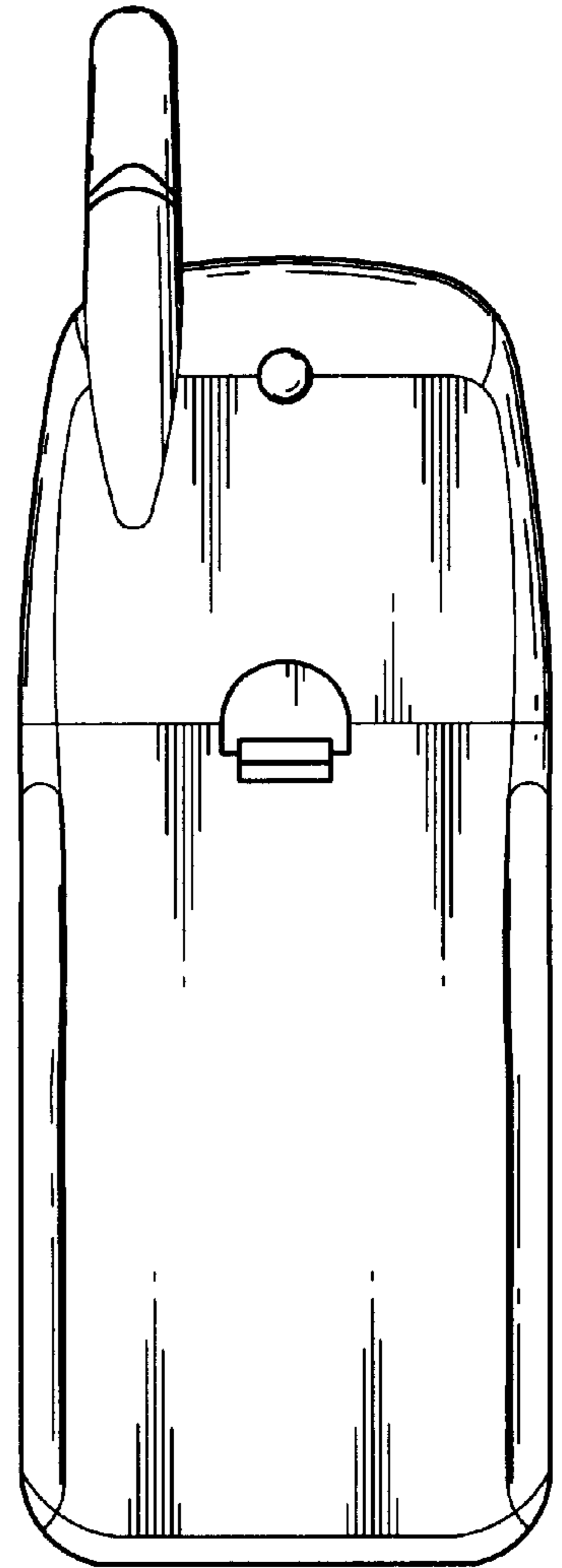
