### [57] CLAIM

The ornamental design for a hand held electronic game, as shown and described.

#### DESCRIPTION

FIG. 1 is a front, bottom right side perspective view of a hand held electronic game in accordance with the new design;  
 FIG. 2 is a front elevational view of the hand held electronic game illustrated in FIG. 1;  
 FIG. 3 is a rear elevational view of the hand held electronic game illustrated in FIGS. 1 and 2;  
 FIG. 4 is a left side elevational view of the hand held electronic game illustrated in FIGS. 1-3;  
 FIG. 5 is a right side elevational view of the hand held electronic game illustrated in FIGS. 1-4;  
 FIG. 6 is a top plan view of the hand held electronic game illustrated in FIGS. 1-5; and,  
 FIG. 7 is a bottom plan view of the hand held electronic game illustrated in FIGS. 1-6.

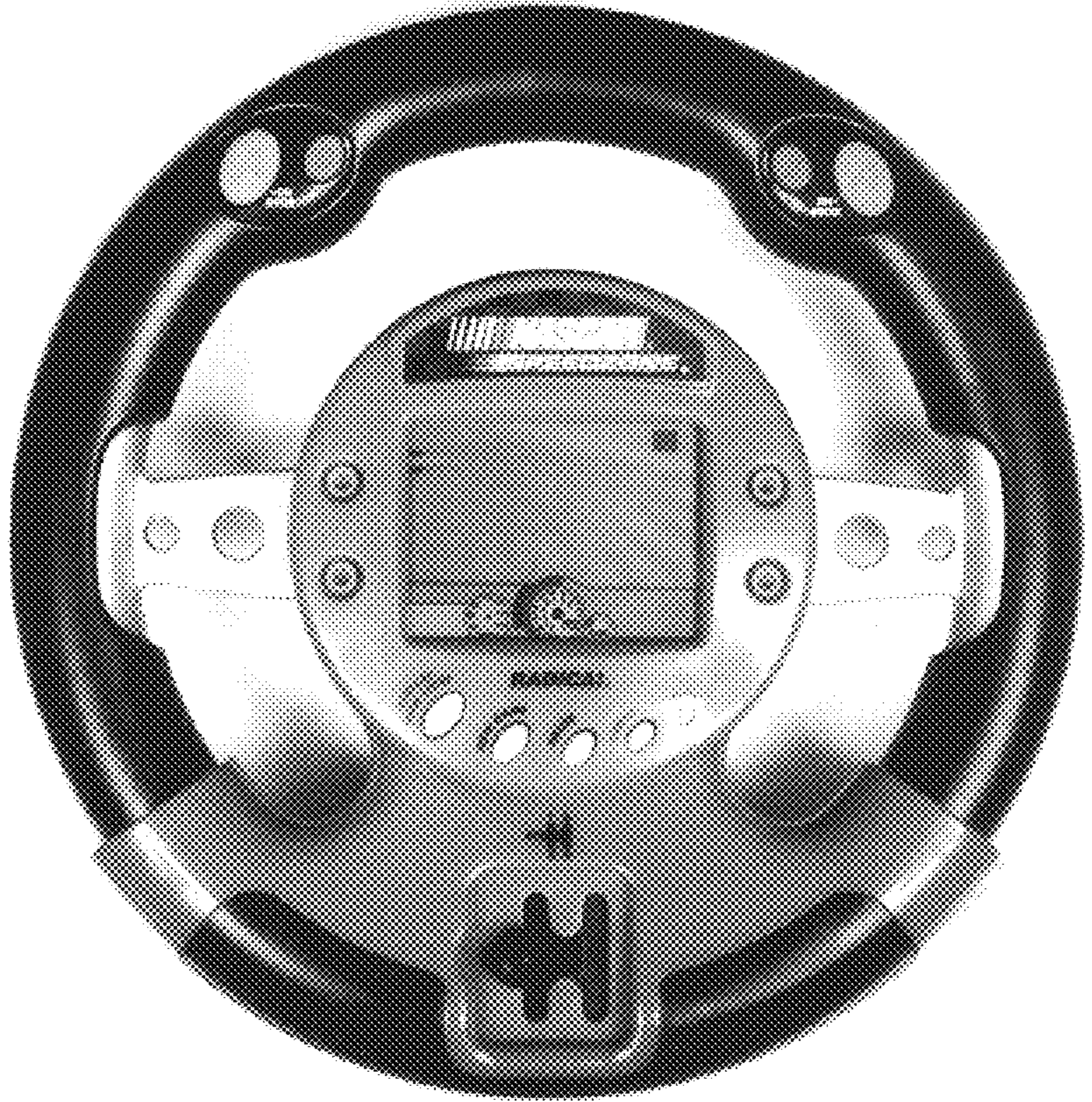

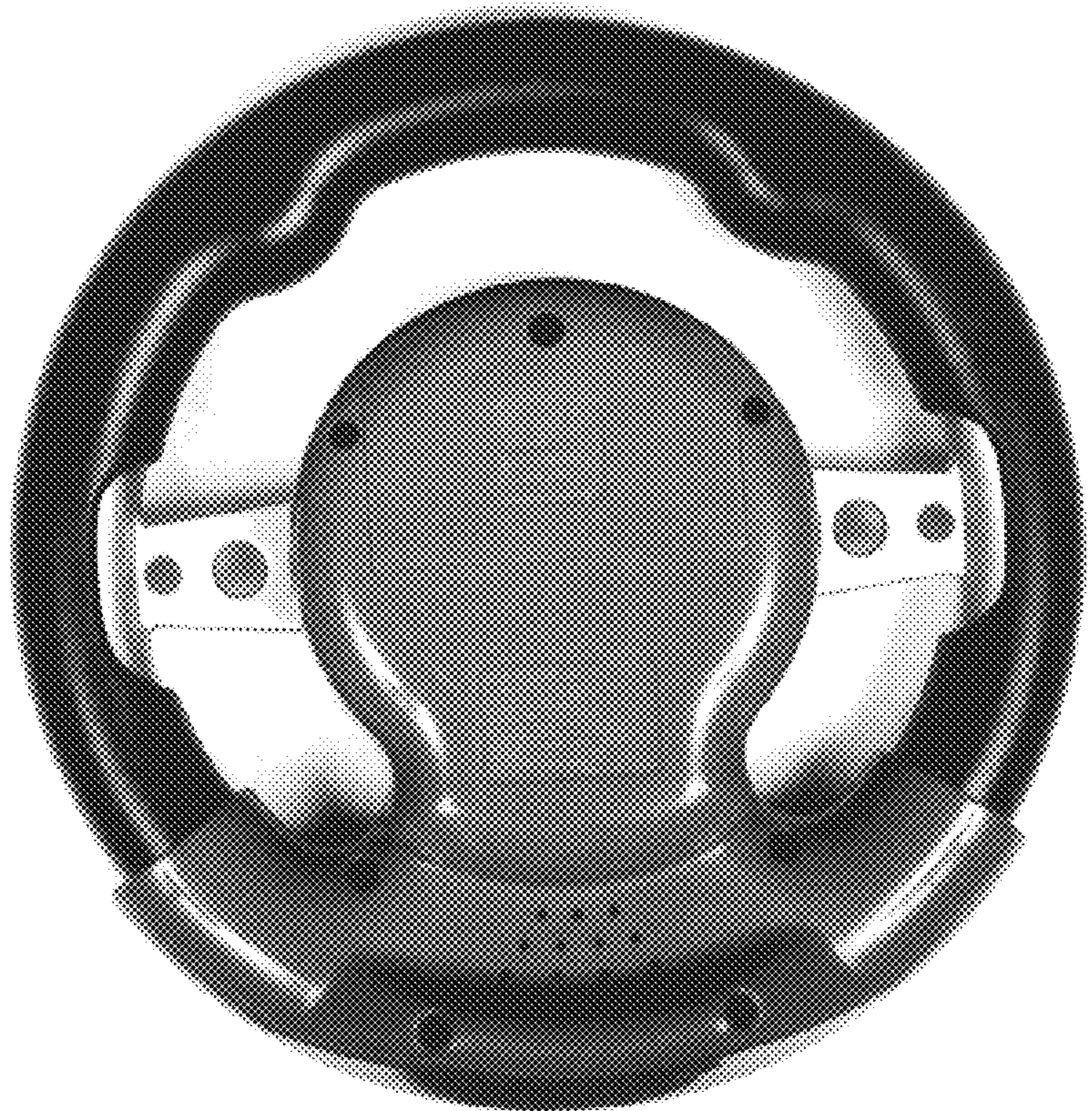

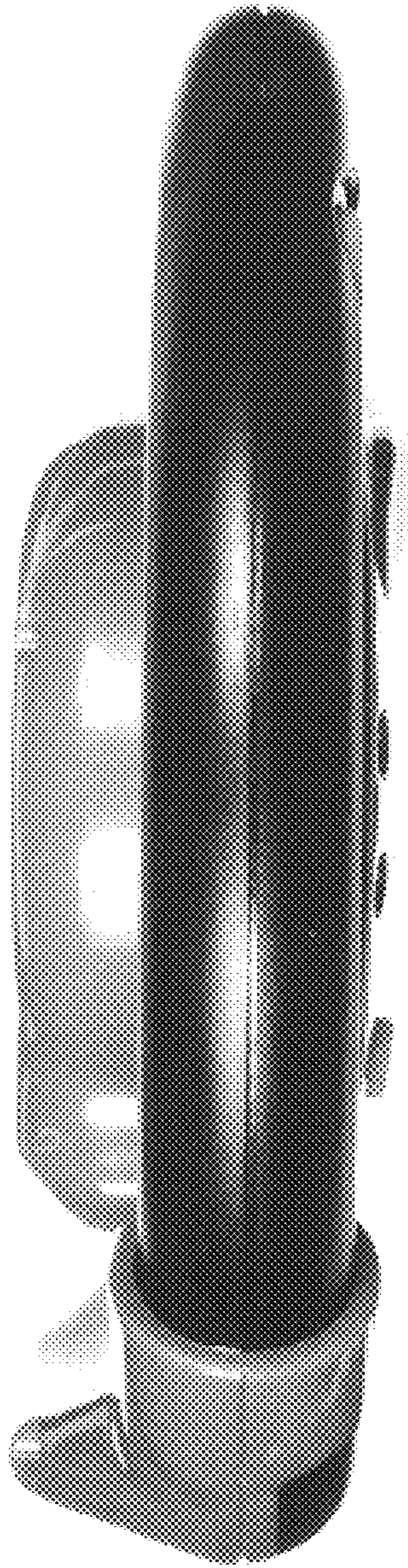

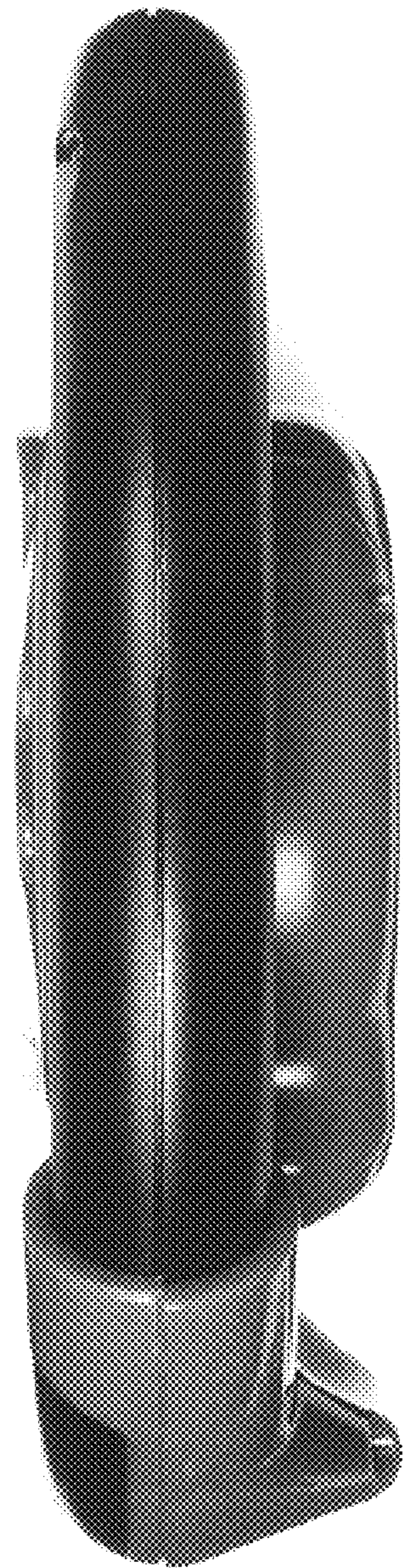

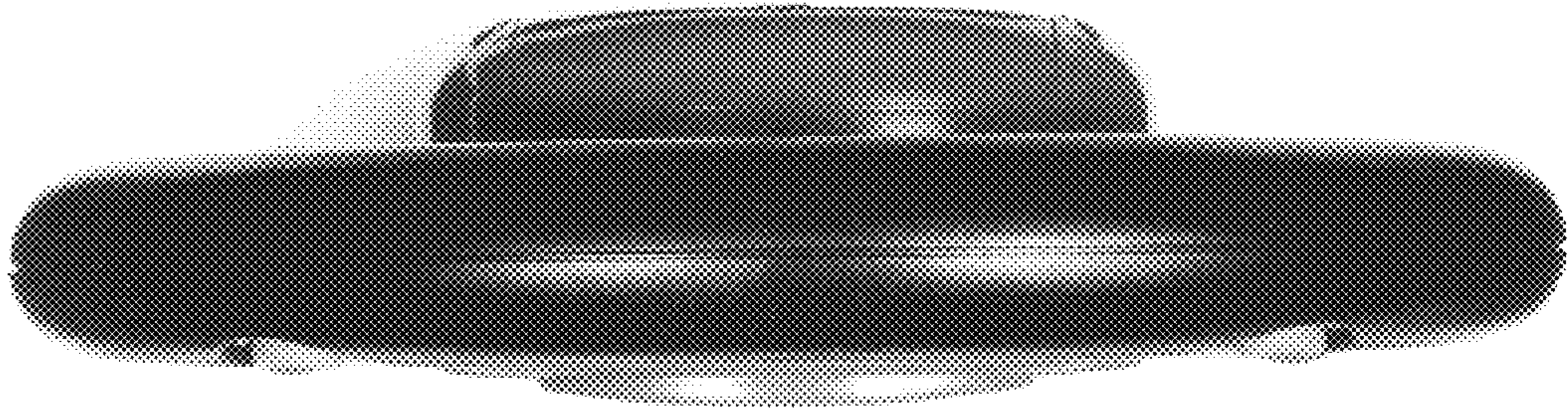

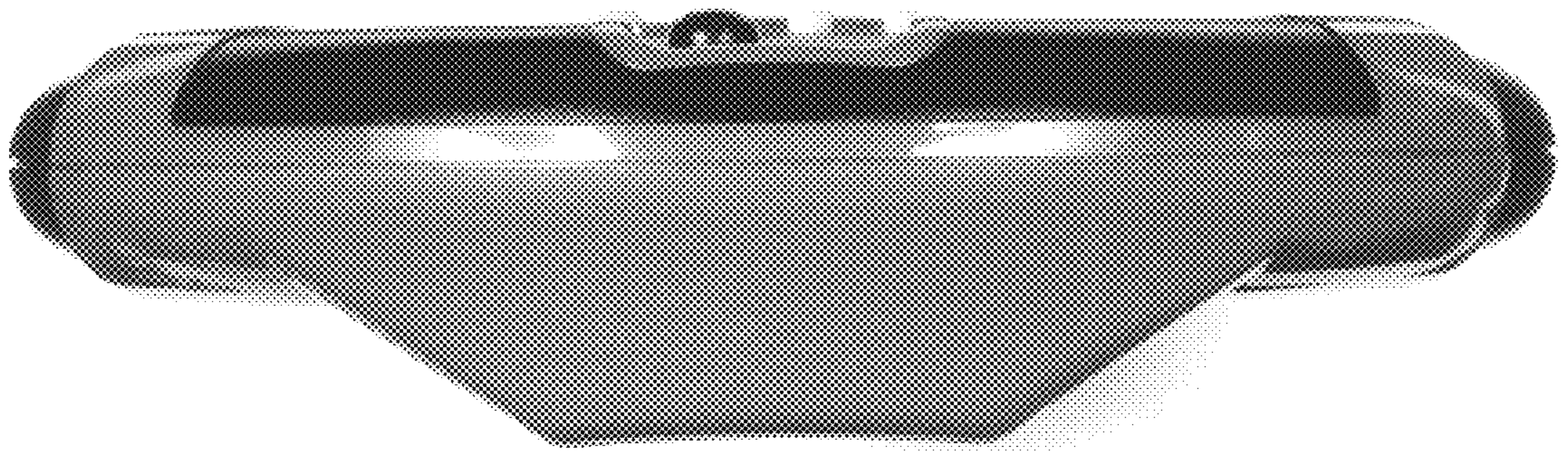
