[57] **CLAIM**

The ornamental design for a golf club head, a shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the present golf club head; FIG. 2 is a front elevational view of the golf club head, looking at the face of the head; FIG. 3 is a rear elevational view of the golf club head; FIG. 4 is a top view of the golf club head; FIG. 5 is a bottom view of the golf club head; FIG. 6 is a toe view of the golf club head; FIG. 7 is a heel view of the golf club head, looking at the hosel of the head; and, FIG. 8 is a bottom view of an alternate embodiment of the golf club head.

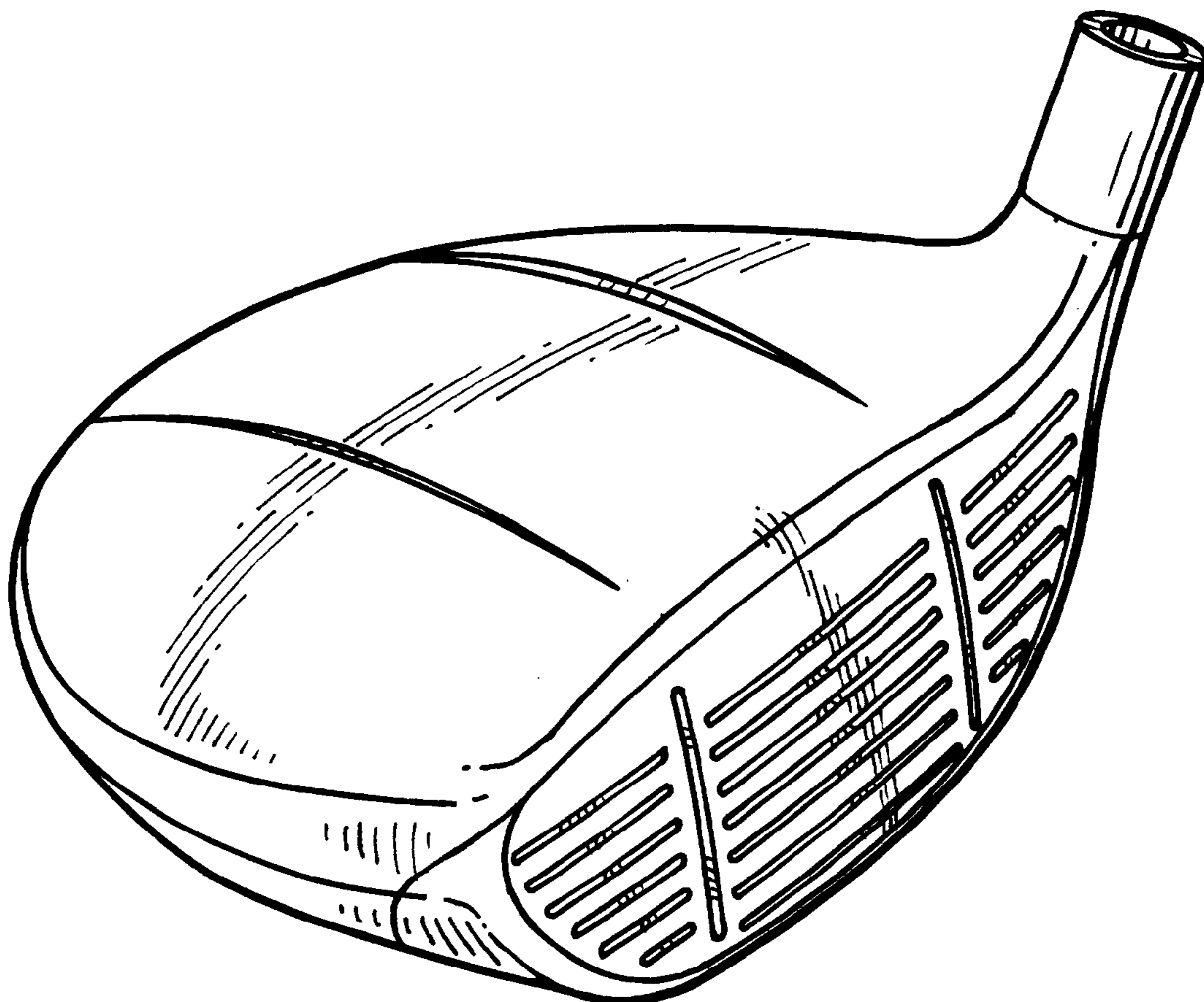

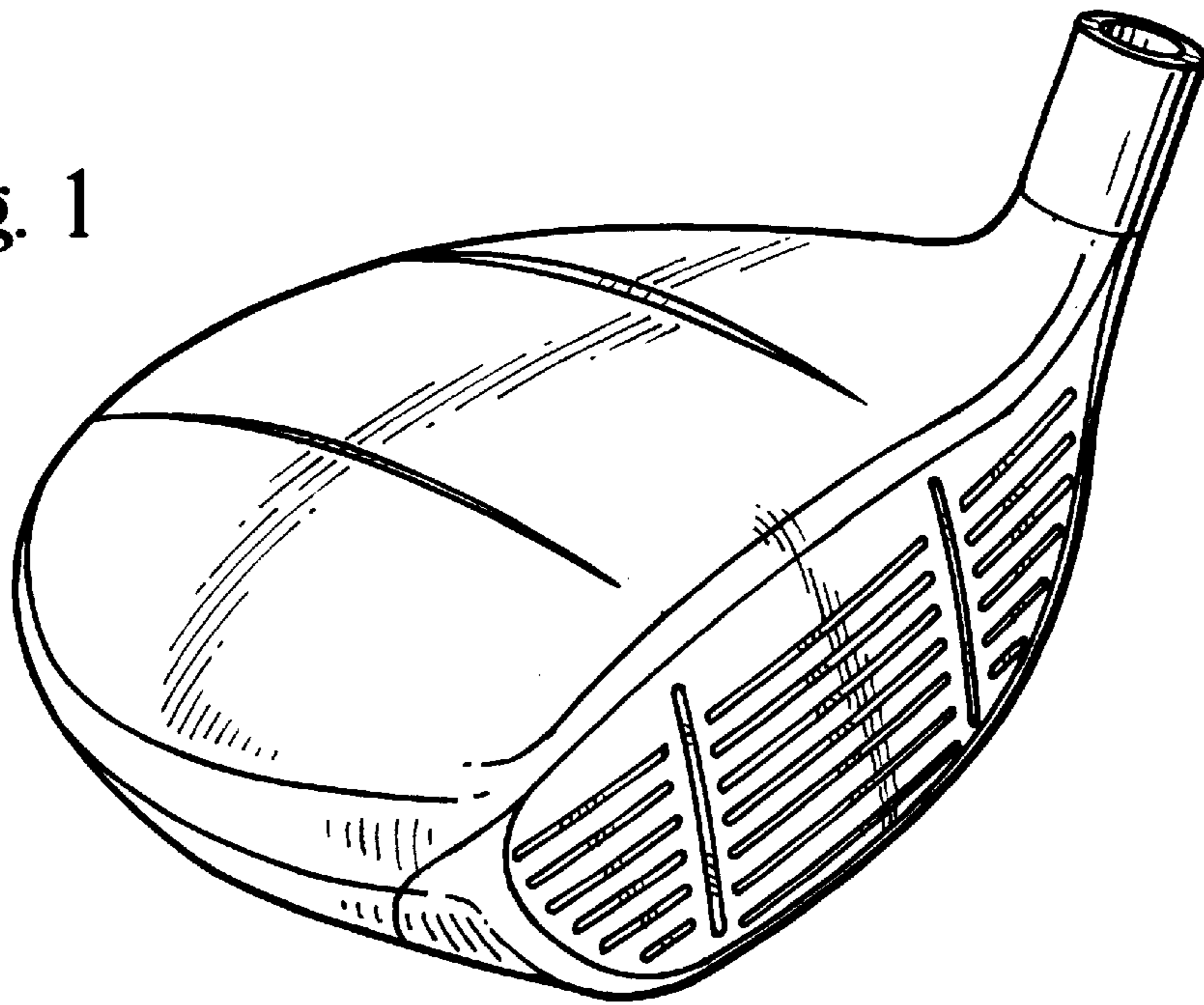

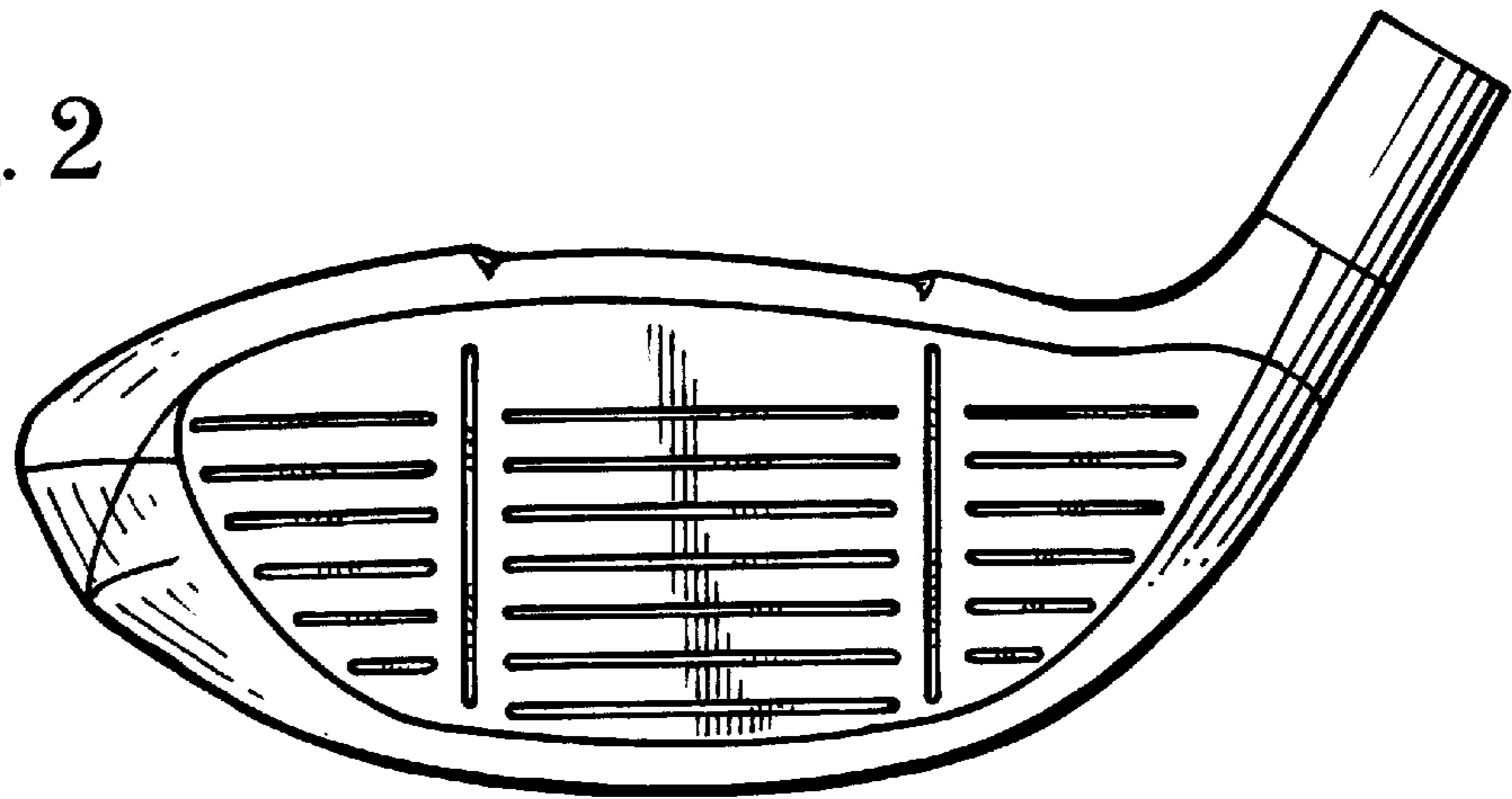
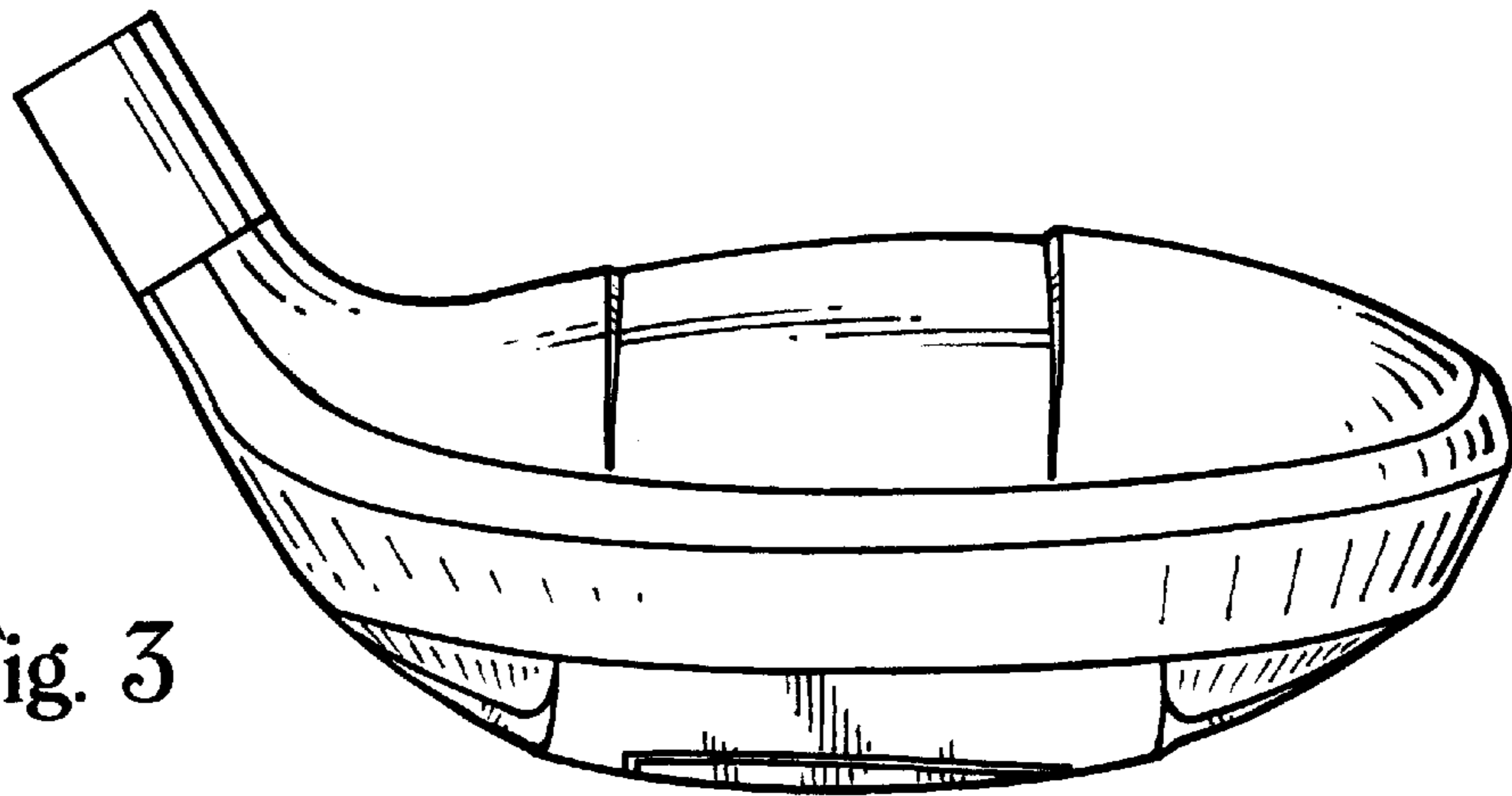

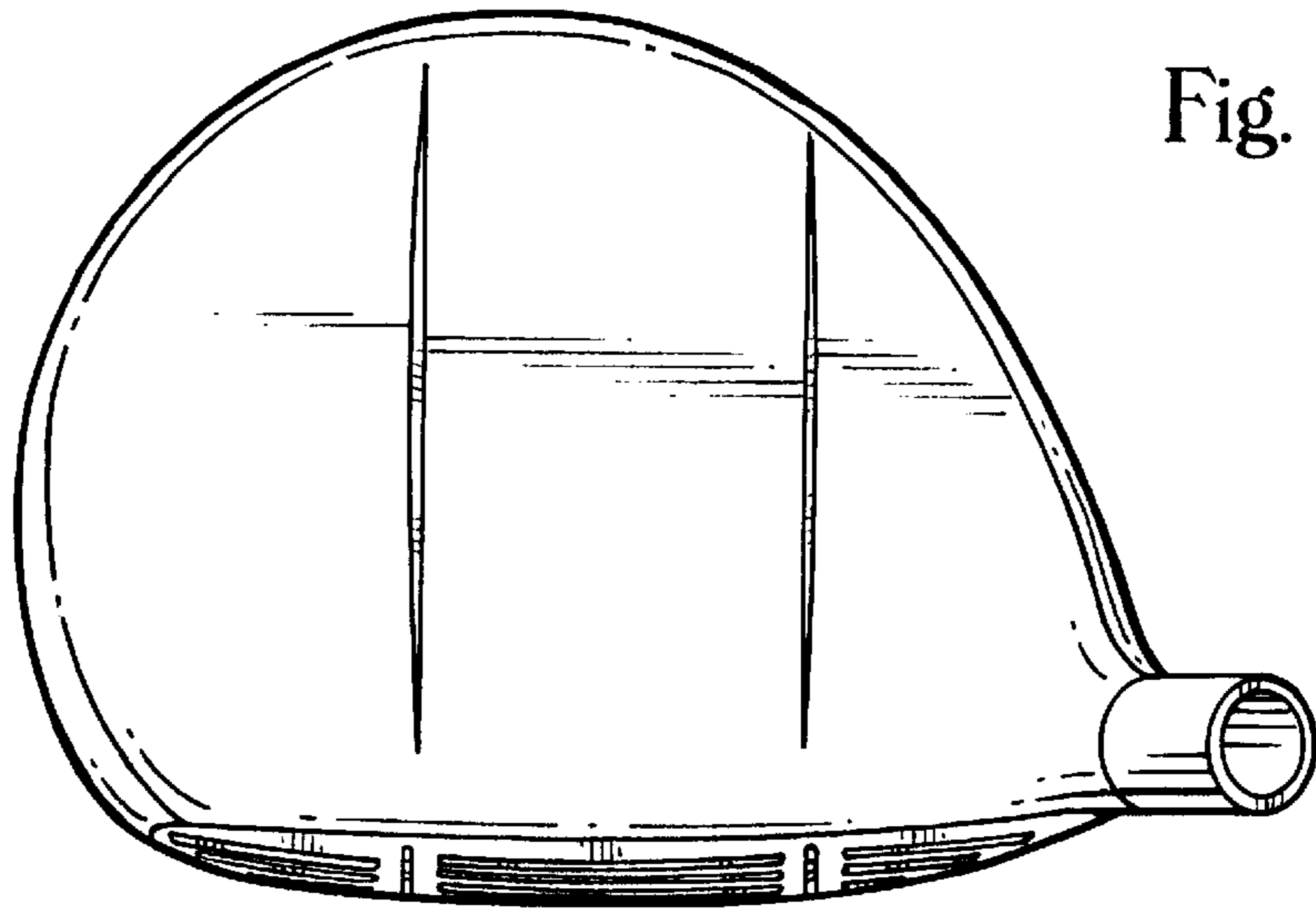

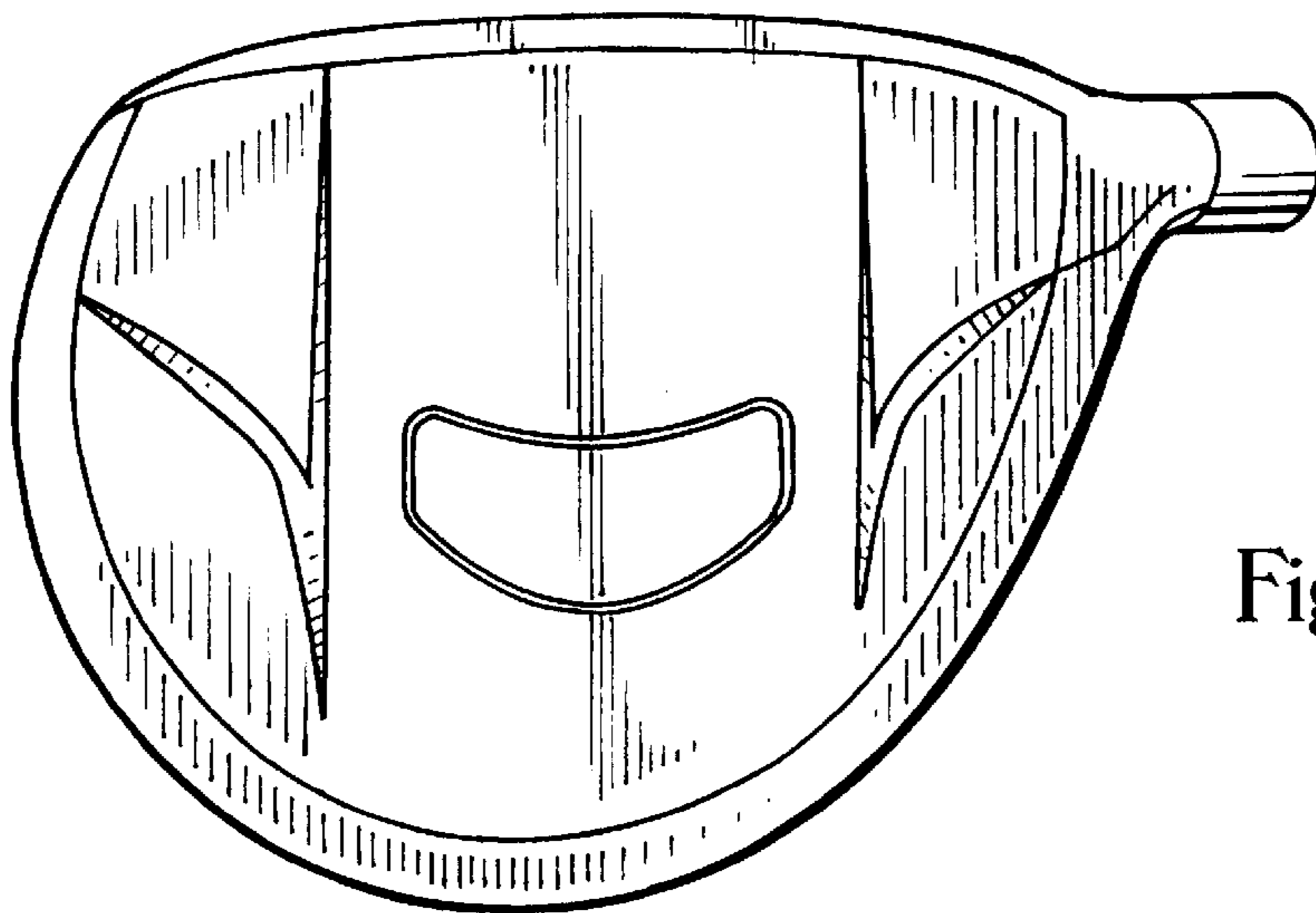

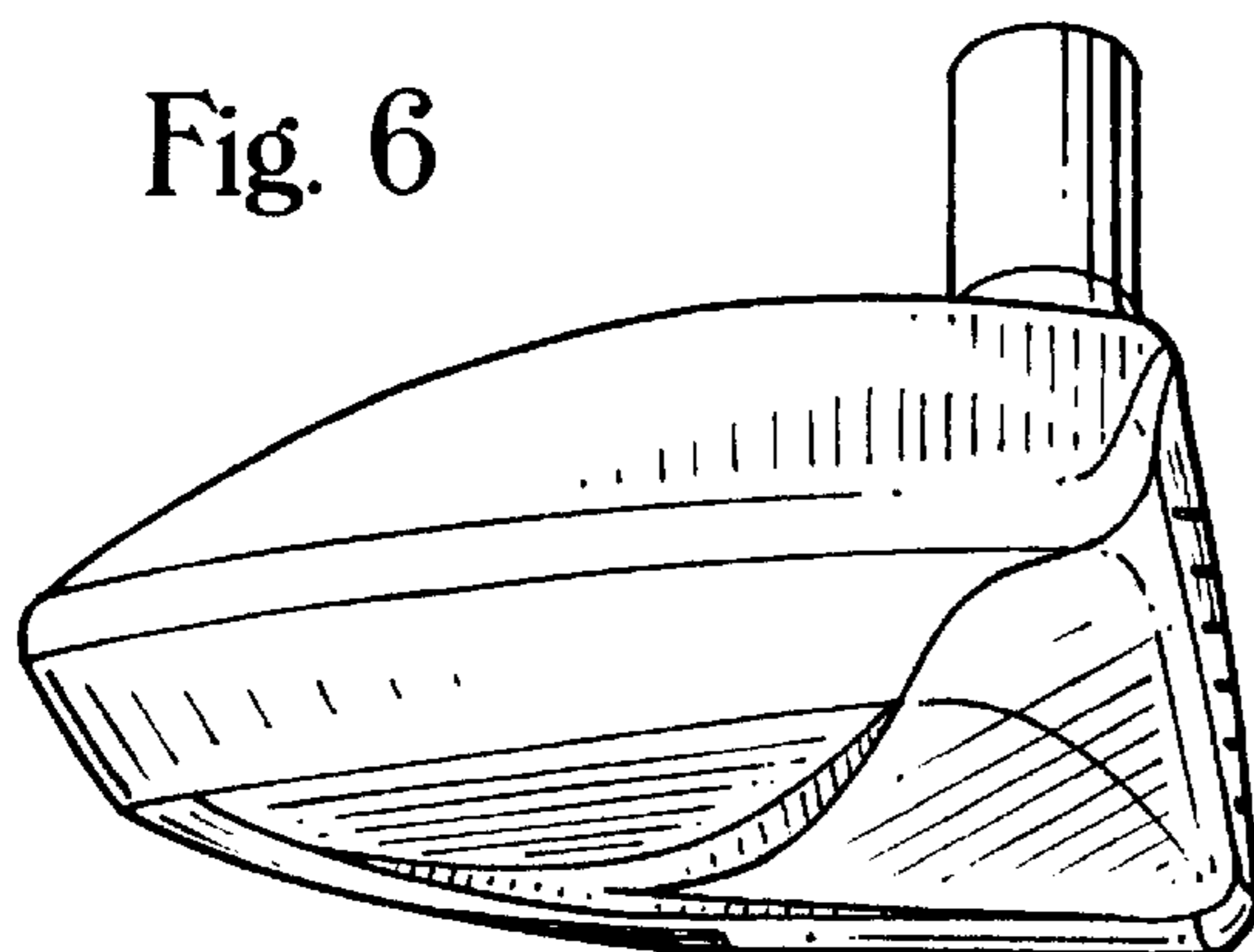

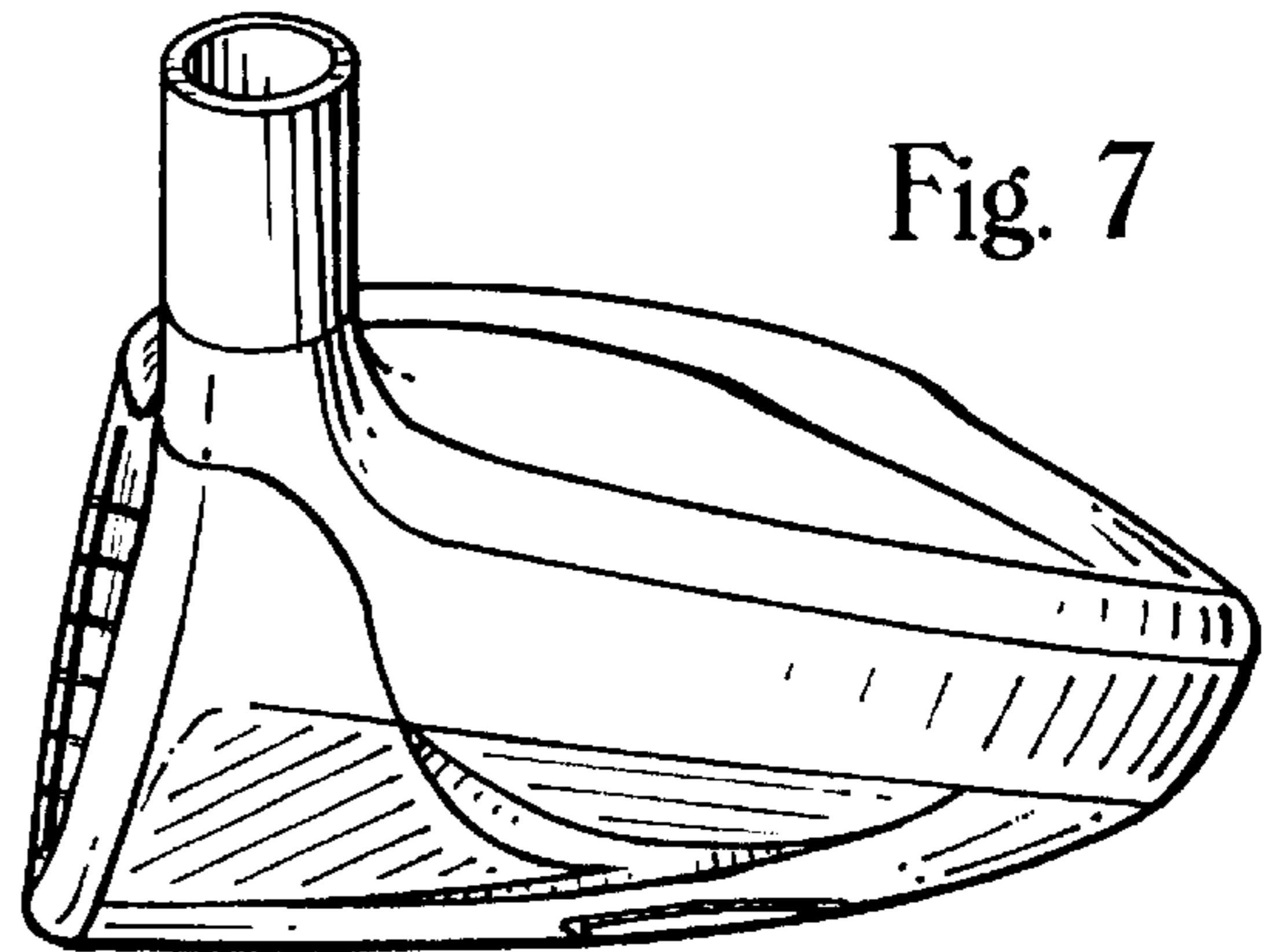

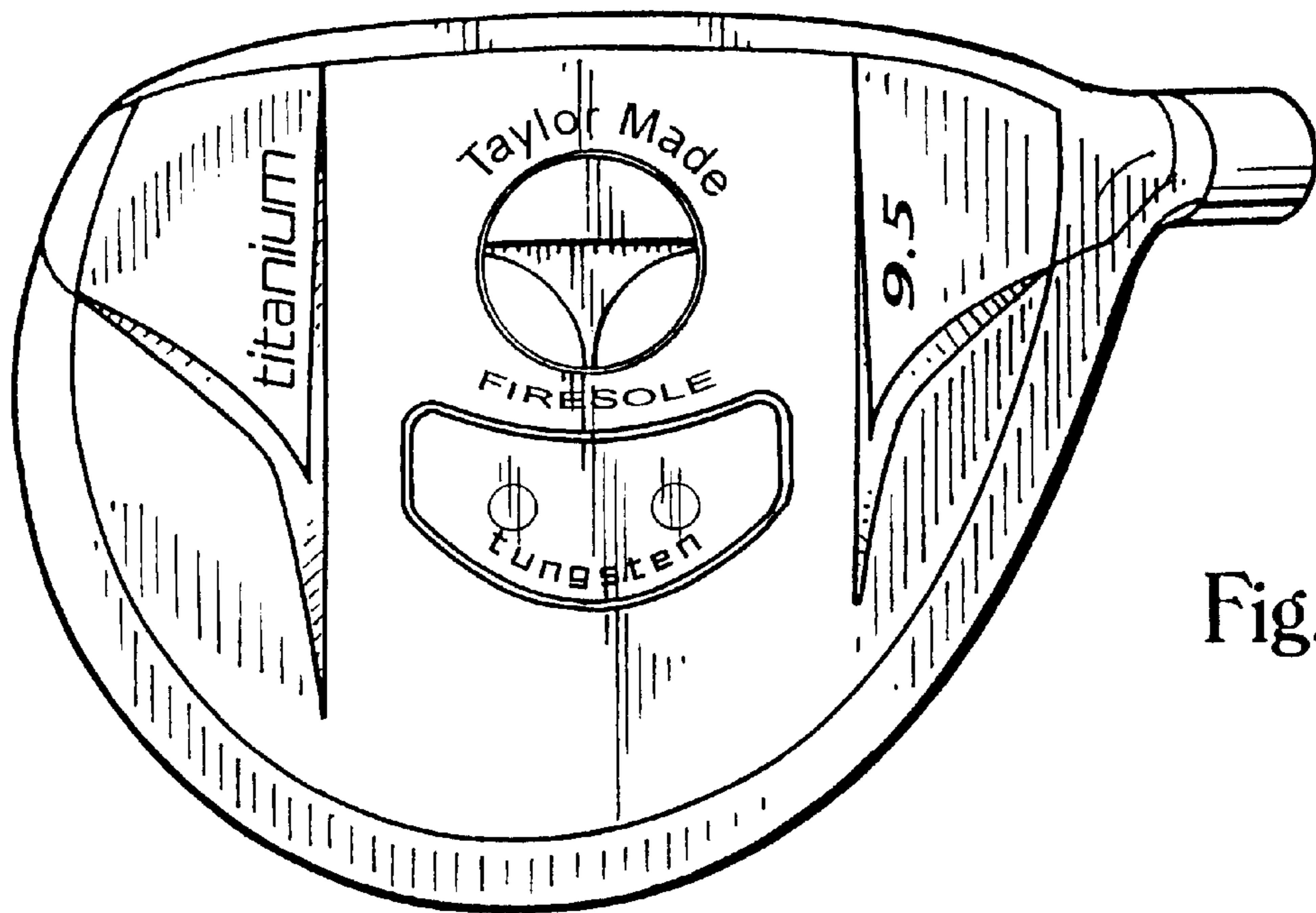
