[57] **CLAIM**

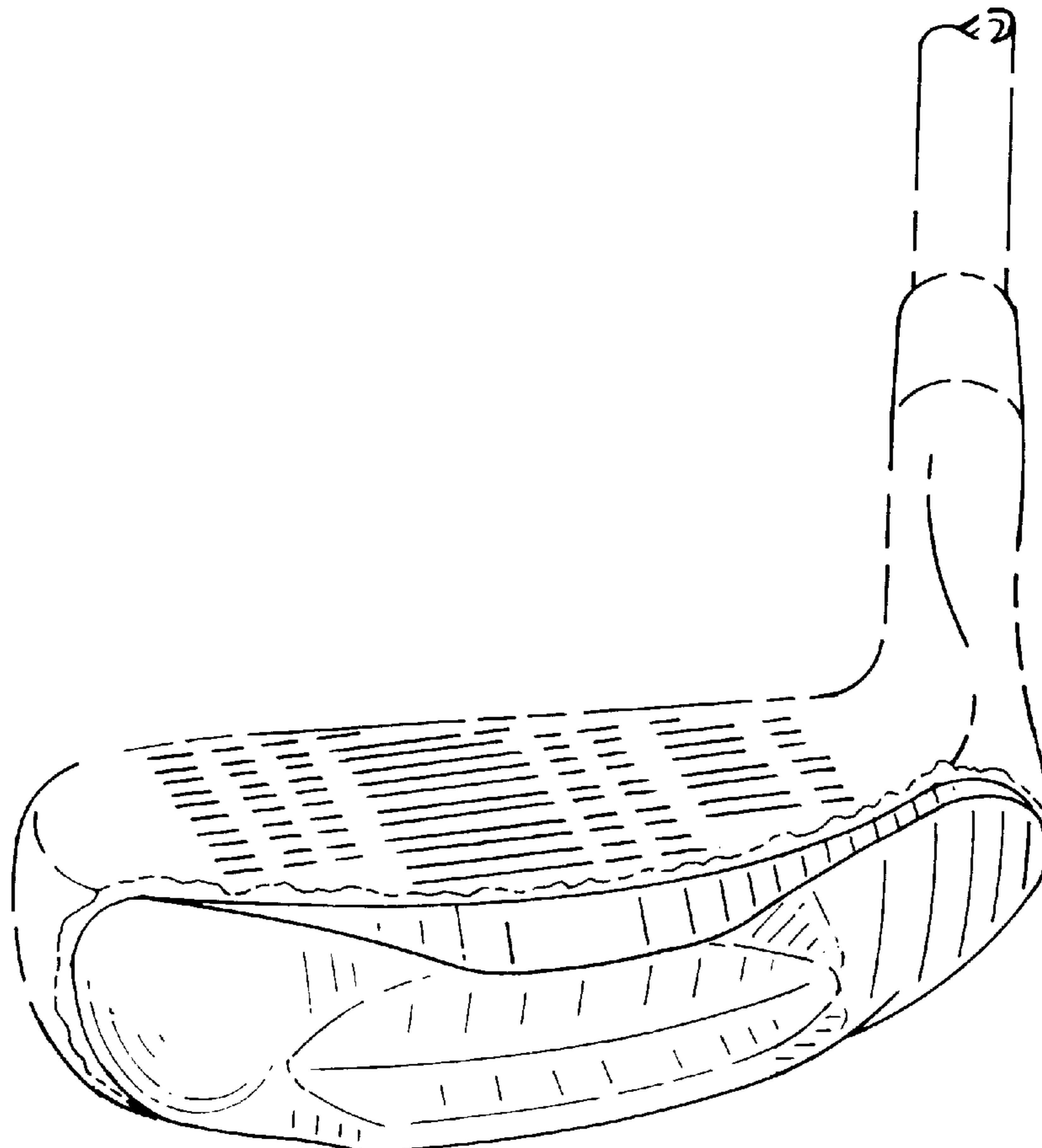
The ornamental design for a golf club head bottom, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a golf club head bottom showing my new design;  
FIG. 2 is a rear perspective thereof;  
FIG. 3 is a heel end perspective view thereof;  
FIG. 4 is a plan view thereof;  
FIG. 5 is a rear elevational view thereof;  
FIG. 6 is a toe end view thereof;  
FIG. 7 is a heel end view thereof; and,  
FIG. 8 is a front elevational view thereof.

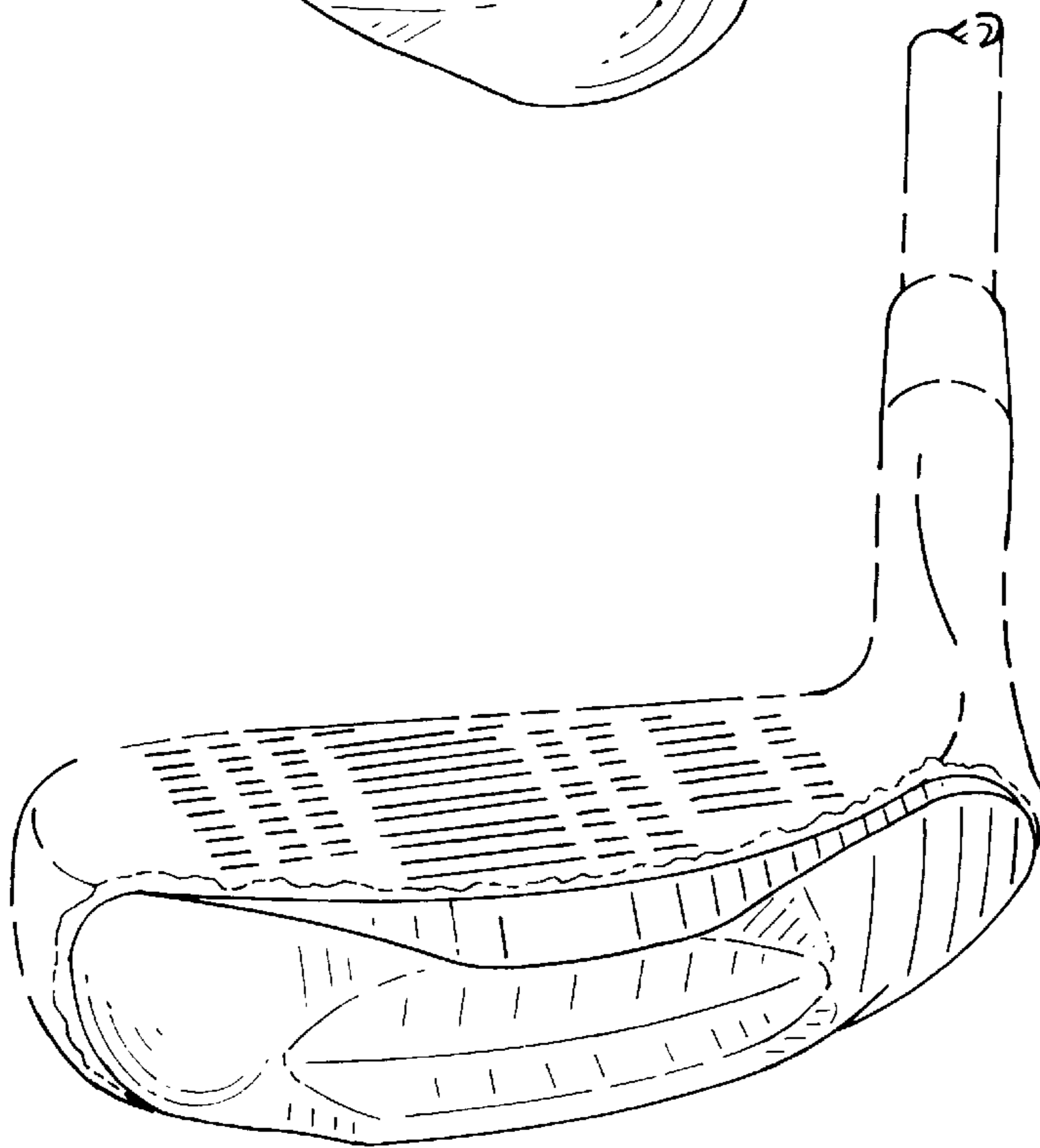
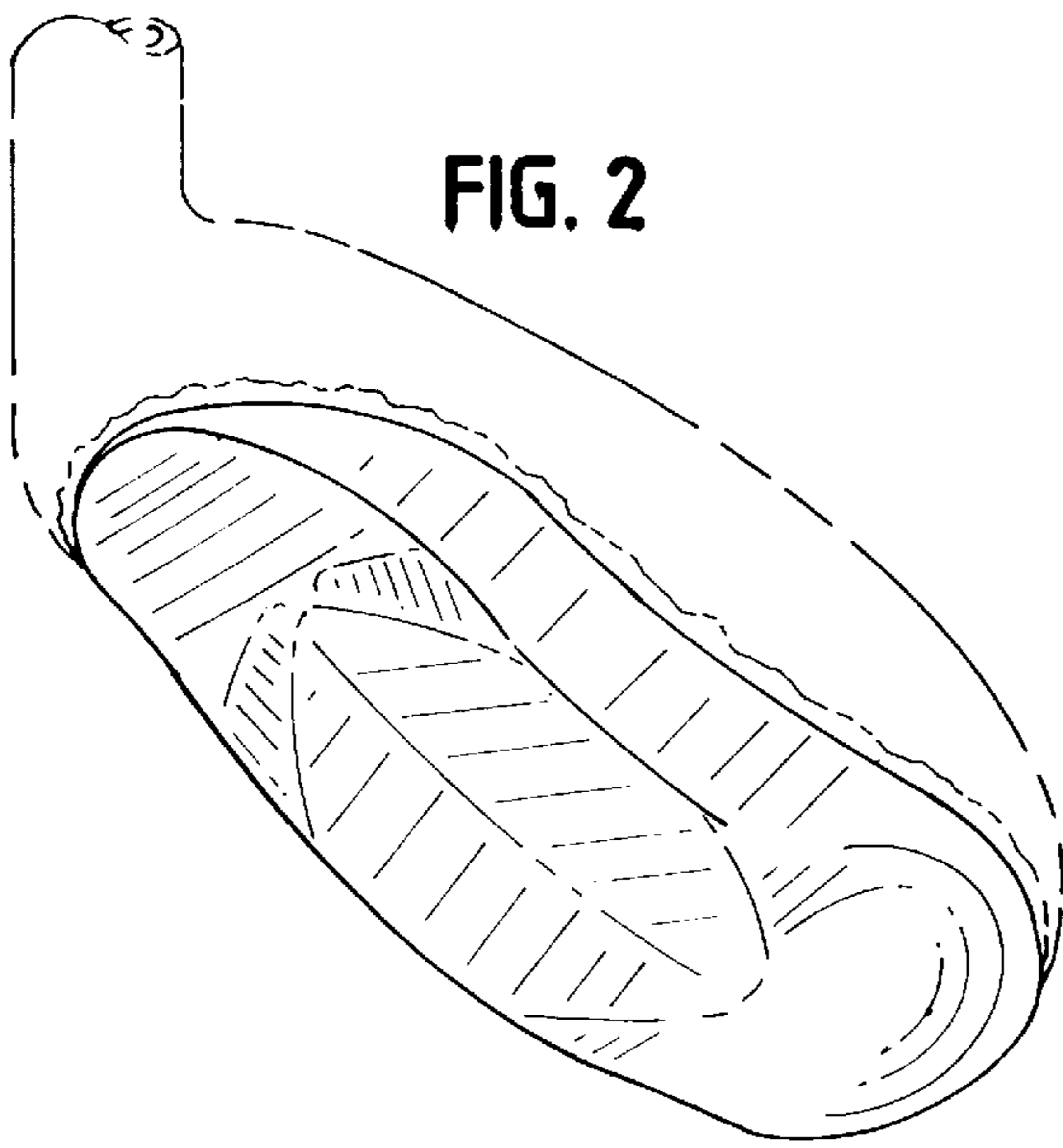

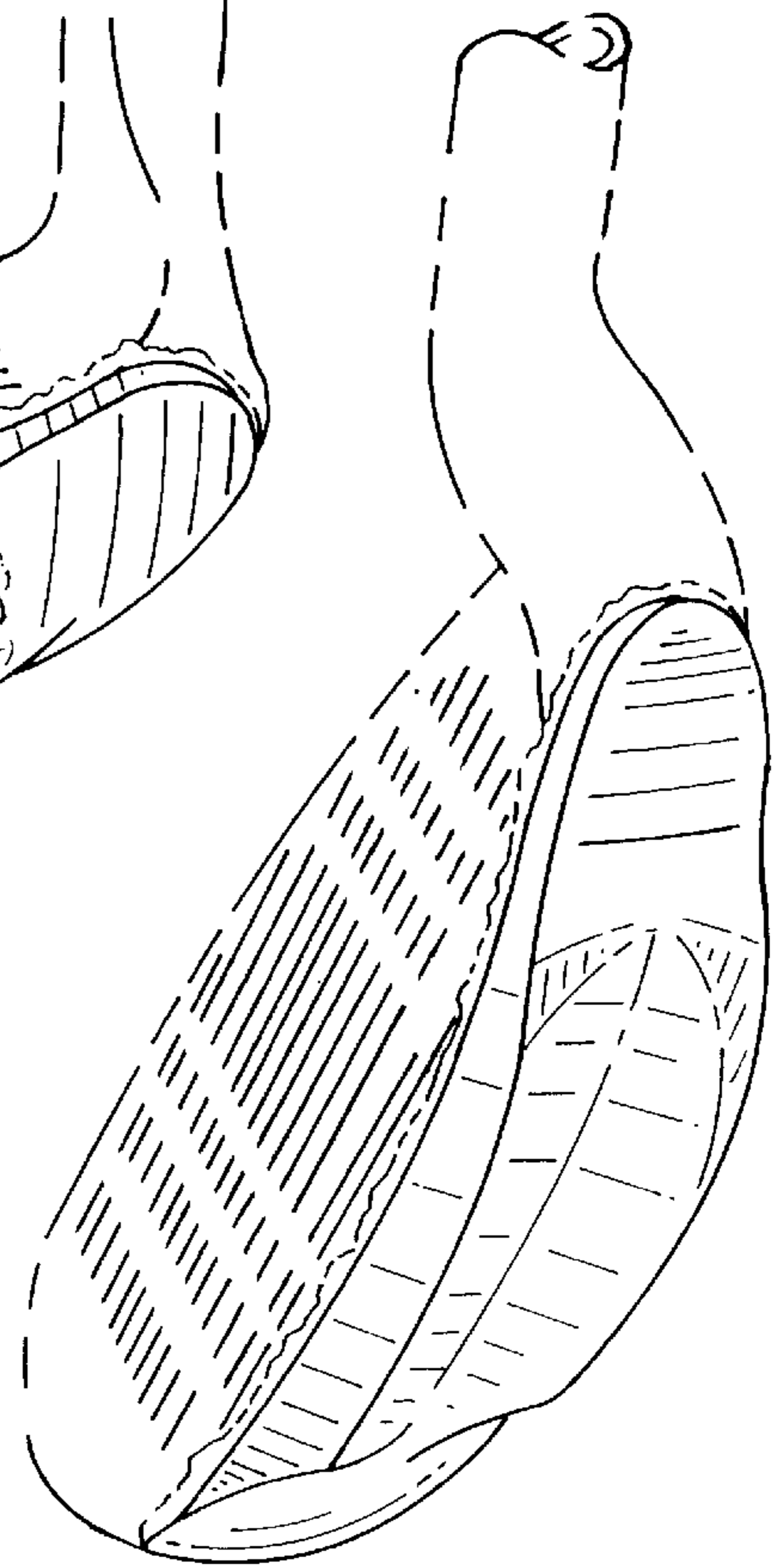

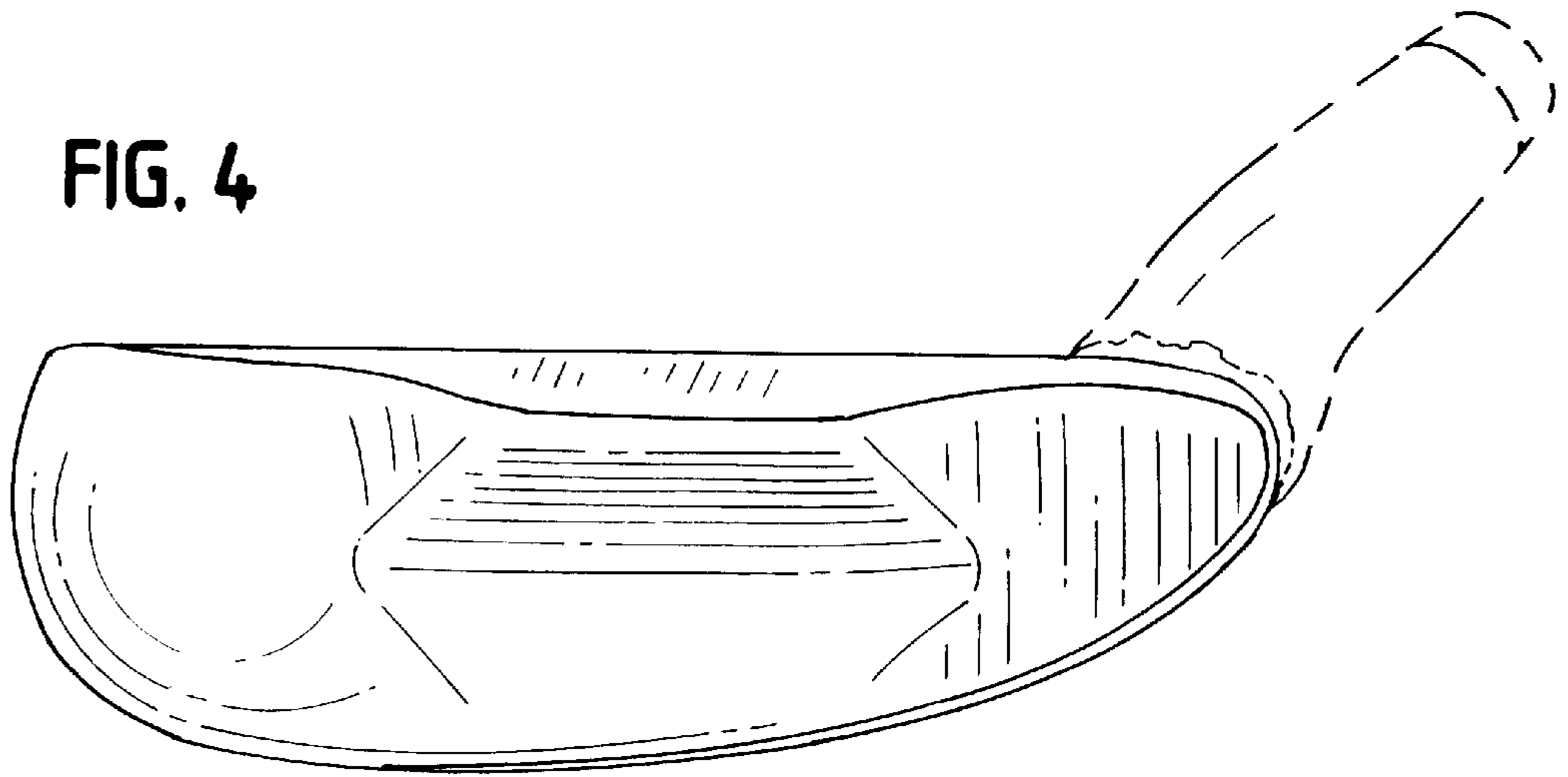

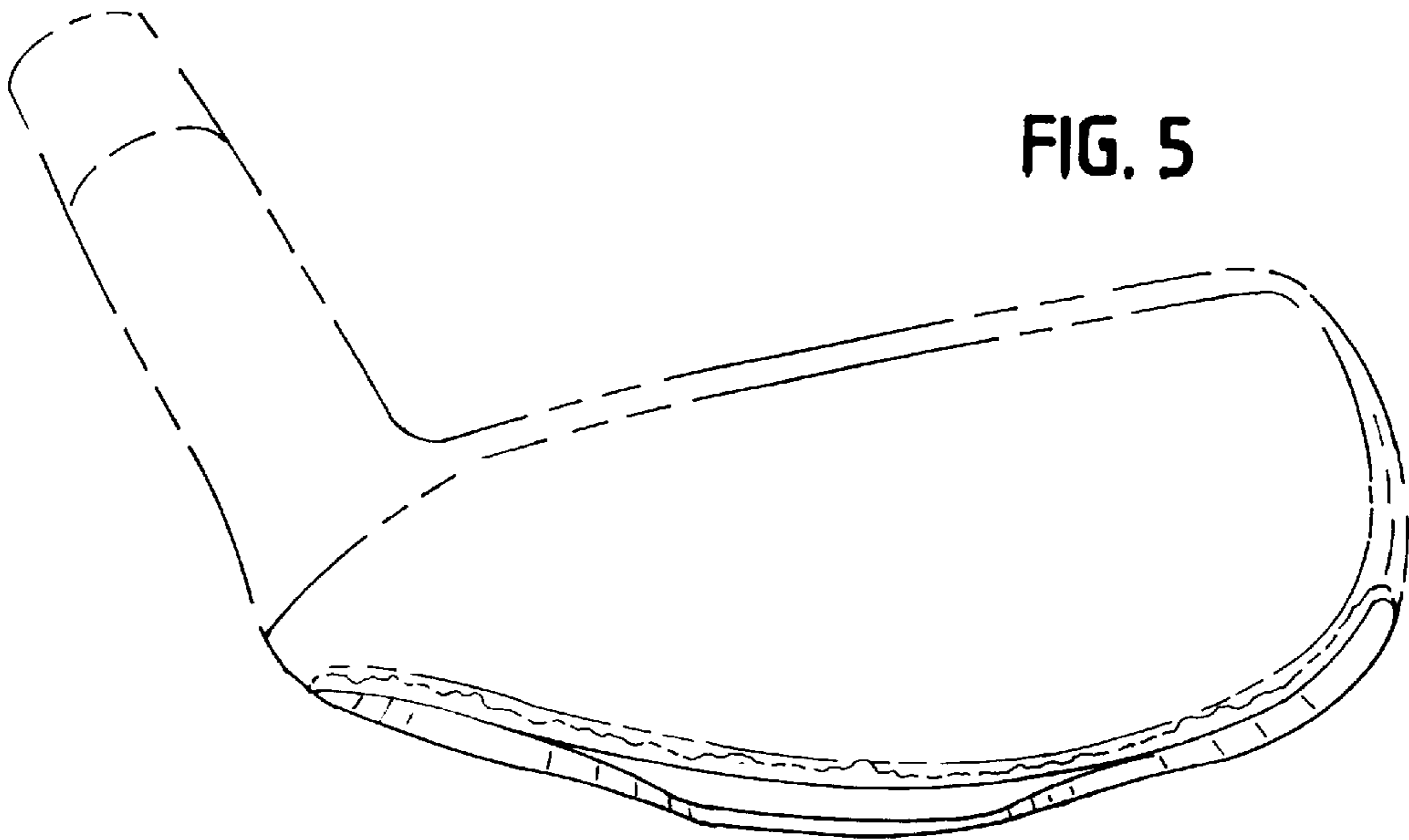

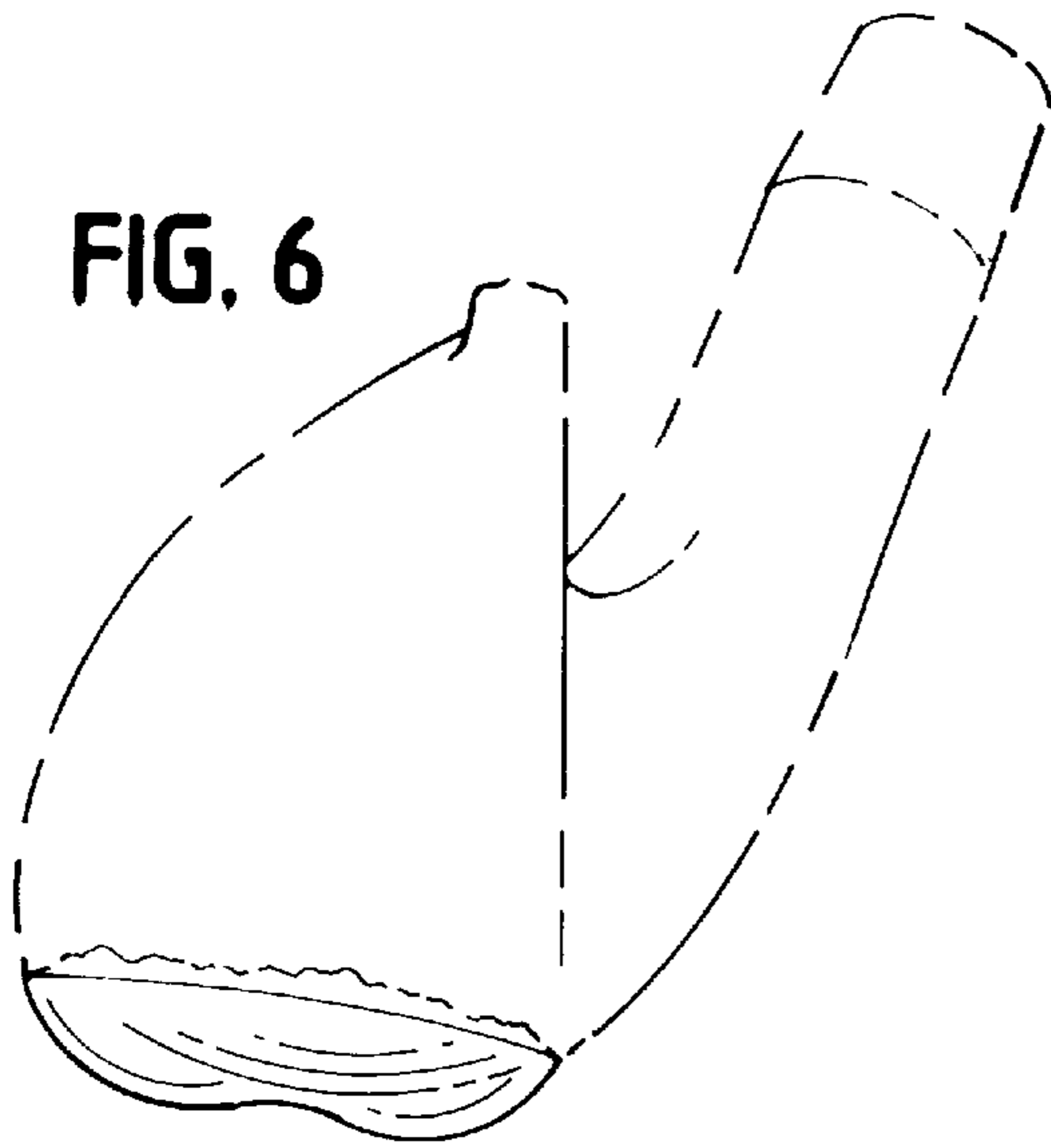
