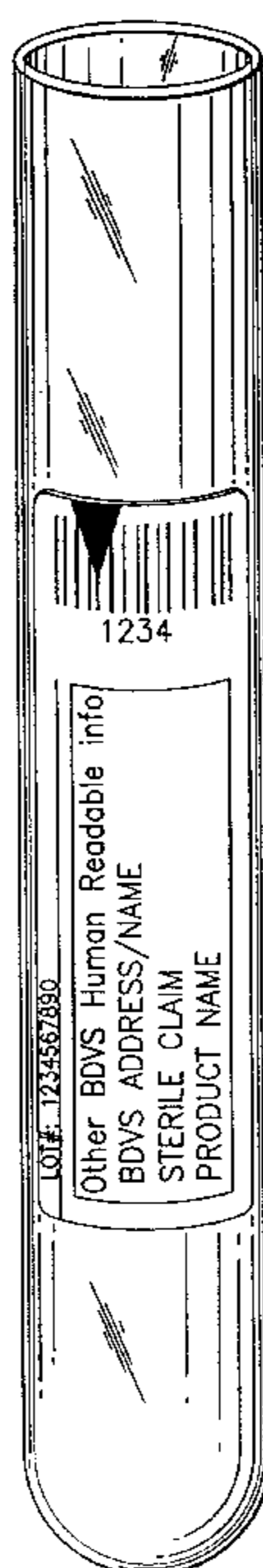
## [57] CLAIM

The ornamental design for a collection tube with a specimen label, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of the collection tube with a specimen label;  
FIG. 2 is a front view of FIG. 1;  
FIG. 3 is a top plan view of FIG. 1;  
FIG. 4 is a left side view of FIG. 1;  
FIG. 5 is a right side view of FIG. 1; and,  
FIG. 6 is a bottom plan view of FIG. 1.

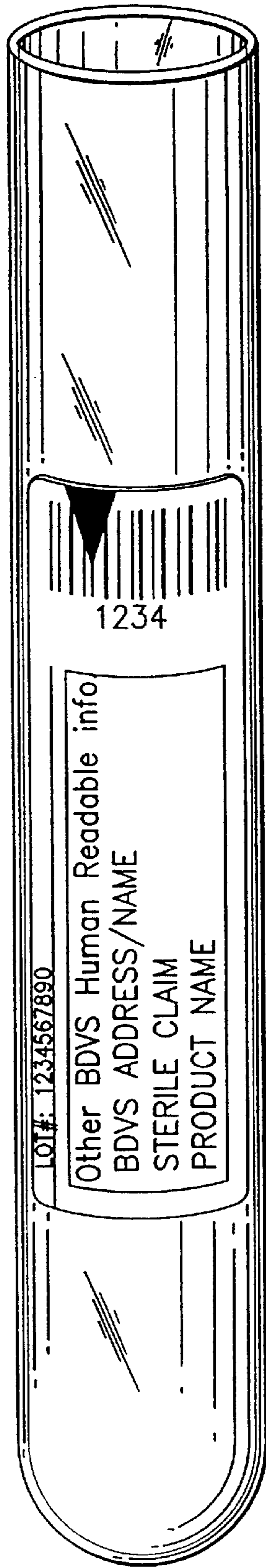

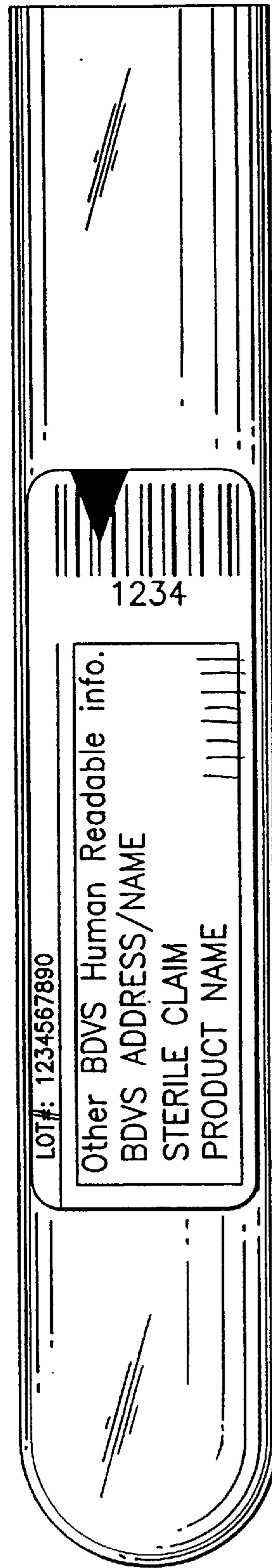

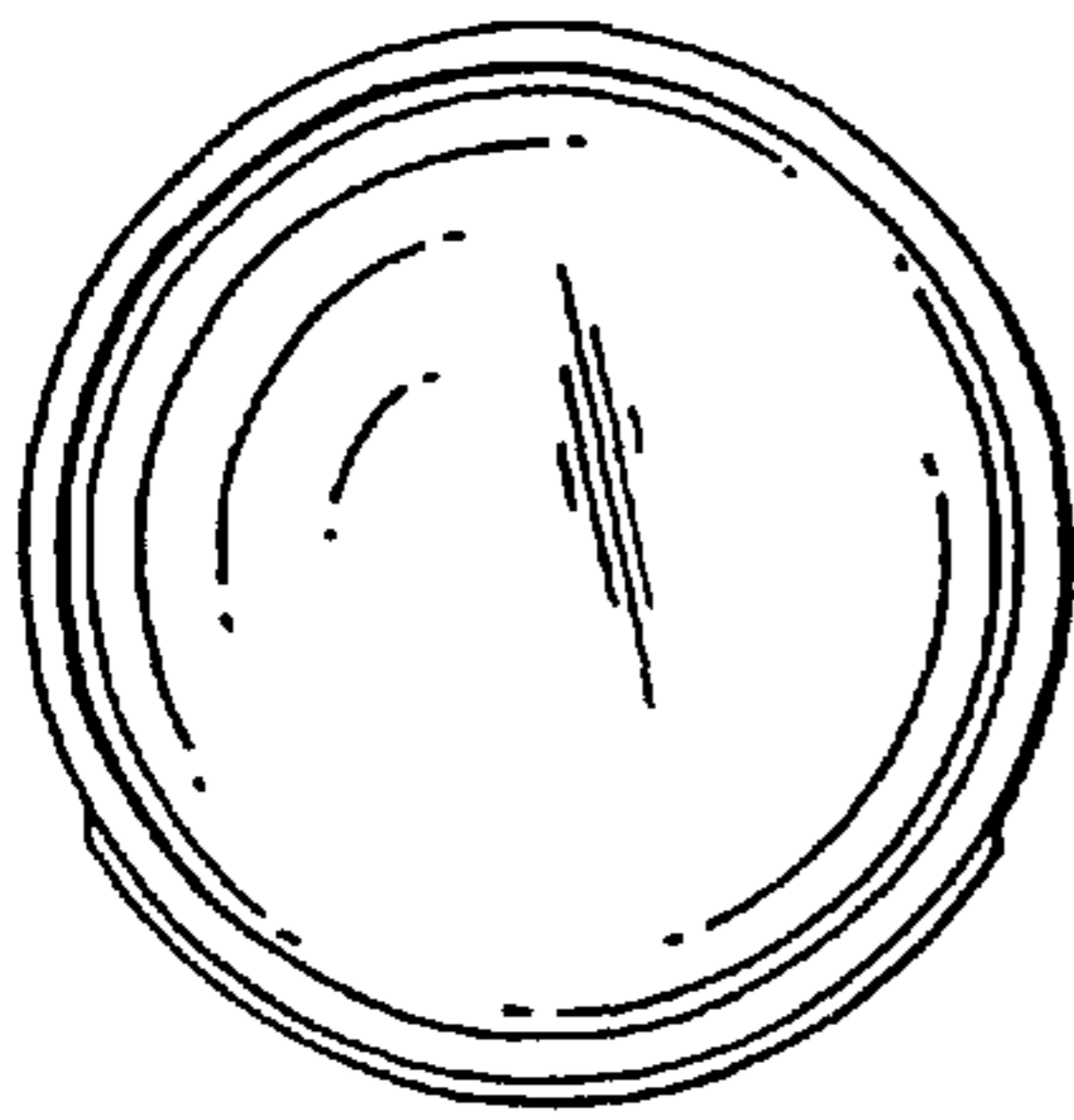

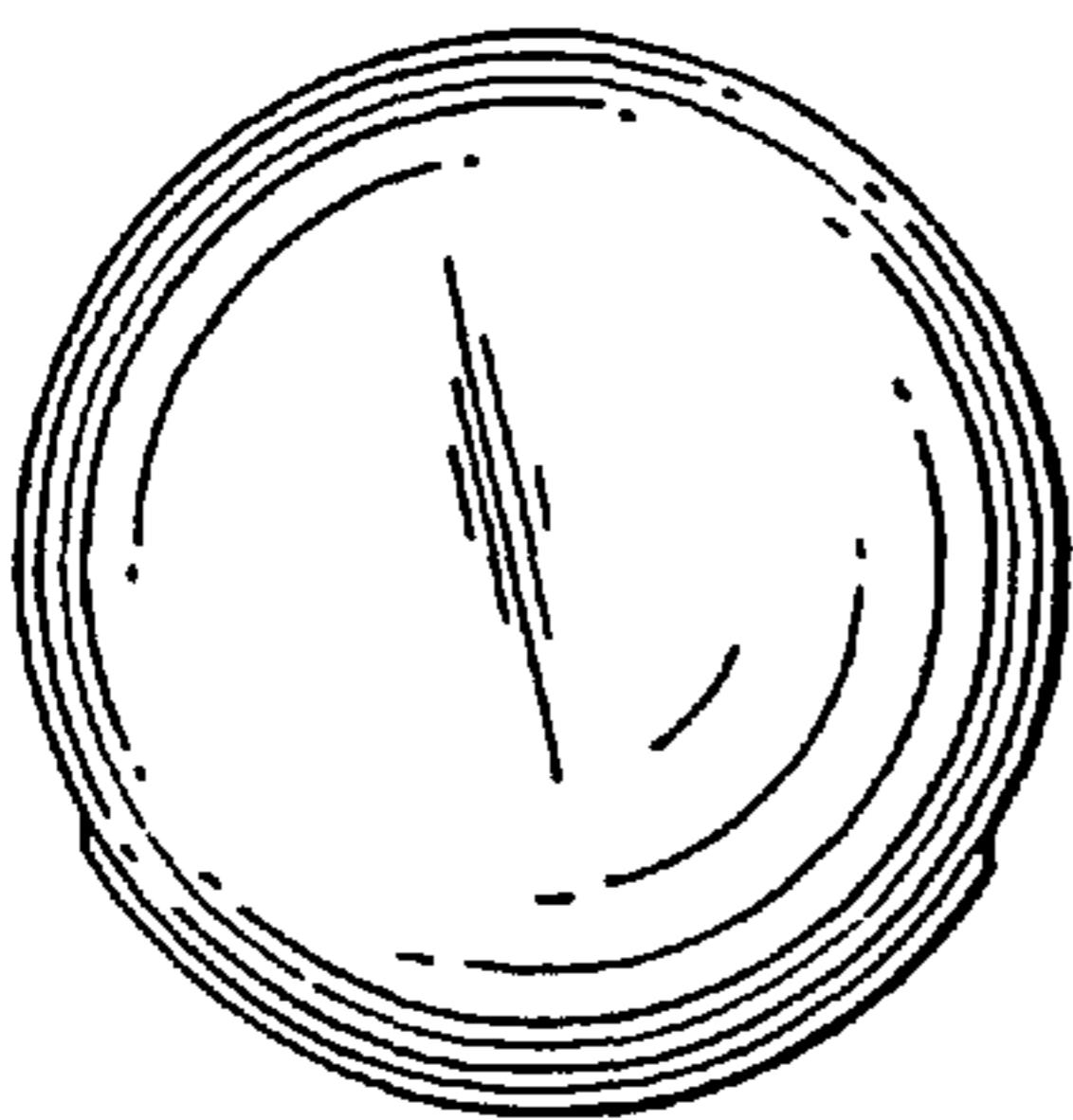

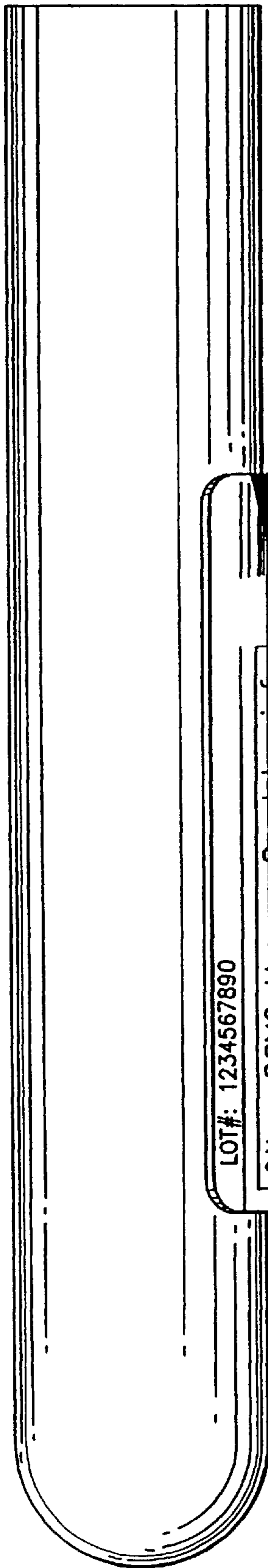

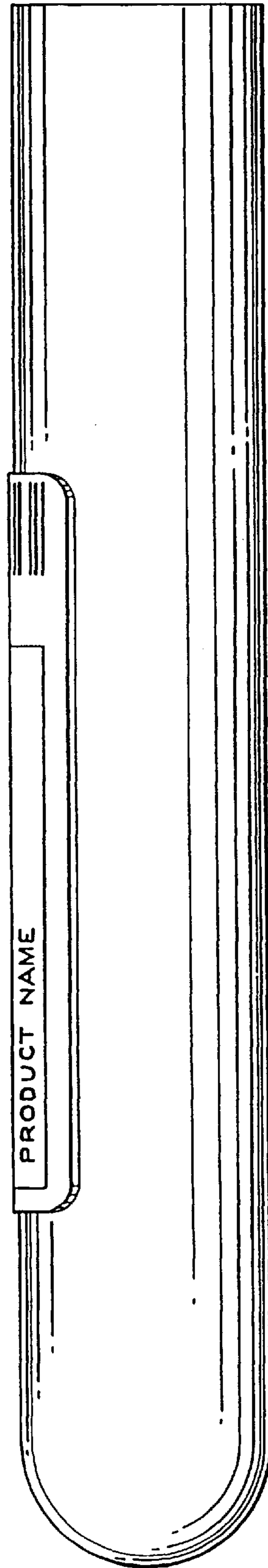
