[57] **CLAIM**

The ornamental design for a decorative rim for a fishbowl, as shown and described.

**DESCRIPTION**

FIG. 1 is a top and front perspective view showing my new design reduced in size relative to the views described below;

FIG. 2 is a top plan view thereof;

FIG. 3 is a front elevational view thereof, the rear, right side and left side elevational views being identical thereto;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a cross-sectional view taken along line 5—5 of FIG. 4;

FIG. 6 is a top plan view showing another embodiment of my new design;

FIG. 7 is a front elevational view thereof, the rear, right side and left side elevational views being identical thereto;

FIG. 8 is a bottom plan view thereof;

FIG. 9 is a cross-sectional view taken along line 9—9 of FIG. 8;

FIG. 10 is a top plan view showing still another embodiment of my new design;

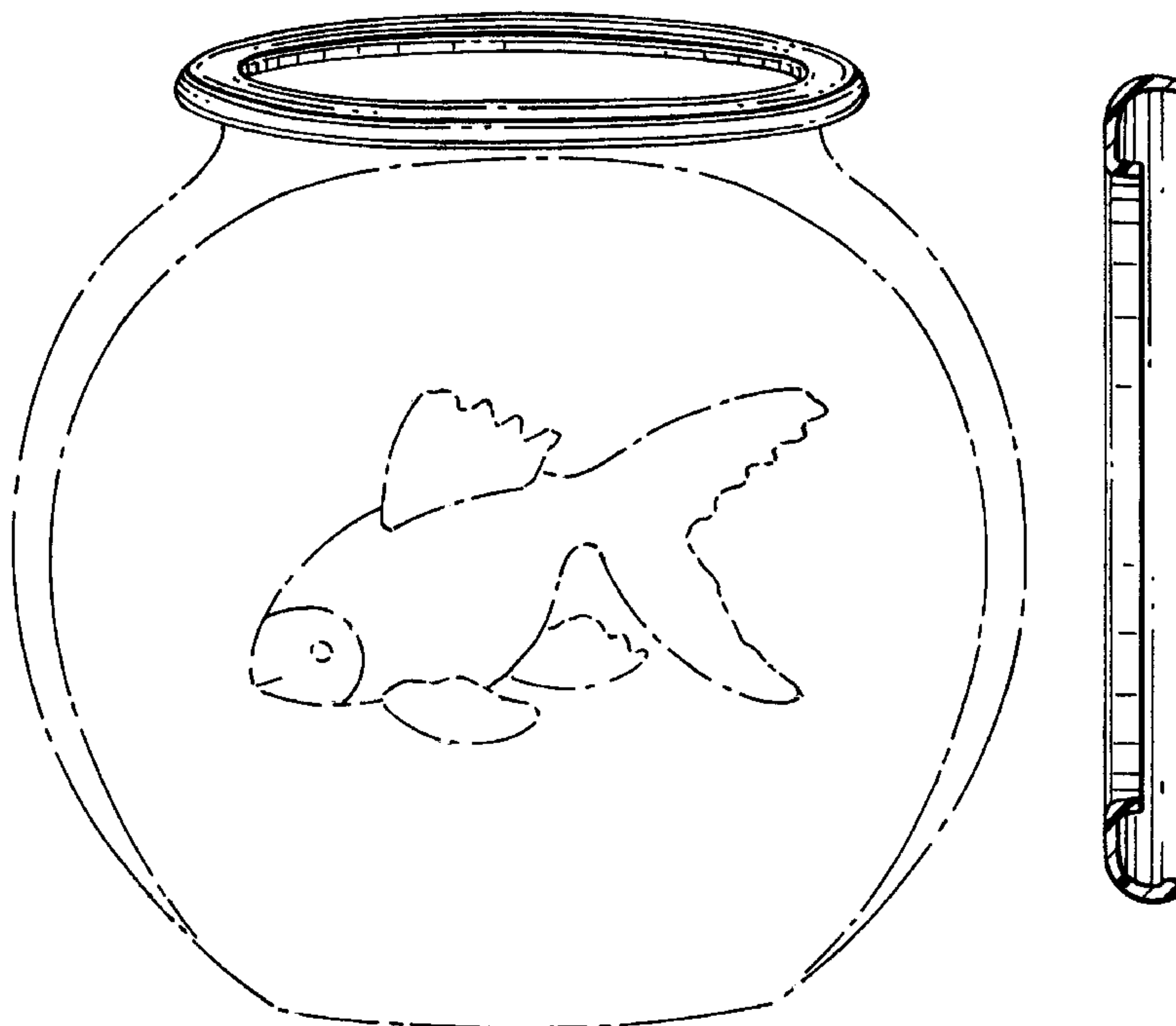
FIG. 11 is a front elevational view thereof, the rear, right side and left side elevational views being identical thereto;

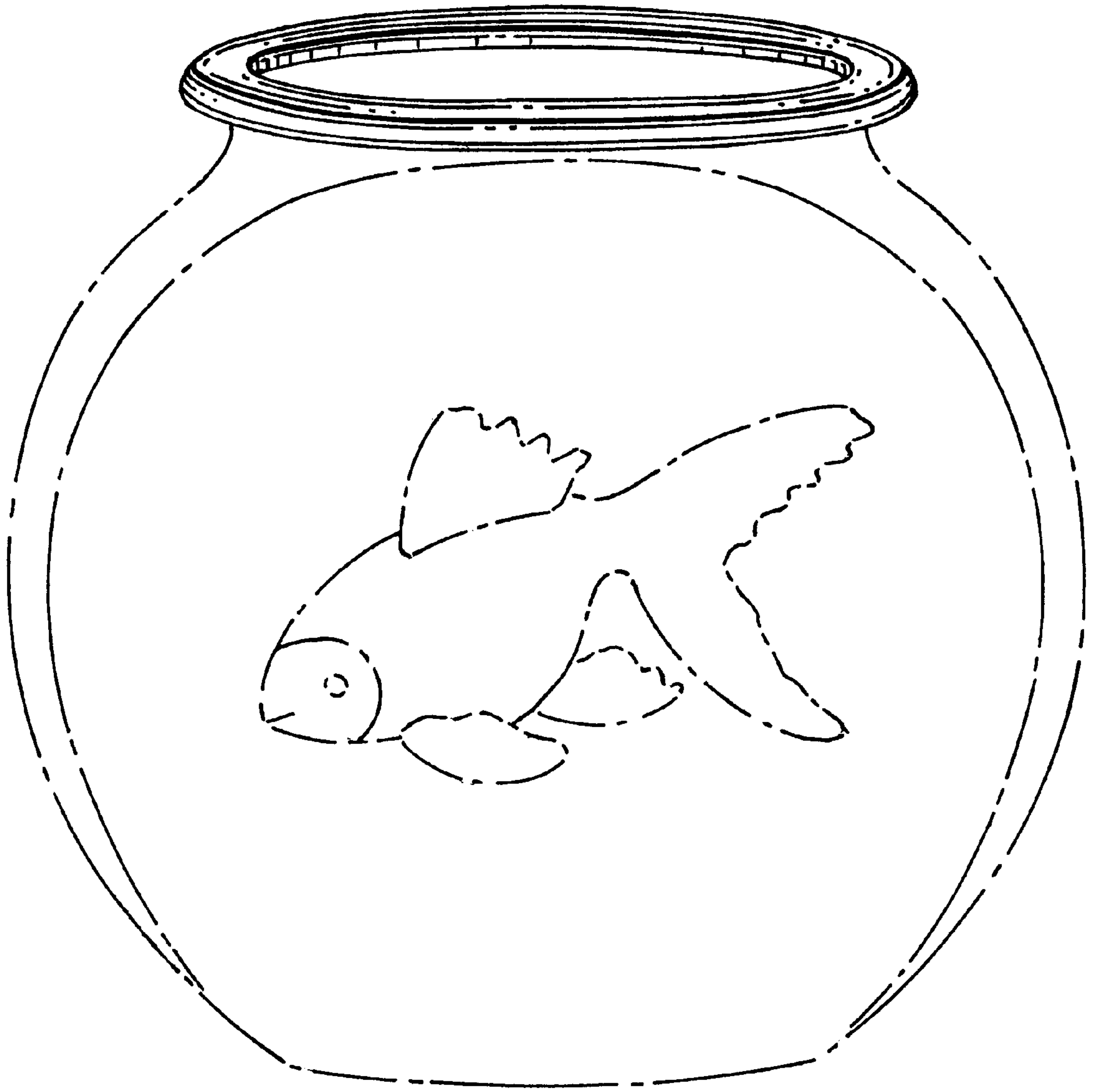

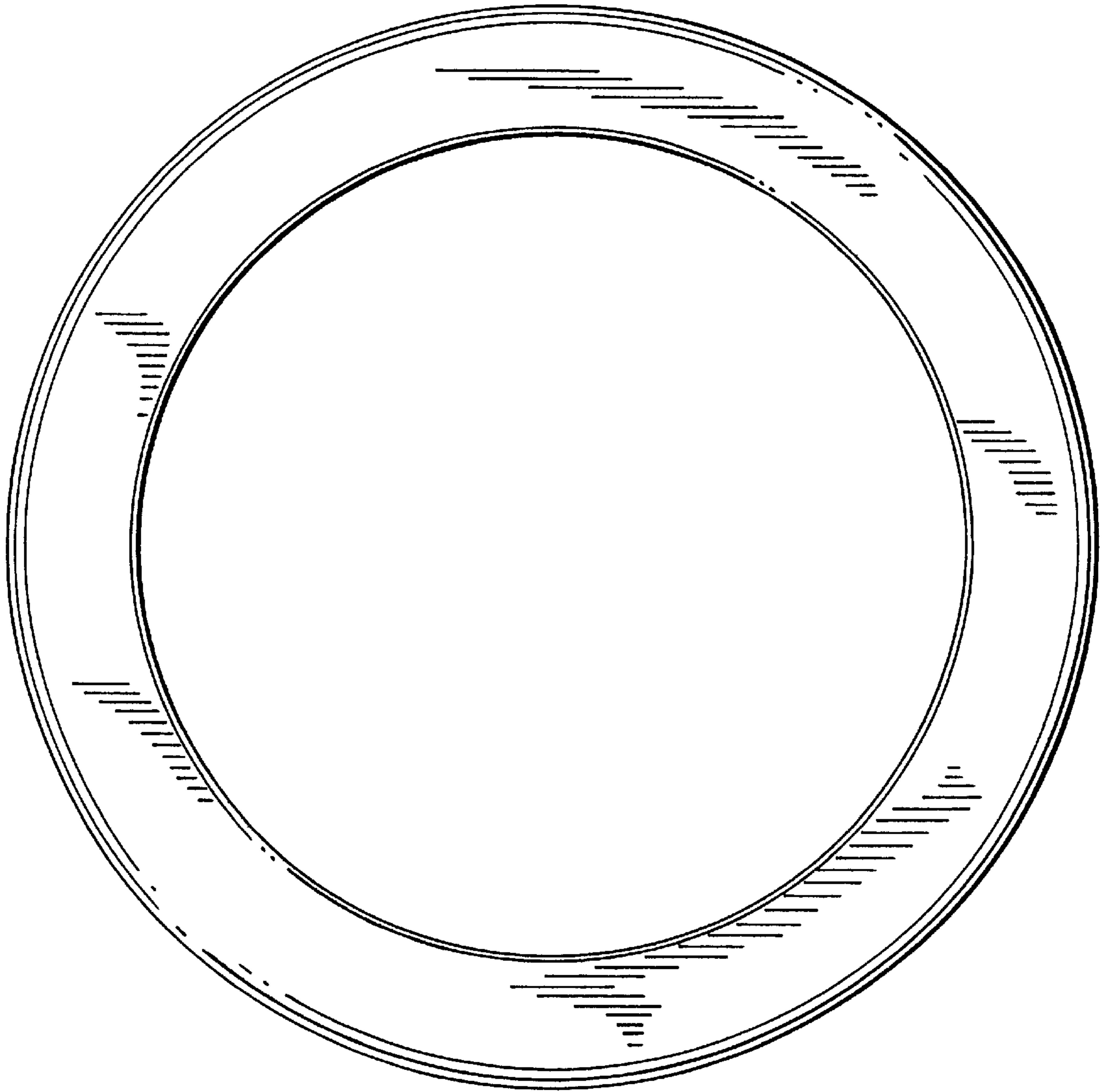

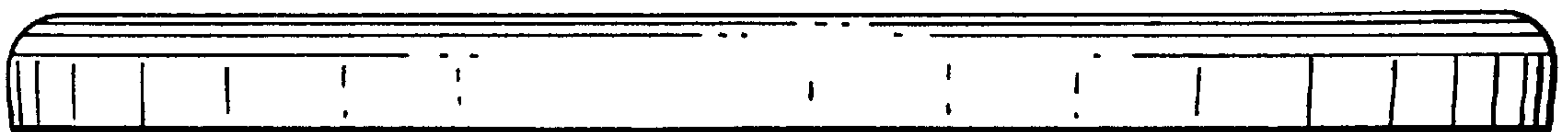

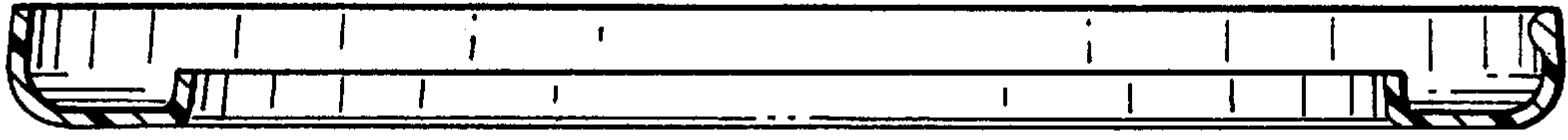

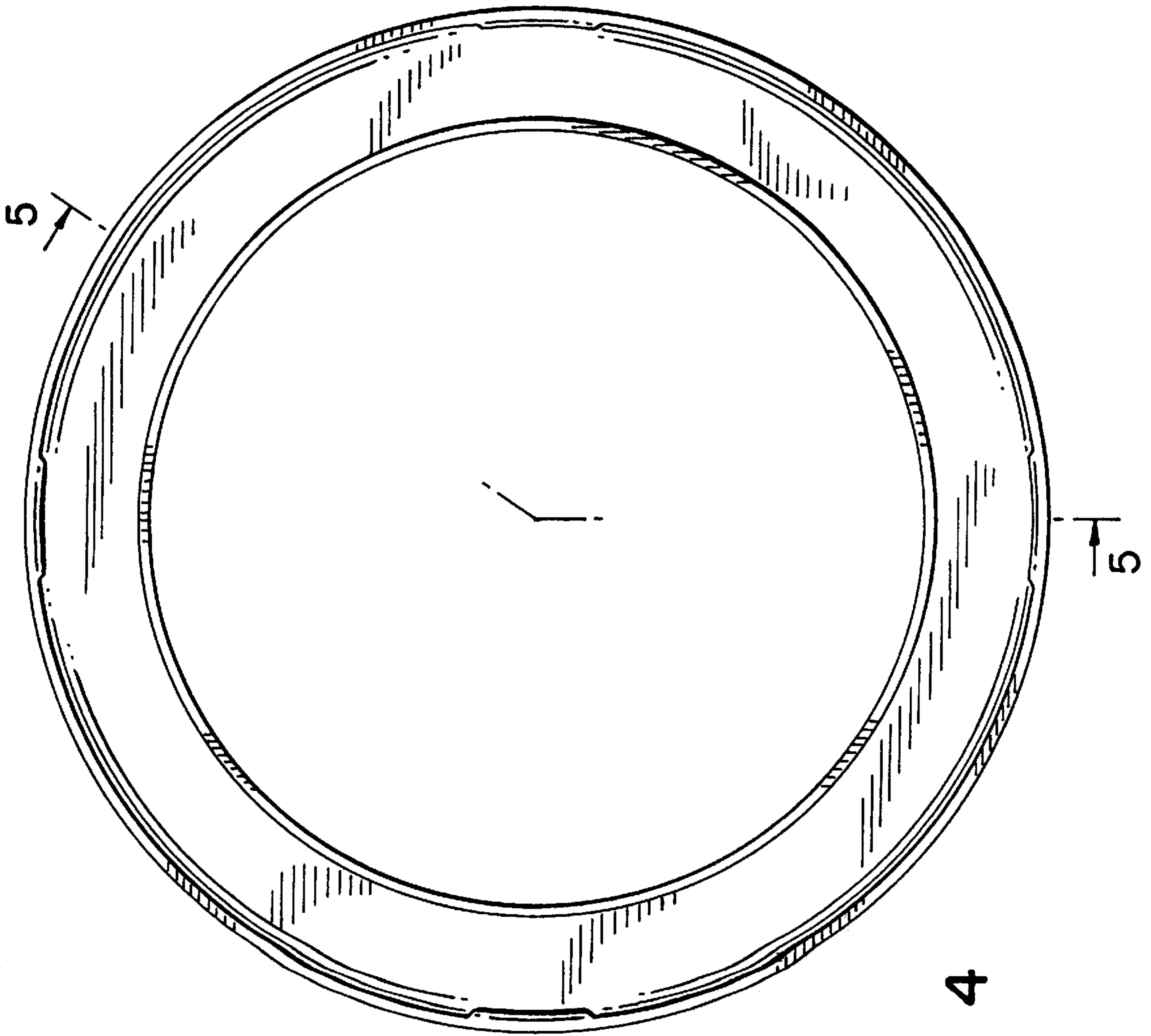

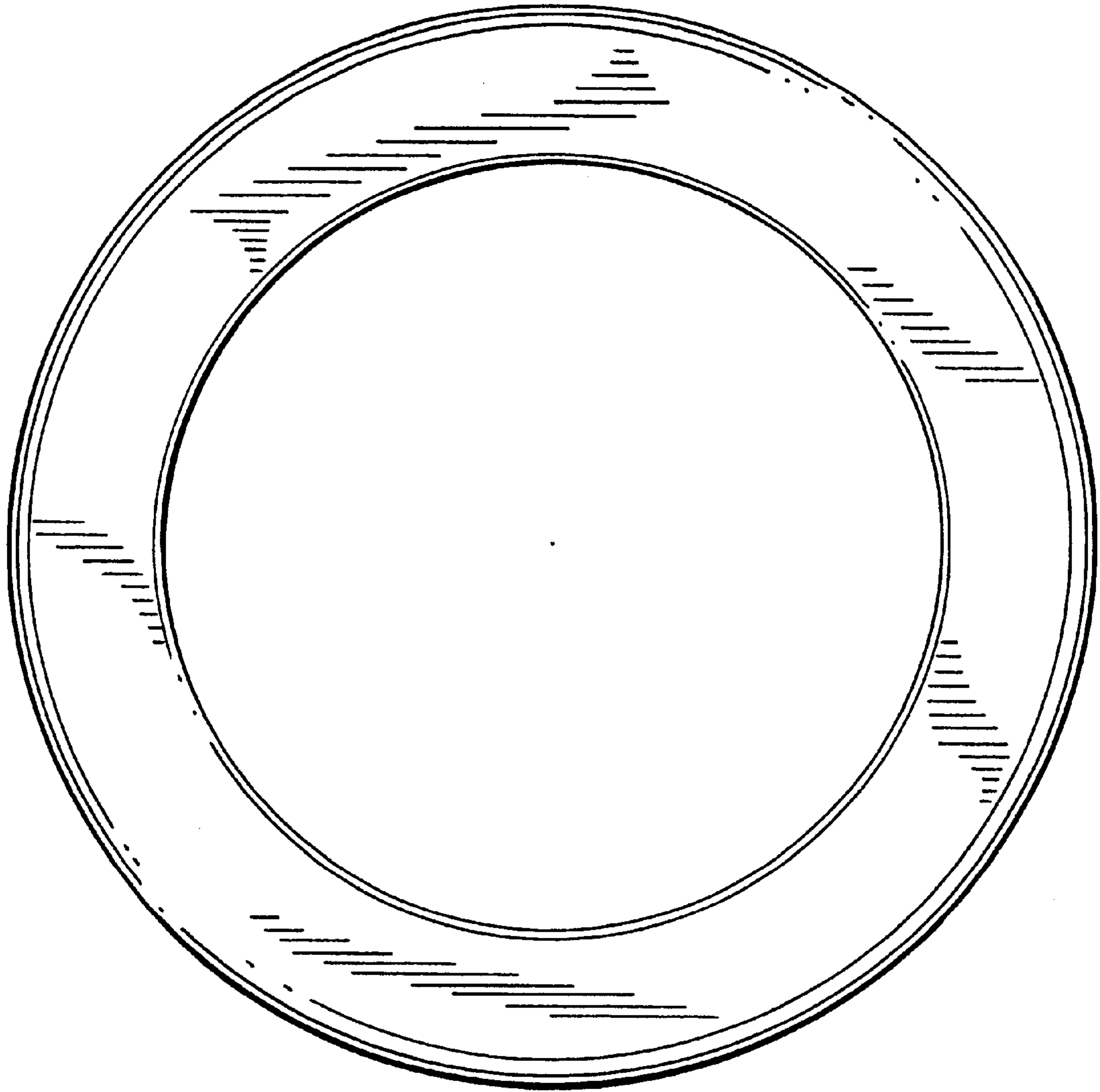

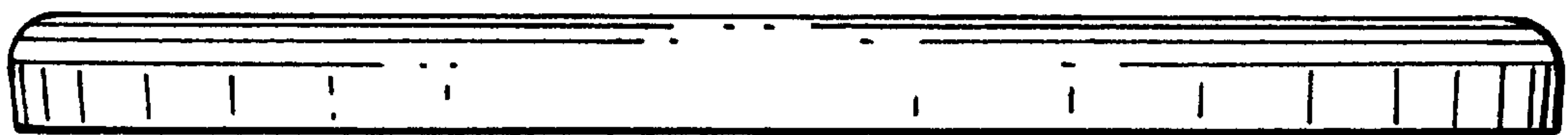

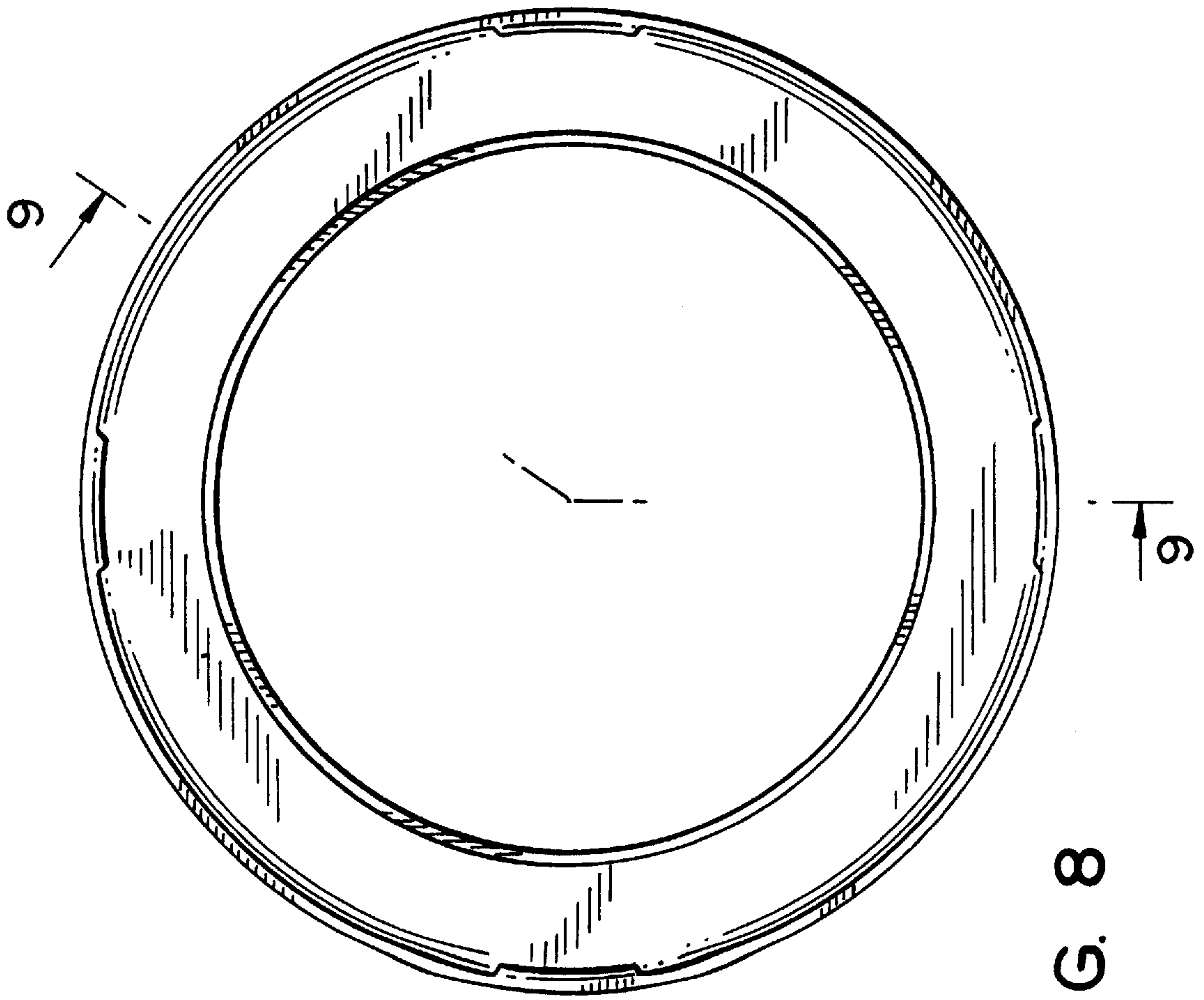

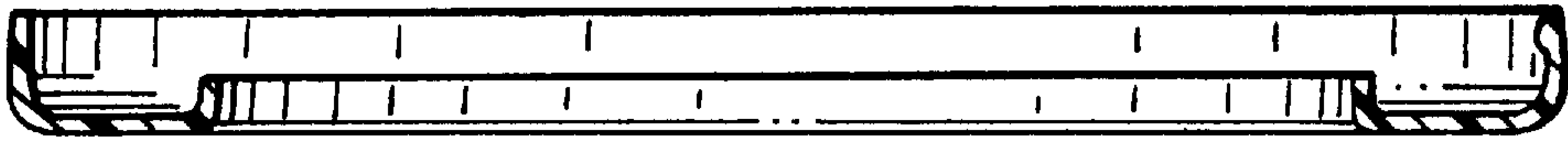

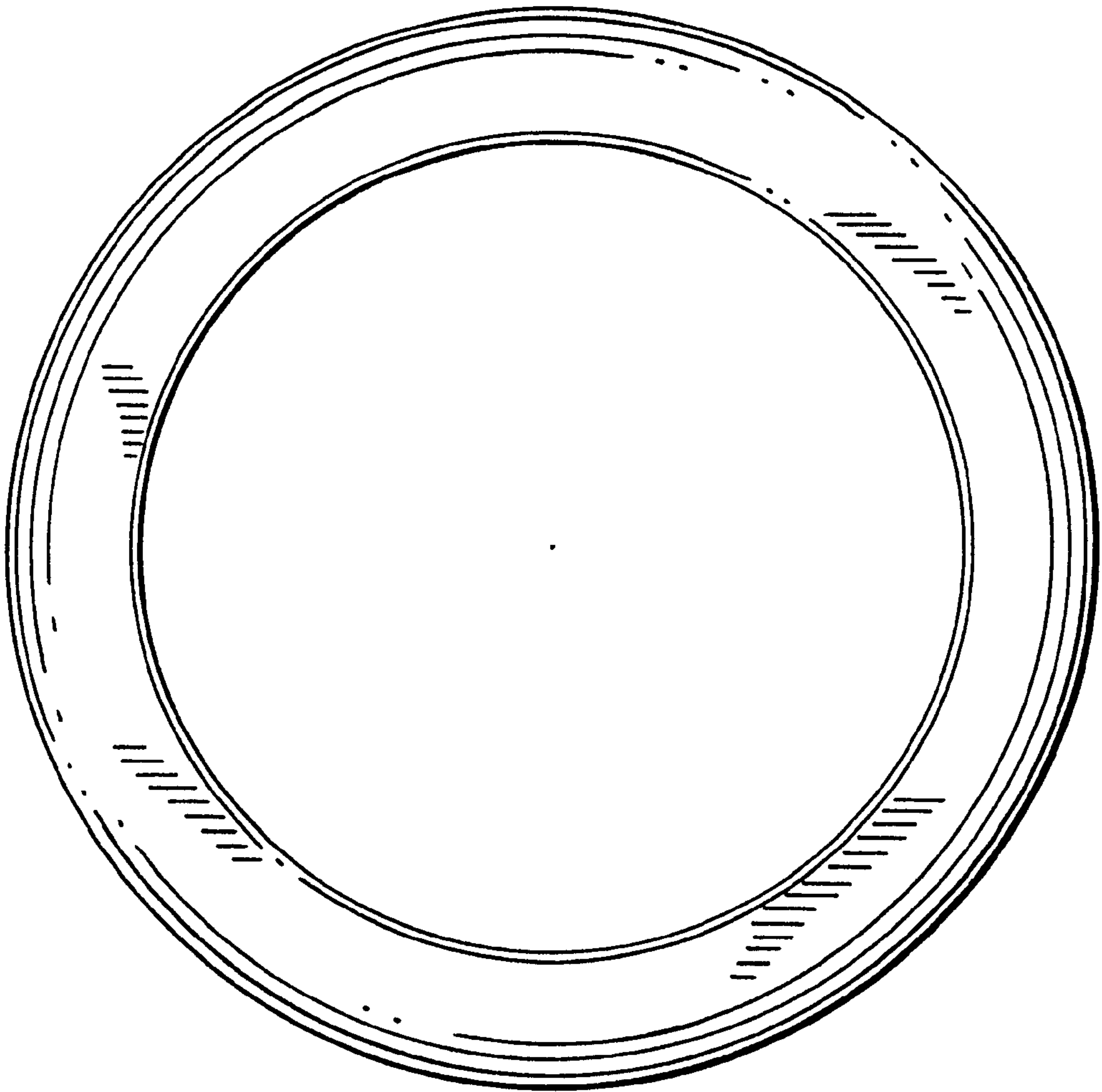

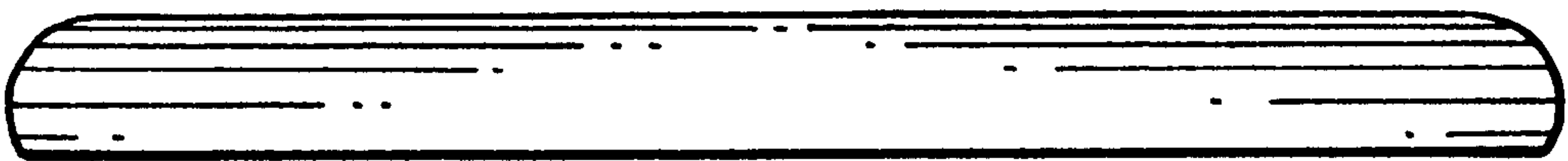

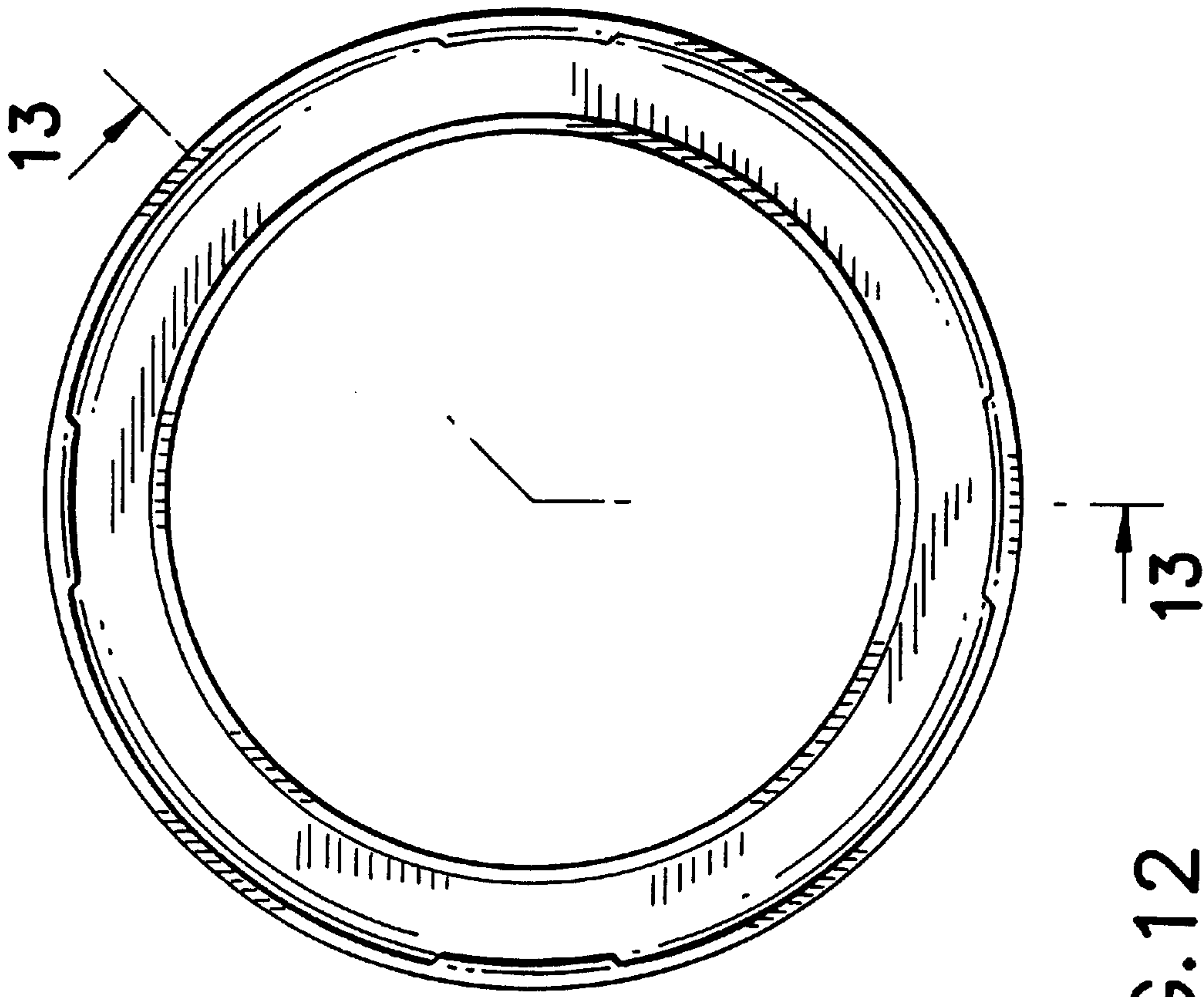

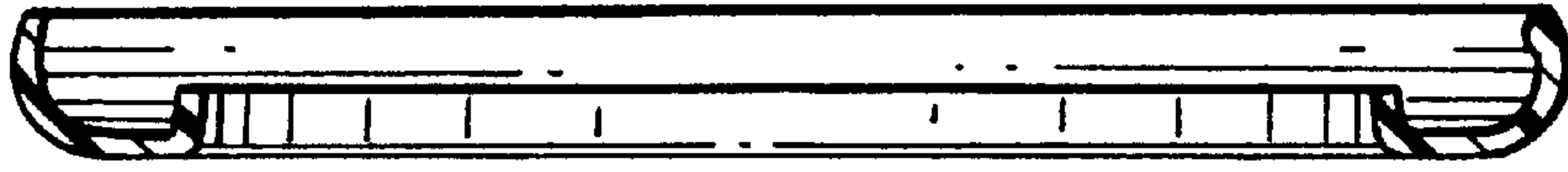
