### [57] CLAIM

The ornamental design for a multi-level cat scratching post, as shown and described.

### DESCRIPTION

FIG. 1 is a front perspective view of a multi-level cat scratching post showing our new design; FIG. 2 is an elevational view of a first side thereof, the elevational views of the other three sides being substantially identical that appearing in FIG. 2; FIG. 3 is a top plan view thereof; and, FIG. 4 is a bottom plan thereof.

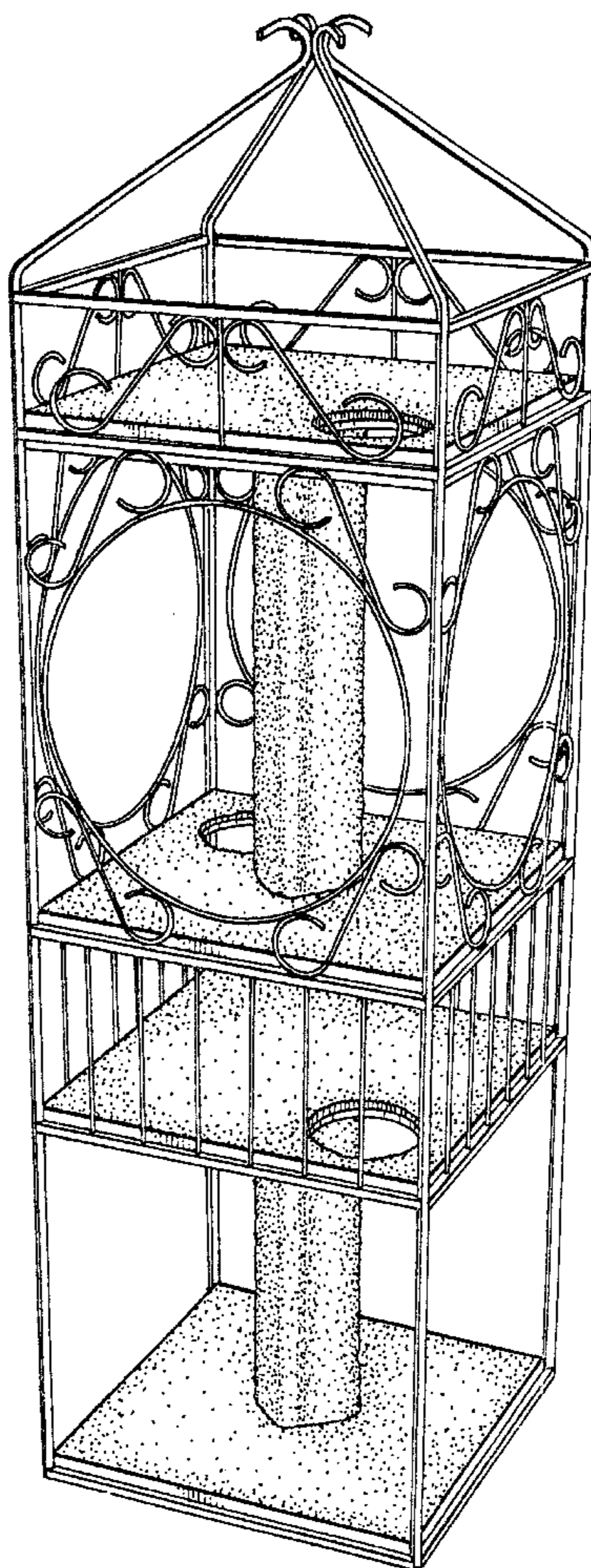

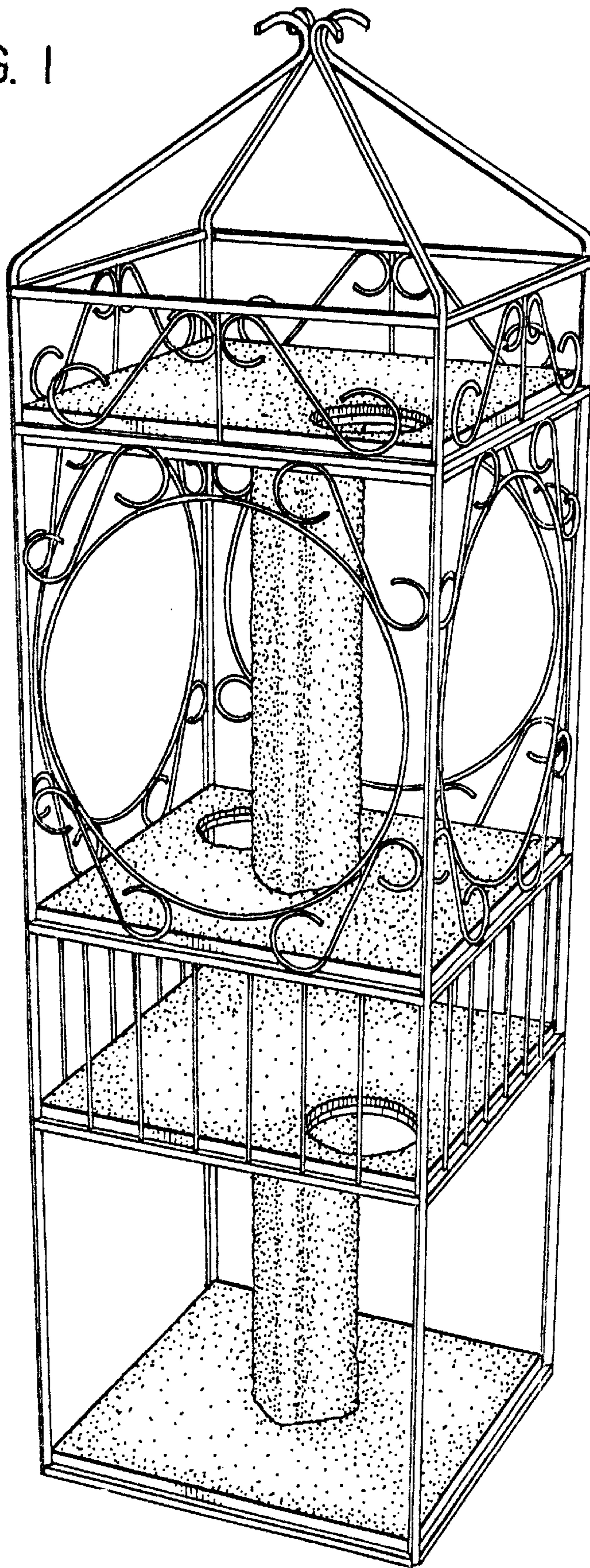

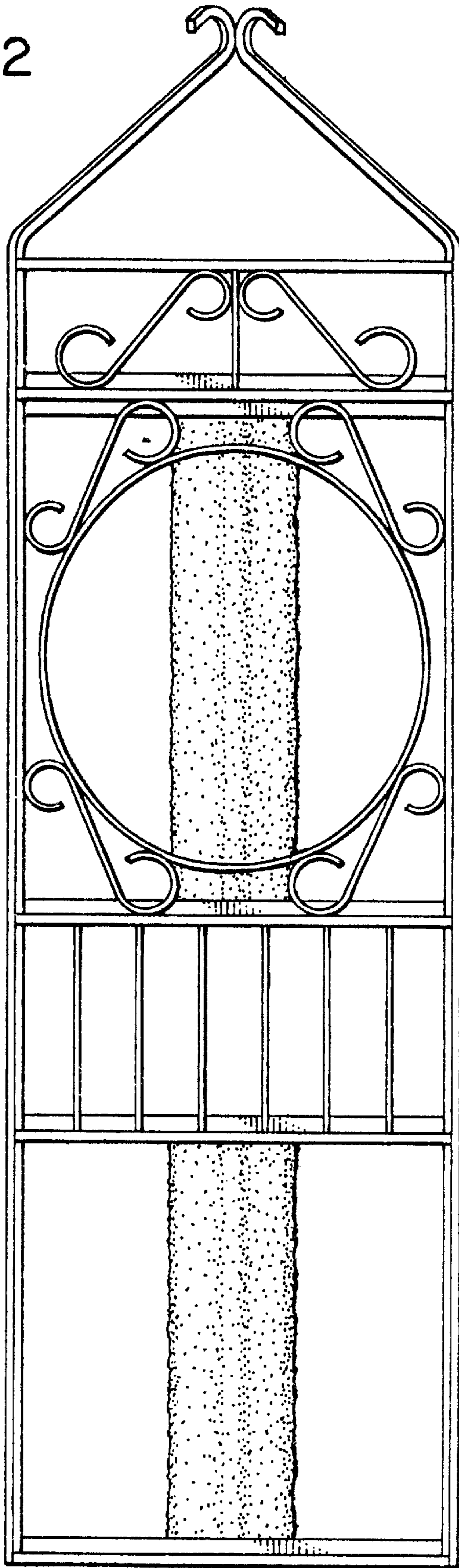

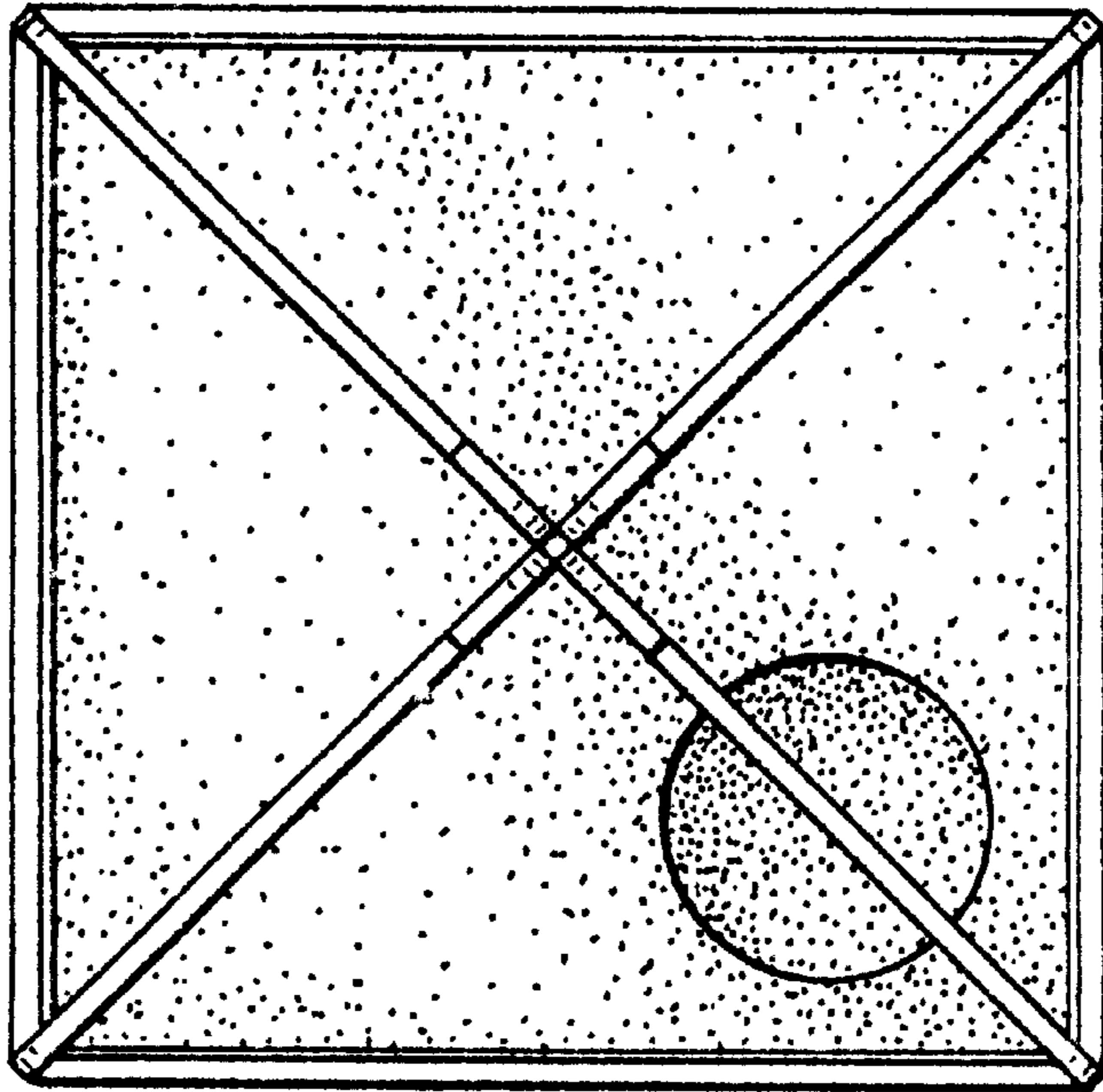
