FIG. 13 is a top planar view thereof; and,

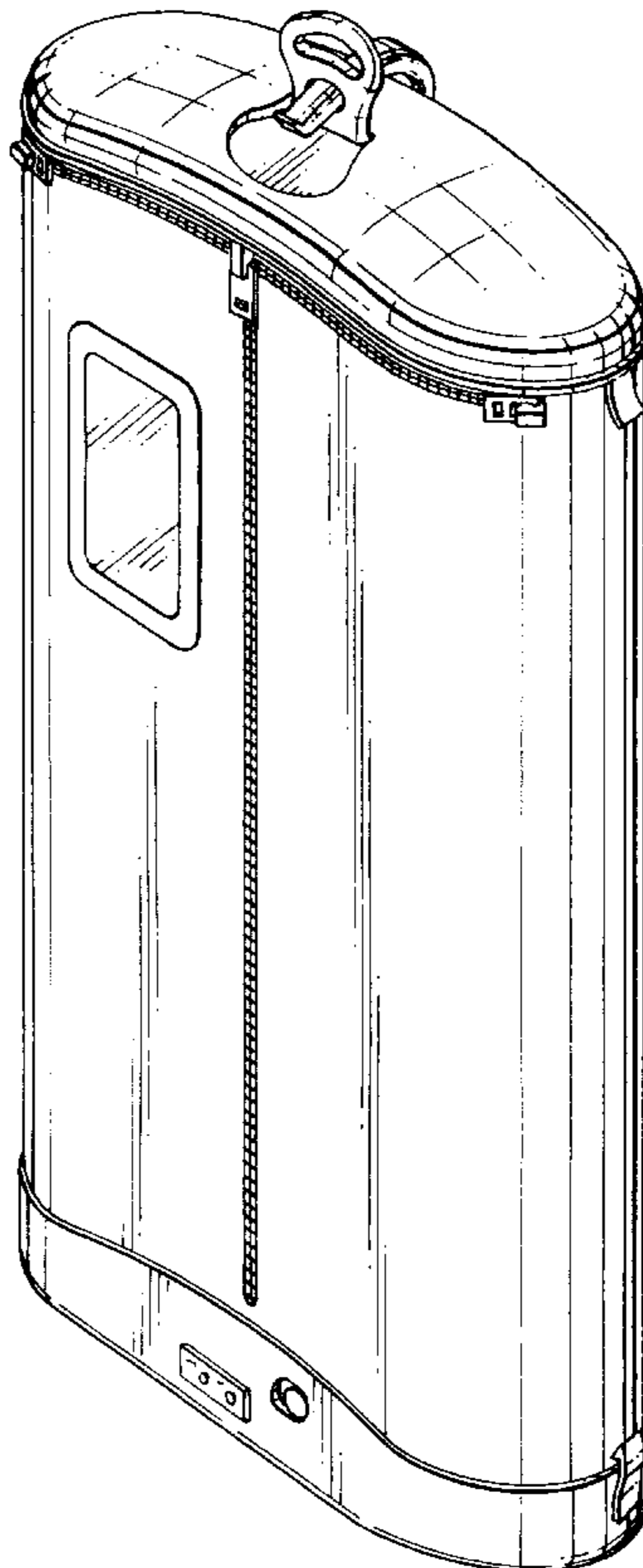
FIG. 14 is a bottom planar view thereof.

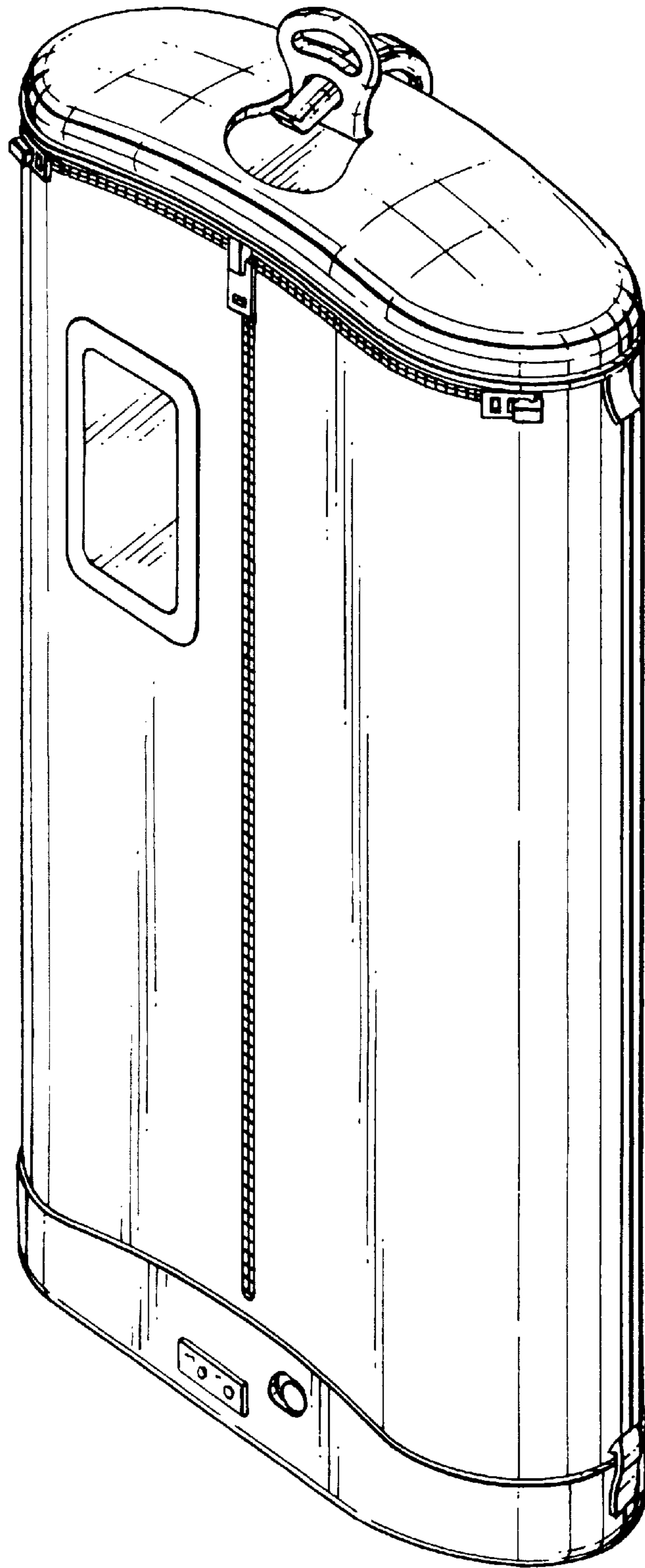

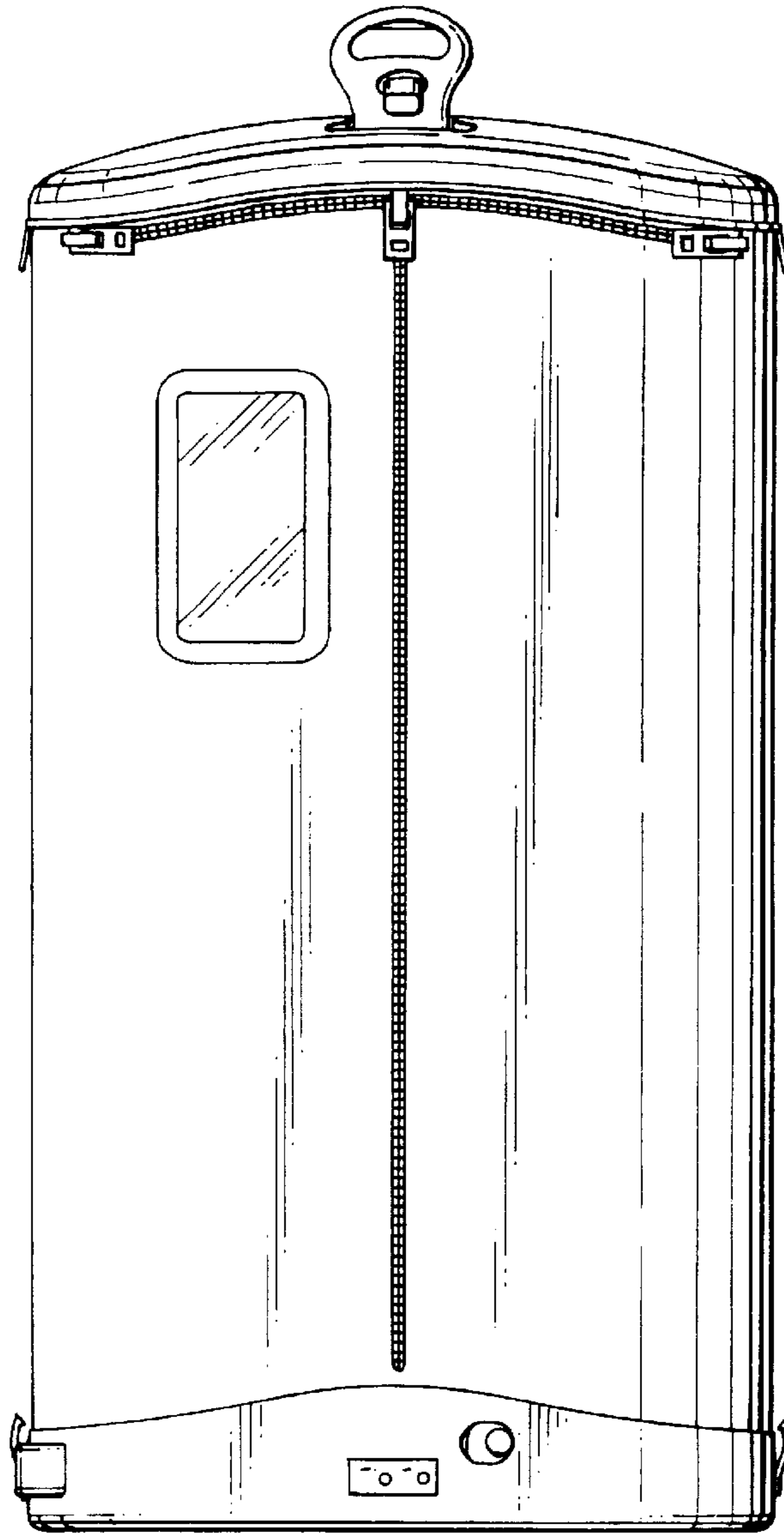

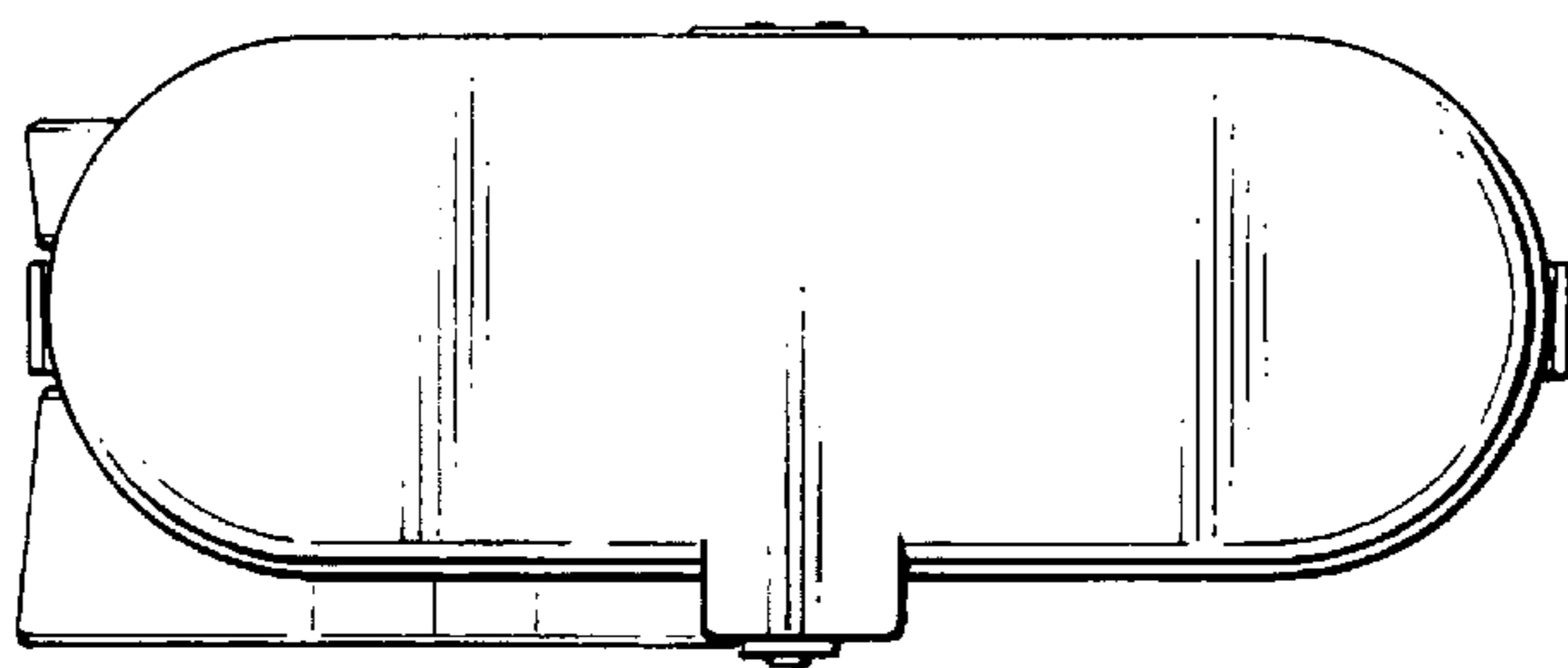

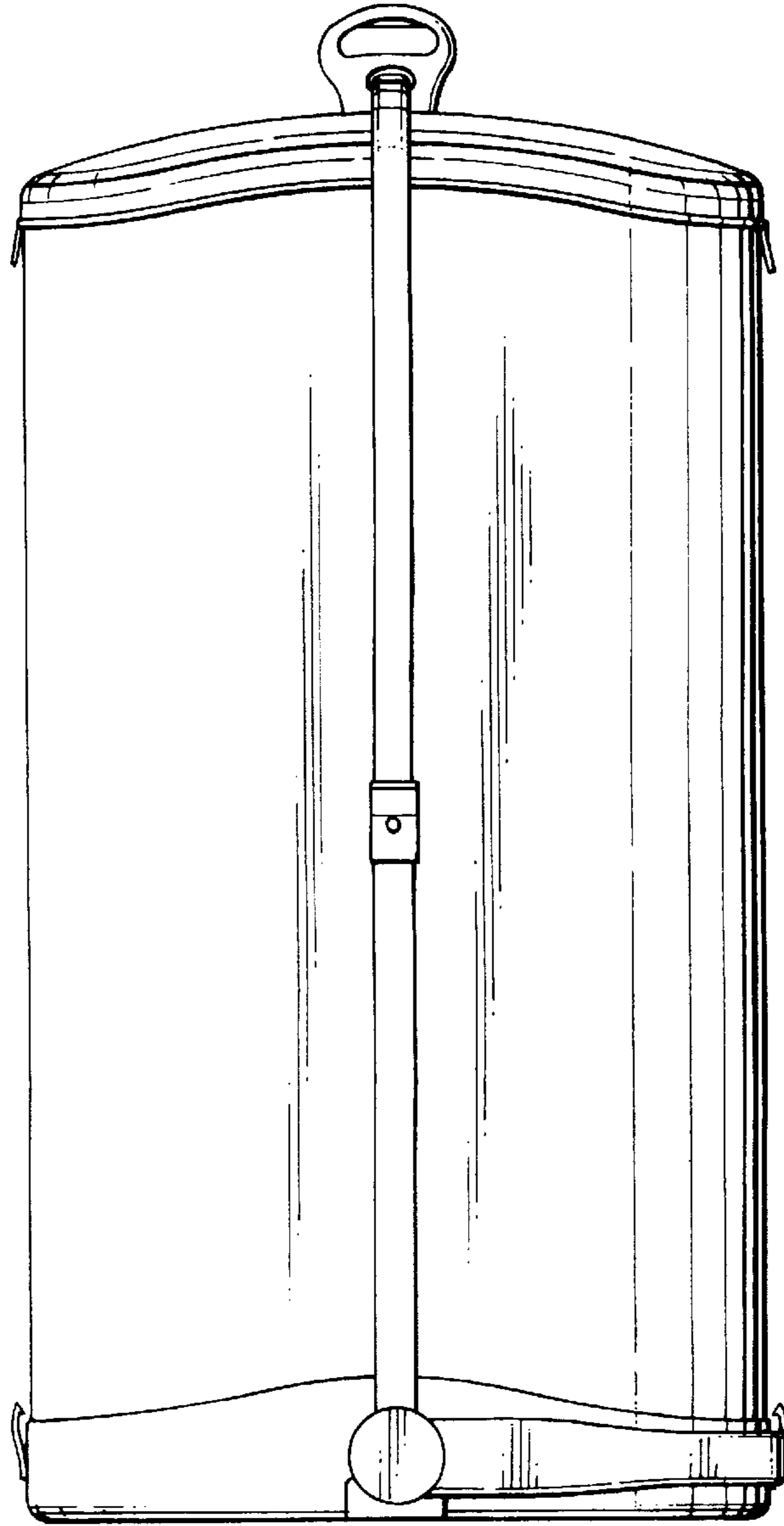

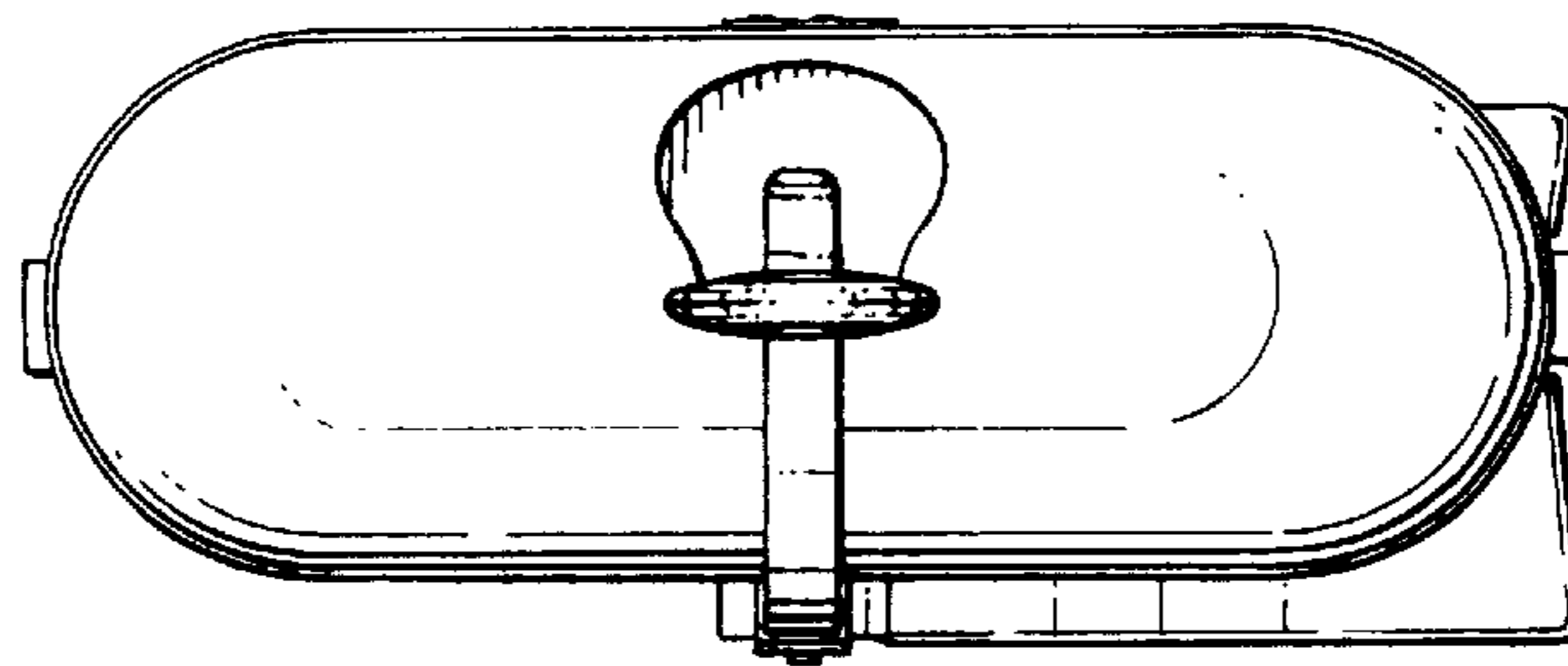

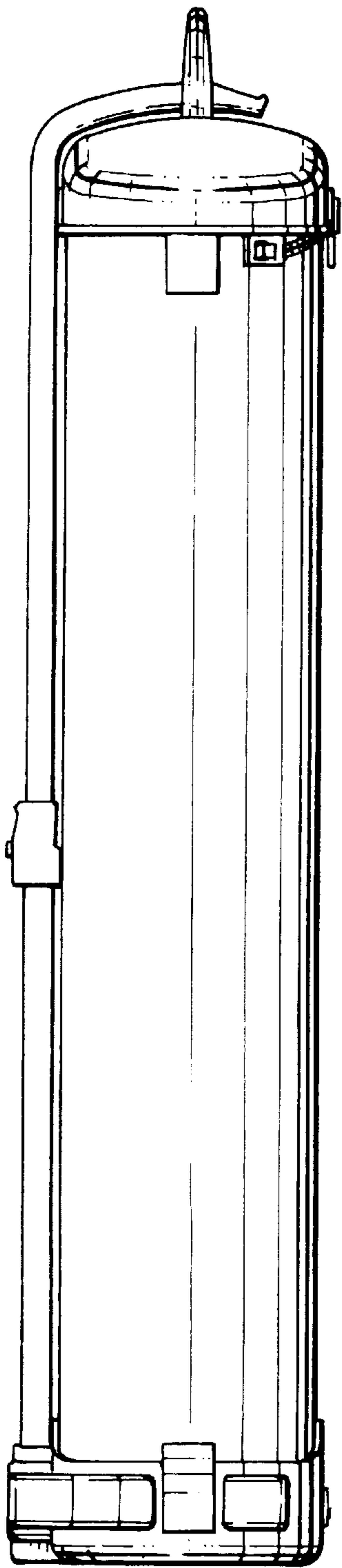

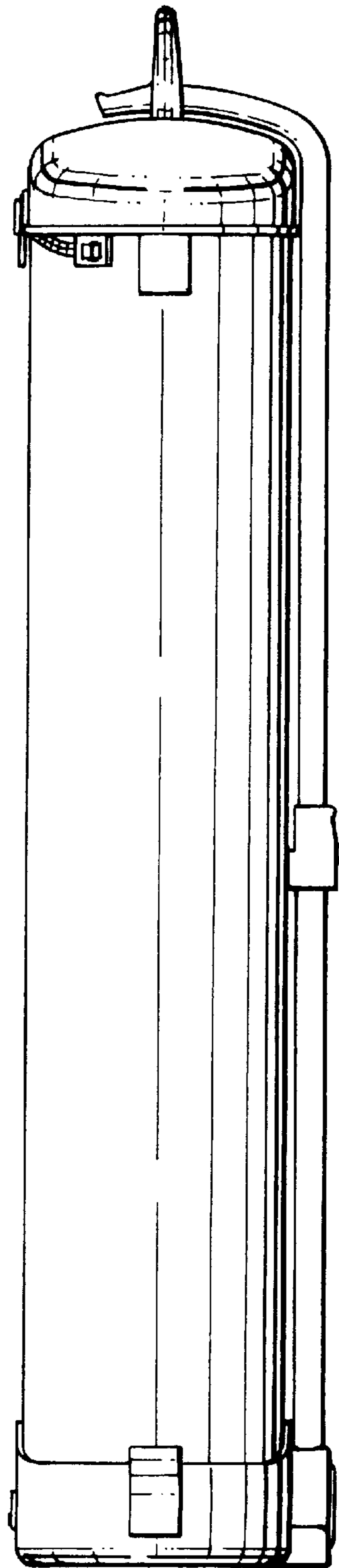

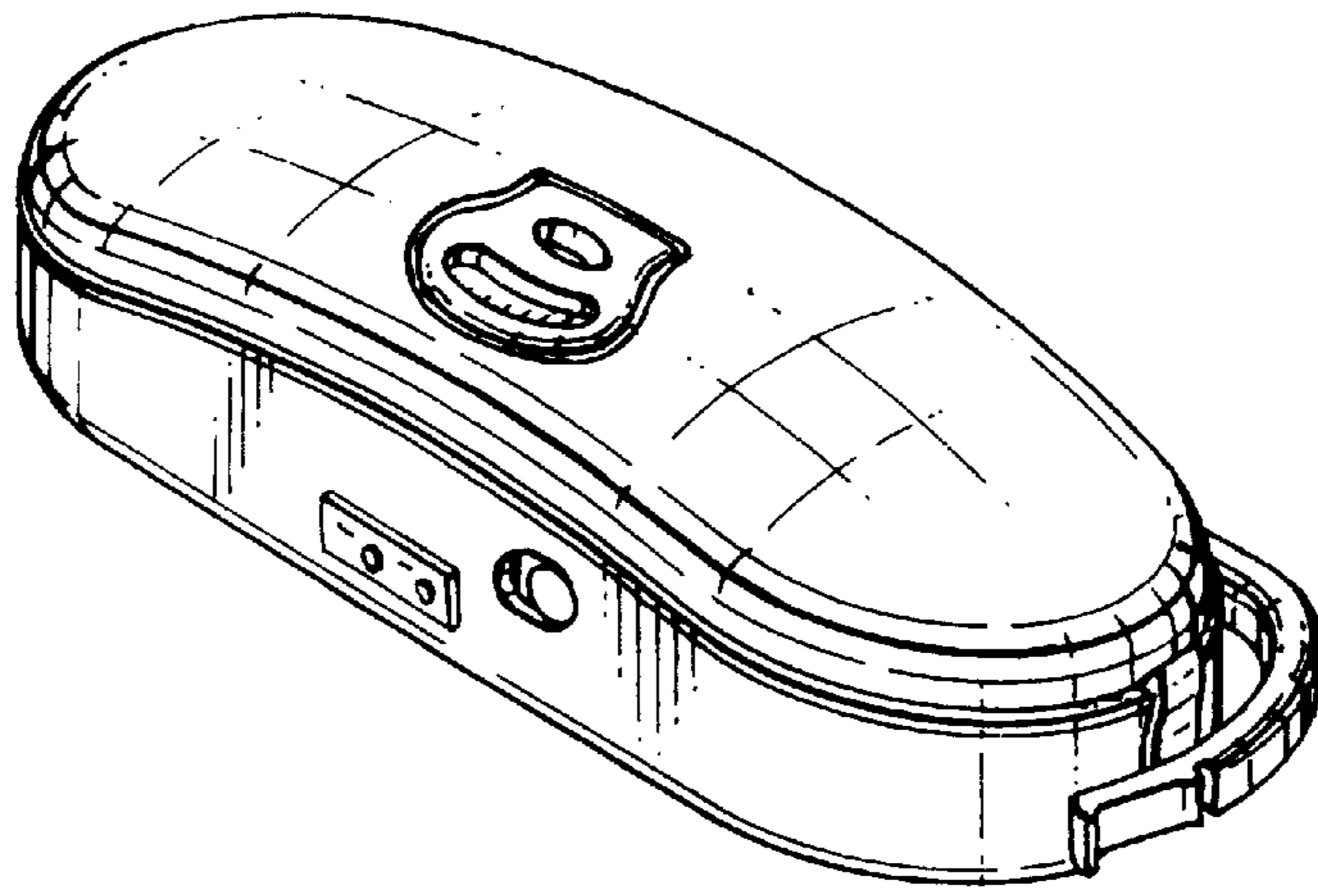

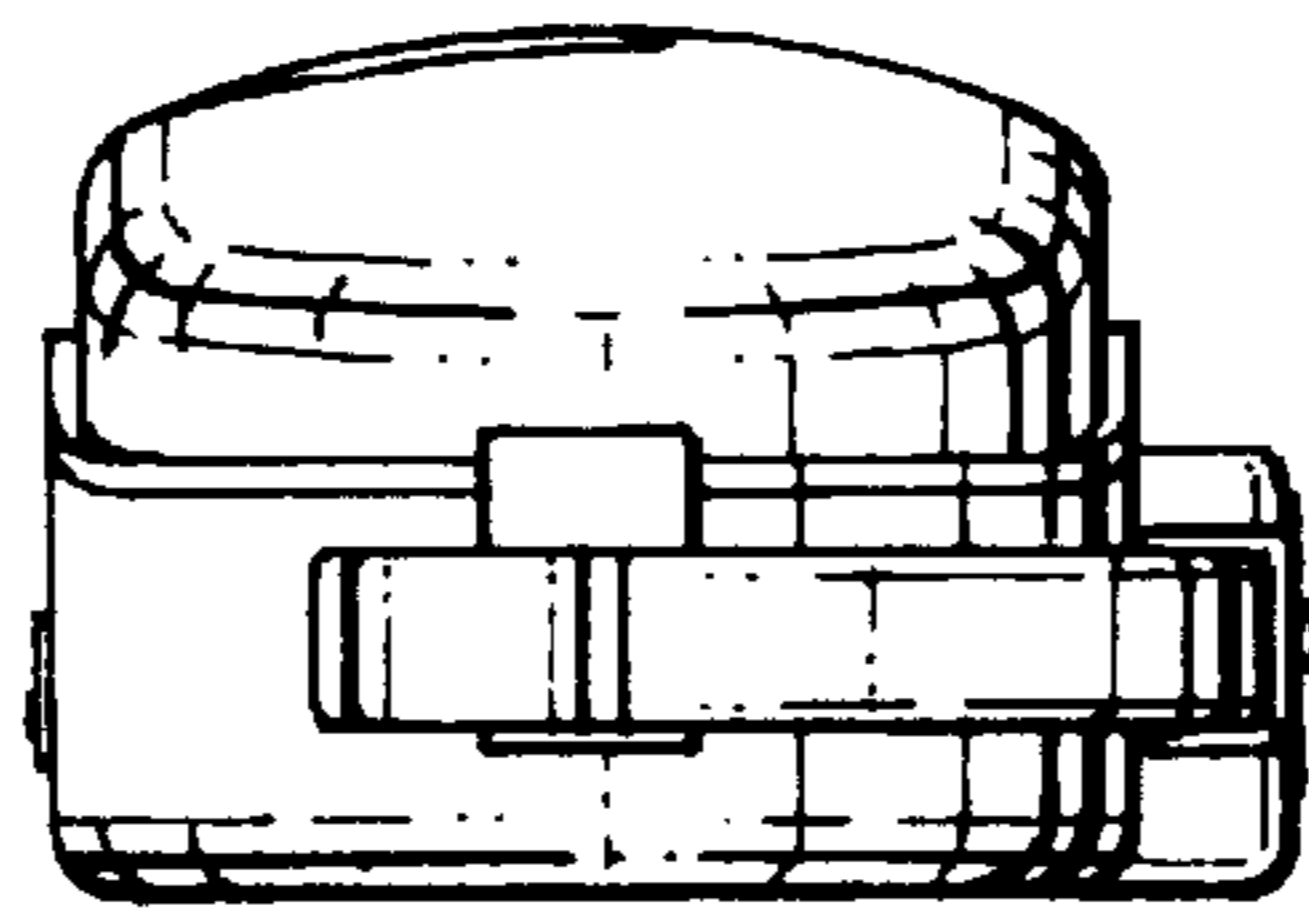

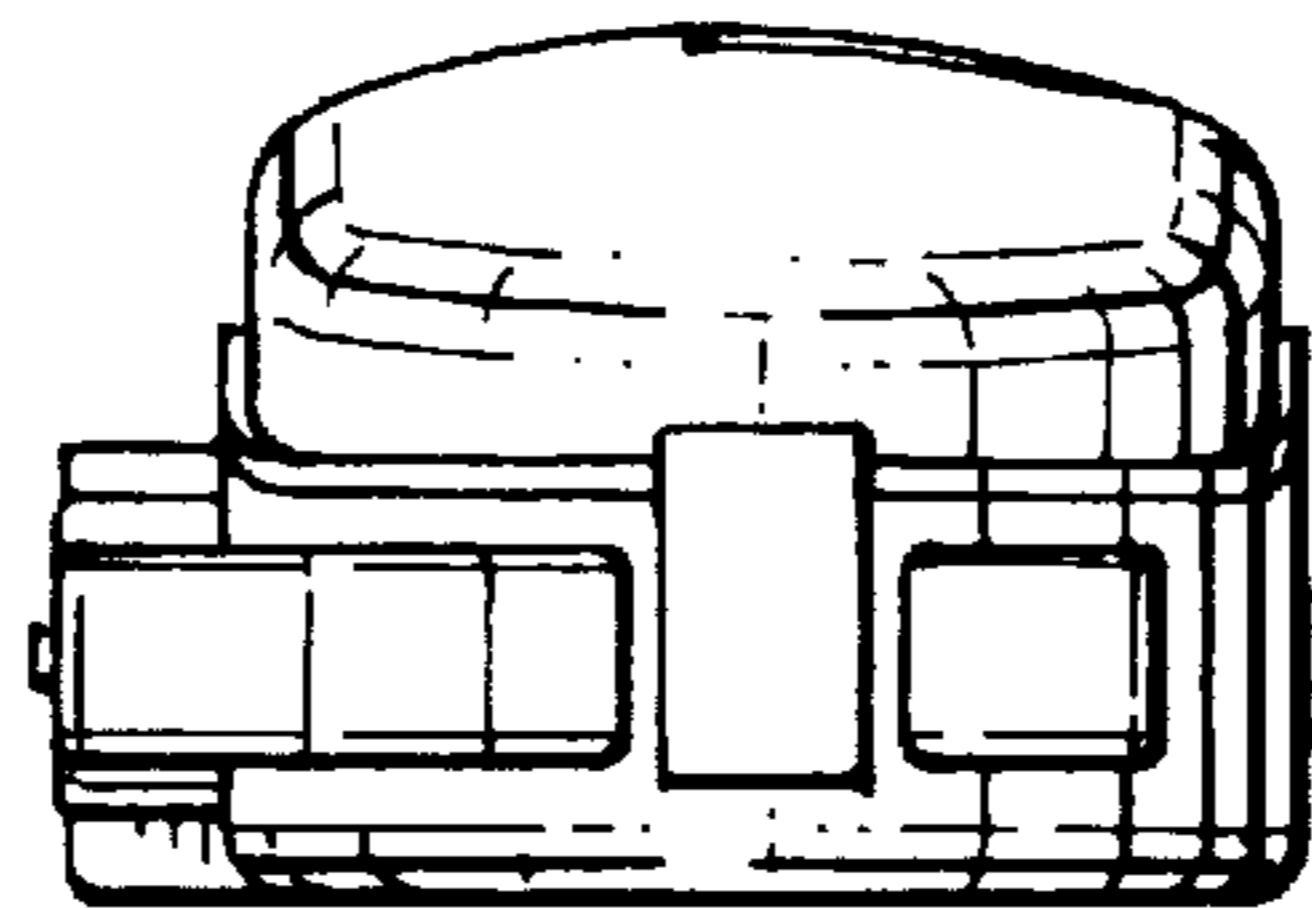

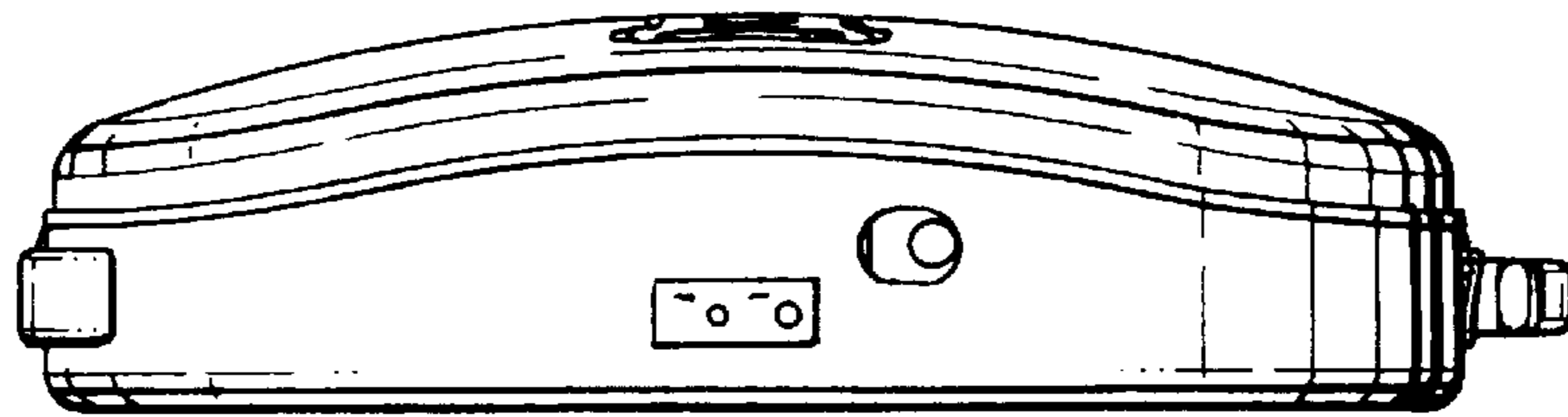

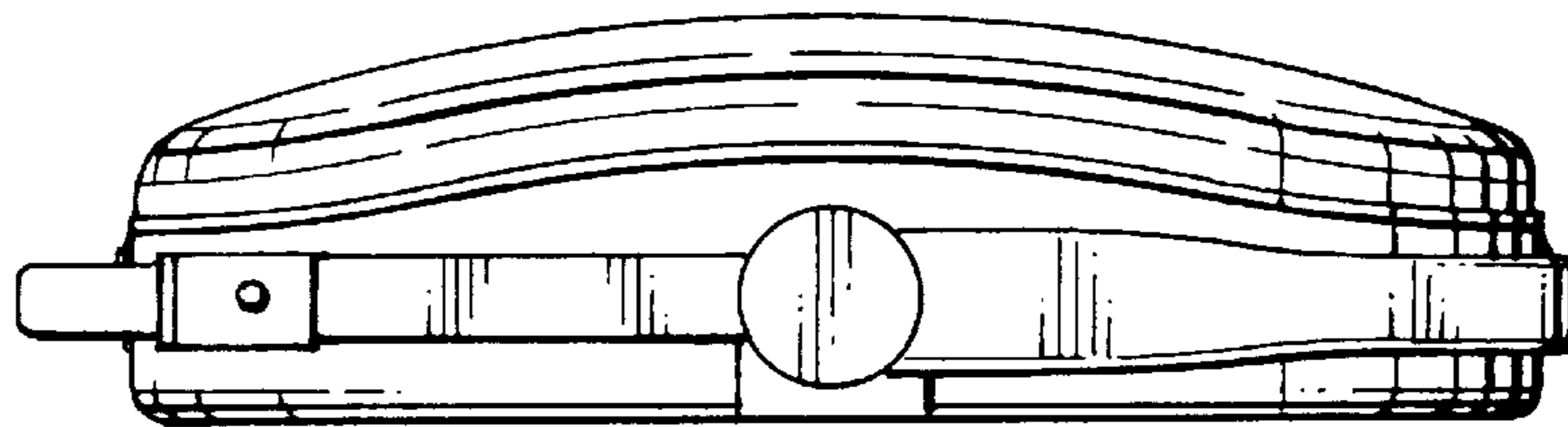

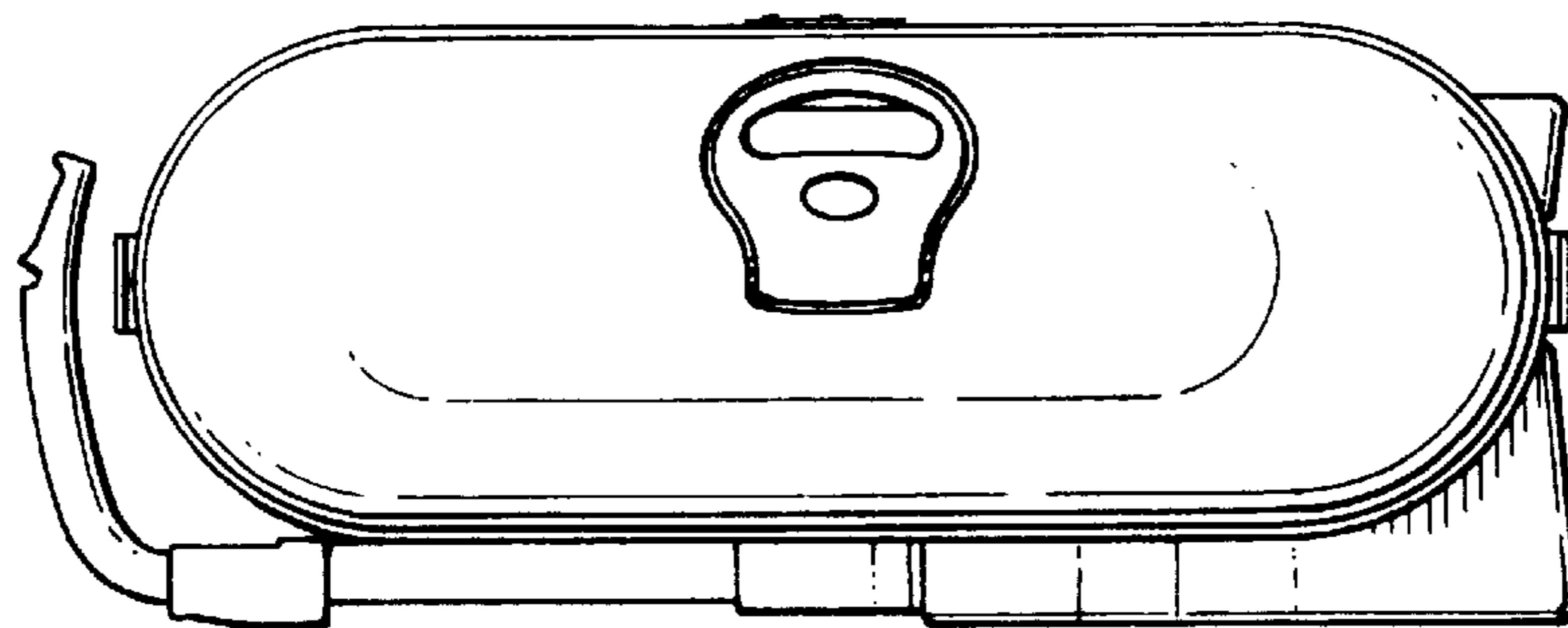

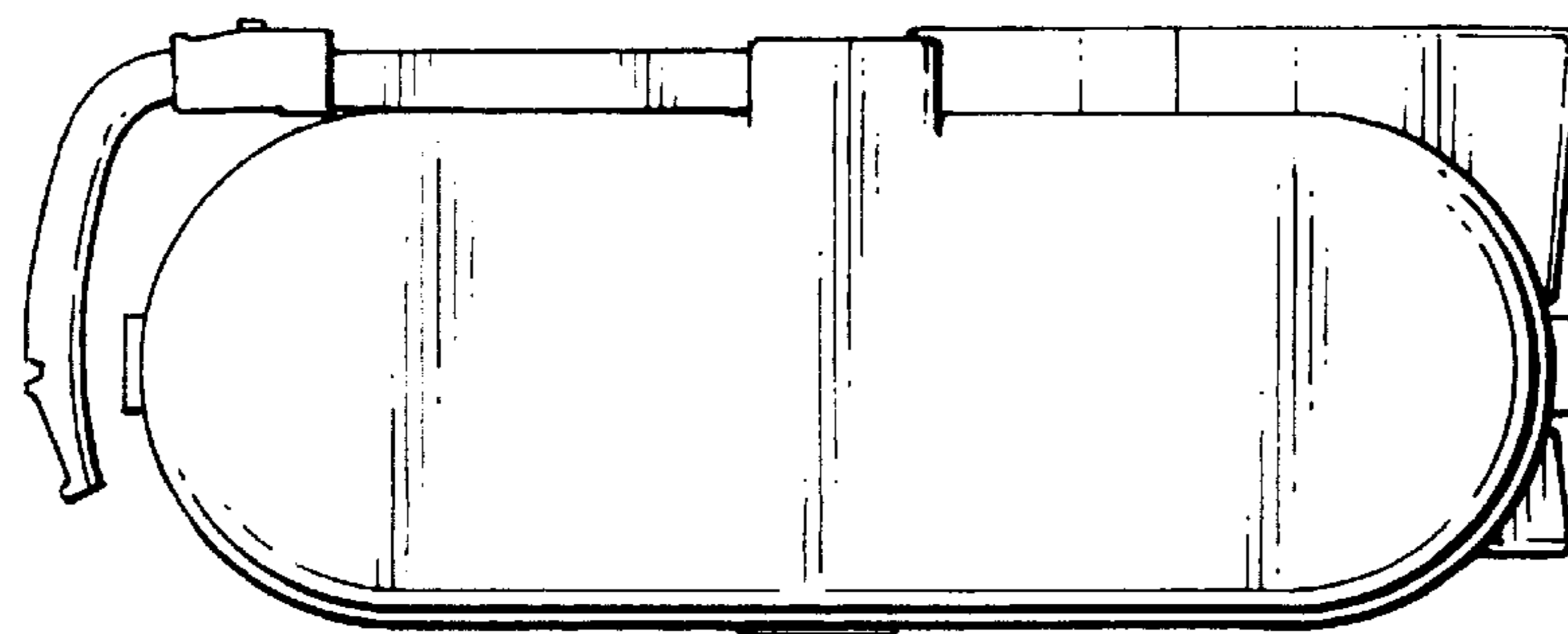
