DESCRIPTION

FIG. 8 is a right side view in elevation of FIG. 7;

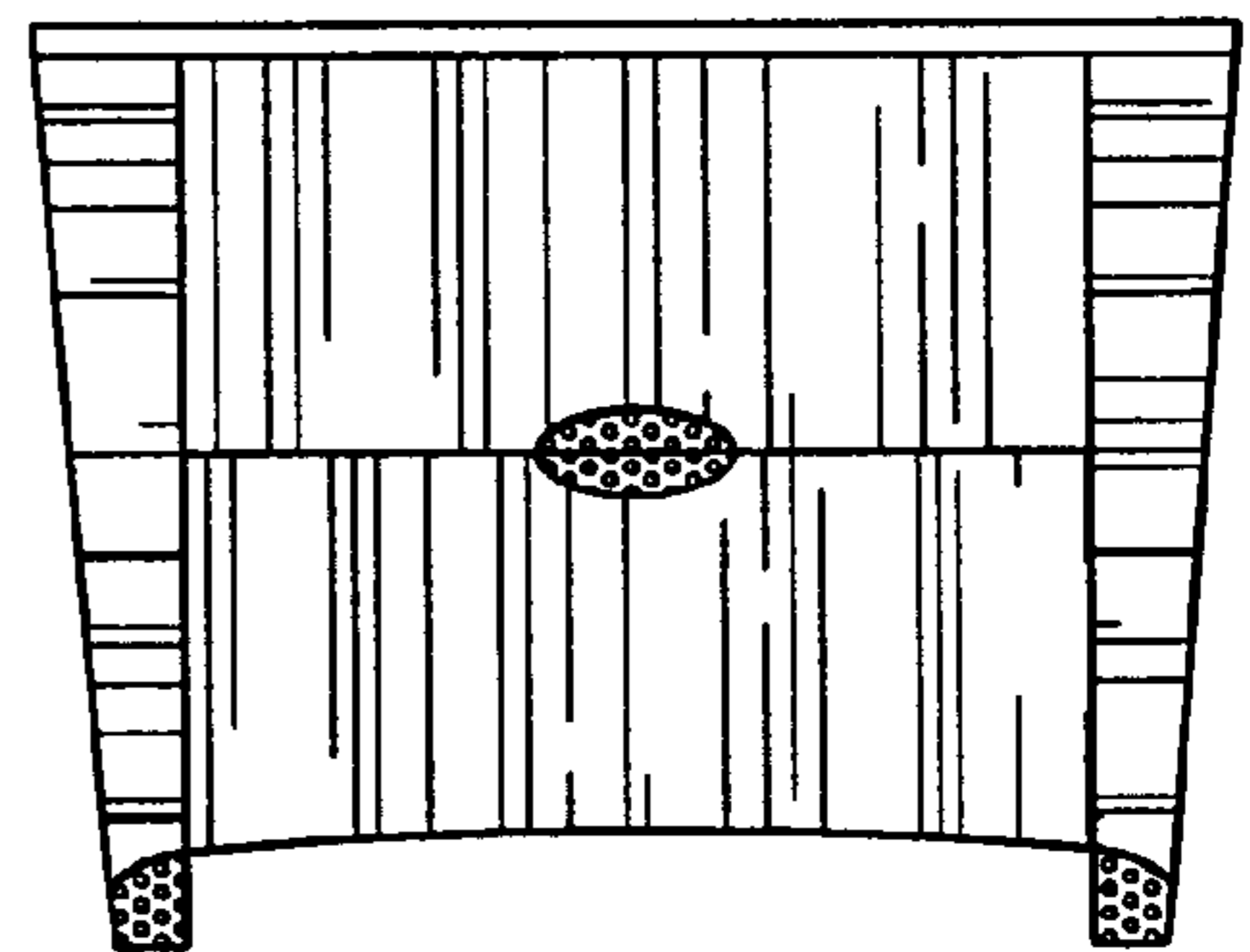
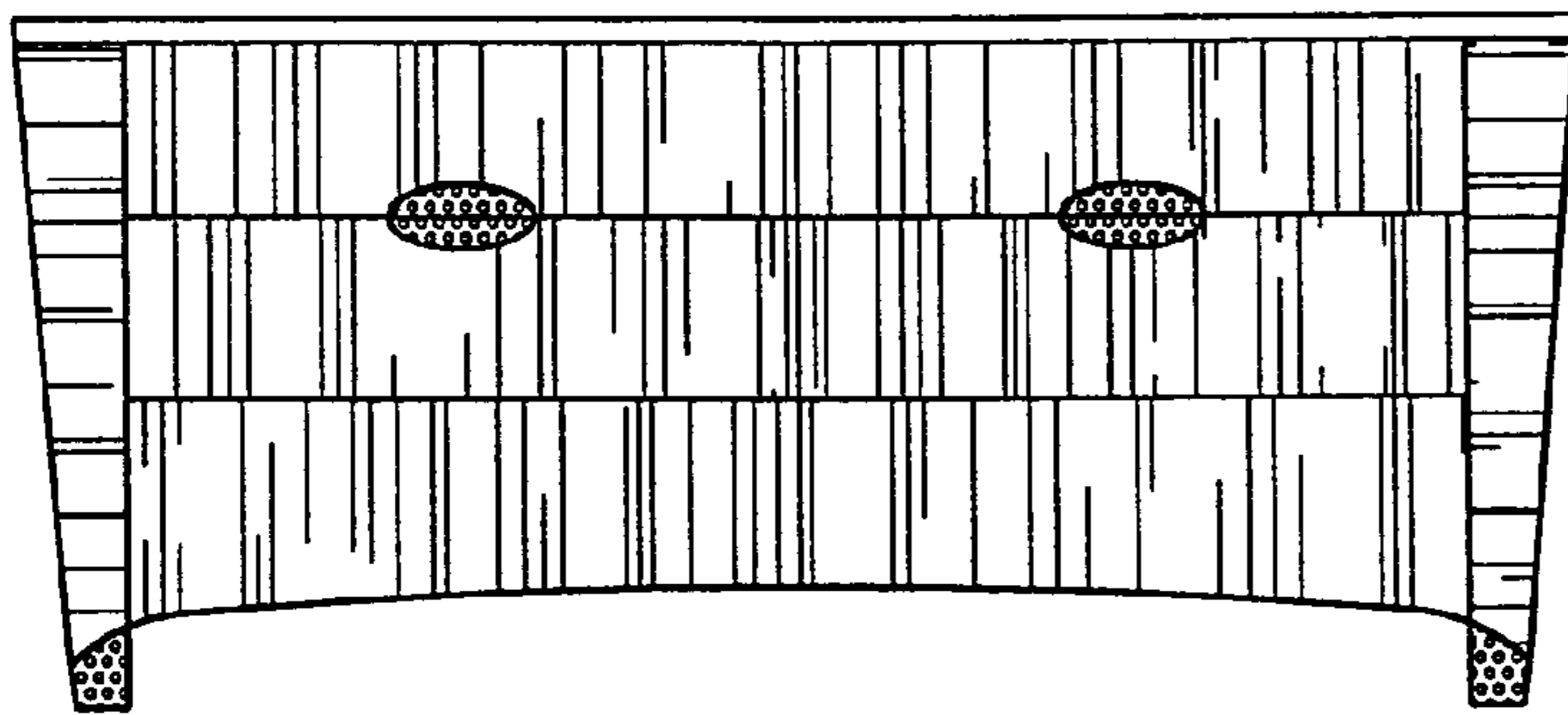
FIG. 9 is a rear view in elevation of FIG. 7;

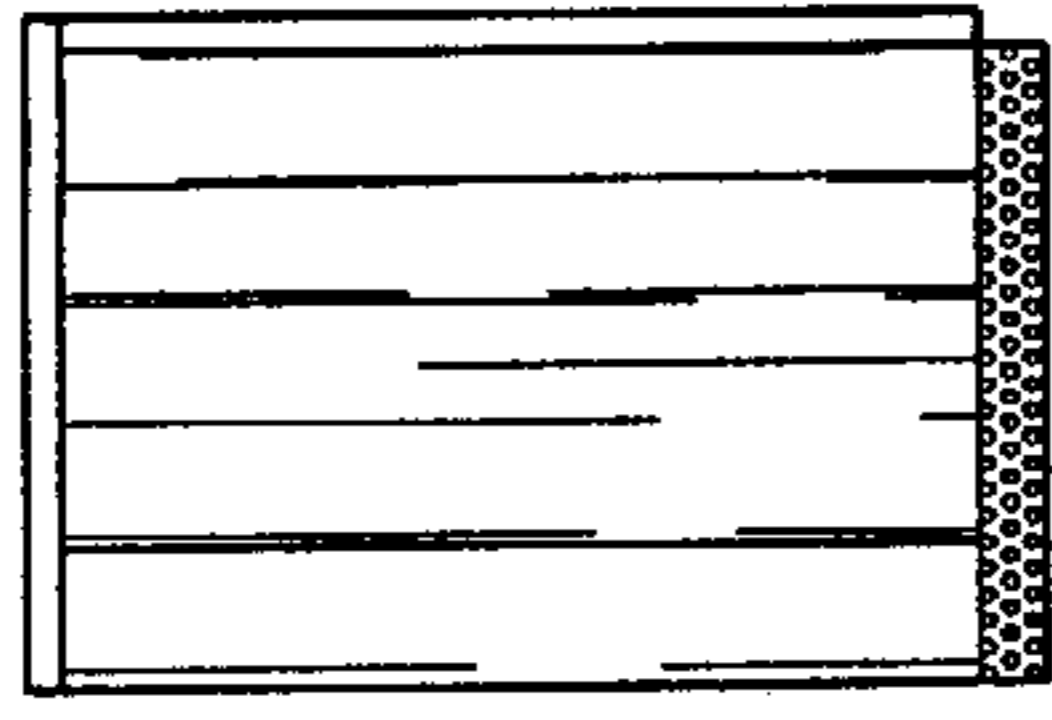

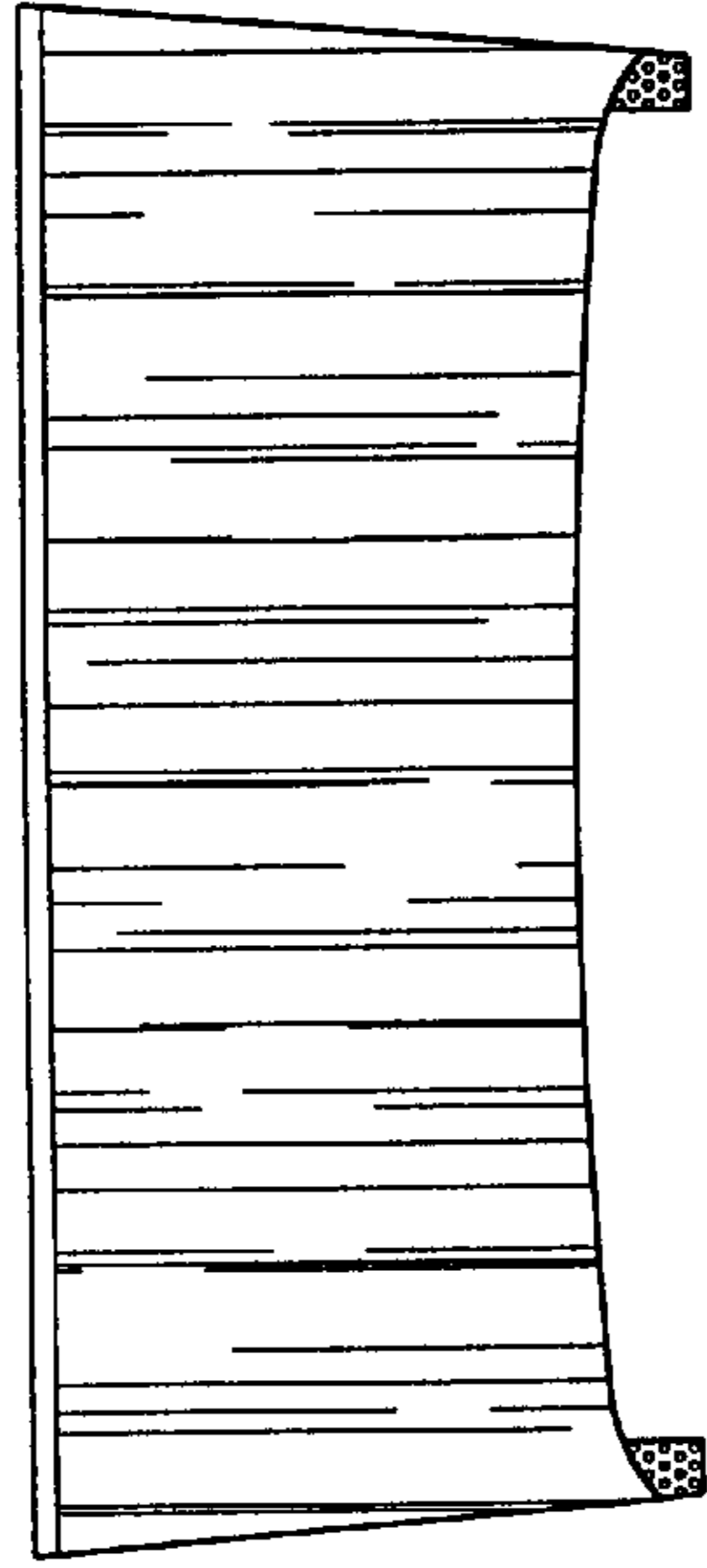

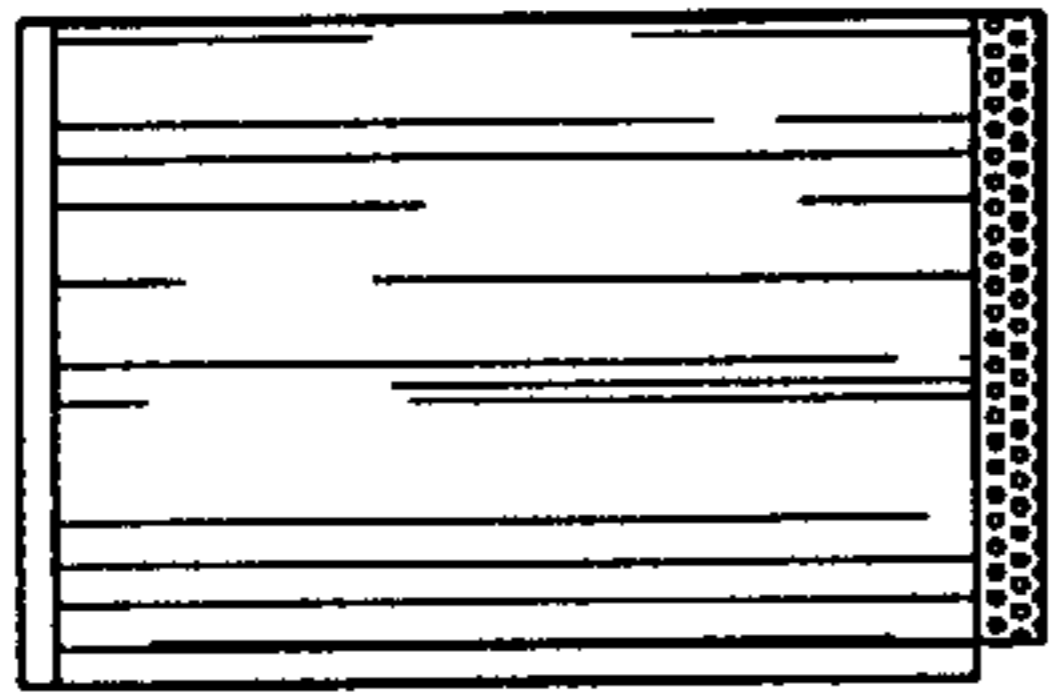

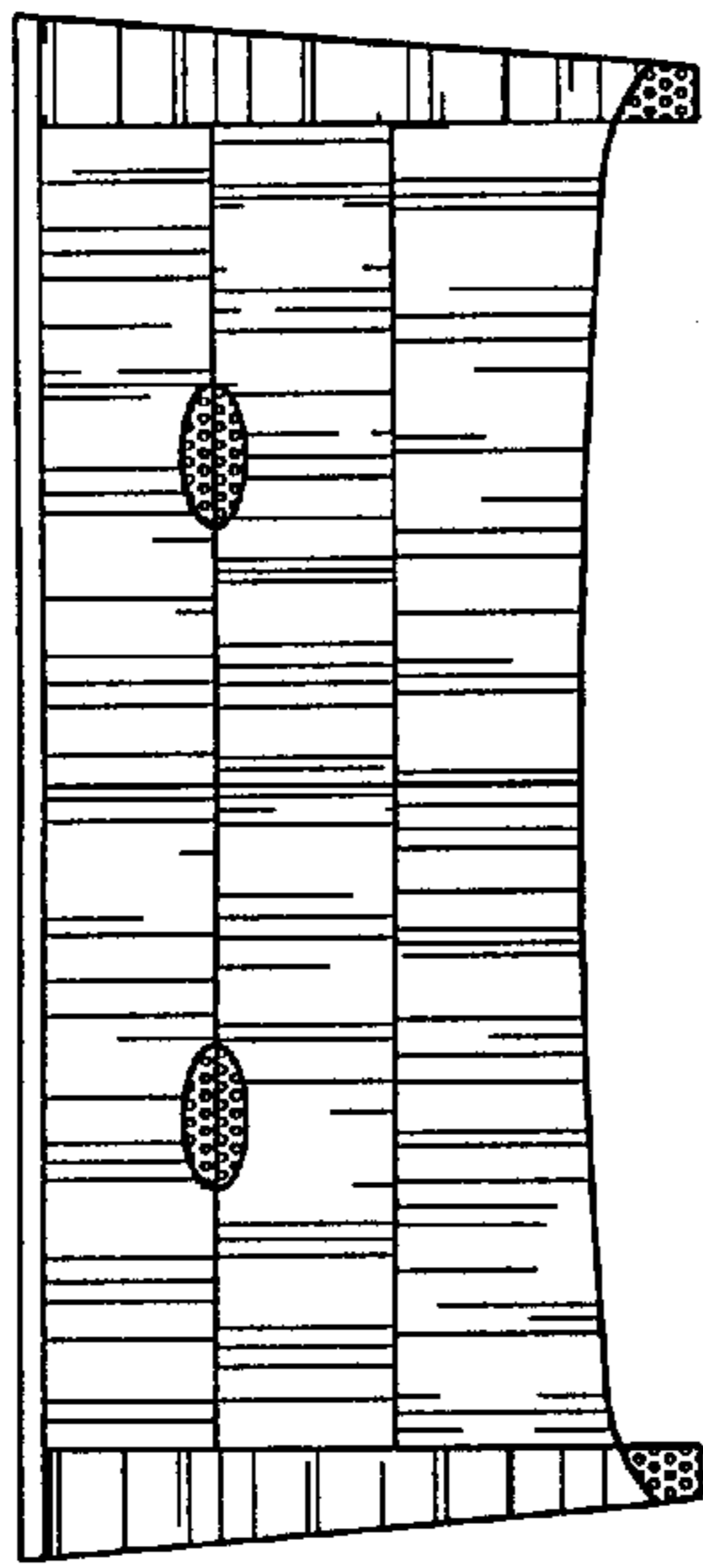

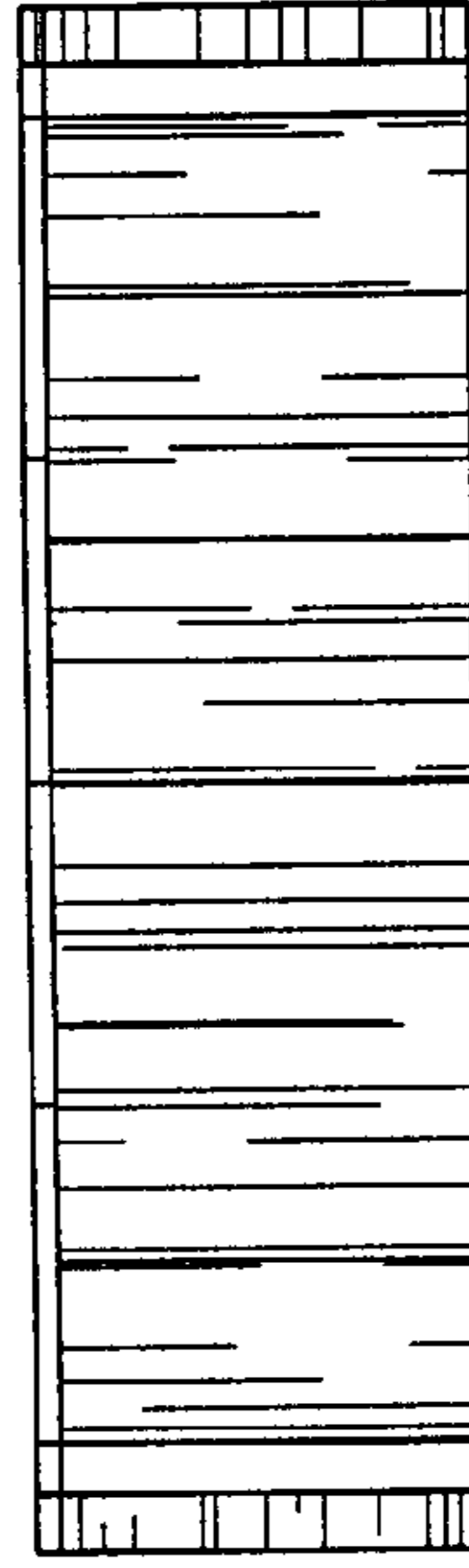

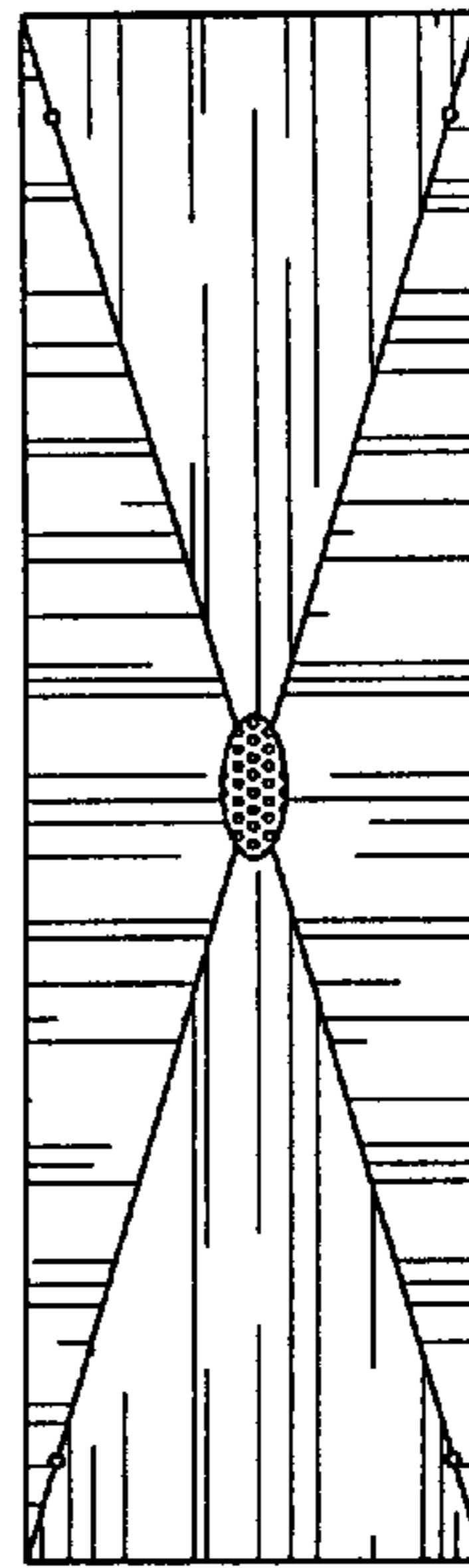

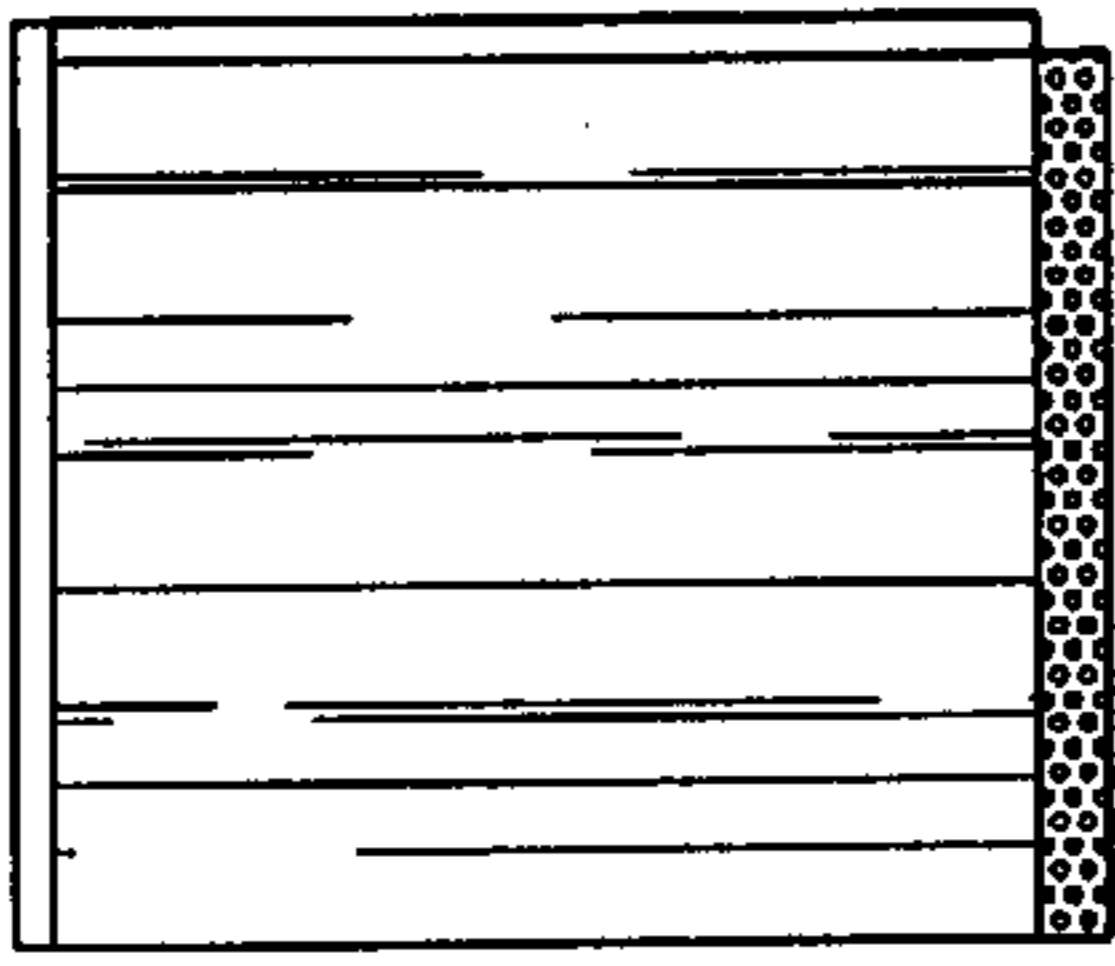

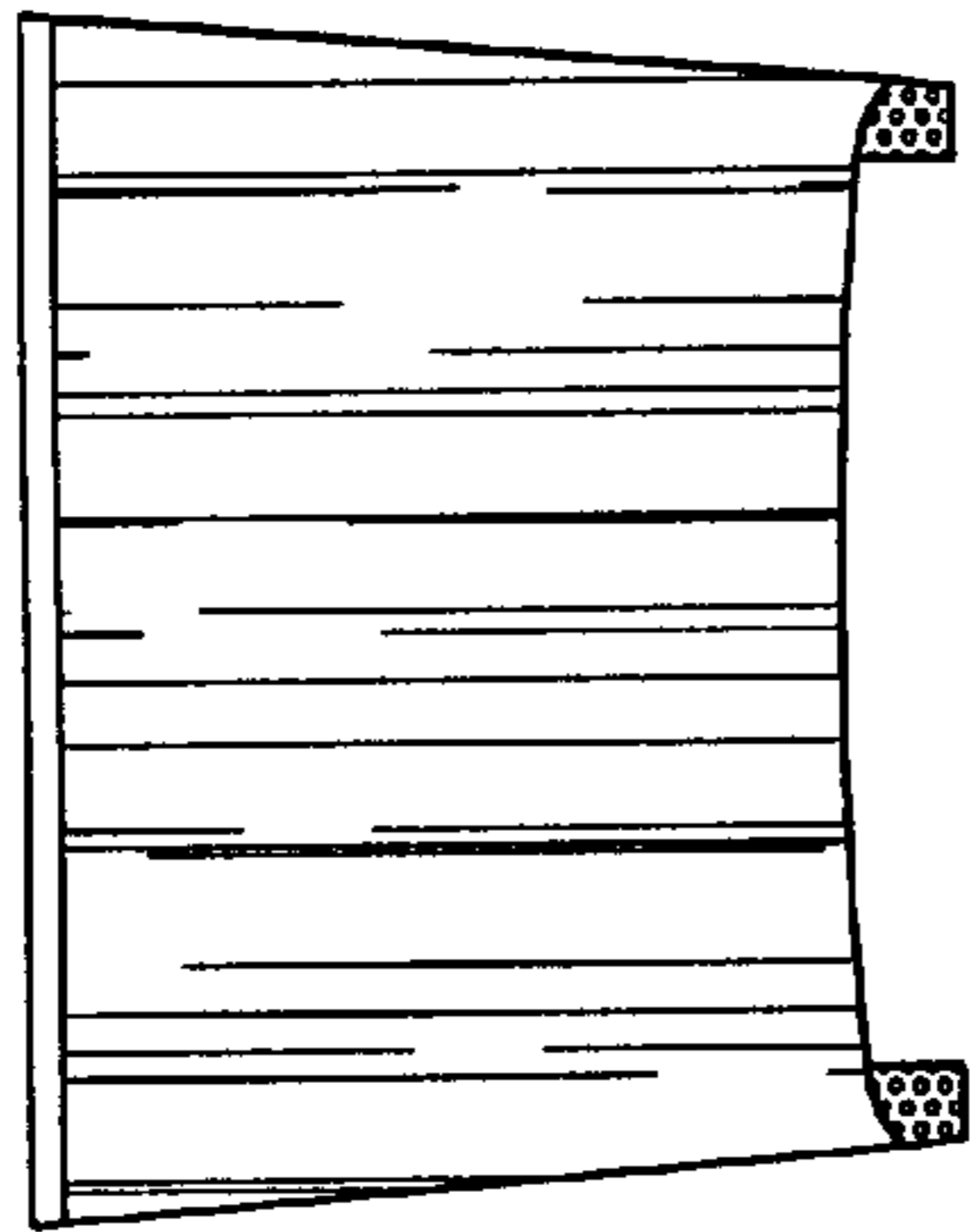

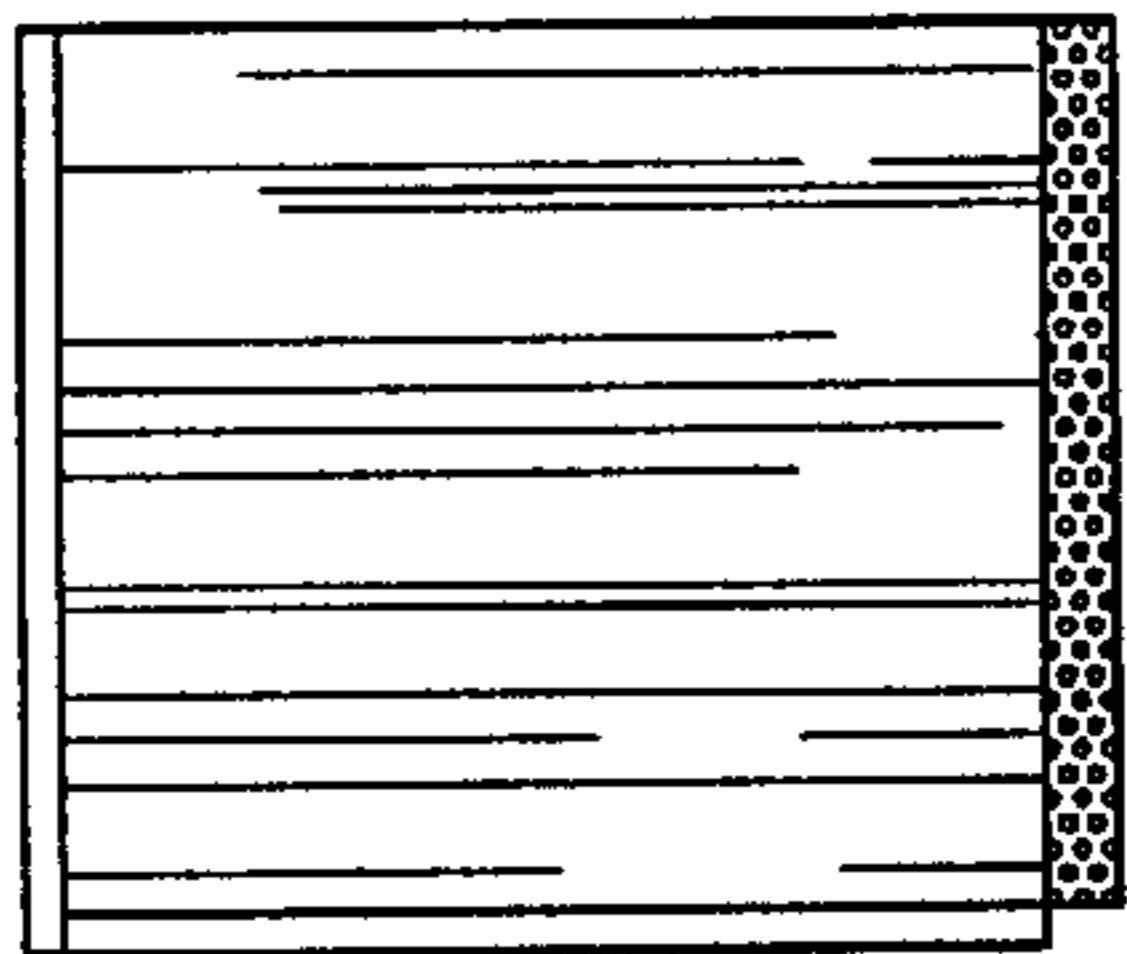

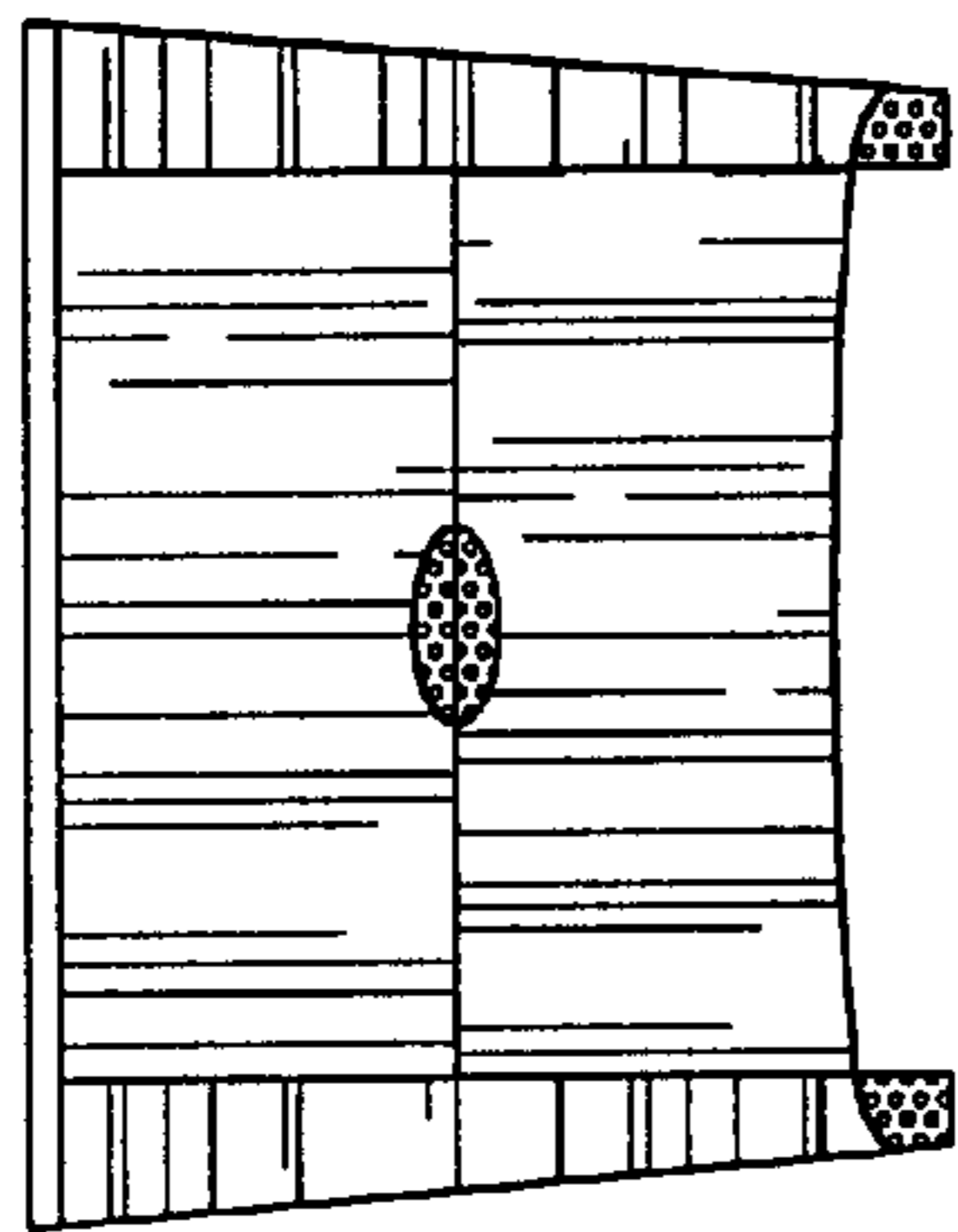

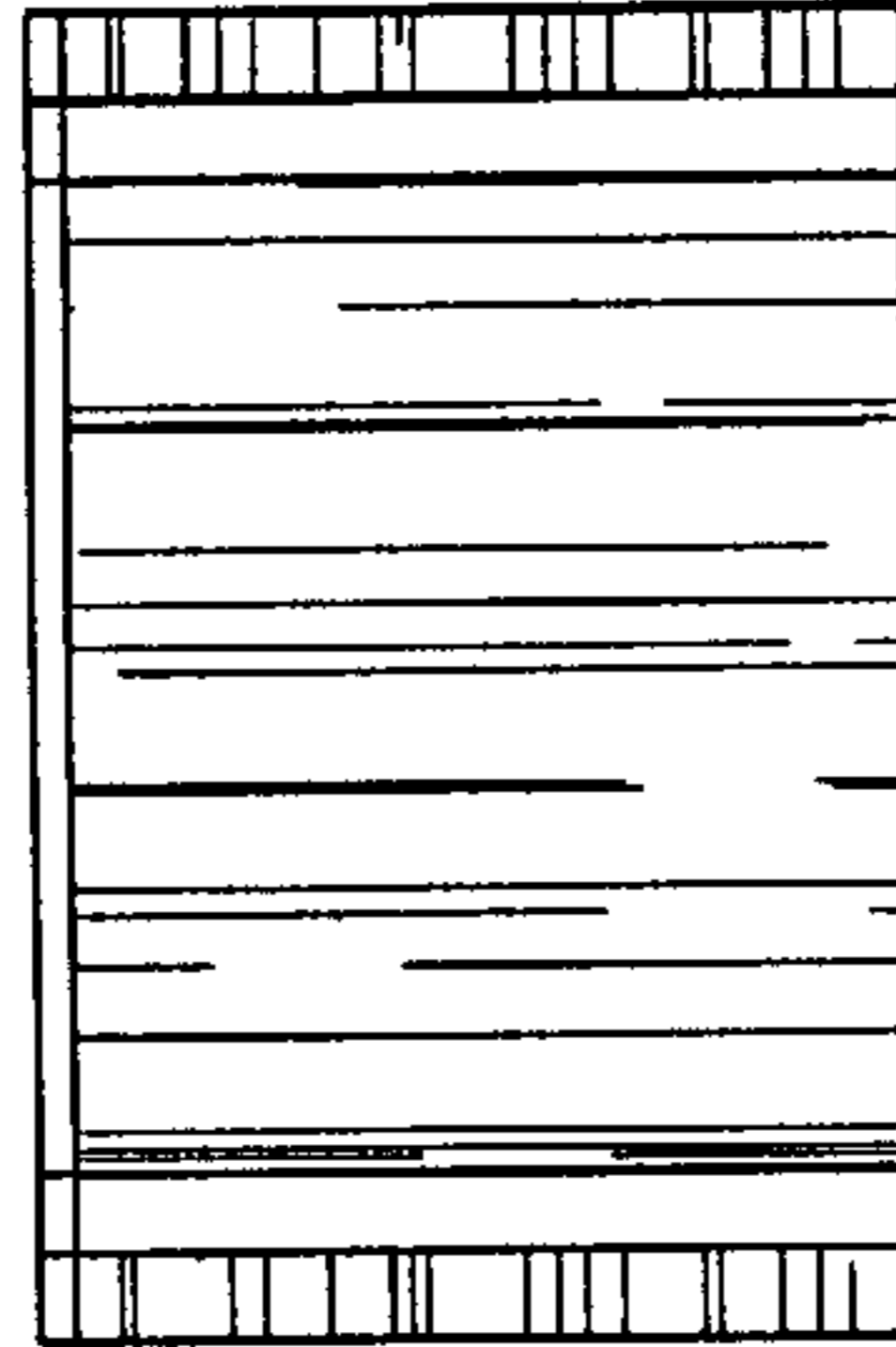

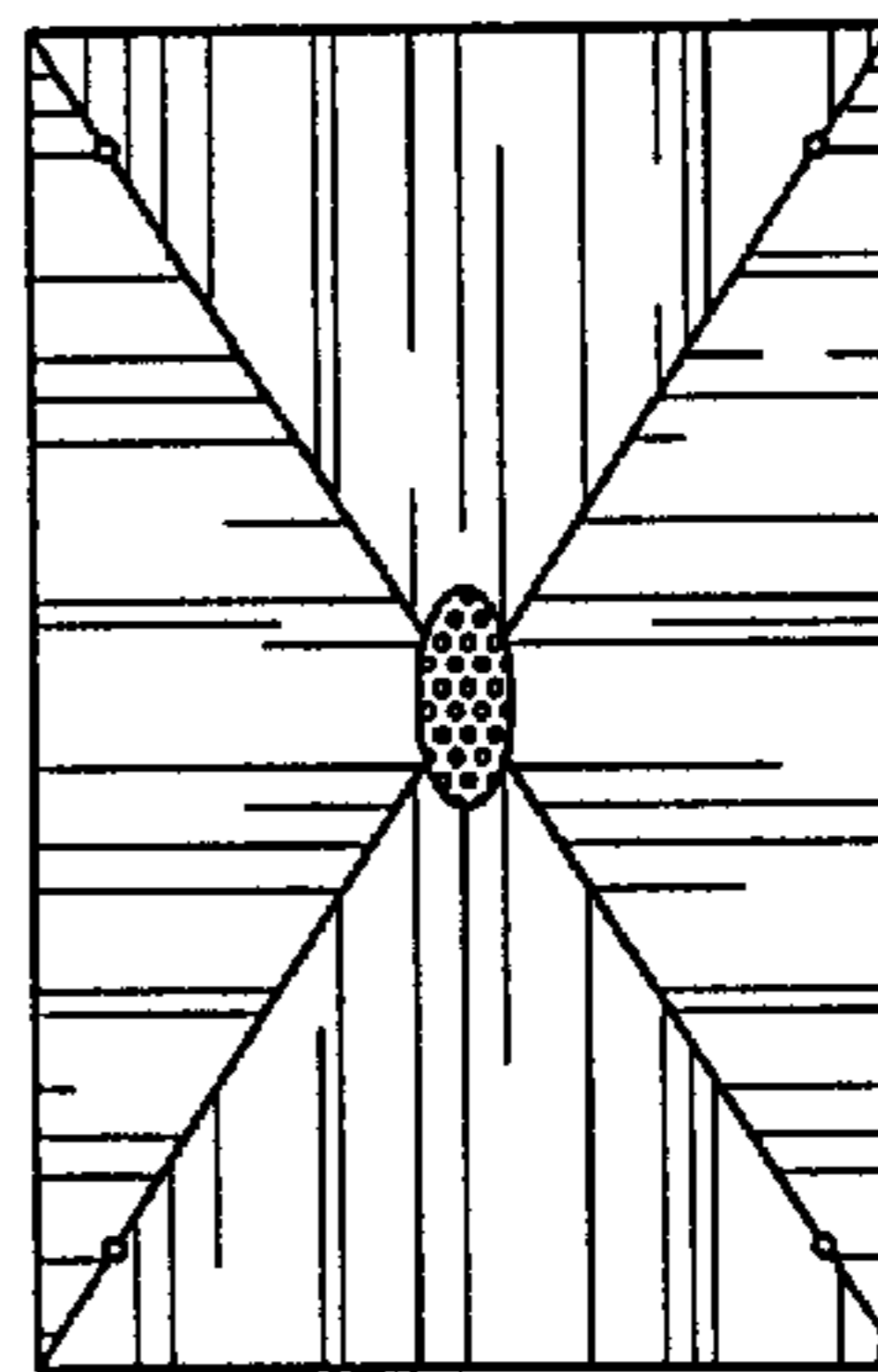
