(57) **CLAIM**

The ornamental design for a chair arm, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a chair arm showing my new design, the broken line showing of the chair is for illustrative purposes only and forms no part of the claimed design;

FIG. 2 is a top, front, outside, perspective view of the chair arm.

FIG. 3 is an outside elevational view of the chair arm.

FIG. 4 is an inside elevational view of the chair arm.

FIG. 5 is a front elevational view of the chair arm.

FIG. 6 is a rear elevational view of the chair arm.

FIG. 7 is a top plan view of the chair arm.

FIG. 8 is a bottom plan view of the chair arm.

FIG. 9 is a cross-sectional view of the chair arm, taken in the direction of the arrows 9—9 in FIG. 3.

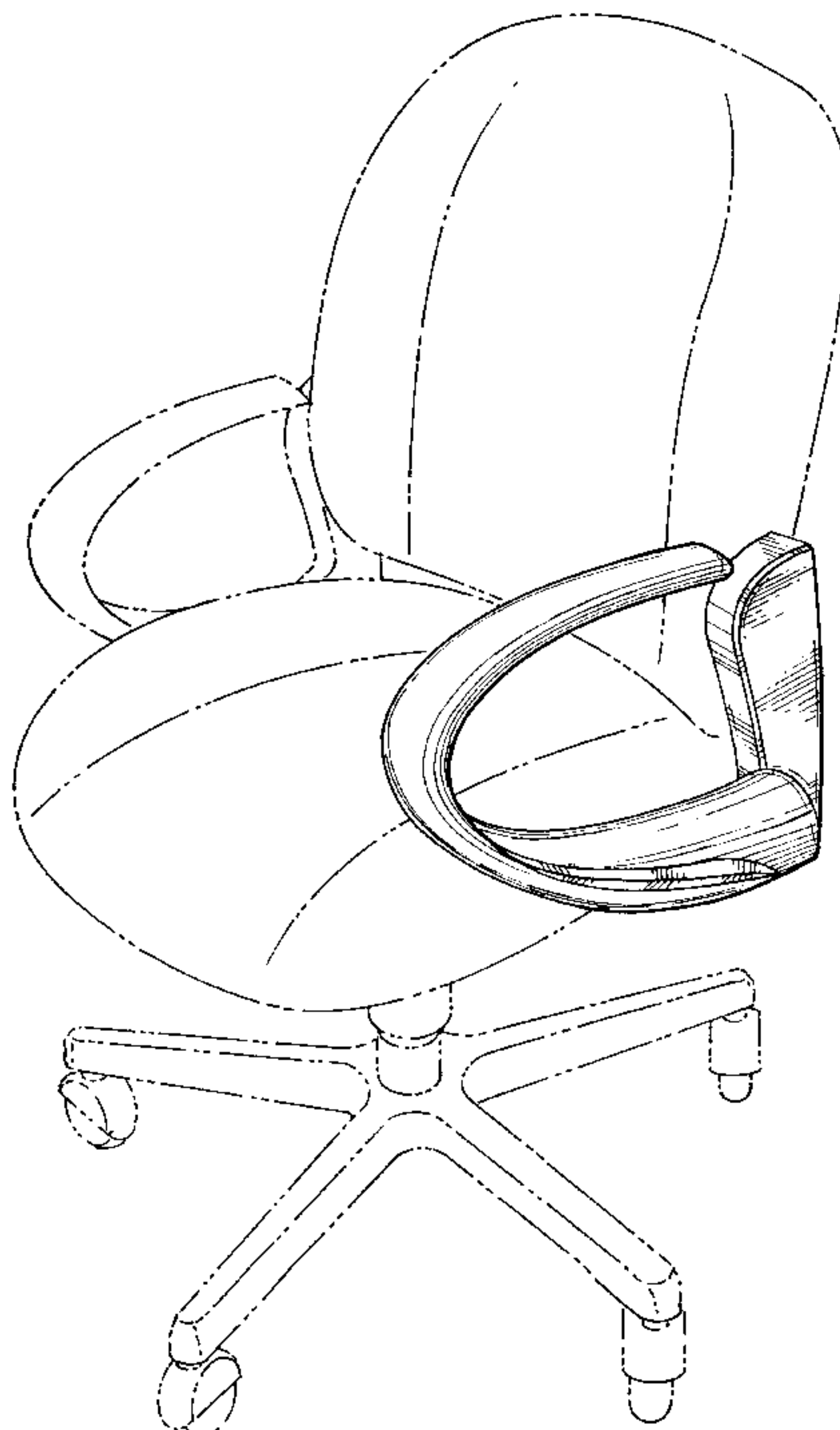
FIG. 10 is a cross-sectional view of the chair arm, taken in the direction of the arrows 10—10 in FIG. 3.

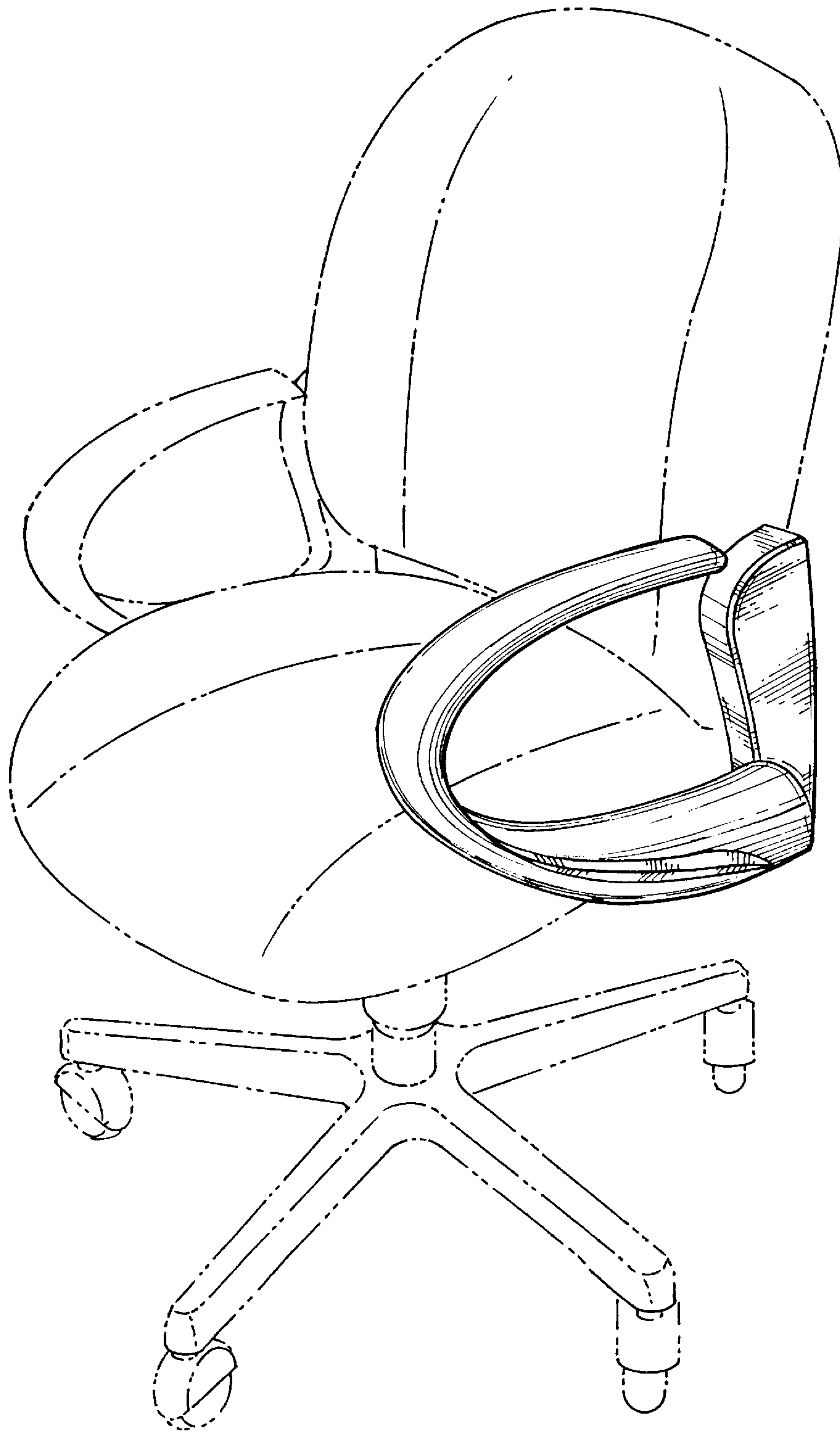

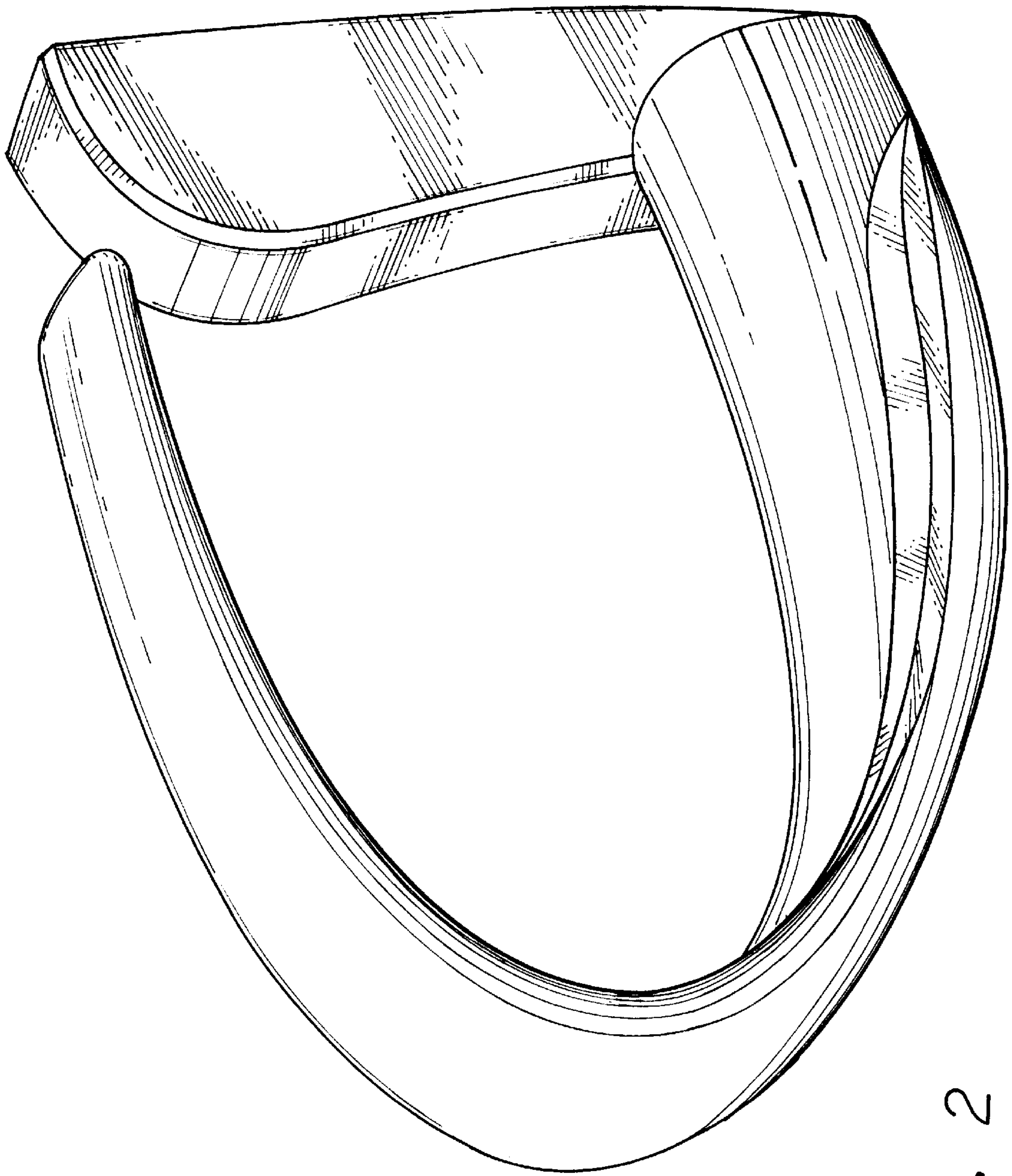

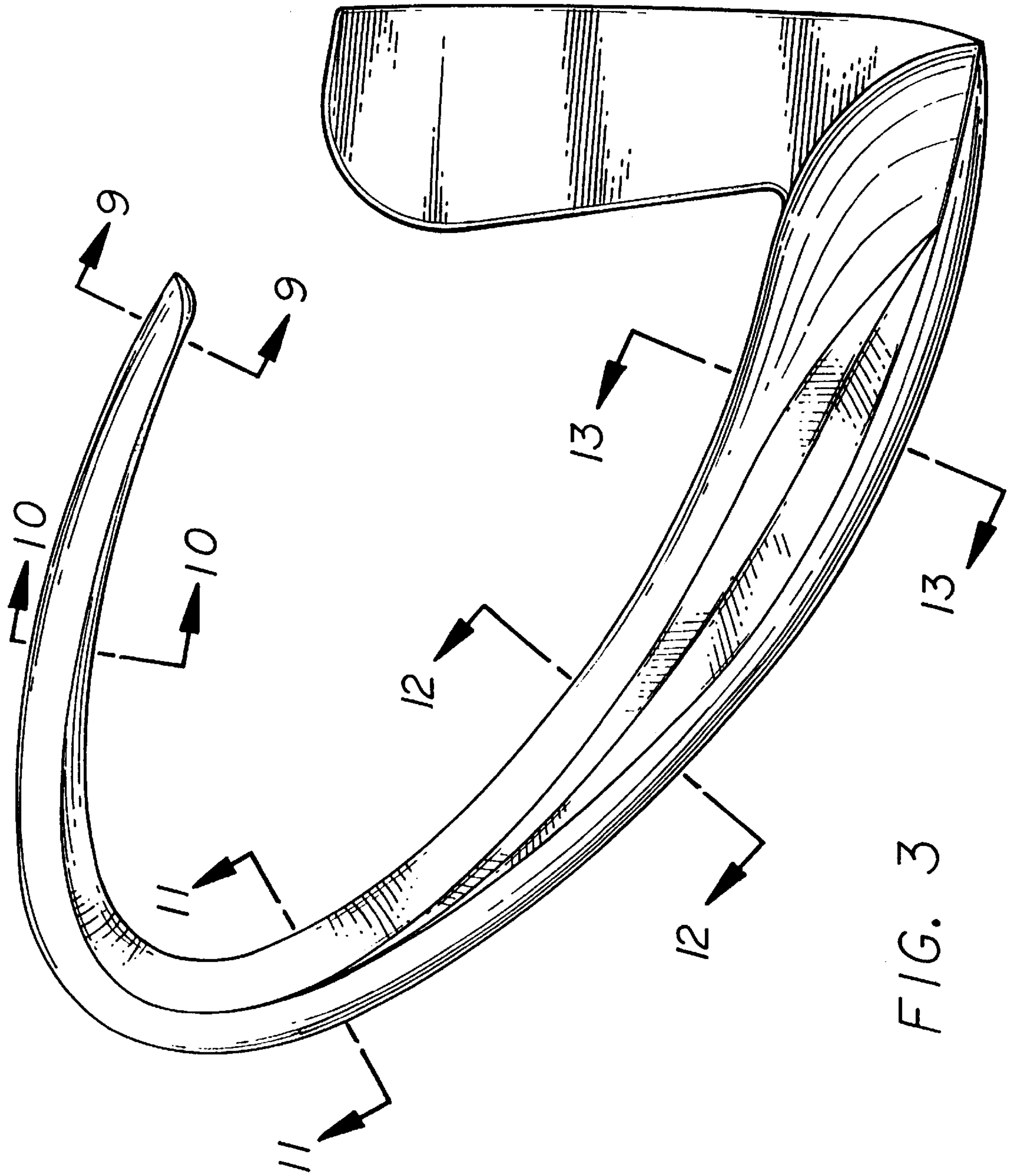

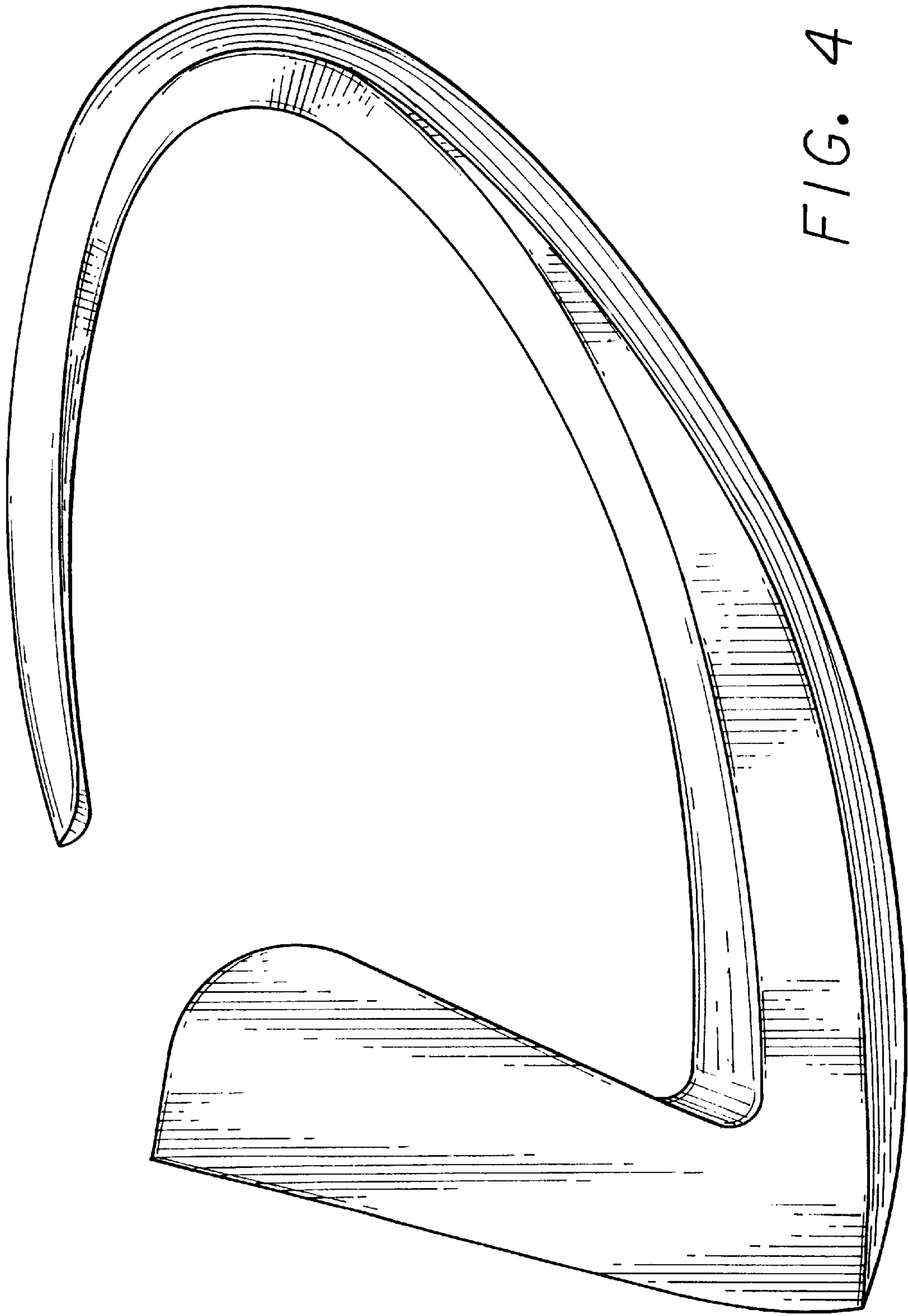

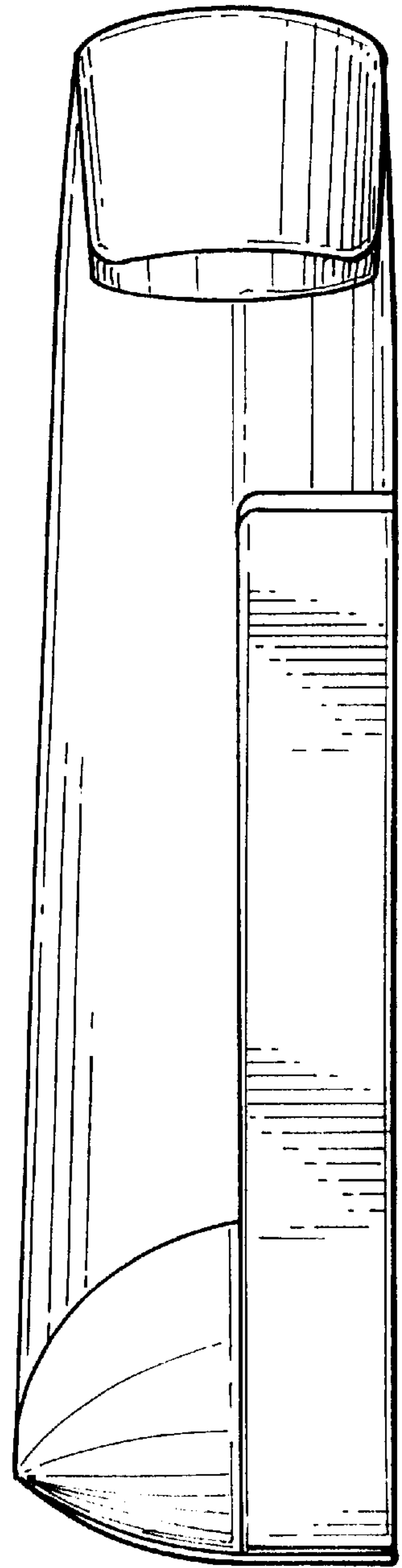
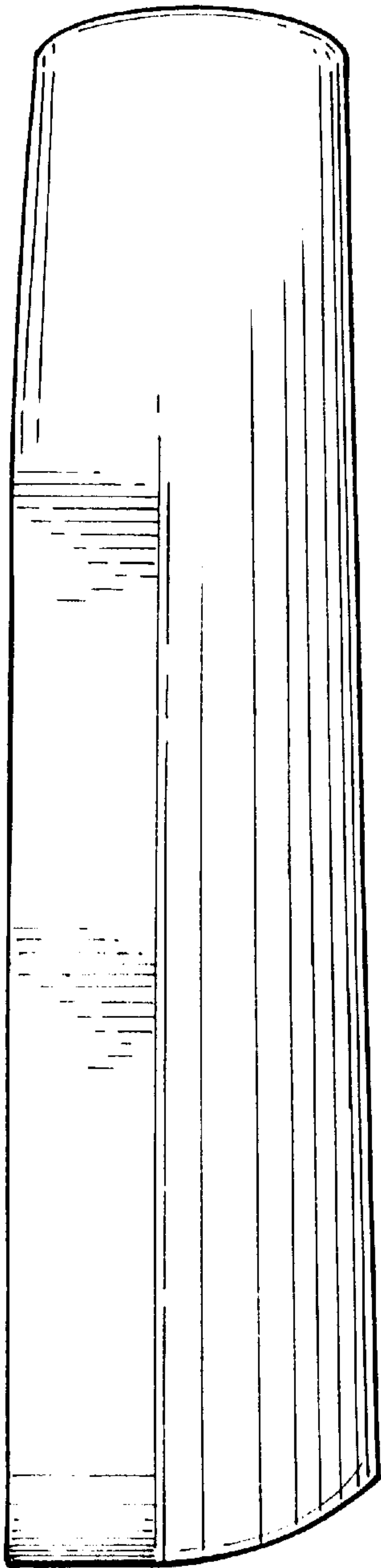

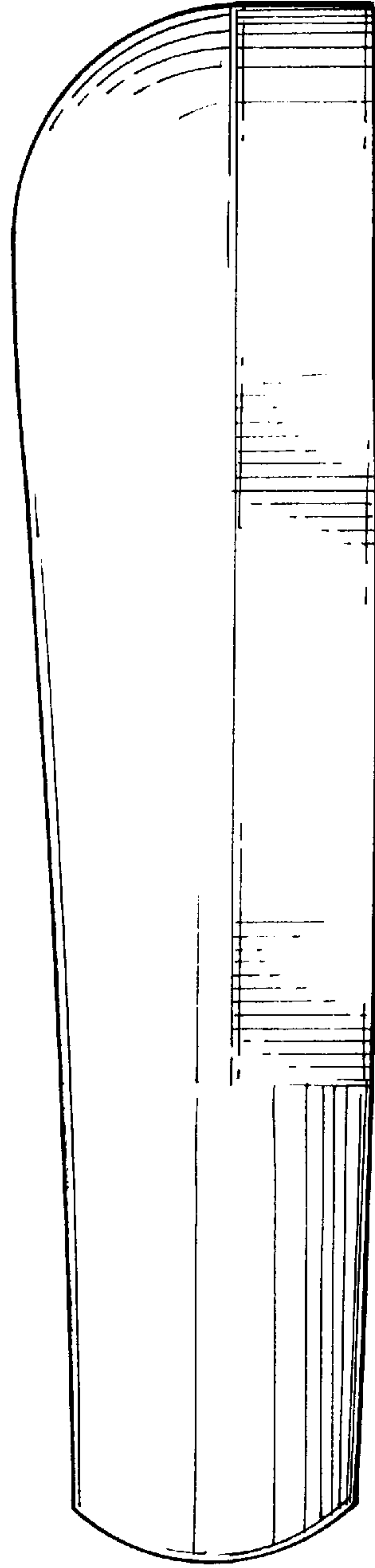
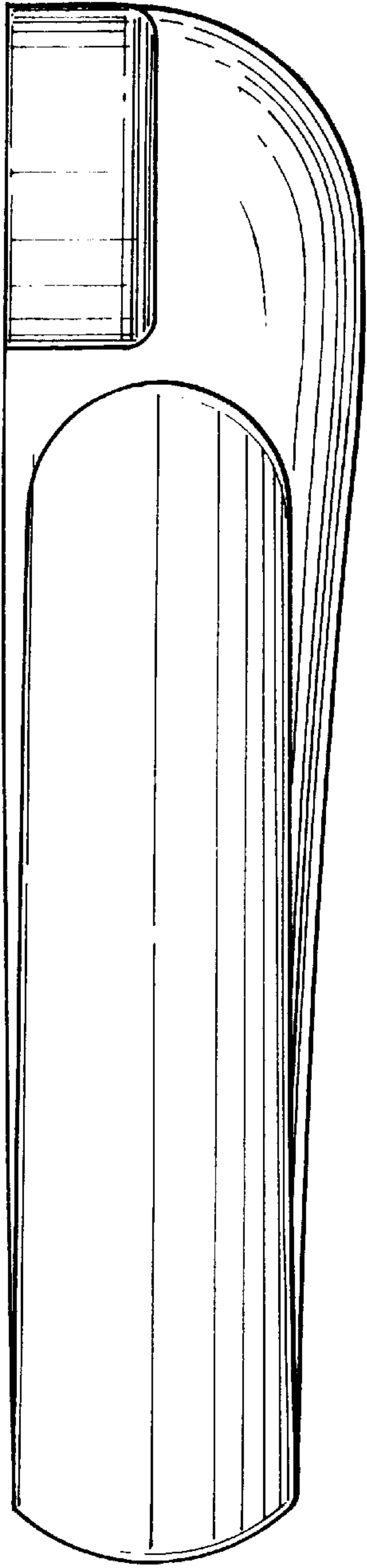

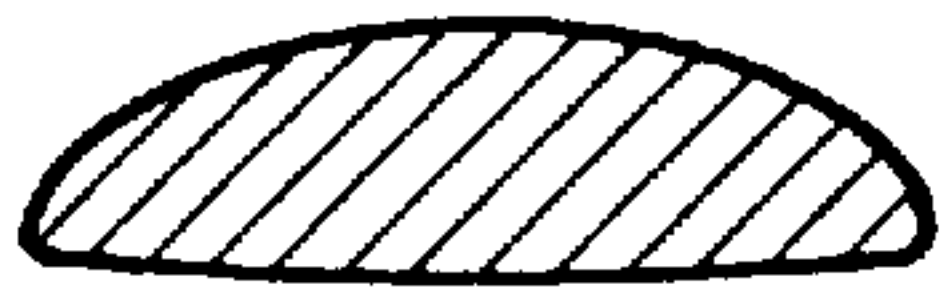

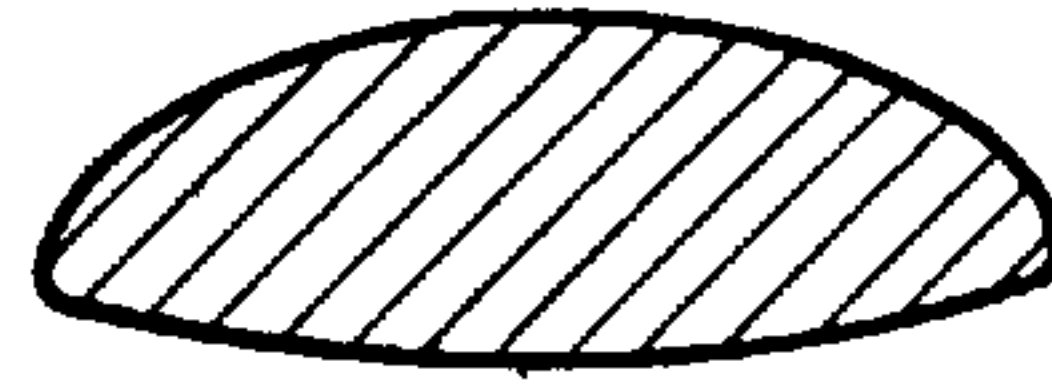

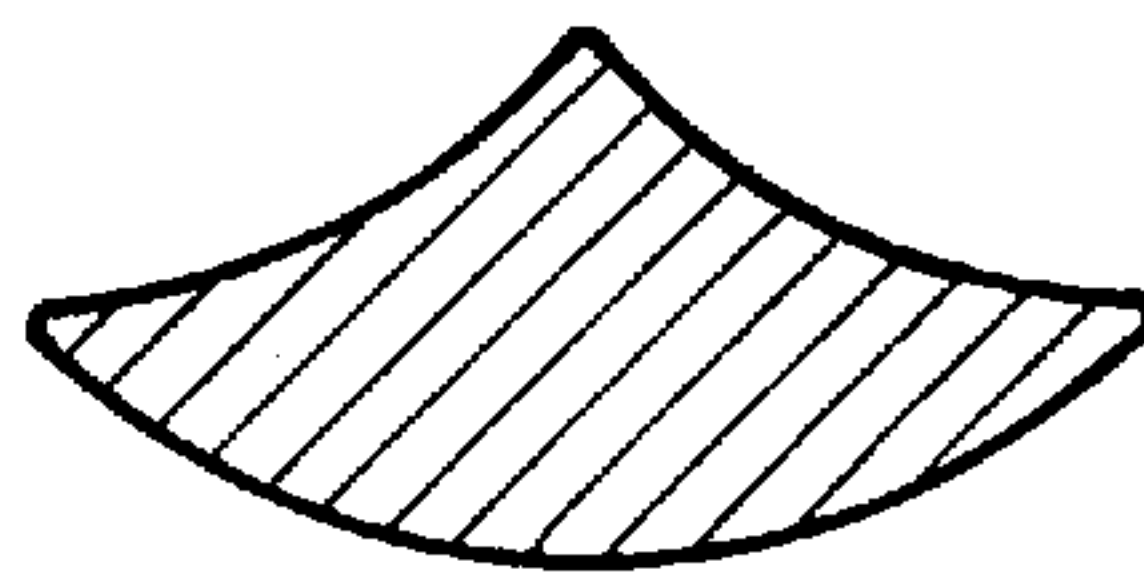

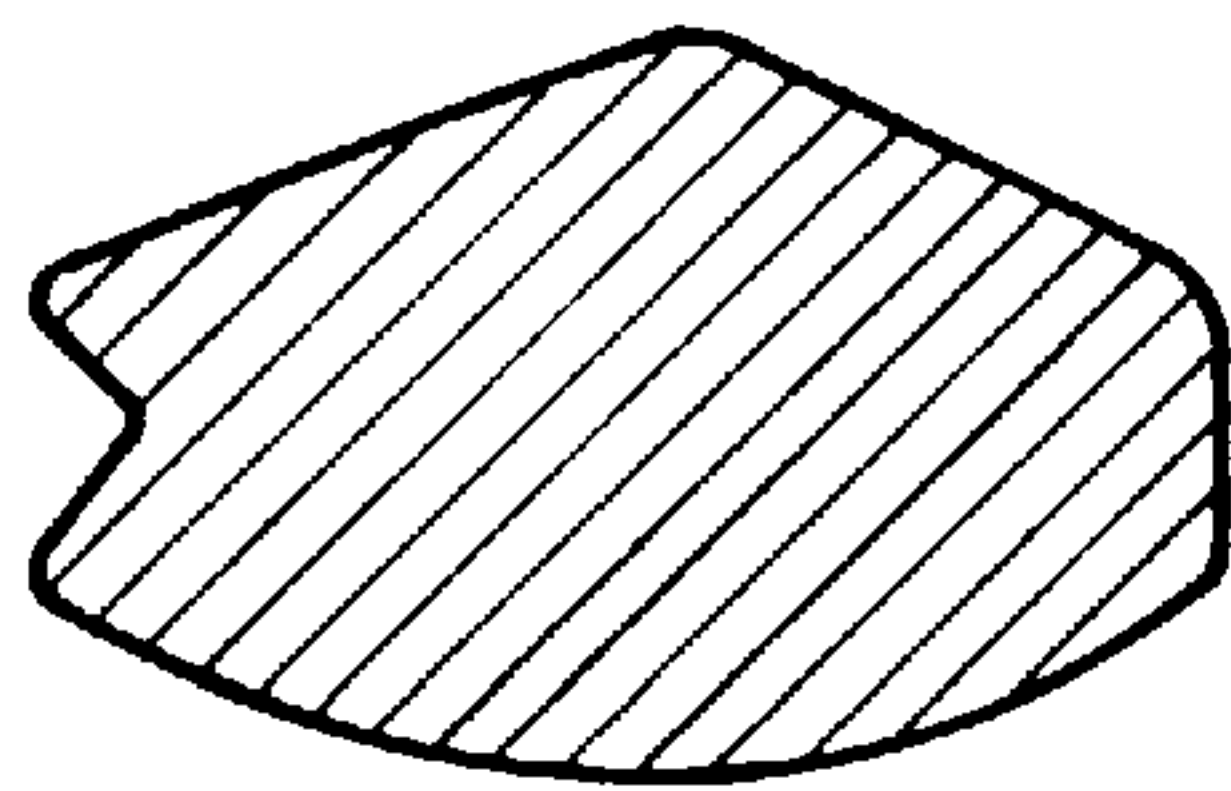

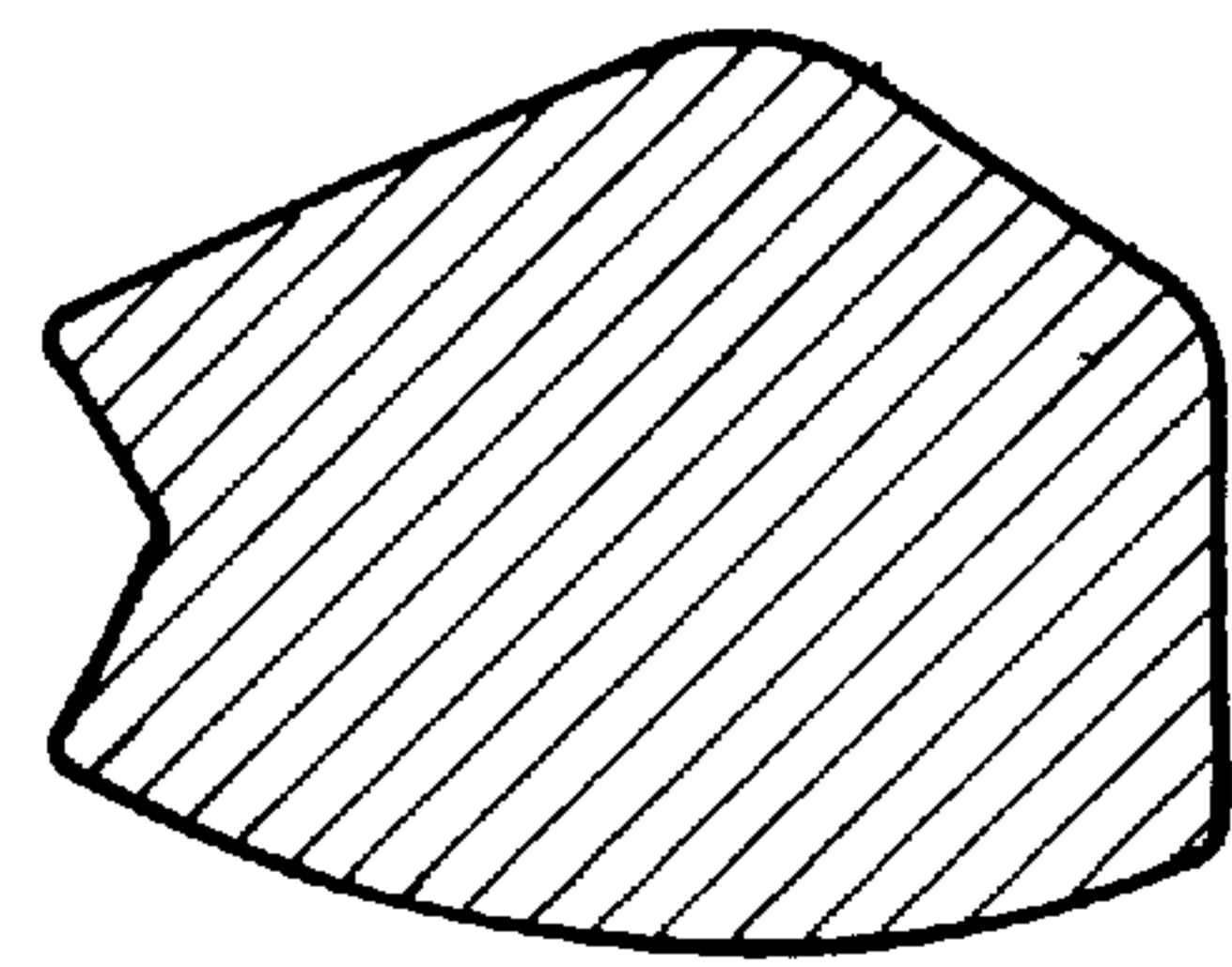
