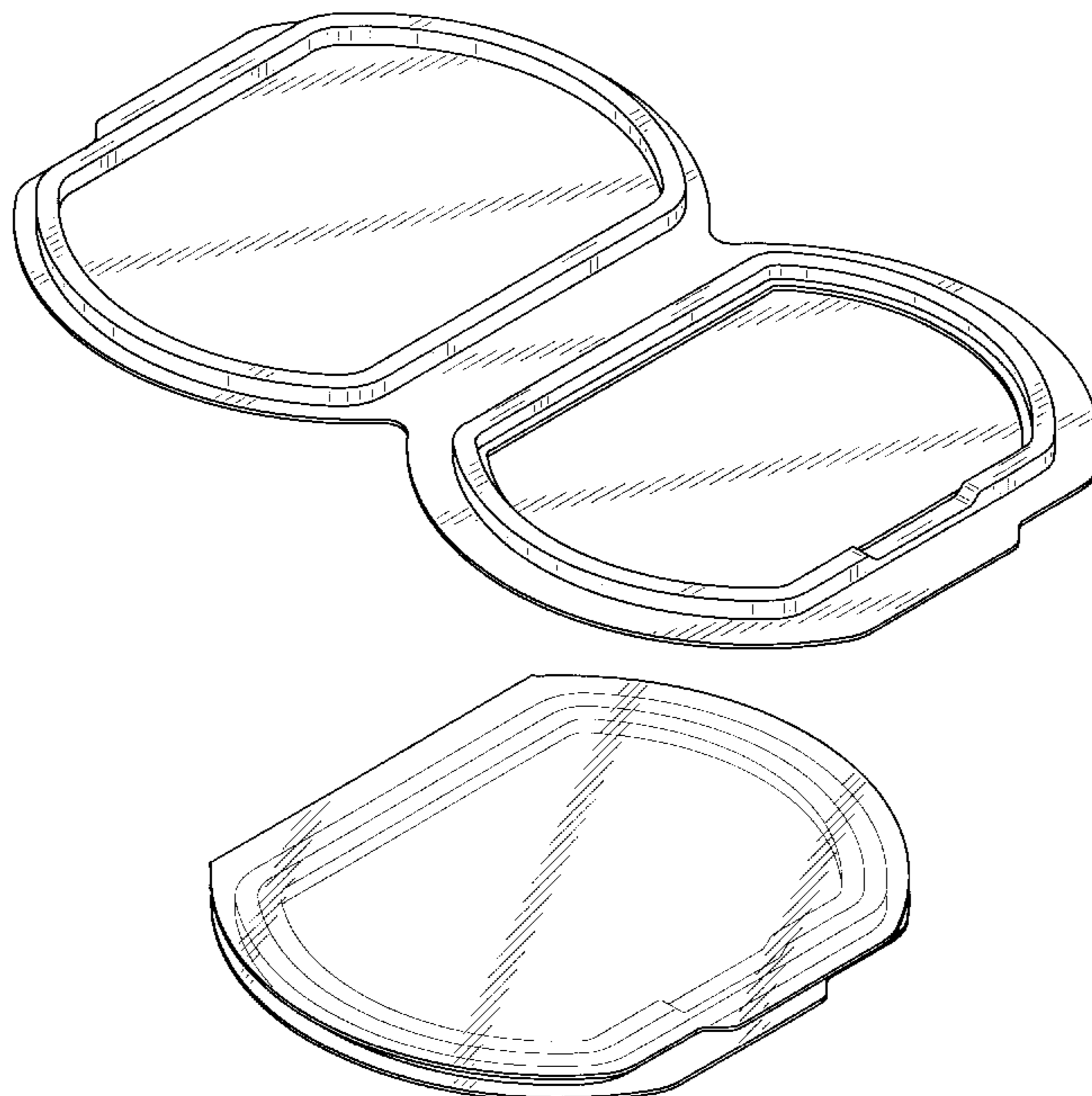
(57) **CLAIM**

The ornamental design for a mini CD-Rom storage container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the mini CD-Rom storage container of the present invention; FIG. 2 is a top plan view of the mini CD-Rom storage container of FIG. 1; FIG. 3 is a front elevational view of FIG. 2; FIG. 4 is a rear elevational view of FIG. 2; FIG. 5 is a left side elevational view of FIG. 2; FIG. 6 is a right side elevational view of FIG. 2; FIG. 7 is a rear plan view of FIG. 2; FIG. 8 is a perspective view of the first embodiment of the mini CD-Rom storage container in a closed position; FIG. 9 is a perspective view of a second embodiment of the mini CD-Rom storage container; FIG. 10 is a top plan view of the mini CD-Rom storage container of FIG. 9; FIG. 11 is a front elevational view of FIG. 10; FIG. 12 is a rear elevational view of FIG. 10; FIG. 13 is a left side elevational view of FIG. 10; FIG. 14 is a right side elevational view of FIG. 10; FIG. 15 is a bottom plan view of FIG. 10; and, FIG. 16 is a view of the second embodiment of the mini CD-Rom storage container in a closed position.

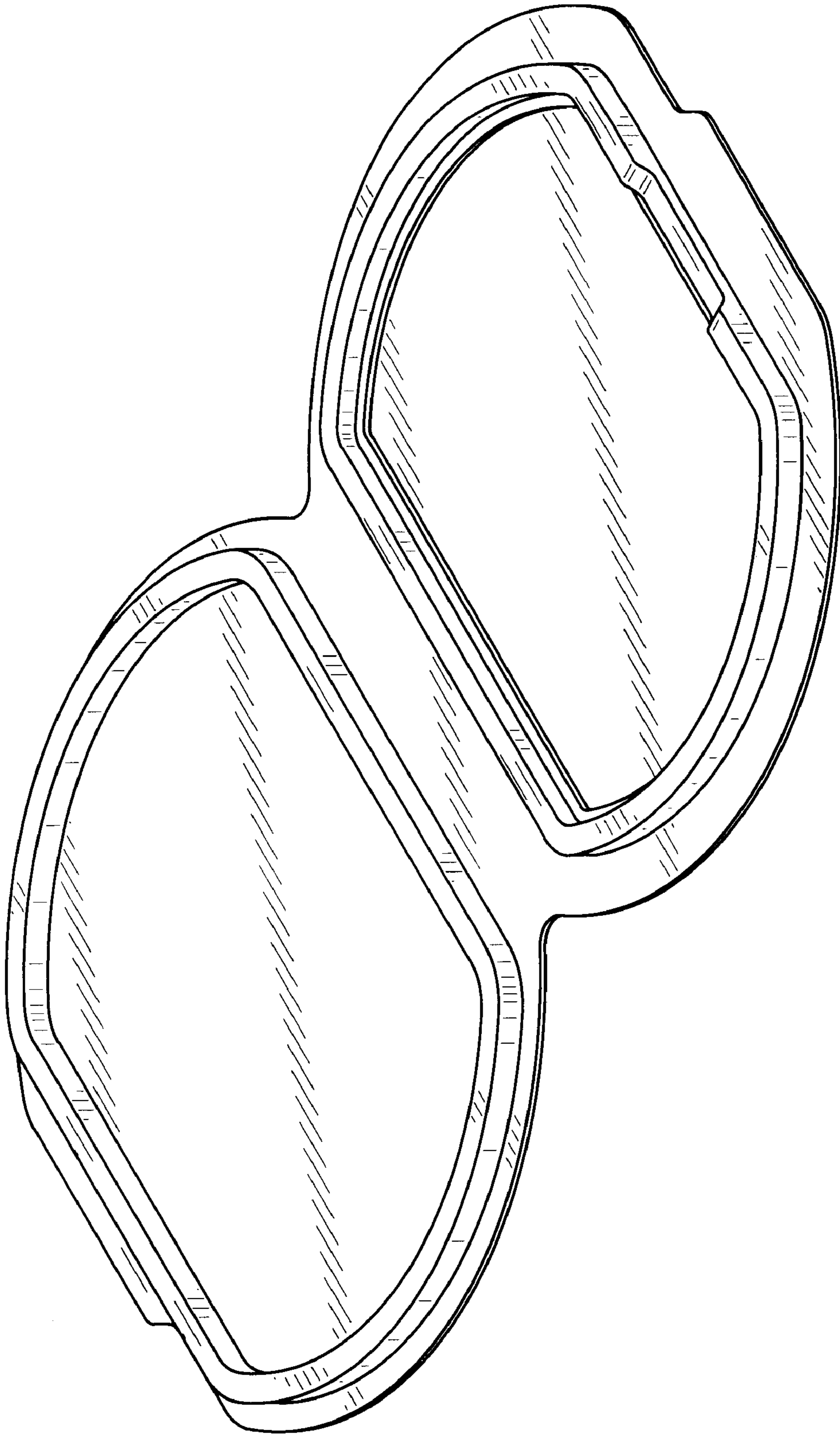

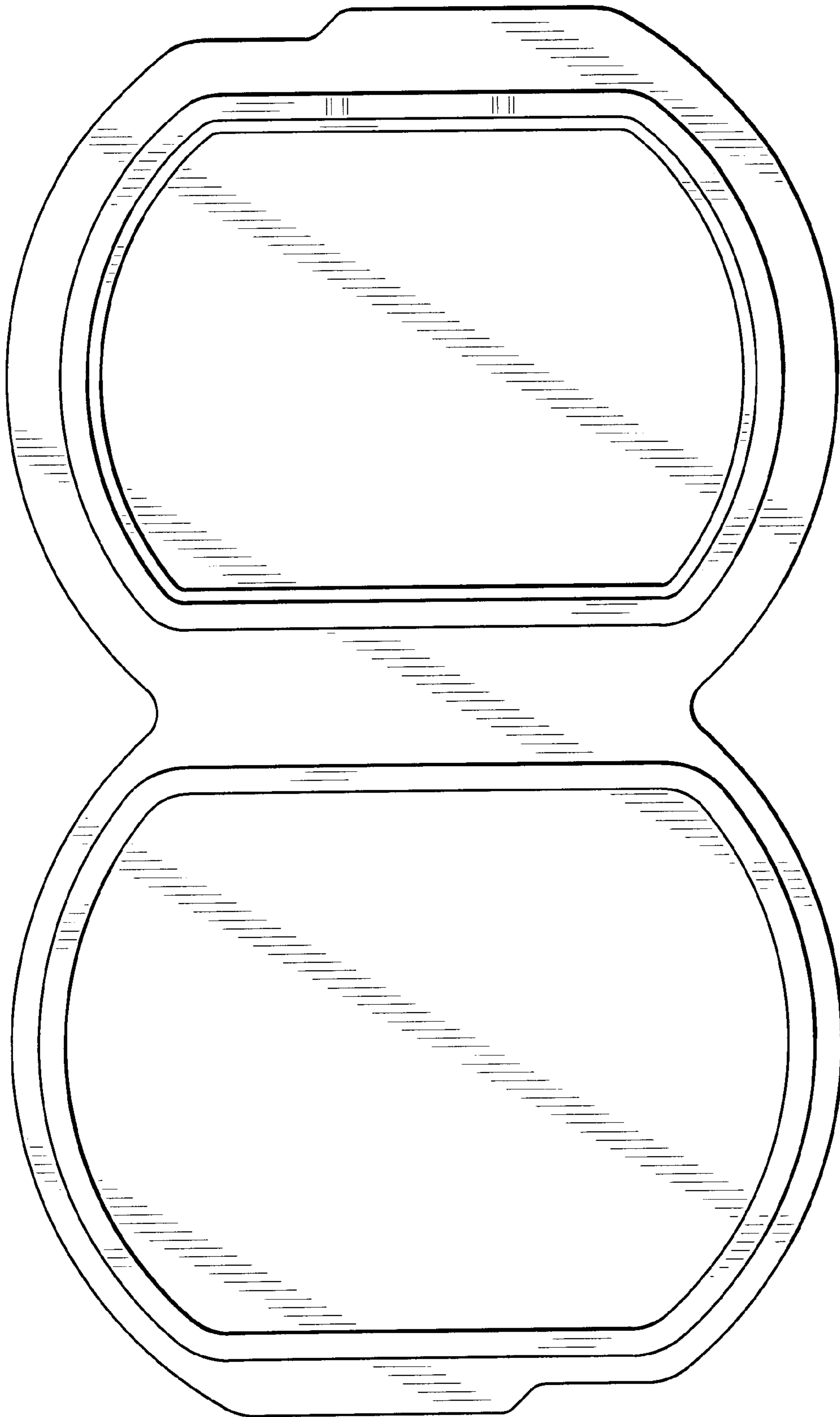

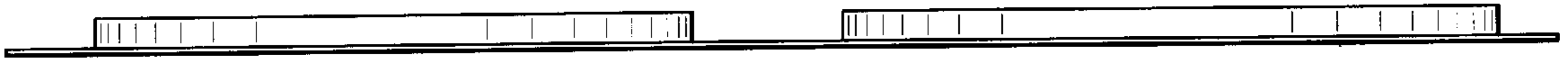

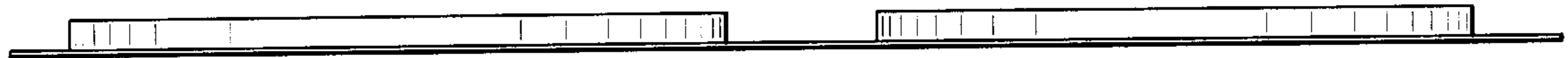

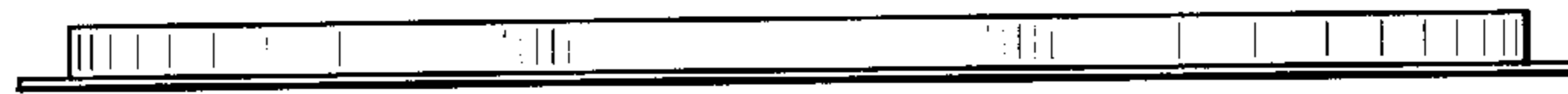

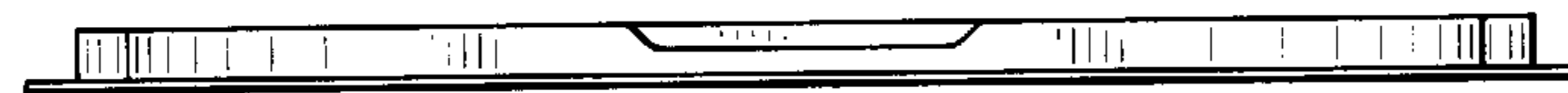

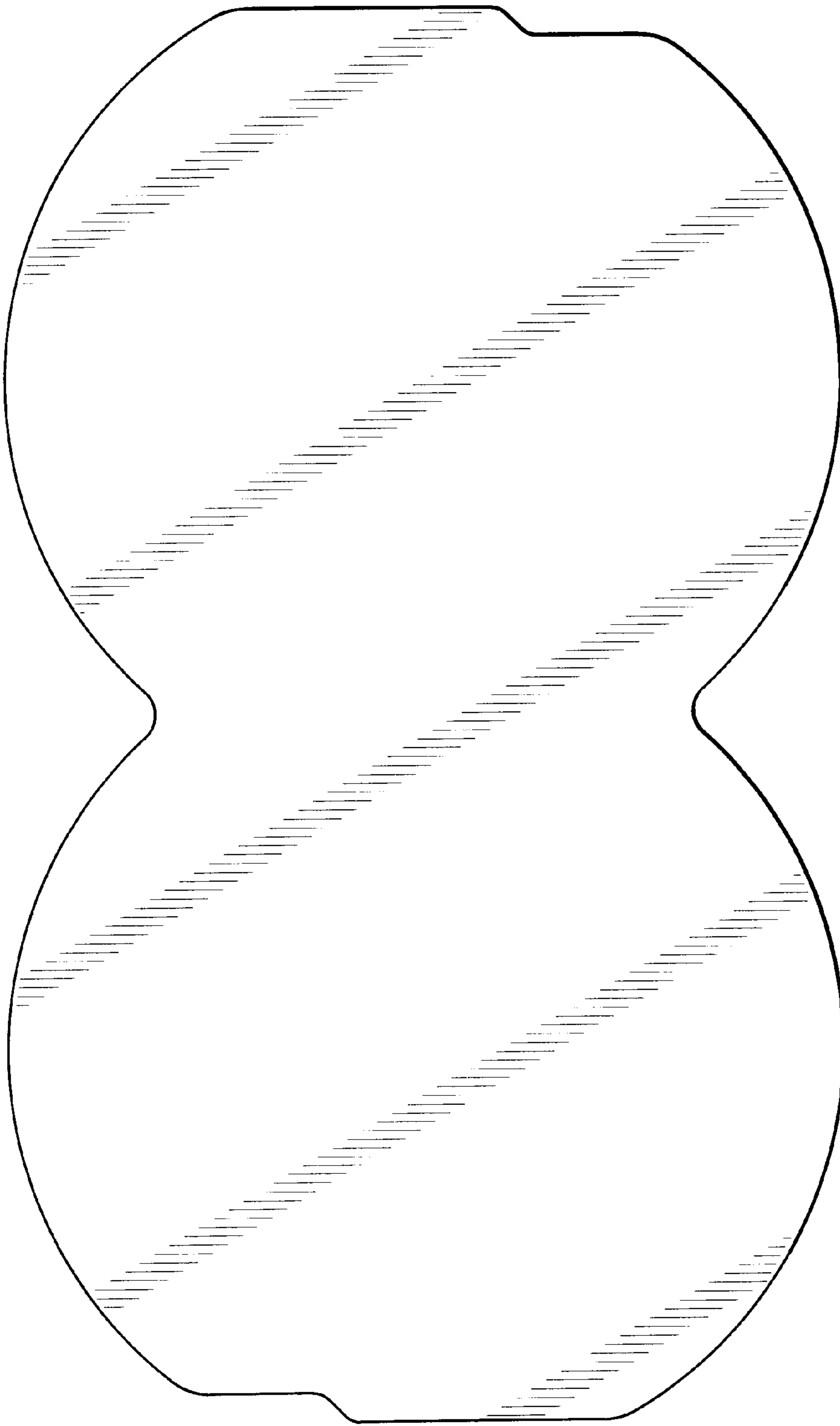

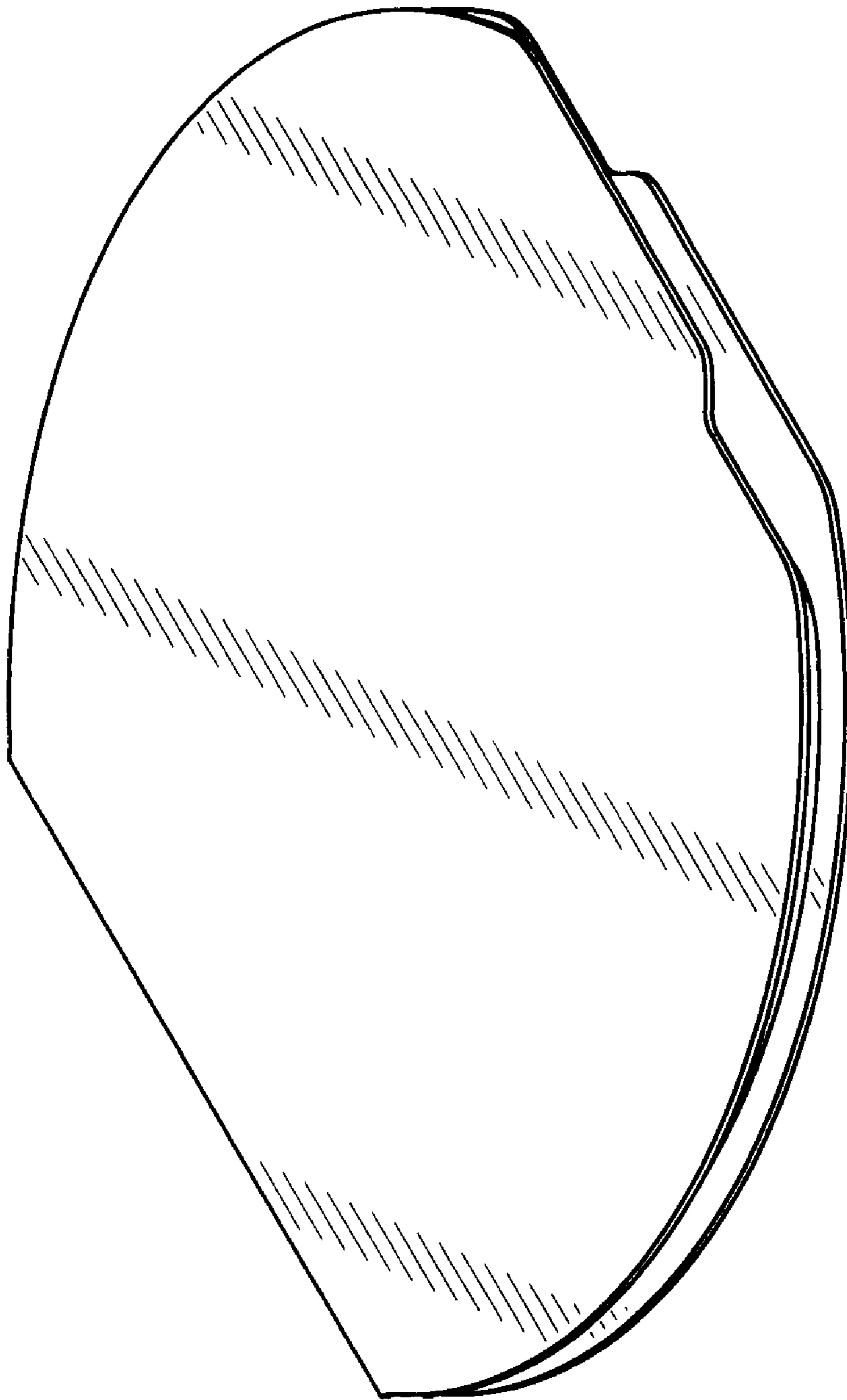

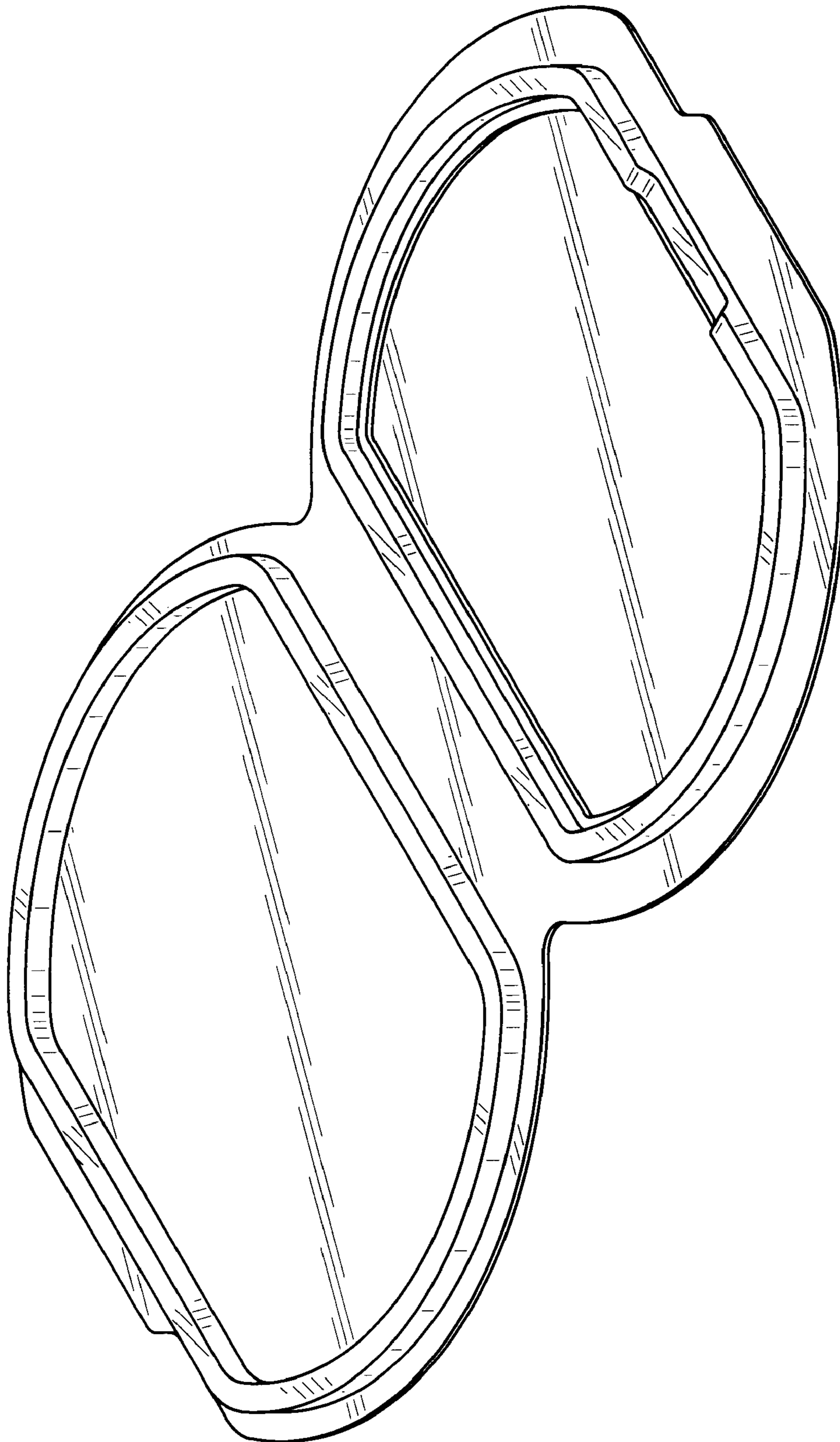

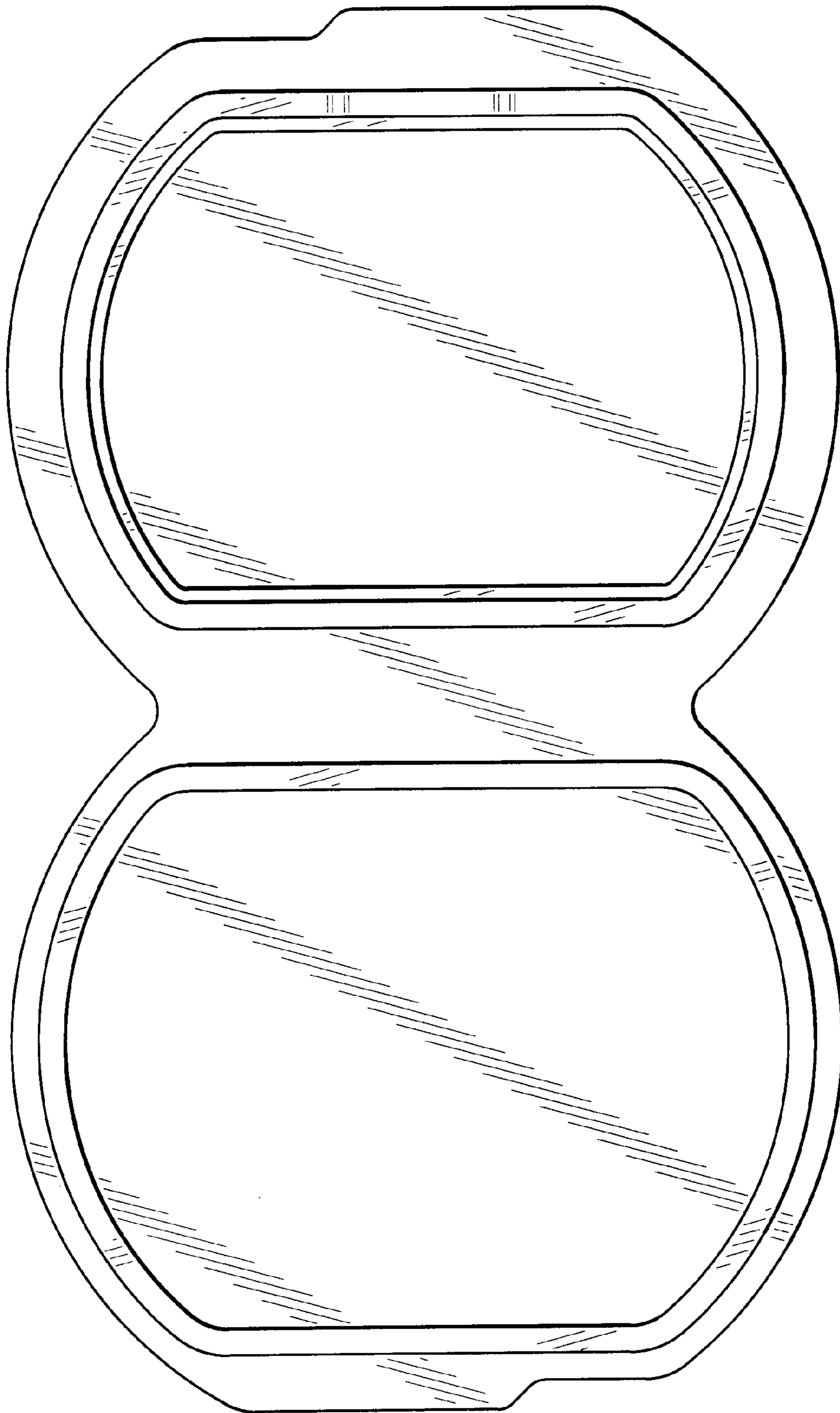

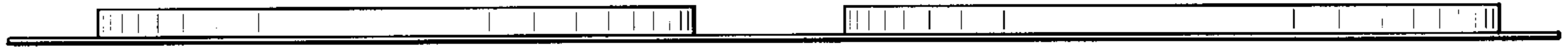

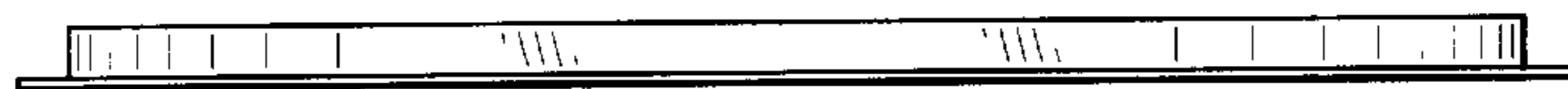

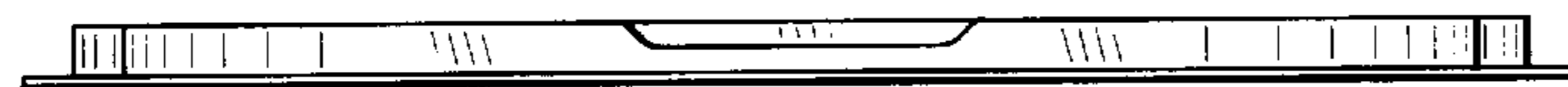

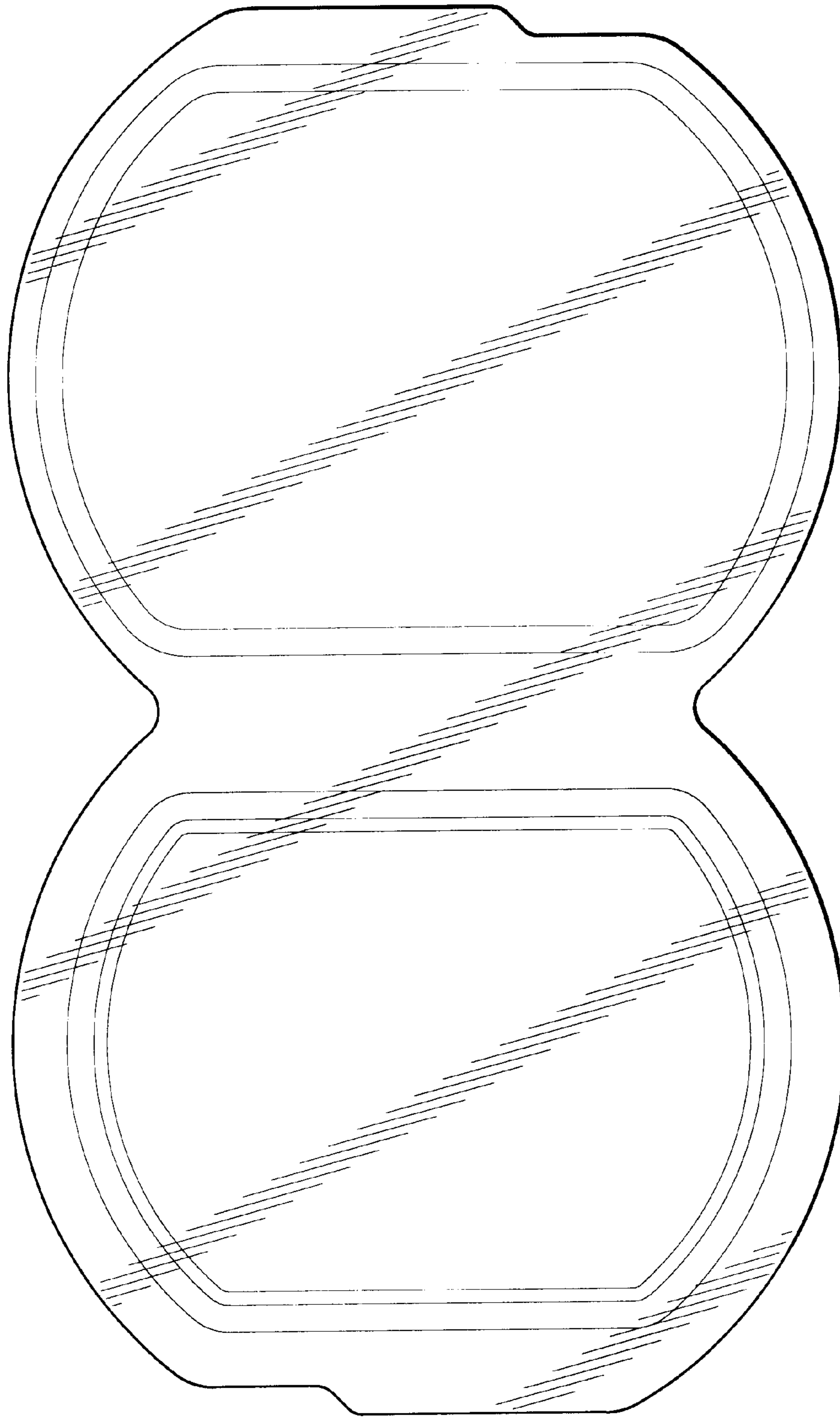

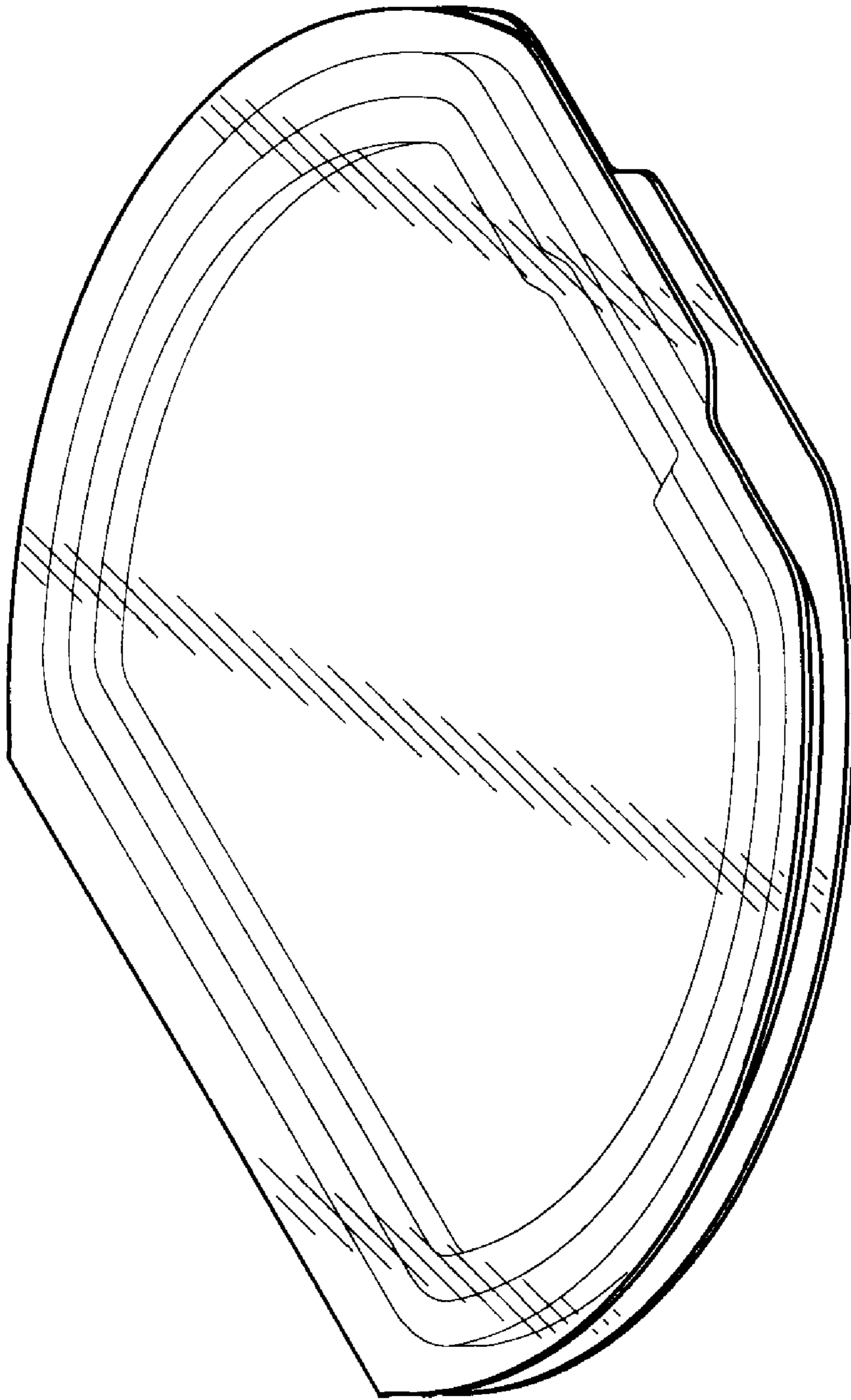
