(57) **CLAIM**

The ornamental design for a combined picture frame and message recorder, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the combined picture frame and message recorder of the present invention;

FIG. 2 is a rear elevational view of the combined picture frame and message recorder of FIG. 1;

FIG. 3 is a left side elevational view of the combined picture frame and message recorder of FIG. 1;

FIG. 4 is a right side elevational view of the combined picture frame and message recorder of FIG. 1;

FIG. 5 is a top plan view of the combined picture frame and message recorder of FIG. 1, the bottom view being a mirror image thereof;

FIG. 6 is a top, front, left side perspective view of the combined picture frame and message recorder of FIG. 1;

FIG. 7 is a front elevational view of an alternate embodiment of FIG. 1 of the combined picture frame and message recorder; and,

FIG. 8 is a left side elevational view of FIG. 7 of the combined picture frame and message recorder.

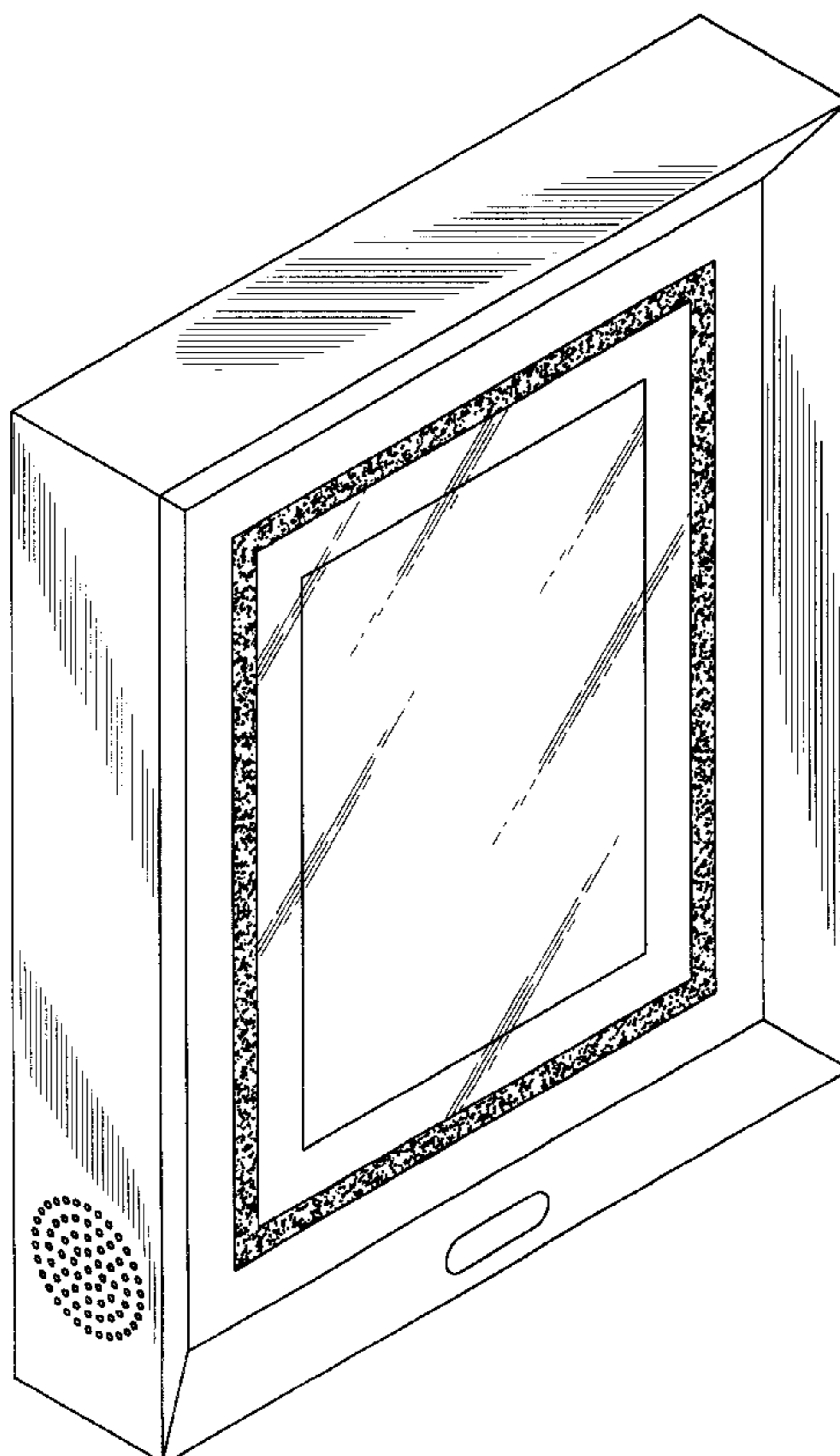

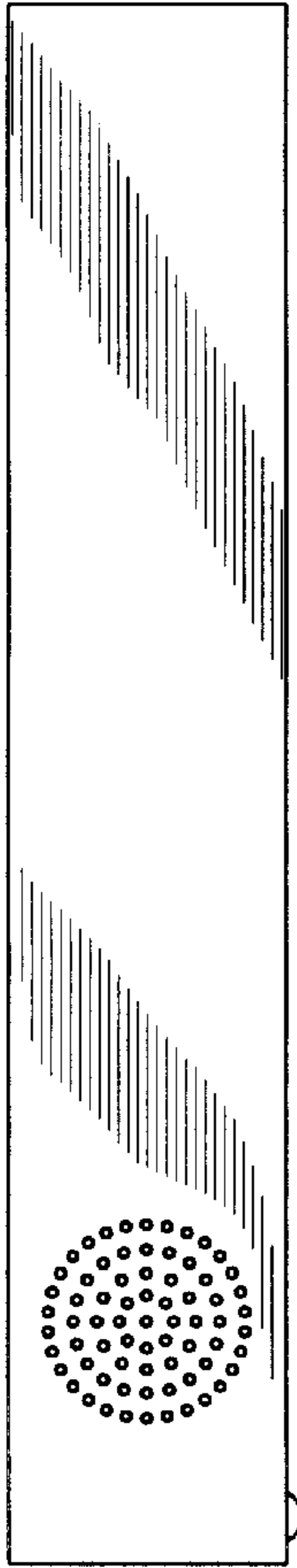

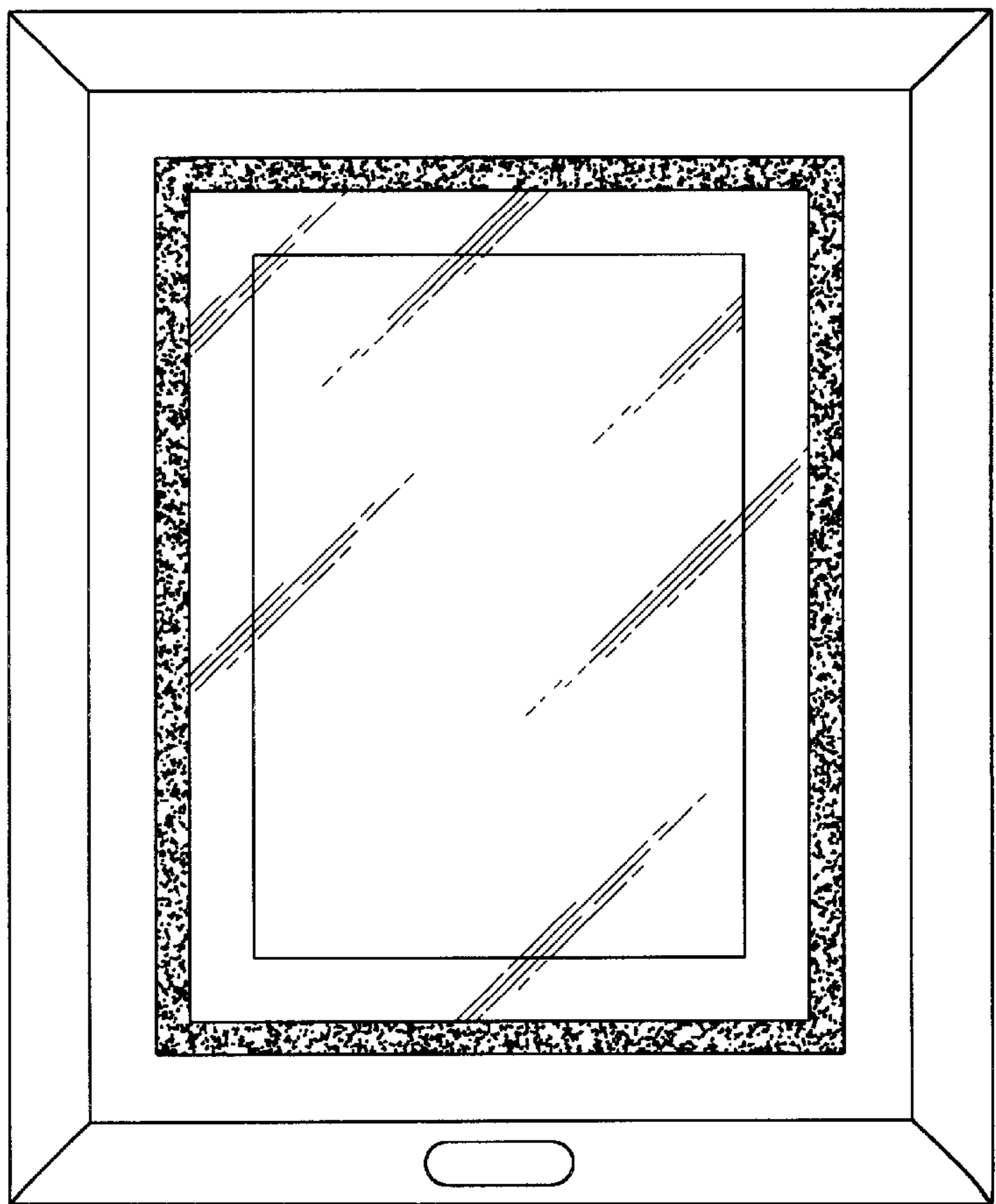

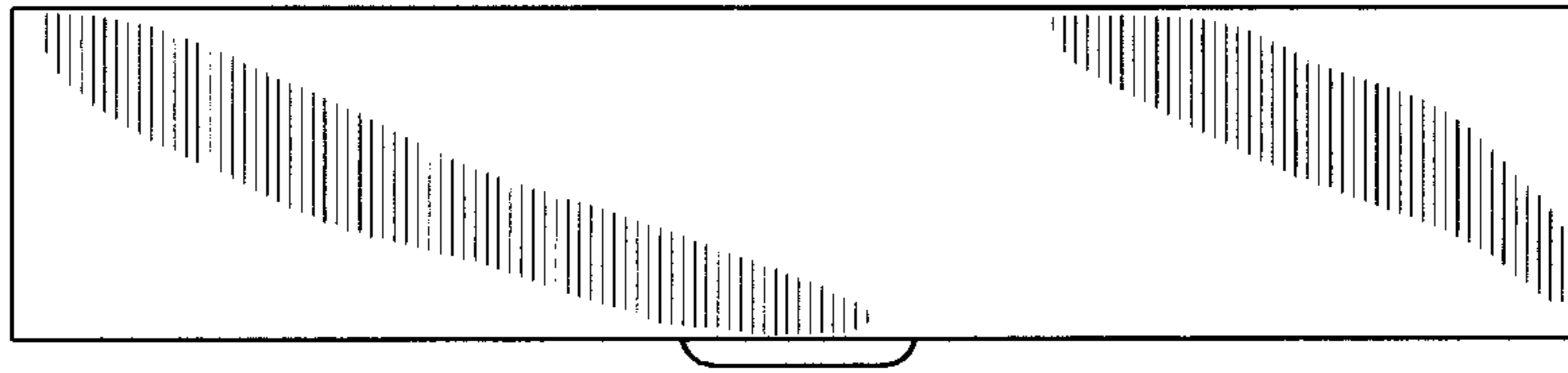

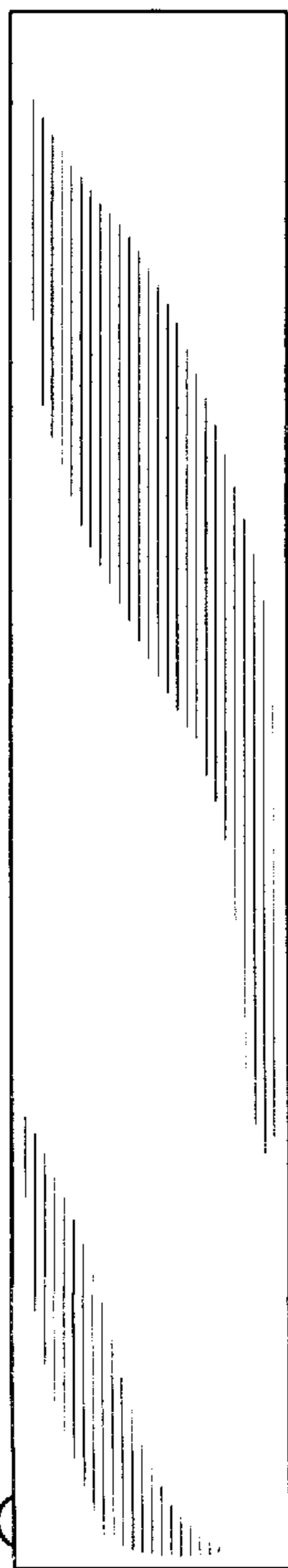

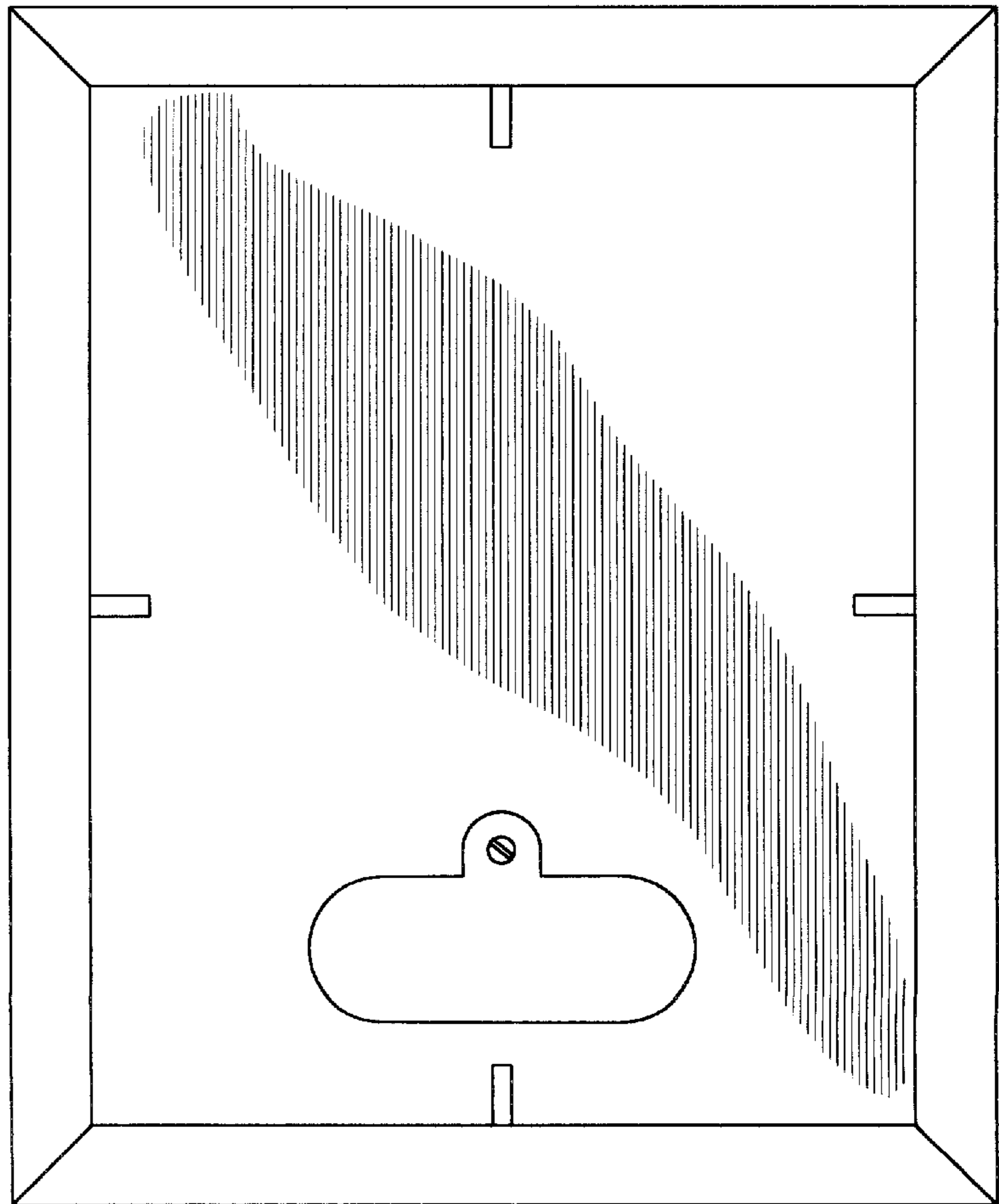

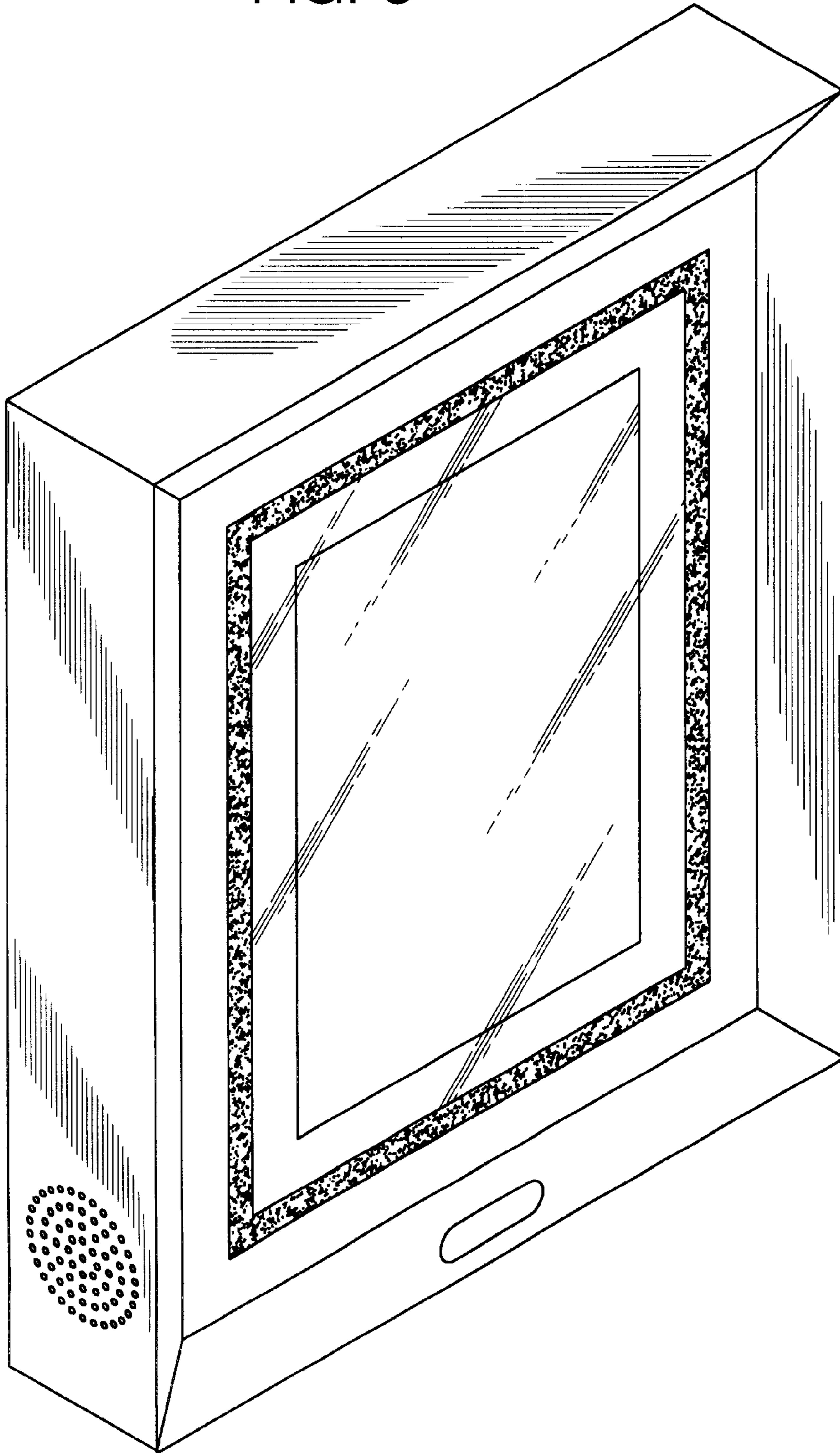

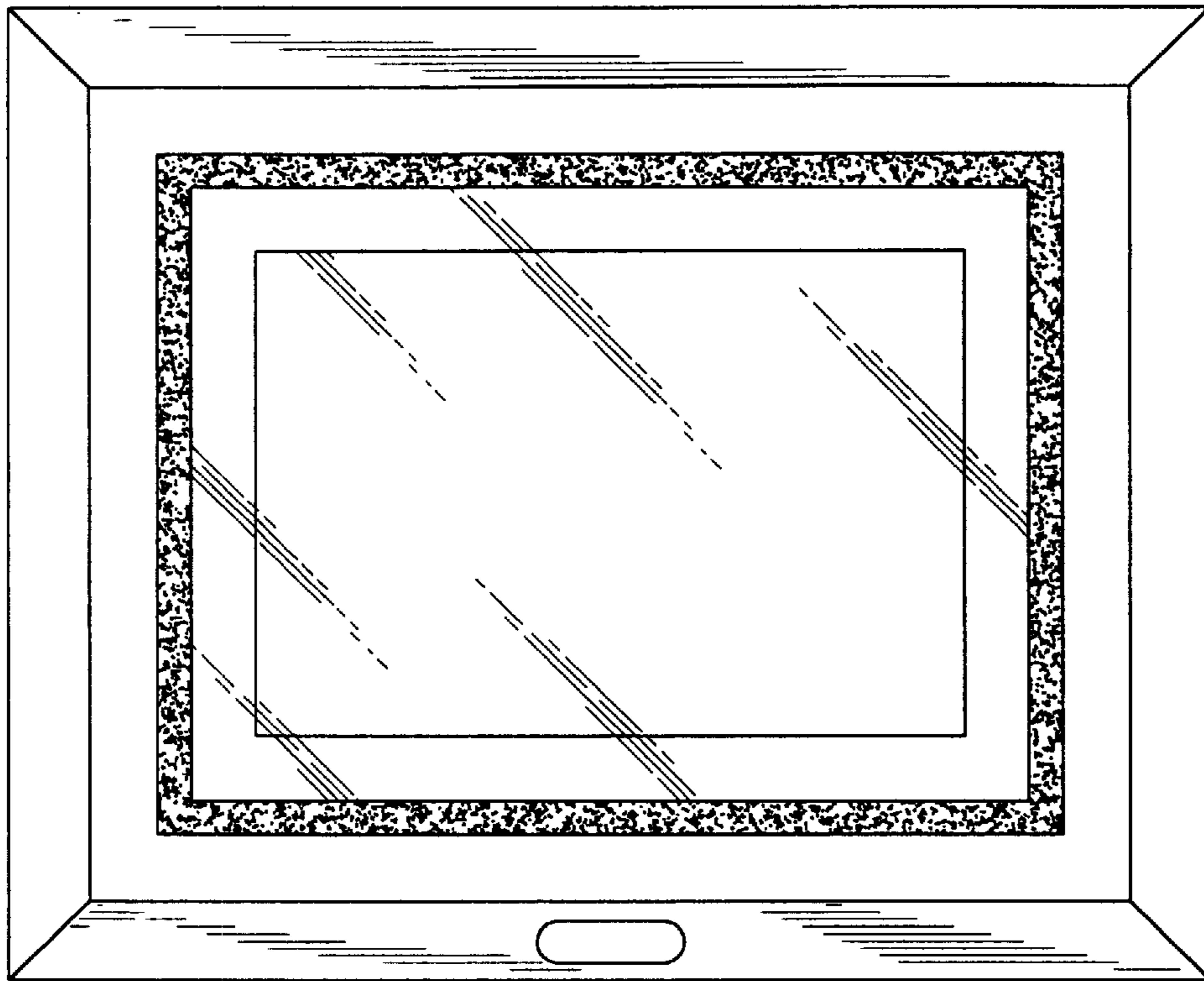
