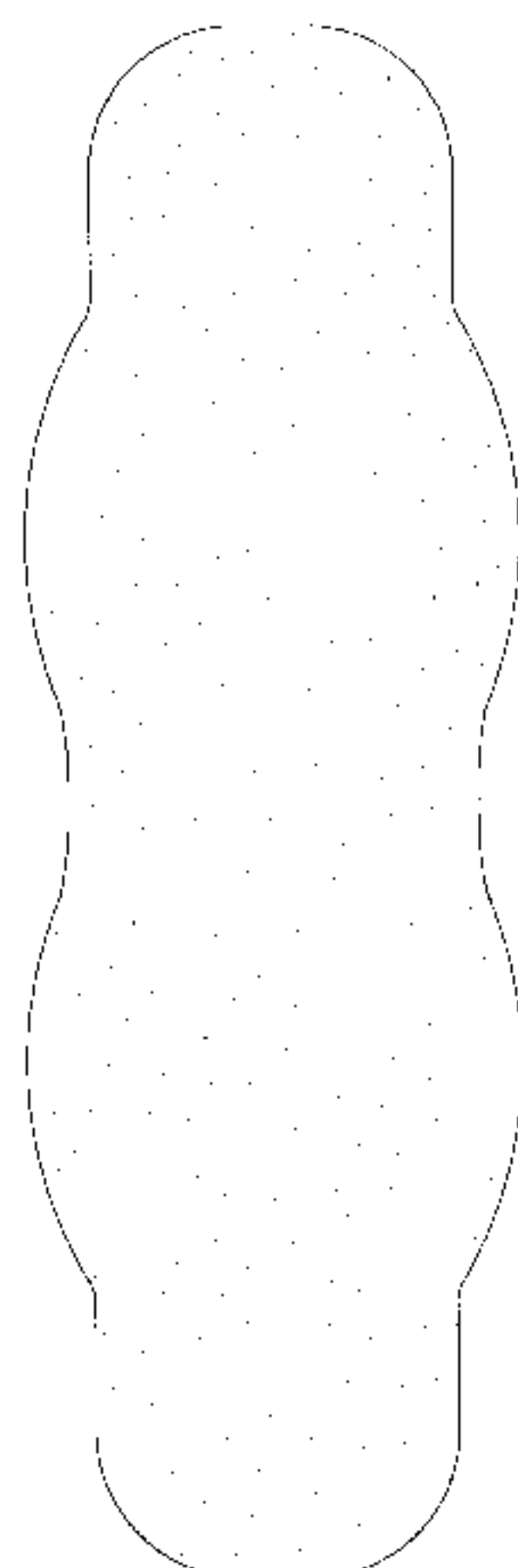
(57) **CLAIM**

The ornamental design for a multipurpose wrap, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a multipurpose wrap, embodying our new design; the back view thereof being a mirror image; FIG. 2 is a side elevational view thereof, the opposite side elevational view thereof being a mirror image; and, FIG. 3 is a bottom view thereof; the top view thereof being a mirror image.

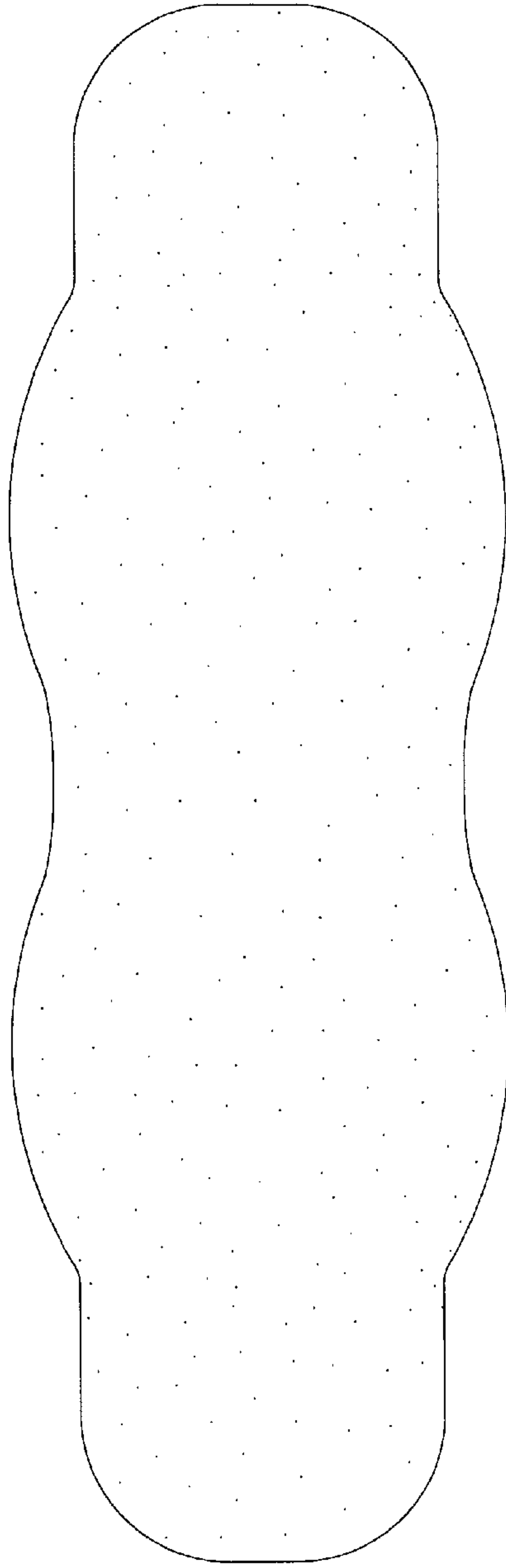

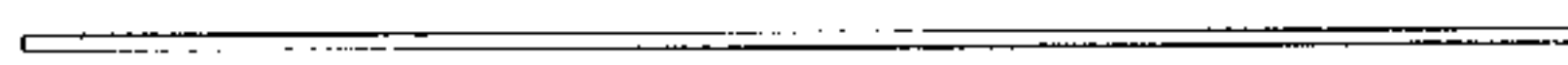
