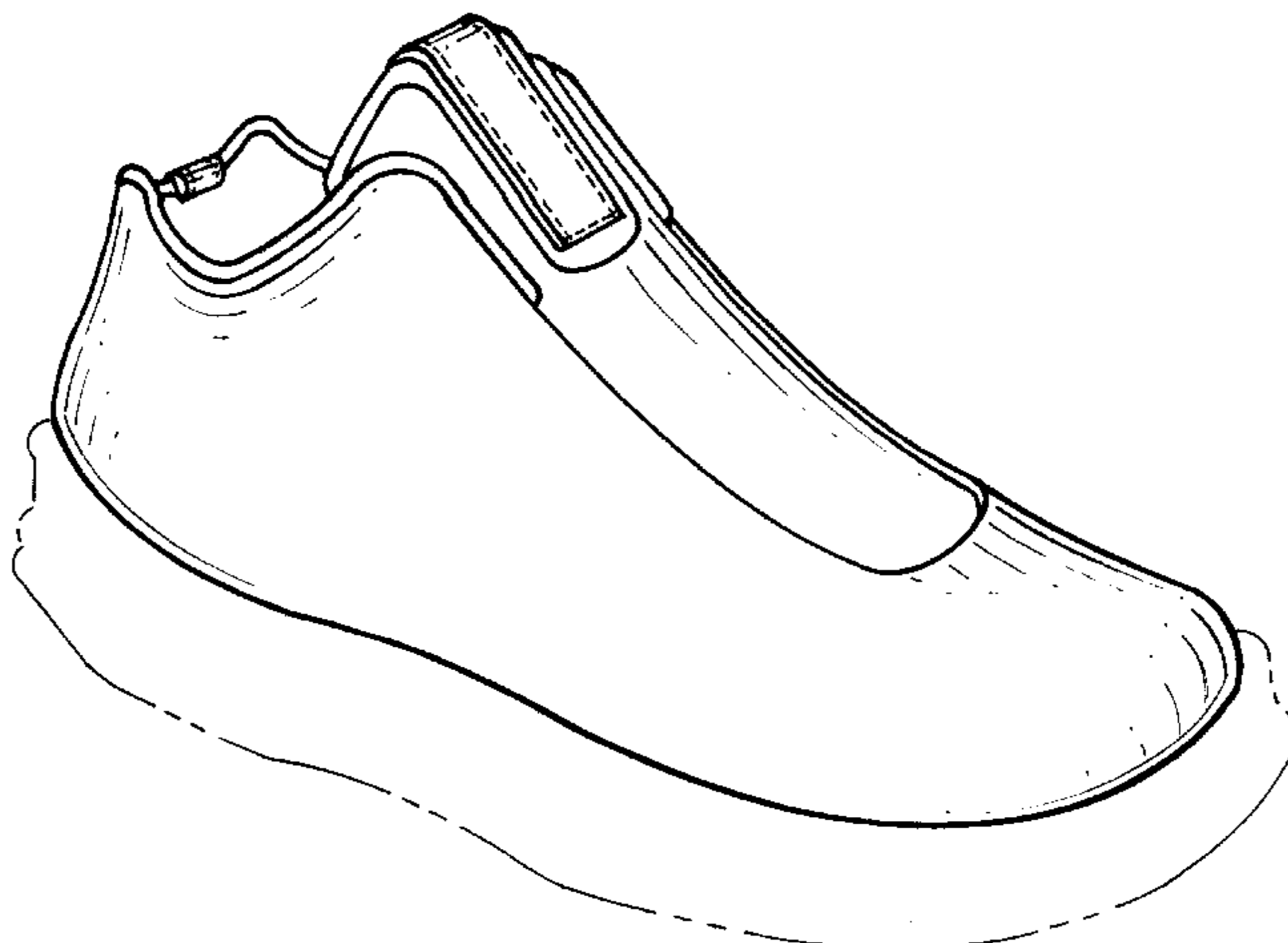
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the front of the shoe upper showing my new design;  
FIG. 2 is a rear perspective view thereof;  
FIG. 3 is a left side elevational view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a front elevational view; and,  
FIG. 7 is a rear elevational view.

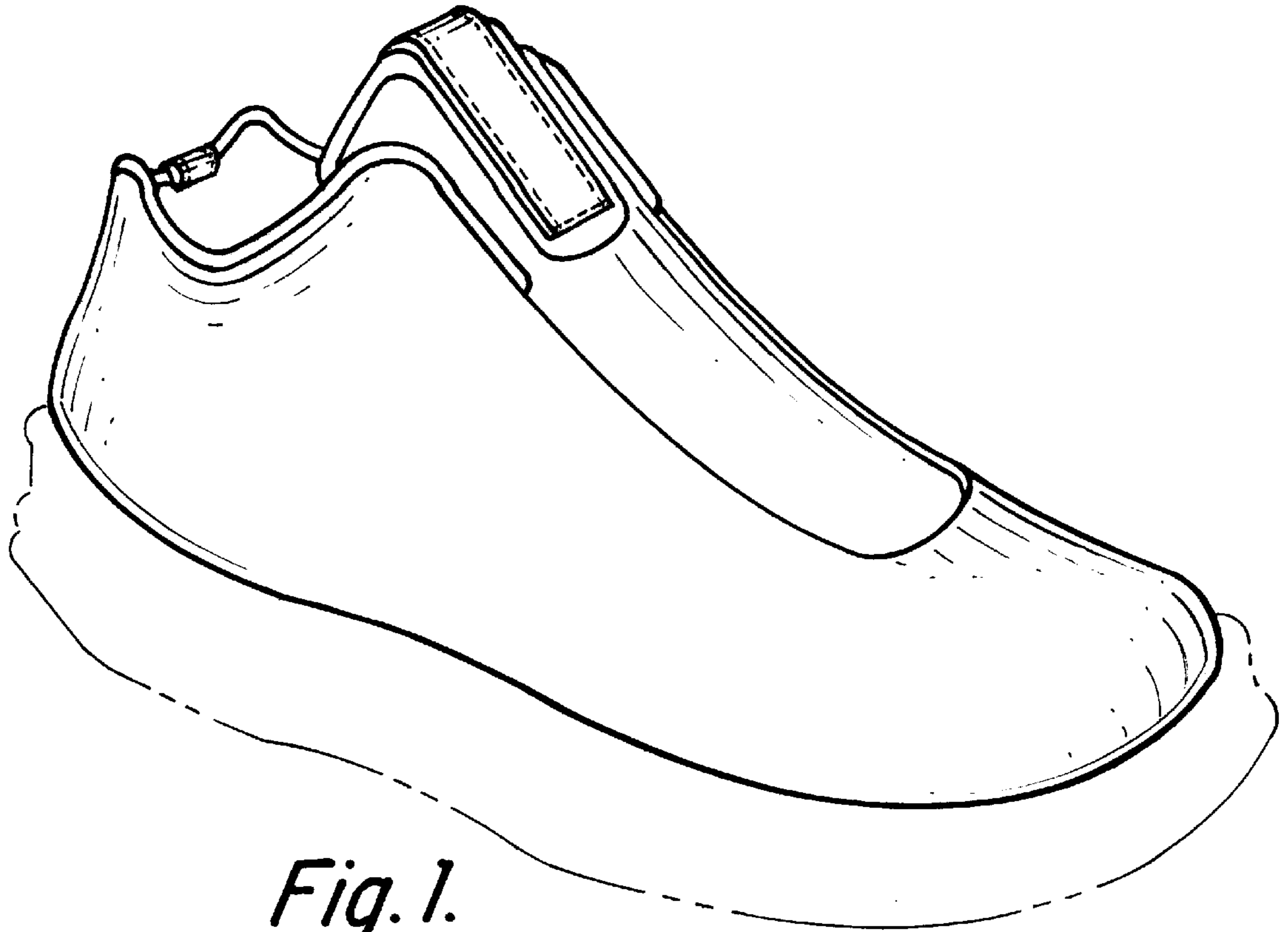

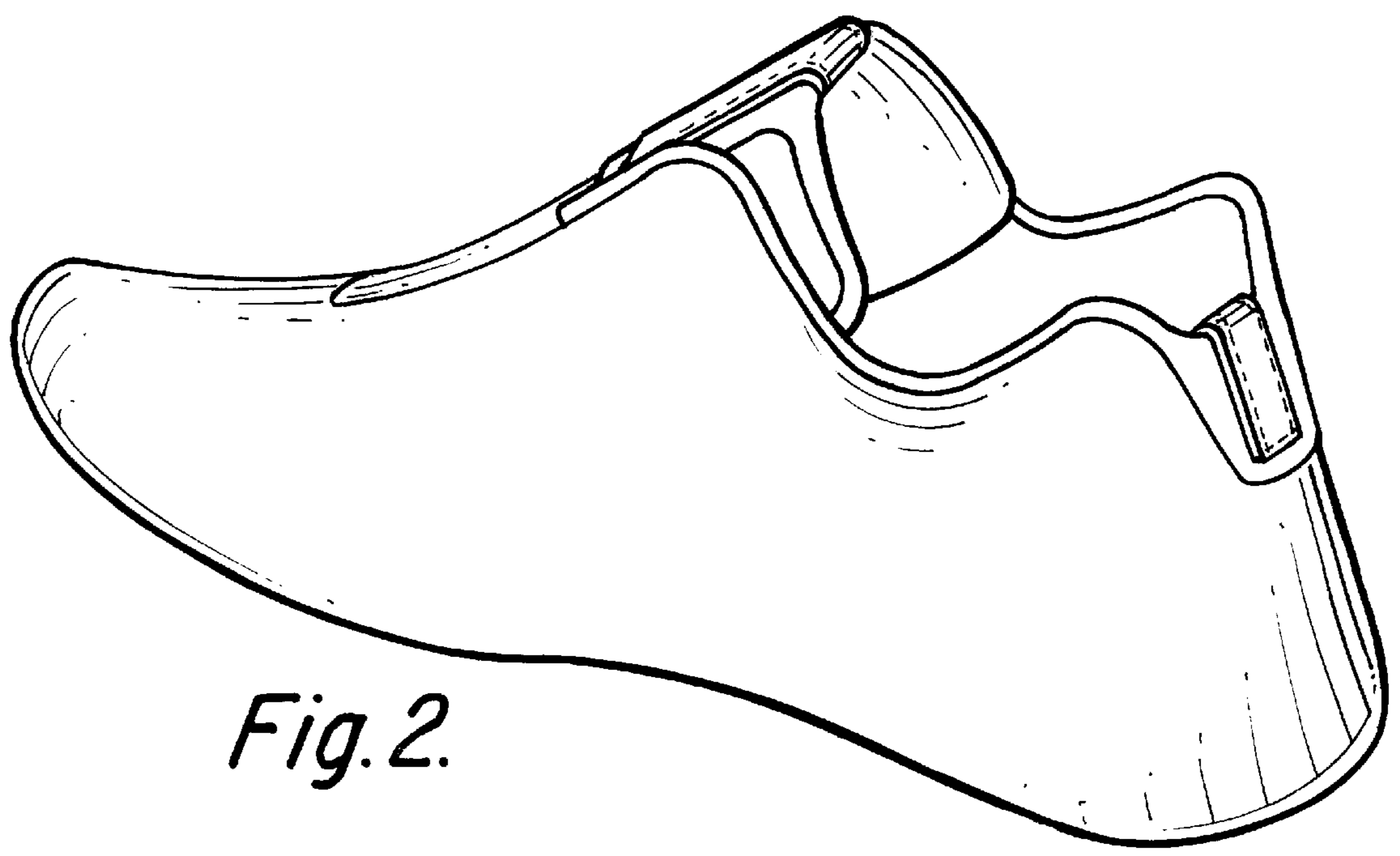

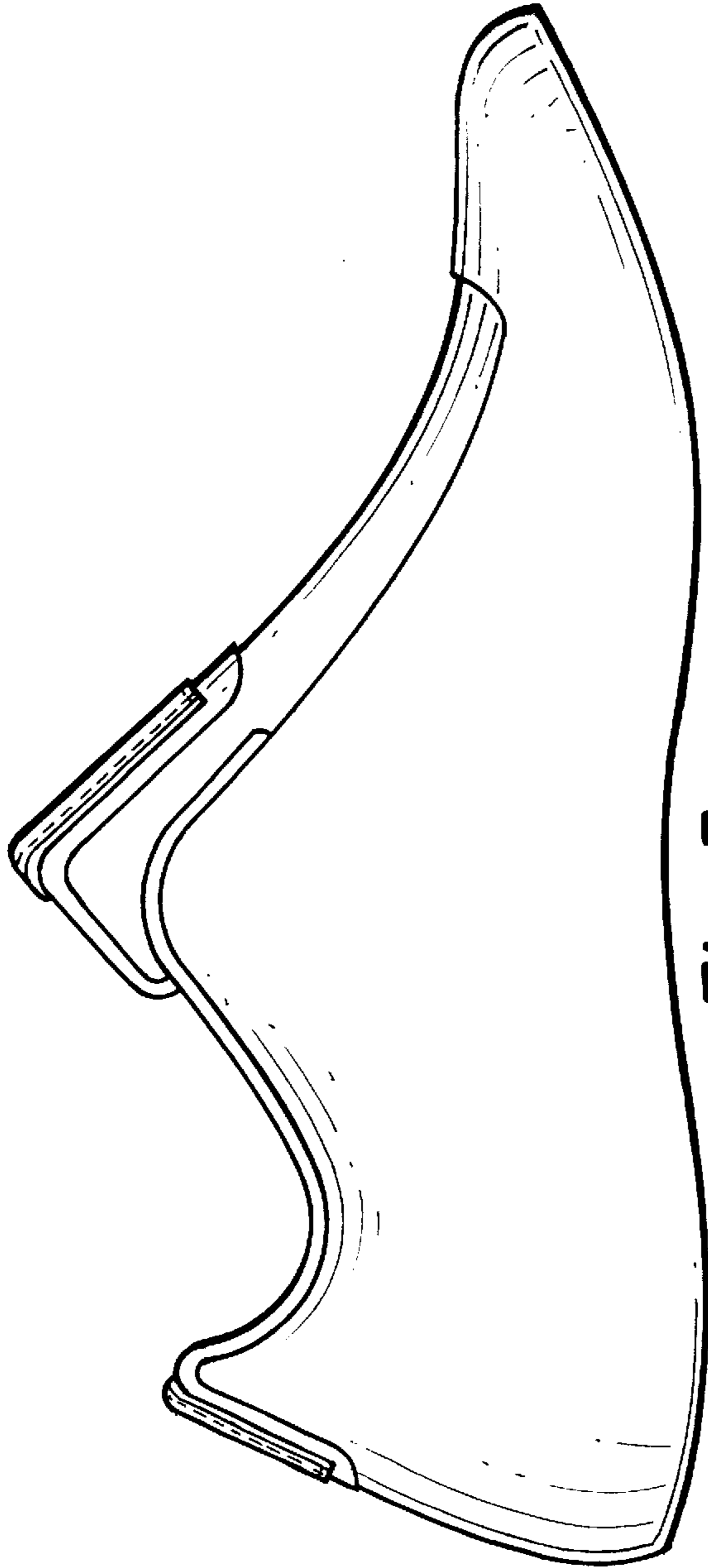

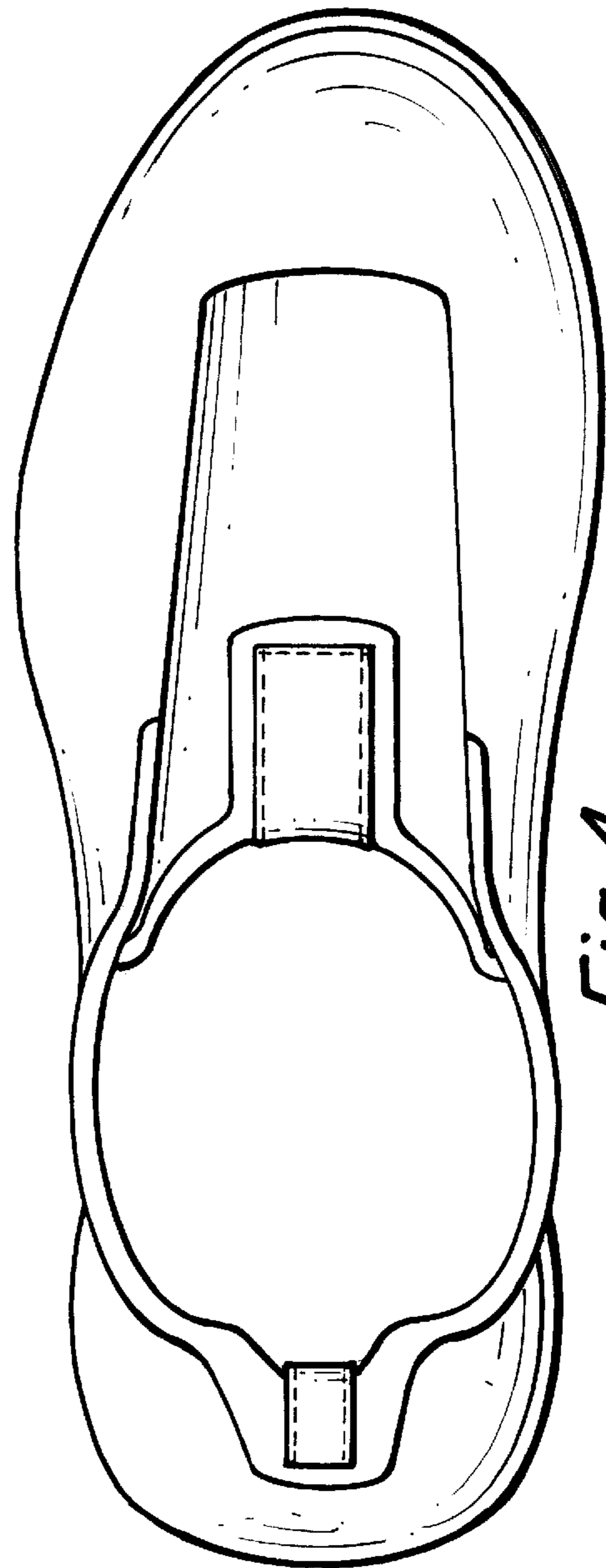

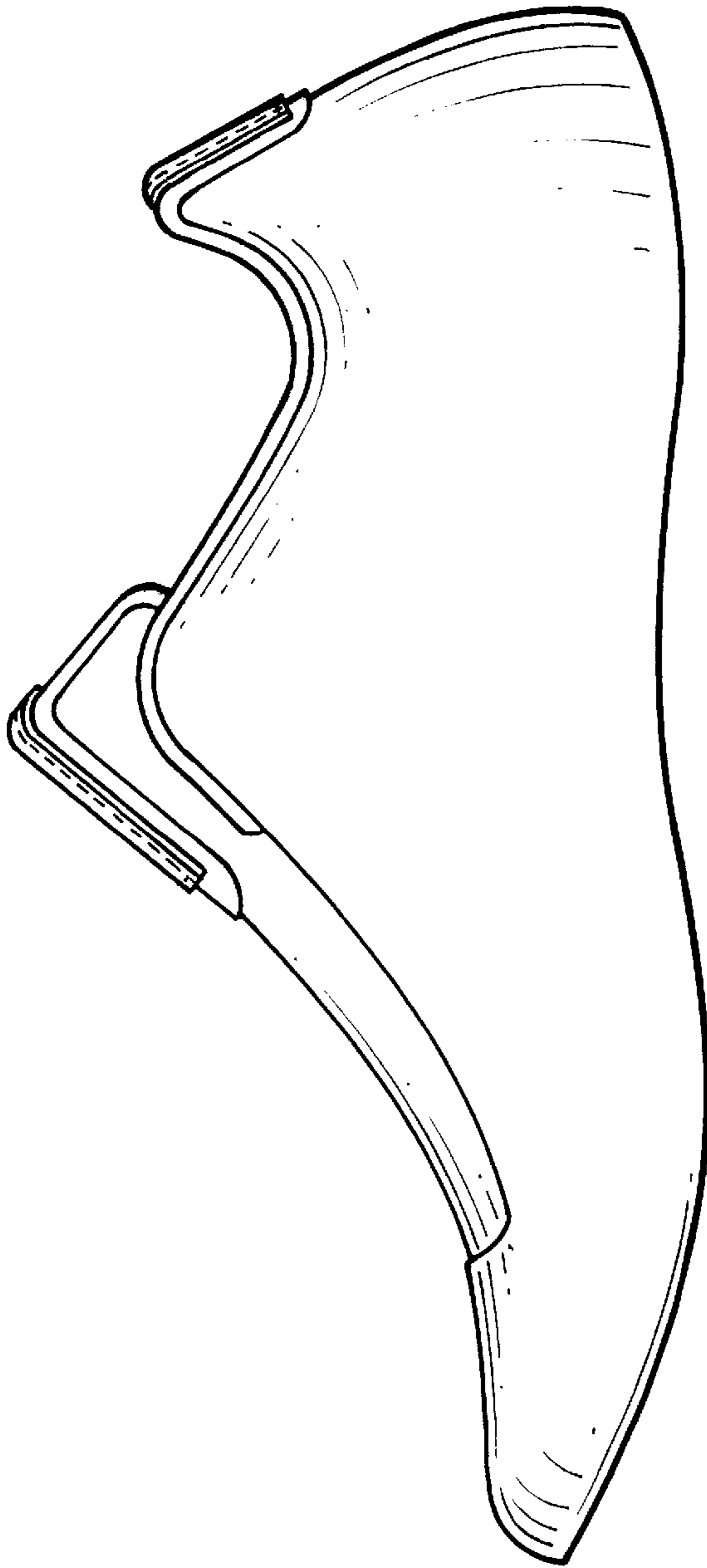

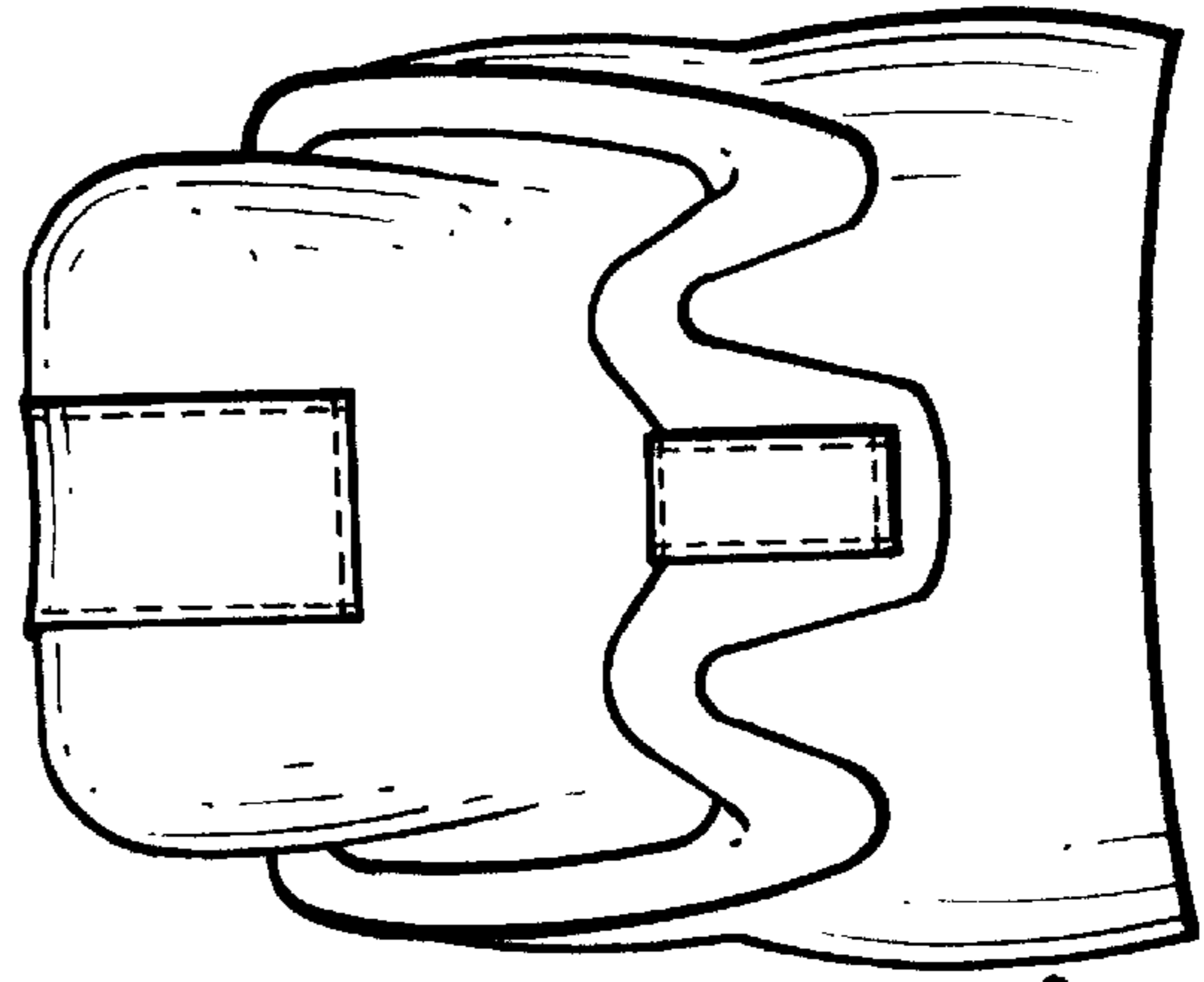

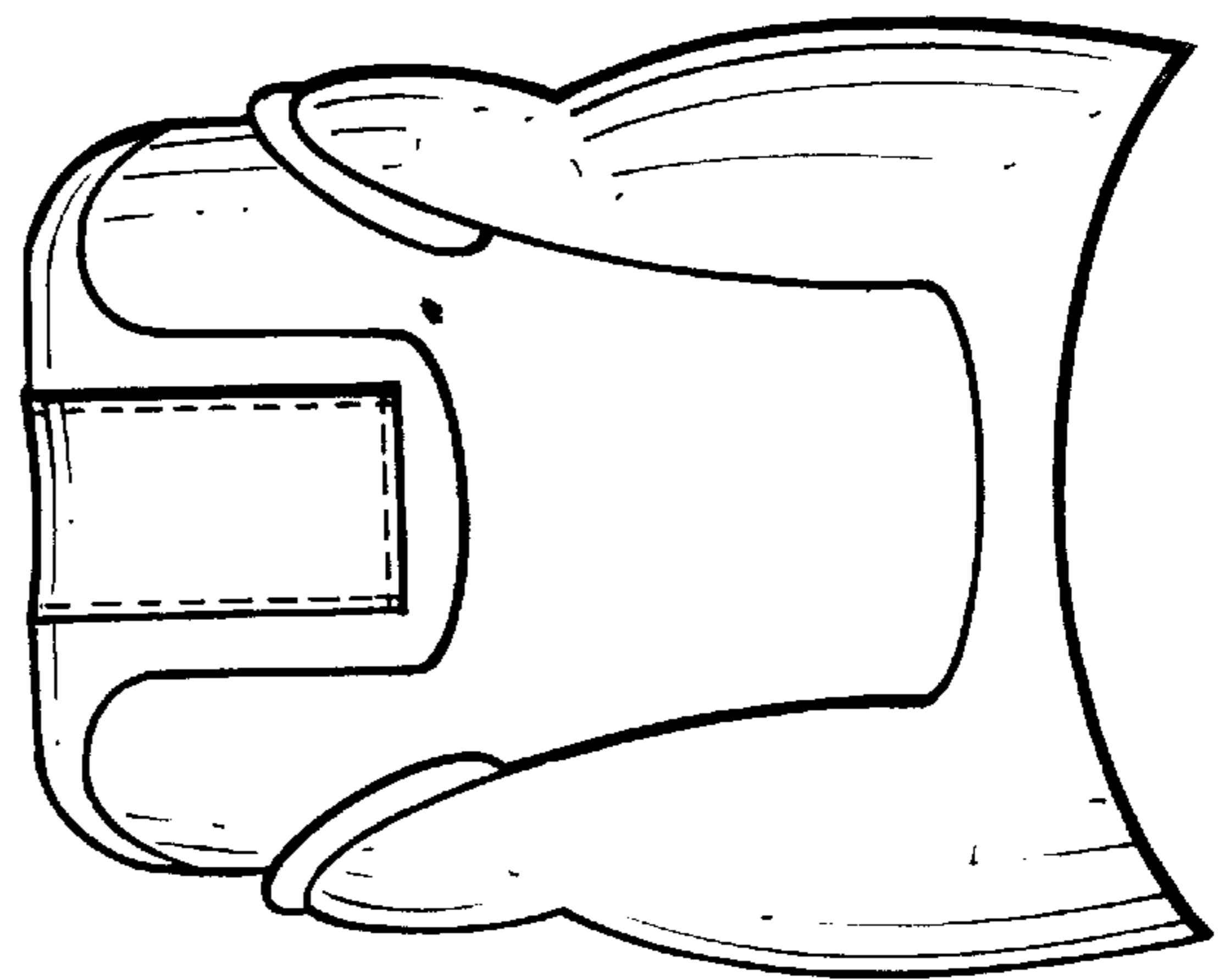
