We claim the ornamental design for a portion of a seat, as shown and described.

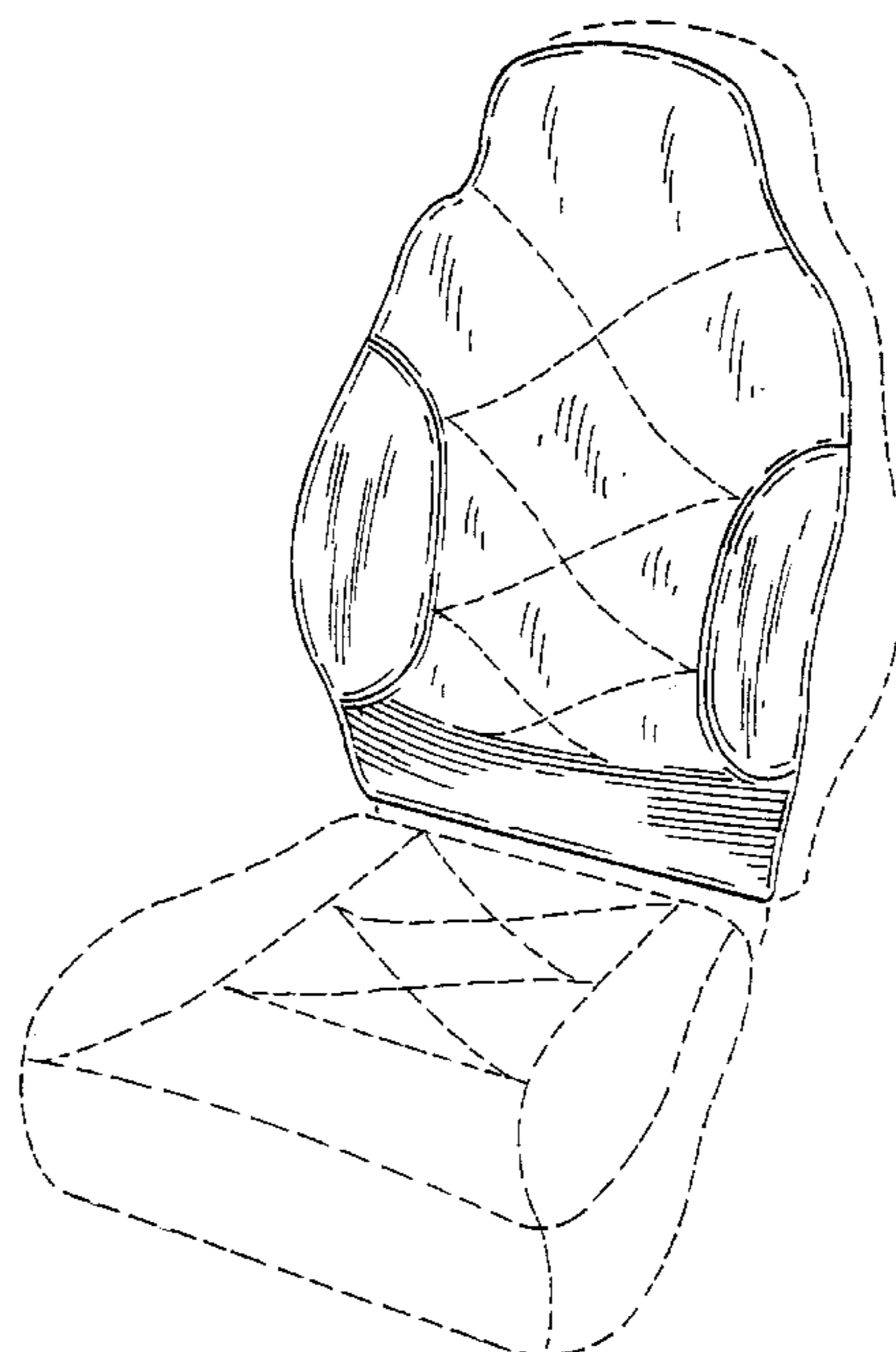
**DESCRIPTION**

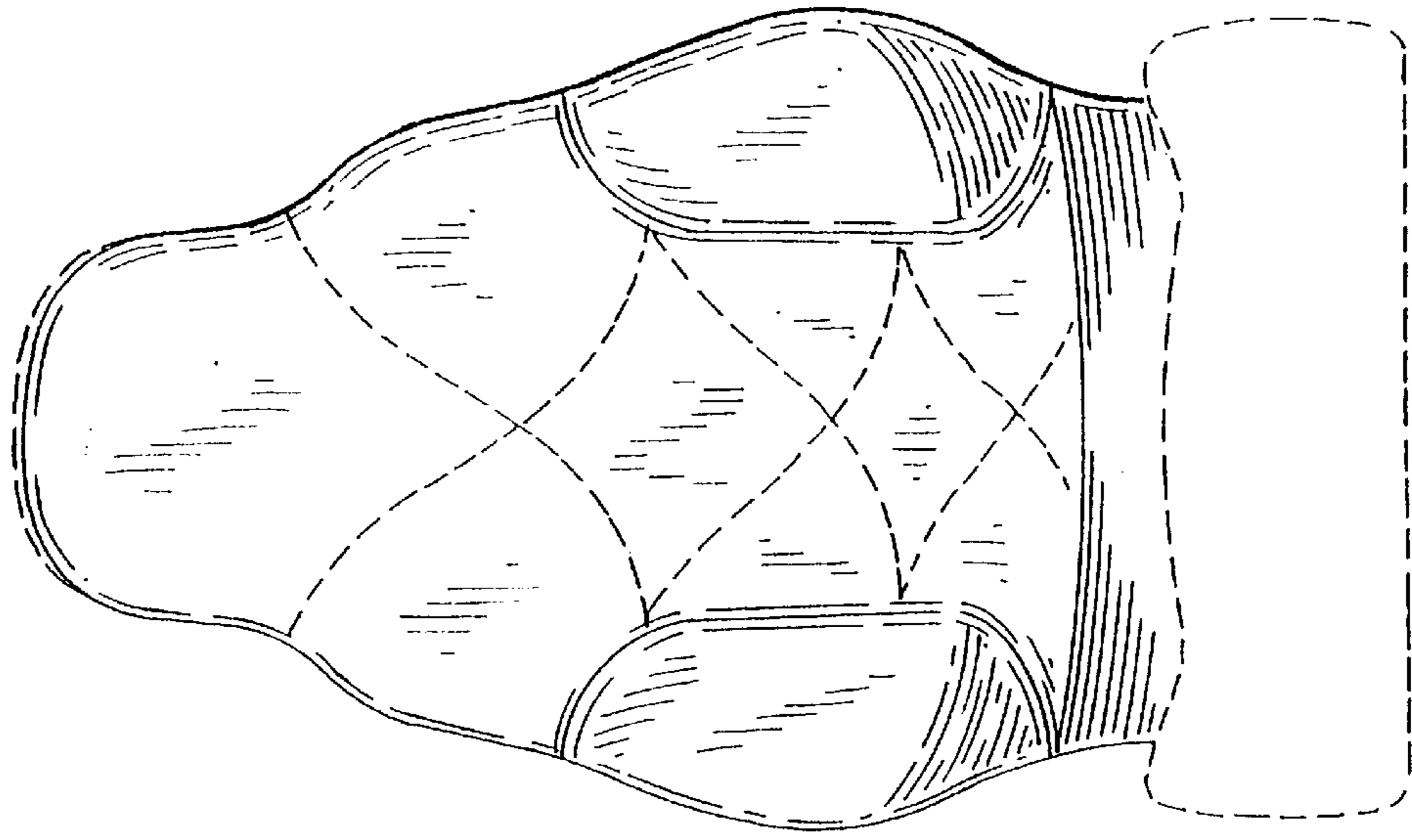
FIG. 1 is a perspective view of the ornamental design of a portion of a seat; and,

FIG. 2 is a front view of the portion of a seat.

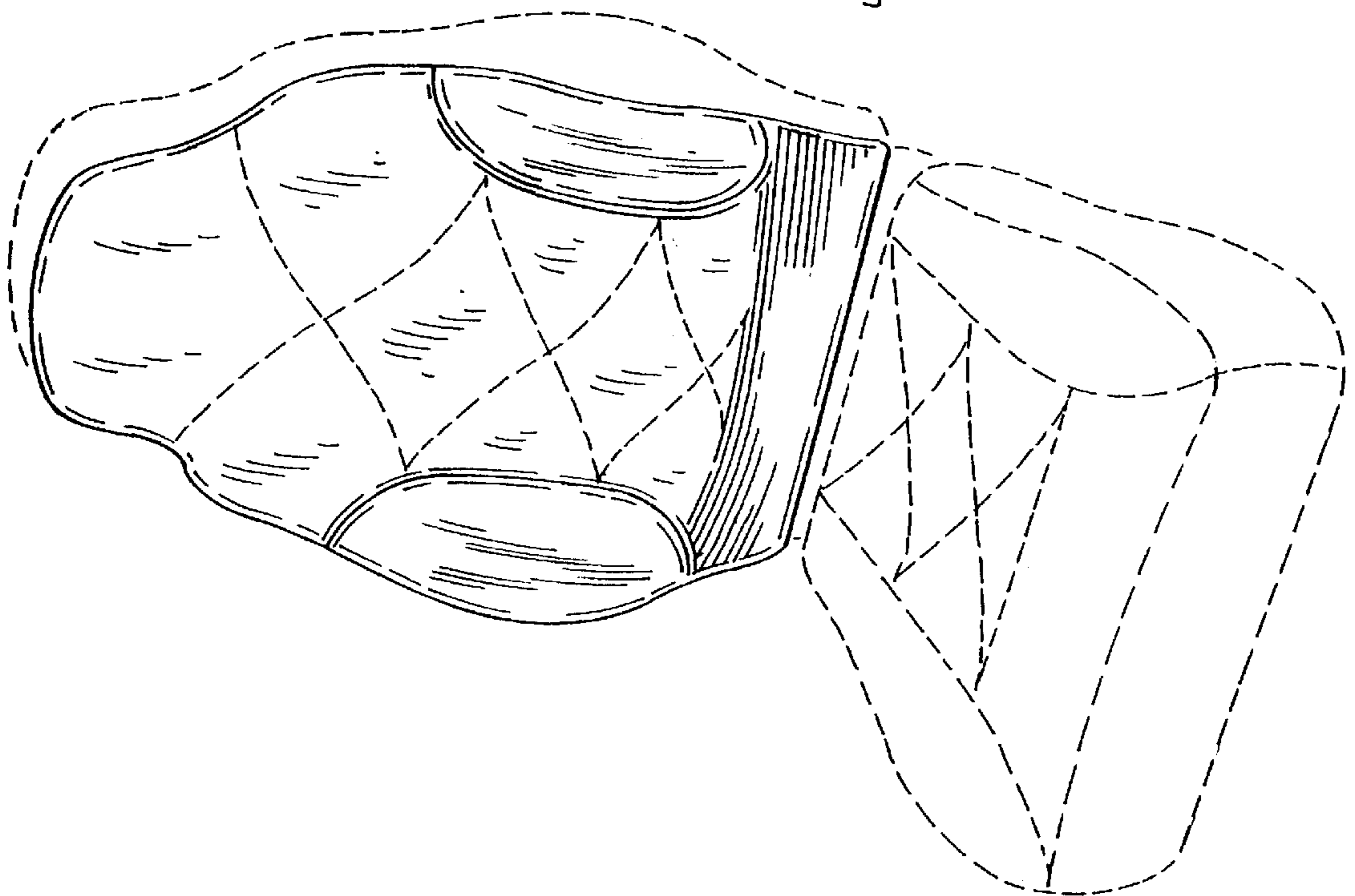
