(57) **CLAIM**

I claim the ornamental design for the water pitcher with lid, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a water pitcher with lid showing my new design;
 FIG. 2 is a front elevational view thereof;
 FIG. 3 is a rear elevational view thereof;
 FIG. 4 is a right side elevational view thereof, the opposite side being a mirror image thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof; and,
 FIG. 7 is a cross-sectional view thereof taken line 7—7 of FIG. 2.

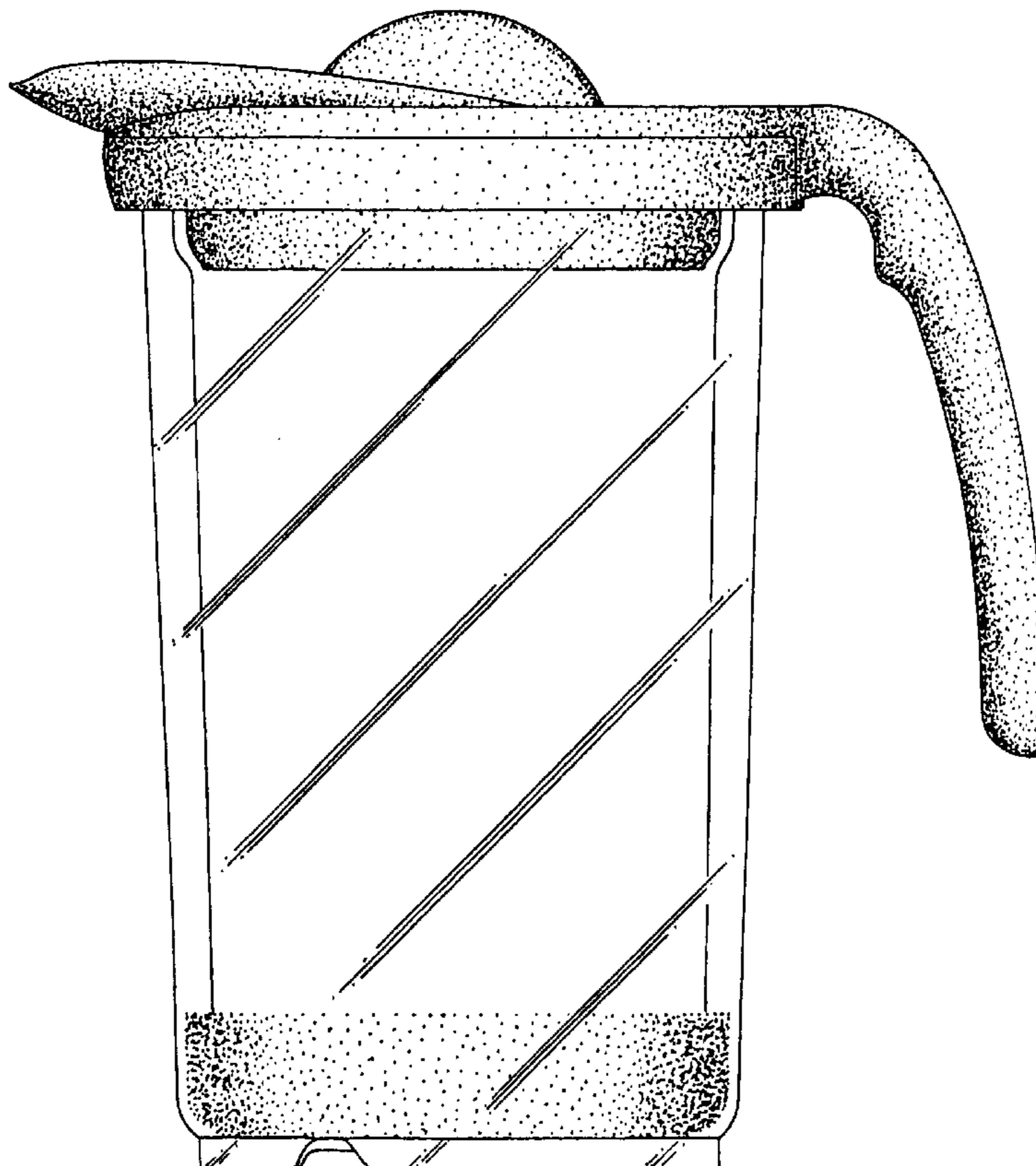

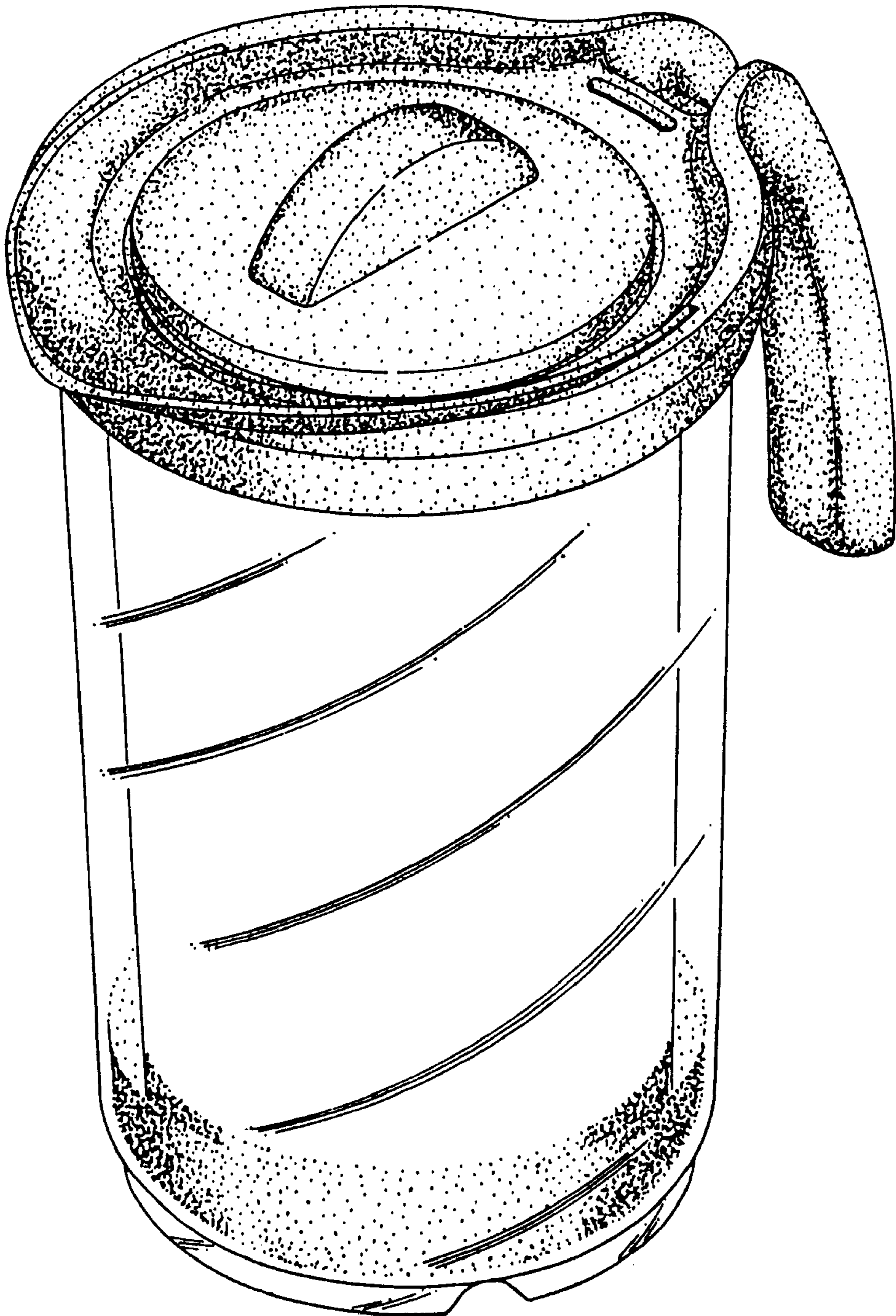

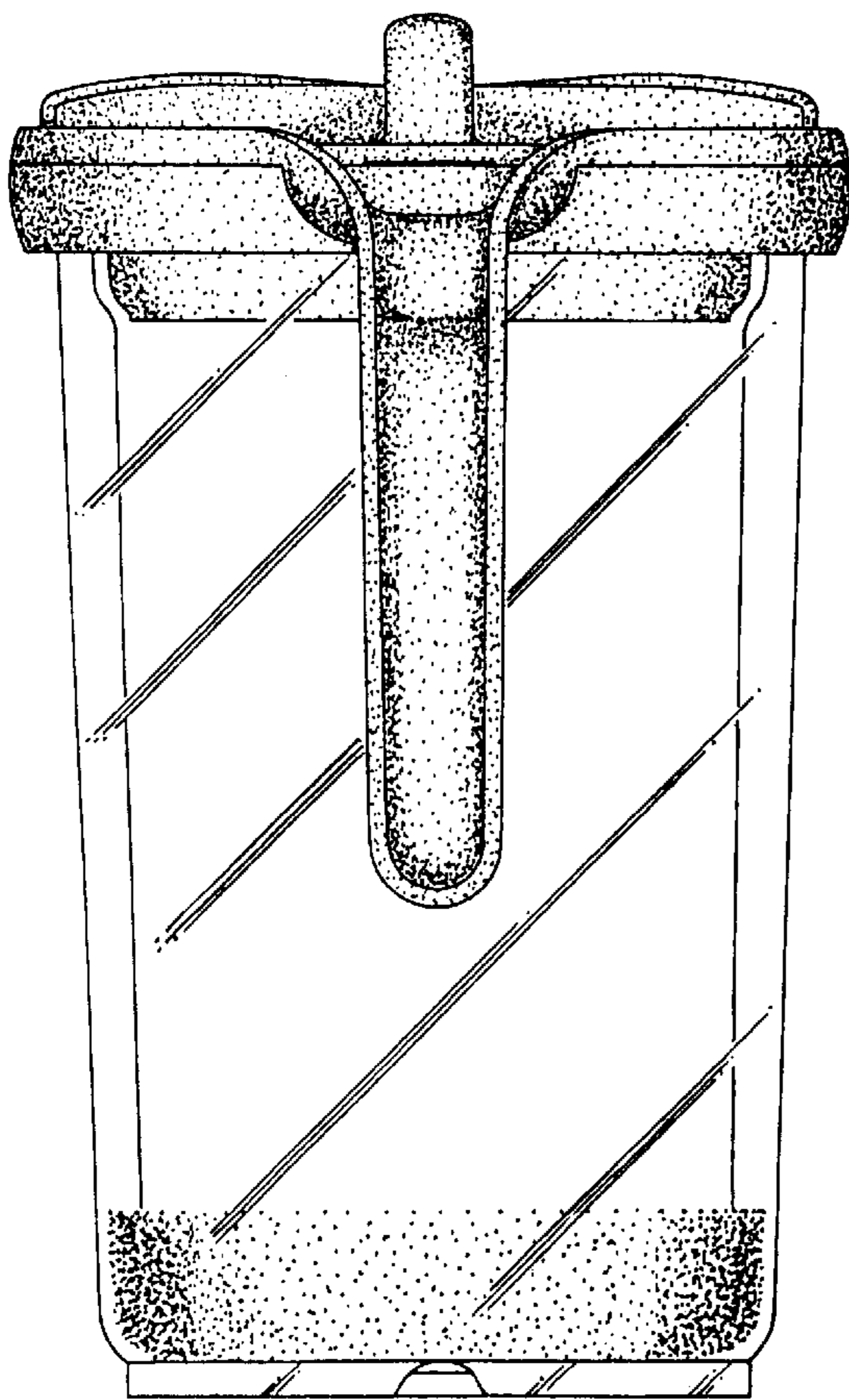

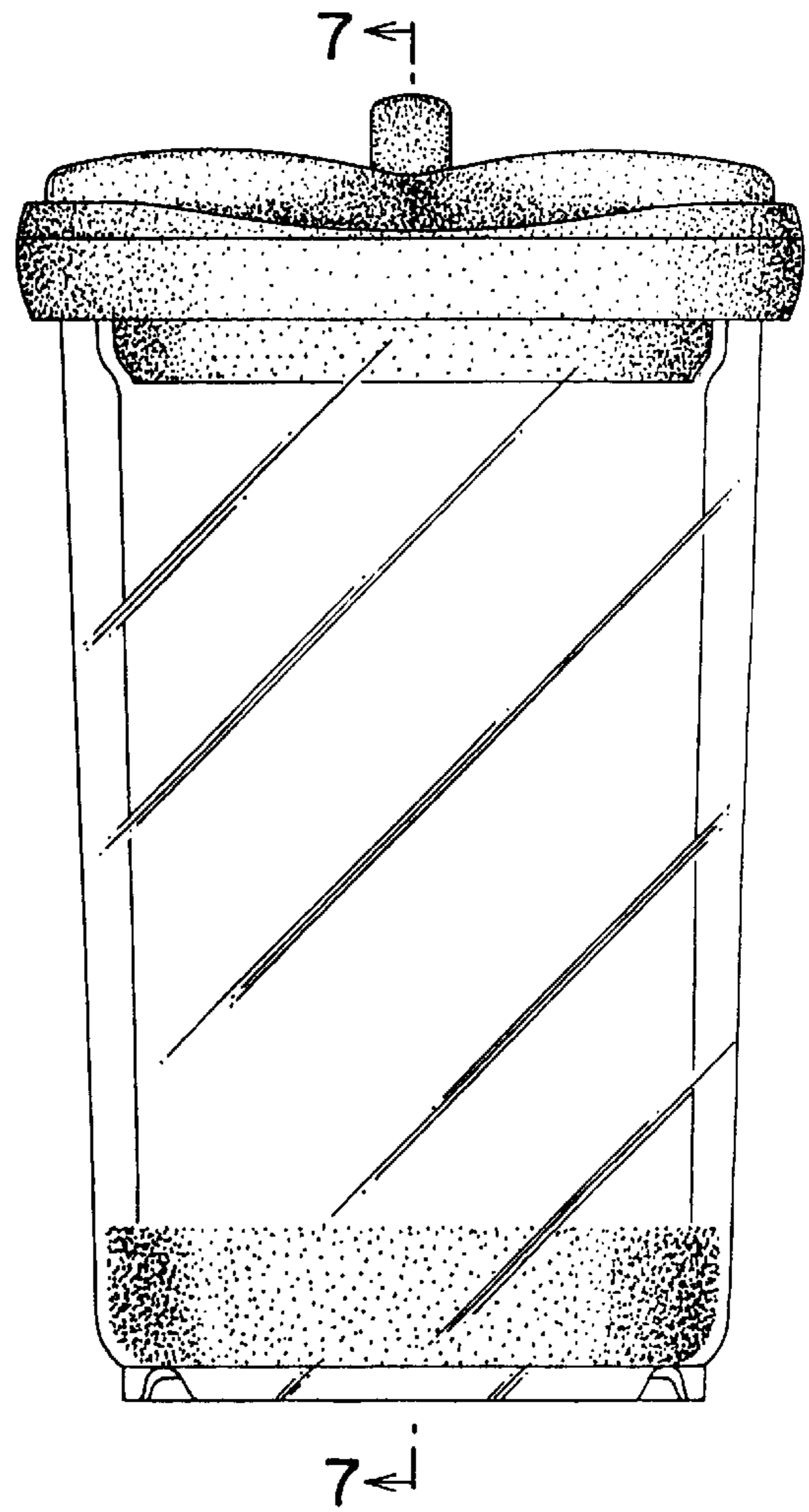

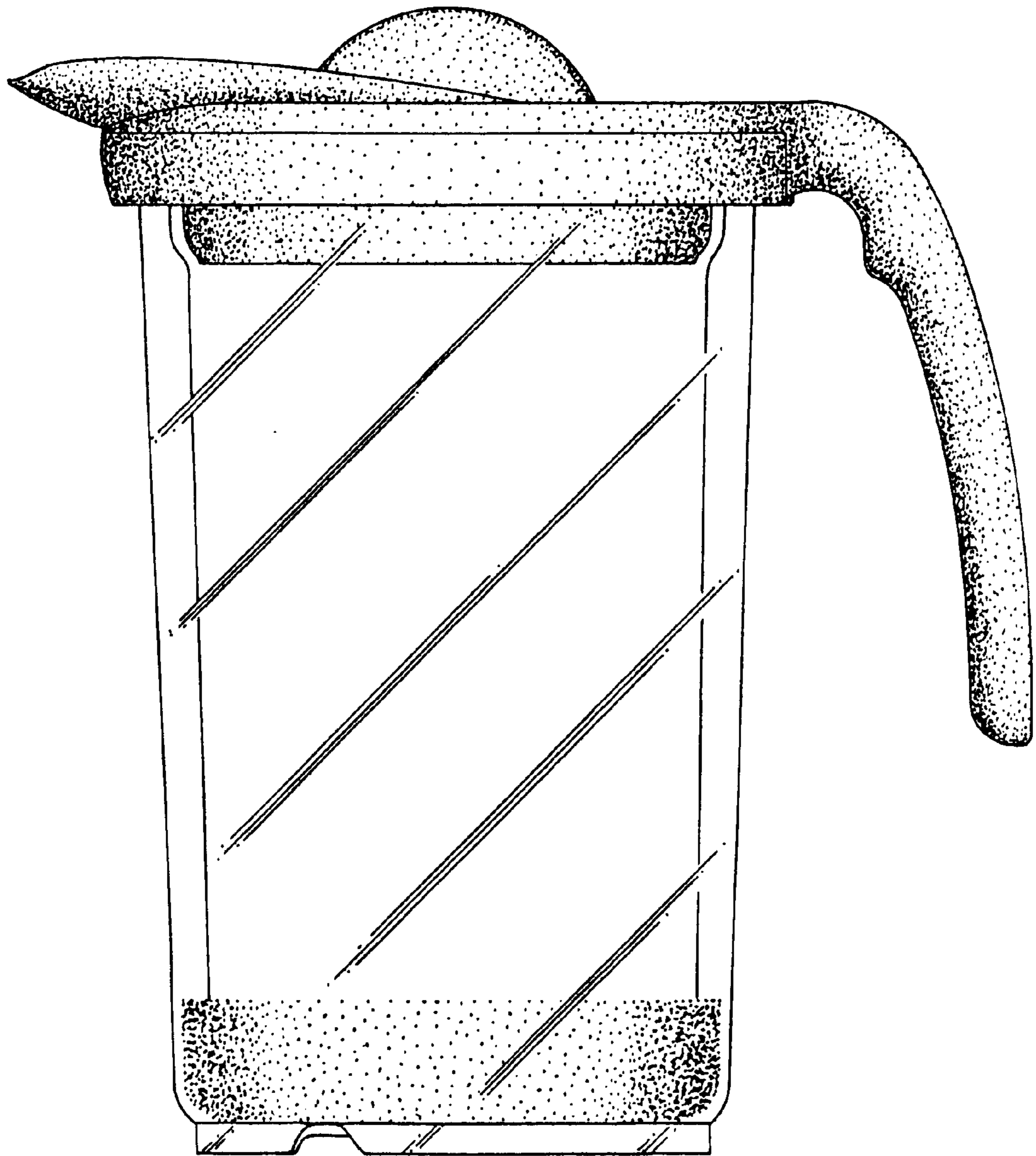

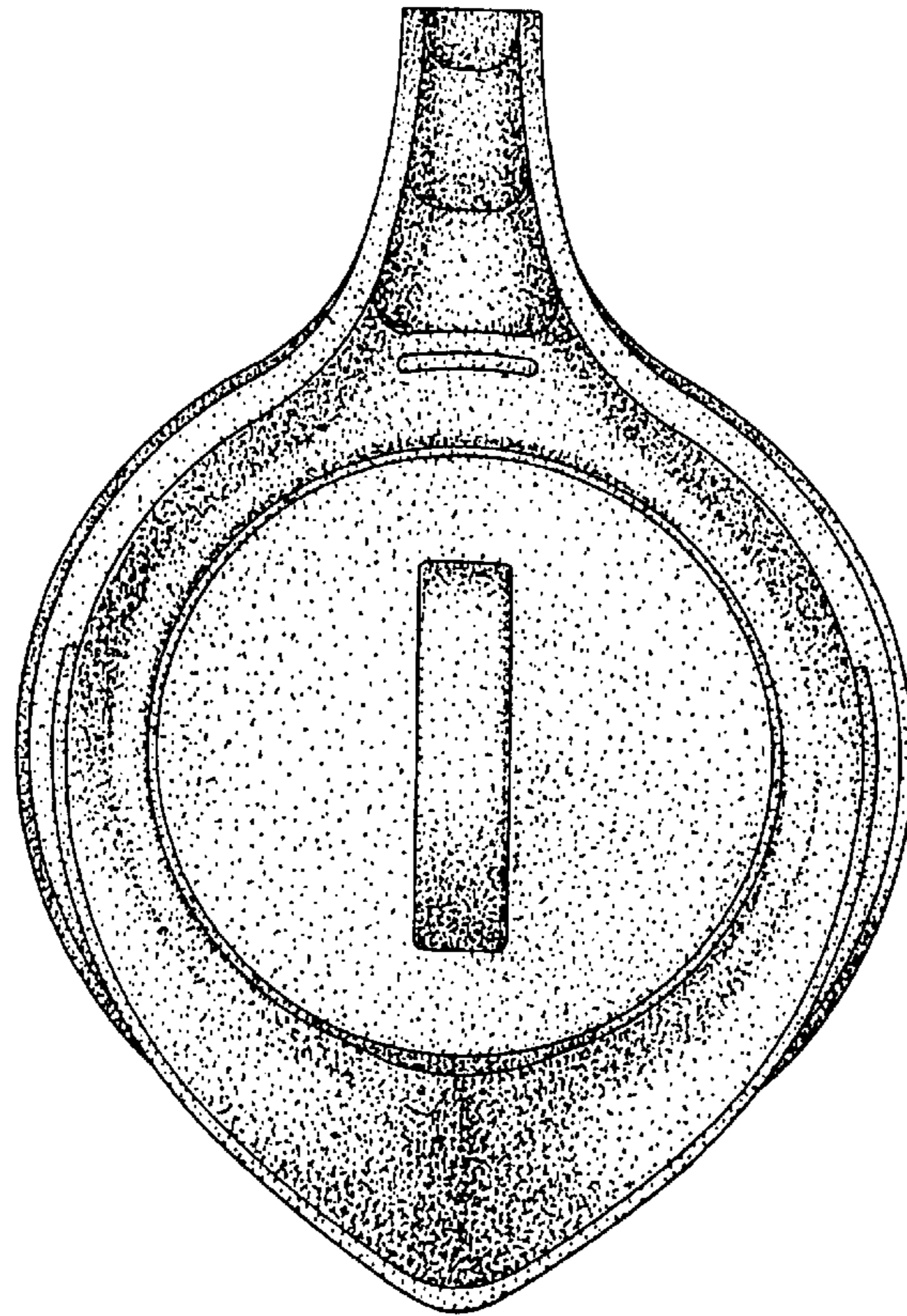

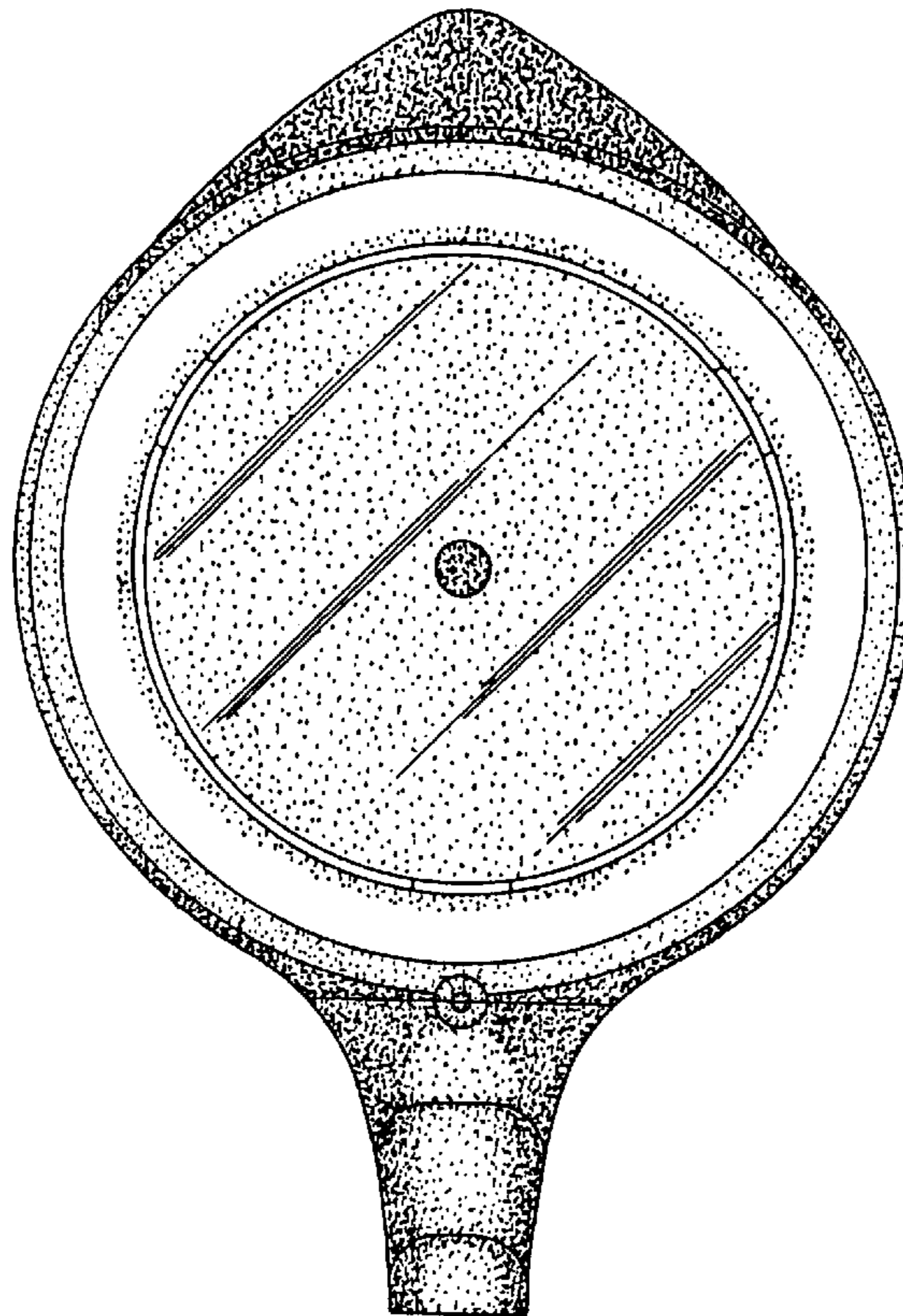
