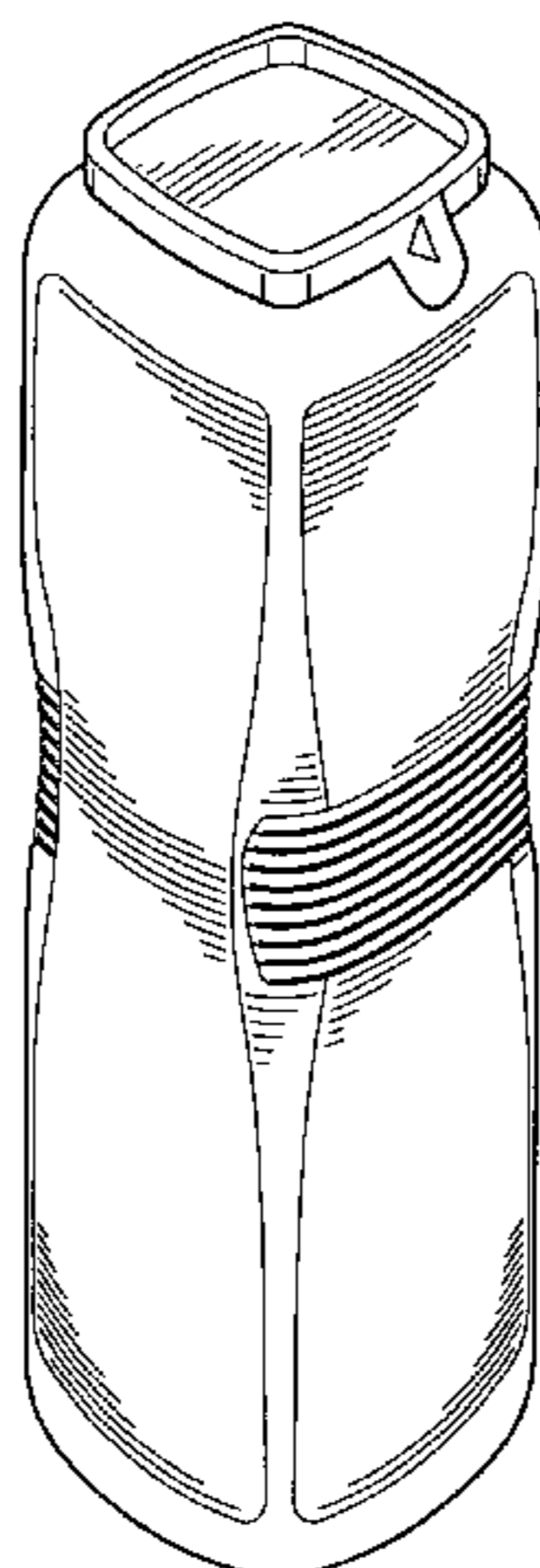
(57) **CLAIM**

The ornamental design for a consumables container, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the consumables container of the present invention;  
FIG. 2 is a side view in elevation of the consumables container of FIG. 1 as seen from the right-hand side of FIG. 1;  
FIG. 3 is a side view in elevation of the consumables container of FIG. 1 as seen from the front of FIG. 1, the back of FIG. 1 being a reverse mirror image of FIG. 3;  
FIG. 4 is a side view in elevation of the consumables container of FIG. 1 as seen from the left-hand side of FIG. 1;  
FIG. 5 is a top plan view in elevation of the consumables container of FIG. 1; and,  
FIG. 6 is a bottom plan view in elevation of the consumables container of FIG. 1.

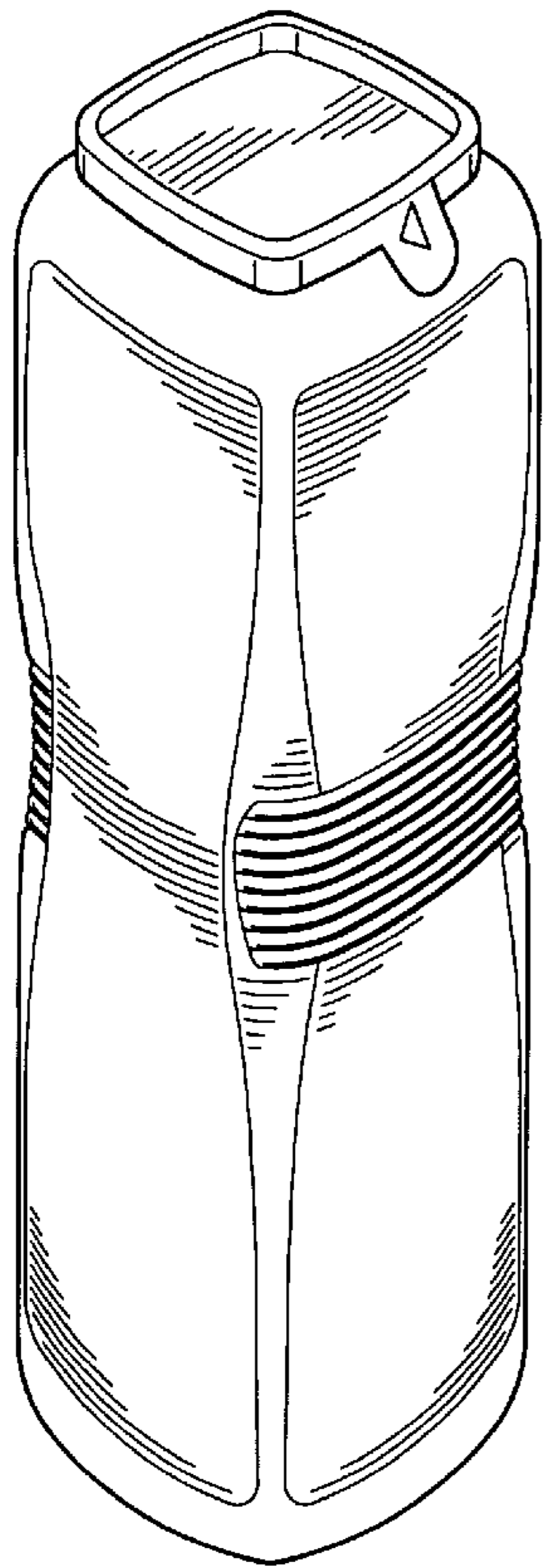

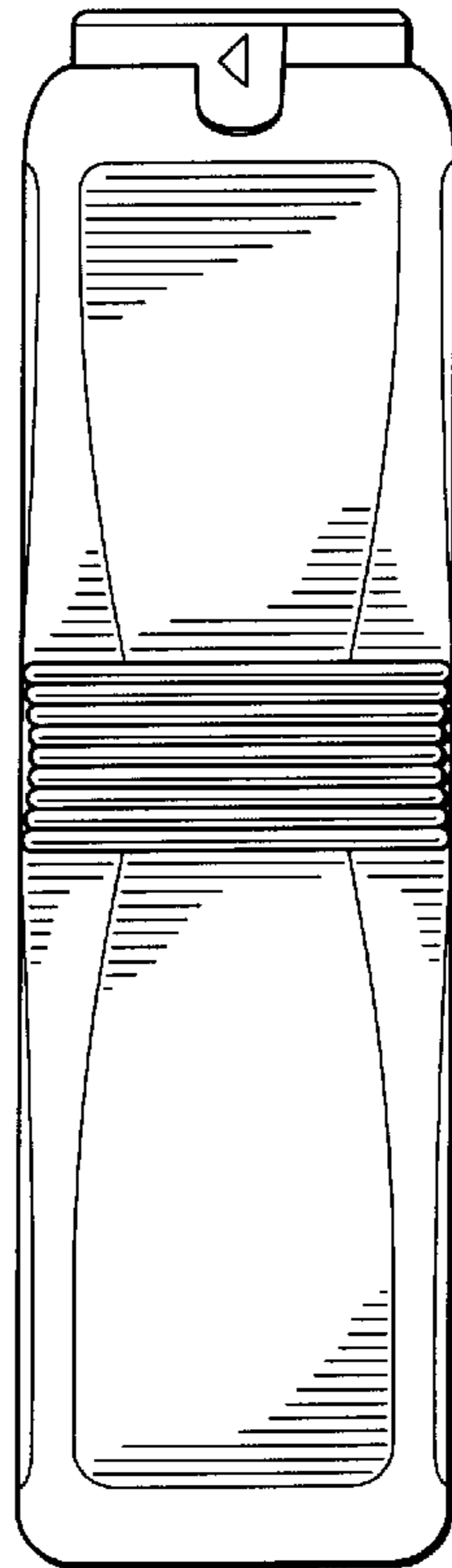

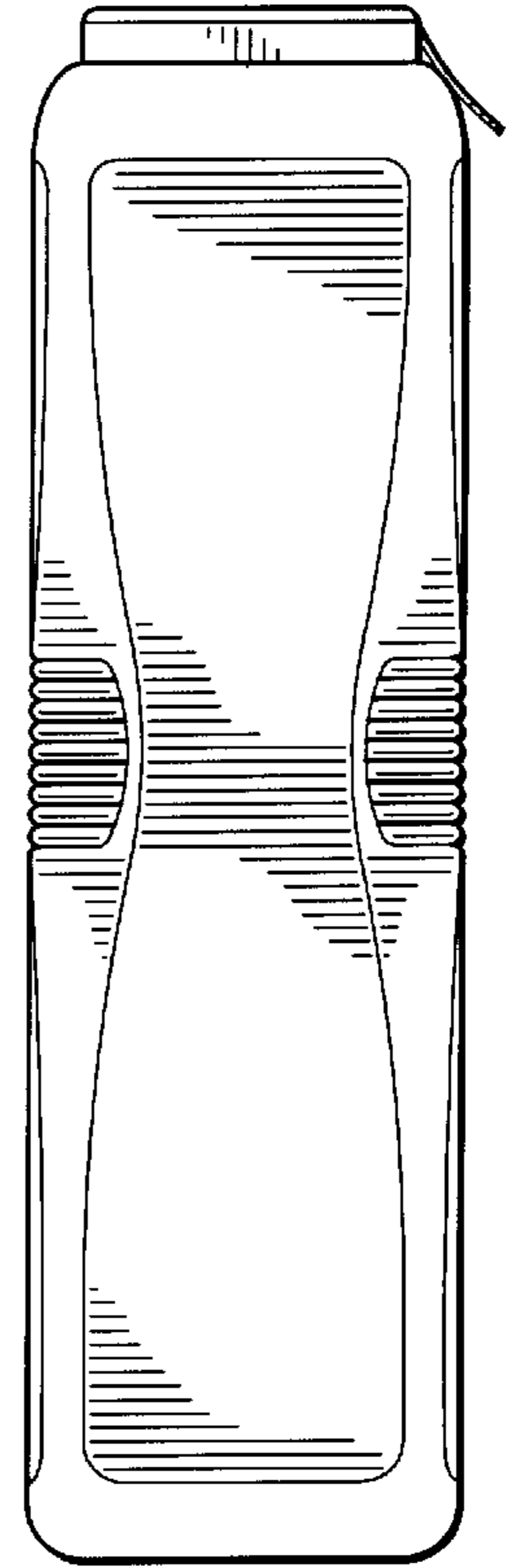

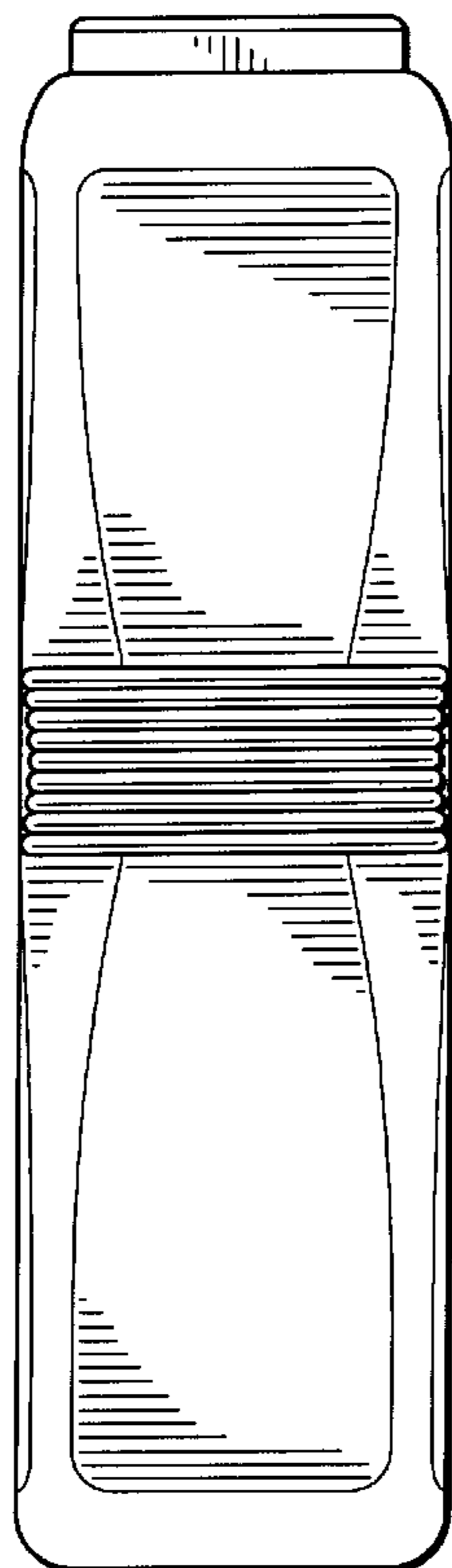

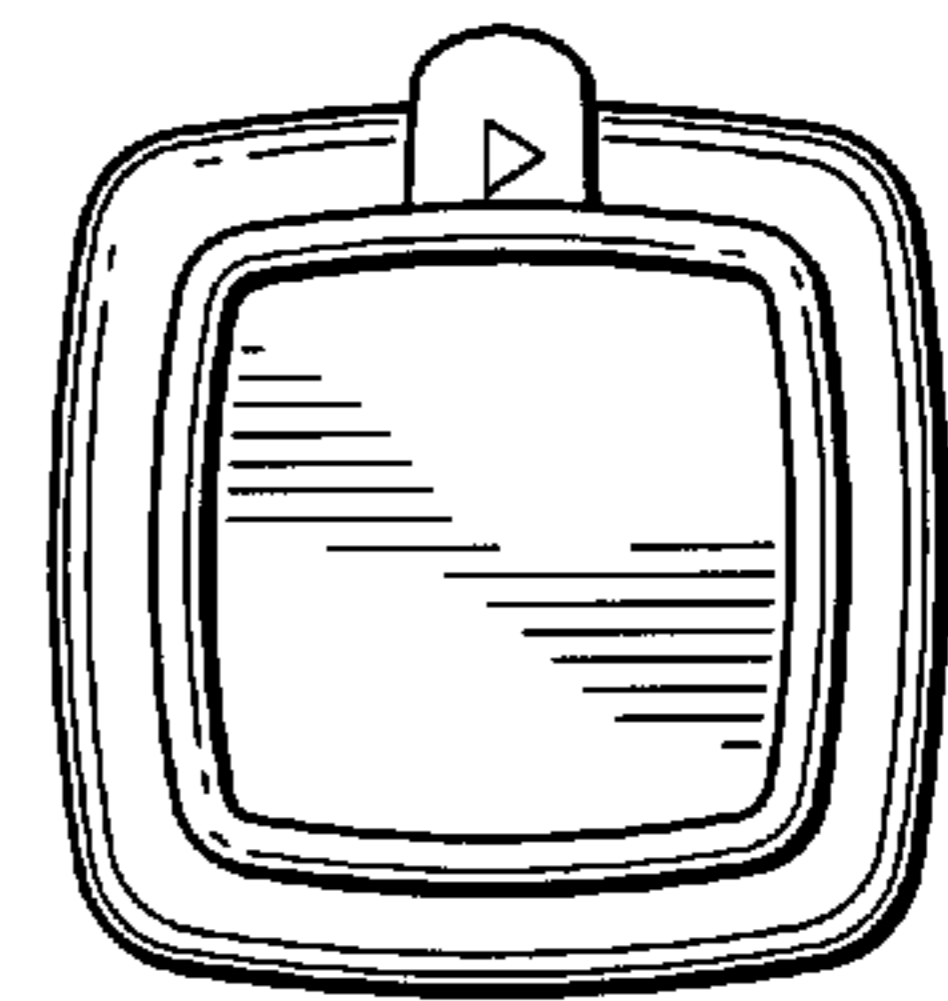

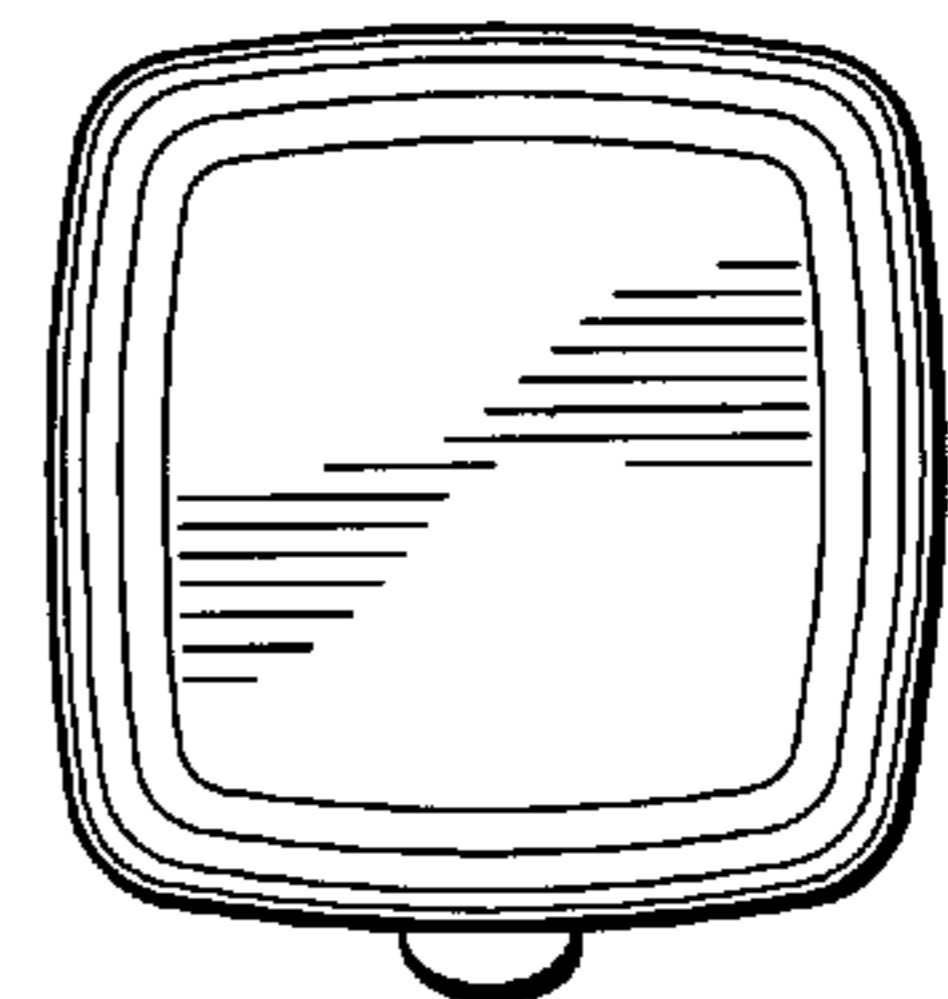


