The ornamental design for an electrical cord connection, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an electrical cord connection showing my new design, the broken lines showing the electrical cord sections are for illustrative purposes only, and form no part of the claimed design;

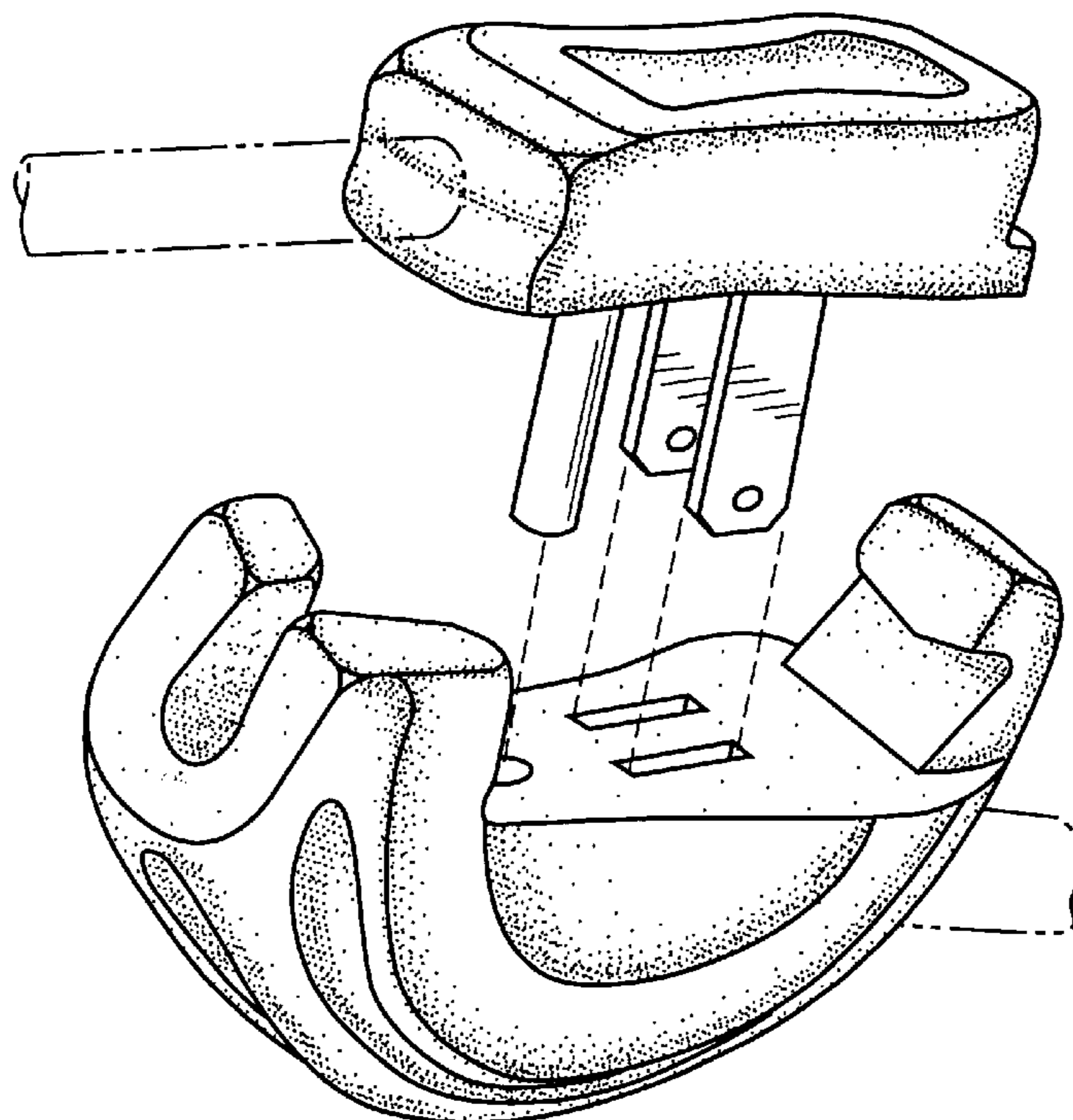
FIG. 3 is a rear view thereof, the broken lines showing the electrical cord are for illustrative purposes only, and form no part of the claimed design;

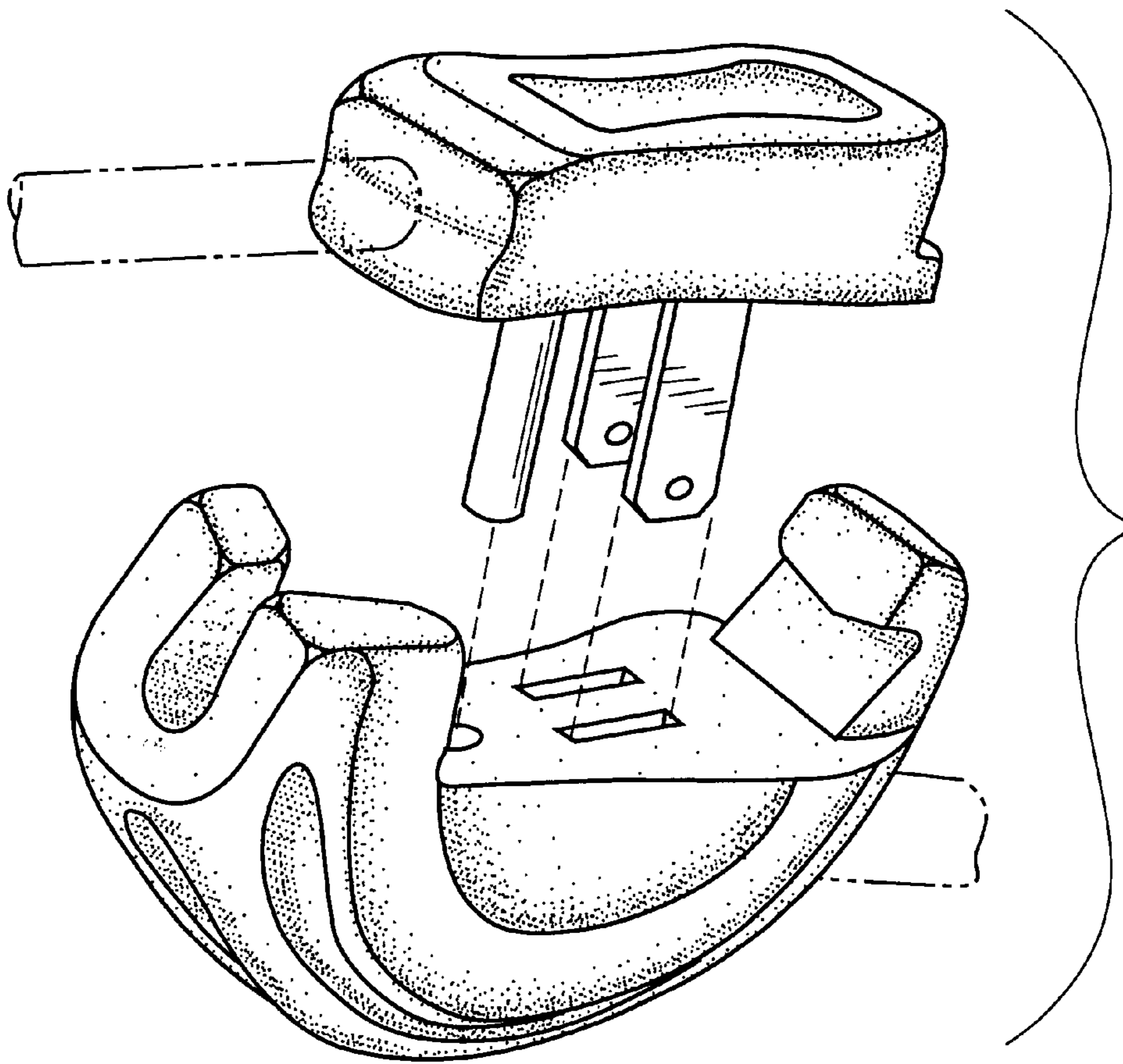
FIG. 4 is a front view thereof, the broken lines showing the electrical cord are for illustrative purposes only, and form no part of the claimed design;

FIG. 5 is a top view of my design, the broken lines showing the electrical cord sections are for illustrative purposes only, and form no part of the claimed design; and,

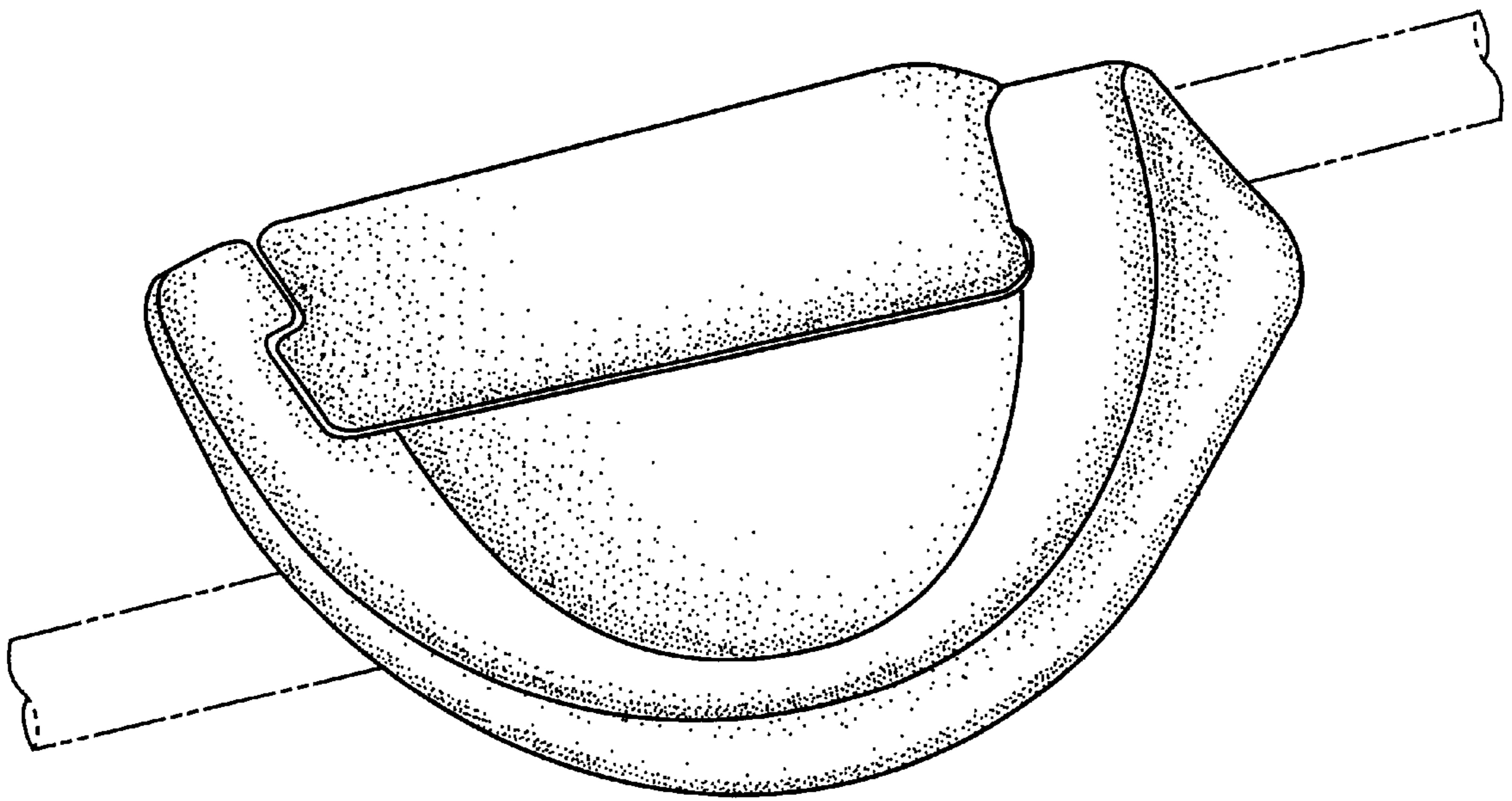
FIG. 6 is a bottom view of my design, the broken lines showing the electrical cord sections are for illustrative purposes only, and form no part of the claimed design.

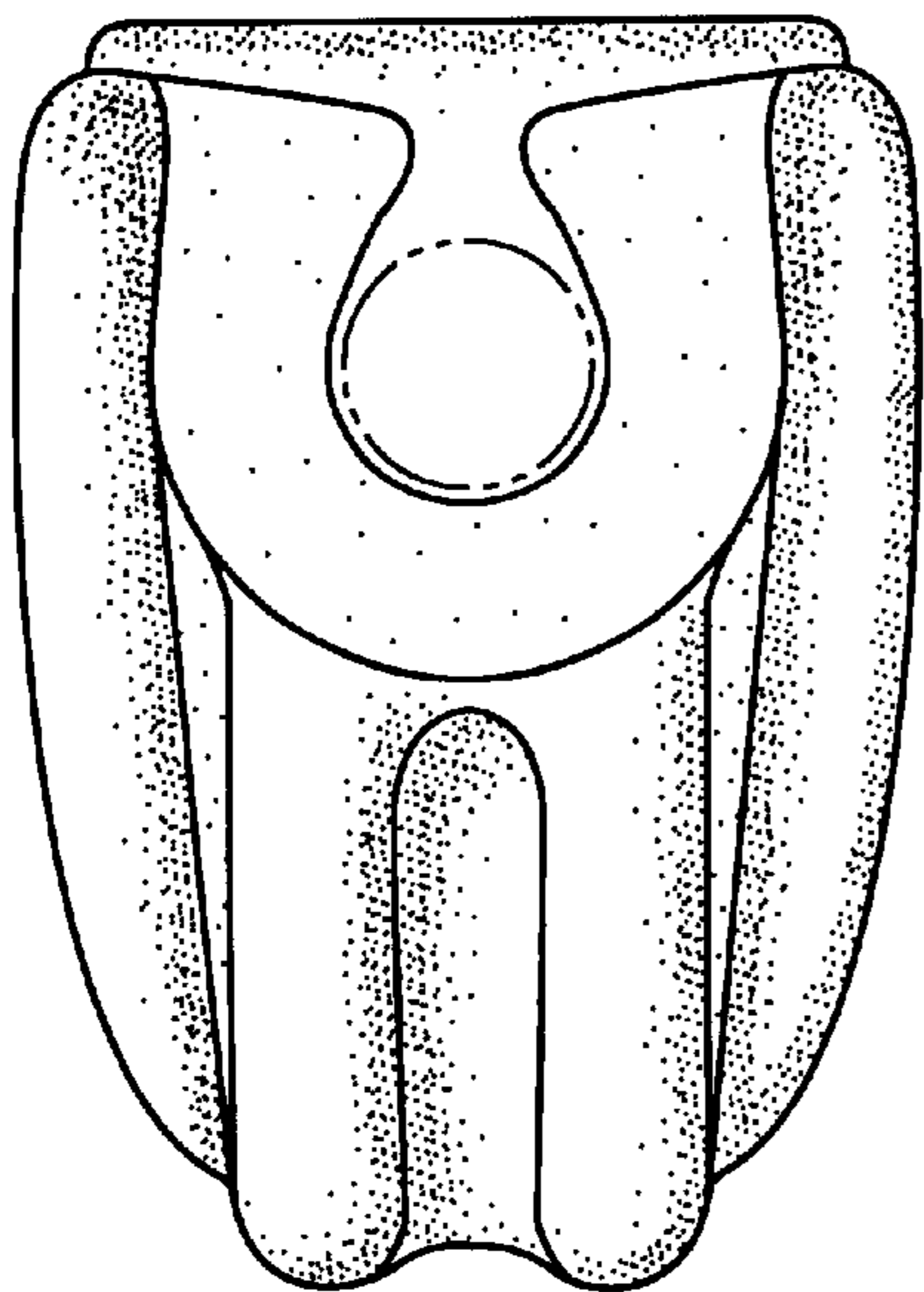




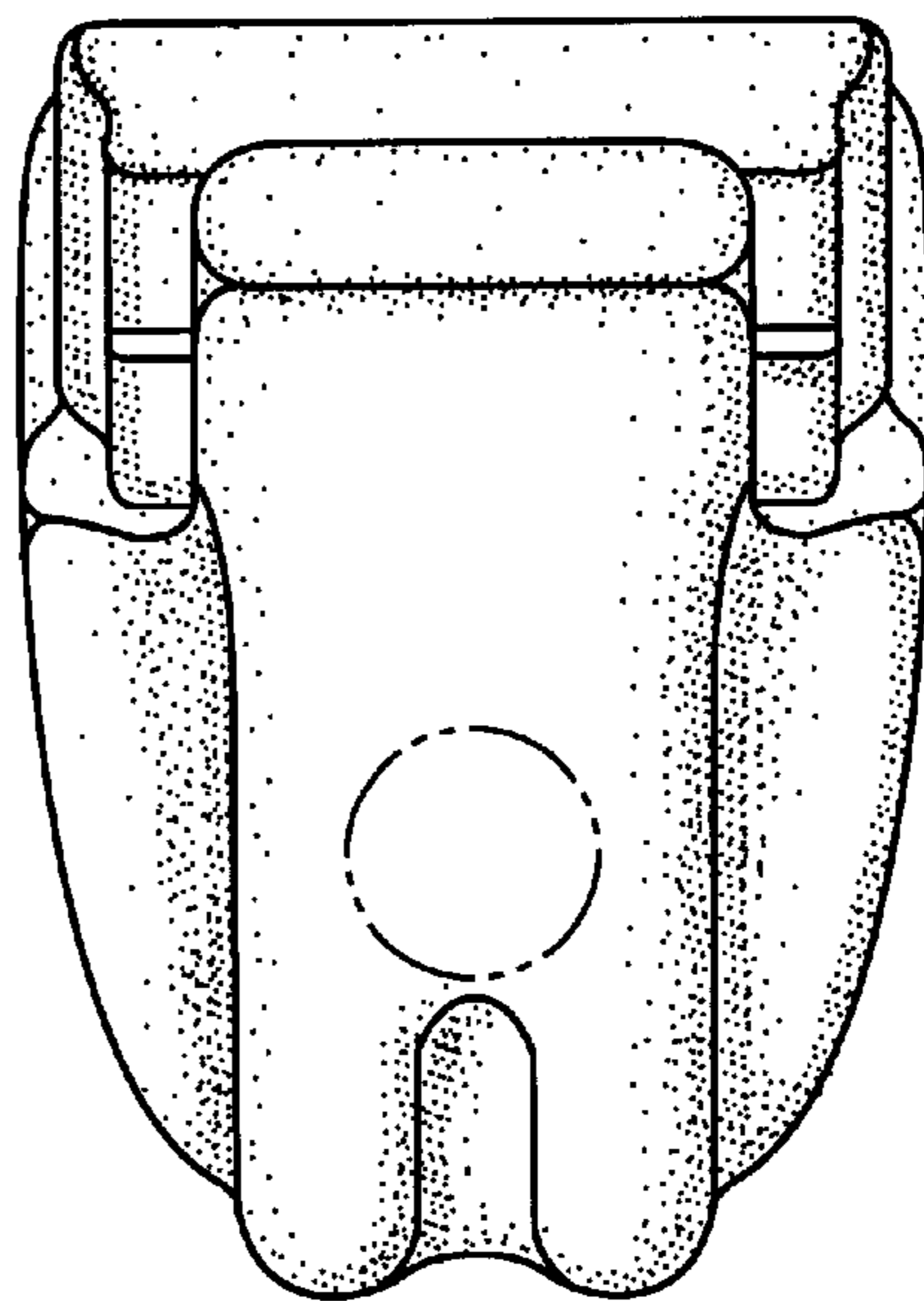

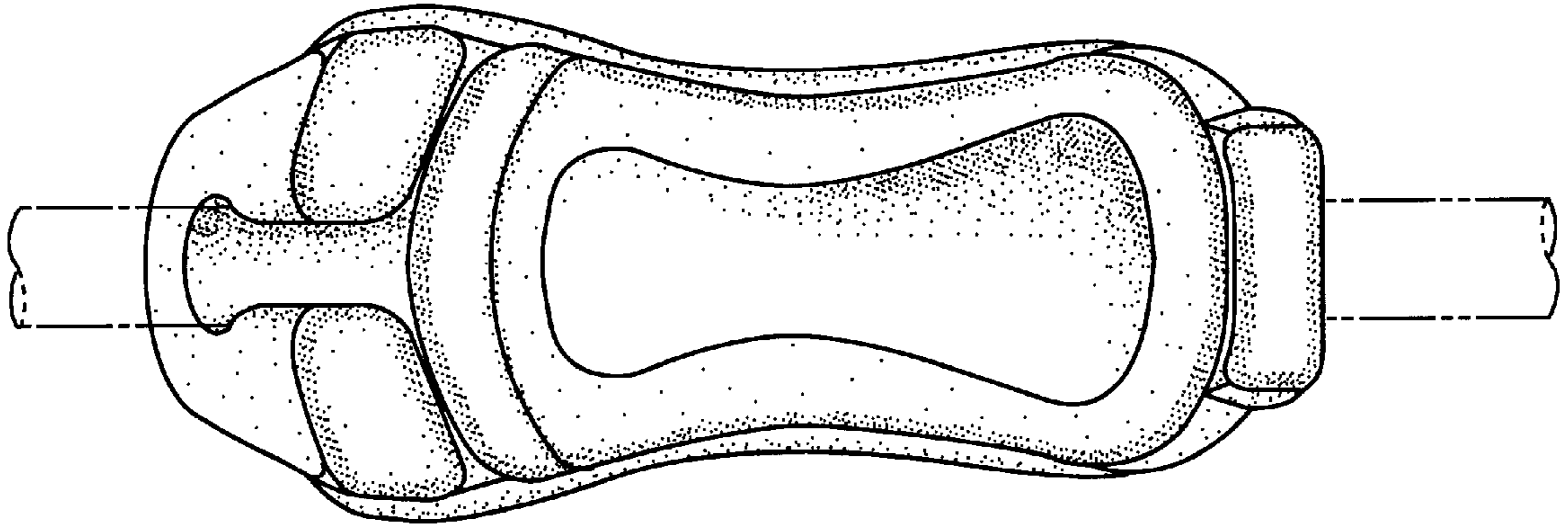

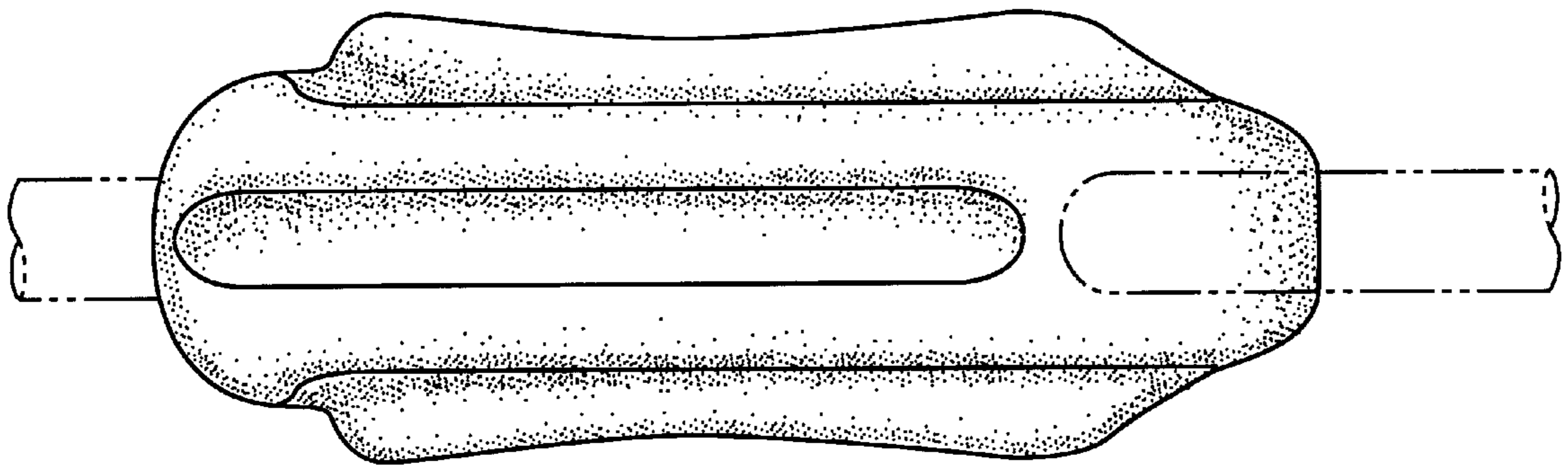
