**DESCRIPTION**

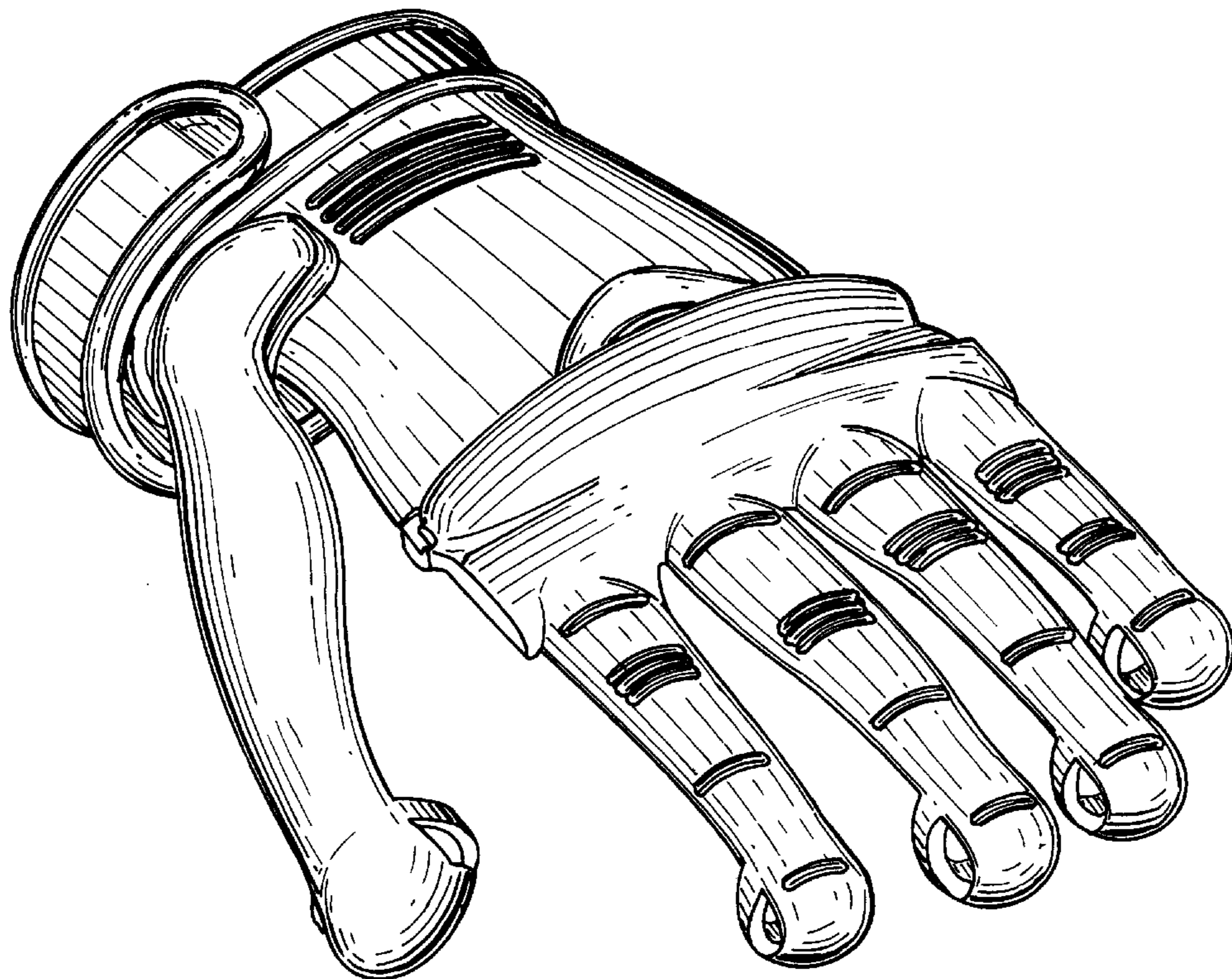
FIG. 1 is a perspective view of the universal exercise glove showing my new design;

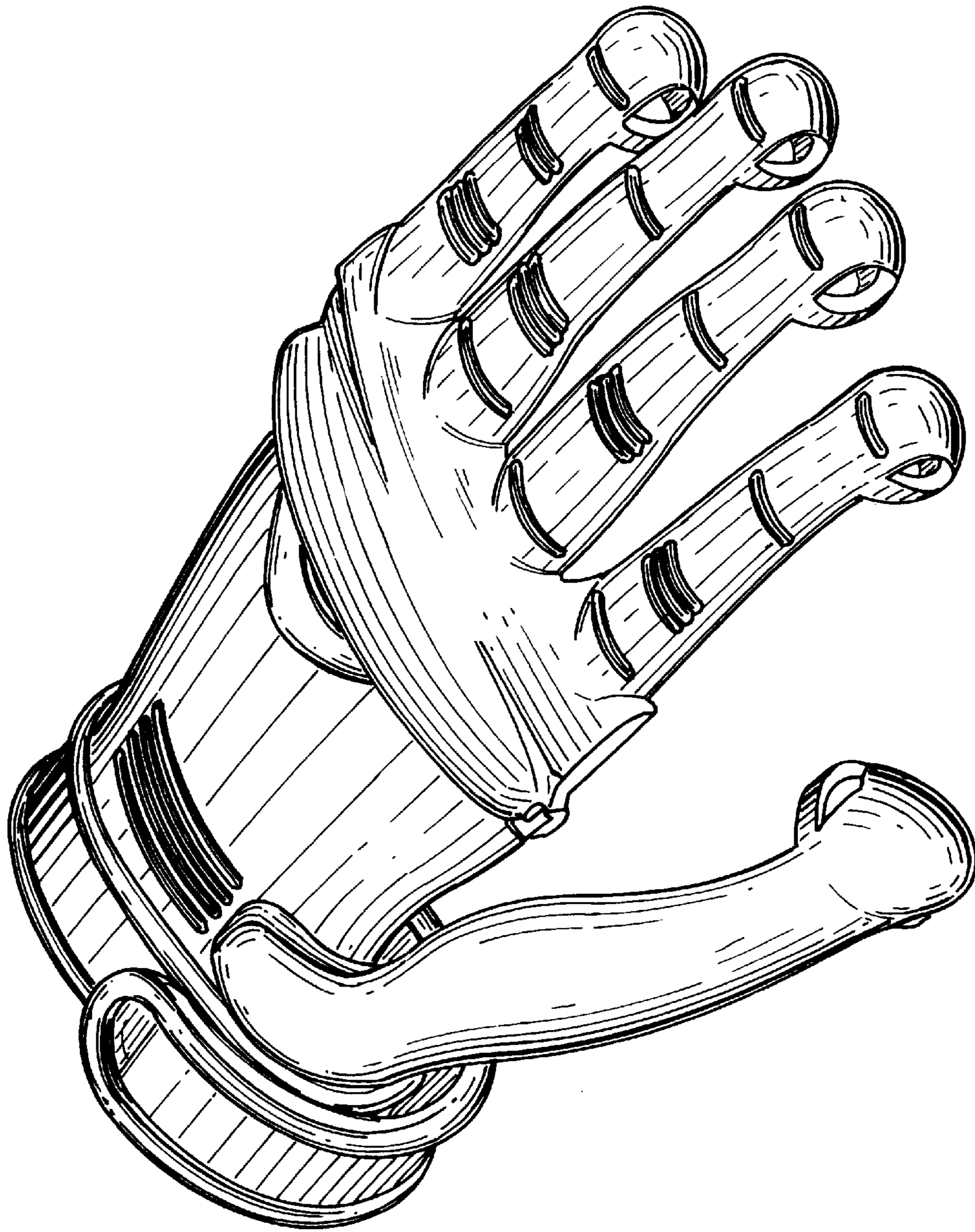

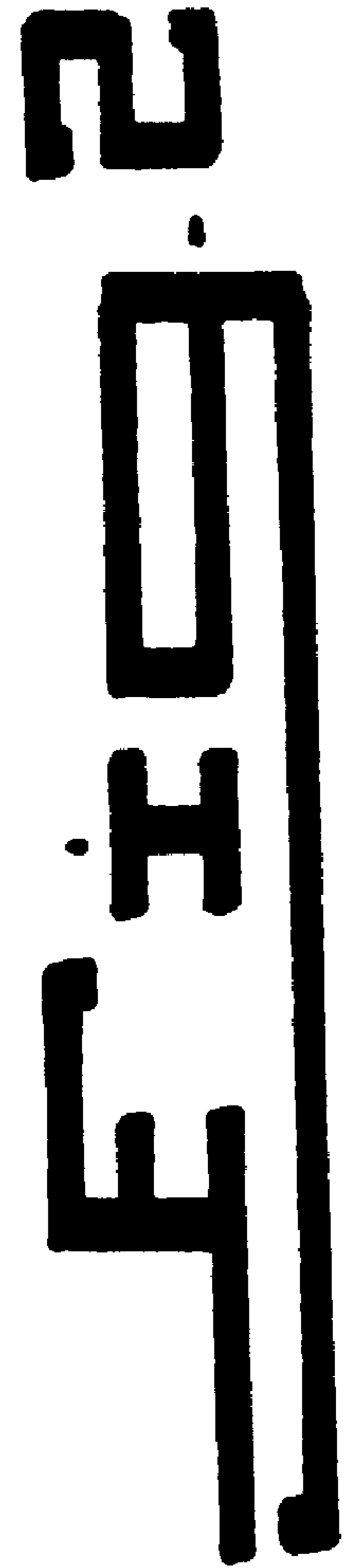
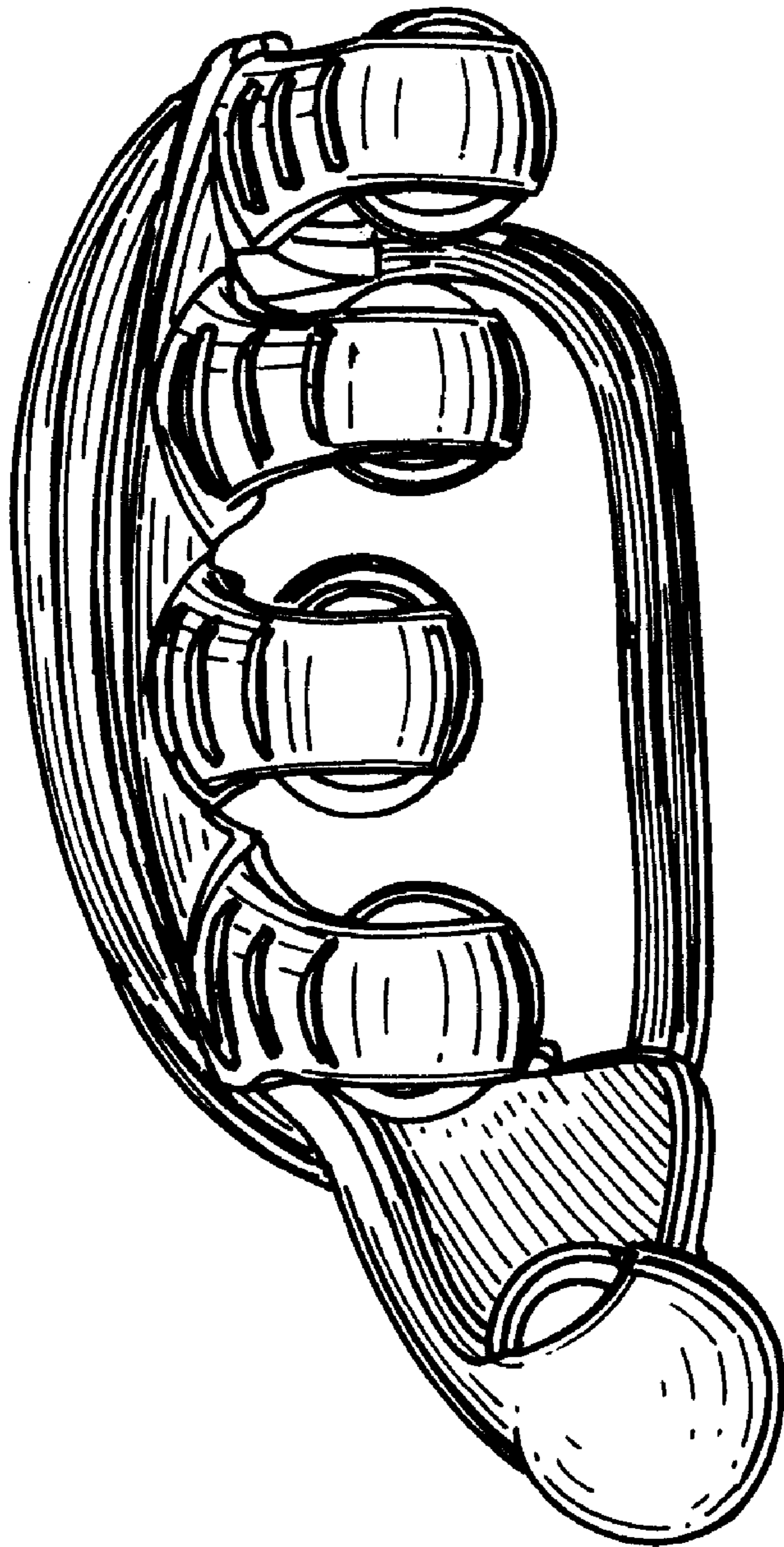

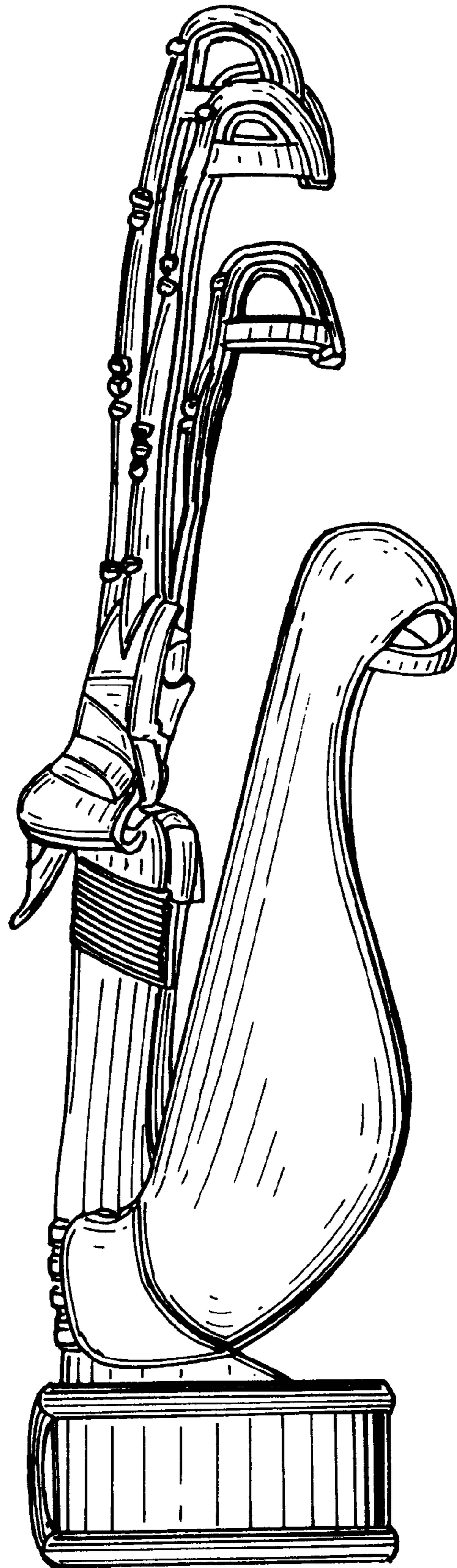
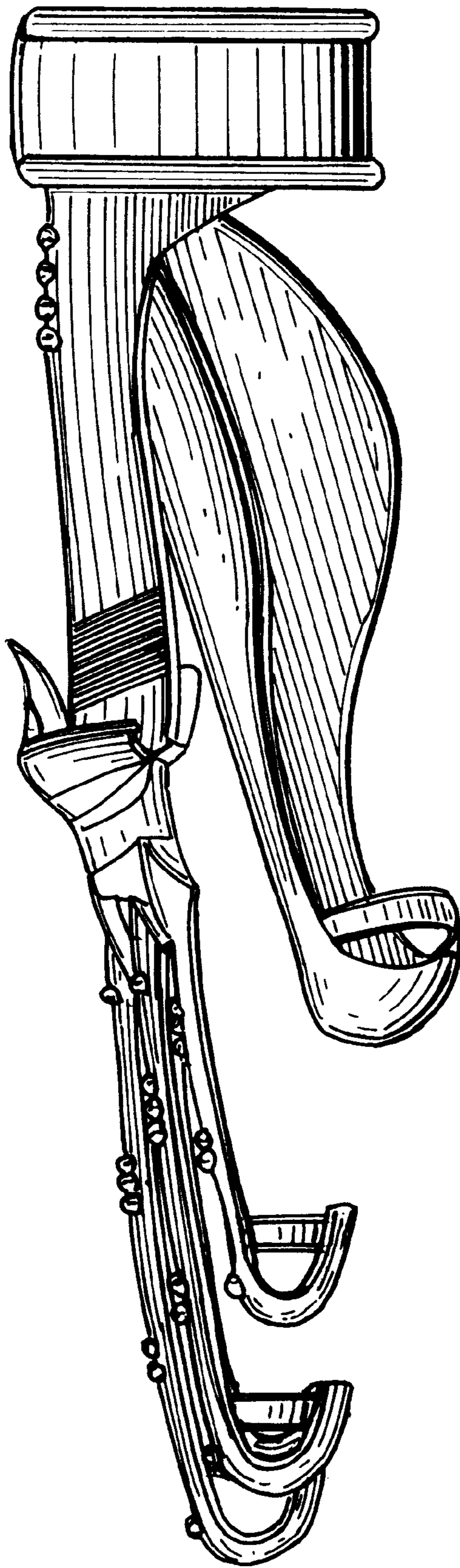
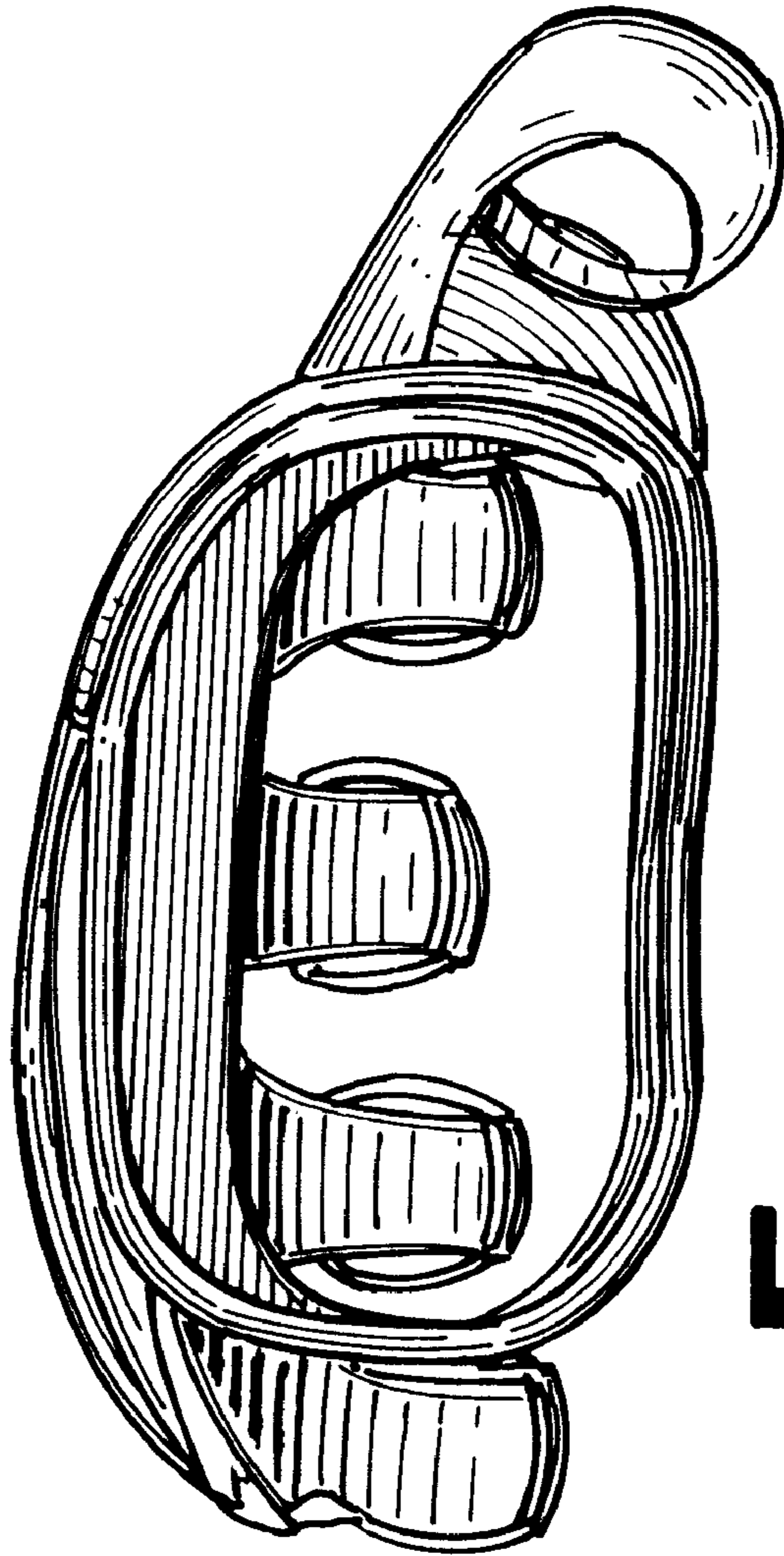

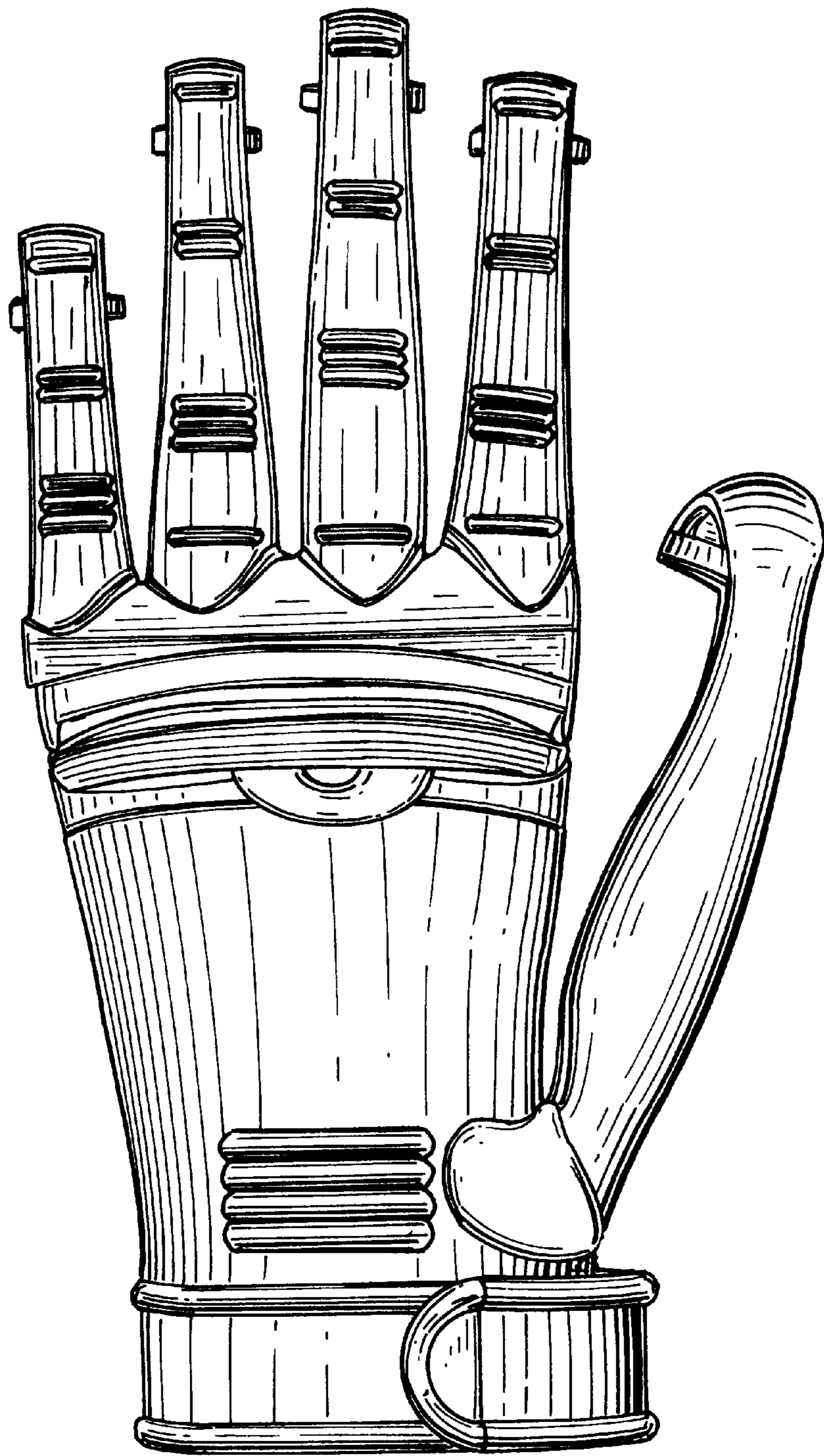

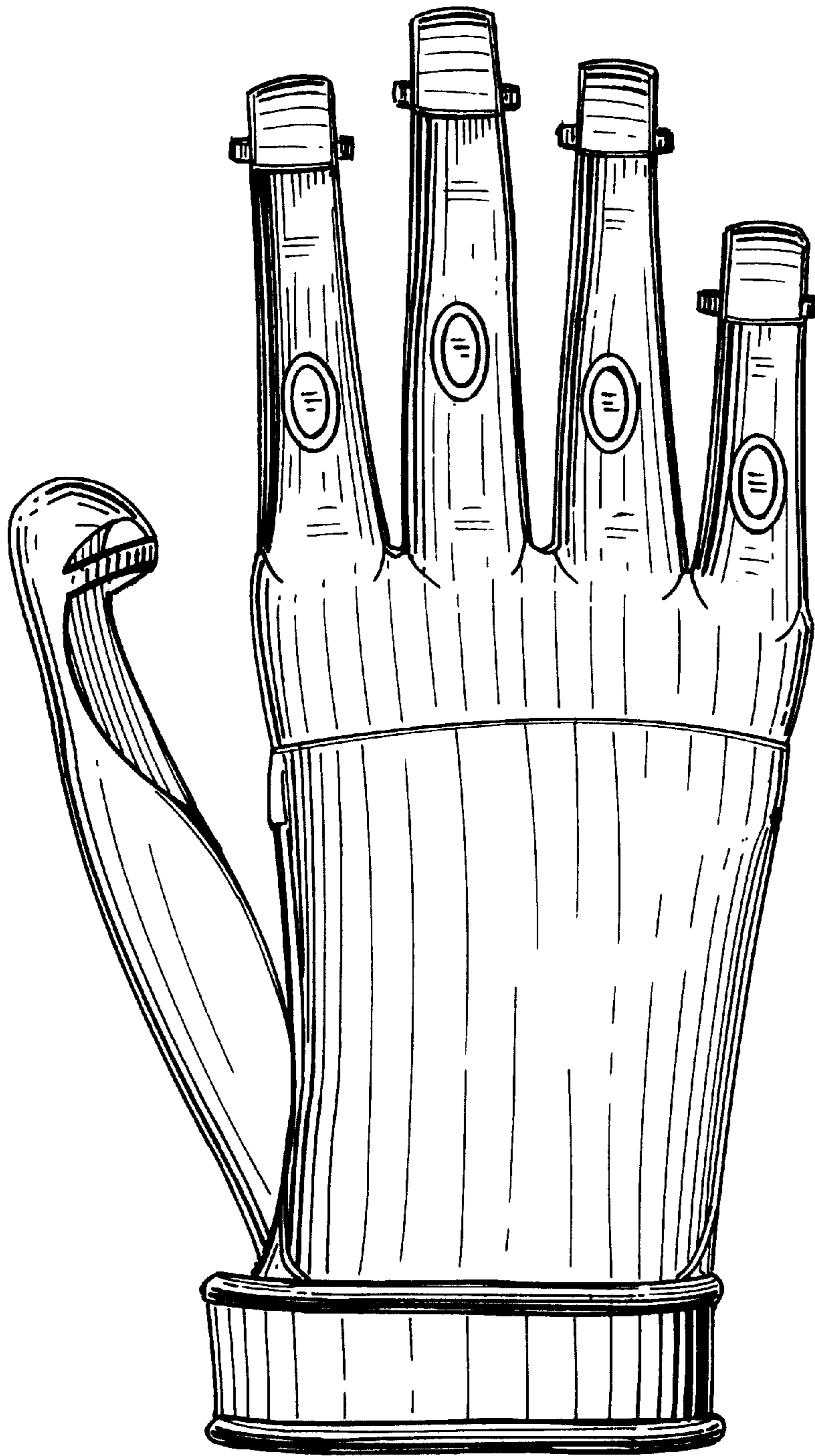
