FIG. 3 is a left side plan view thereof;

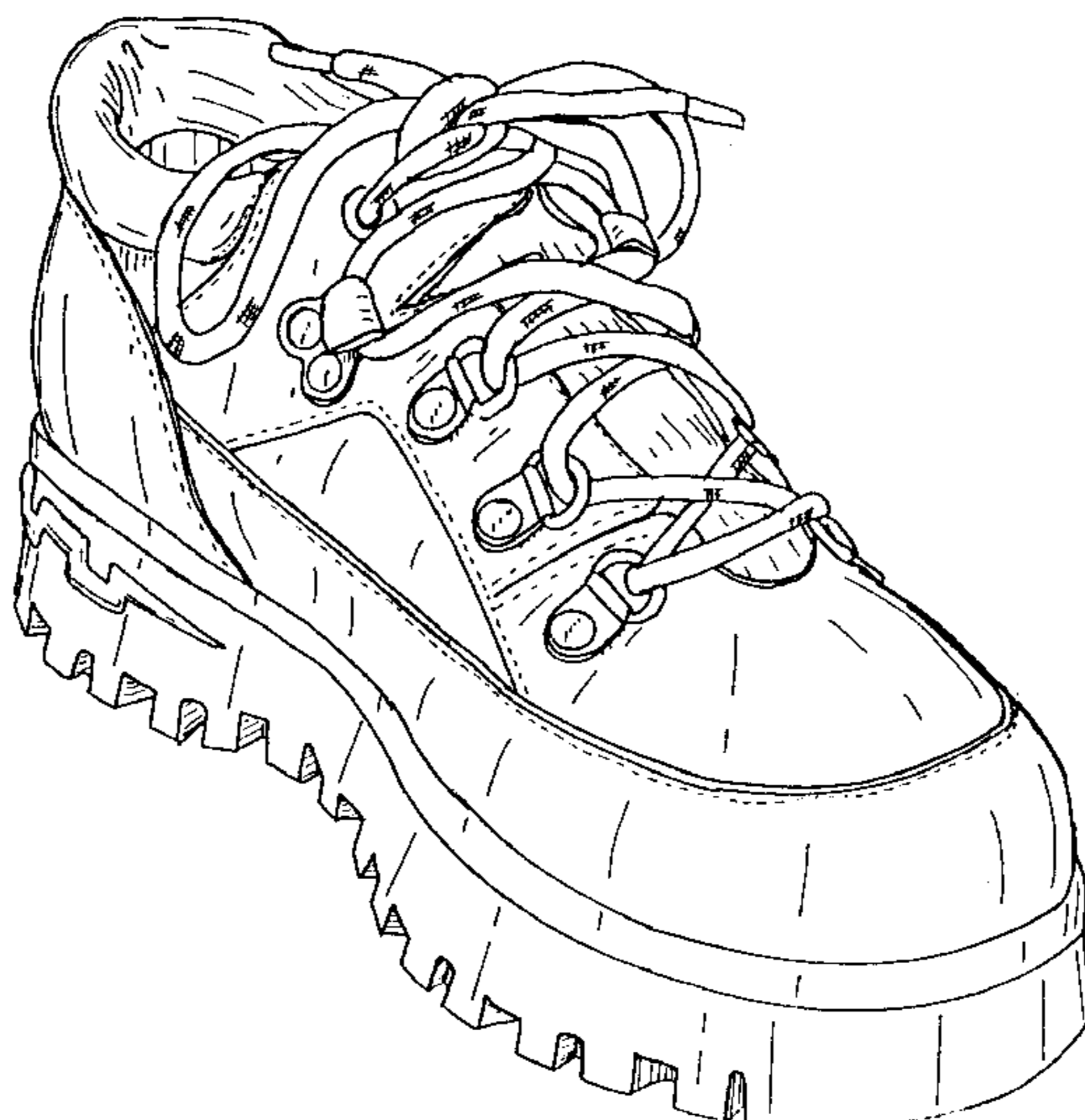
FIG. 4 is a front plan view thereof;

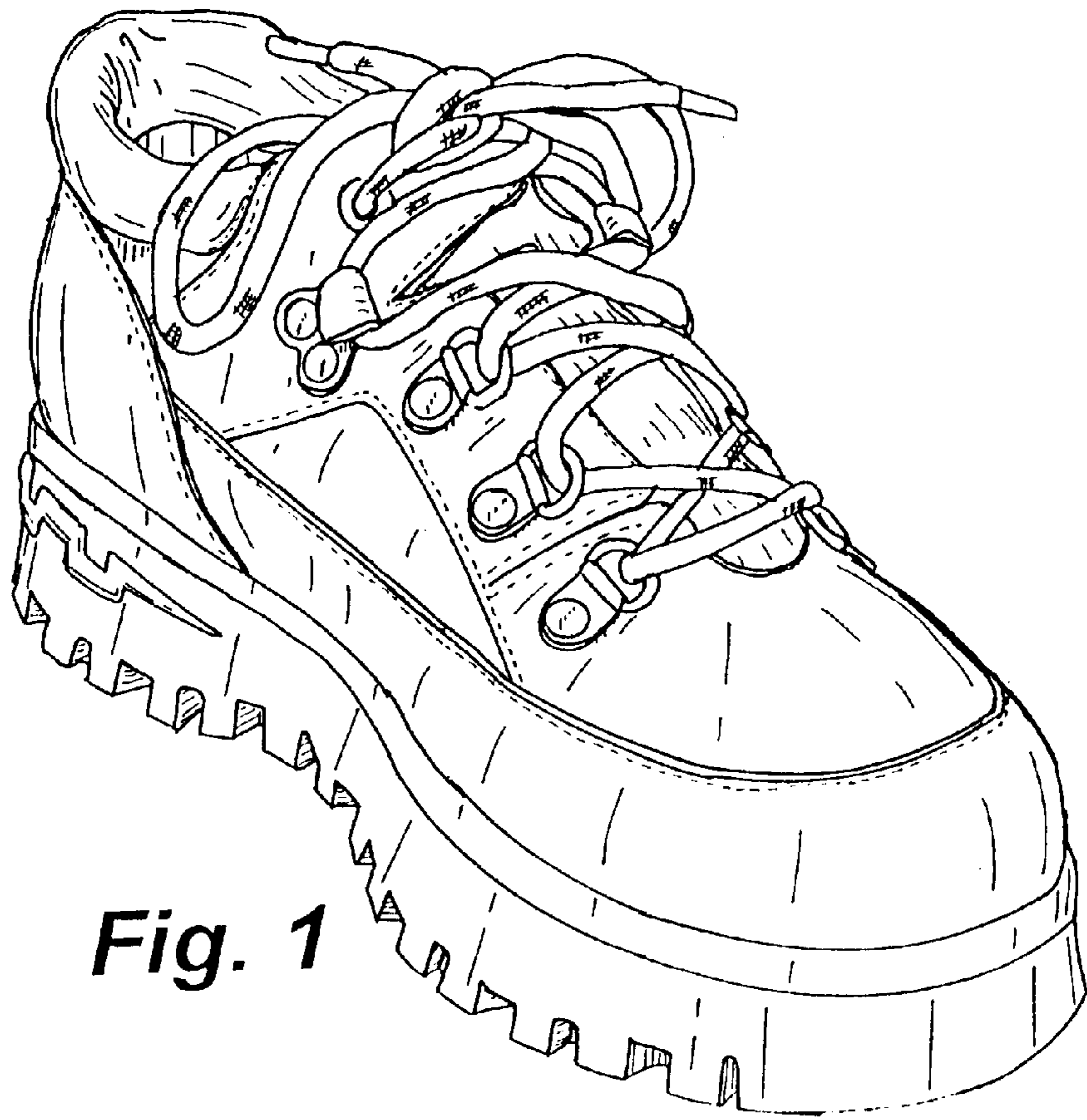

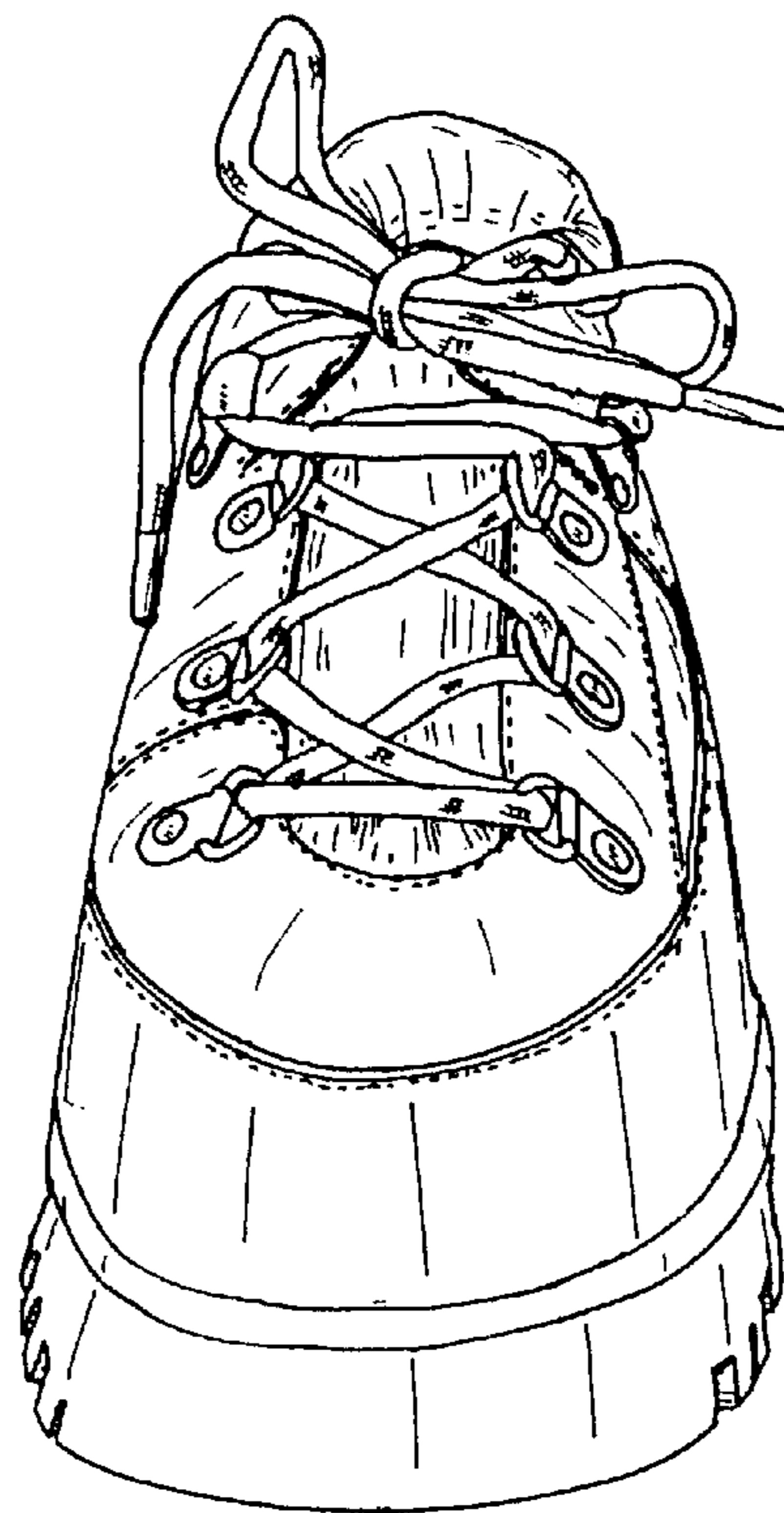

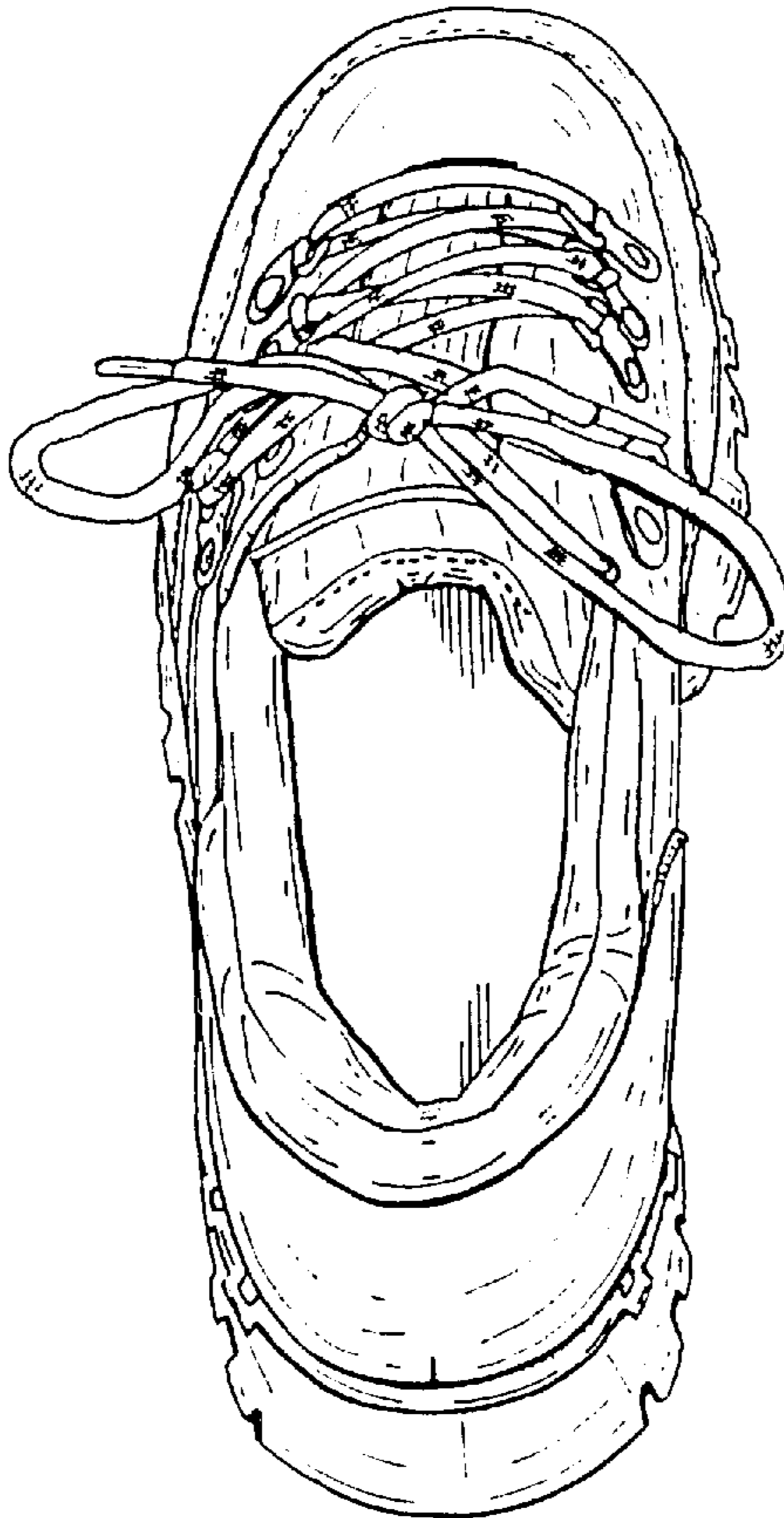
