**DESCRIPTION**

FIG. 1 is a perspective view of a toothbrush from above, showing our design;

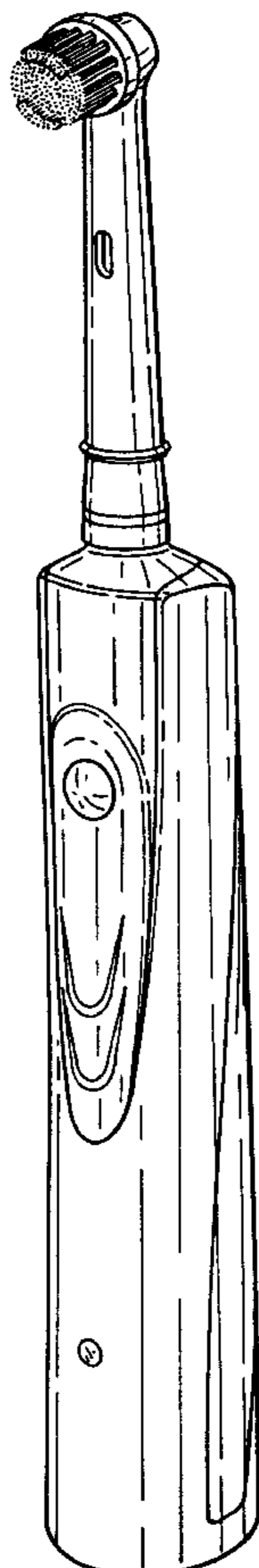
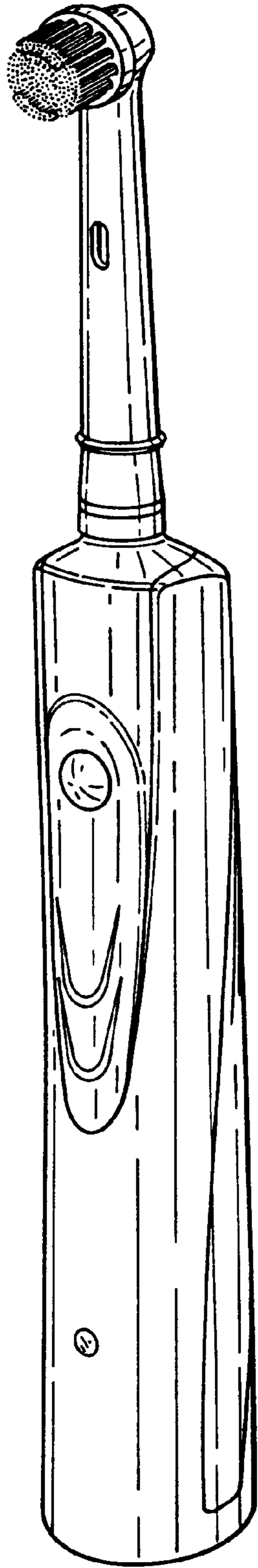

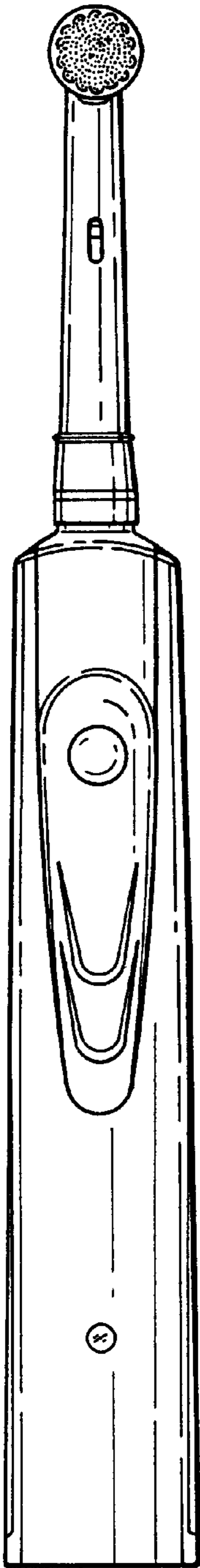

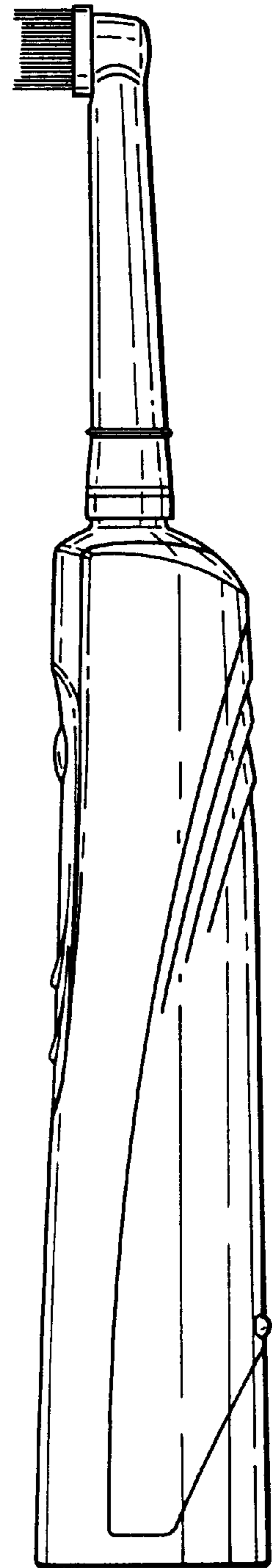

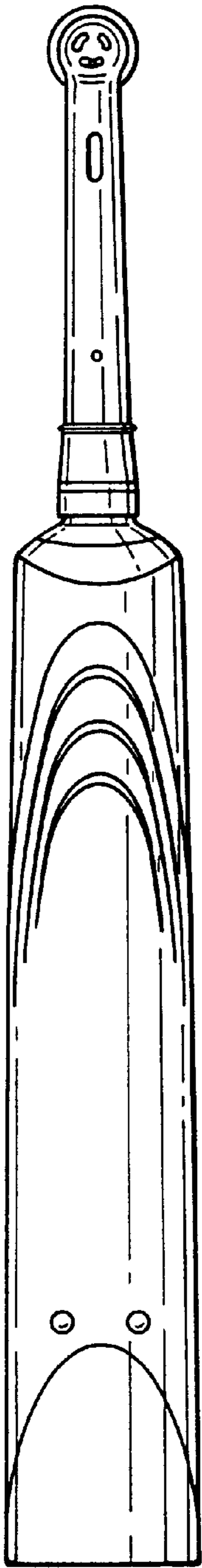

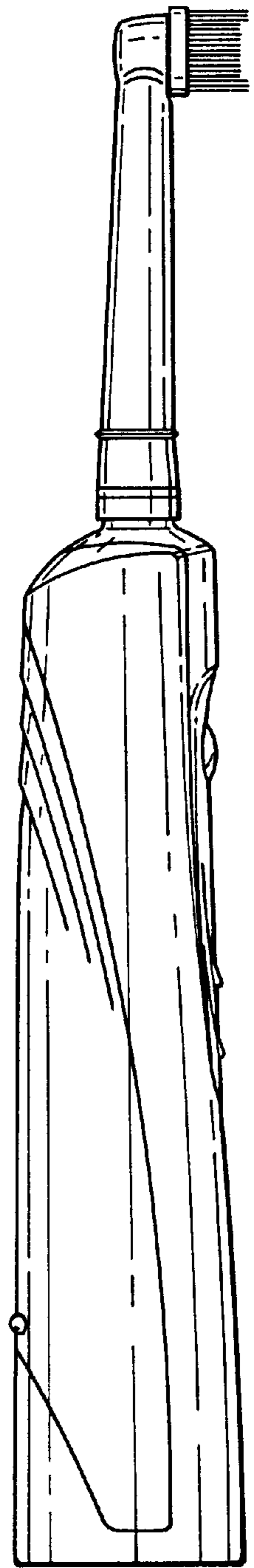

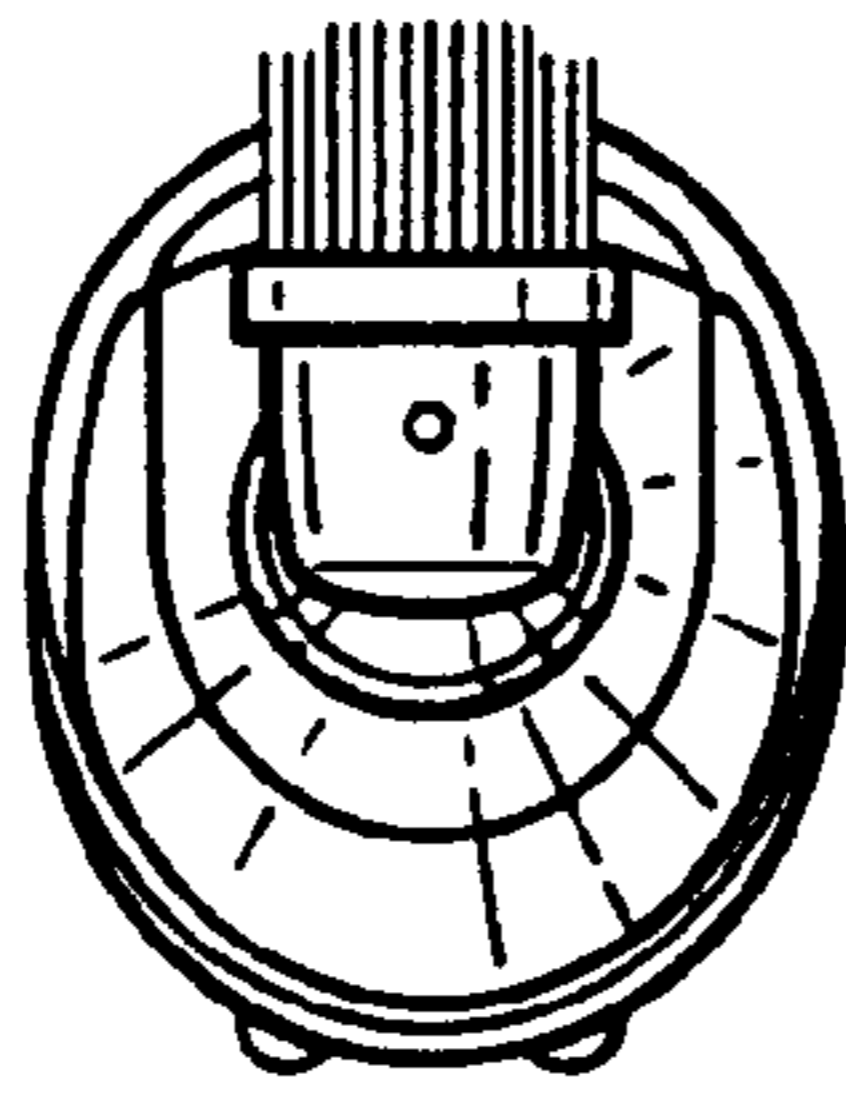

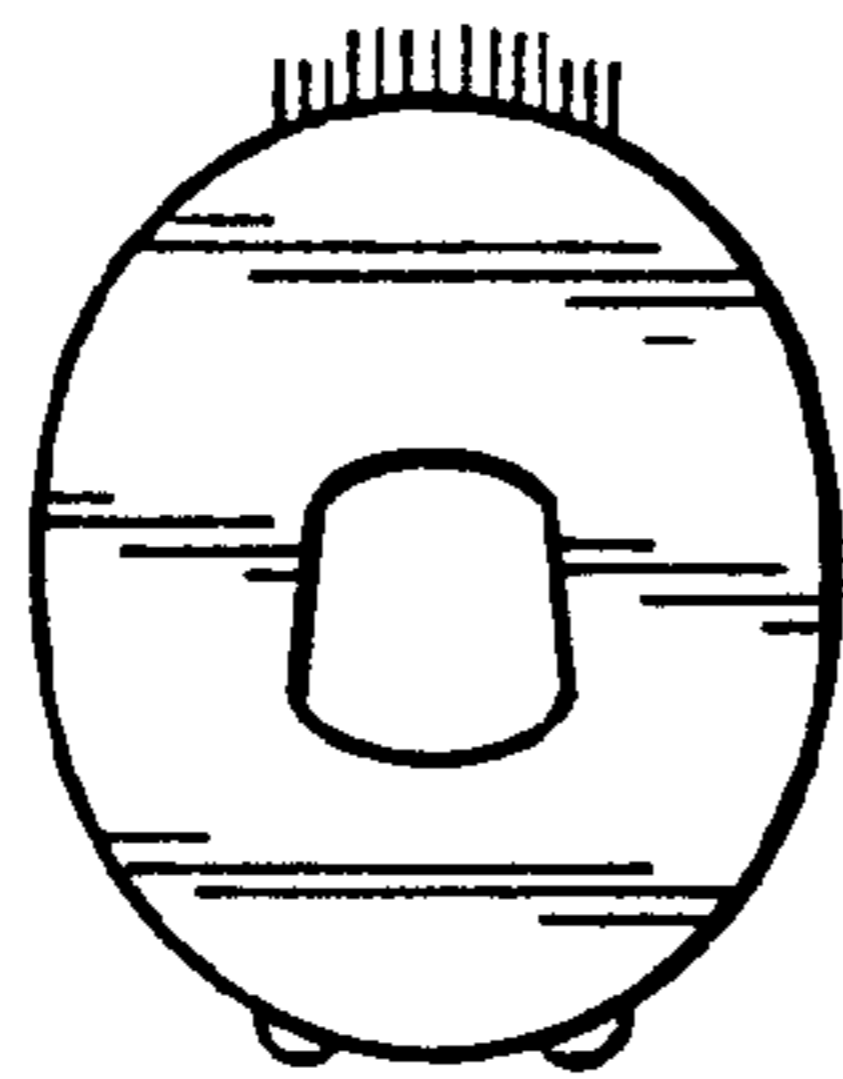
