(57) **CLAIM**

The ornamental design for an ornamental hanger, as shown and described.

DESCRIPTION

FIG. 1 is a frontal perspective view of a embodiment of an ornamental hanger, comprising outer arms that curve upwardly;

FIG. 2 is a front elevational view of the preferred hanger seen in FIG. 1;

FIG. 3 is a top plan view of the preferred embodiment seen in FIG. 1;

FIG. 4 is a left side elevational view of the preferred hanger seen in FIG. 1;

FIG. 5 is a right side elevational view of the preferred hanger seen in FIG. 1;

FIG. 6 is a bottom plan view of the preferred embodiment seen in FIG. 1;

FIG. 7 is a rear elevational view of the preferred embodiment seen in FIG. 1;

FIG. 8 is a frontal perspective view of a second embodiment of an ornamental hanger, which comprises an auxiliary hook;

FIG. 9 is a front elevational view of the second embodiment seen in FIG. 8;

FIG. 10 is top plan view of the second embodiment seen in FIG. 8;

FIG. 11 is a left side elevational view of the second hanger seen in FIG. 8;

FIG. 12 is a right side elevational view of the second hanger seen in FIG. 8;

FIG. 13 is a bottom plan of the second embodiment seen in FIG. 8;

FIG. 14 is a rear elevational view of the second hanger seen in FIG. 8;

FIG. 15 is a frontal perspective view of a third embodiment of an ornamental hanger, comprising outer arms that curve downwardly instead of upwardly;

FIG. 16 is a front elevational view of the third embodiment seen in FIG. 15;

FIG. 17 is a top plan view of the third embodiment seen in FIG. 15;

FIG. 18 is a bottom plan of the third embodiment seen in FIG. 15;

FIG. 19 is a left side elevational view of the third embodiment seen in FIG. 15;

FIG. 20 is a right elevational view of the third embodiment seen in FIG. 15;

FIG. 21 is a rear elevational view of the third embodiment seen in FIG. 15;

FIG. 22 is a frontal perspective view of a fourth embodiment of an ornamental hanger, which comprises an auxiliary hook like the hanger of FIG. 8 and which has arms that curve downwardly like the hanger of FIG. 15;

FIG. 23 is a front elevational view of the fourth embodiment seen in FIG. 22;

FIG. 24 is a top plan view of the fourth embodiment seen in FIG. 22;

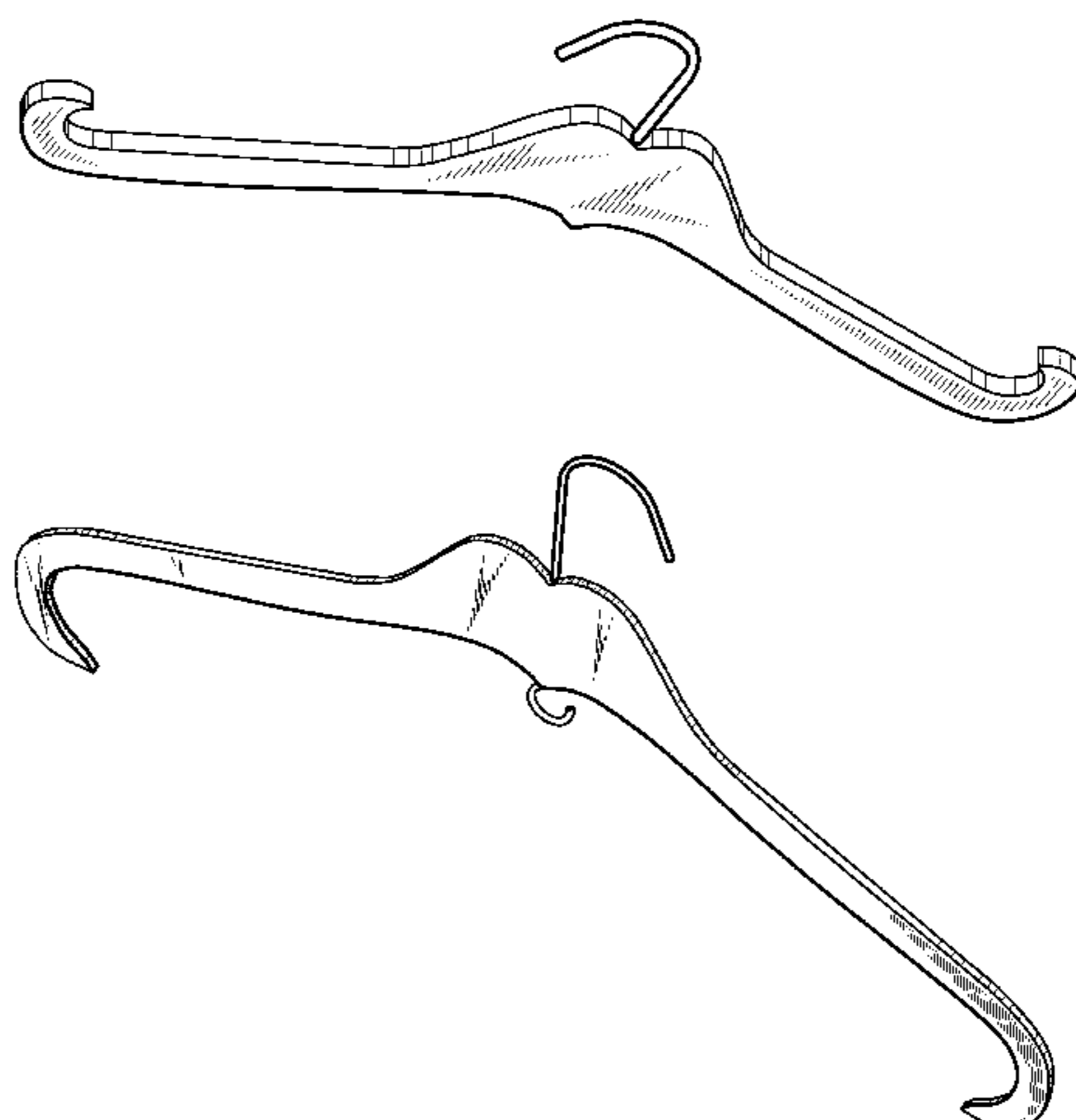
FIG. 25 is a bottom plan of the fourth embodiment seen in FIG. 22;

FIG. 26 is a left side elevational view of the fourth embodiment seen in FIG. 22;

FIG. 27 is a right side elevational view of the fourth embodiment seen in FIG. 22; and,

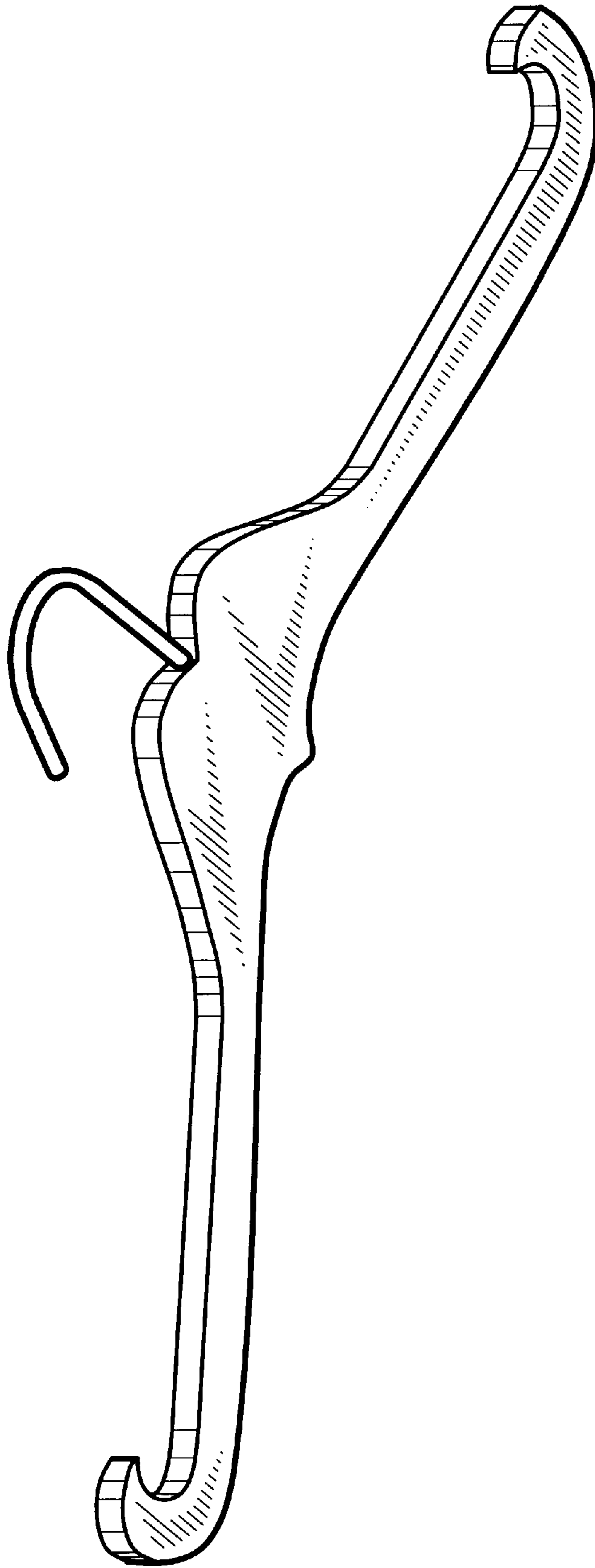

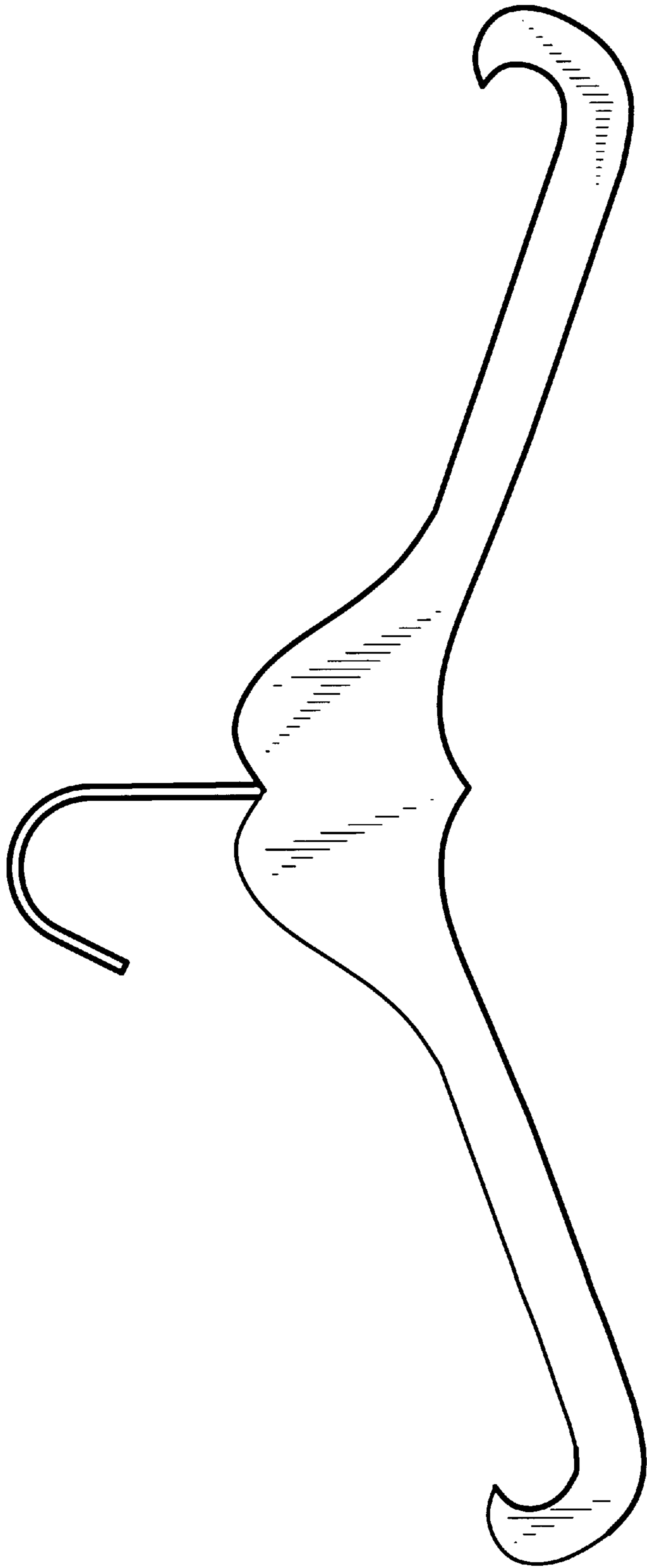

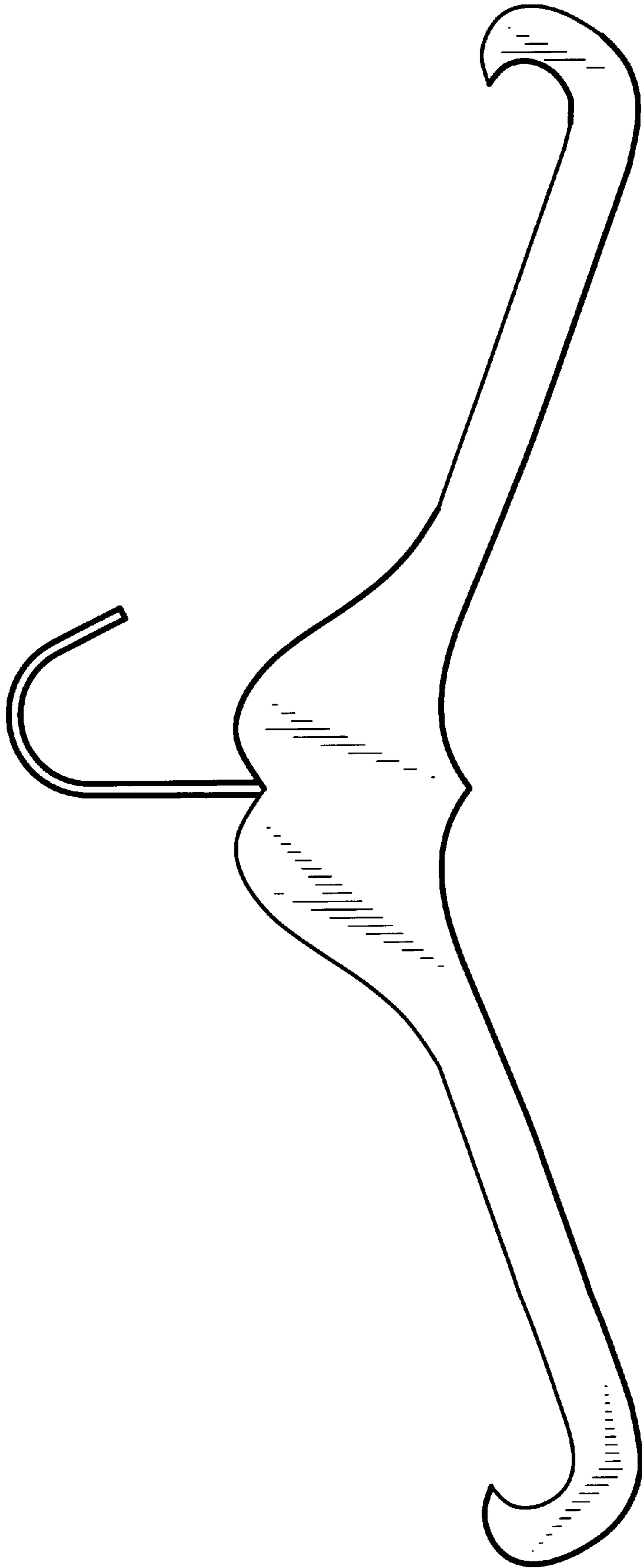

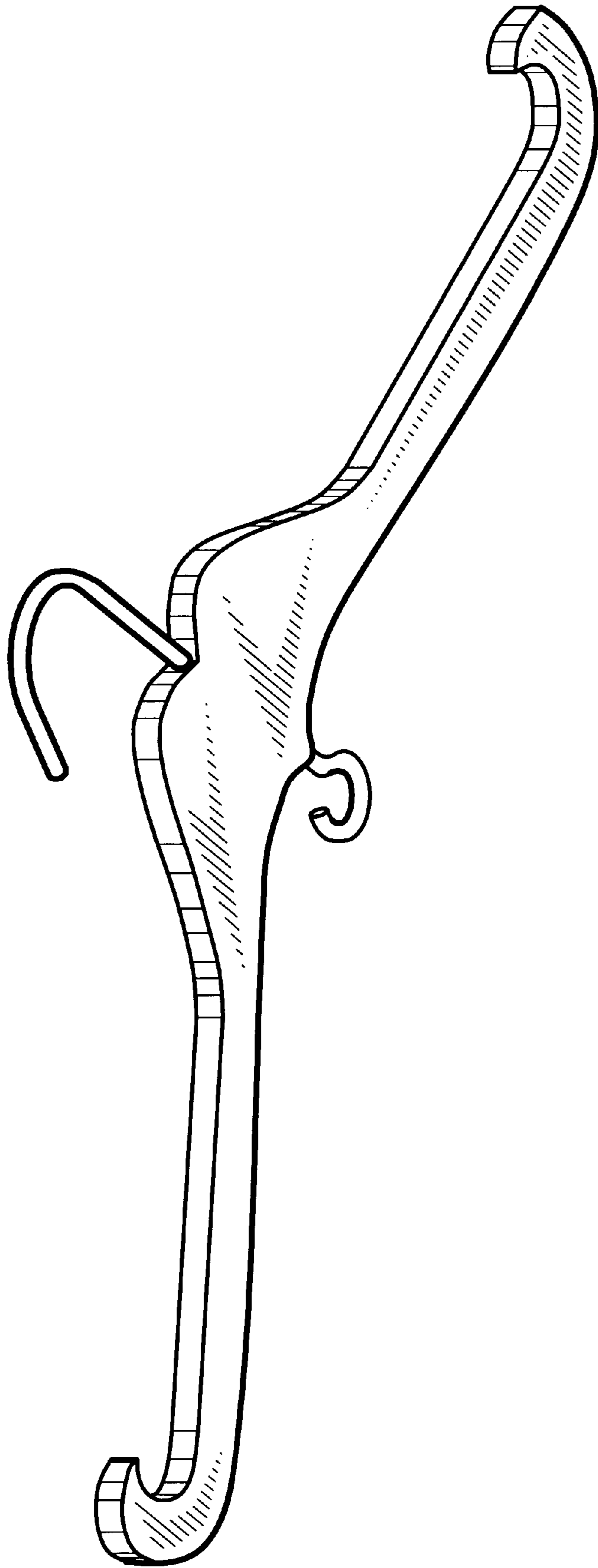

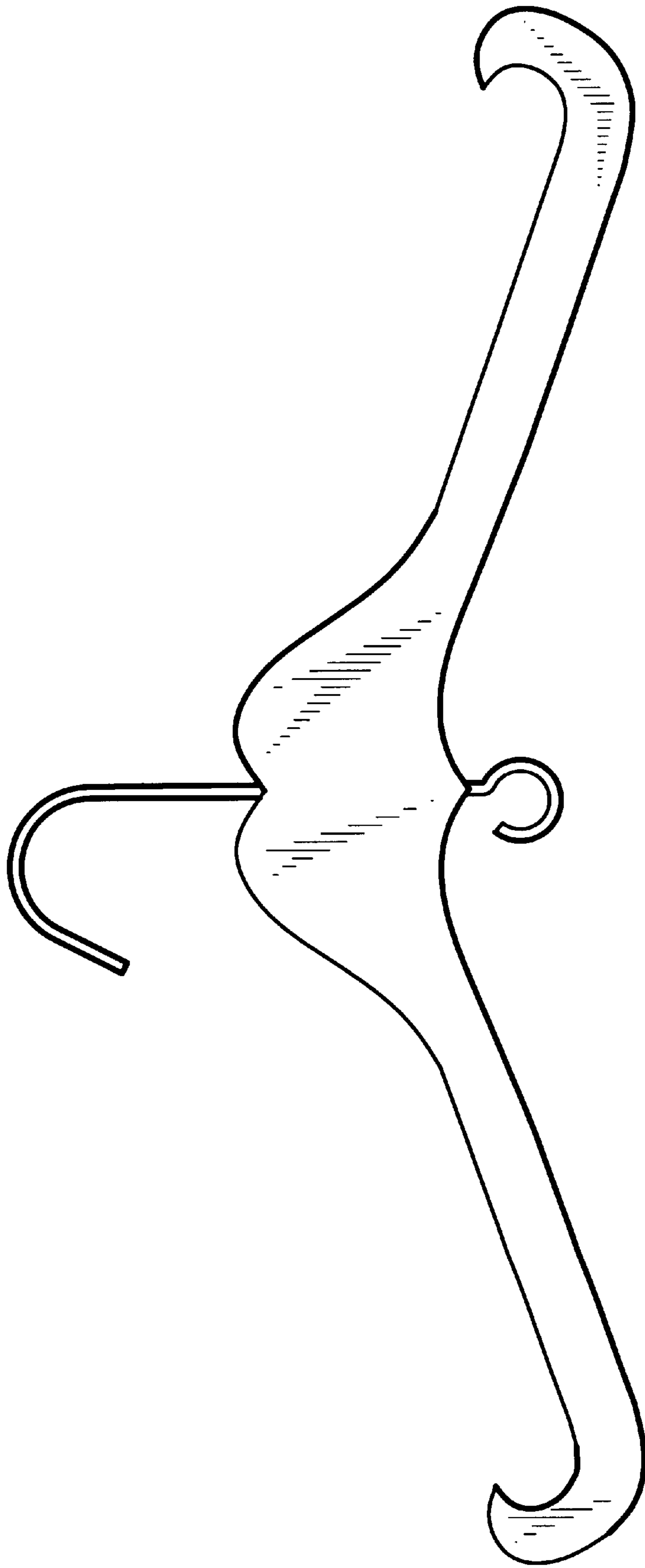

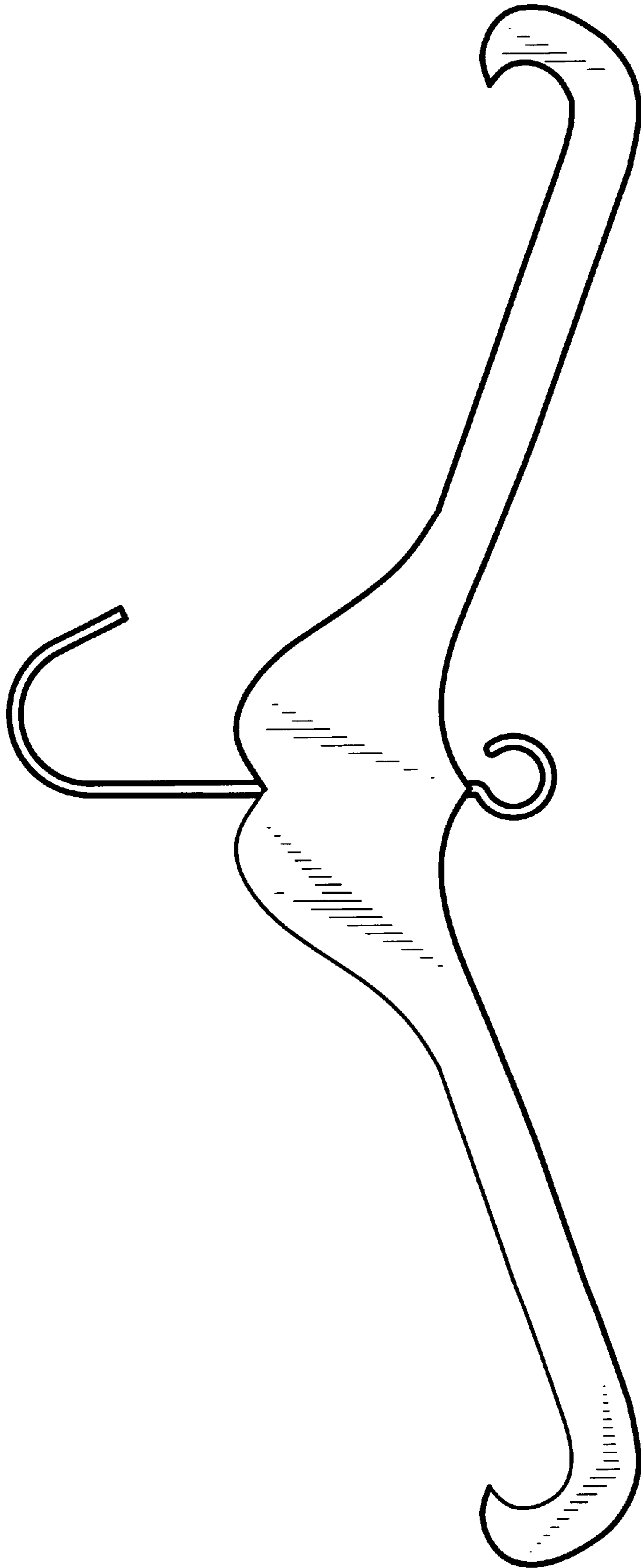

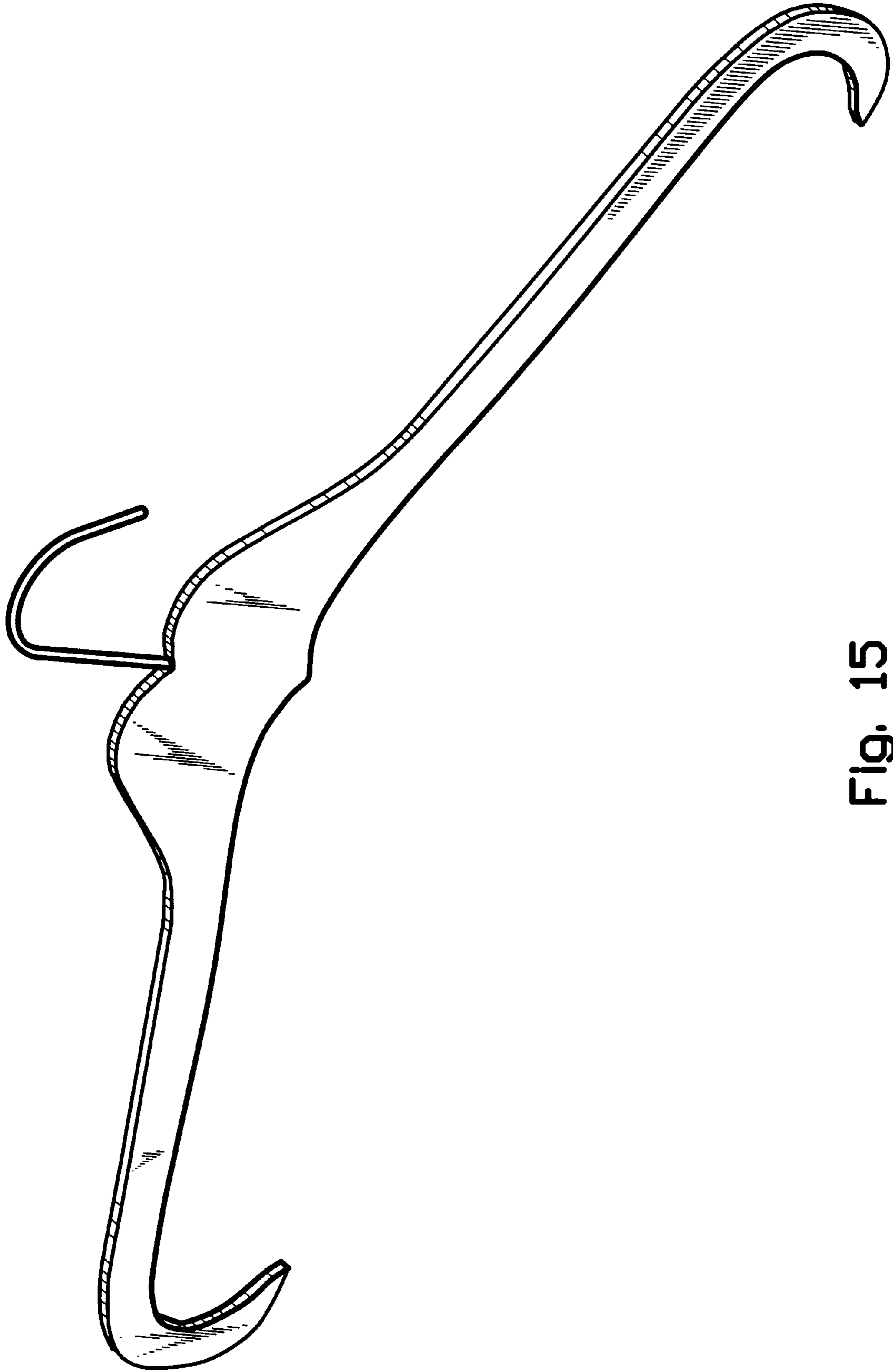

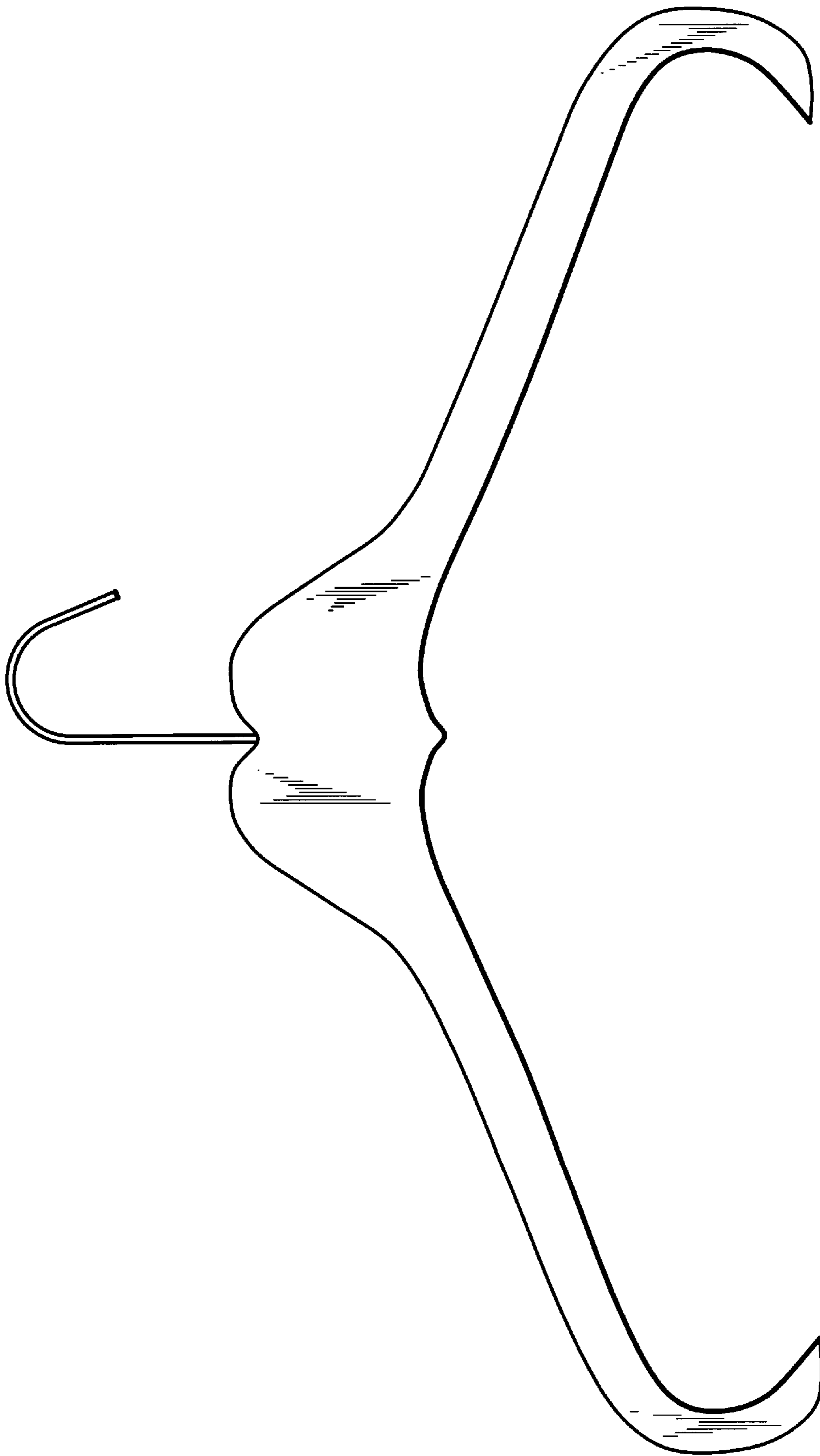

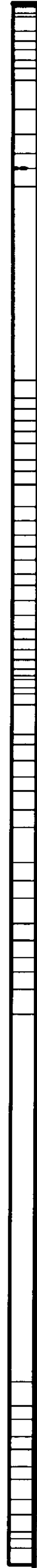

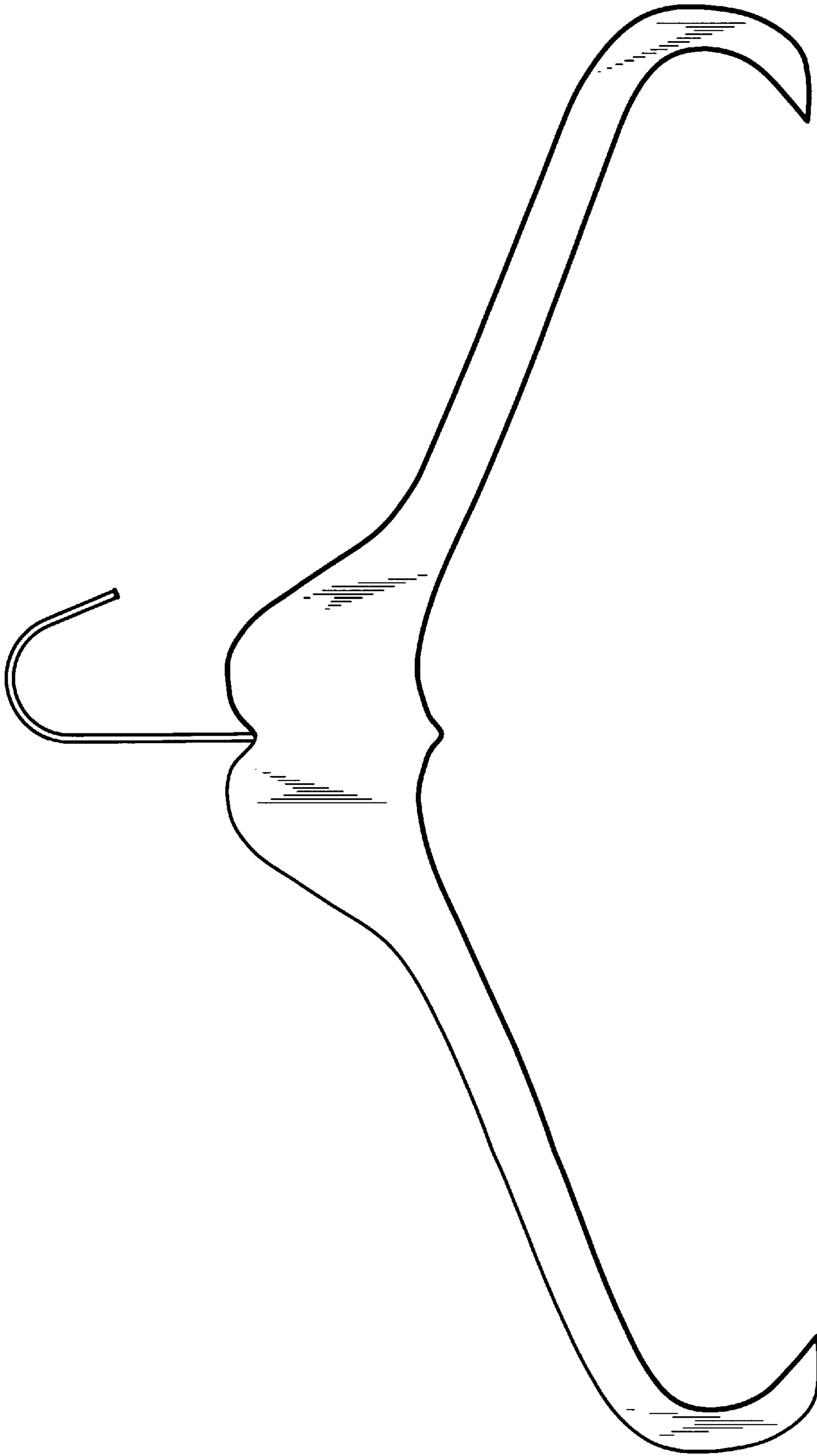

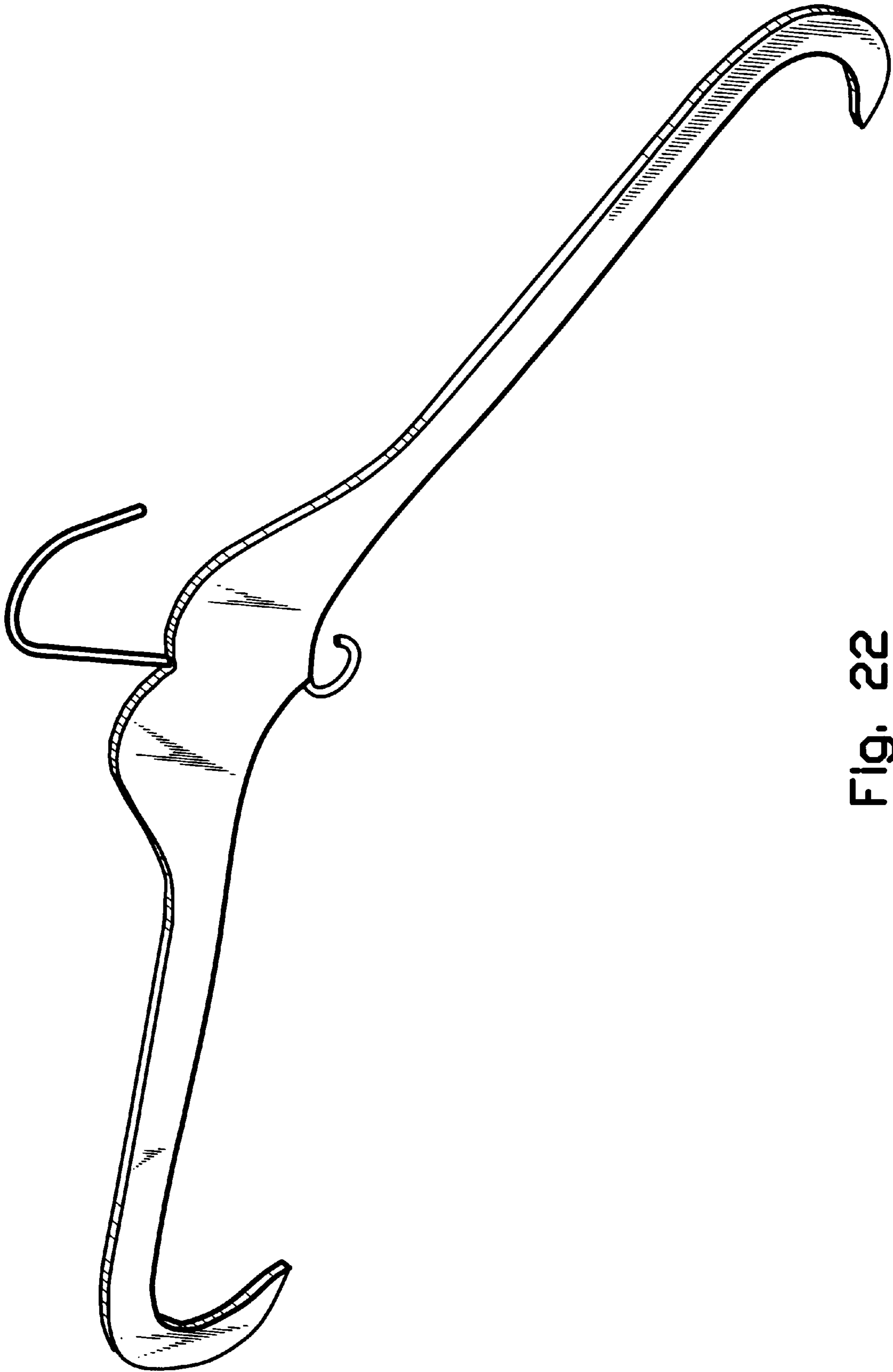

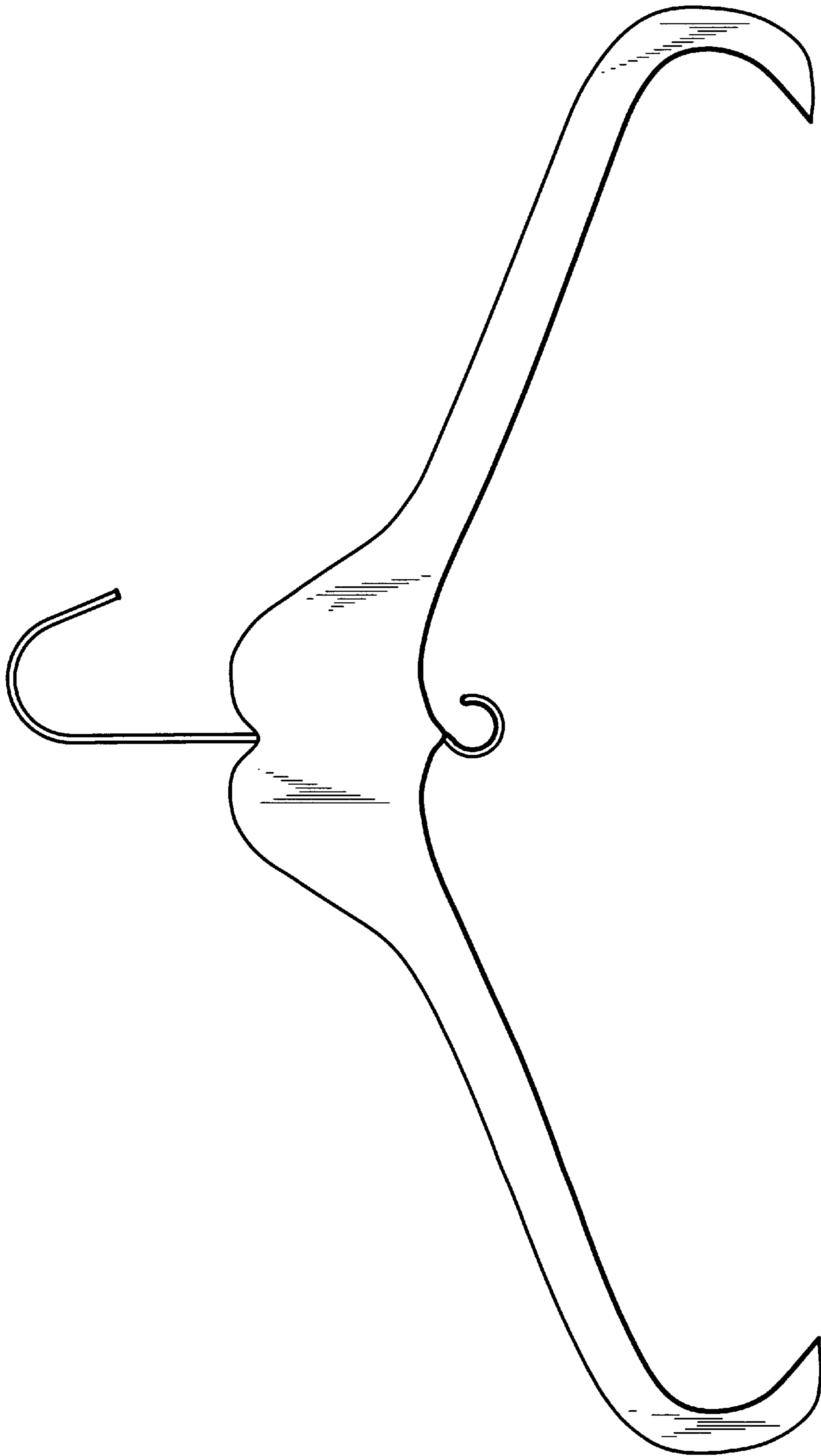

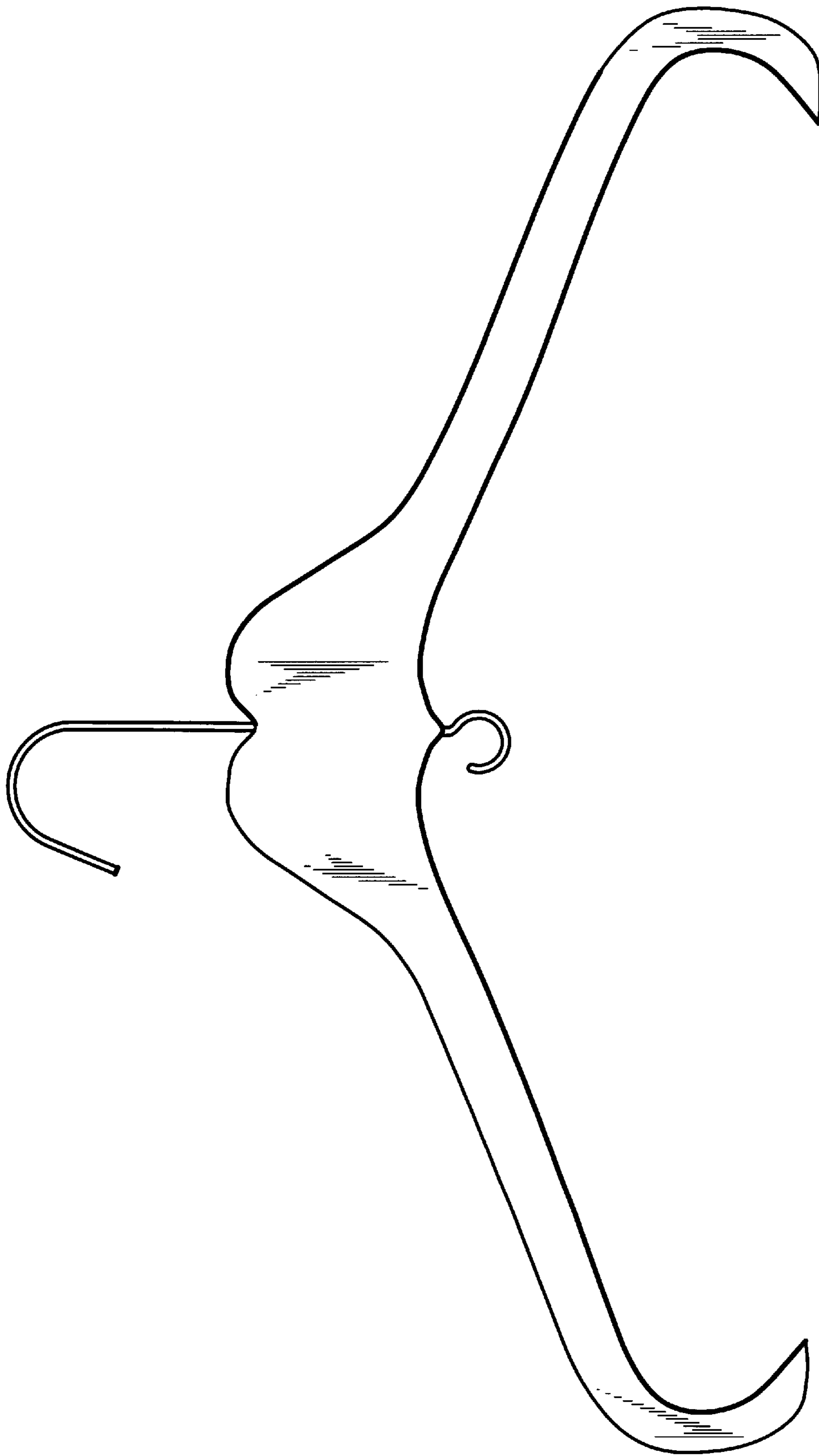
