(57) **CLAIM**

The ornamental design for putter head, as shown and described.

DESCRIPTION

The putter head is to be used as part of a putter-type golf club.

FIG. 1 is a perspective view of a putter head showing my new design;

FIG. 4 is a right side elevational view thereof;

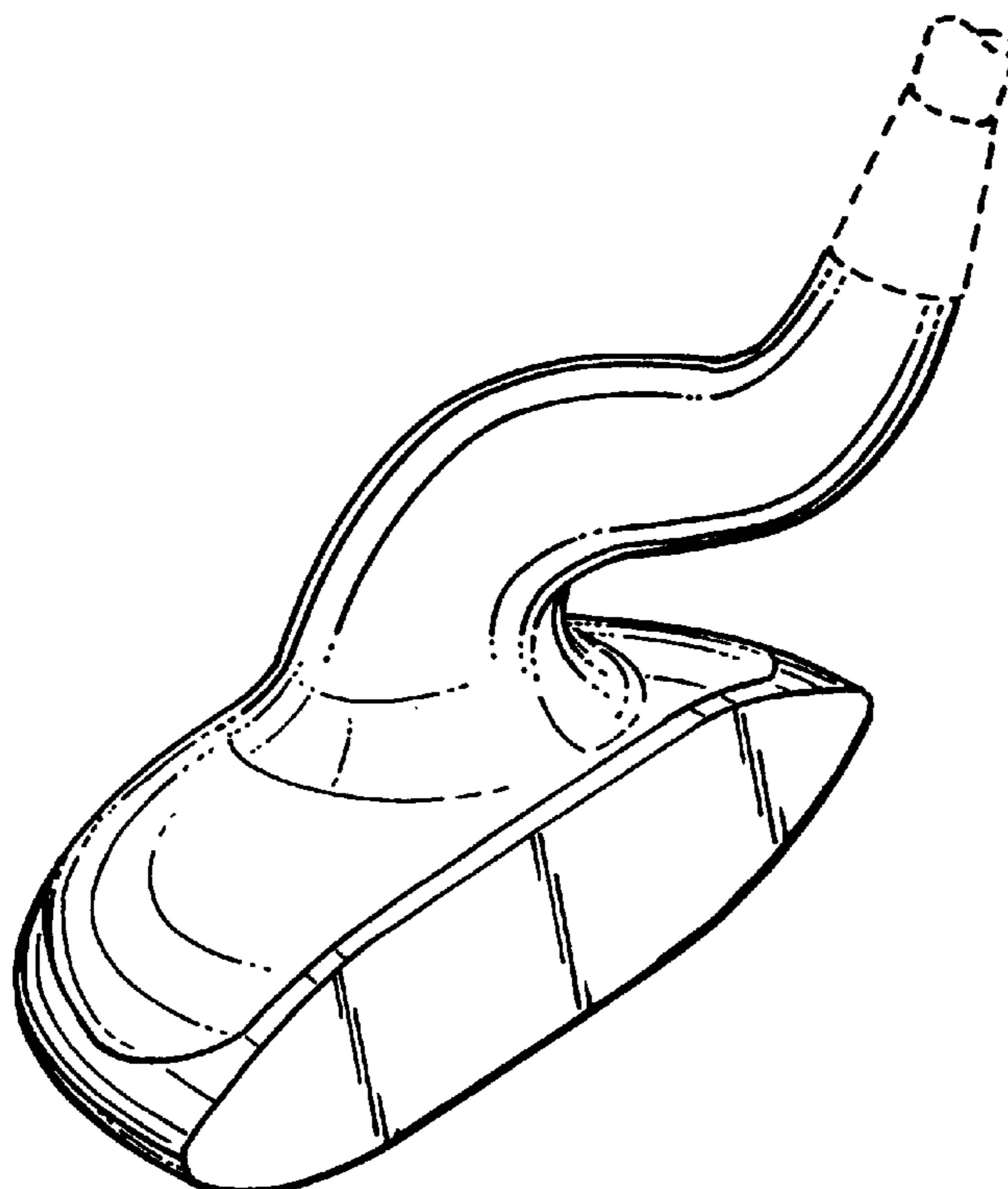
FIG. 5 is a left side elevational view thereof;

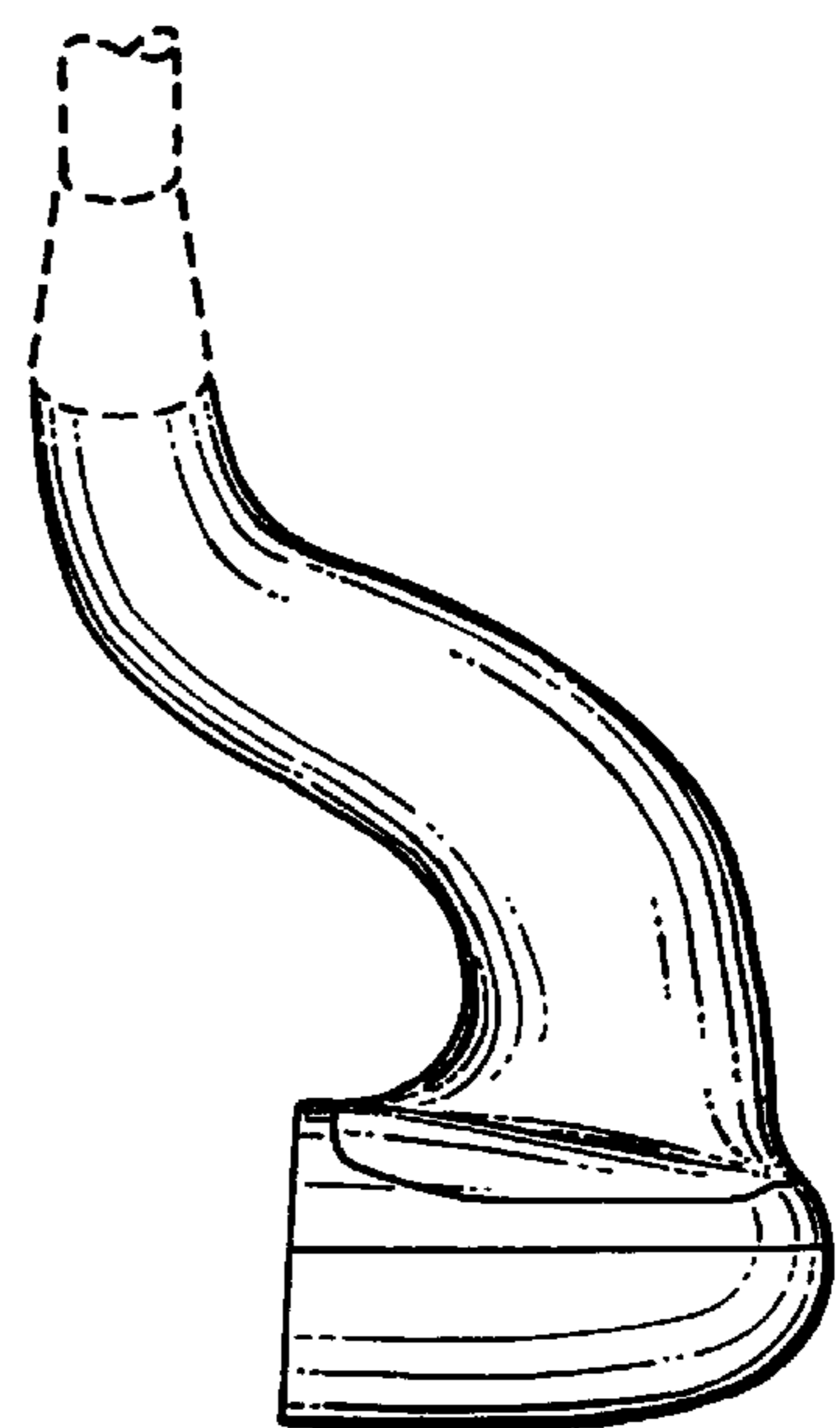
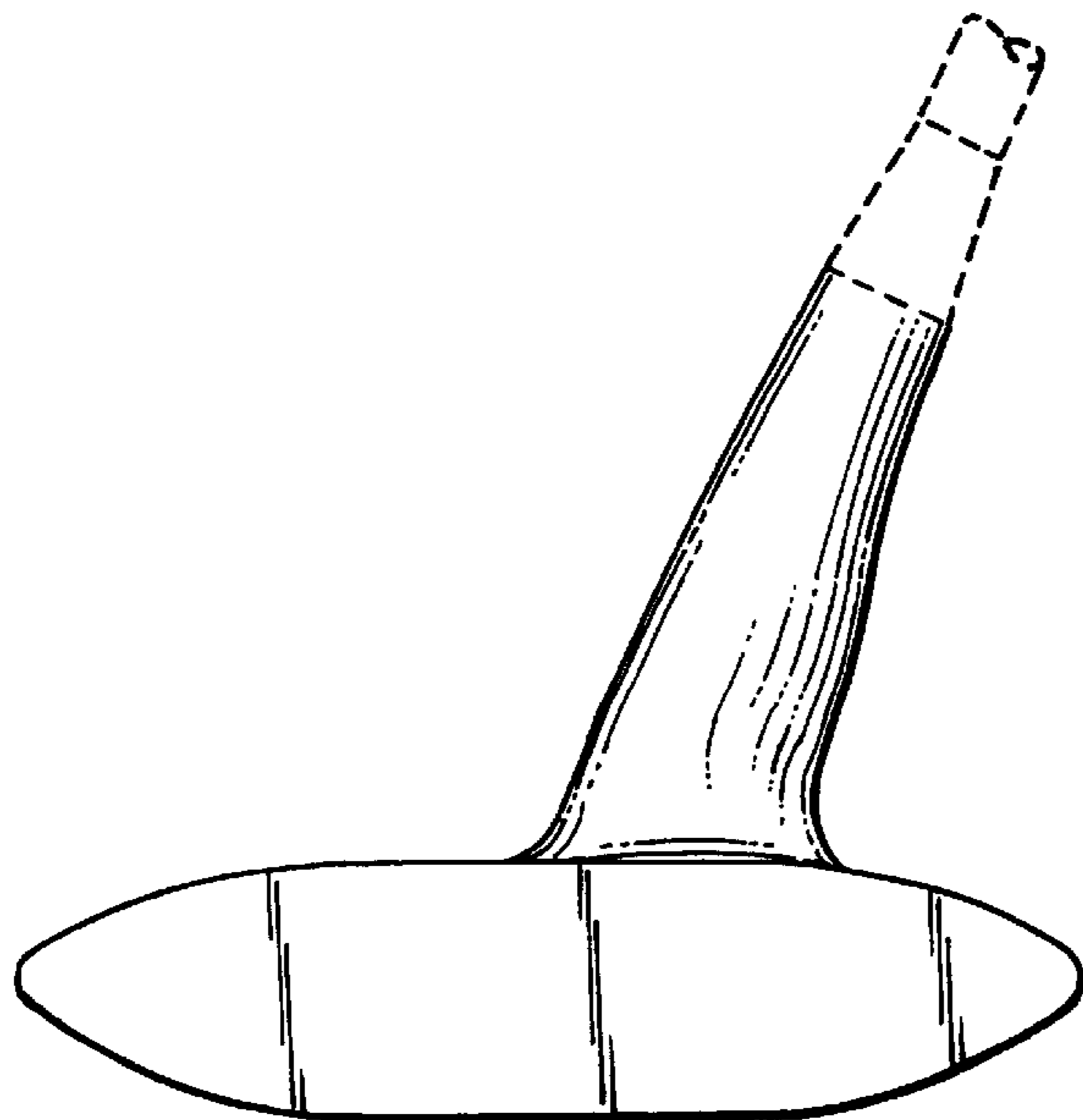
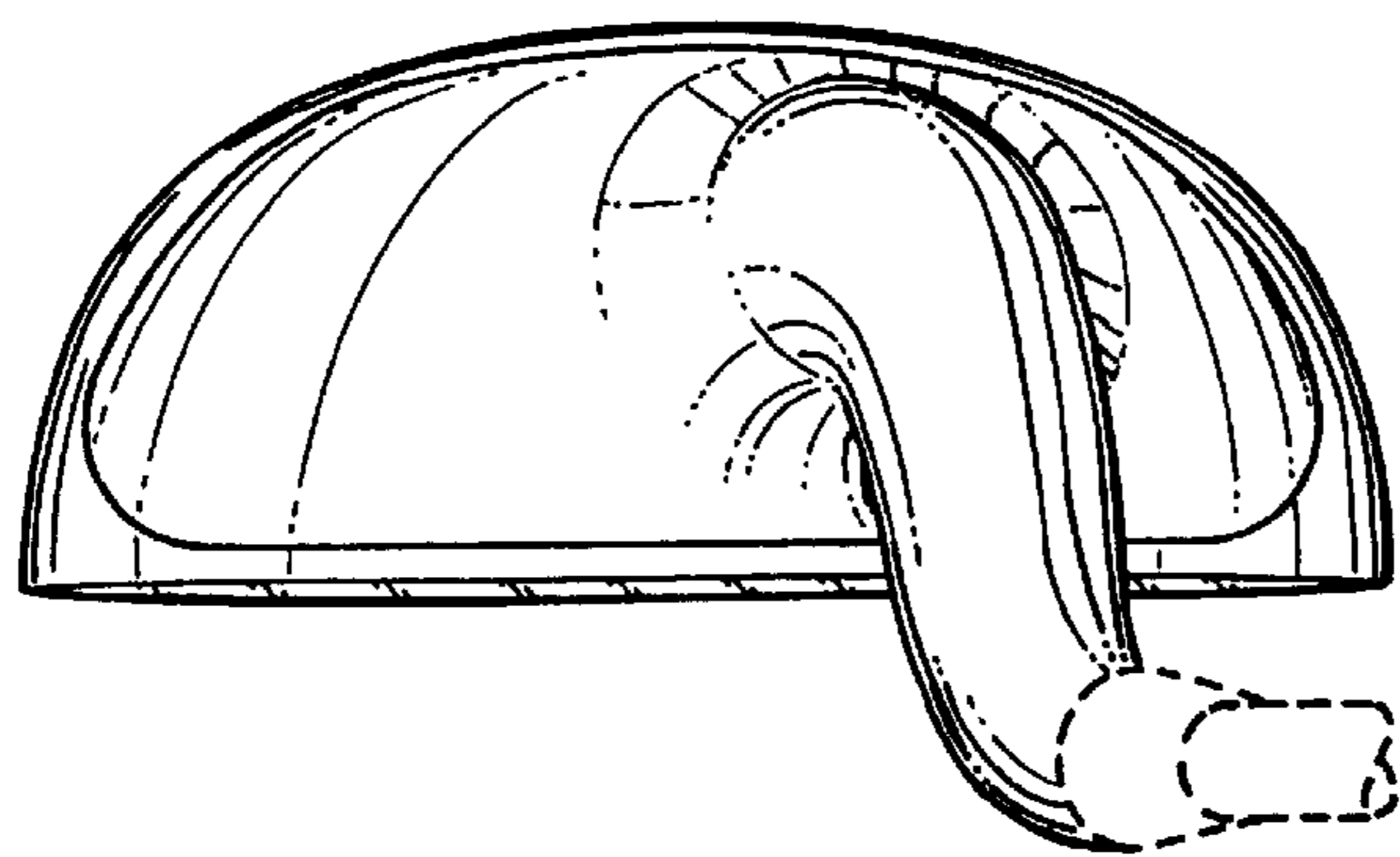
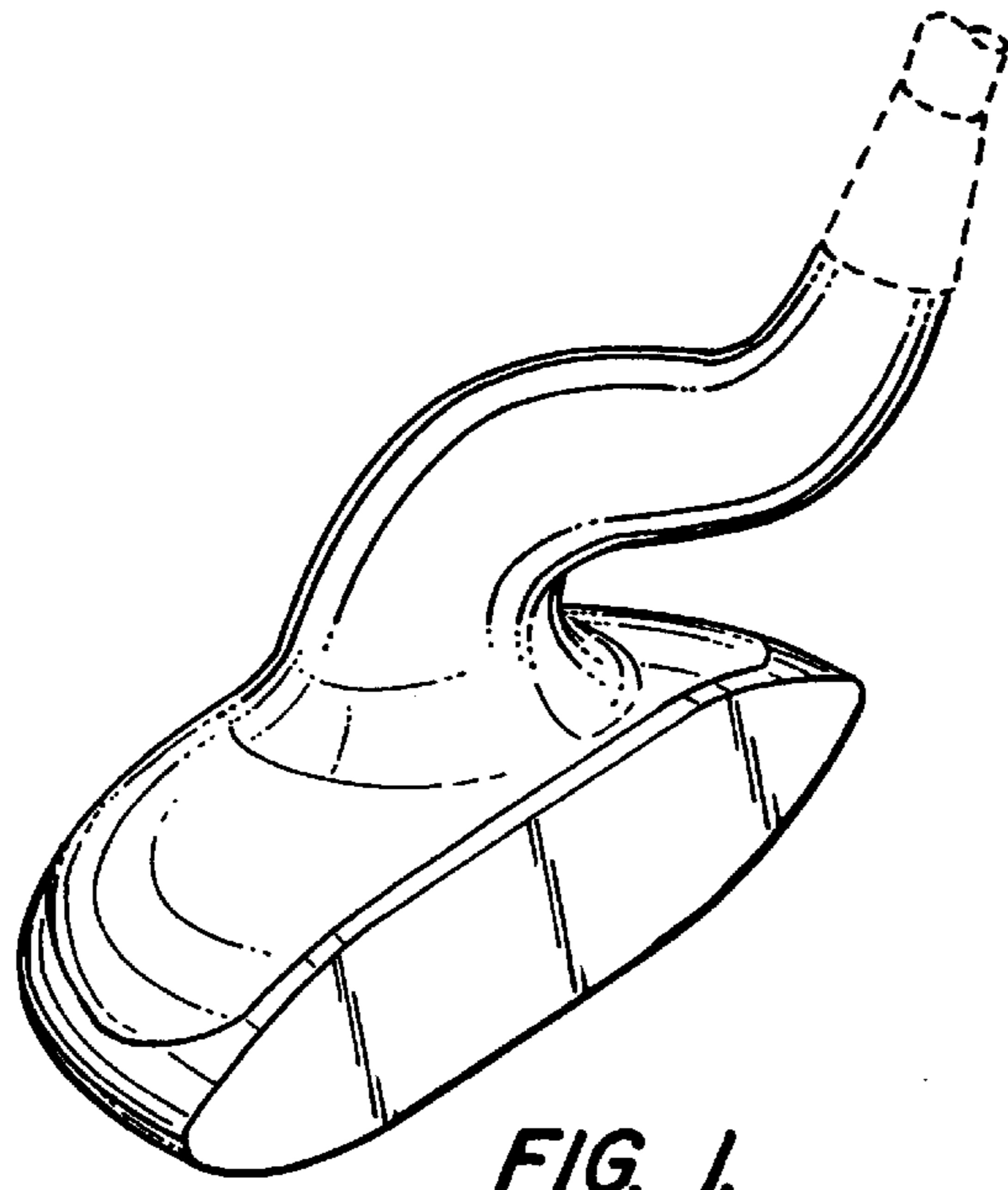
FIG. 6 is a rear elevational view thereof; and,

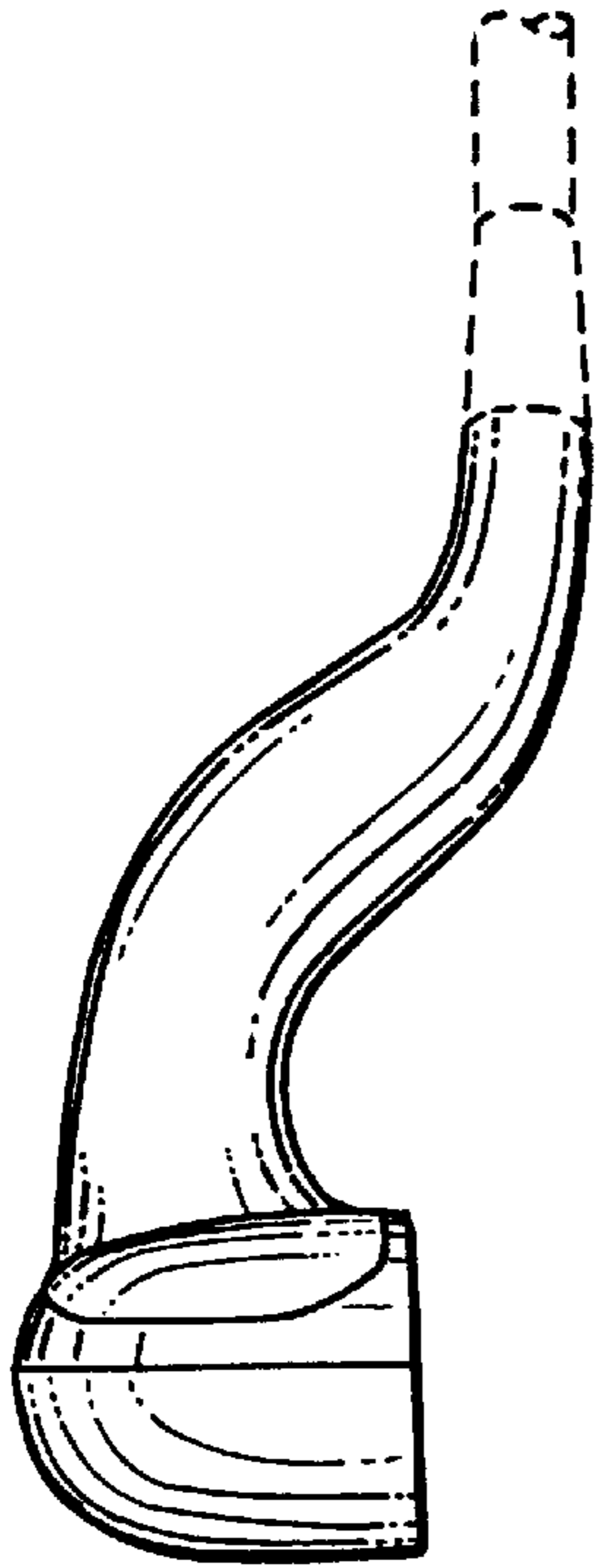

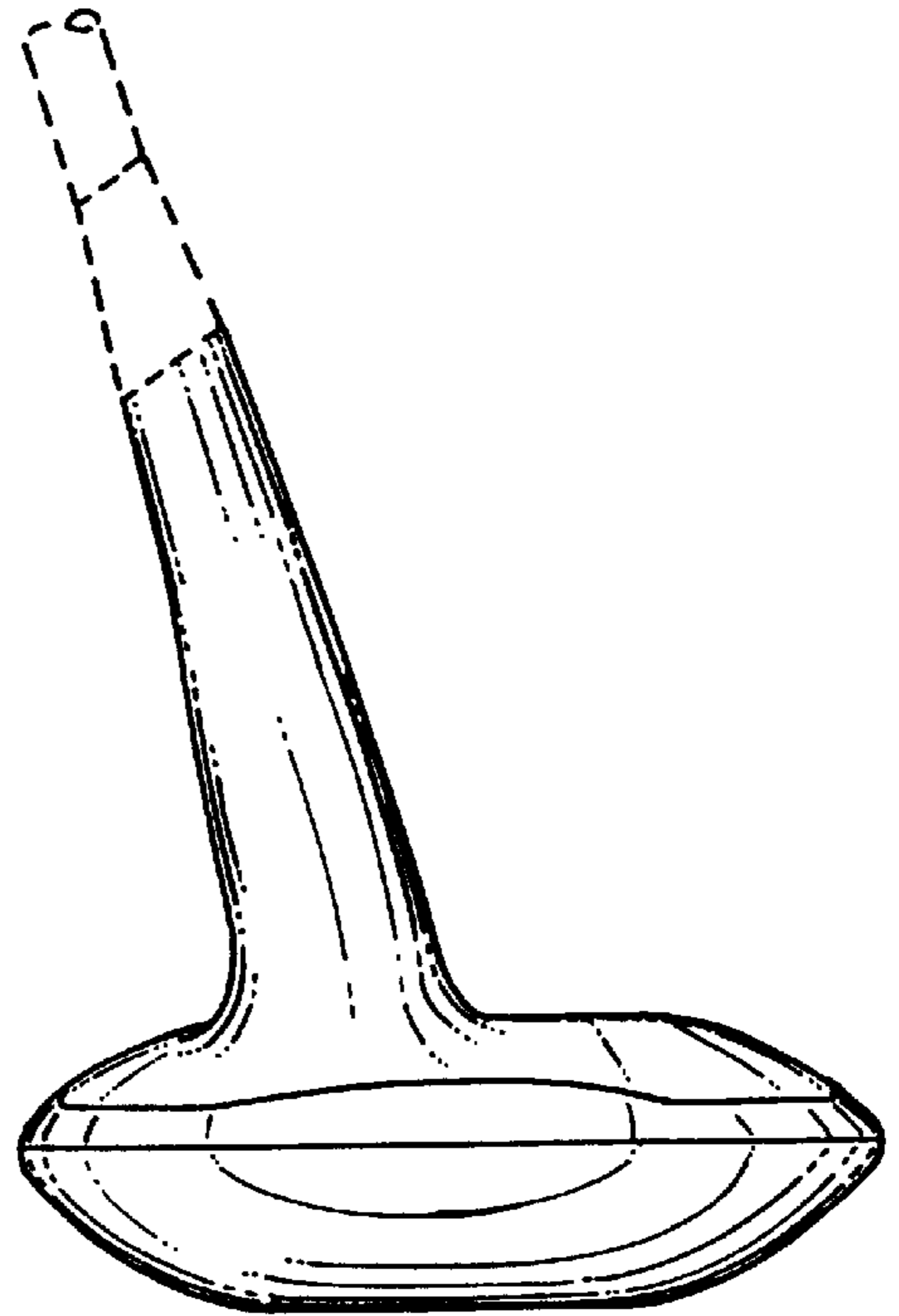

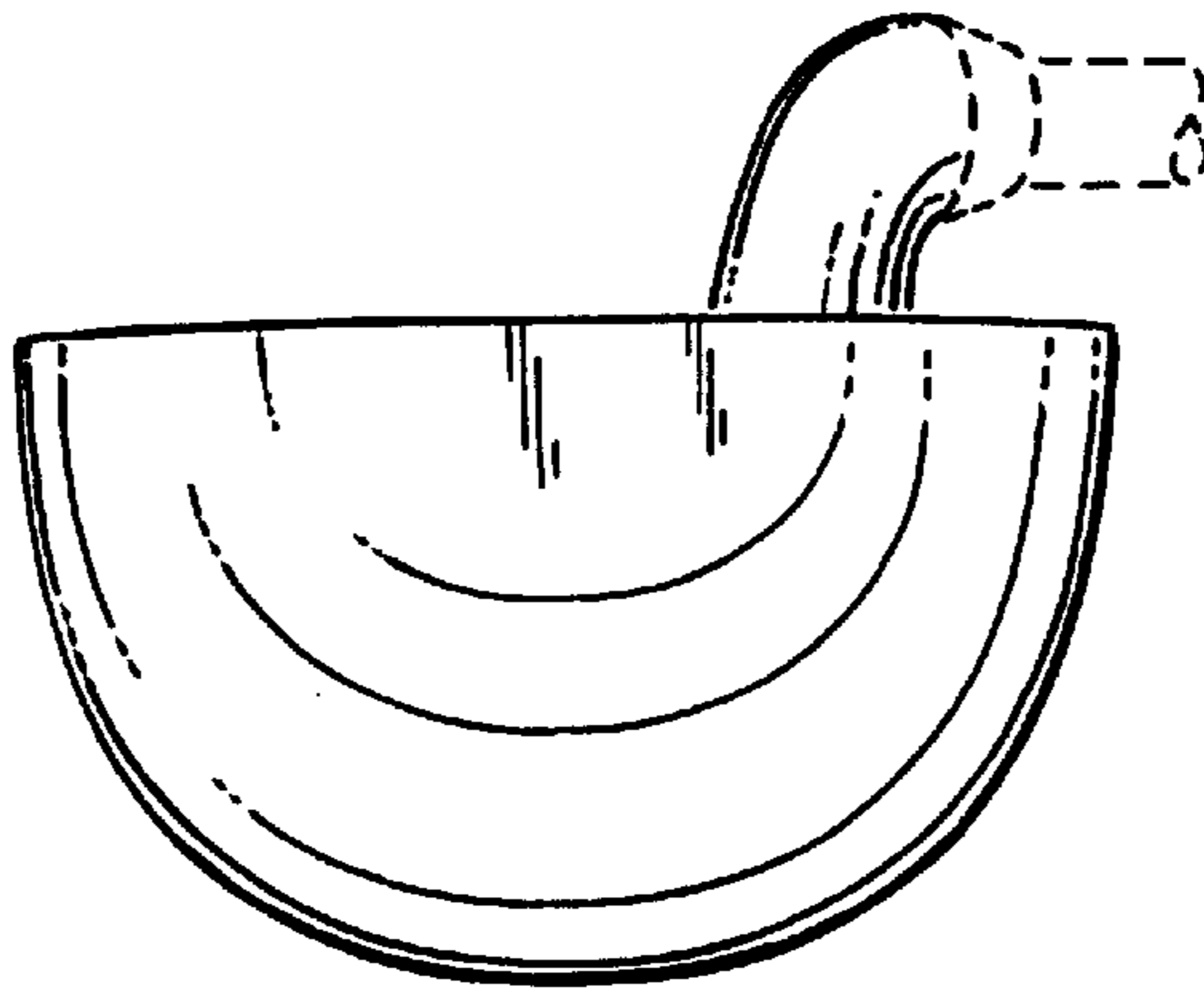
