(57) **CLAIM**

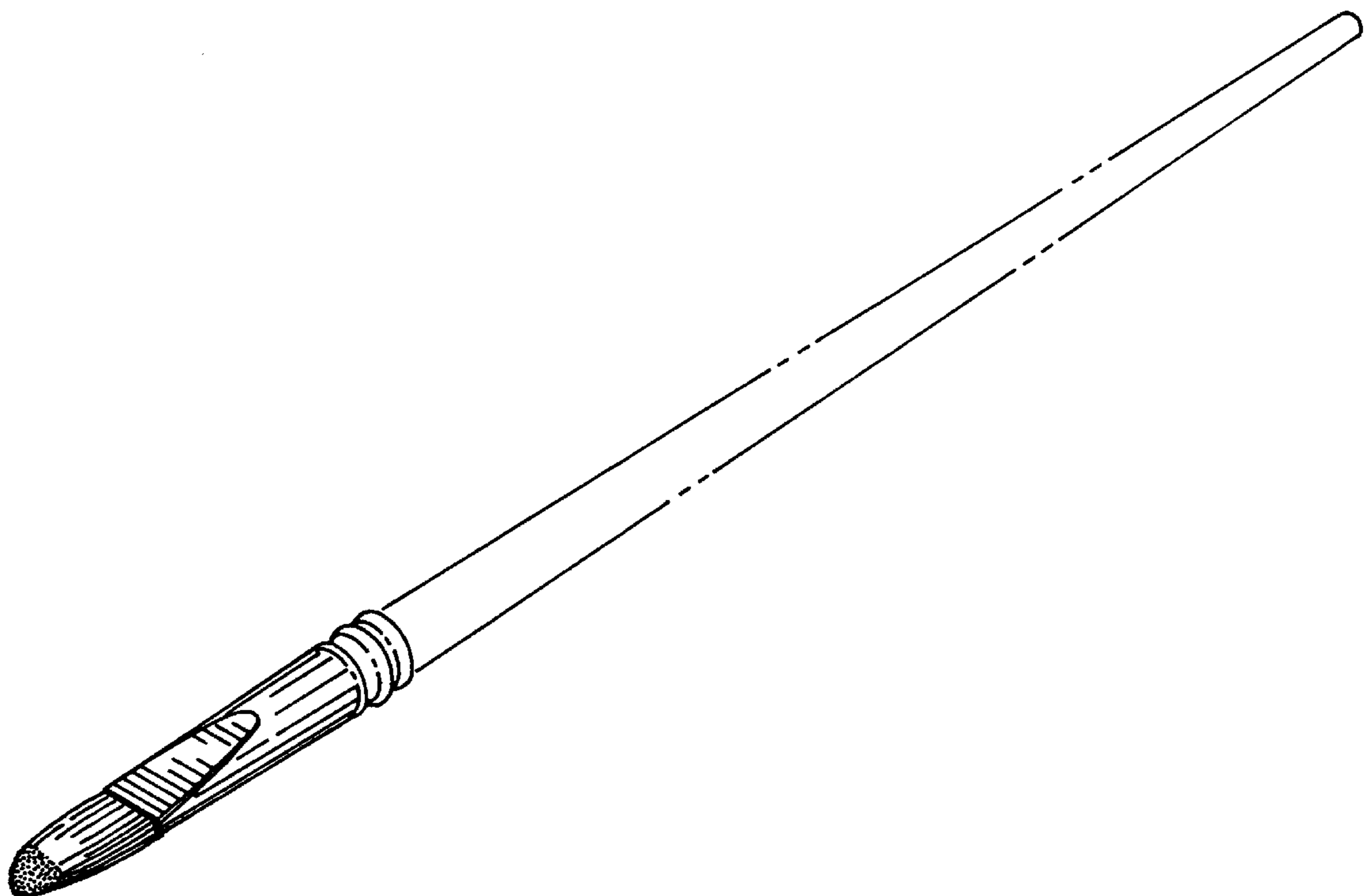
The ornamental design for “manicure brush”, as shown and described.

**DESCRIPTION**

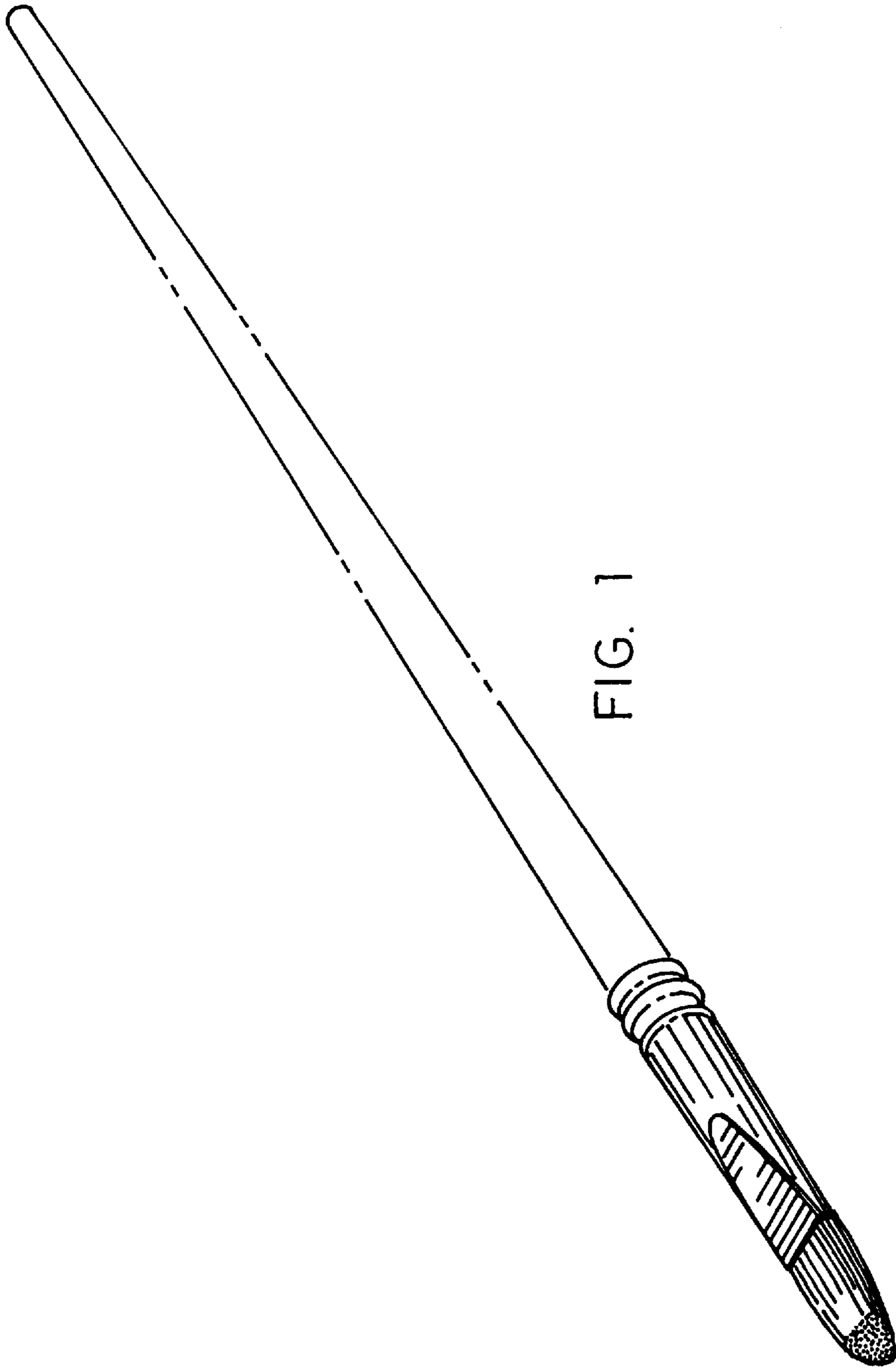

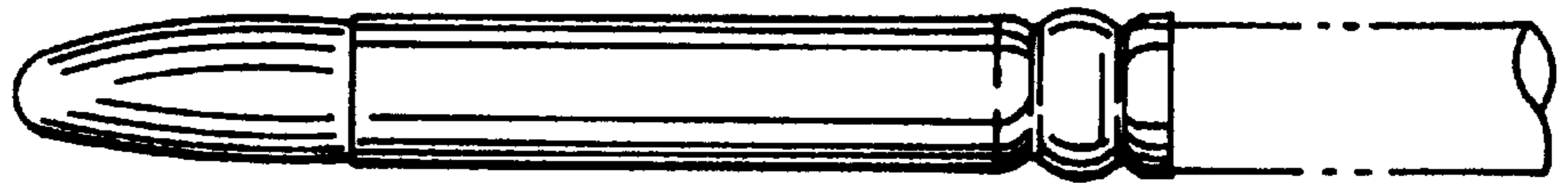

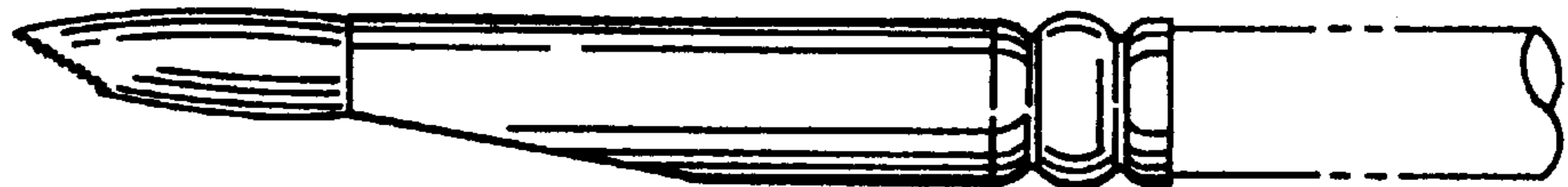

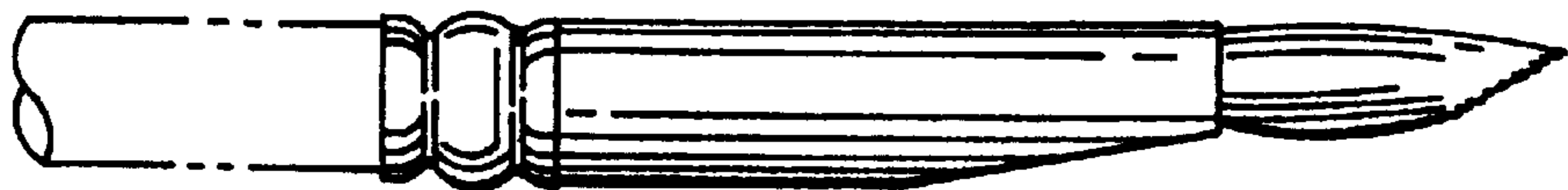
