**DESCRIPTION**

FIG. 1 is a front perspective view of a chair showing my new design;

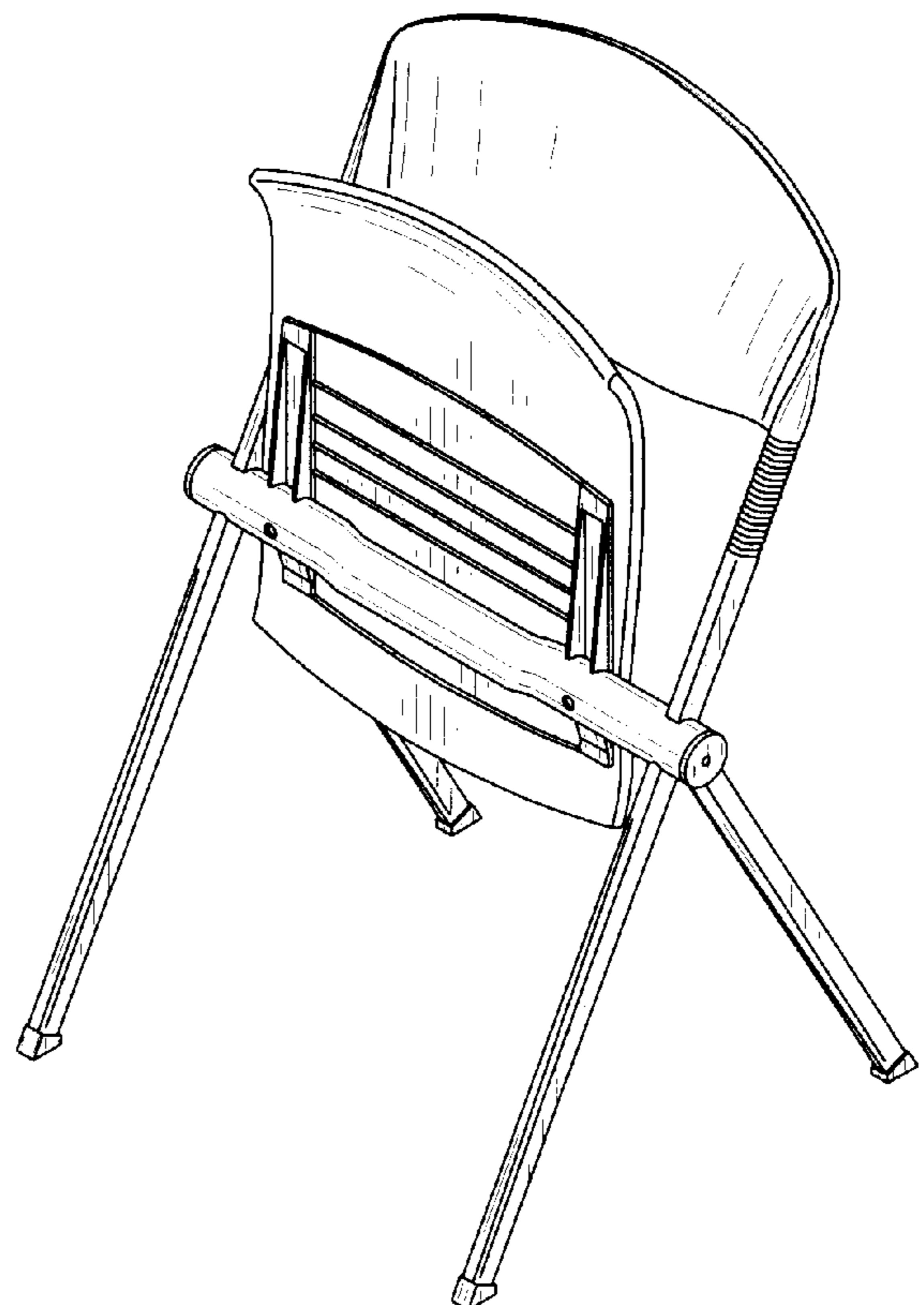
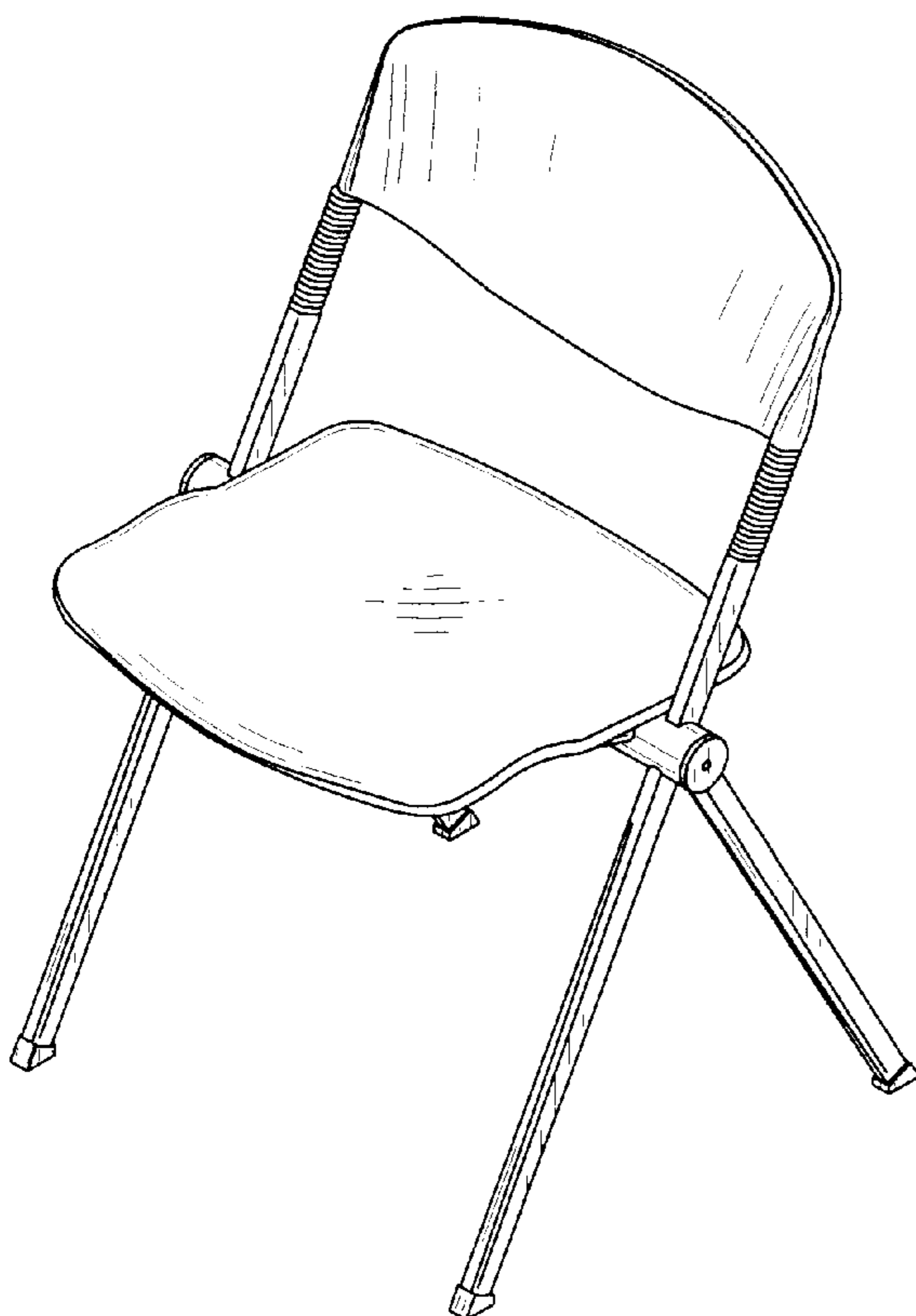

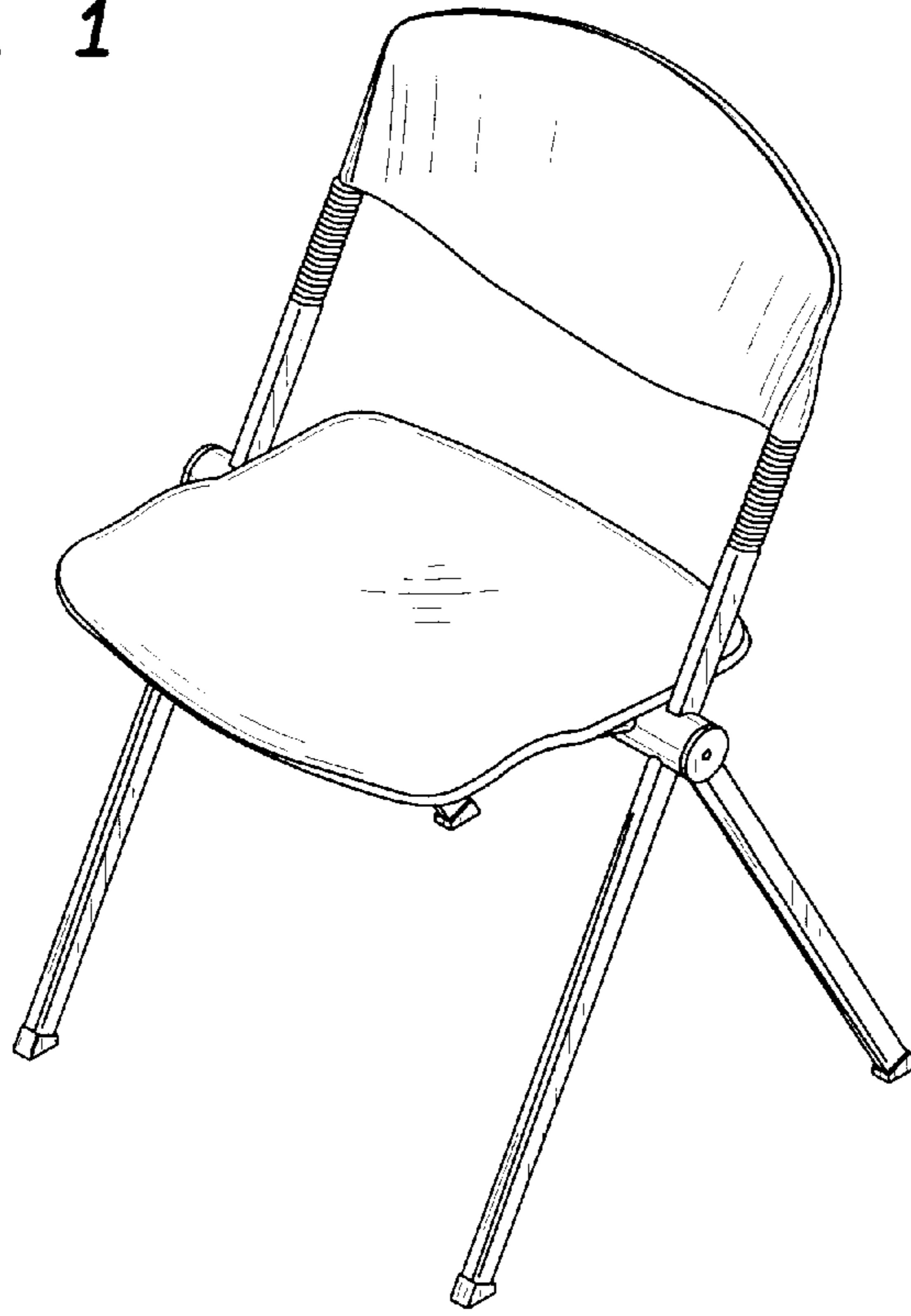
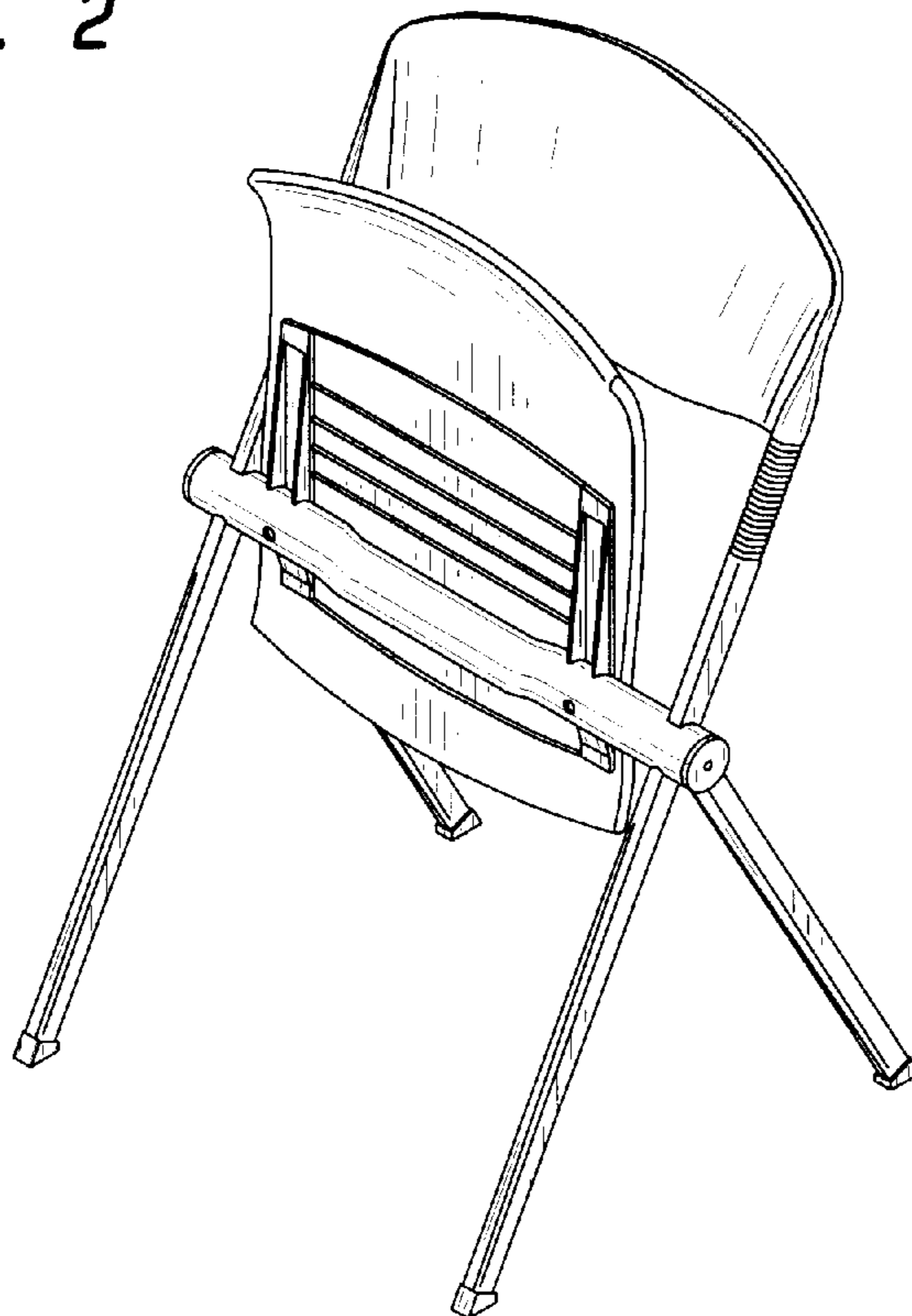
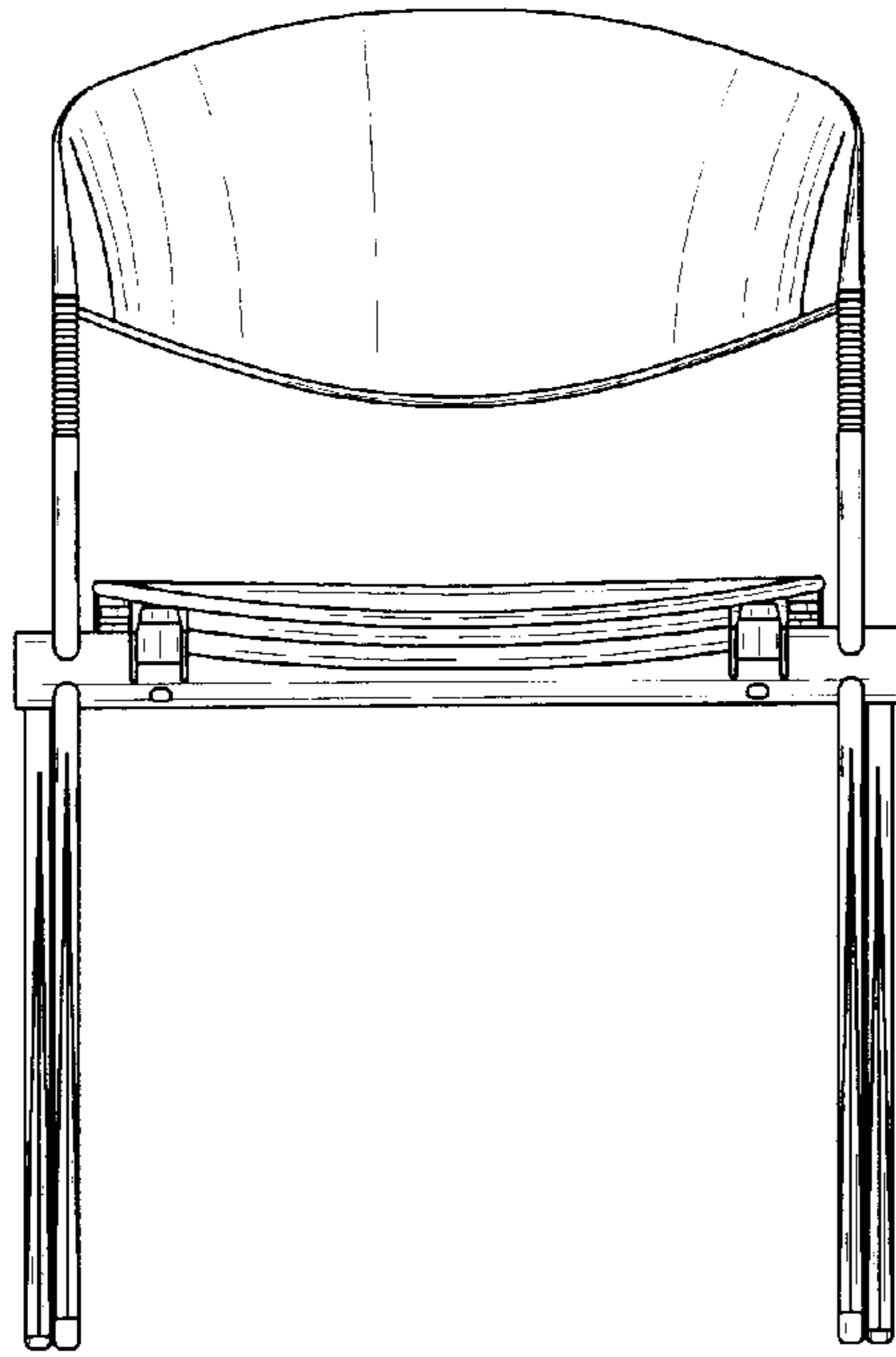


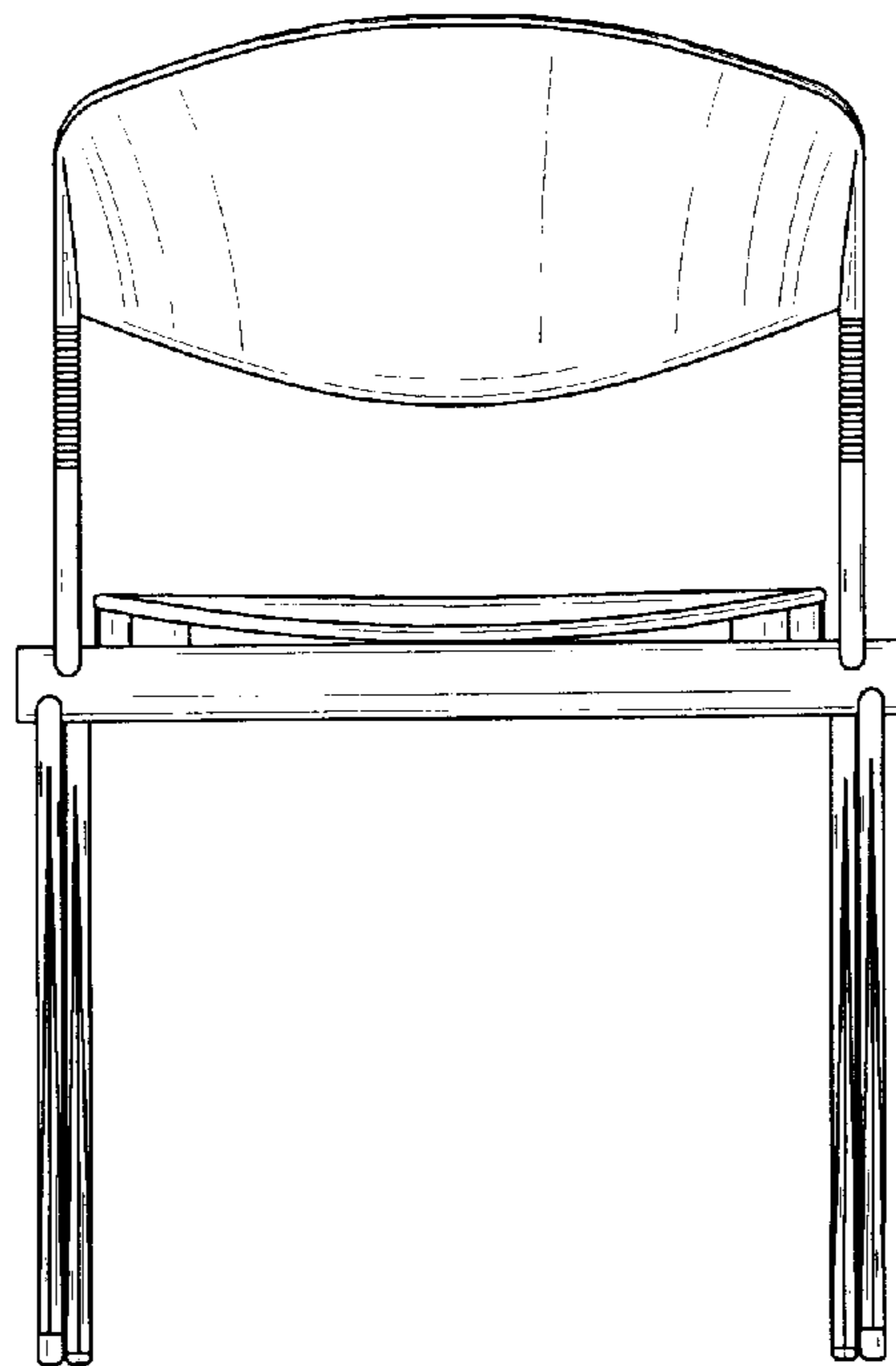

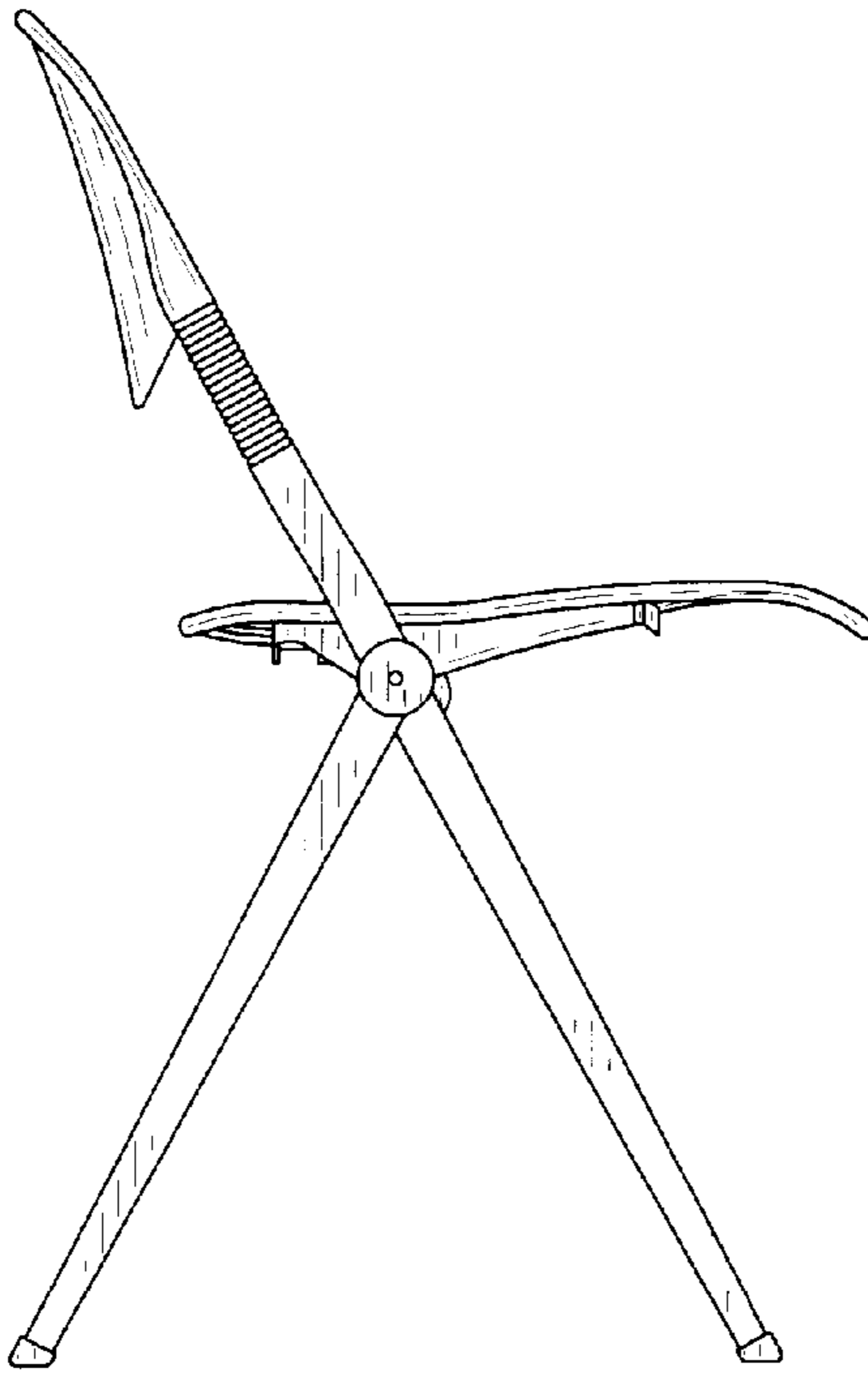

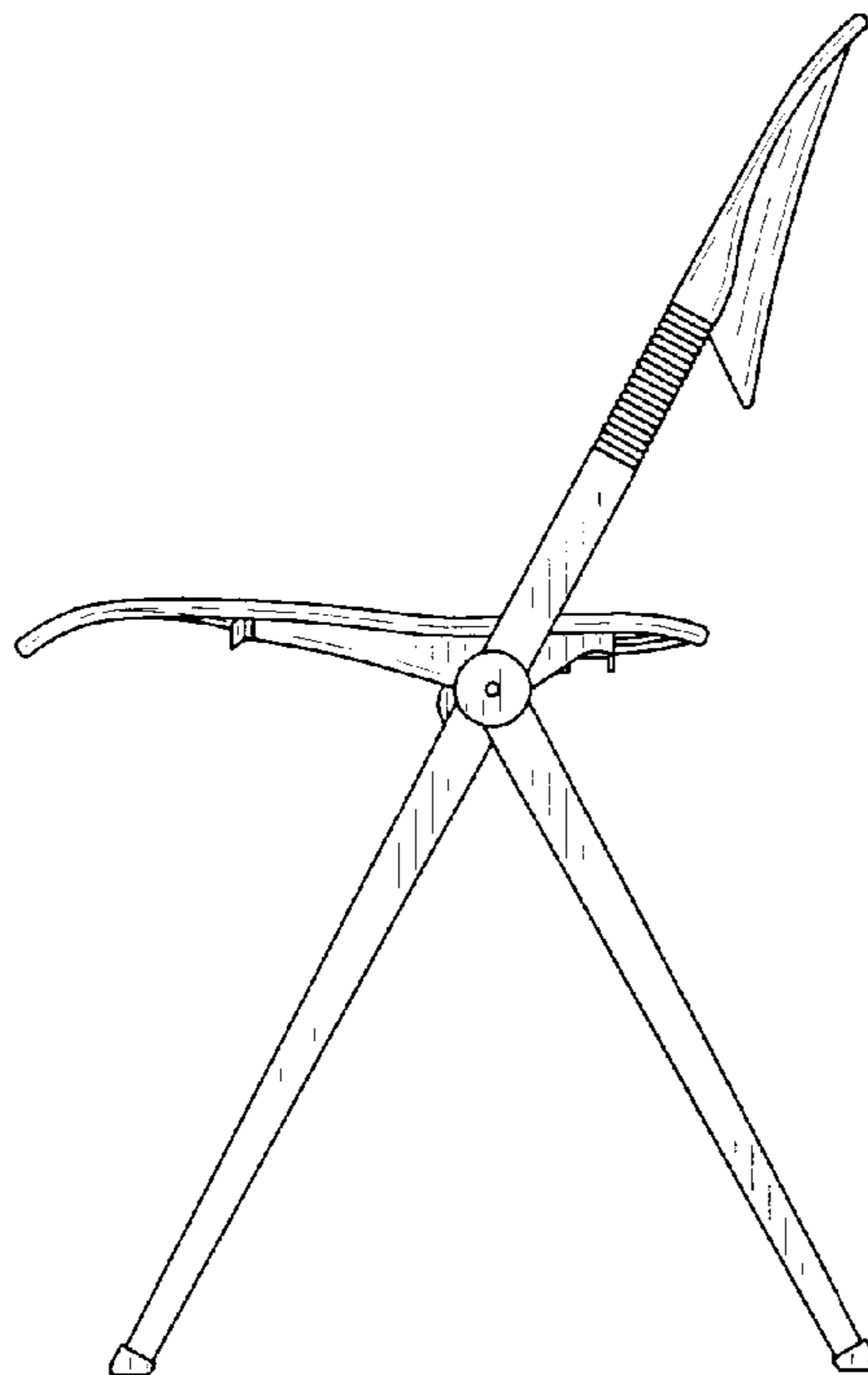

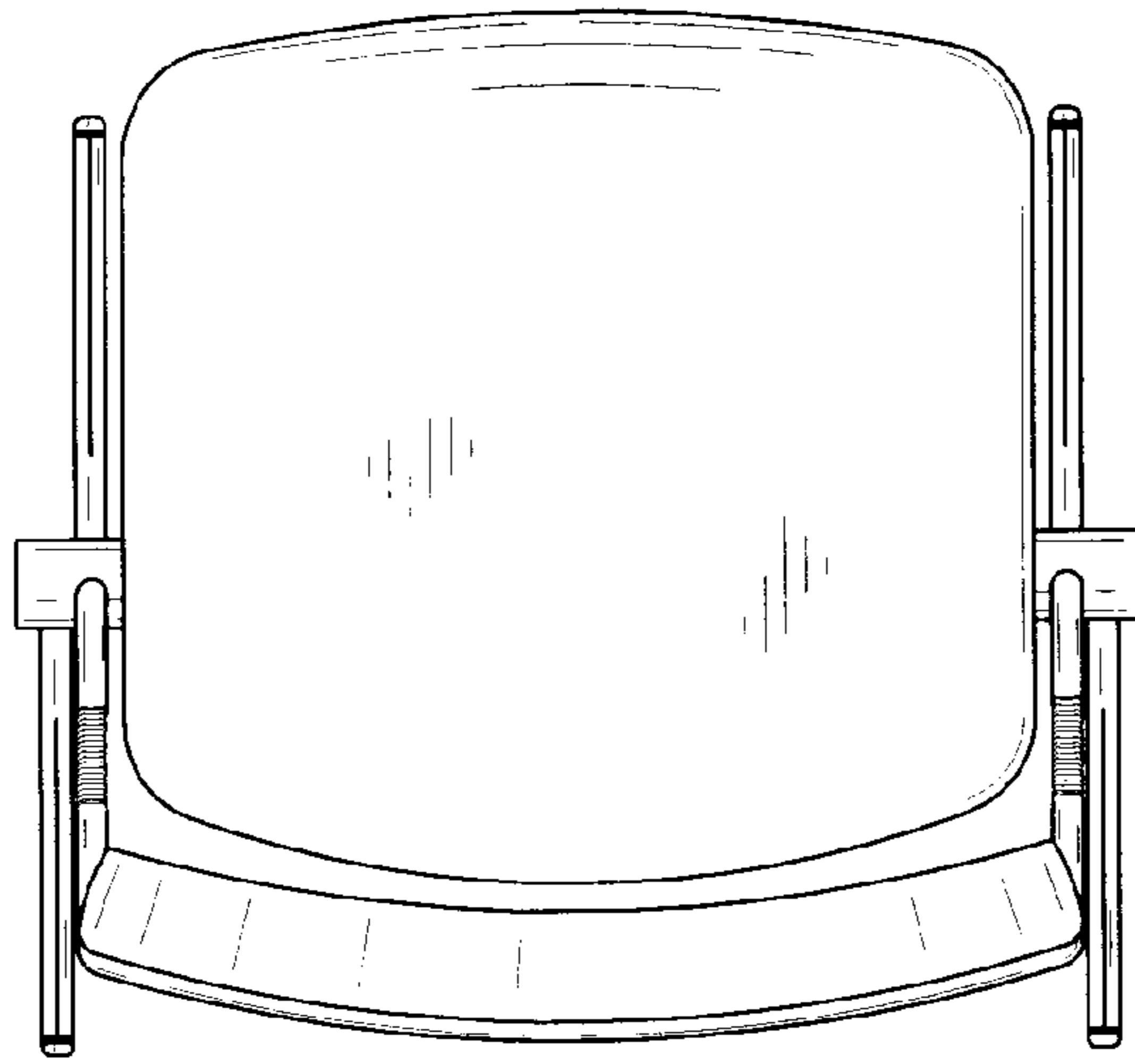
