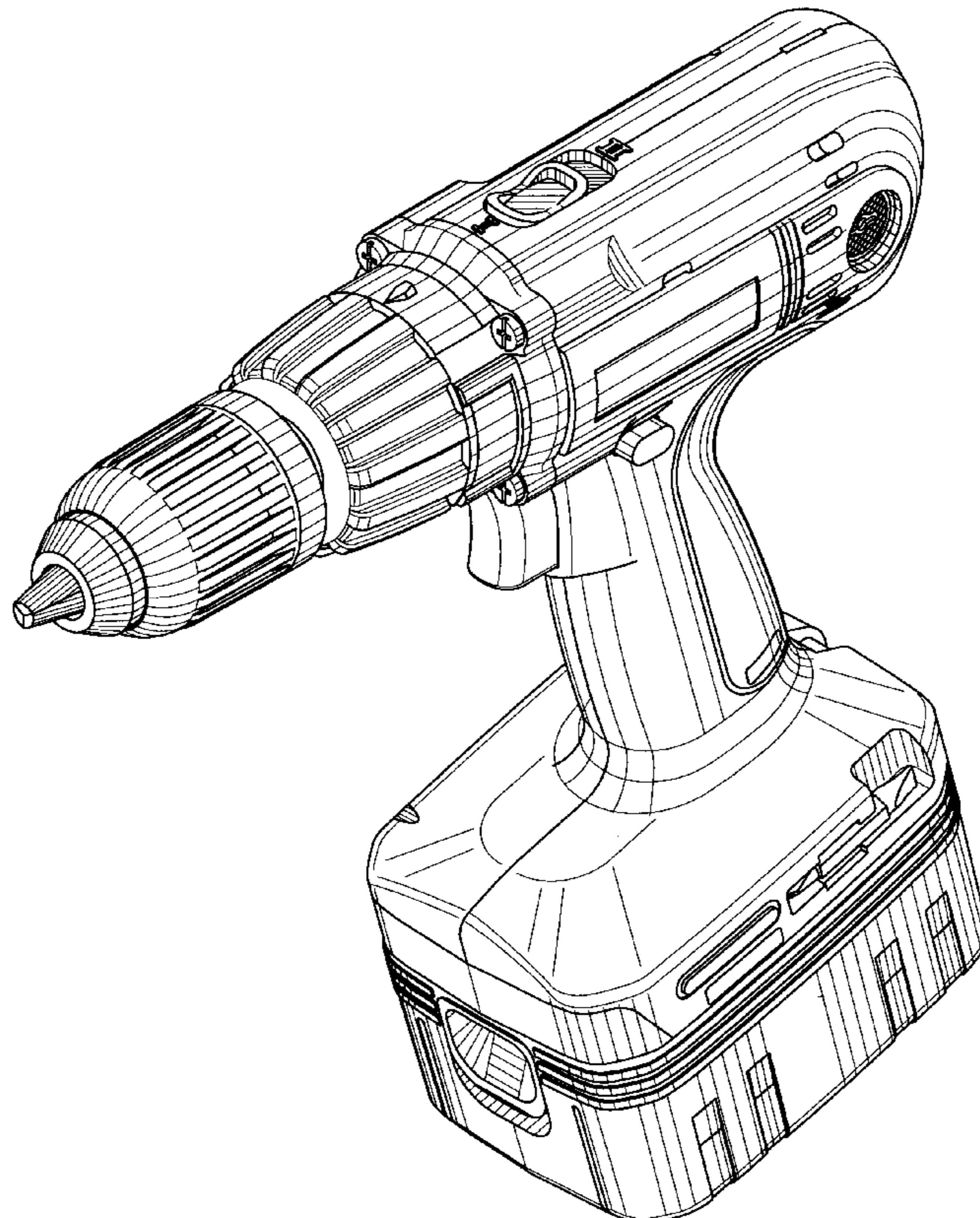
(57) **CLAIM**

The ornamental design for a portable electric drill, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable electric drill showing our new design;

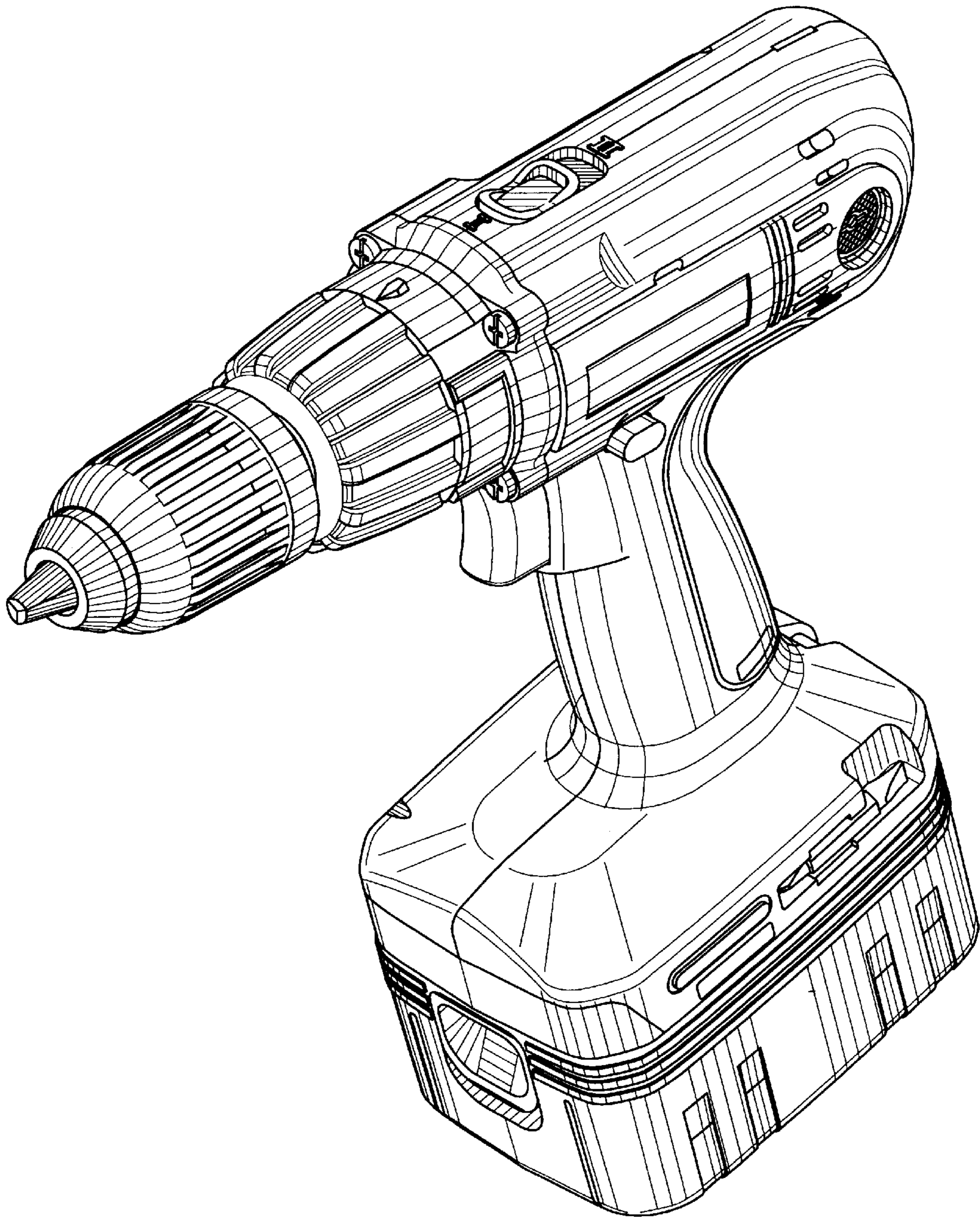

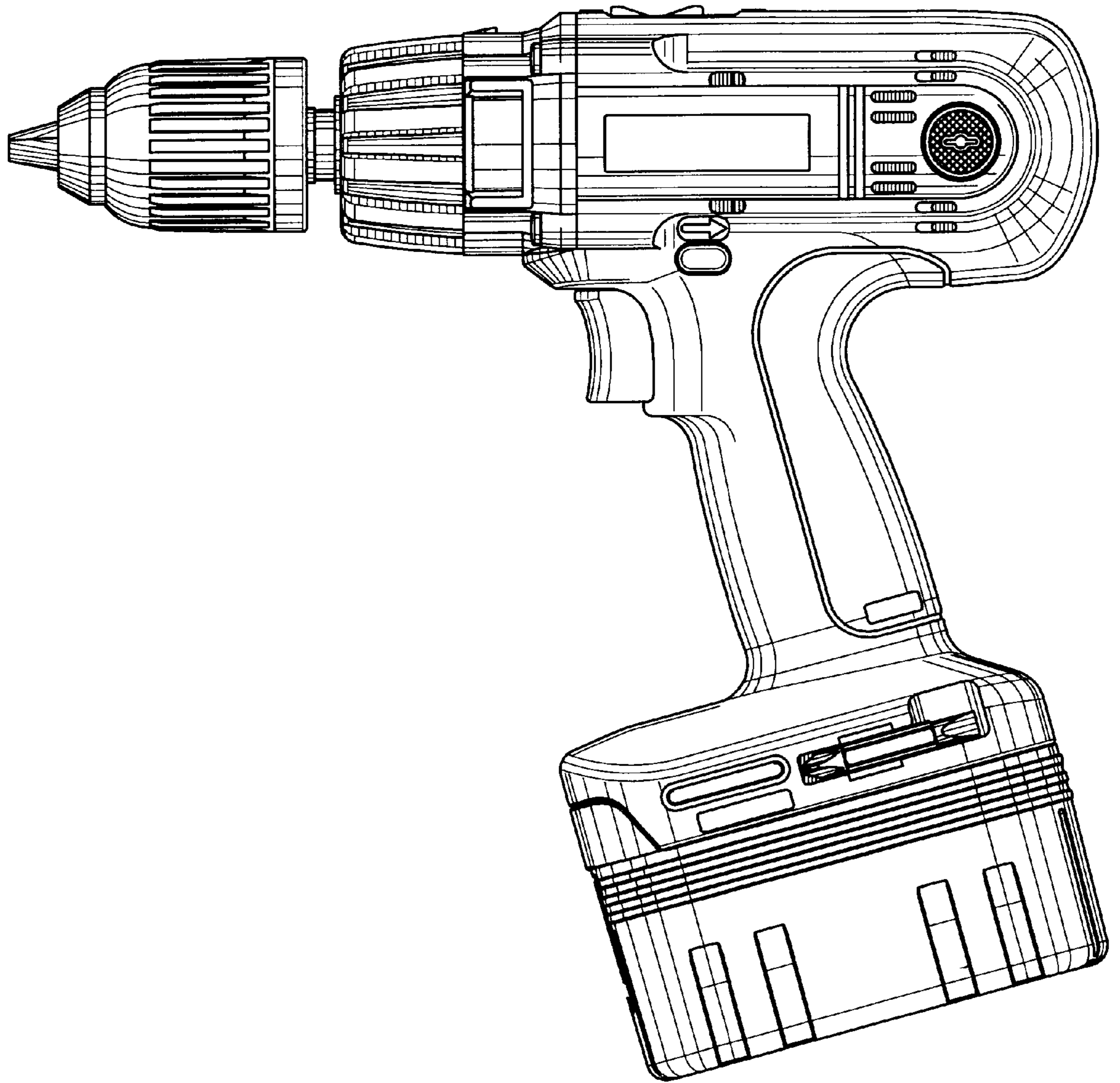

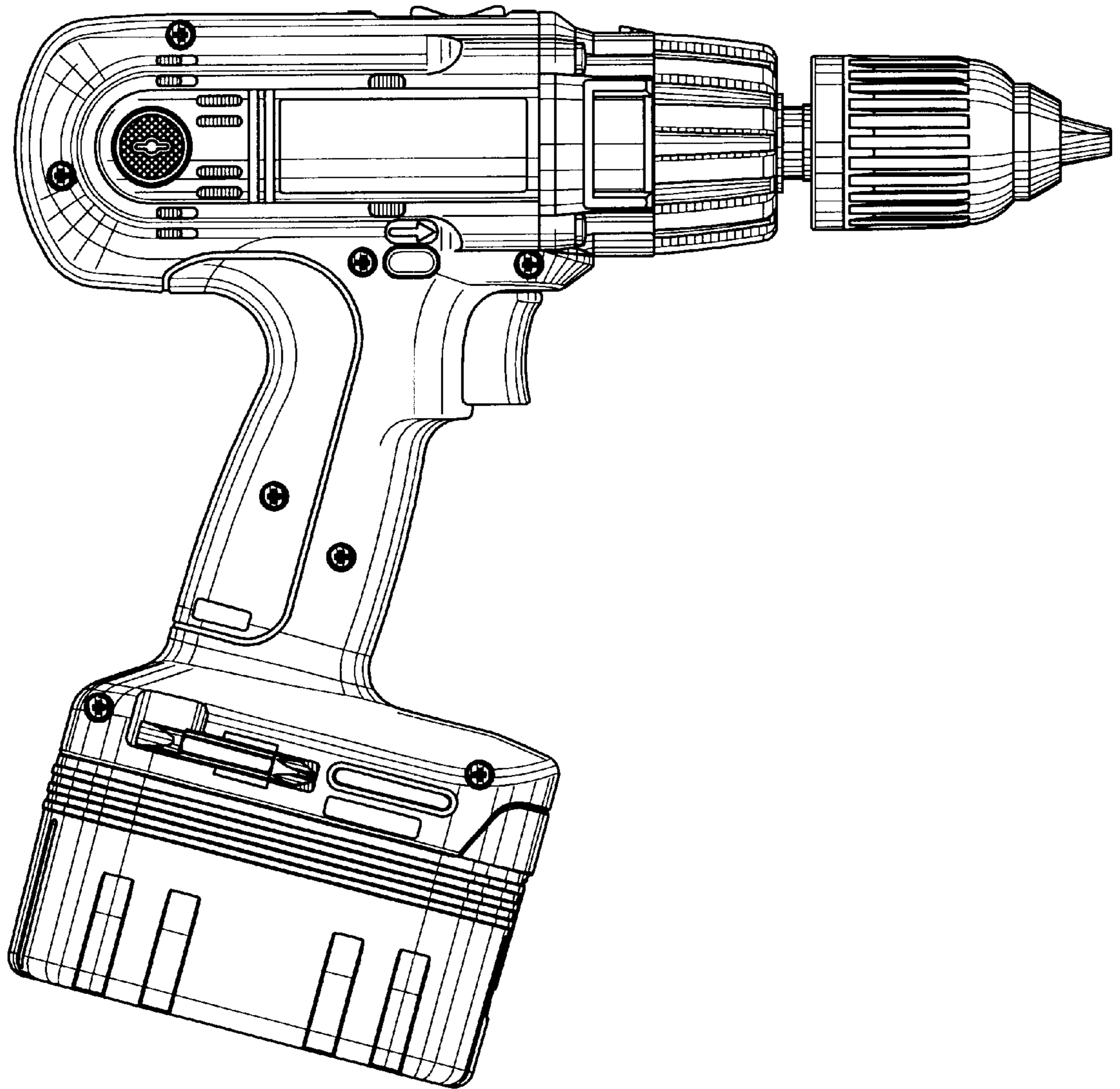

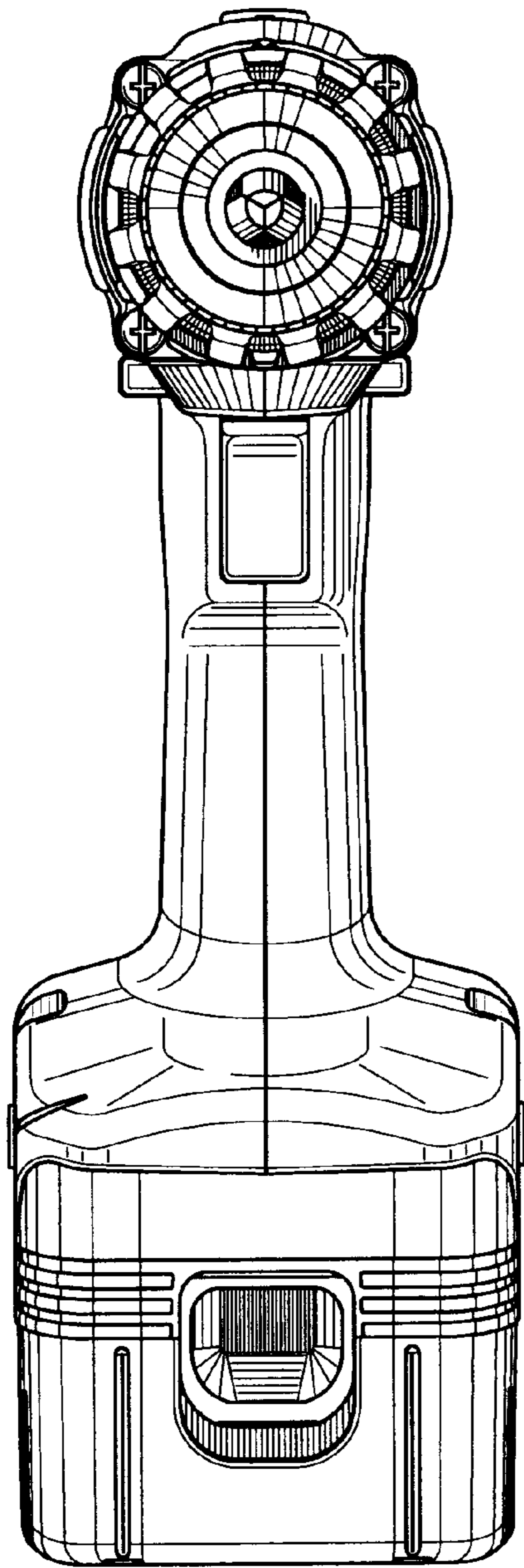

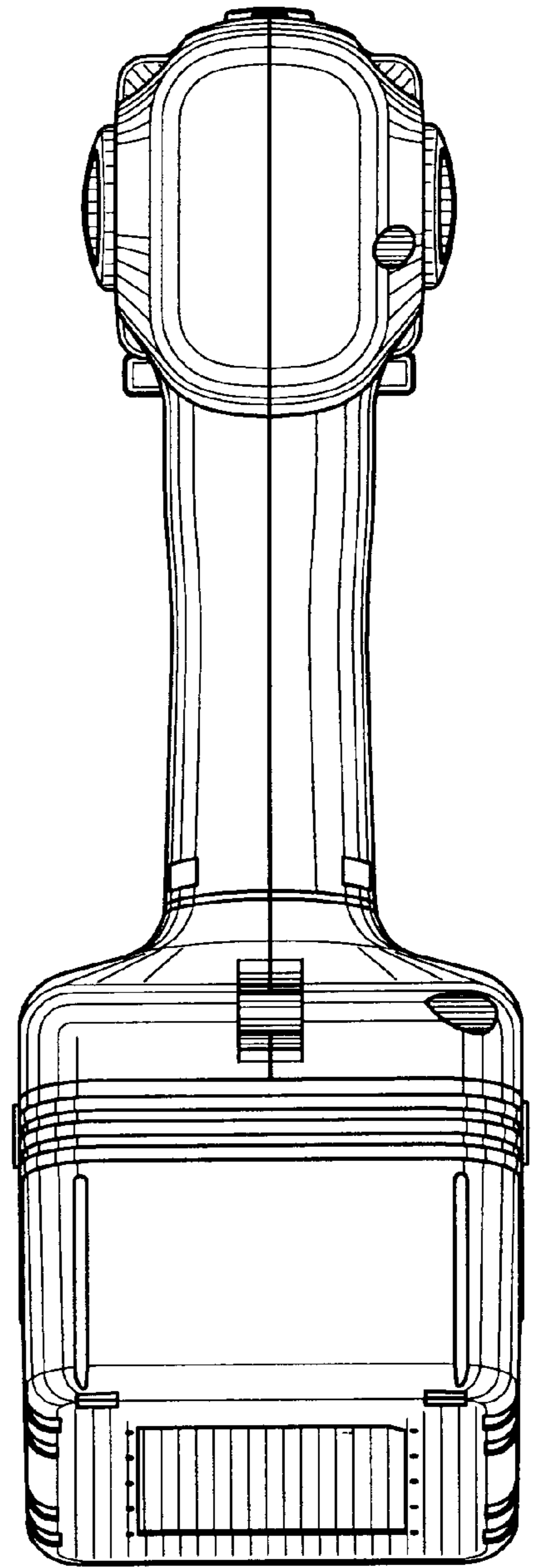

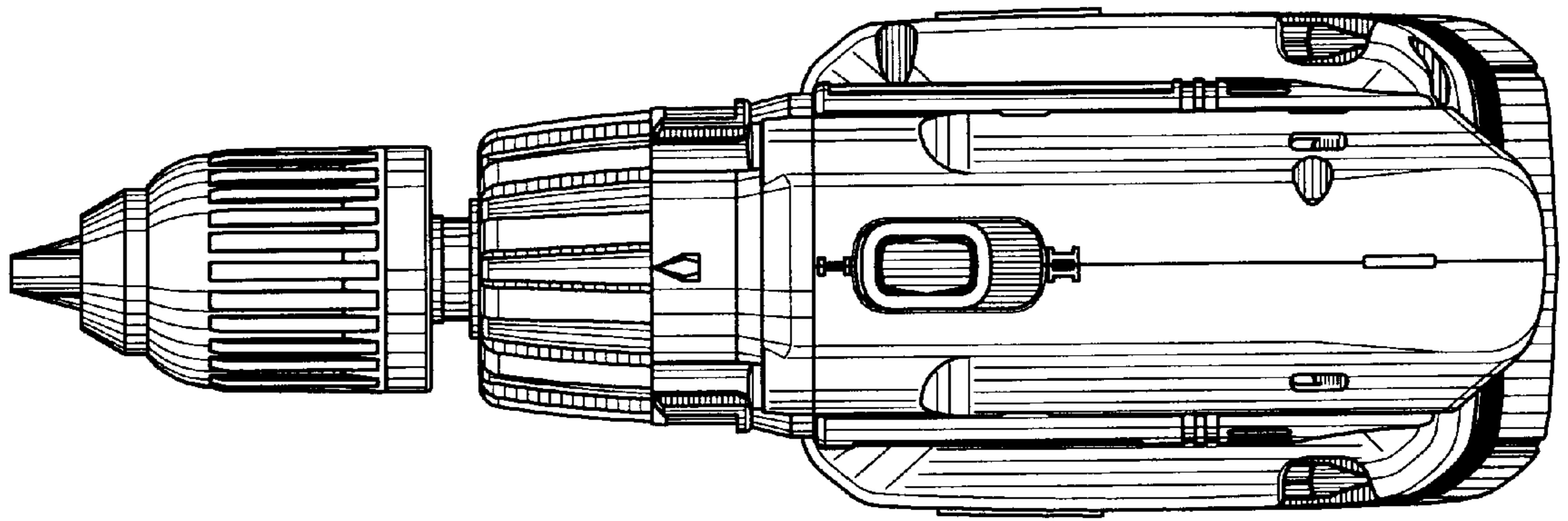

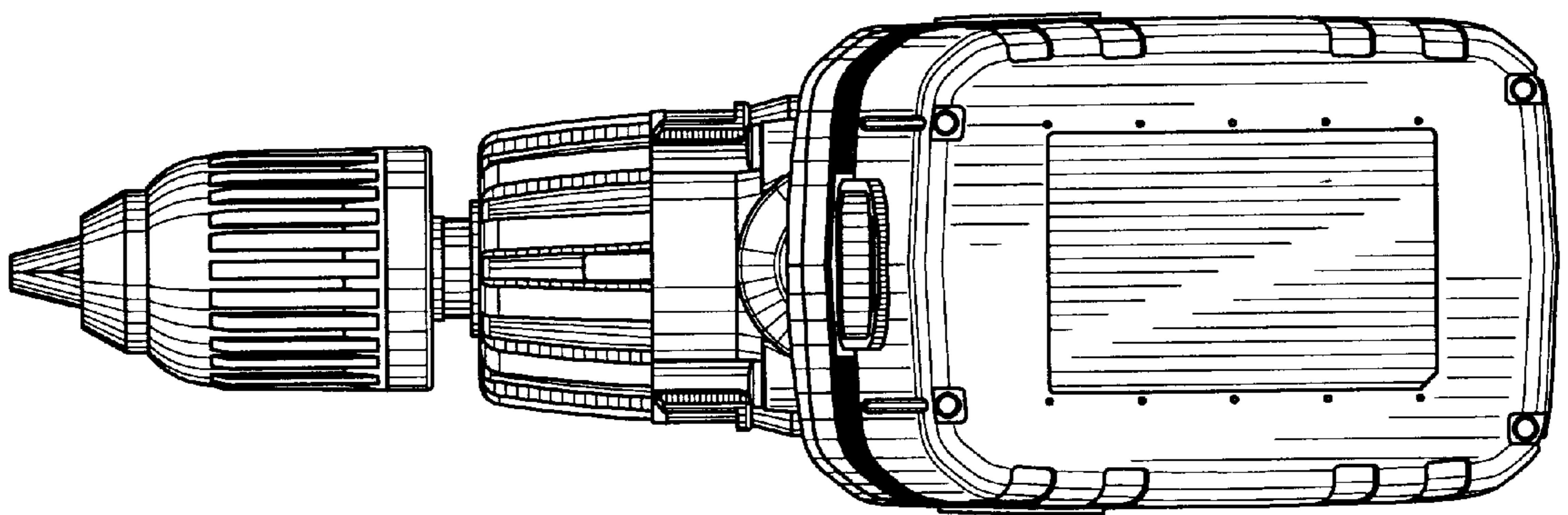
