(57) **CLAIM**

The ornamental design for a socket for screwdriver, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of the socket for screwdriver showing our new design, the rear elevational view being a mirror image thereof;

FIG. 2 is a top plan view of the socket for screwdriver;

FIG. 3 is a bottom view of the socket for screwdriver;

FIG. 4 is a right side elevational view of the socket for screwdriver, the left side elevational view being a mirror image thereof;

FIG. 5 is an enlarged cross sectional view along the line 5—5 of FIG. 1 of the socket for screwdriver;

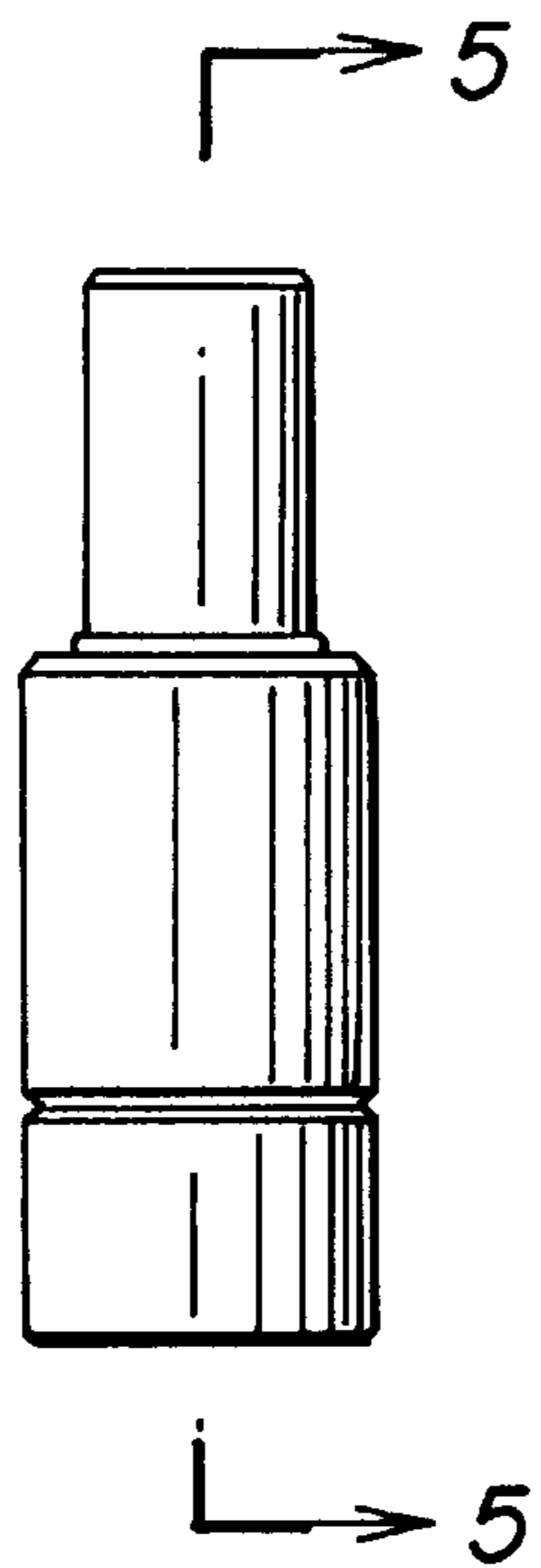
FIG. 6 is a front elevational view of the socket for screwdriver; and,

FIG. 7 is a front elevational view of the socket for screwdriver in an inverted position.

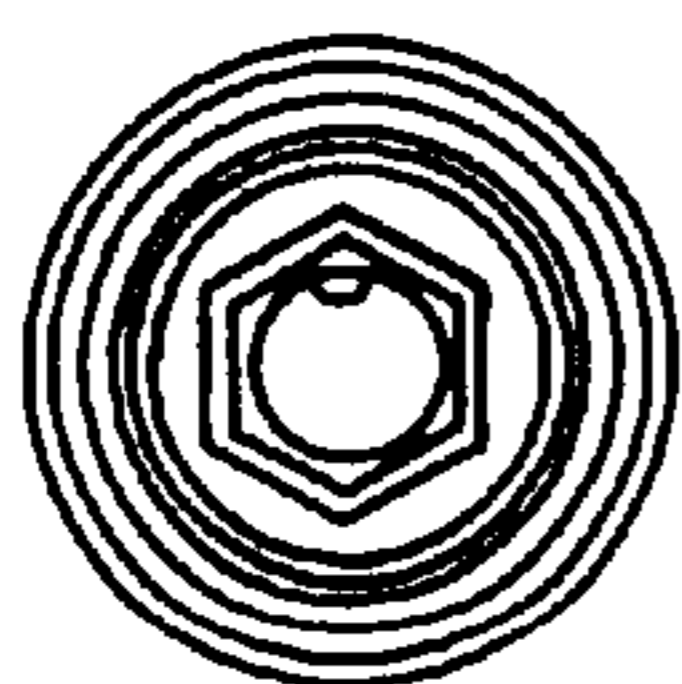
The broken line showings of the screwdriver and bolt in FIGS. 6 and 7 are for illustrative purposes only and form no part of the claimed design.

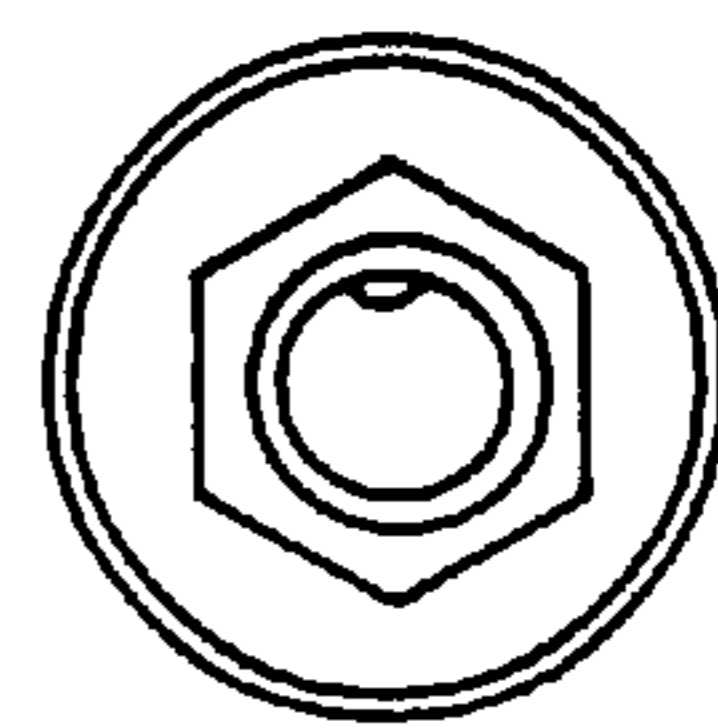




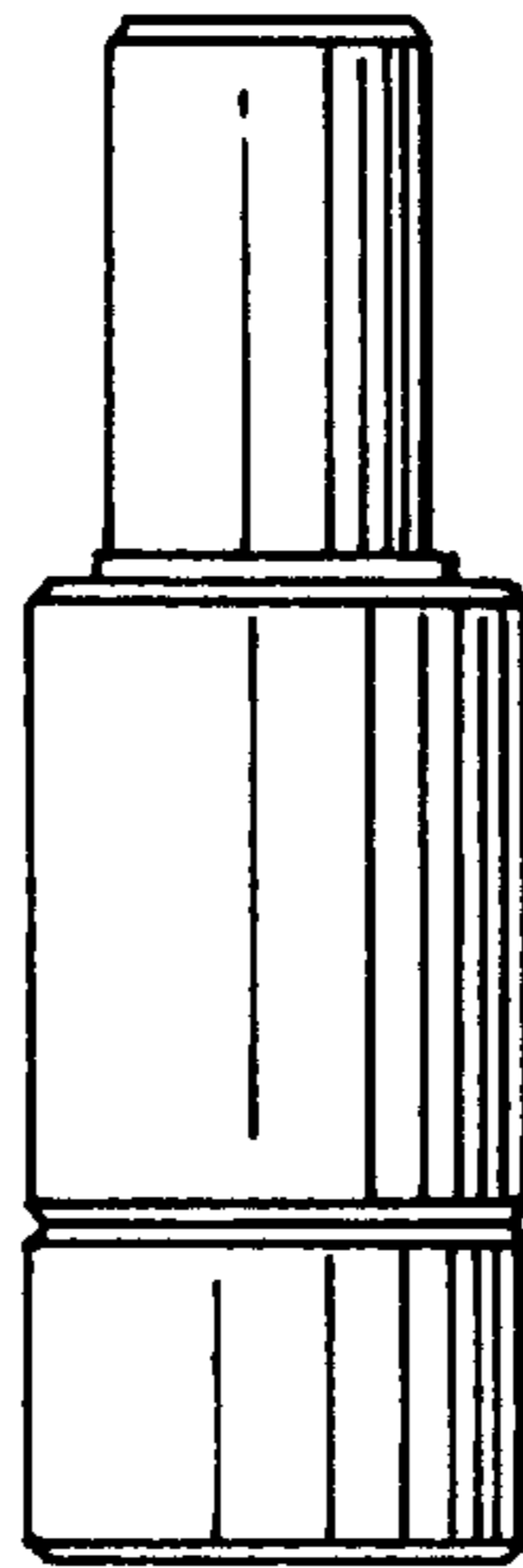

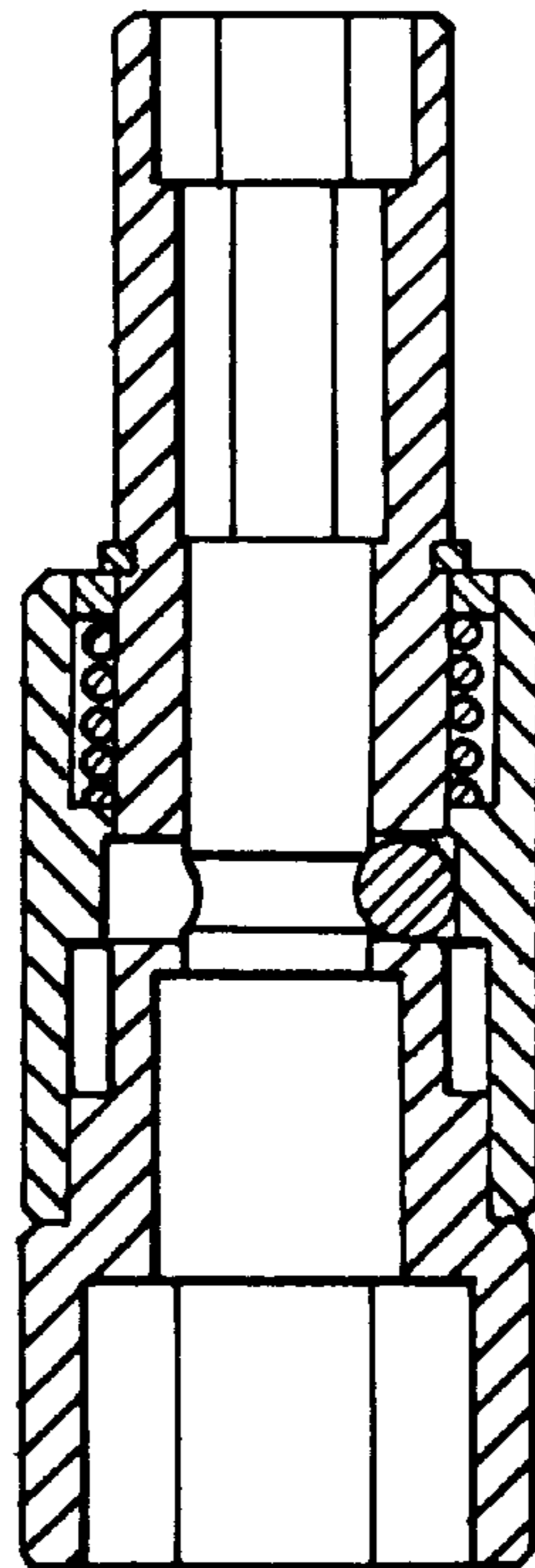

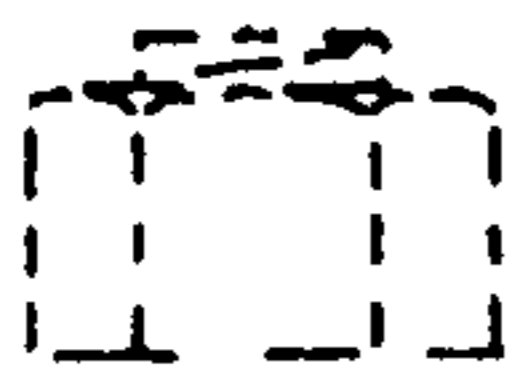

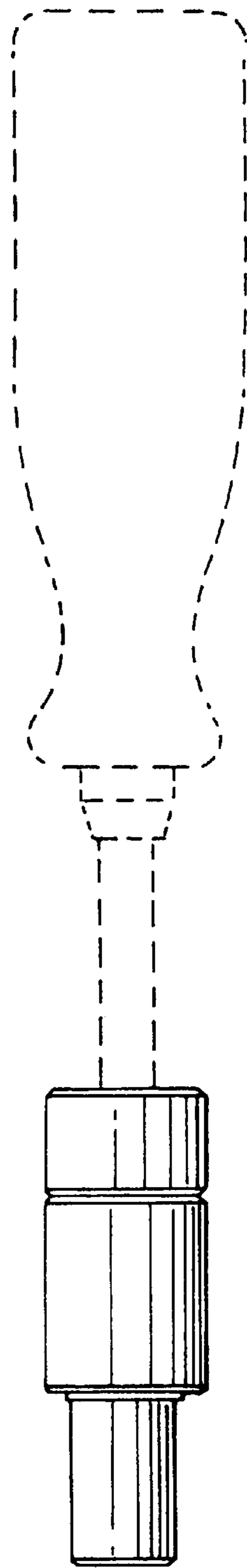
