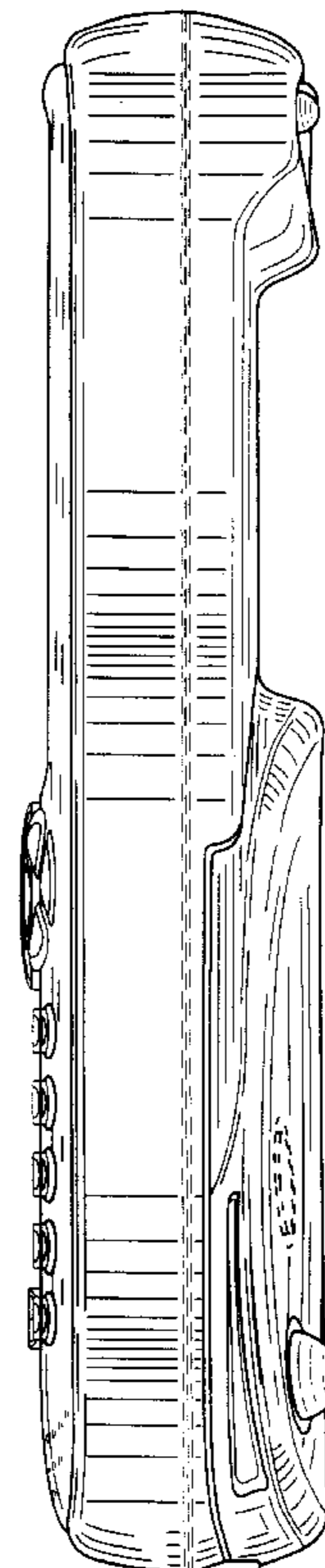
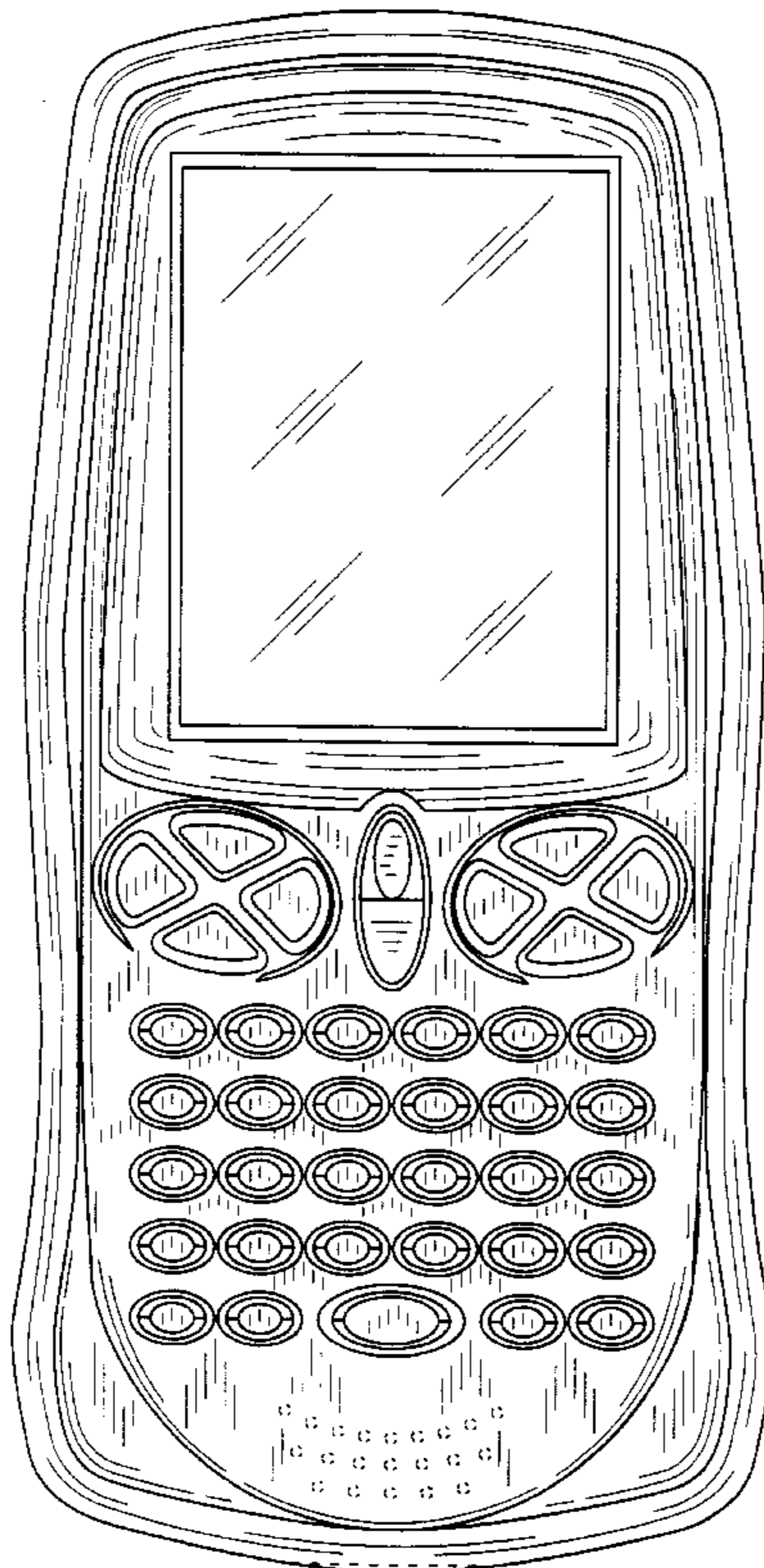
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front view of an electronic device embodying our design;

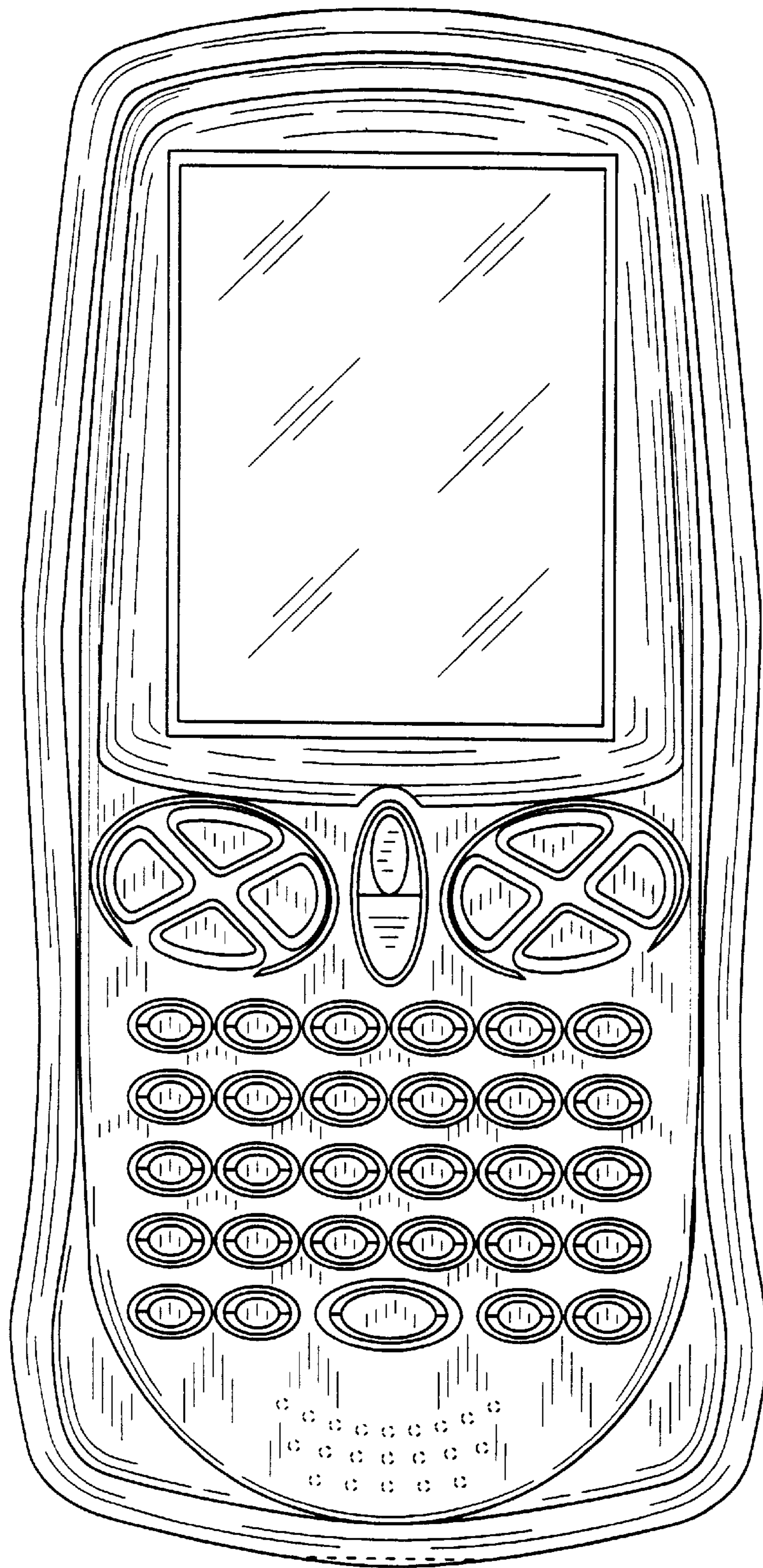

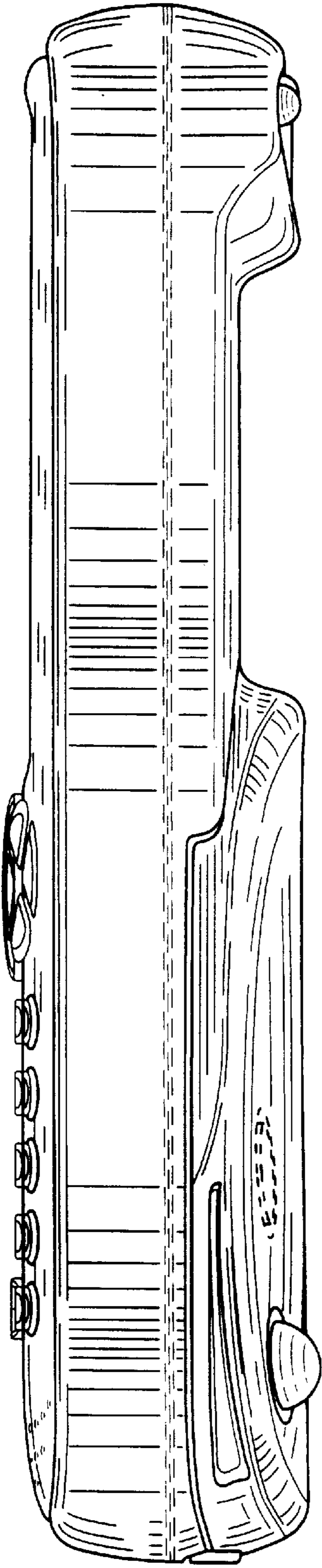

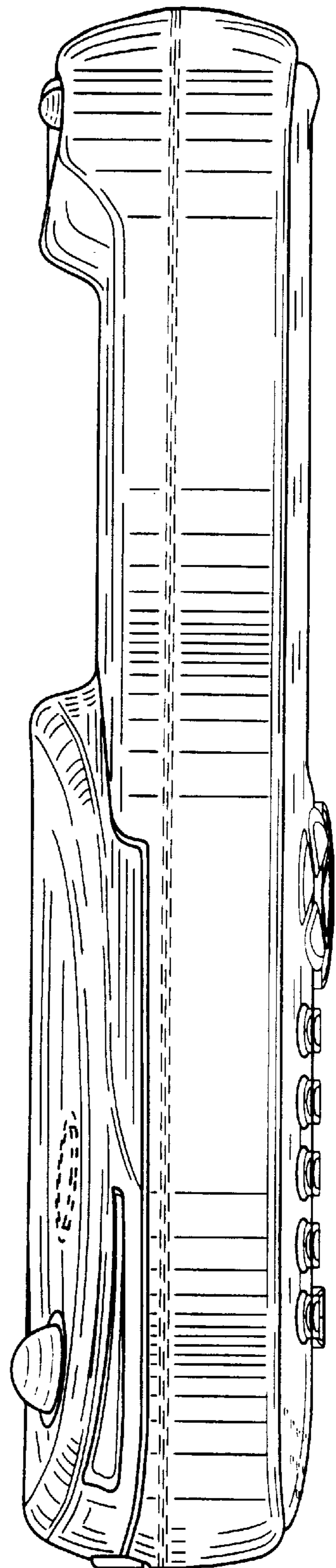

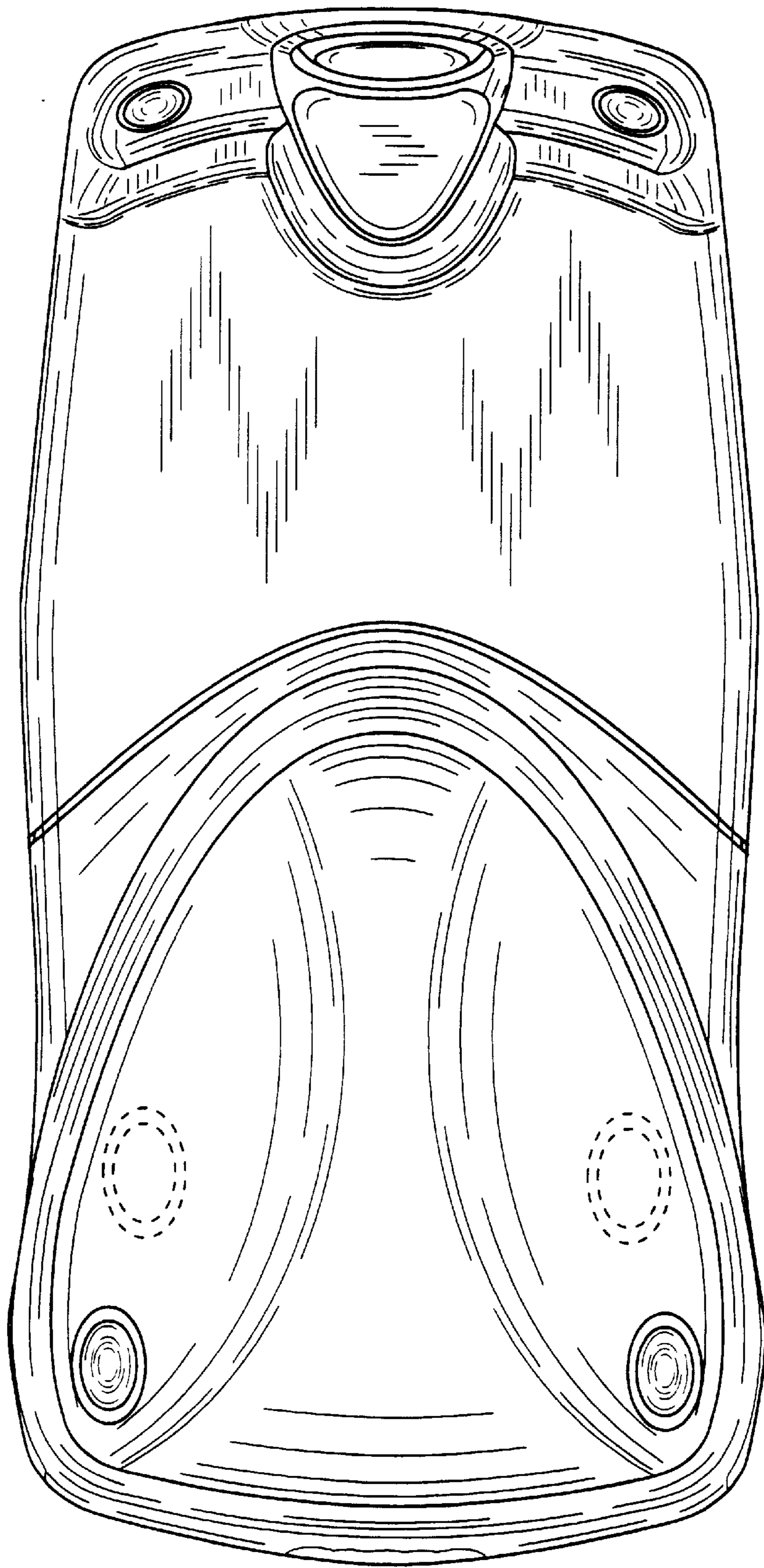

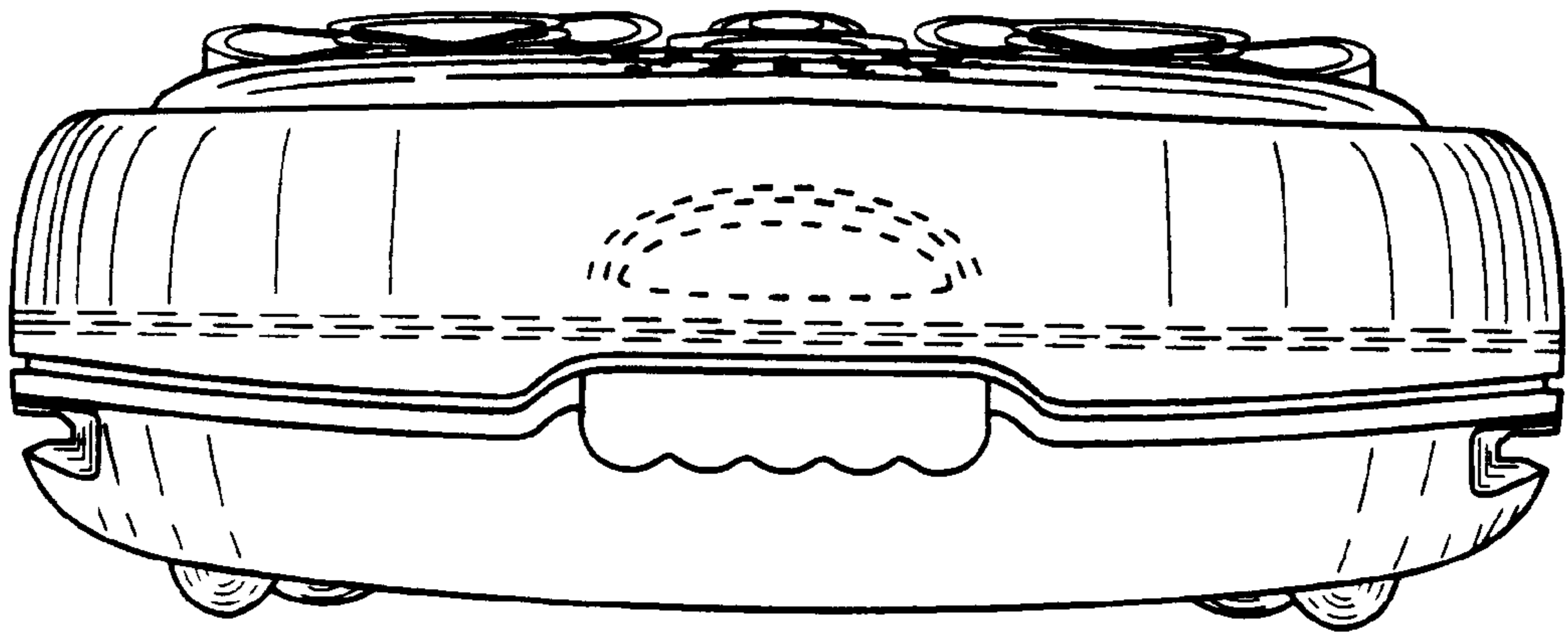

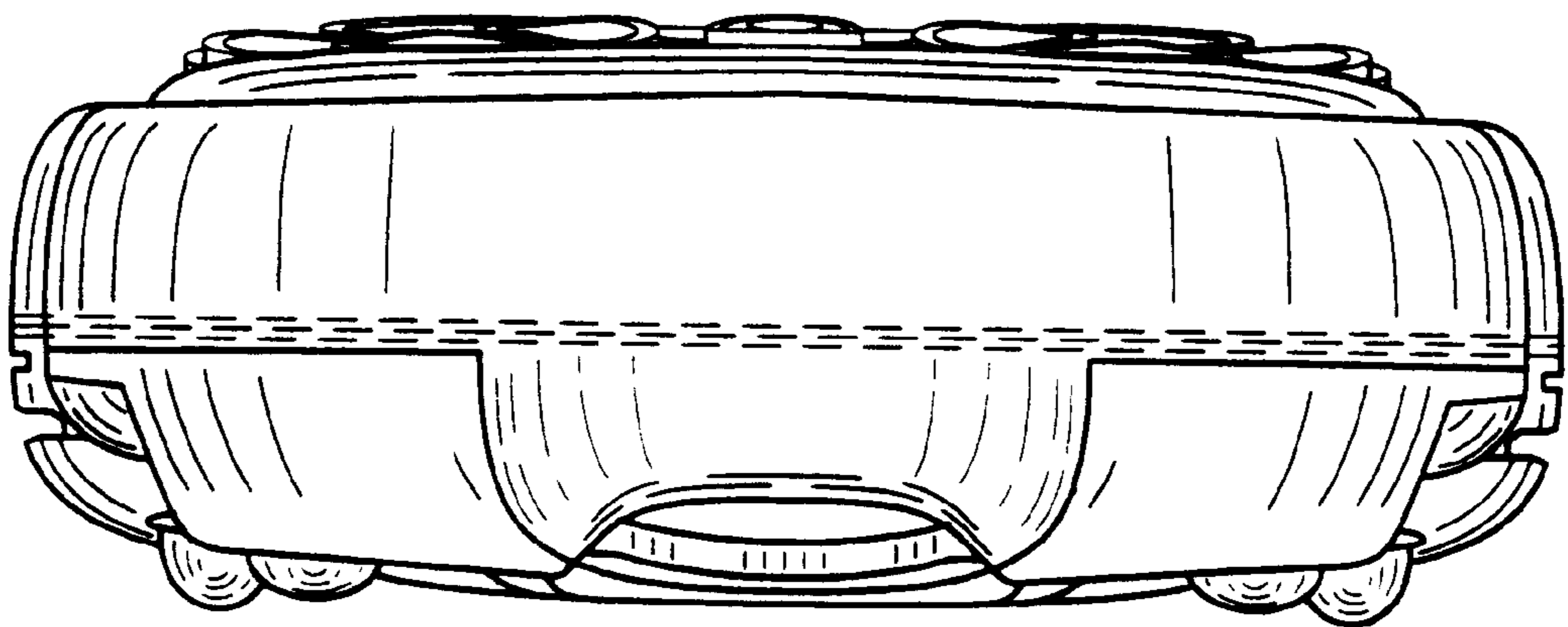
