(57) **CLAIM**

The ornamental design for an internet computer terminal kiosk, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the invention with a card reader portion to the right of a screen portion shown in broken lines, a paper currency slot to the left of the screen portion shown in broken lines, an audio/video port portion above the screen portion shown in broken lines, and a handle portion in a keyboard portion shown in broken lines;

FIG. 2 is a left side view of the invention, the right side view being a mirror image;

FIG. 3 is a top plan view of the invention;

FIG. 4 is a front elevation view of the invention as shown in FIG. 1;

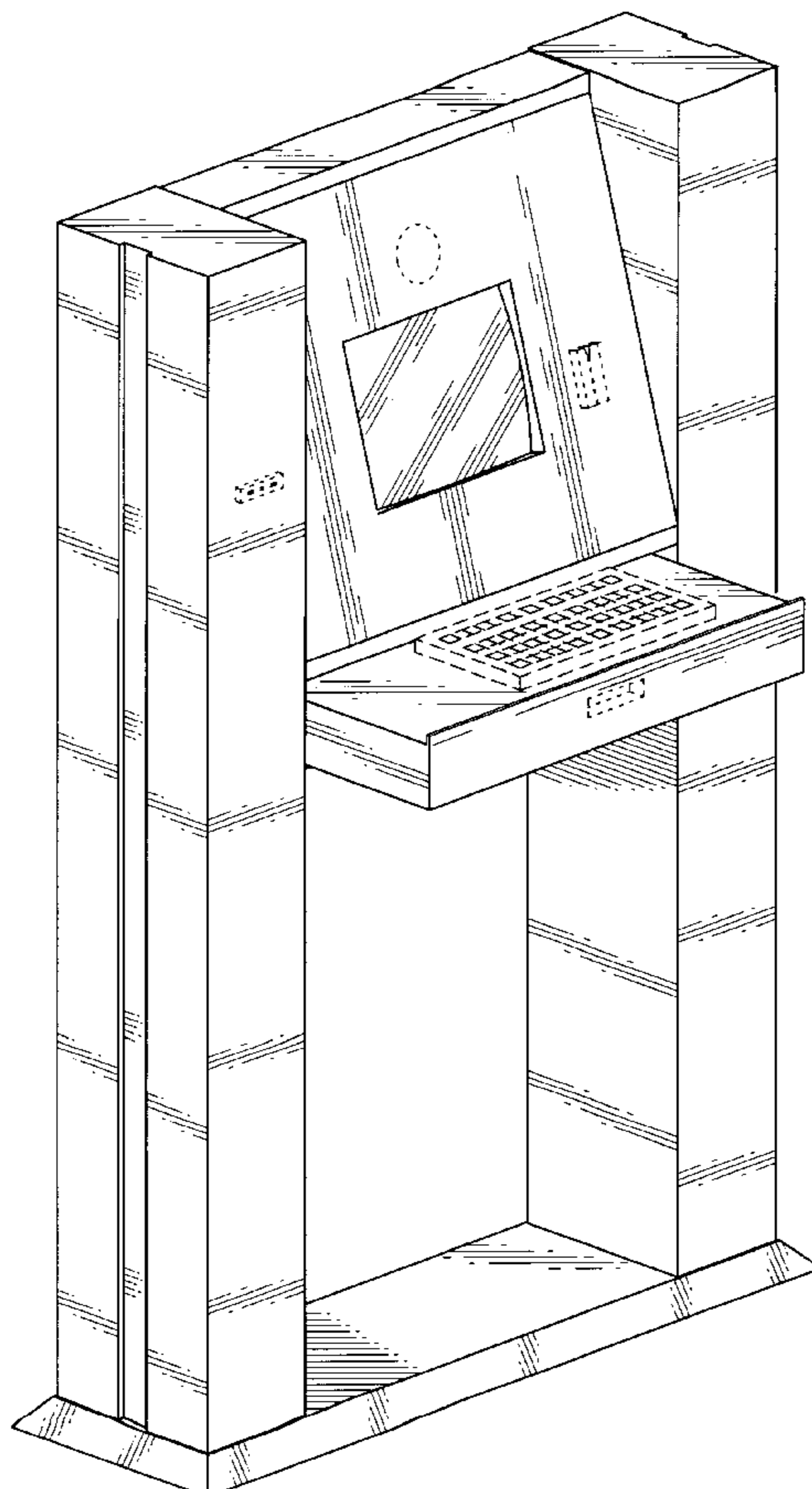
FIG. 5 is a rear elevation view of the invention;

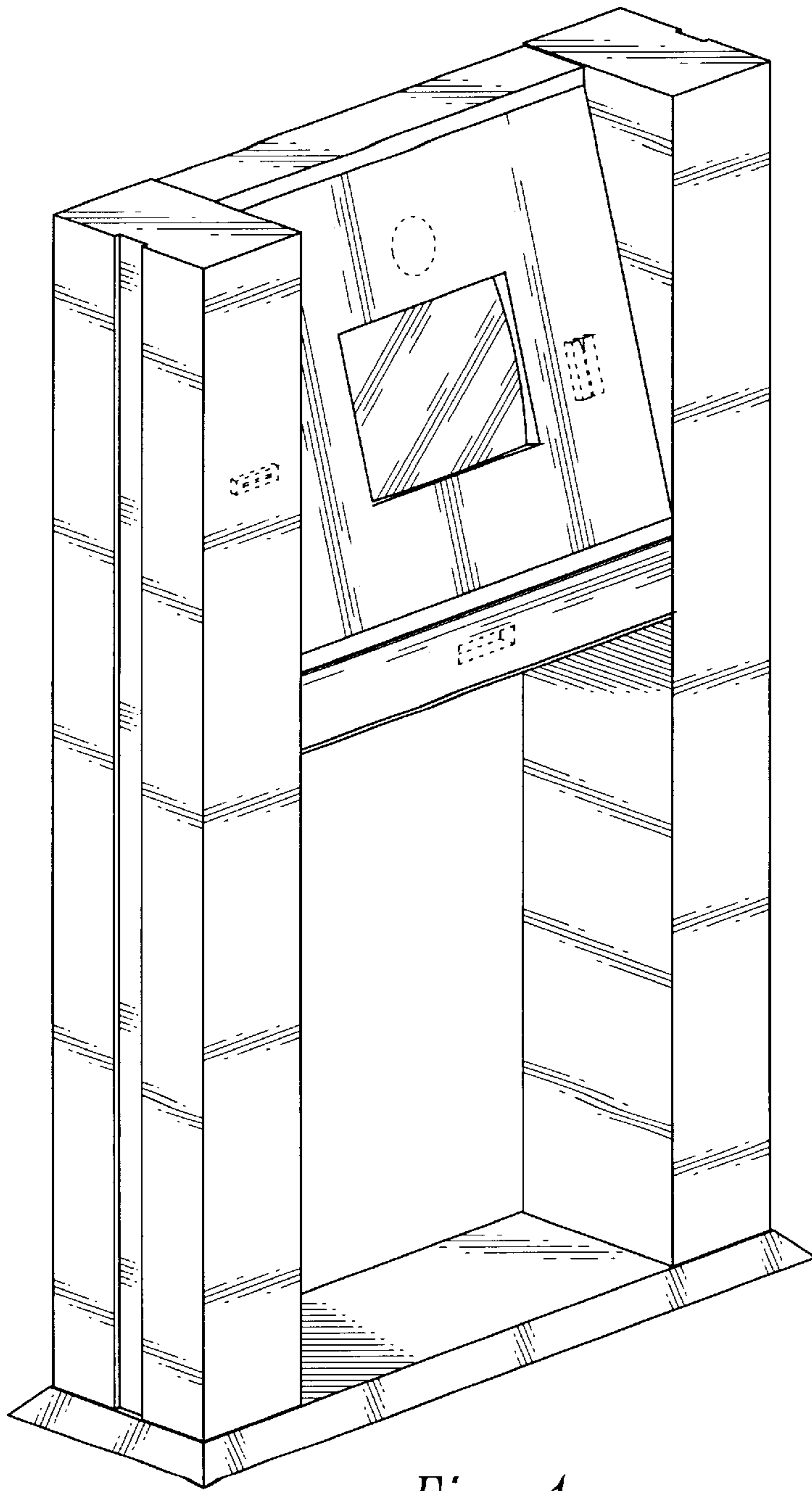
FIG. 6 is a bottom plan view of the invention; and,

FIG. 7 is a perspective view of the invention shown with an open keyboard tray portion having a keyboard portion resting thereon shown in broken lines.

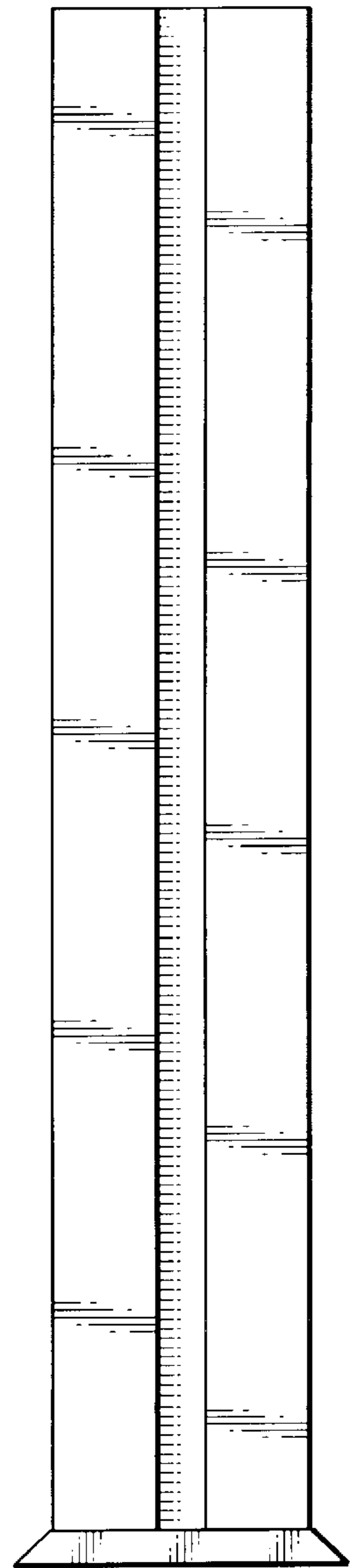
The broken lines in FIGS. 1, 4 and 7 are for purposes of illustration only and form no part of the claimed design.

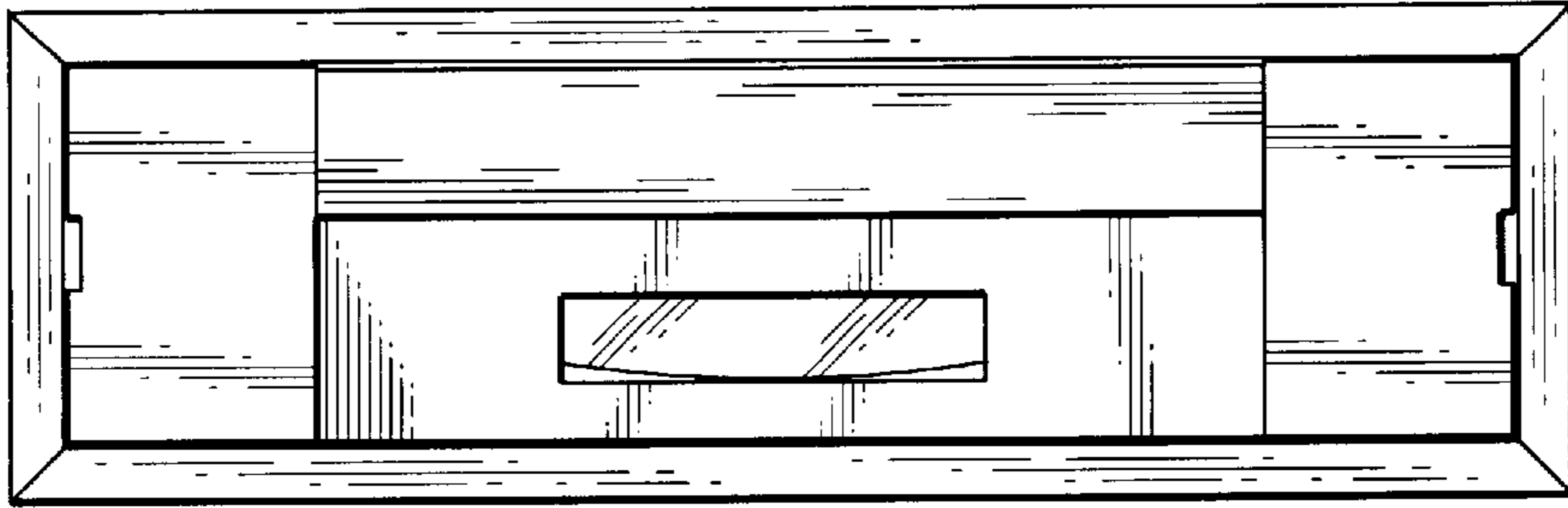




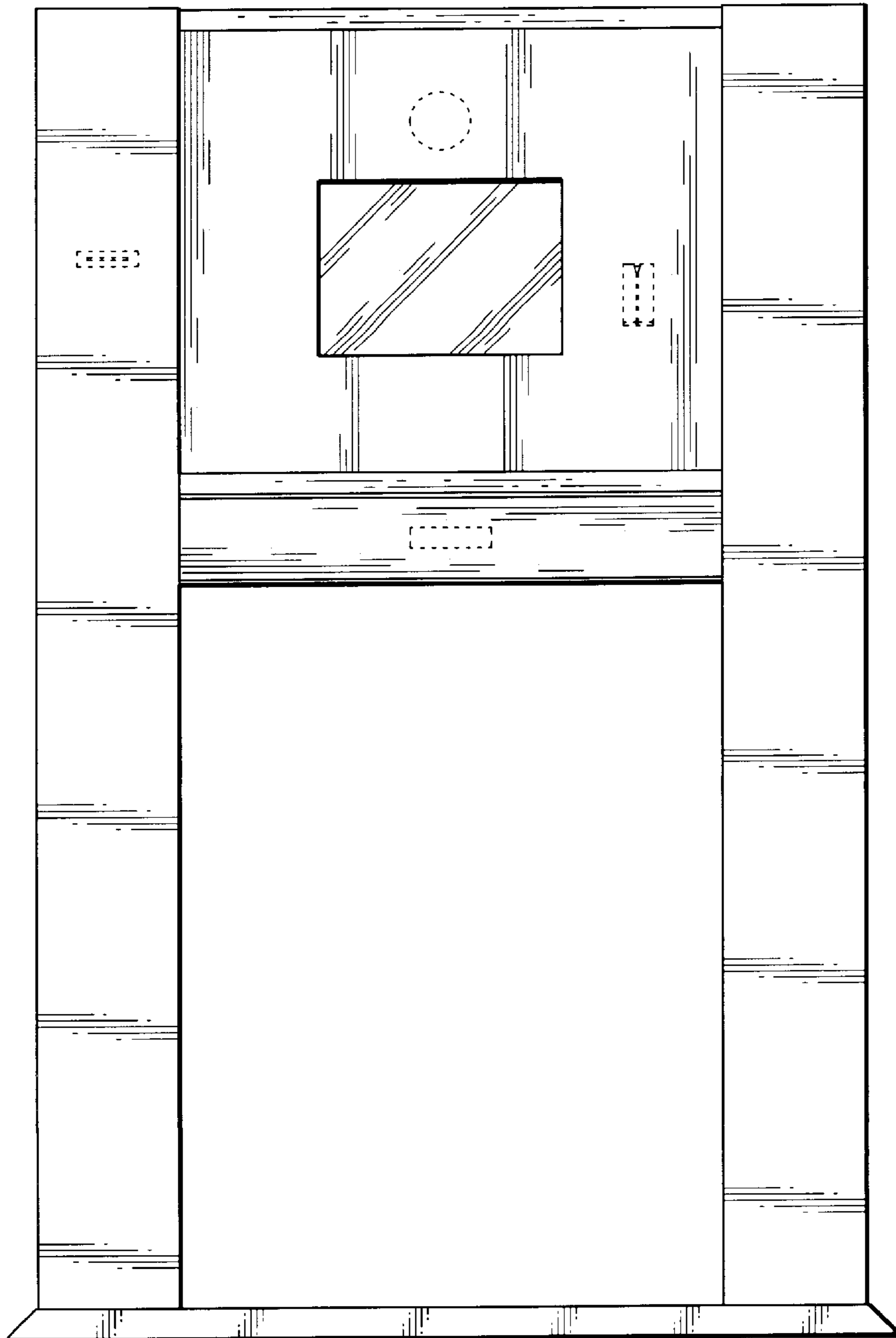

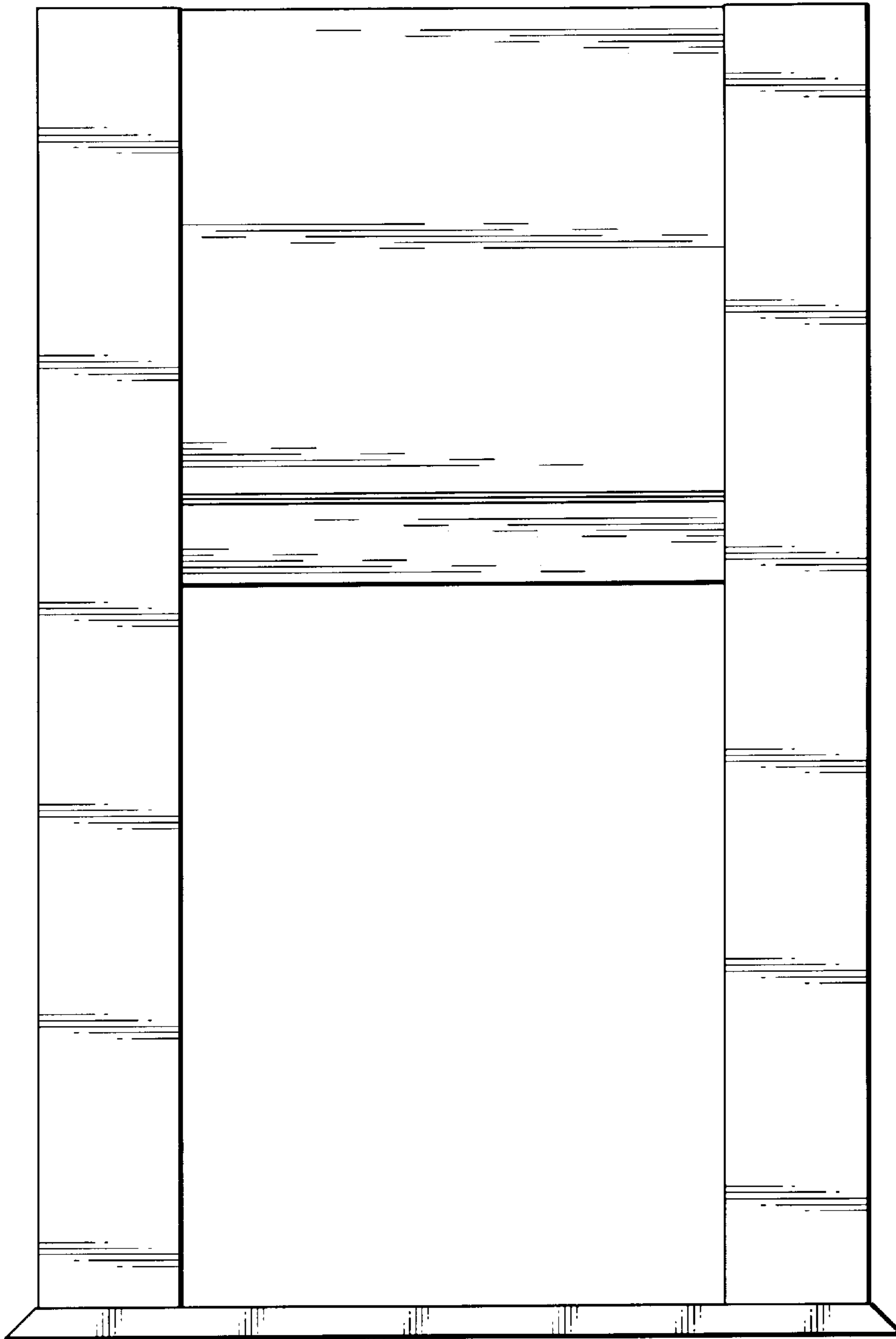

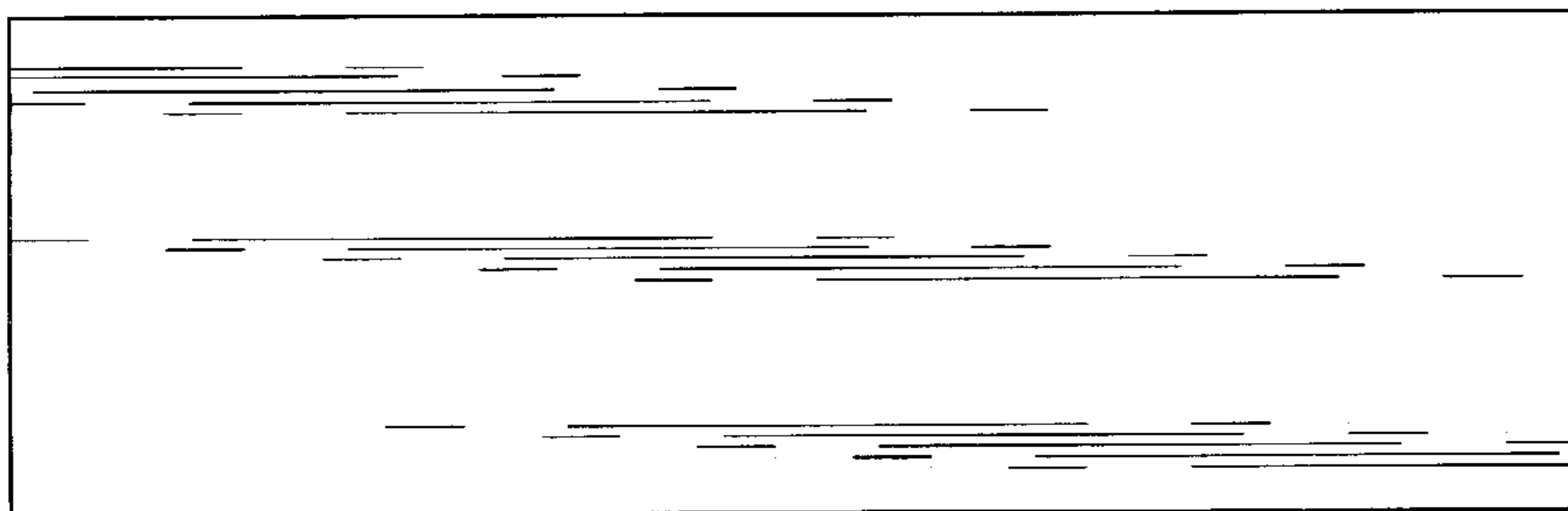

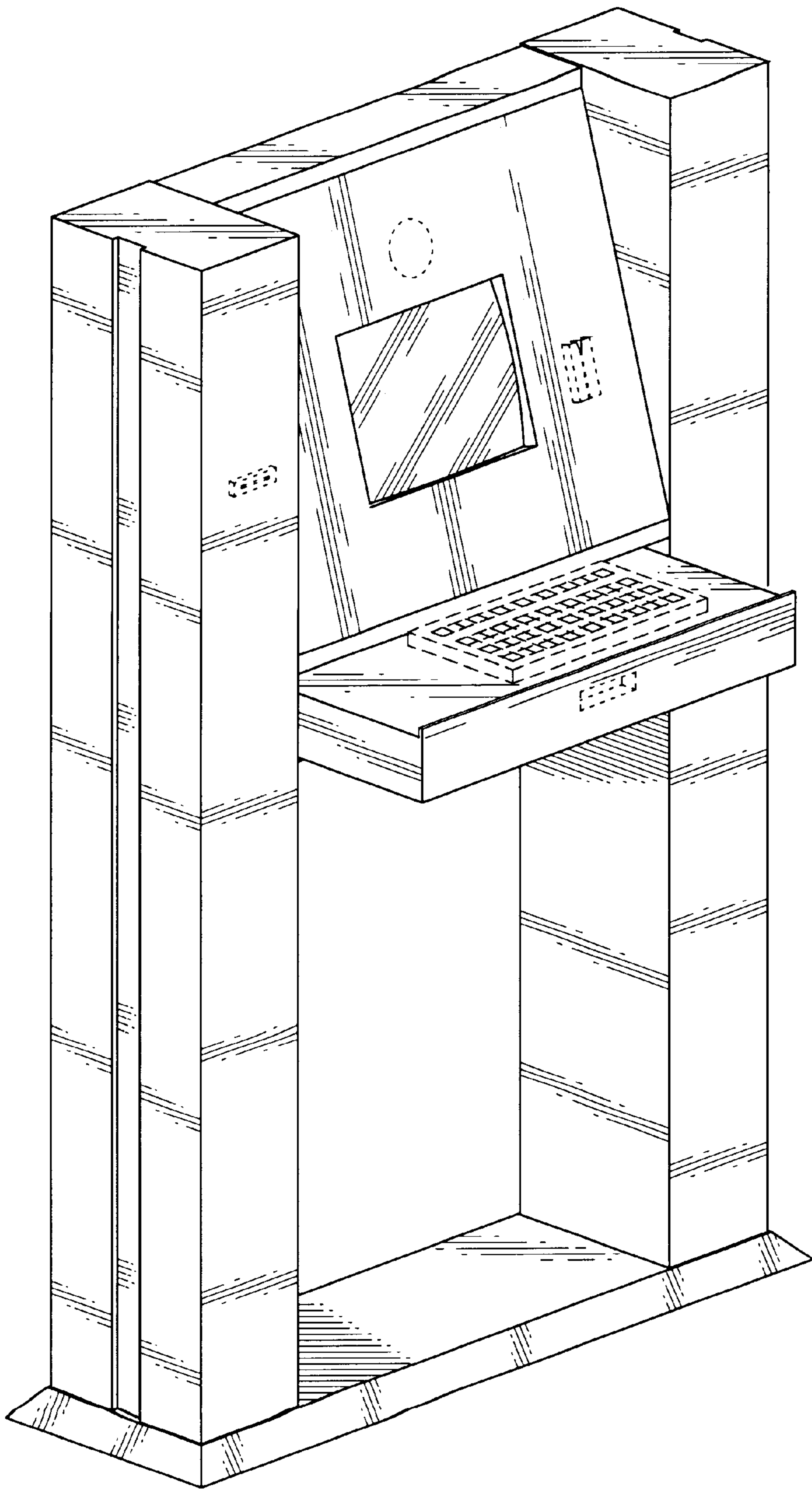
