(57) **CLAIM**

The ornamental design for a pad for transporting multiple transformers, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of one perspective of my design showing my pad for transporting multiple transformers.

FIG. 2 is an isometric view of another perspective of my design.

FIG. 3 is a top plan view of my design.

FIG. 4 is an elevational view of one side of my design, the opposite elevational side view being the same.

FIG. 5 is an elevational view of another side of my design, the opposite elevational side view being the same; and,

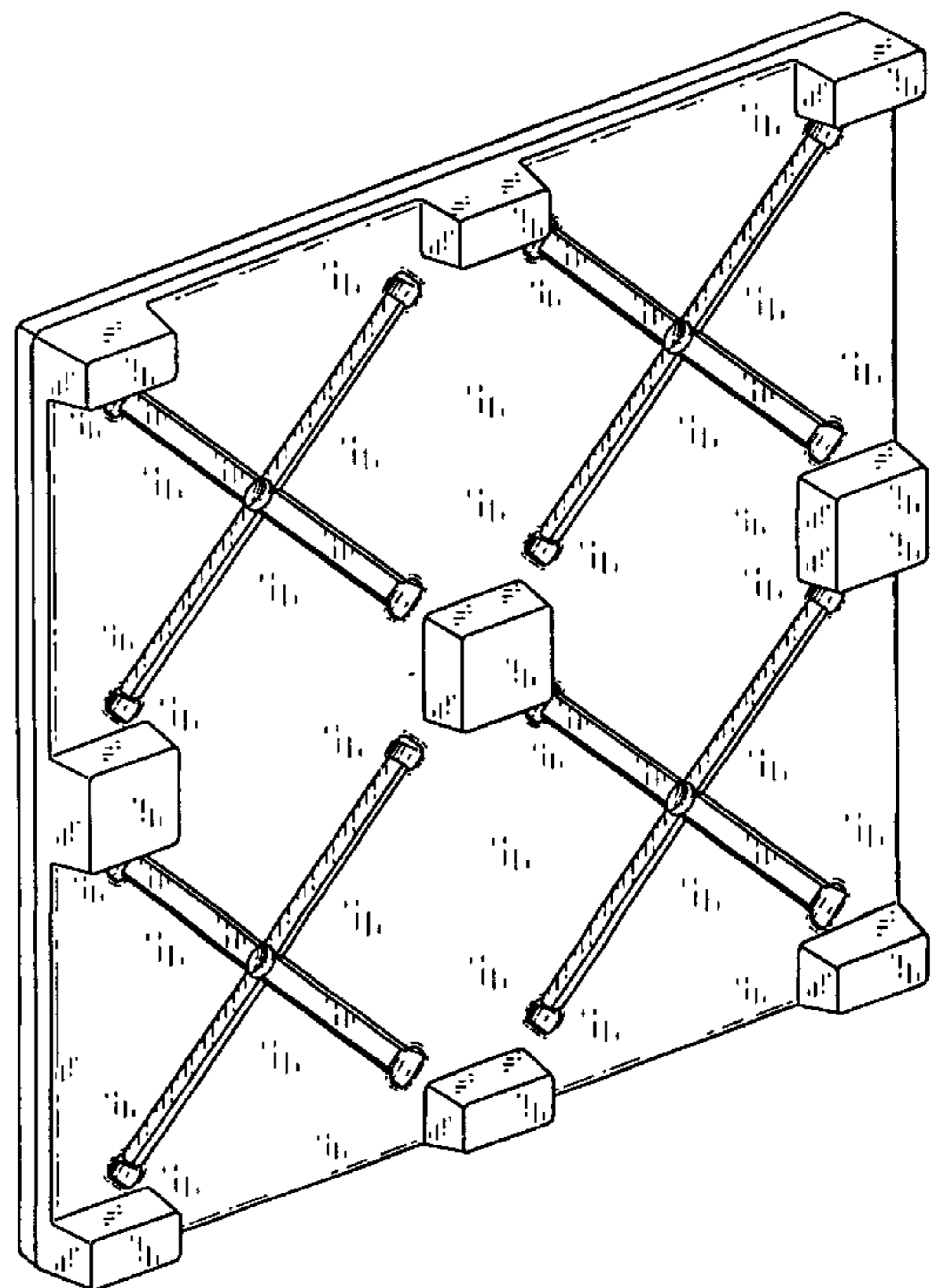
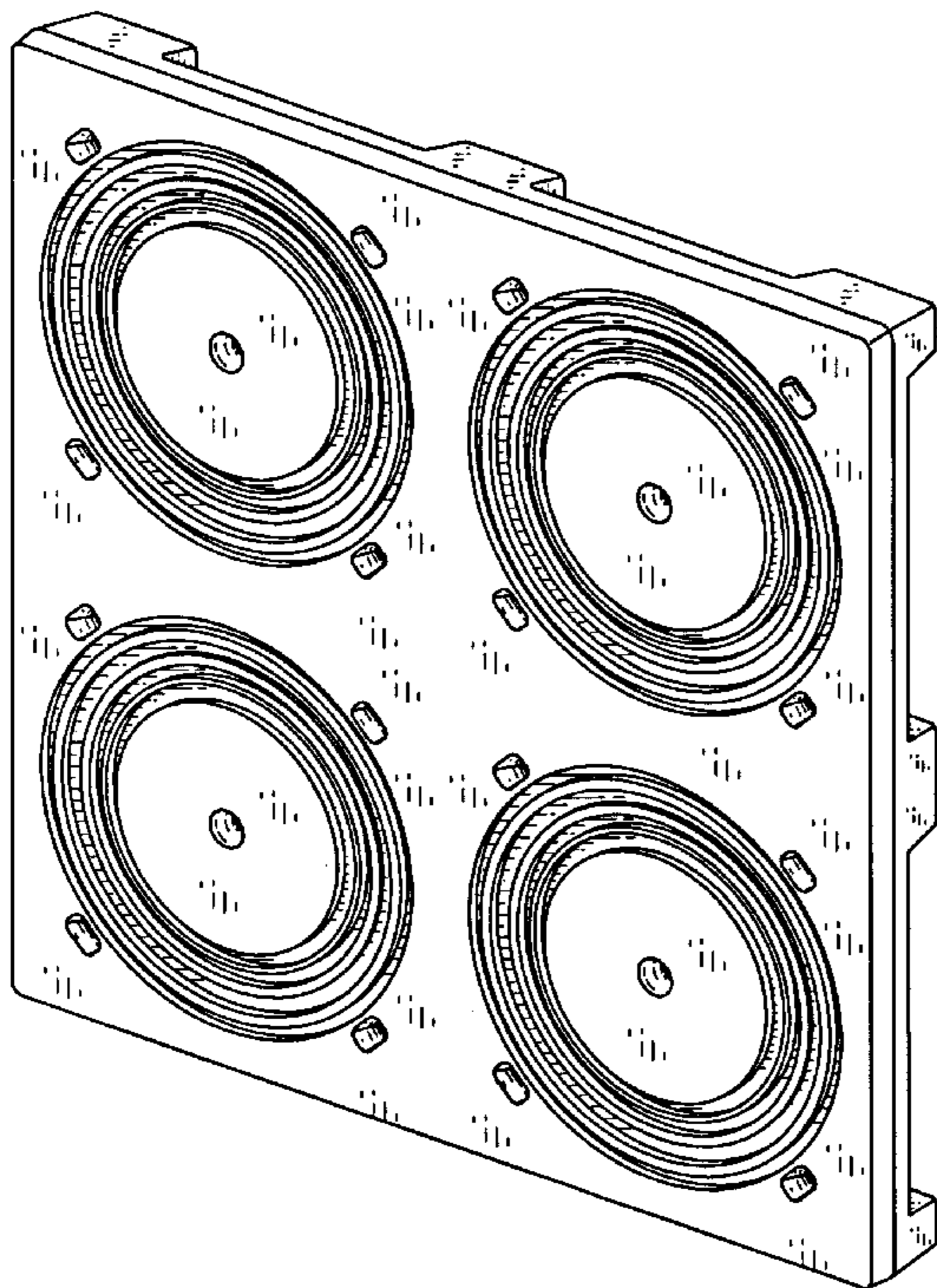

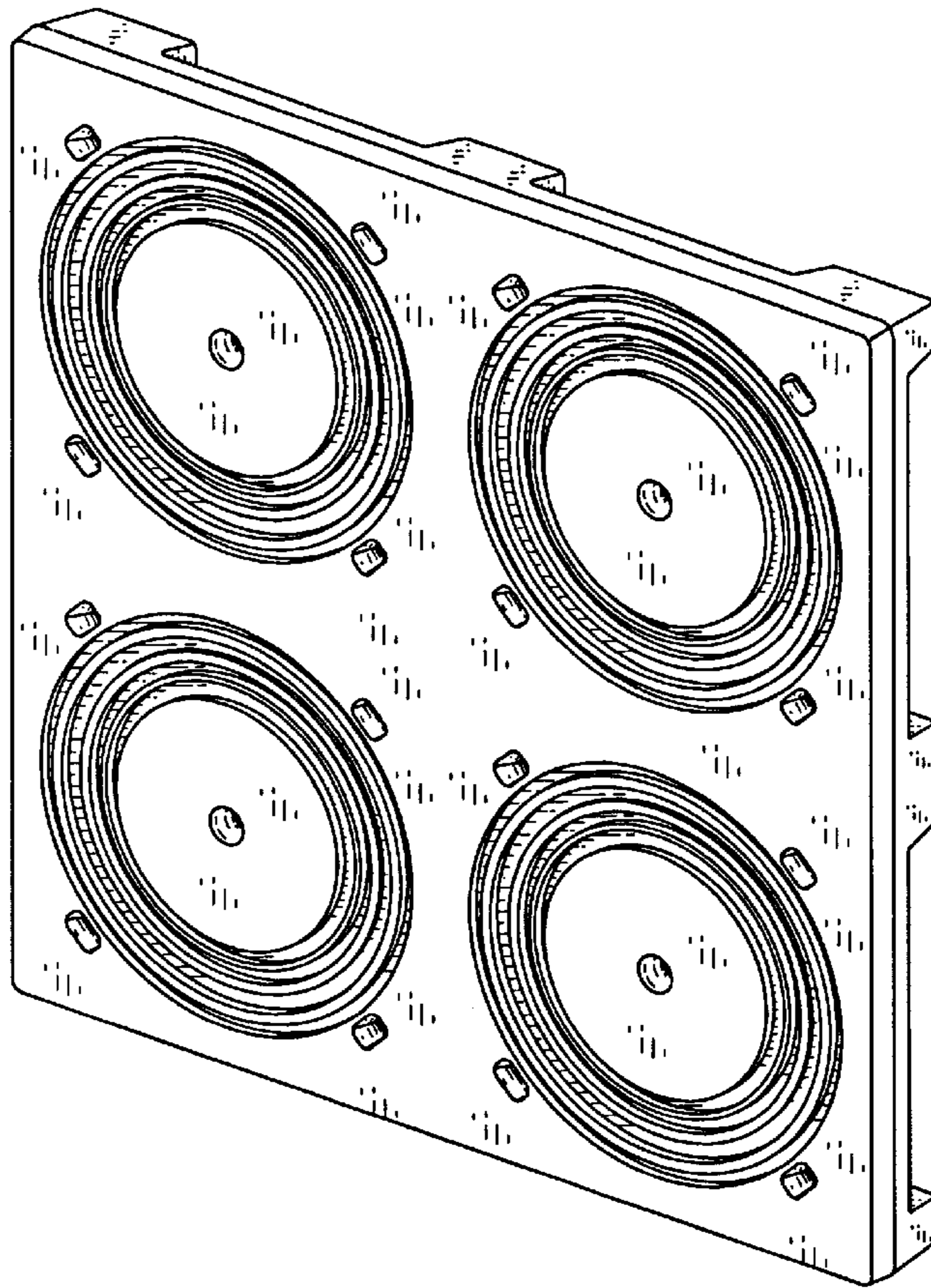

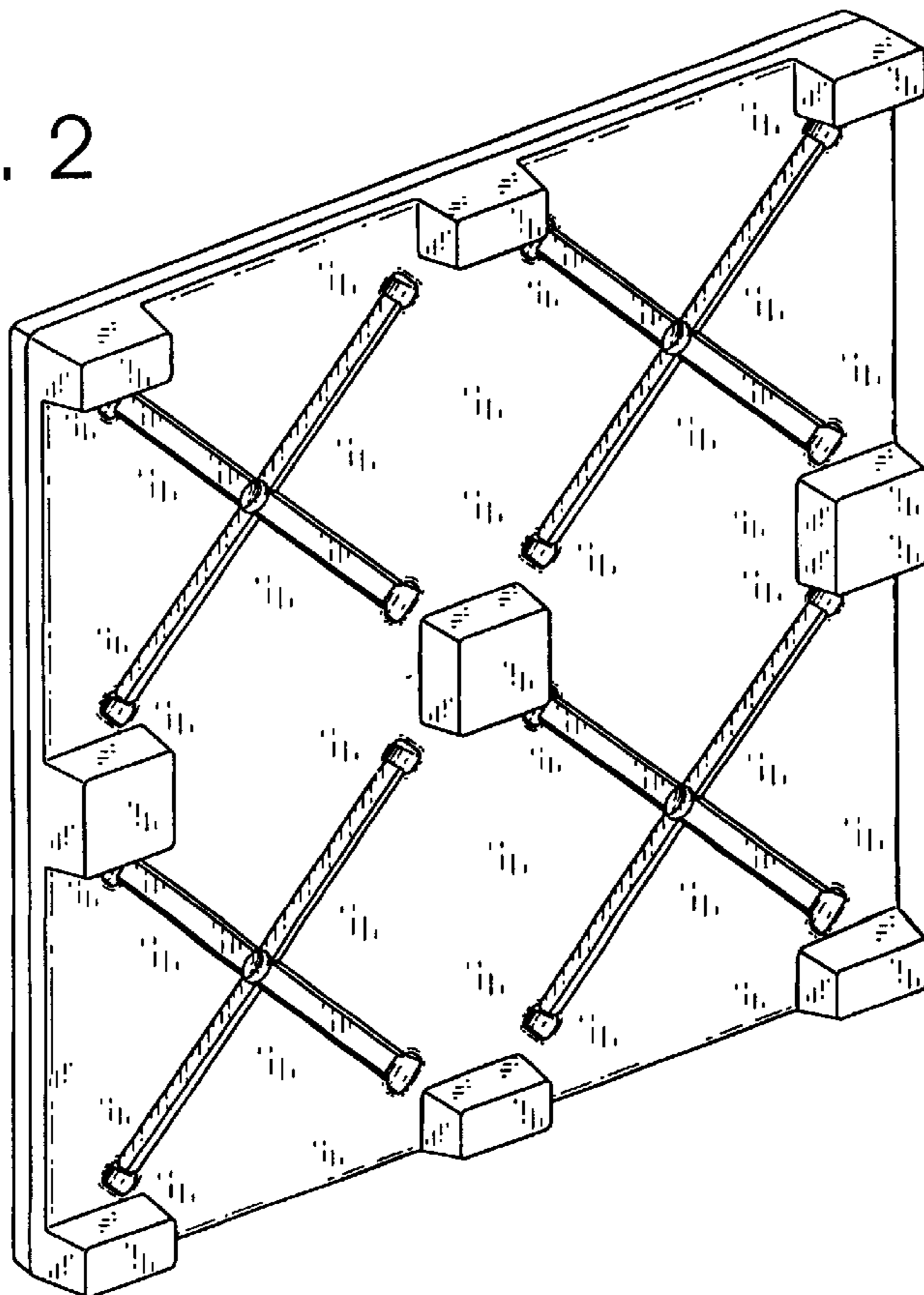

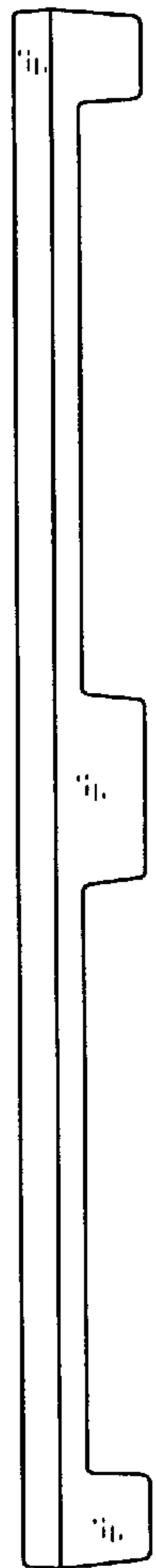
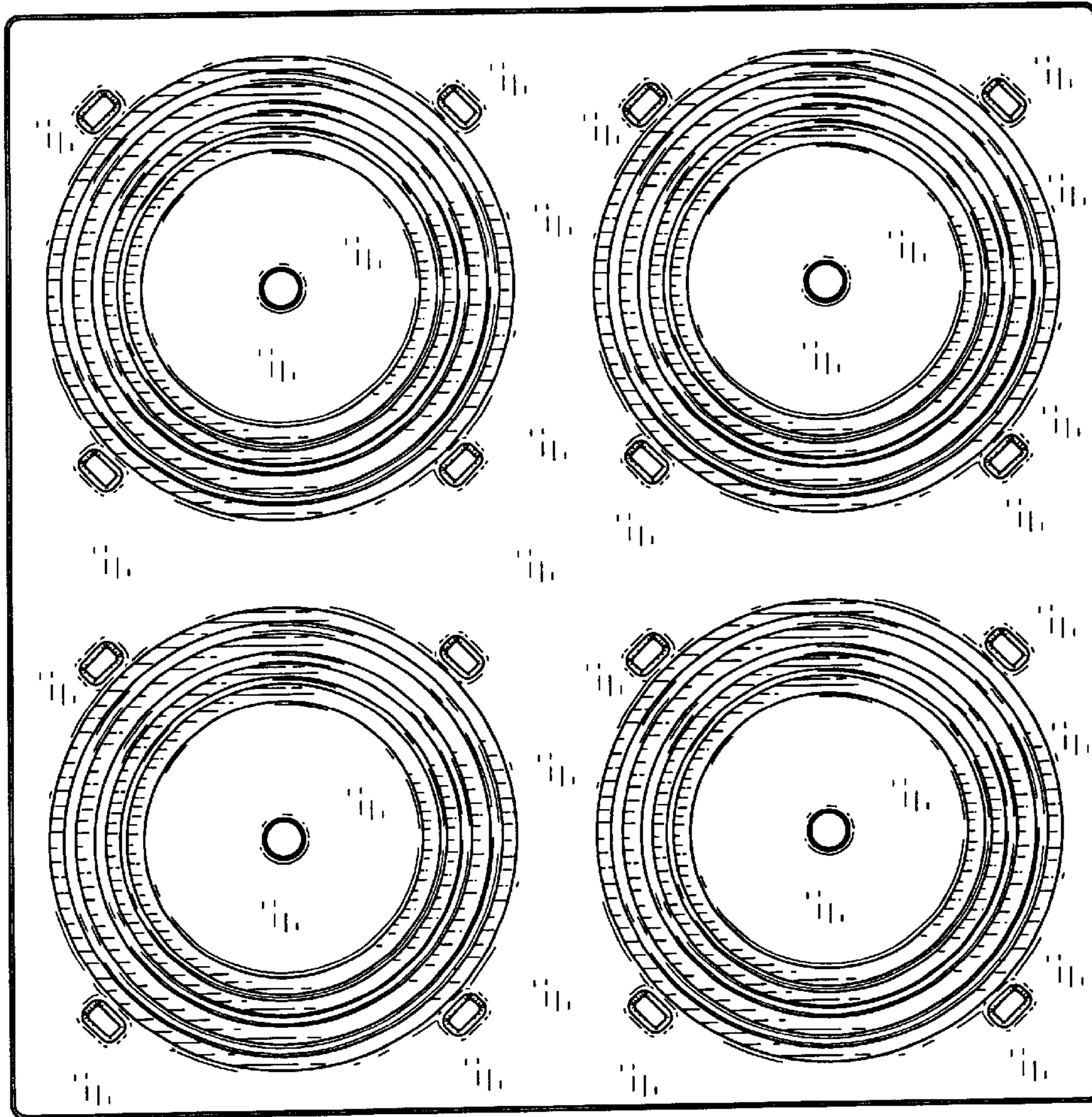

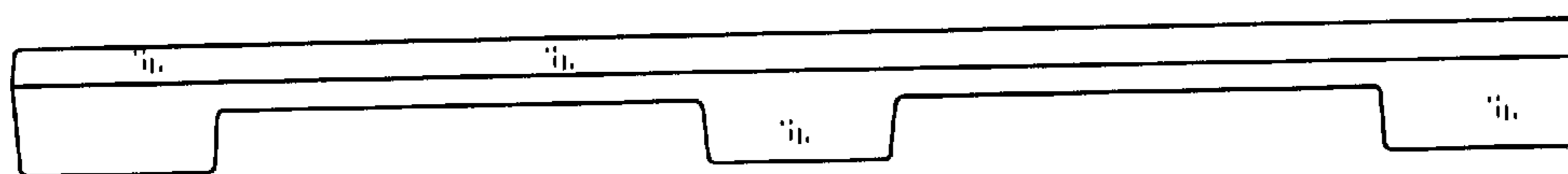
