(57) **CLAIM**

The ornamental design for an outsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of an outsole according to an embodiment of the invention.

FIG. 2 is a right-side elevation view of the outsole of FIG. 1.

FIG. 3 is a left-side elevation view of the outsole of FIG. 1.

FIG. 4 is a front elevation view of the outsole of FIG. 1.

FIG. 5 is a rear elevation view of the outsole of FIG. 1.

FIG. 6 is a bottom perspective view of the outsole of FIG. 1.

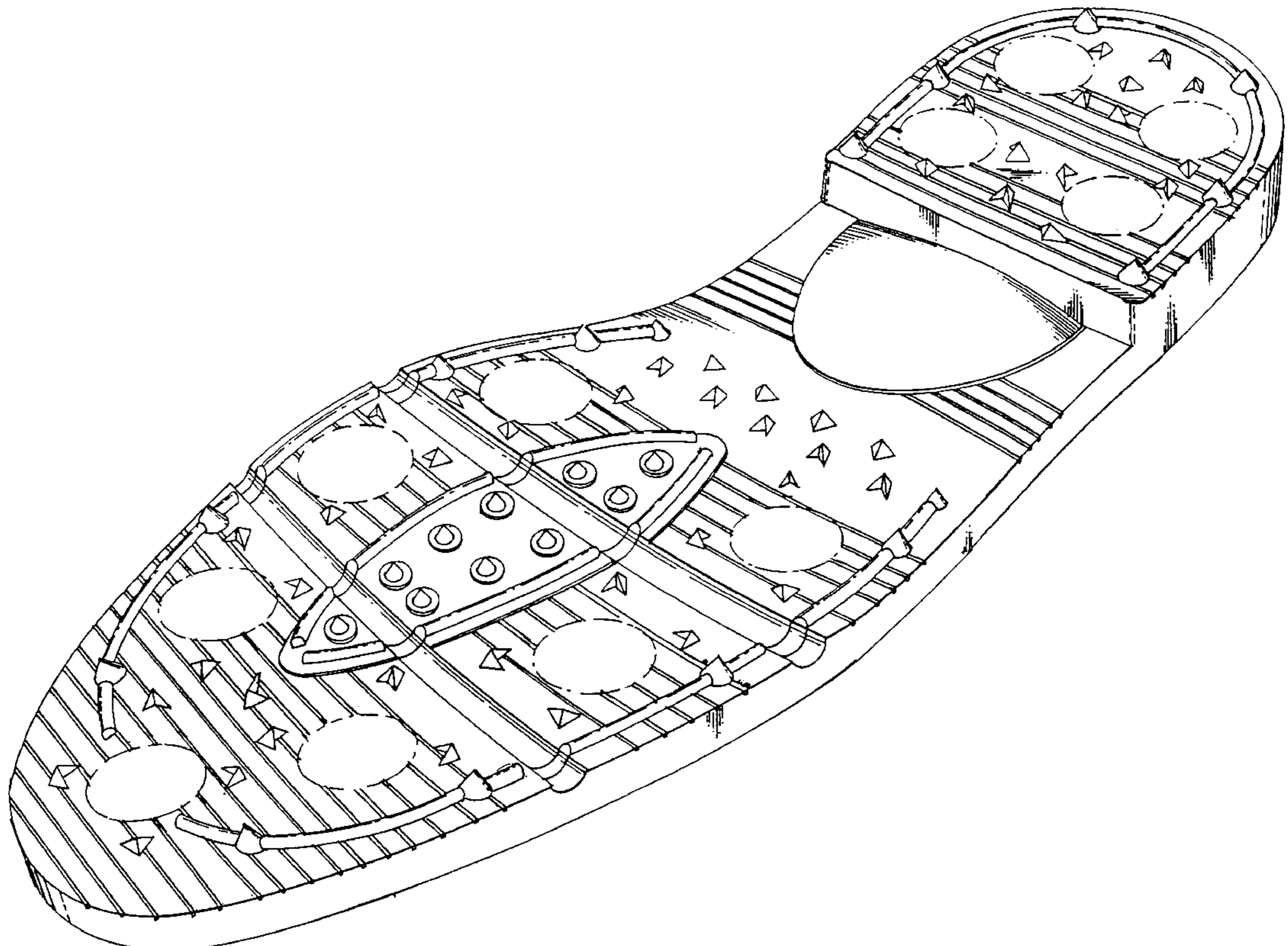
FIG. 7 is a detailed perspective view of a mini spike from FIG. 6.

FIG. 8 is another detailed perspective view of the mini spike from FIGS. 6 and 7; and,

FIG. 9 is a detailed perspective view of a mini spike from the center of the forefoot of the outsole of FIG. 6.

The broken-line showings of the shoe upper in FIG. 1 and of the cleat receptacles in FIG. 6 are for illustration purposes only and form no part of the claimed design.

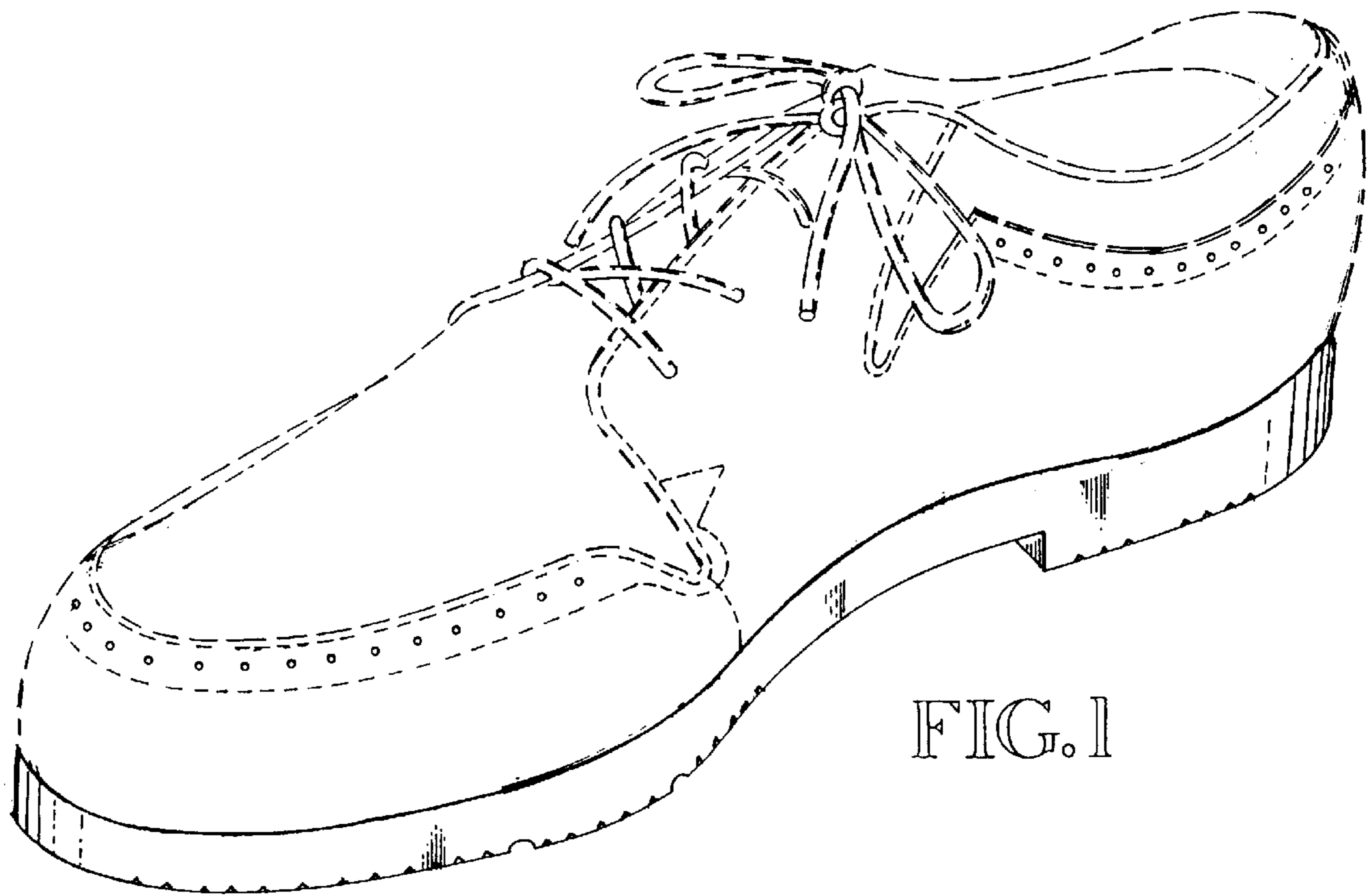

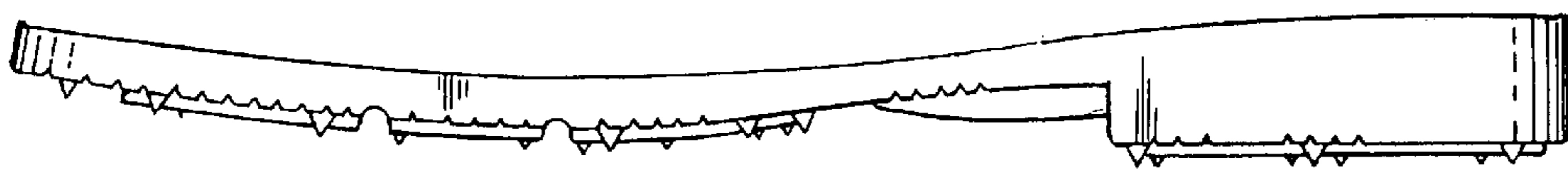

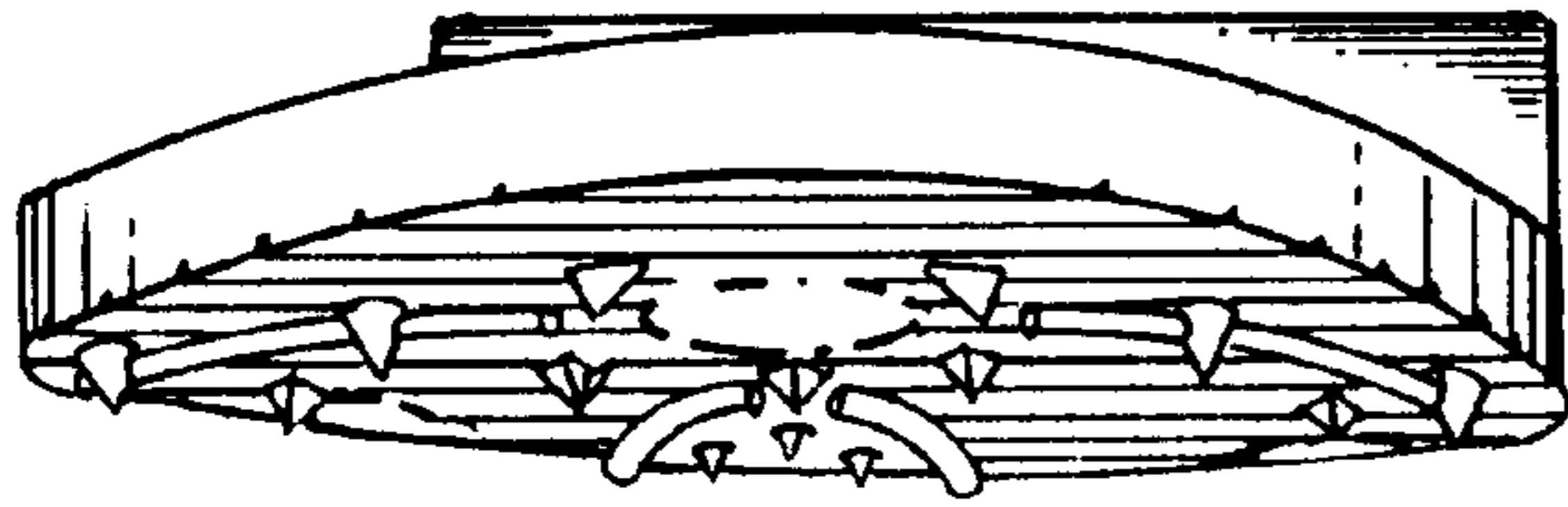

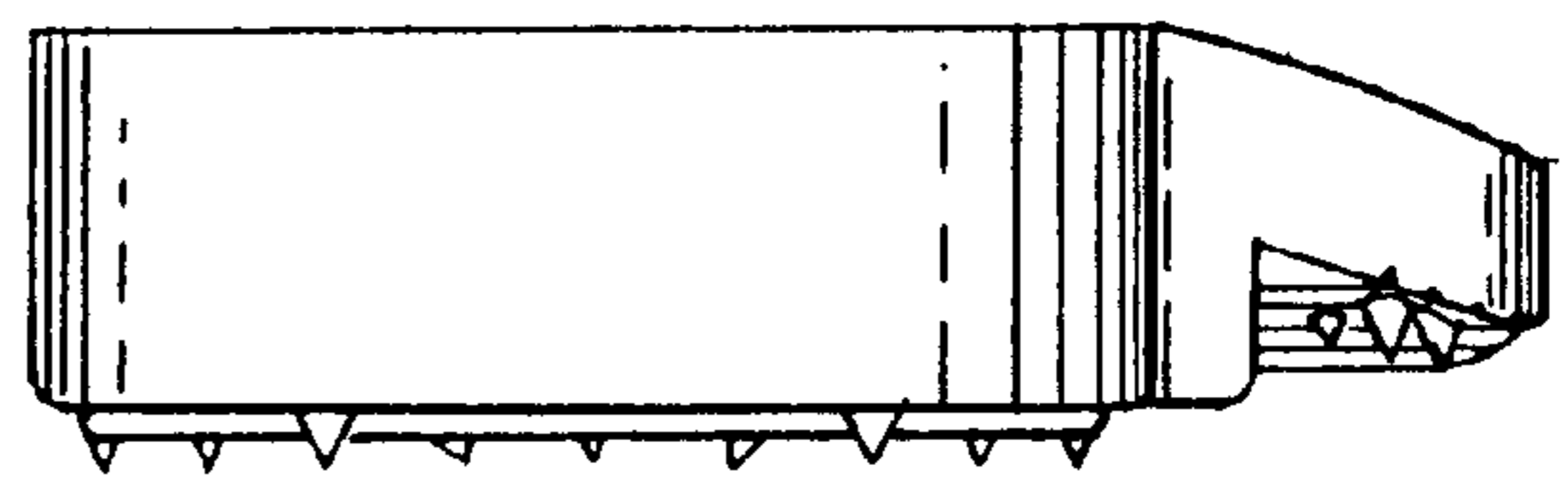

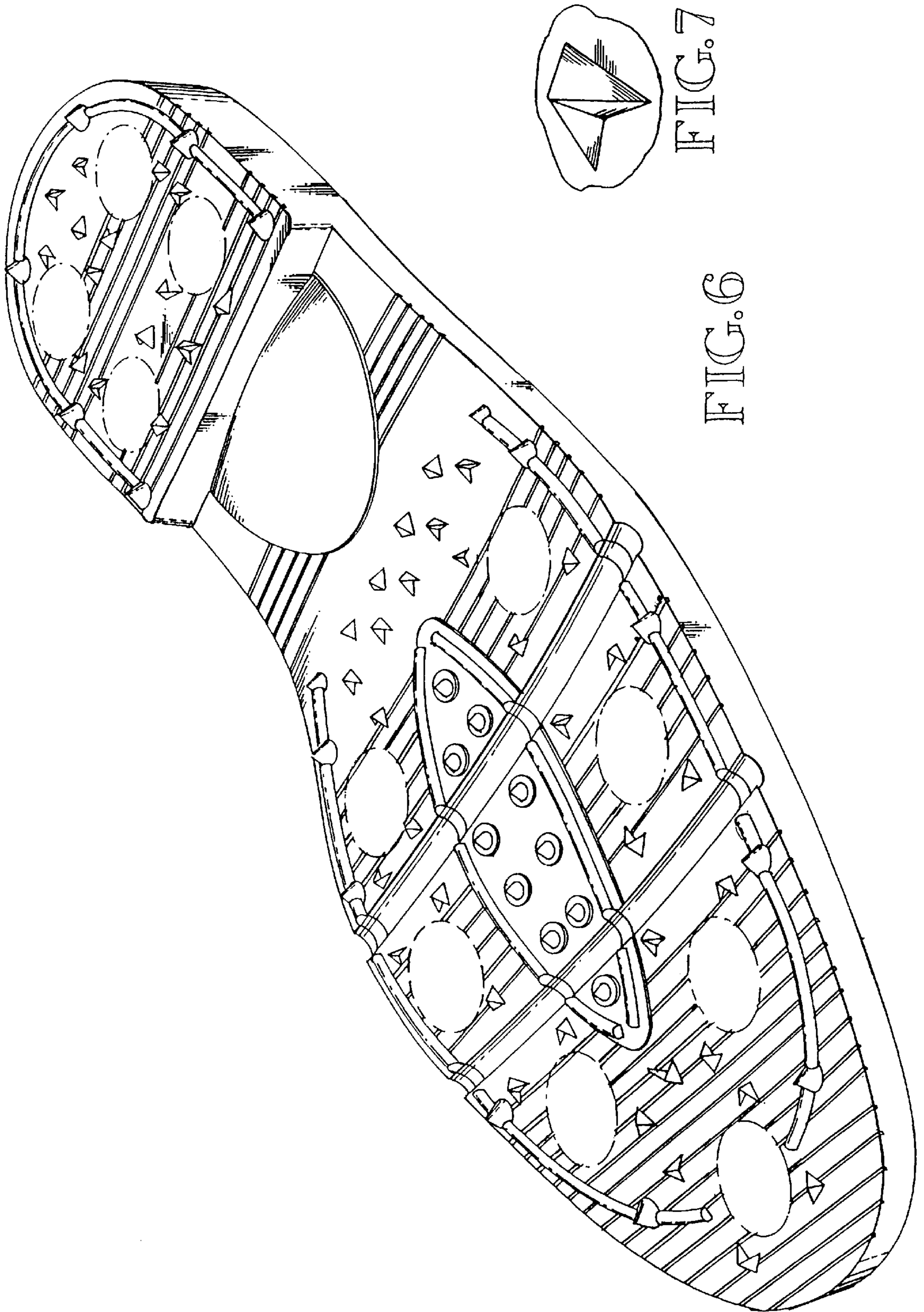

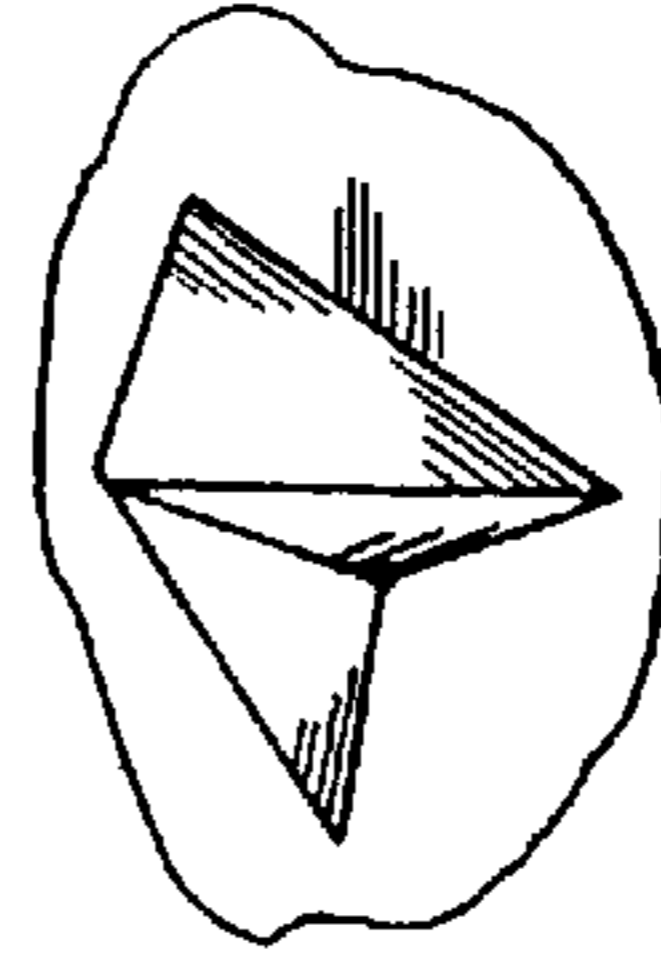

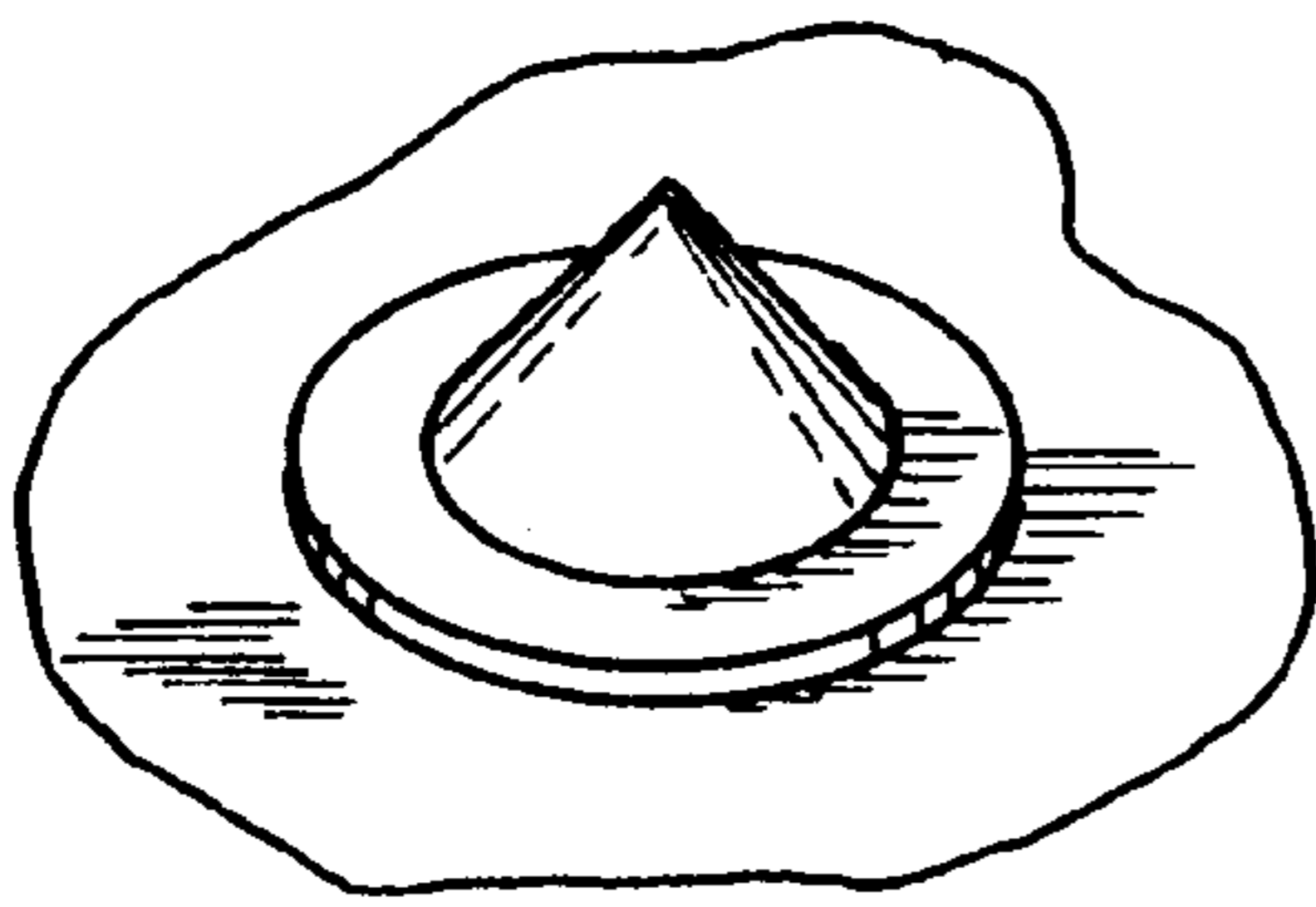
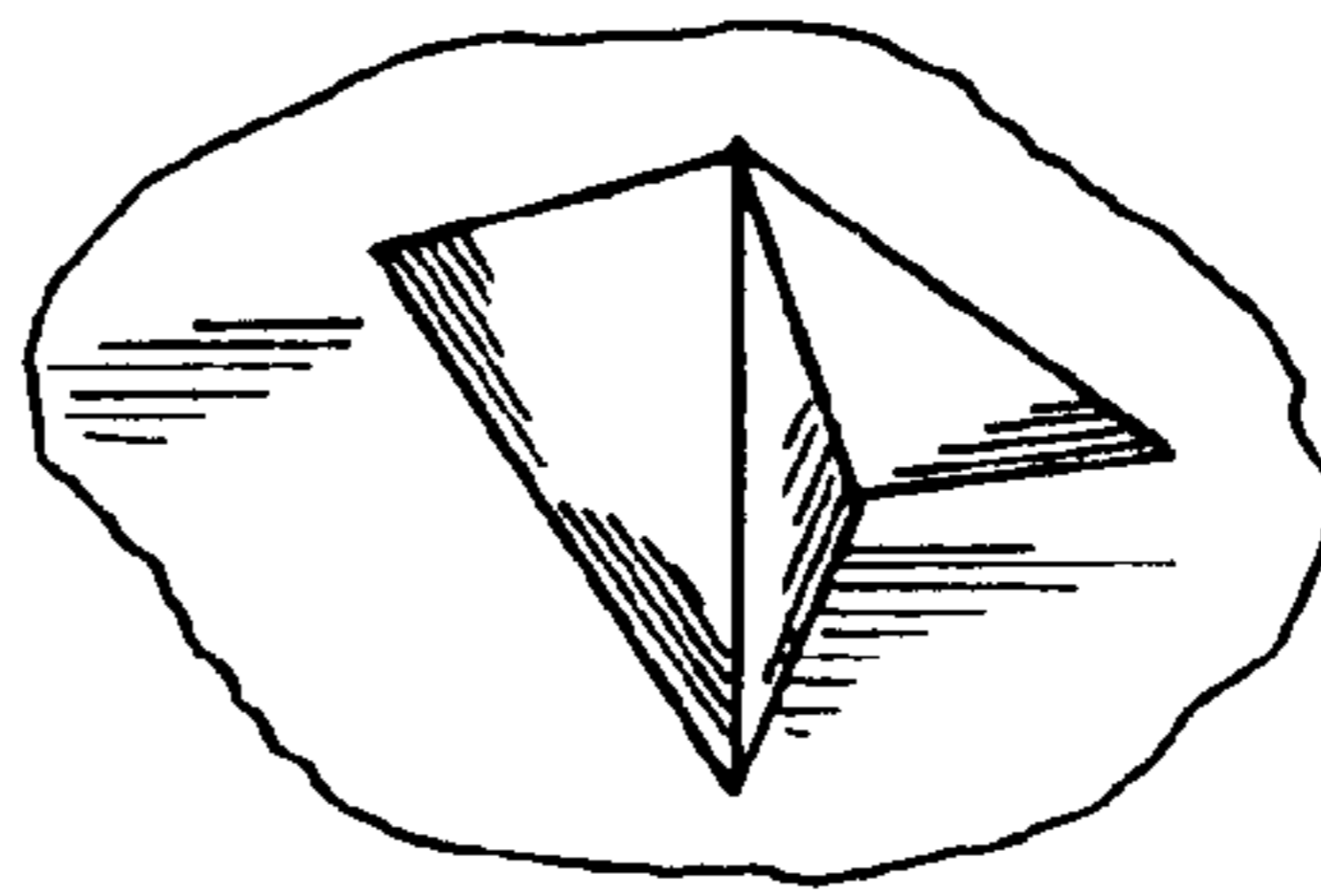
