(57) **CLAIM**

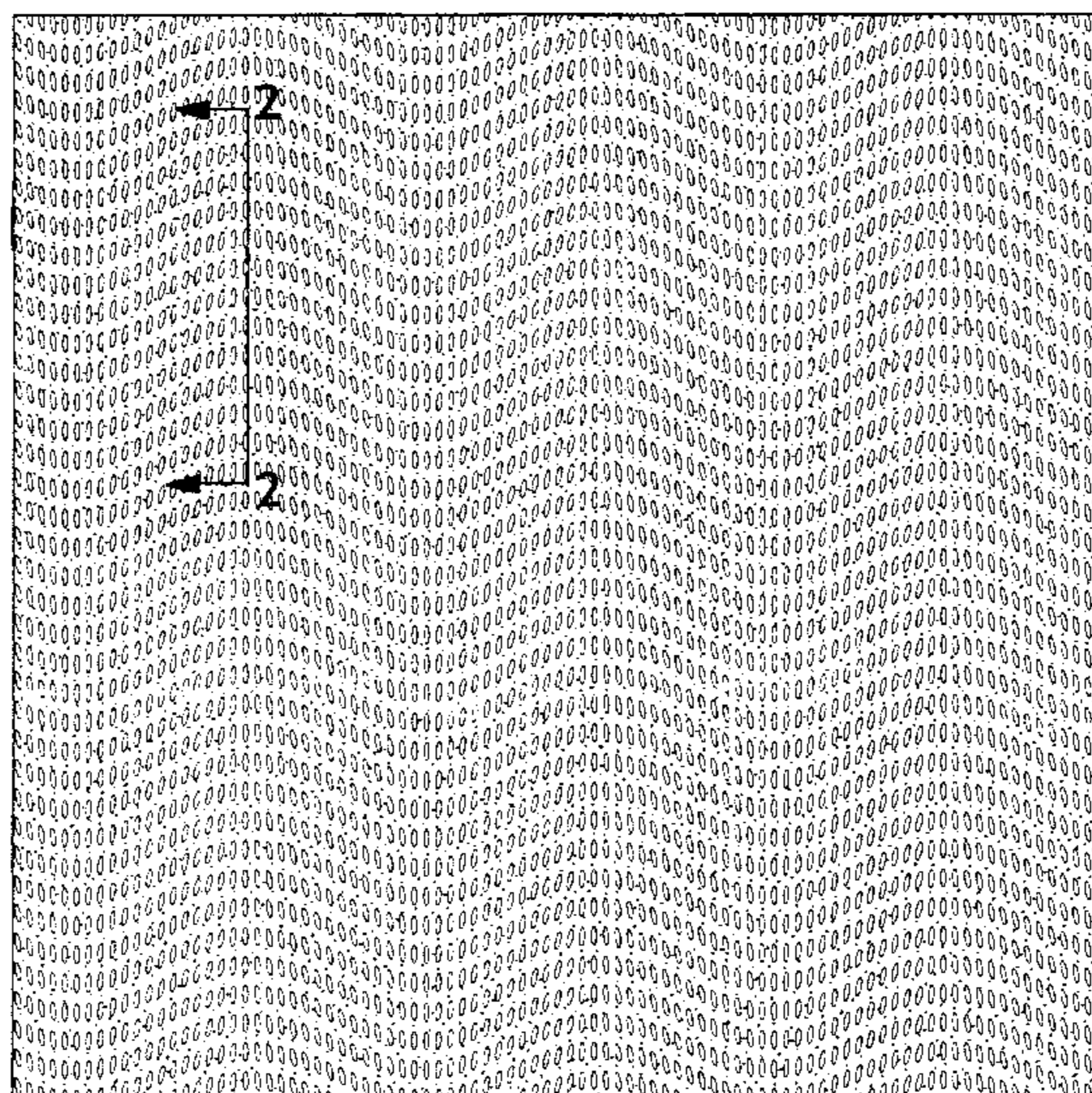
We claim the ornamental design for embossed bath tissue, as

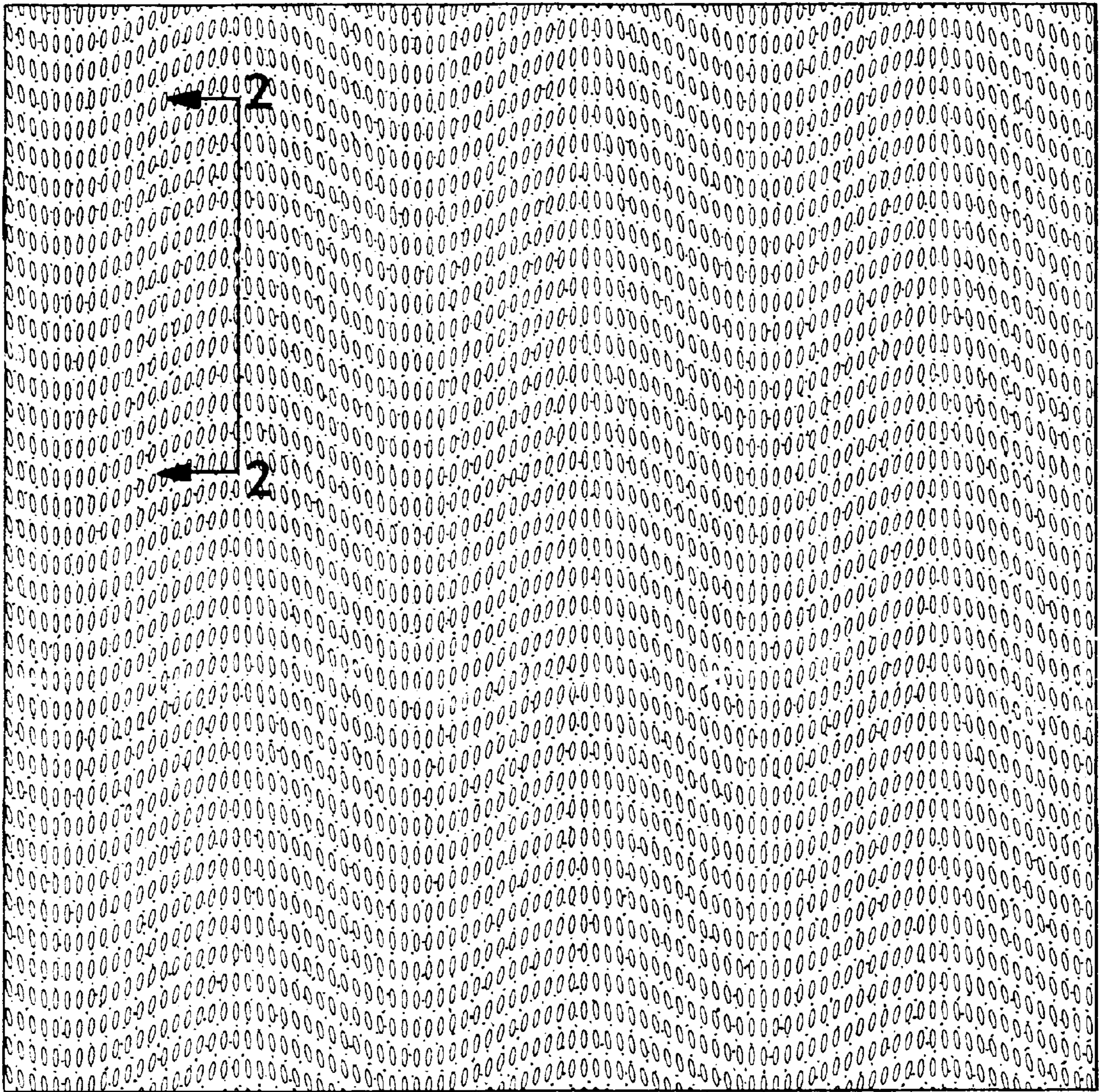
